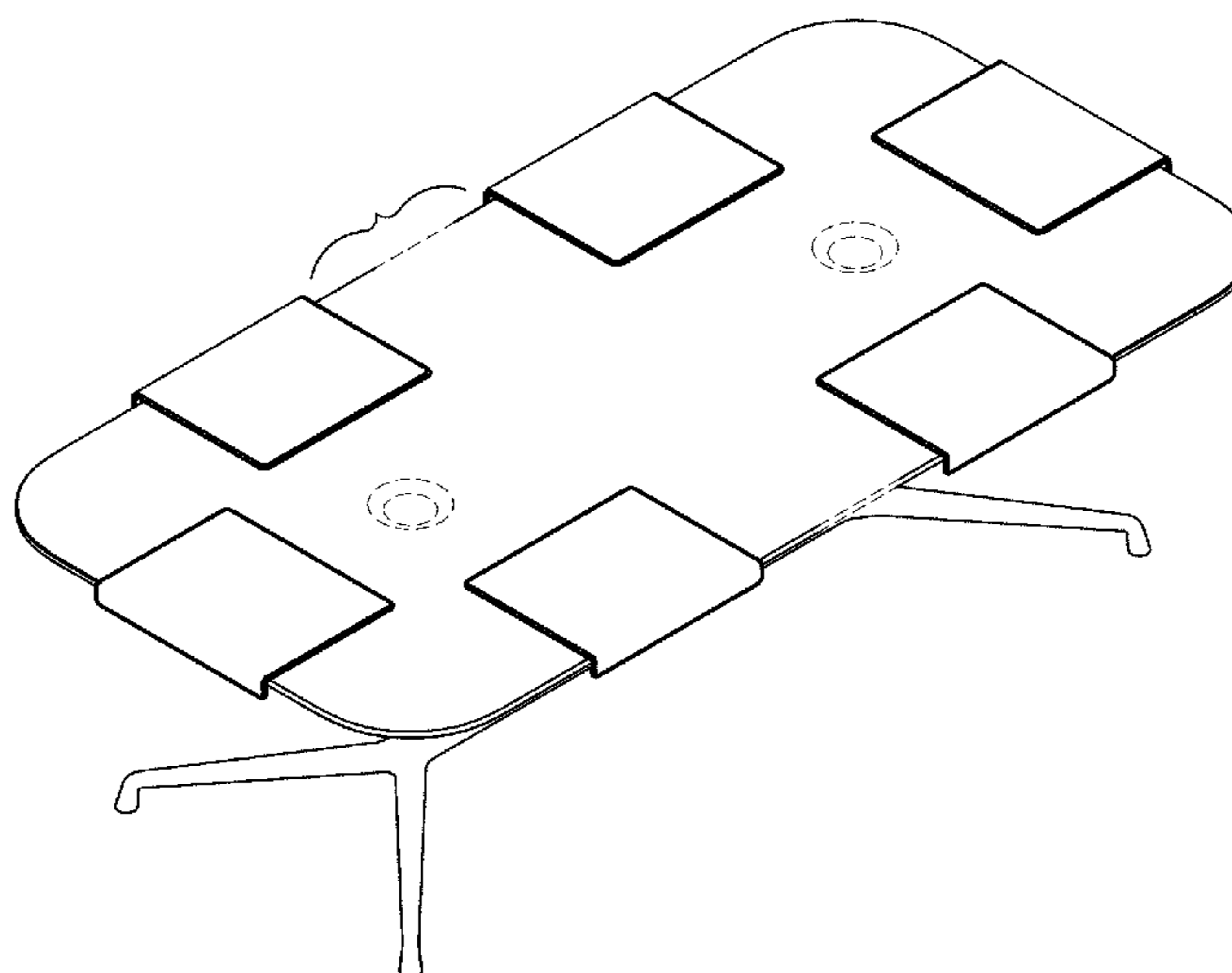
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the table embodying the present invention;
FIG. 2 is a first side elevational view of the table shown in FIG. 1;
FIG. 3 is a rear perspective view of the table shown in FIG. 1; and,
FIG. 4 is a second side elevational view of the table shown in FIG. 1.
Dashed lines and broken lines are for the purposes of illustrating environmental structure, and form no part of the claimed design.

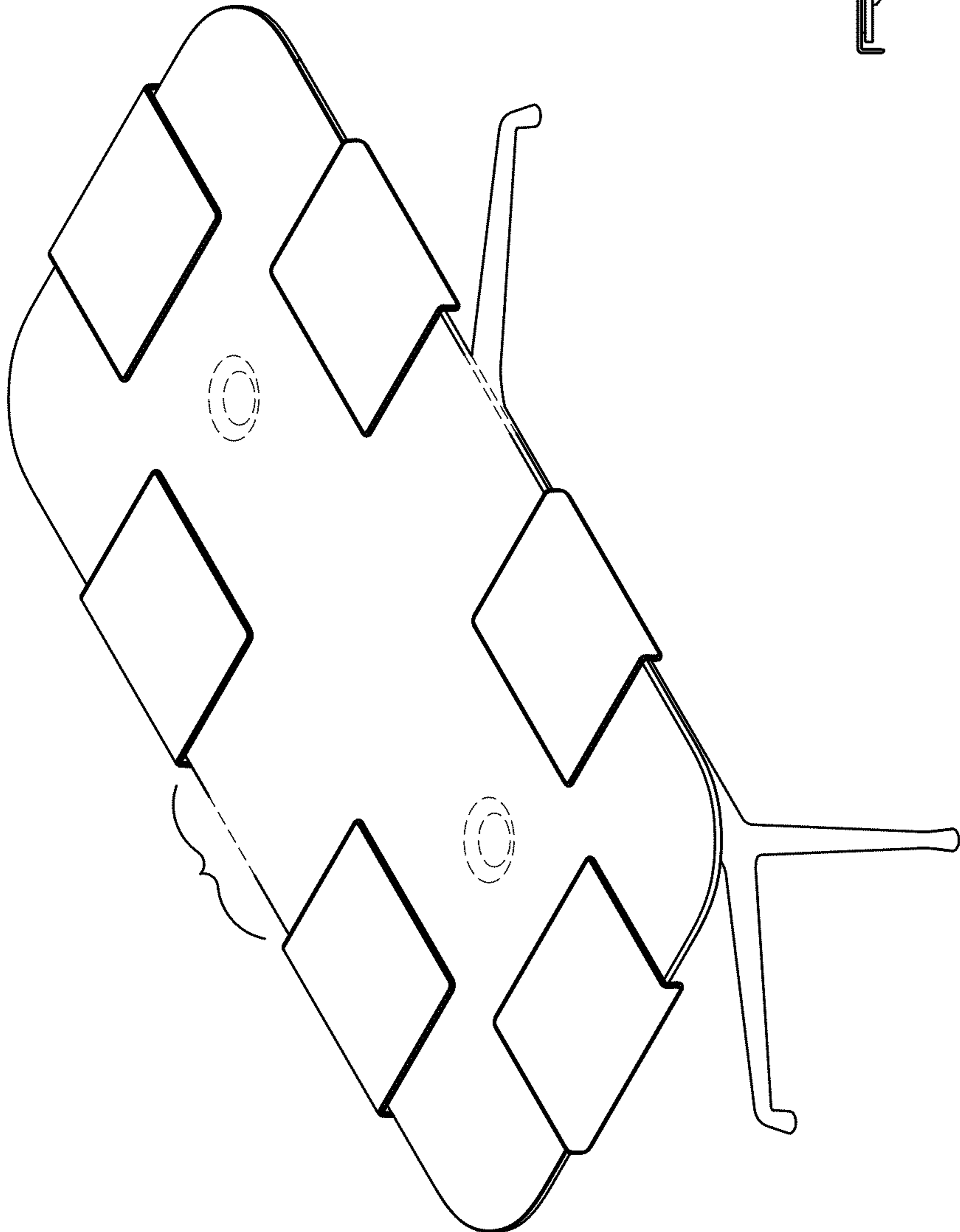

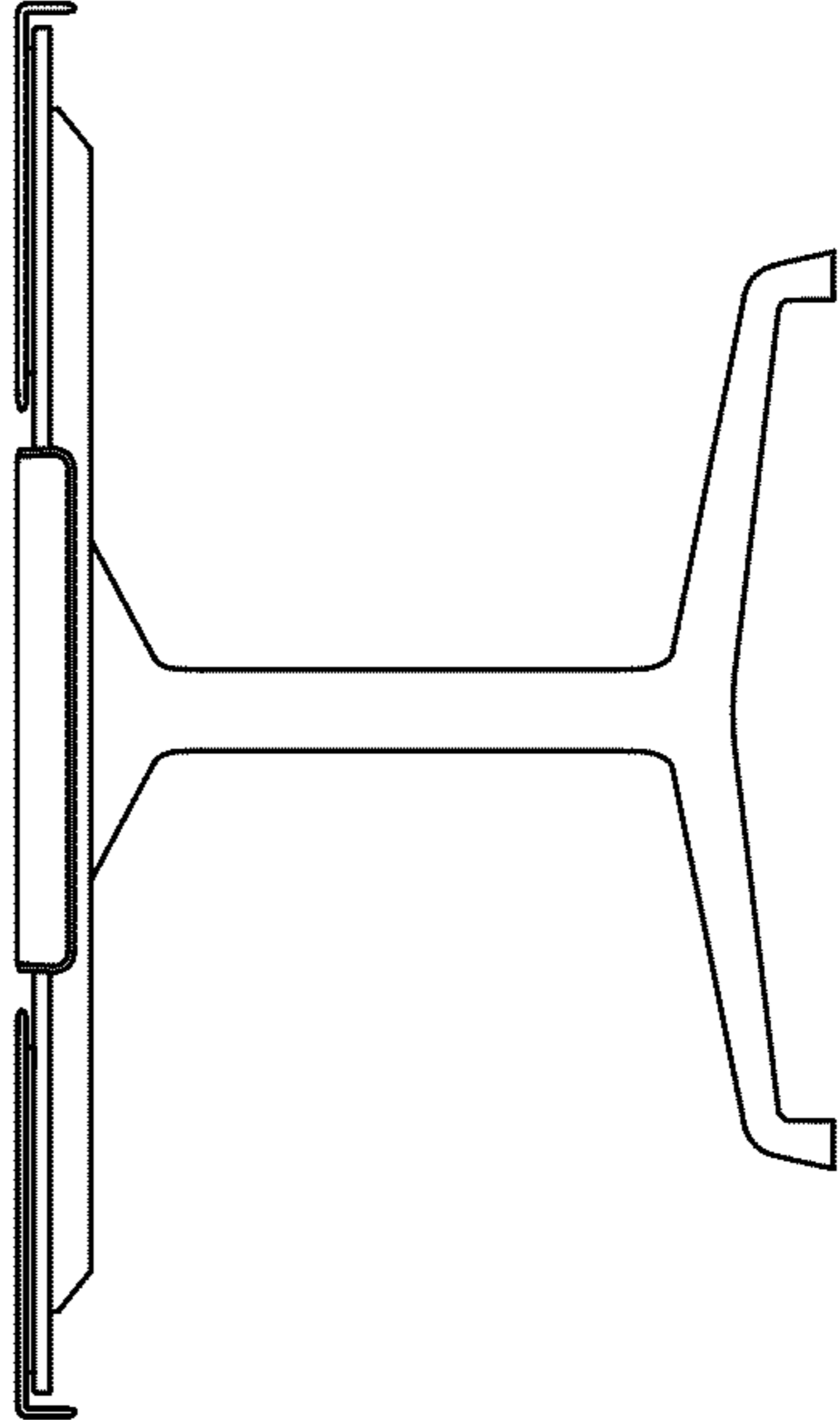

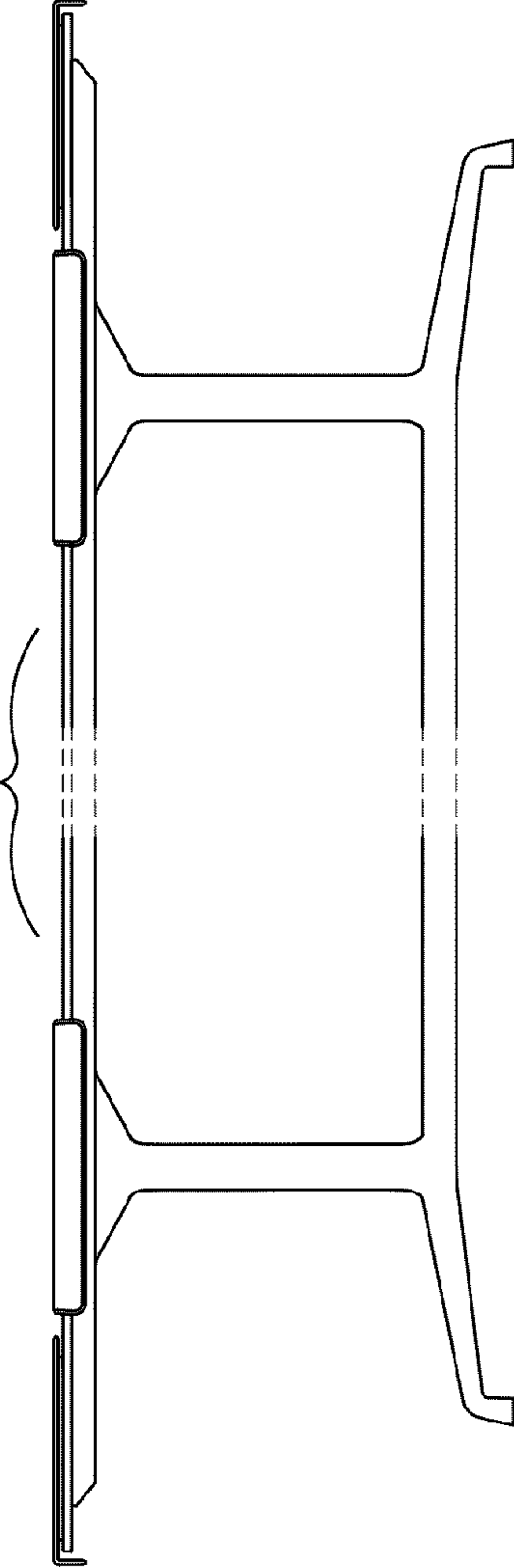

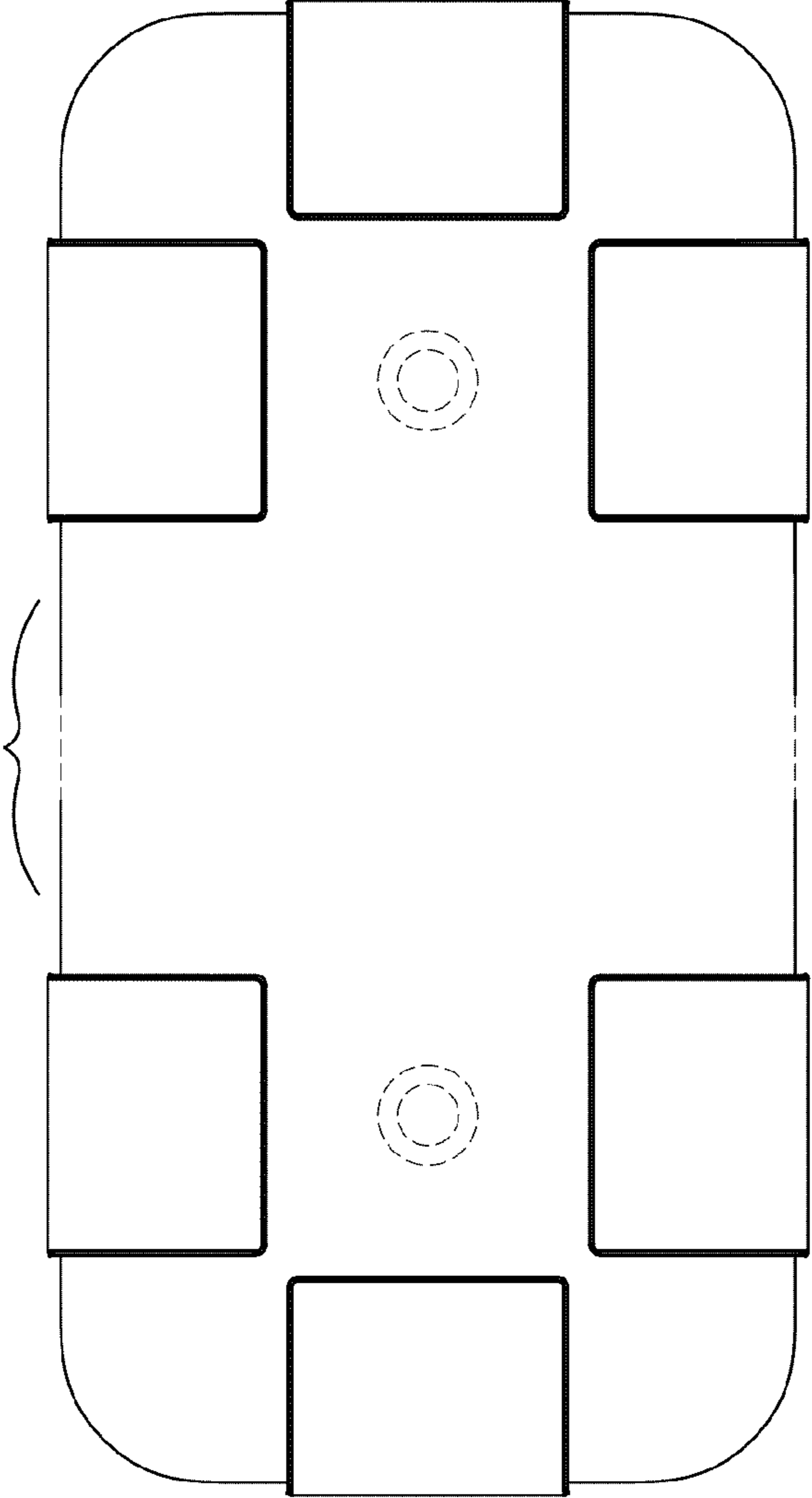
