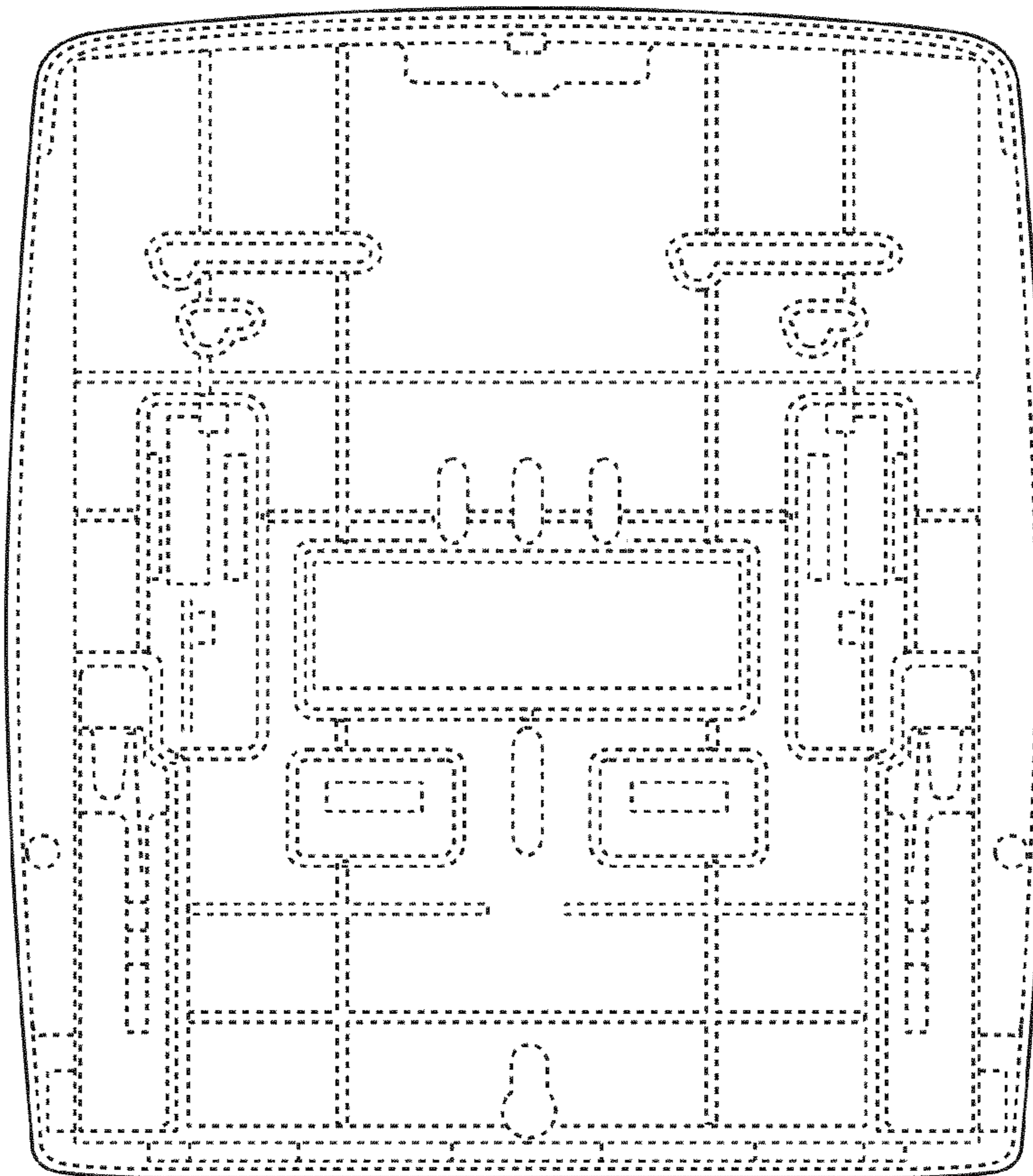
The ornamental design for a towel dispenser, as shown and described.

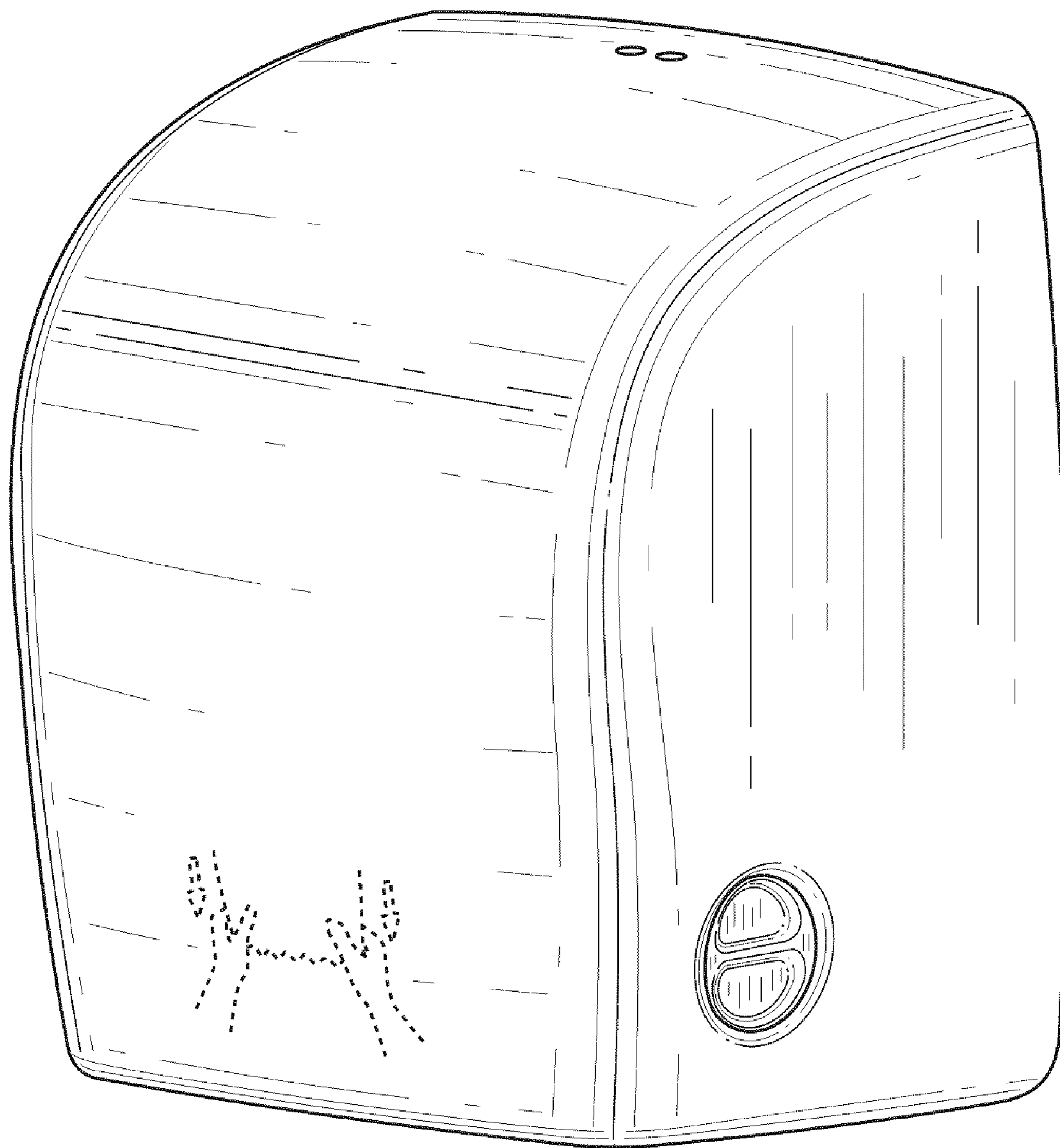
**DESCRIPTION**

FIG. 7 is a top plan view thereof.

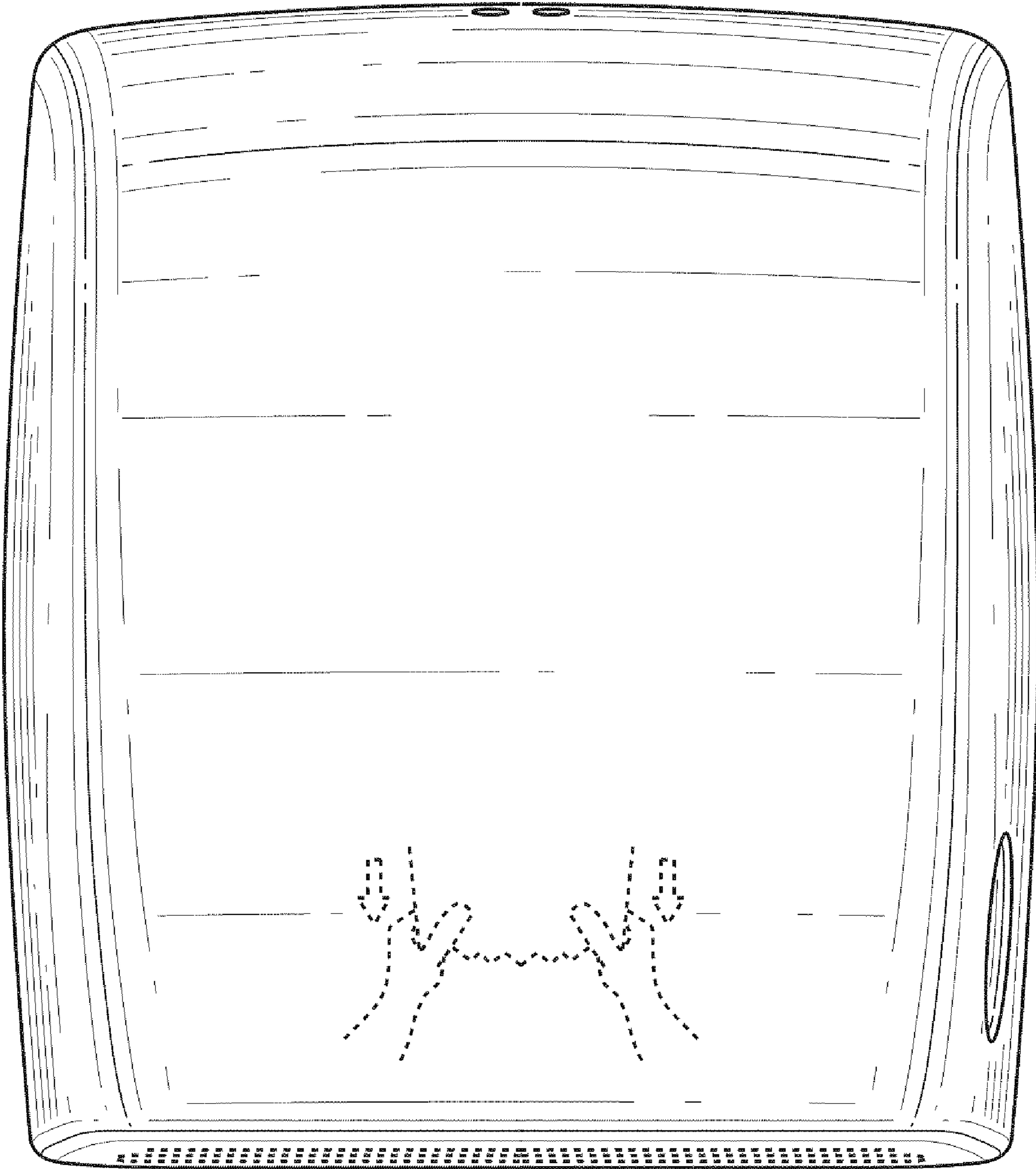
The broken line disclosure in the views represents portions of the article in which the claimed design is embodied, but which form no part of the claimed design.

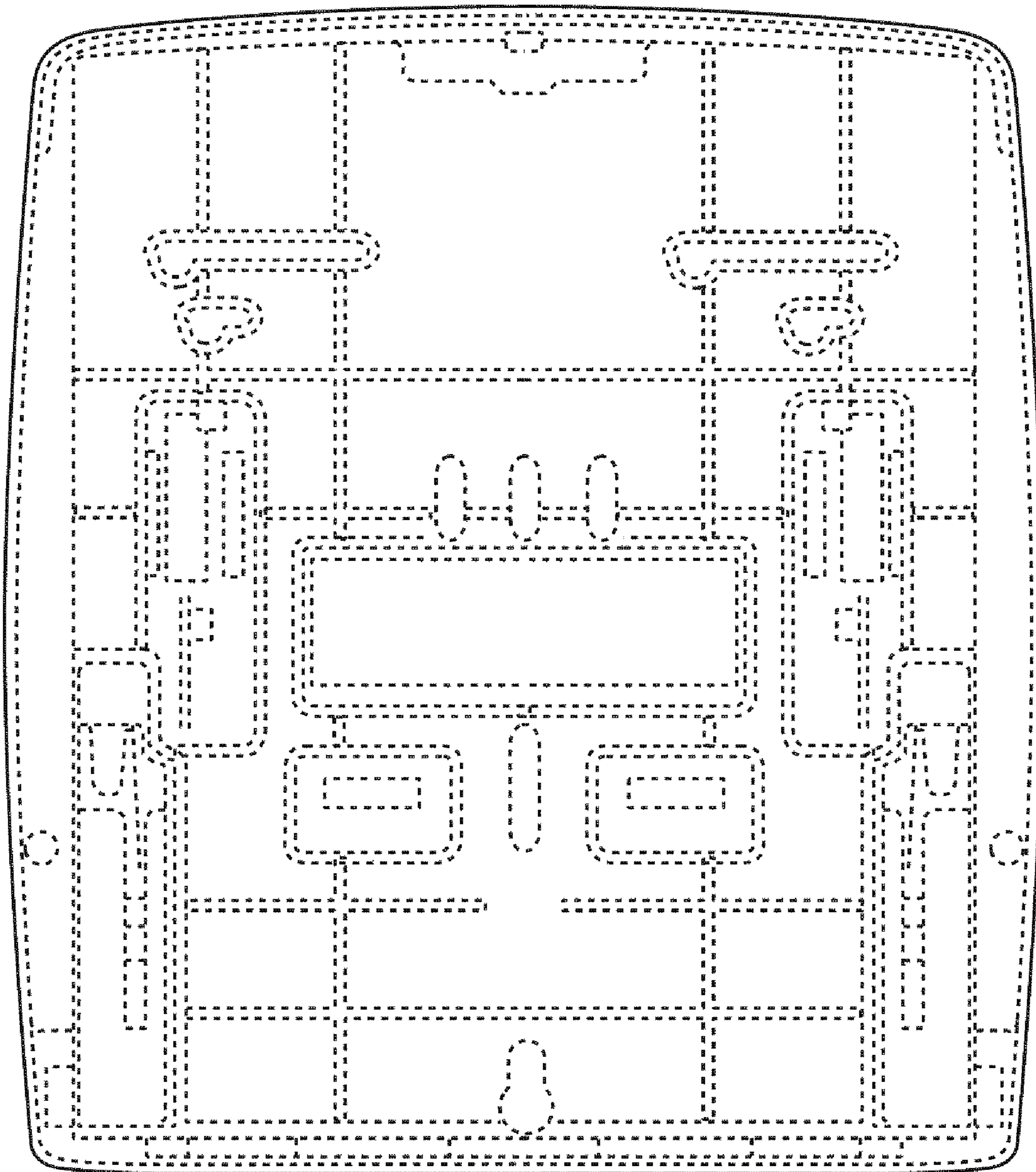

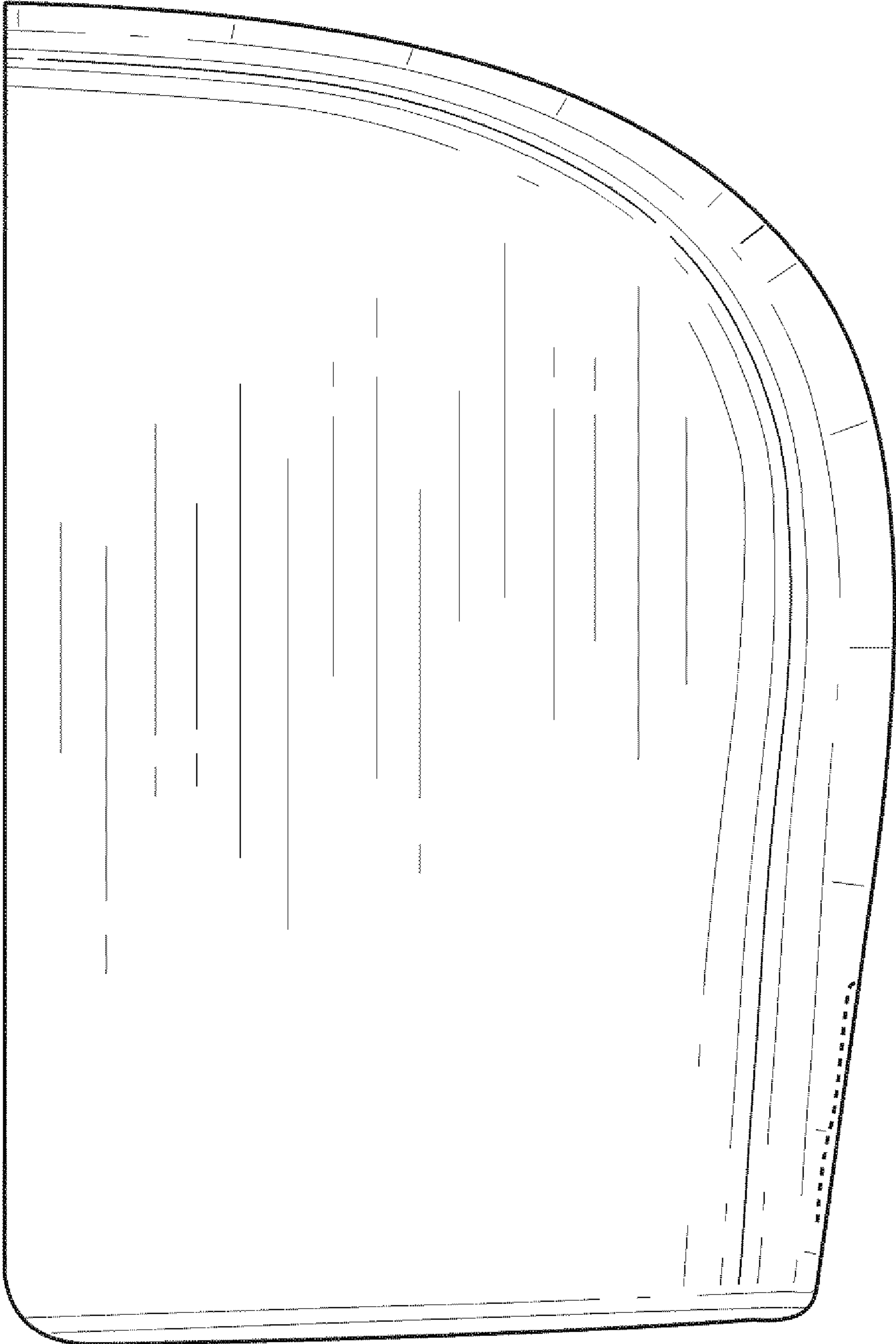

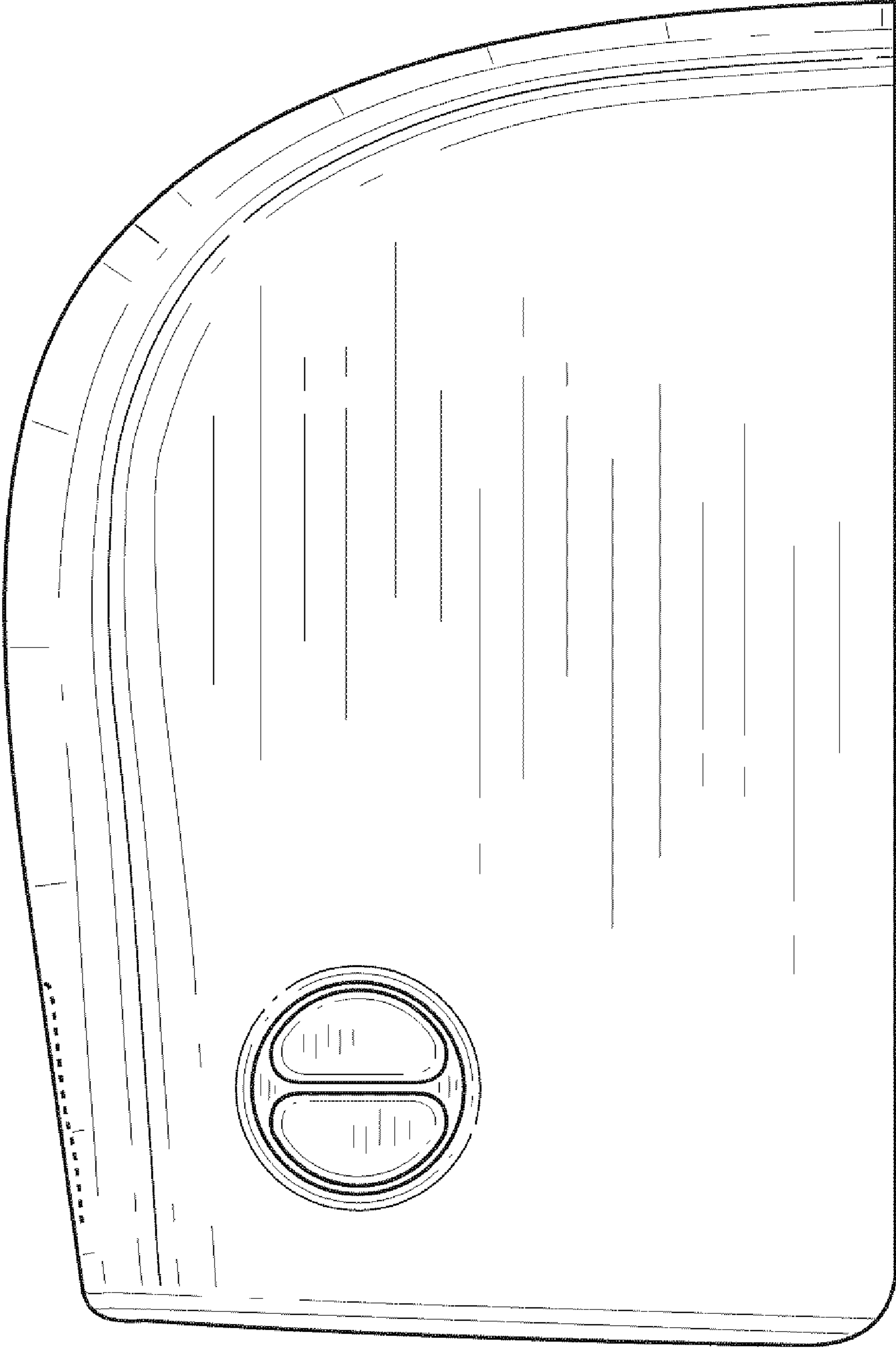




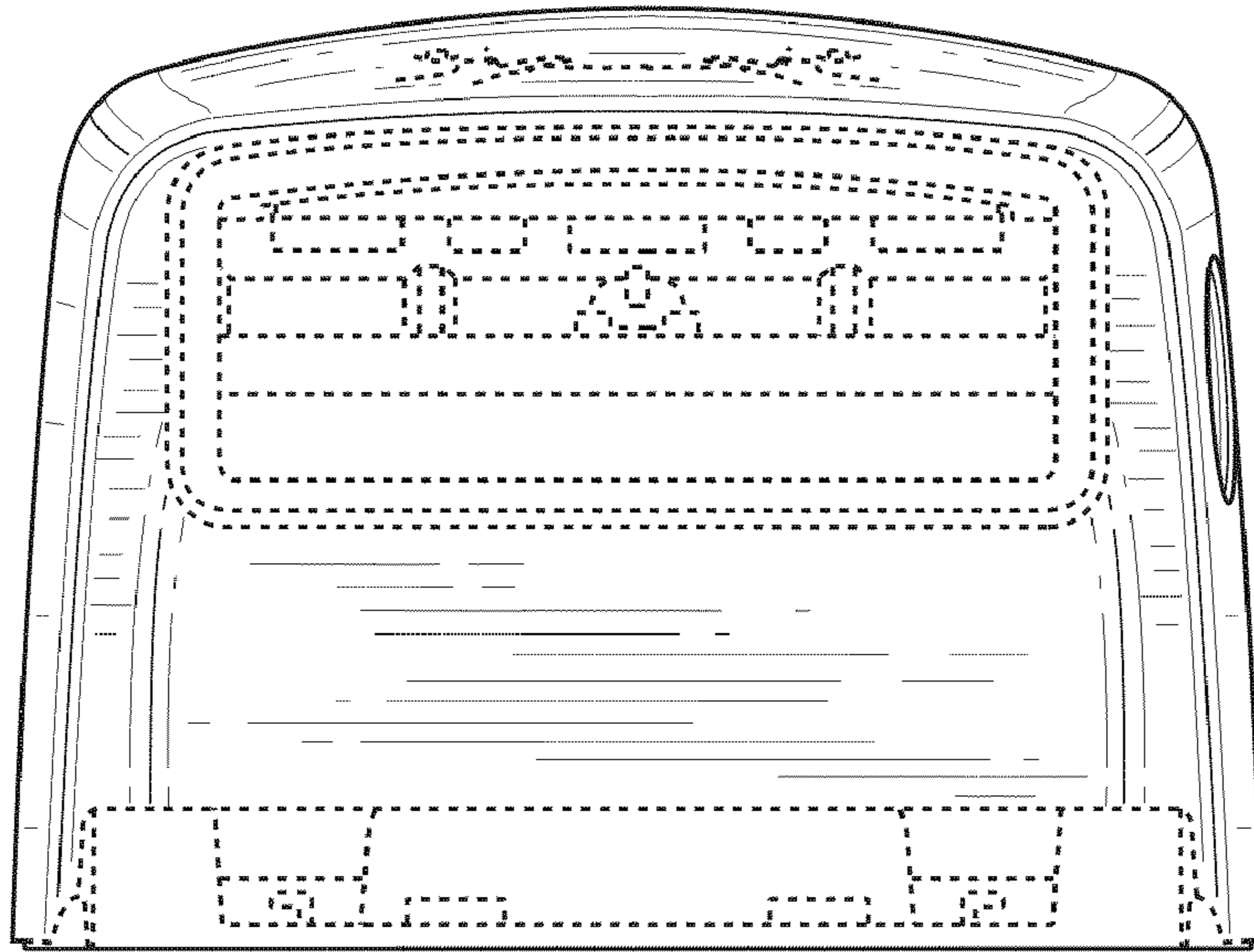

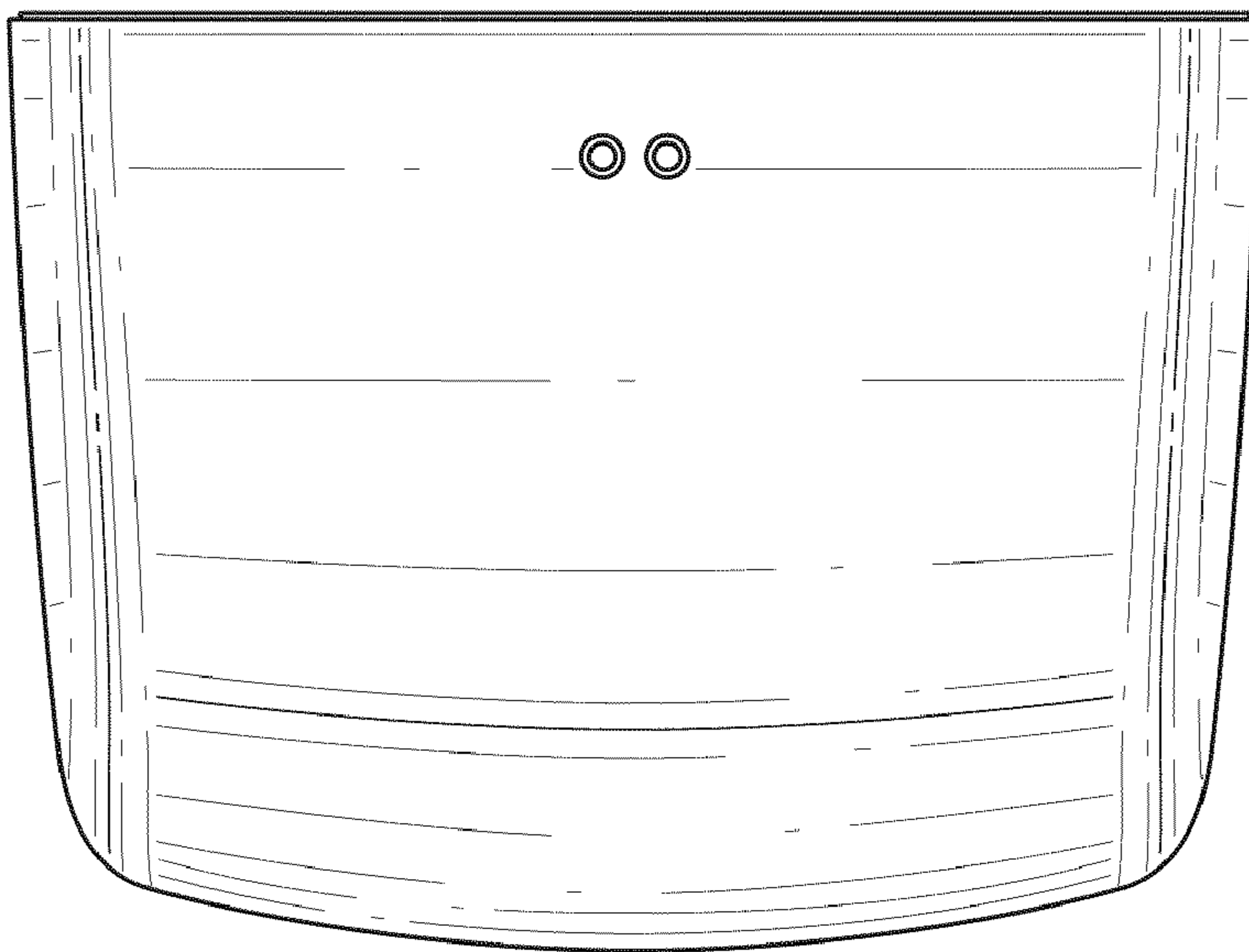
