The ornamental design for an appliance, as shown and described.

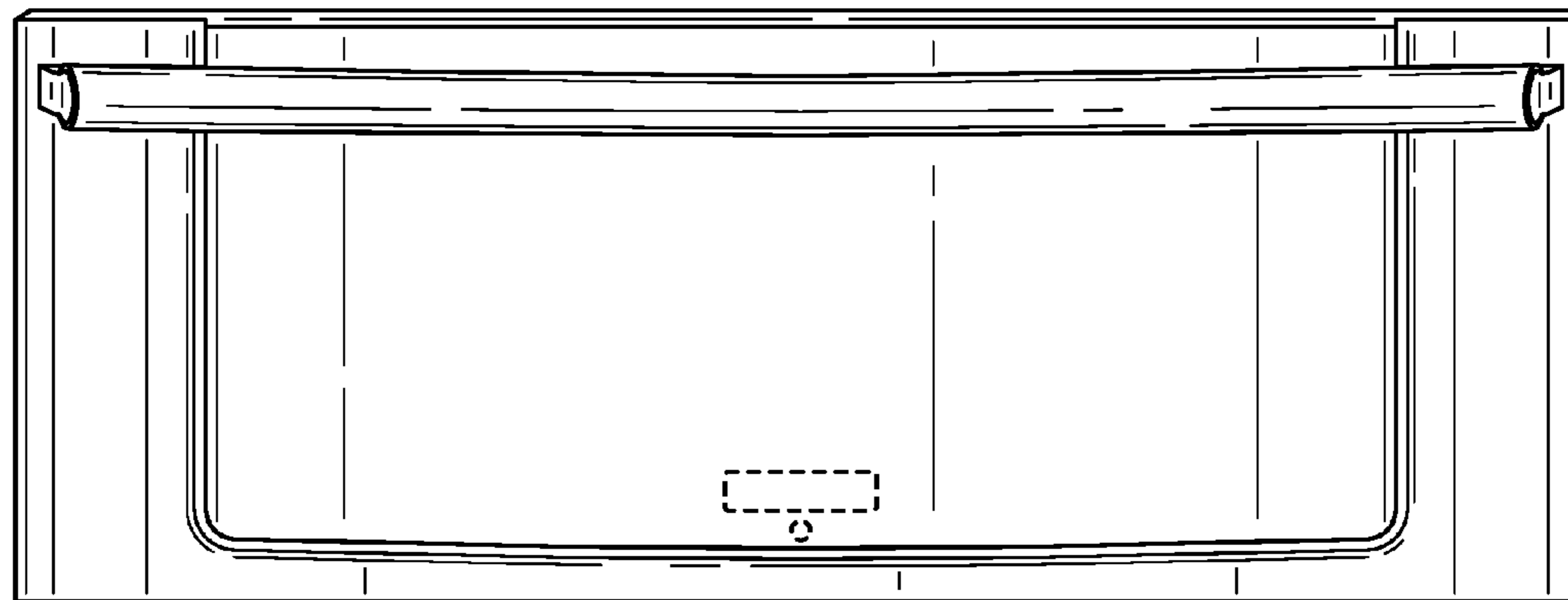
**DESCRIPTION**

FIG. 1 is a front view of a portion of an appliance showing our new design; and,

FIG. 2 is a perspective view thereof.

The unshown top, right side, bottom, and rear of the appliance forms no part of the claimed design. The broken line showing of a rectangle, a circle, and the rear portion of the appliance, including the unshaded areas therein, is for illustrative purposes only and forms no part of the claimed design.

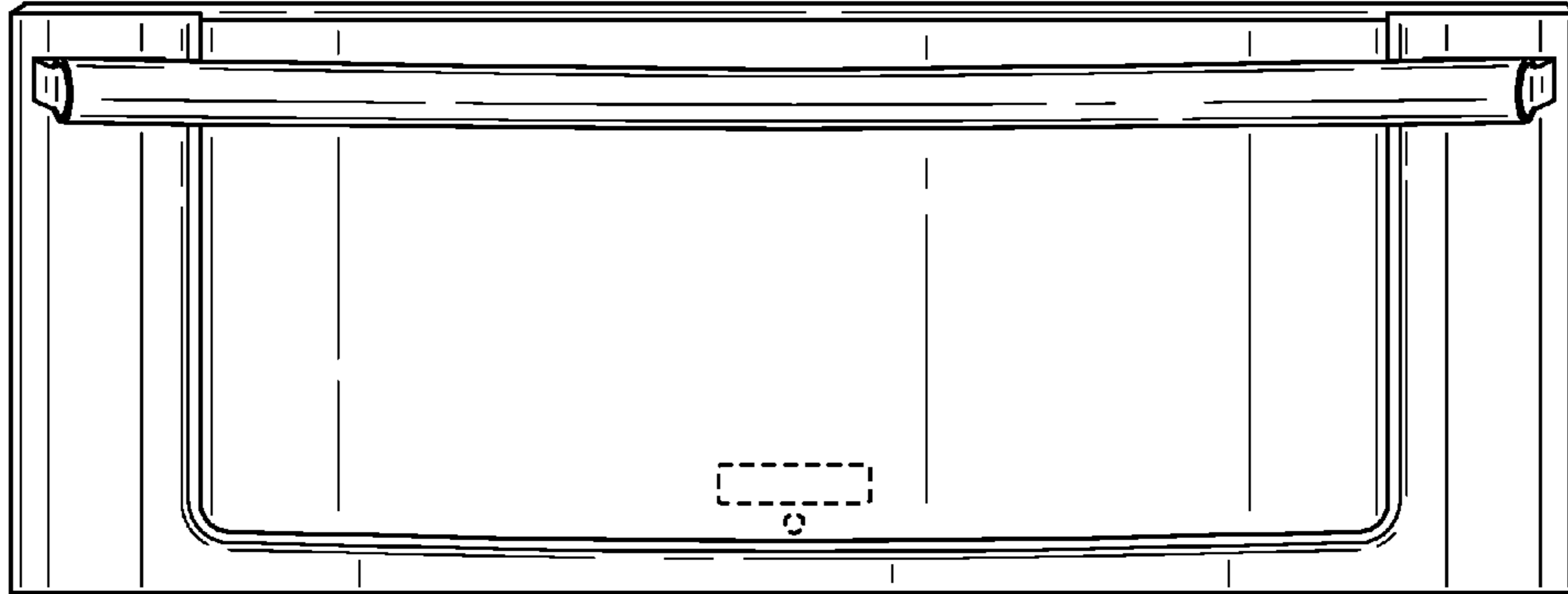

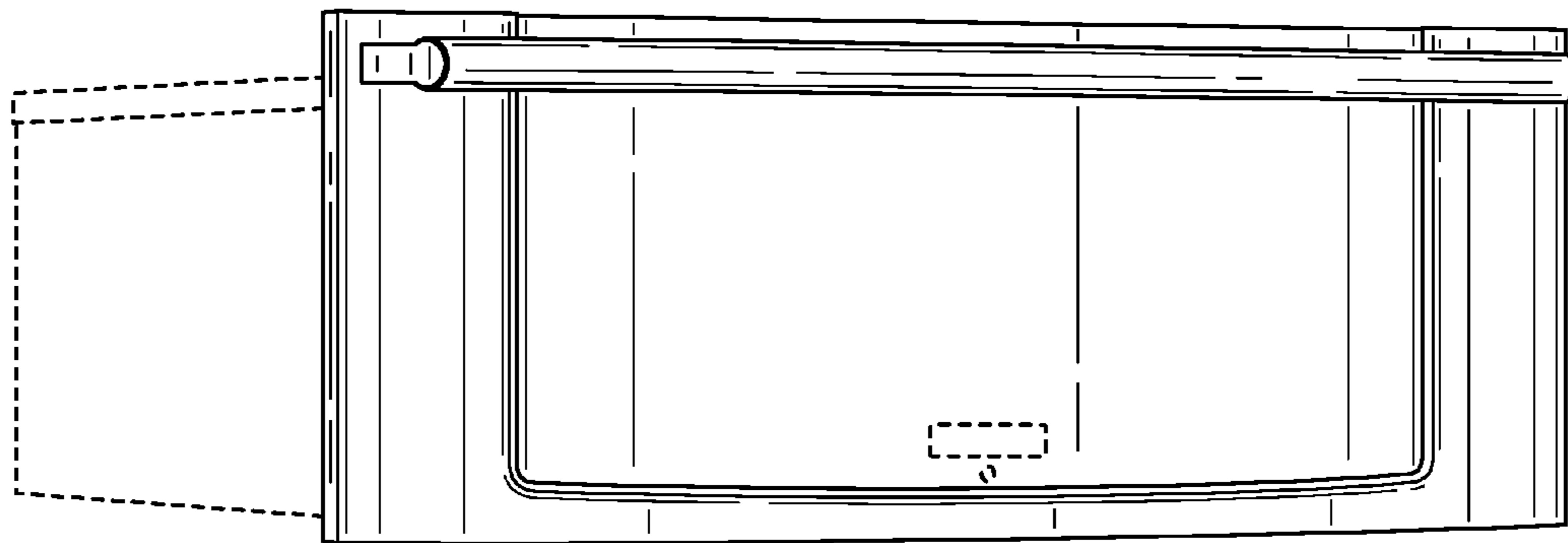
