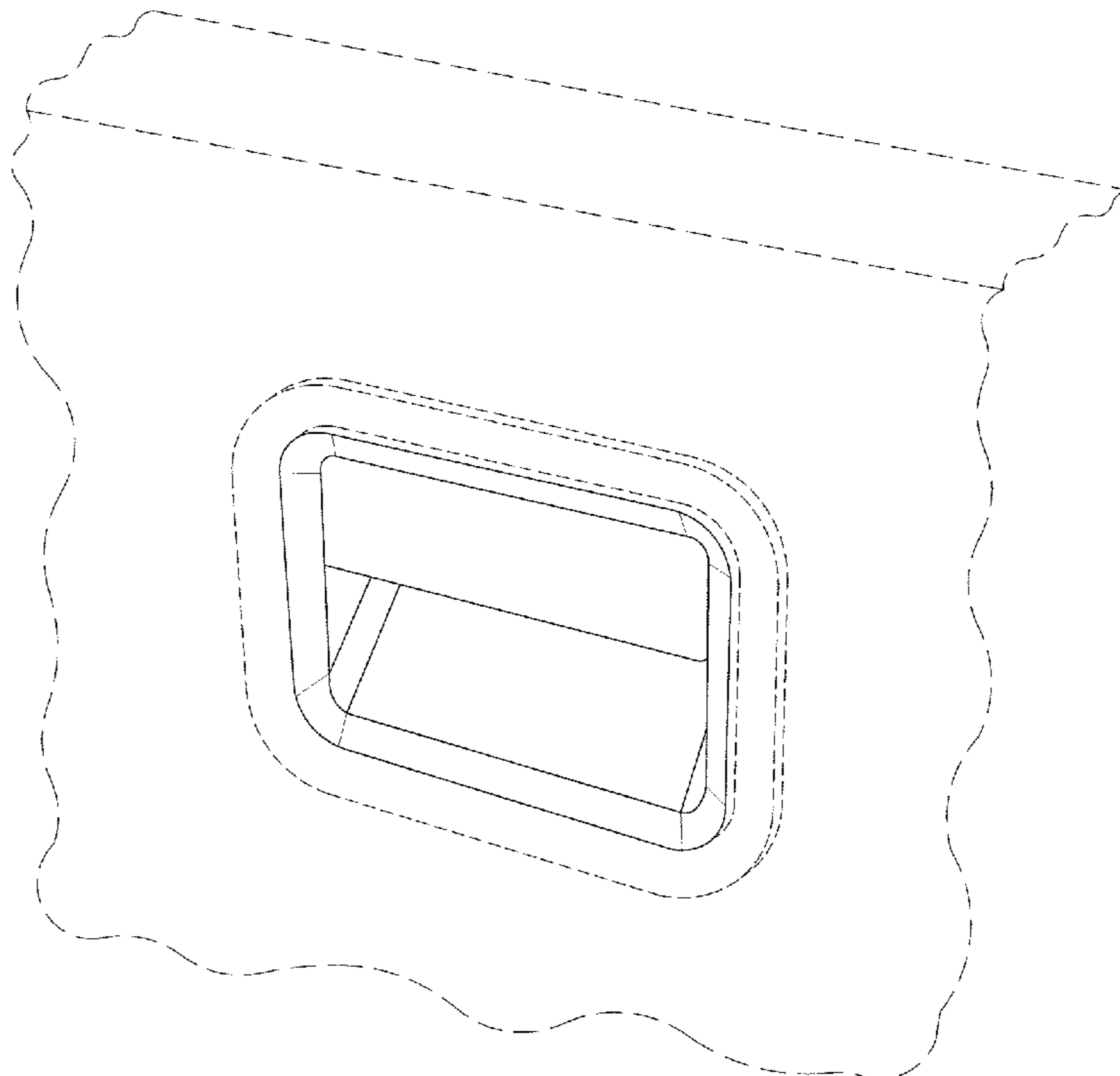
(57) **CLAIM**

I claim the ornamental design for an appliance door latch, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an appliance door latch show-  
ing my new design, shown in environmental use;  
FIG. 2 is an enlarged perspective view thereof.  
FIG. 3 is a front elevational view thereof; and,  
FIG. 4 is a side elevational view thereof, the other side eleva-  
tional view being a mirror image thereof.  
The broken lines are for illustrative purpose only and form no  
part of the claimed design.

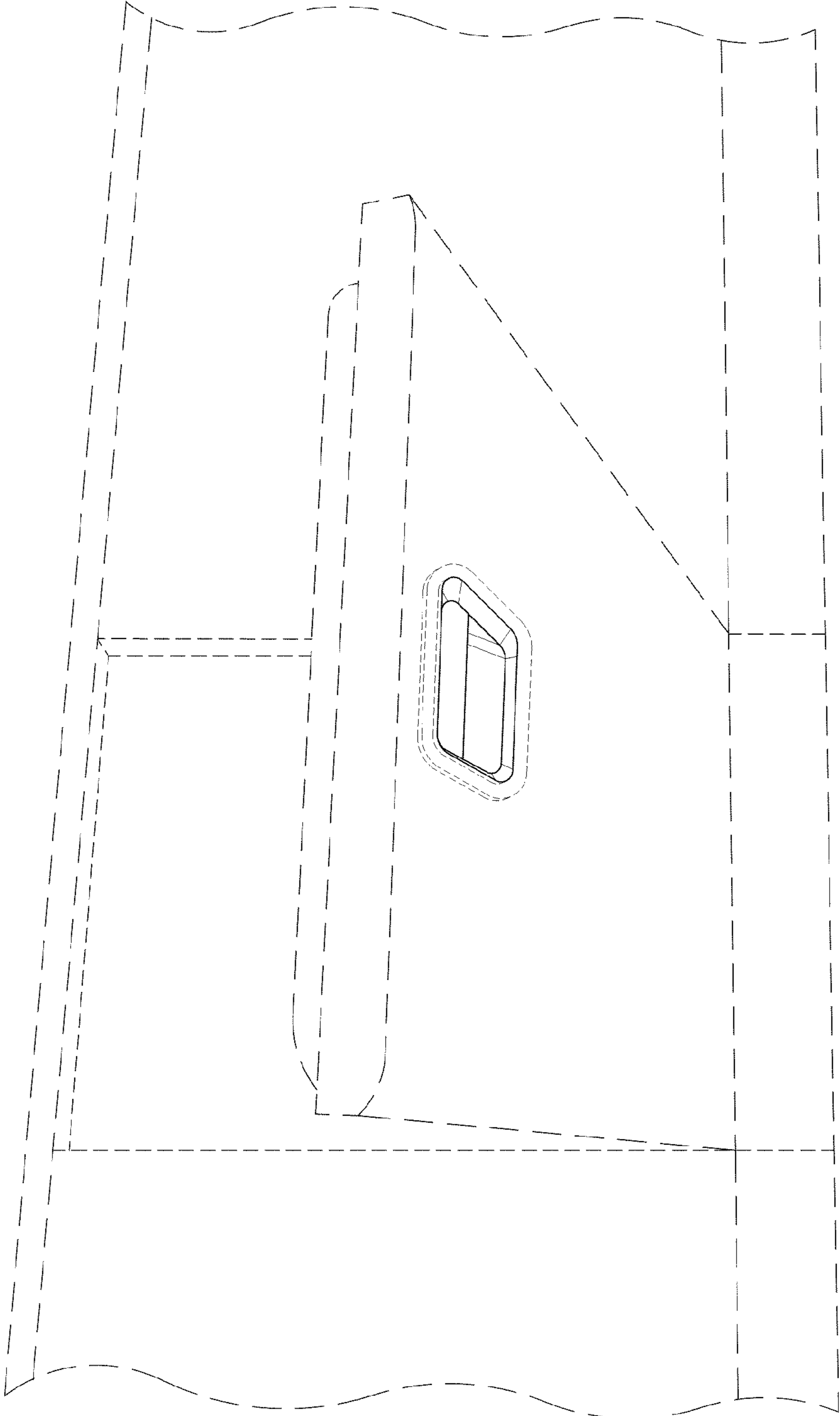

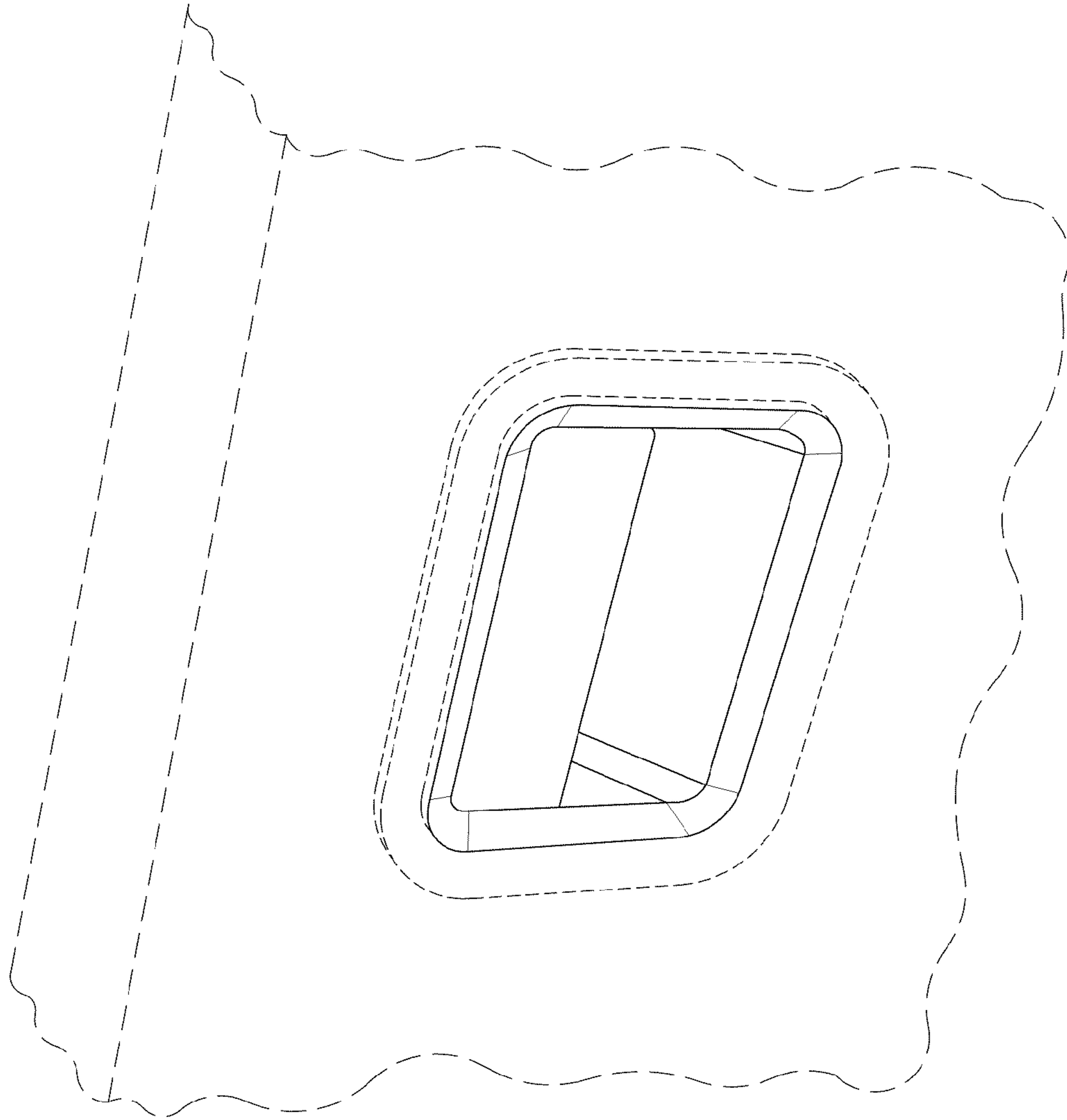

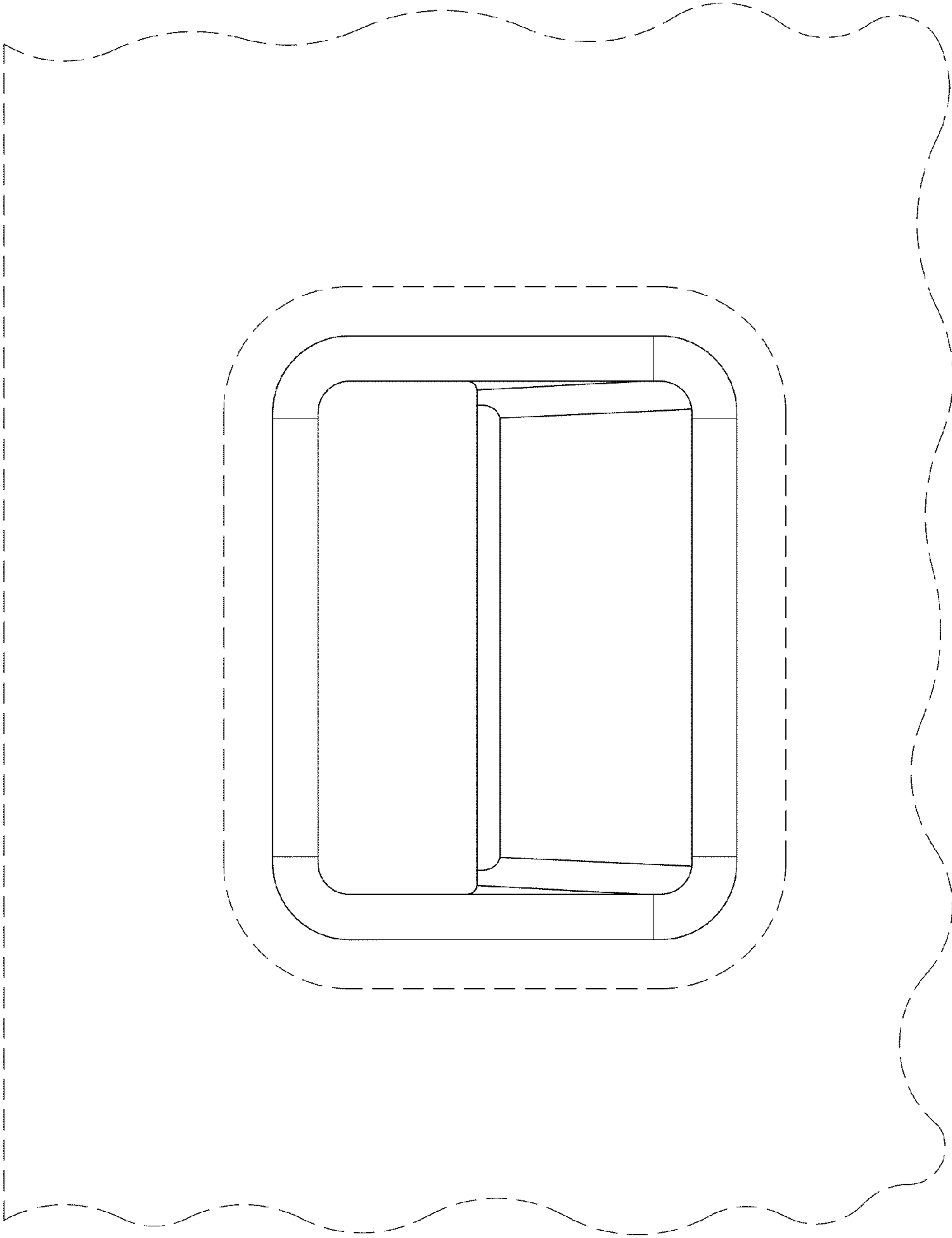

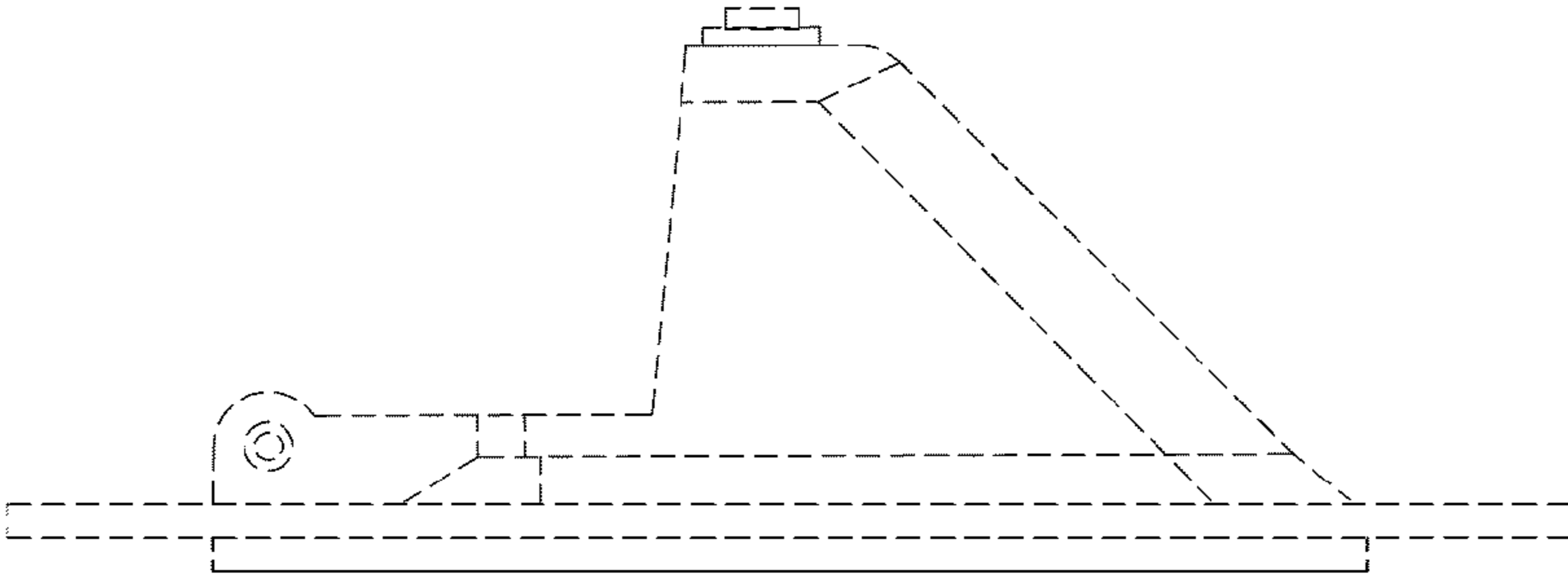
