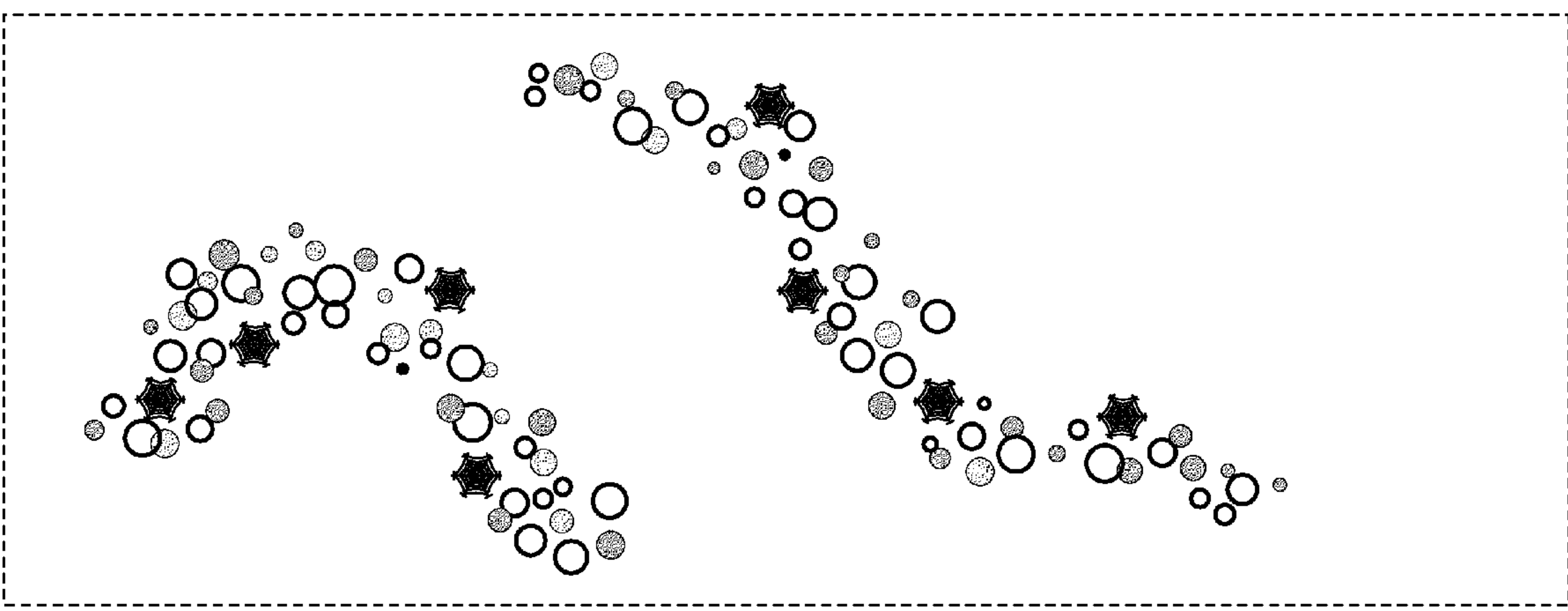
(57) **CLAIM**
The ornamental design for a container label, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a container label incorporating our new design shown in gray scale representing any color; FIG. 2 is a perspective view of our new design applied on a bottle container; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIGS. 5 and 6 are side elevational views thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom view thereof.
The broken lines shown in the drawings depict environmental subject matter only and form no part of the claimed design.

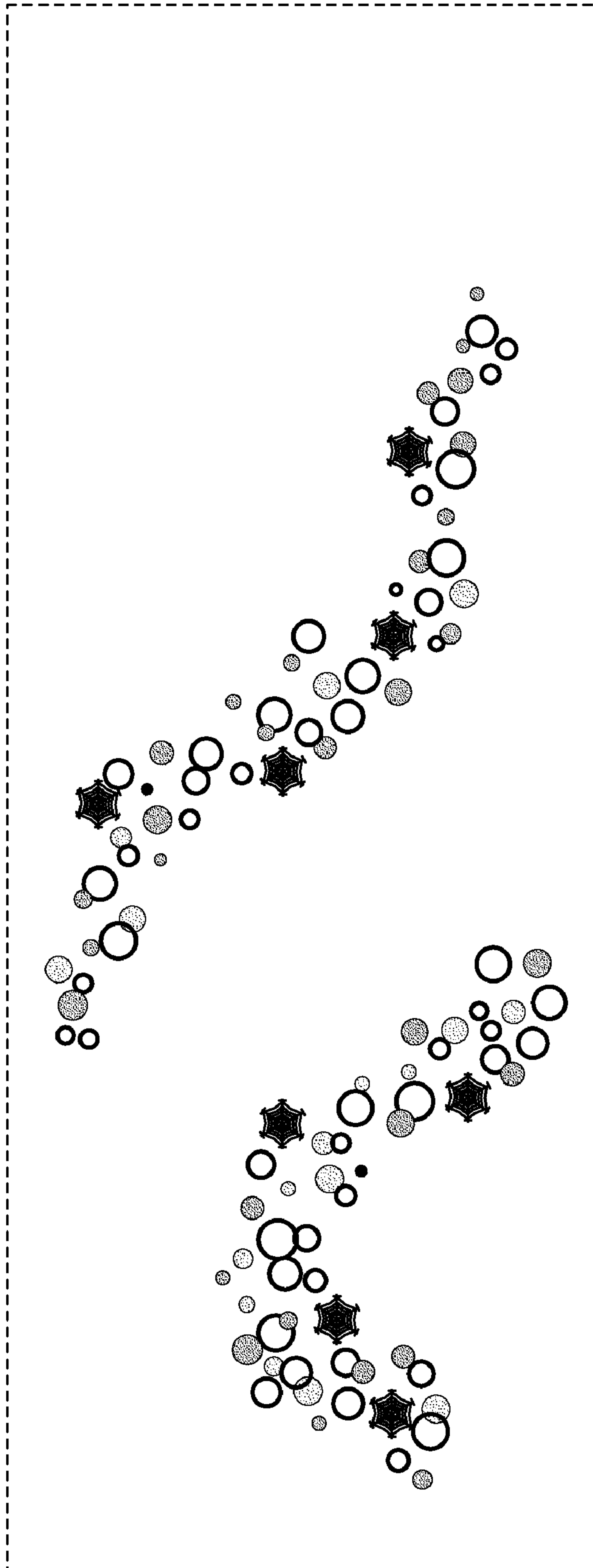

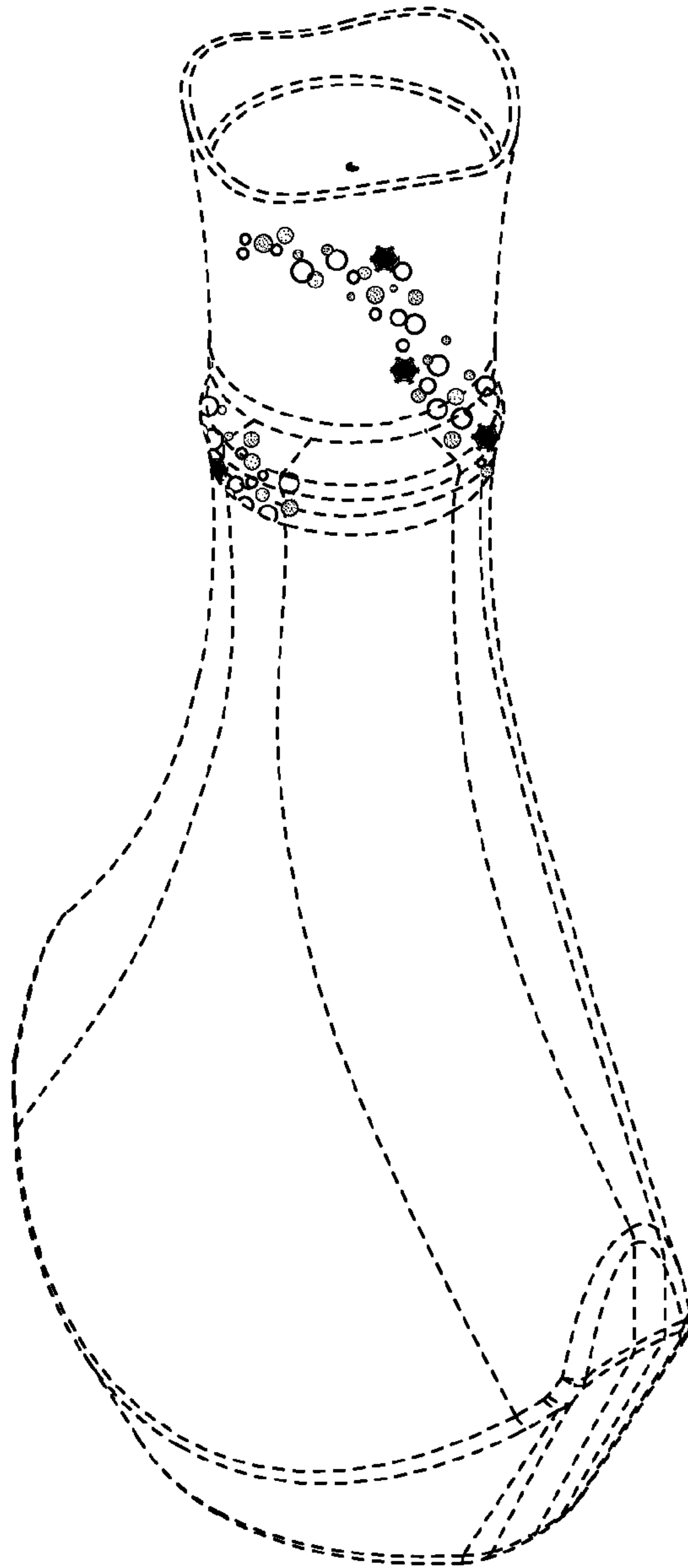

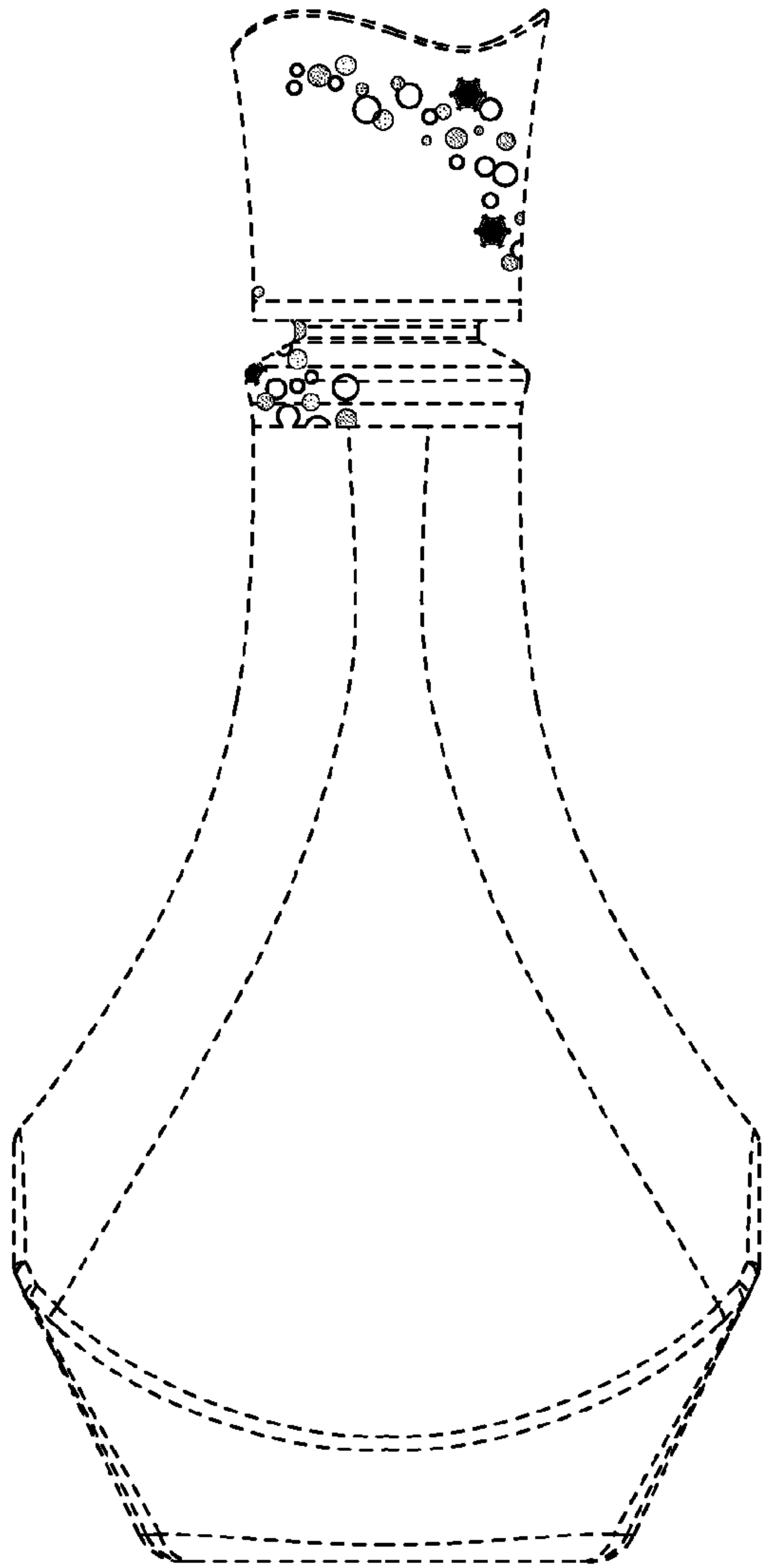

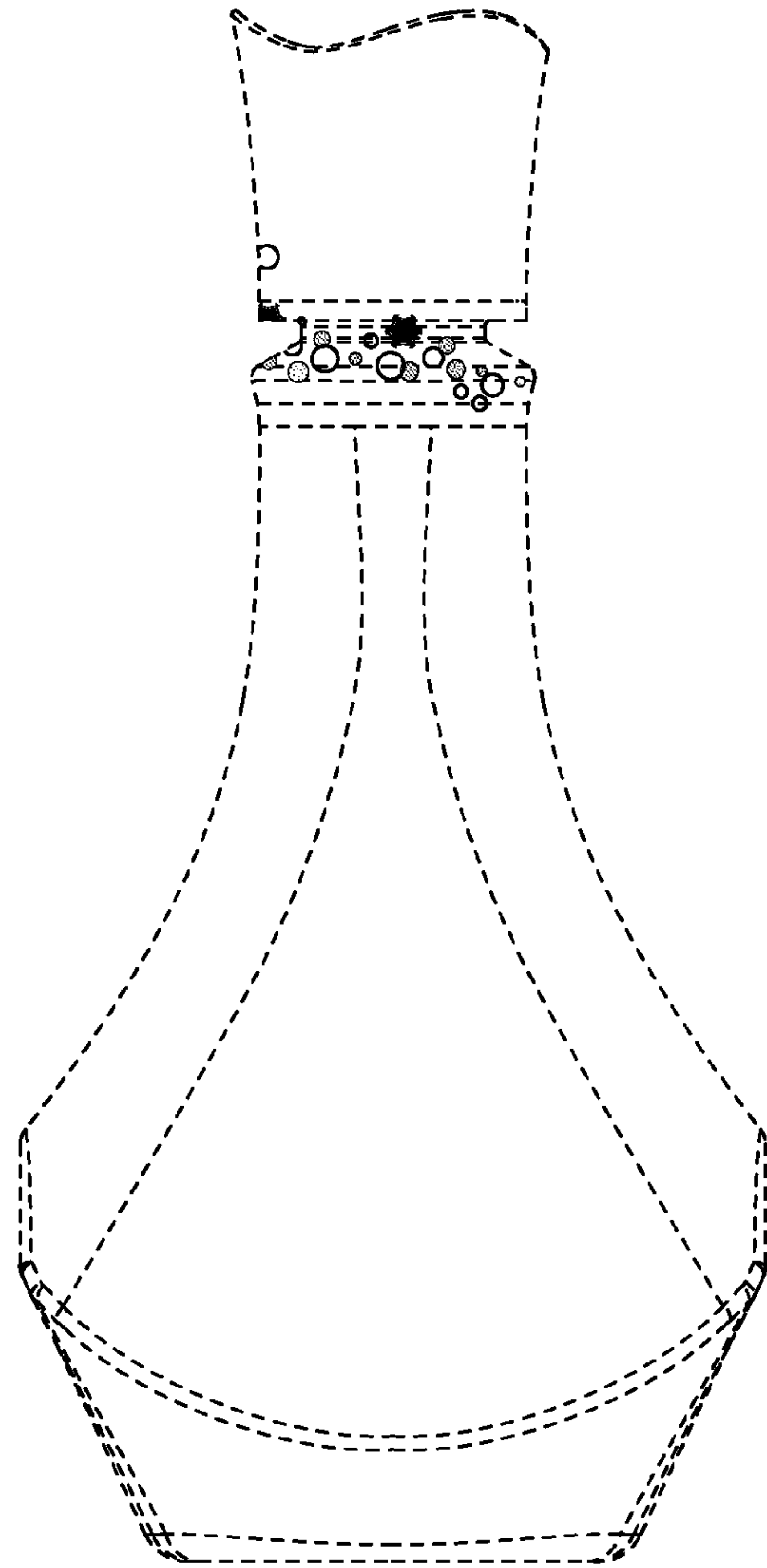

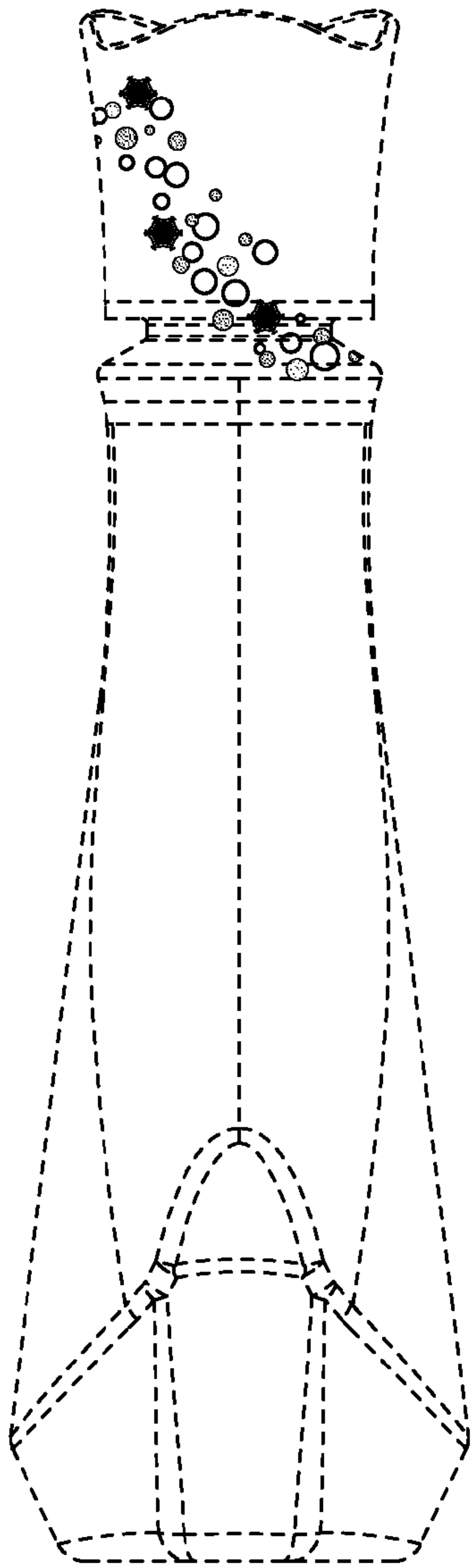

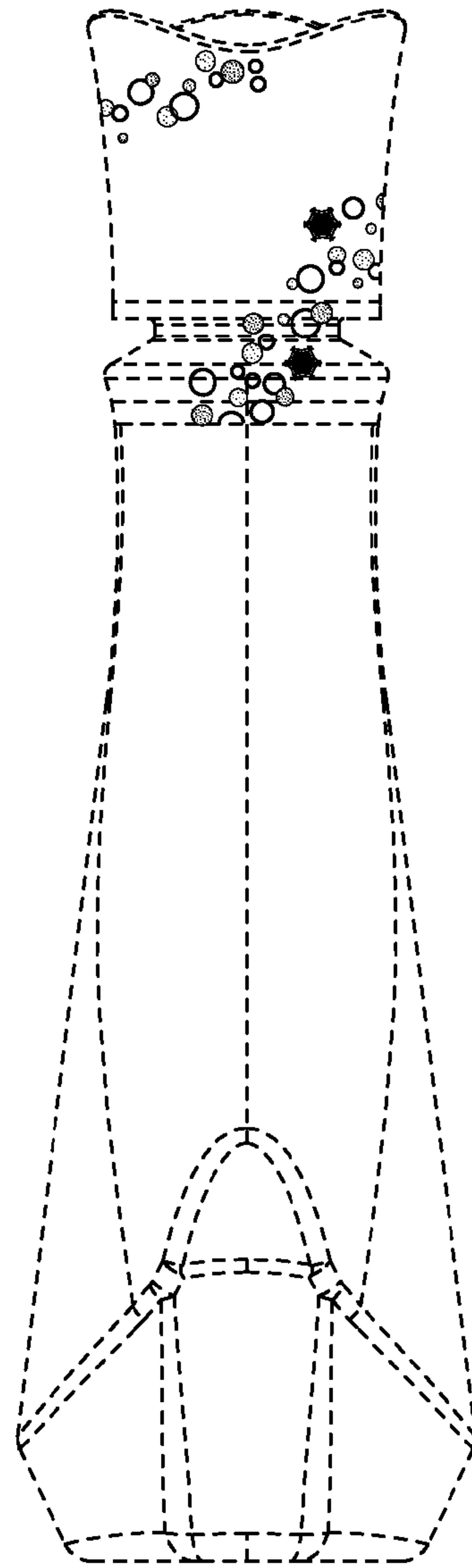

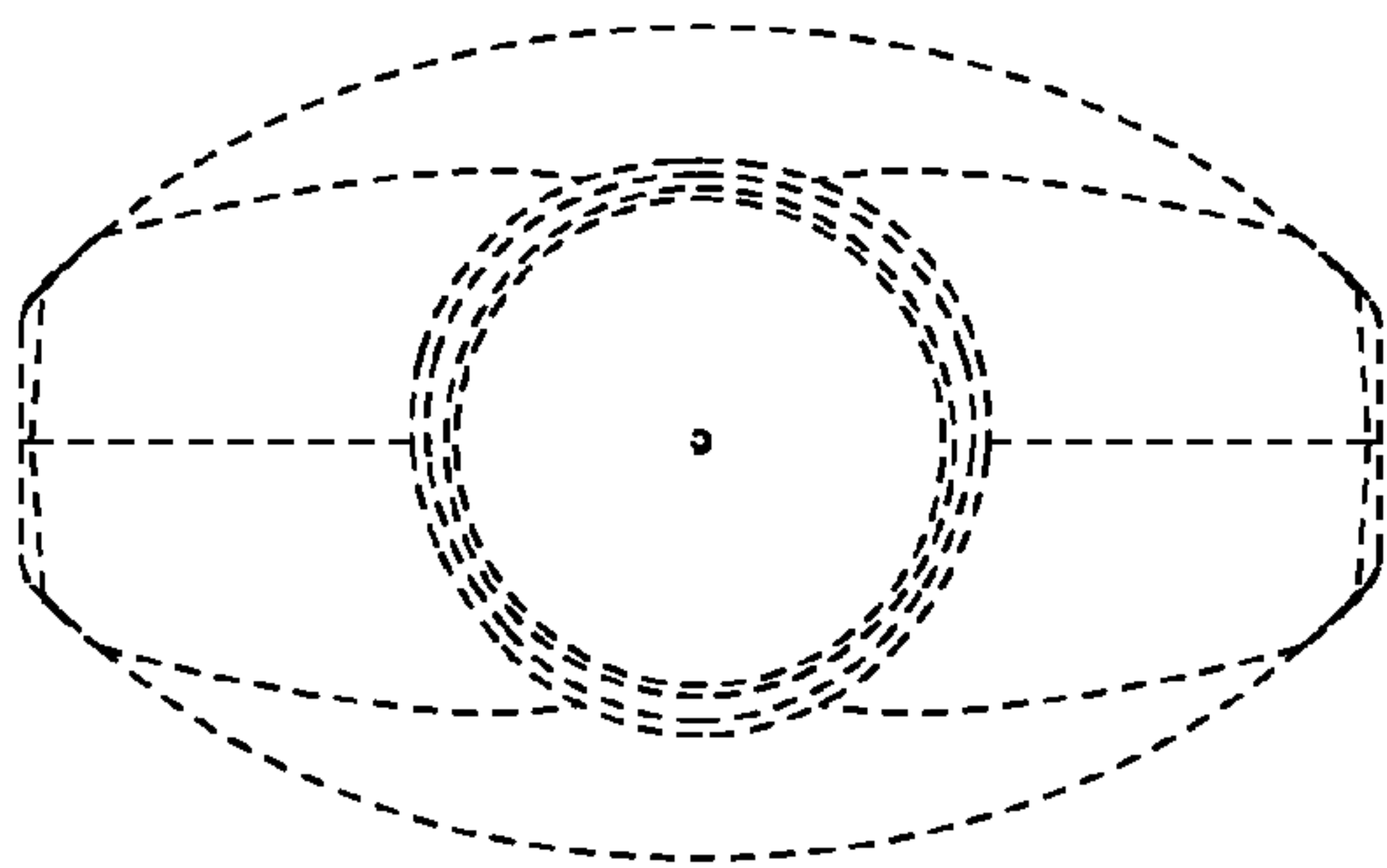

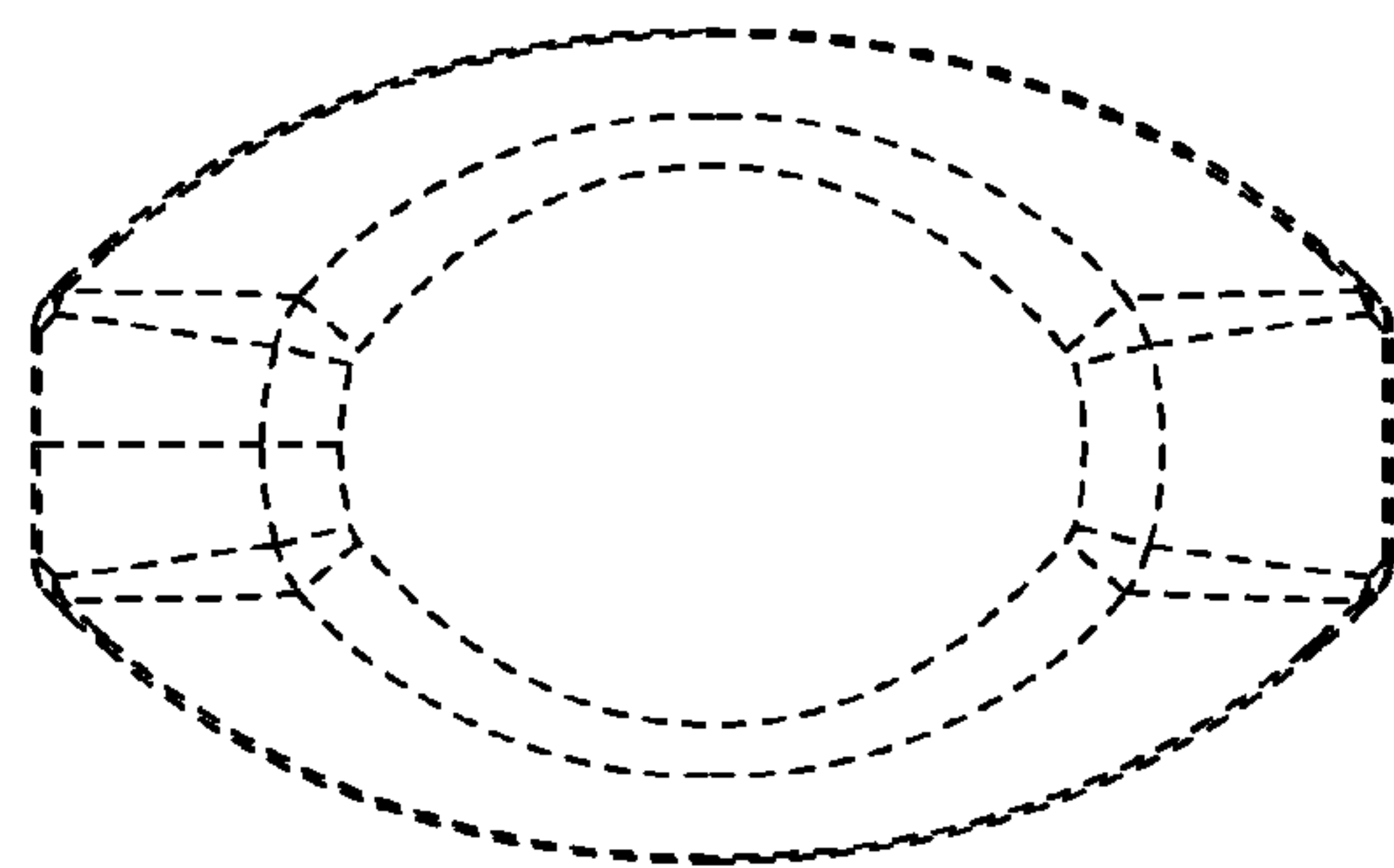
