(57) **CLAIM**

The ornamental design for a re-closable bag with integrated finger sleeves, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a bag with integrated finger sleeves showing the top and front sides thereof, the bag illustrated in a first condition;

FIG. 2 is a perspective view of the bag of FIG. 1, showing the bottom and front sides thereof, the bag illustrated in a first condition;

FIG. 3 is a front plan view of the bag of FIG. 1, the bag illustrated in a first condition;

FIG. 4 is a rear plan view of the bag of FIG. 1, the bag illustrated in a first condition;

FIG. 5 is a perspective view of the bag of FIG. 1, showing the top, left, and front sides thereof, the bag illustrated in a second condition;

FIG. 14 is a perspective view of the bag of FIG. 1, showing the front and left sides thereof, the bag illustrated in a fourth condition;

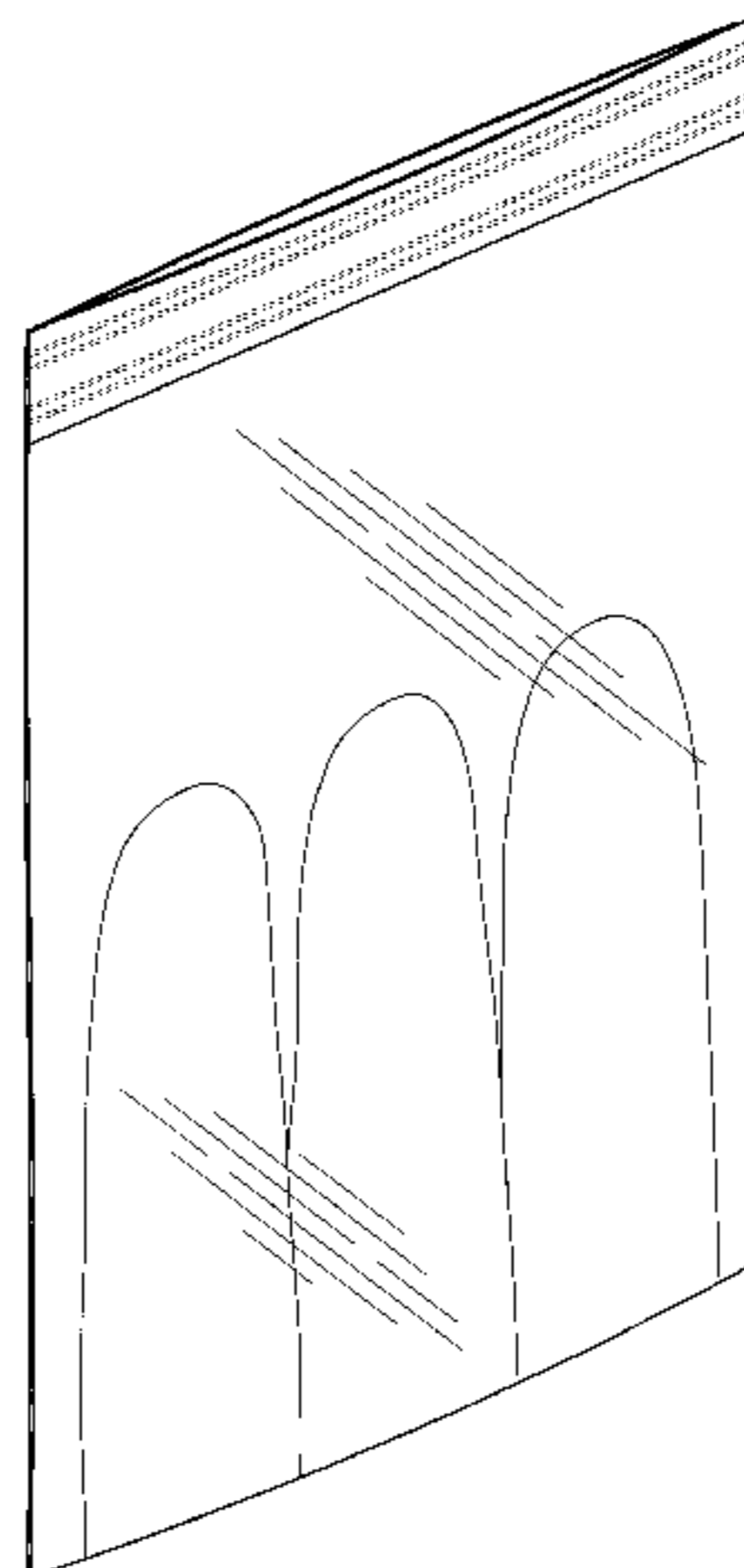
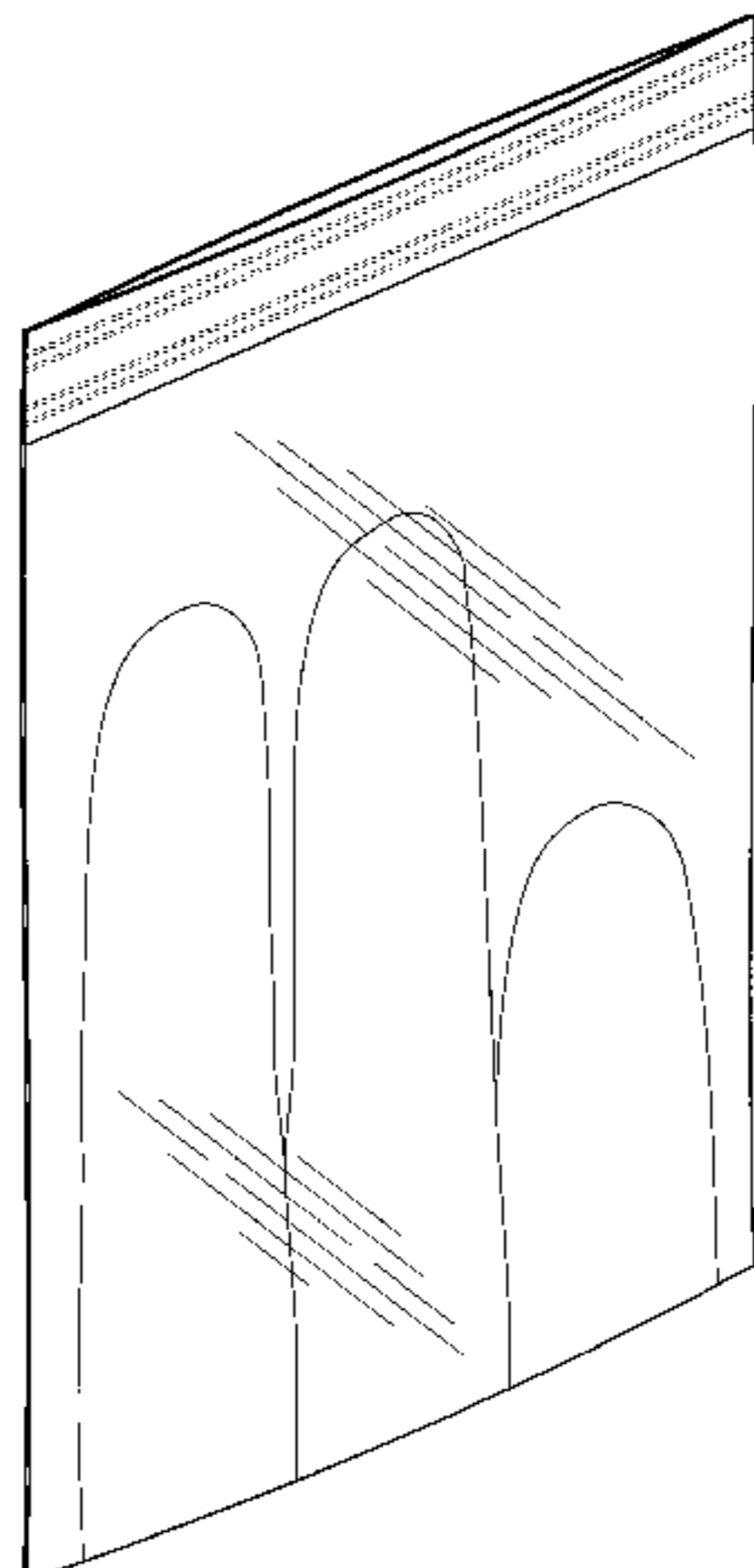


FIG. 15 is a front plan view of the bag of FIG. 1, the bag illustrated in a fourth condition;

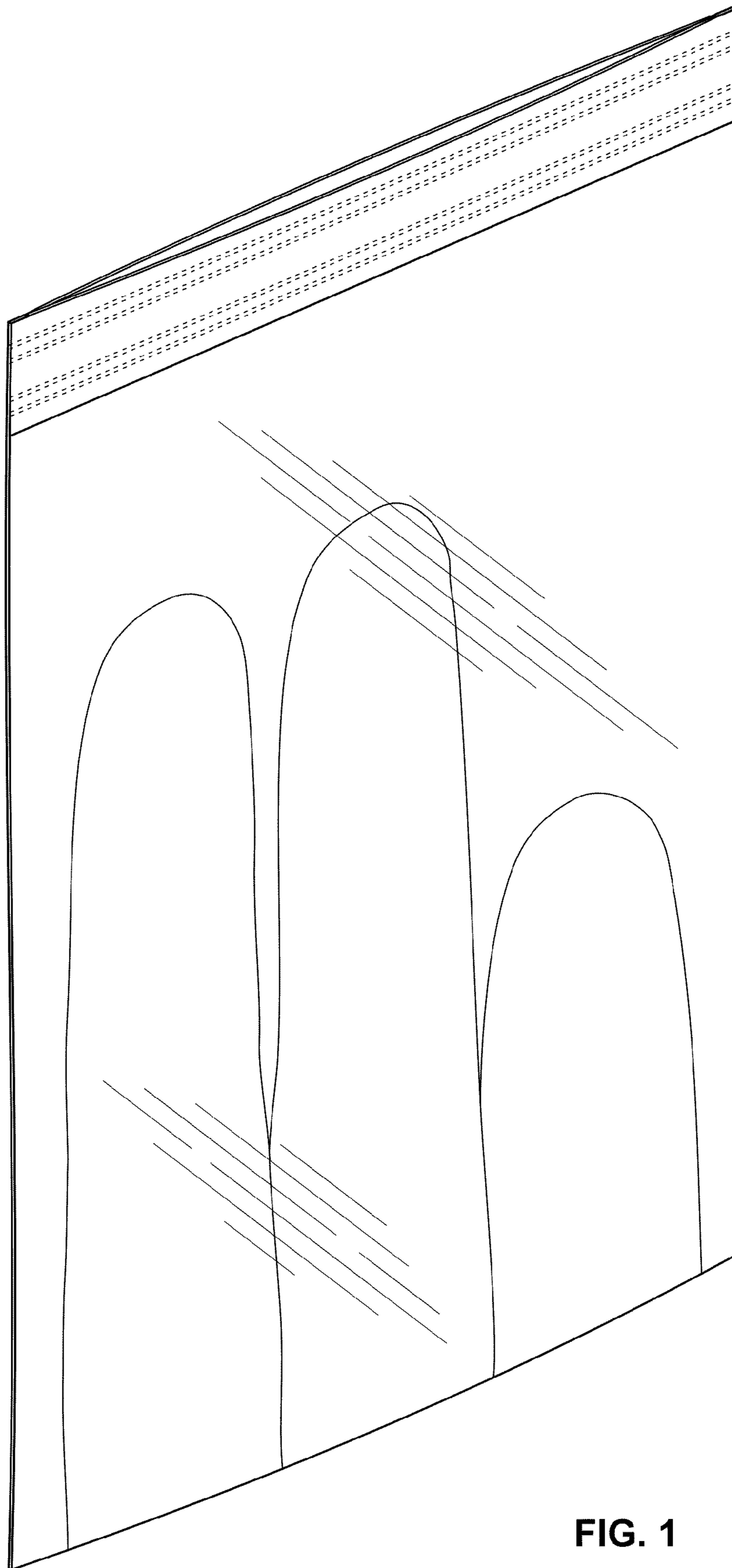

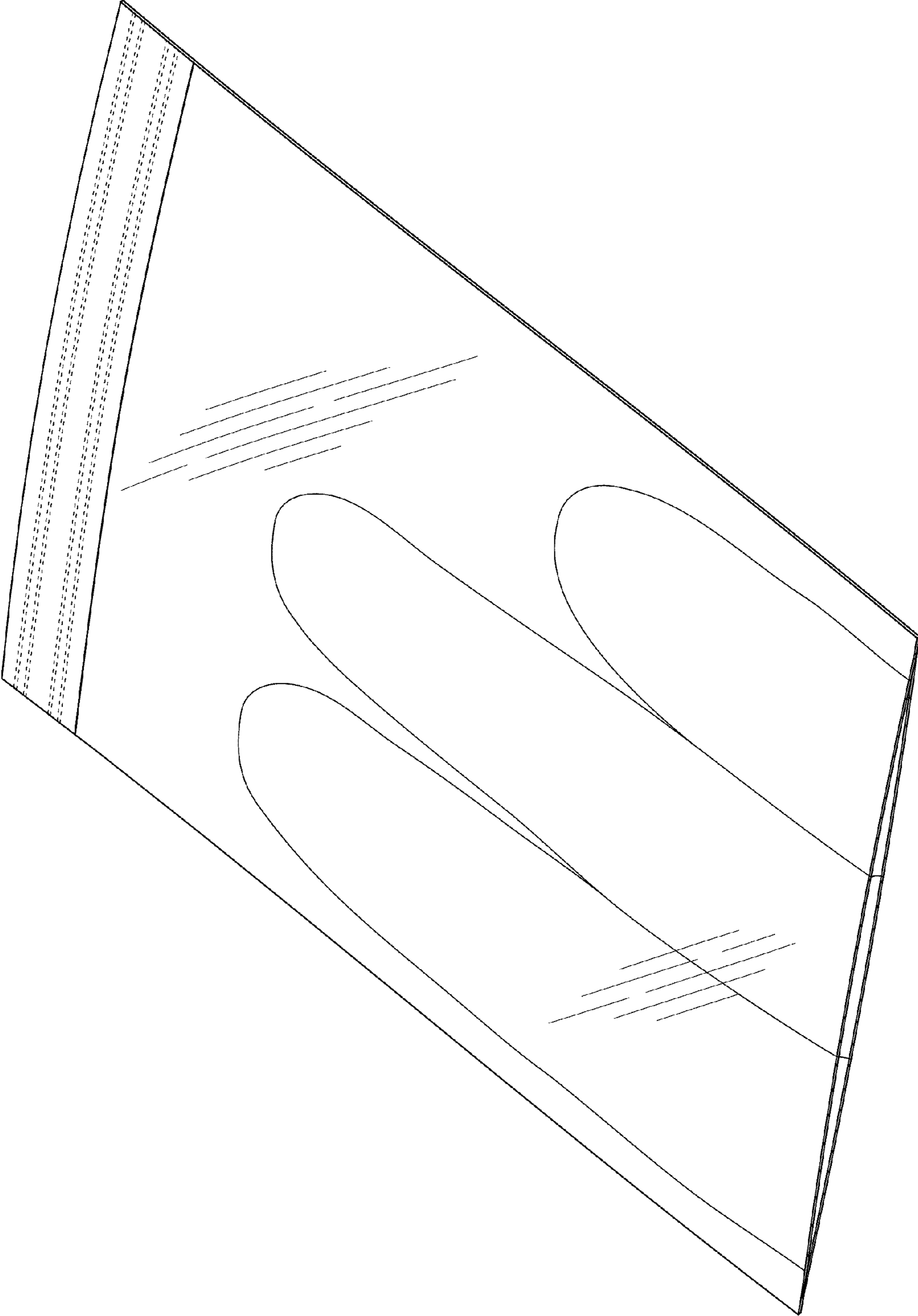

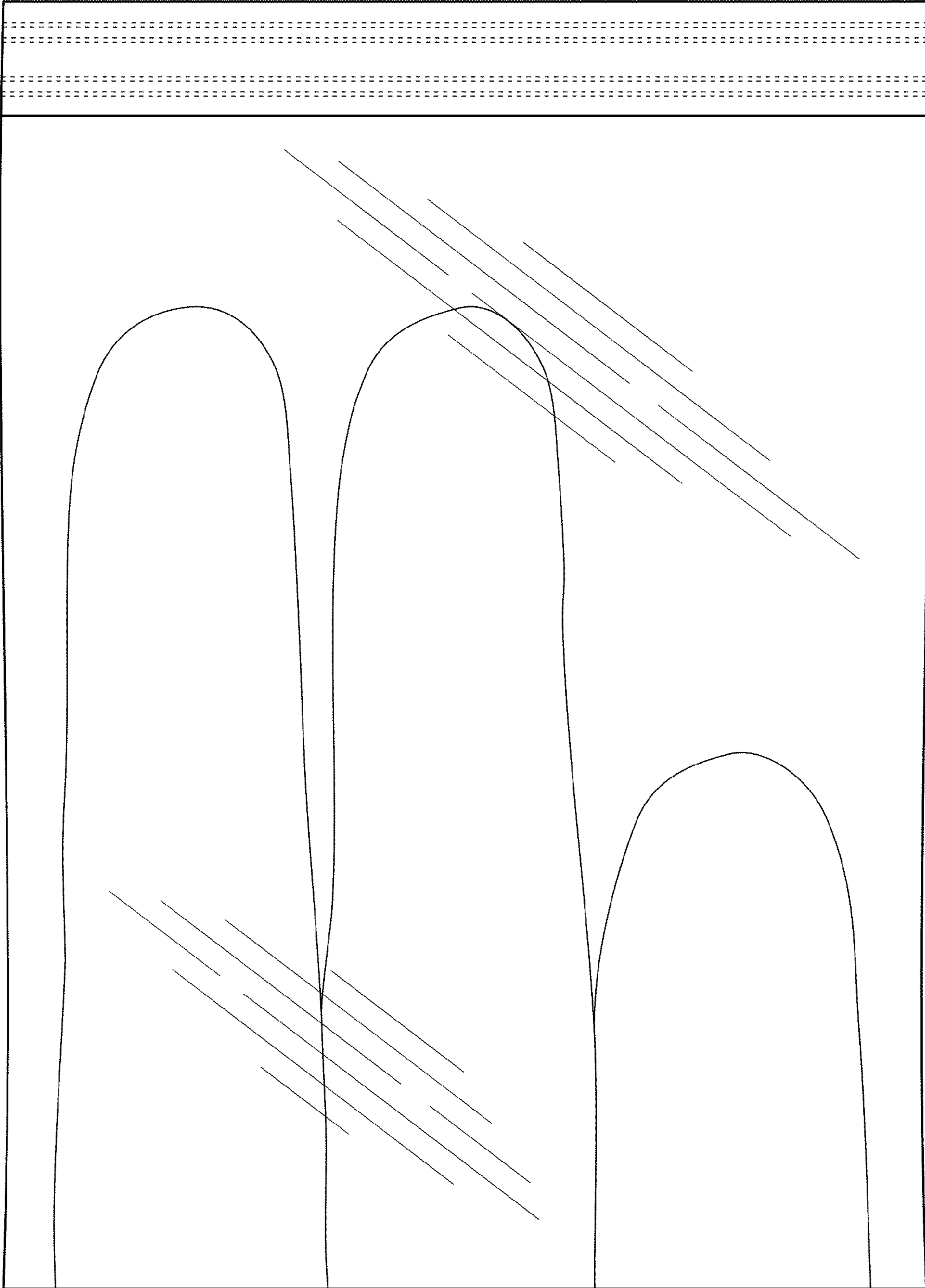

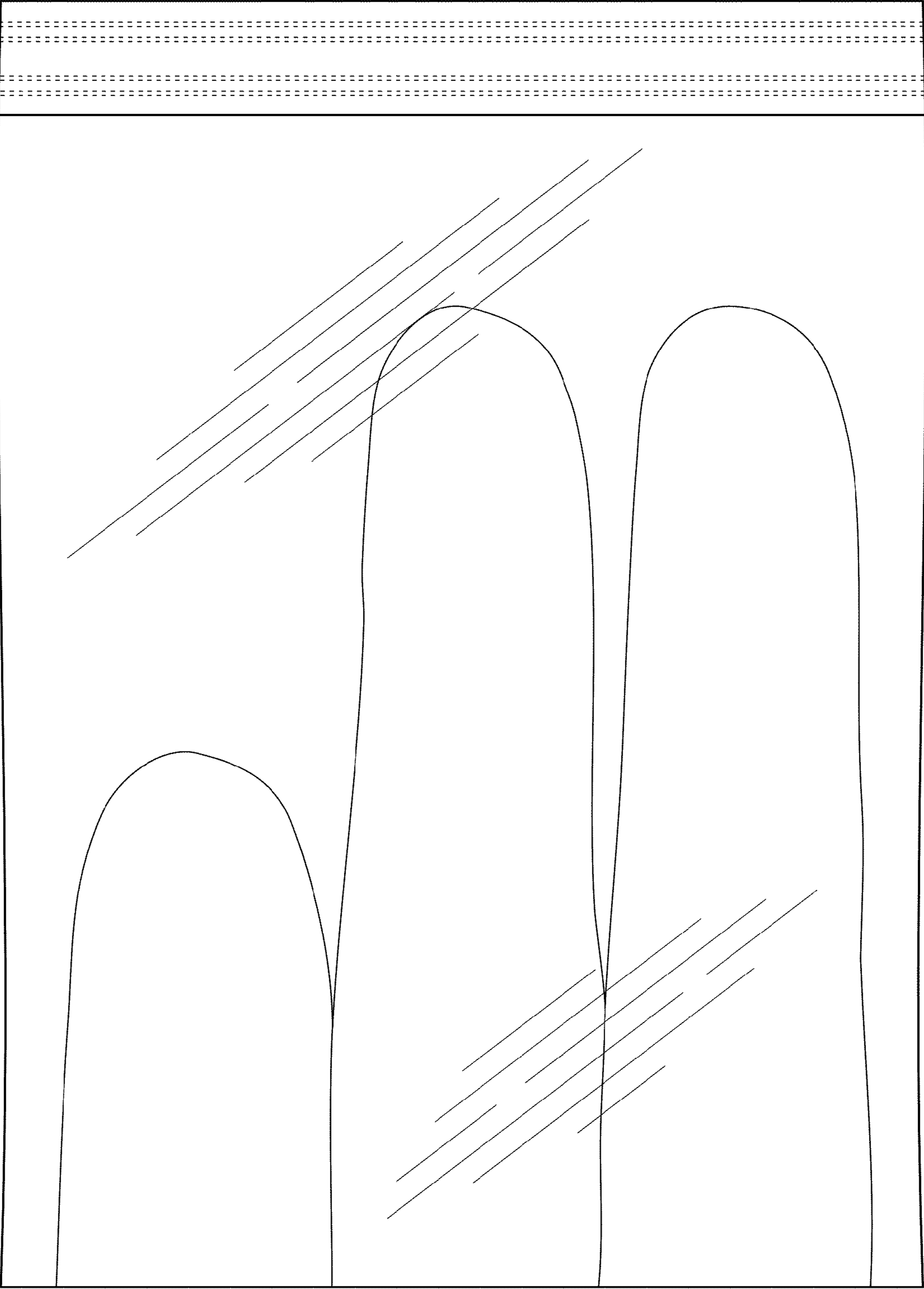

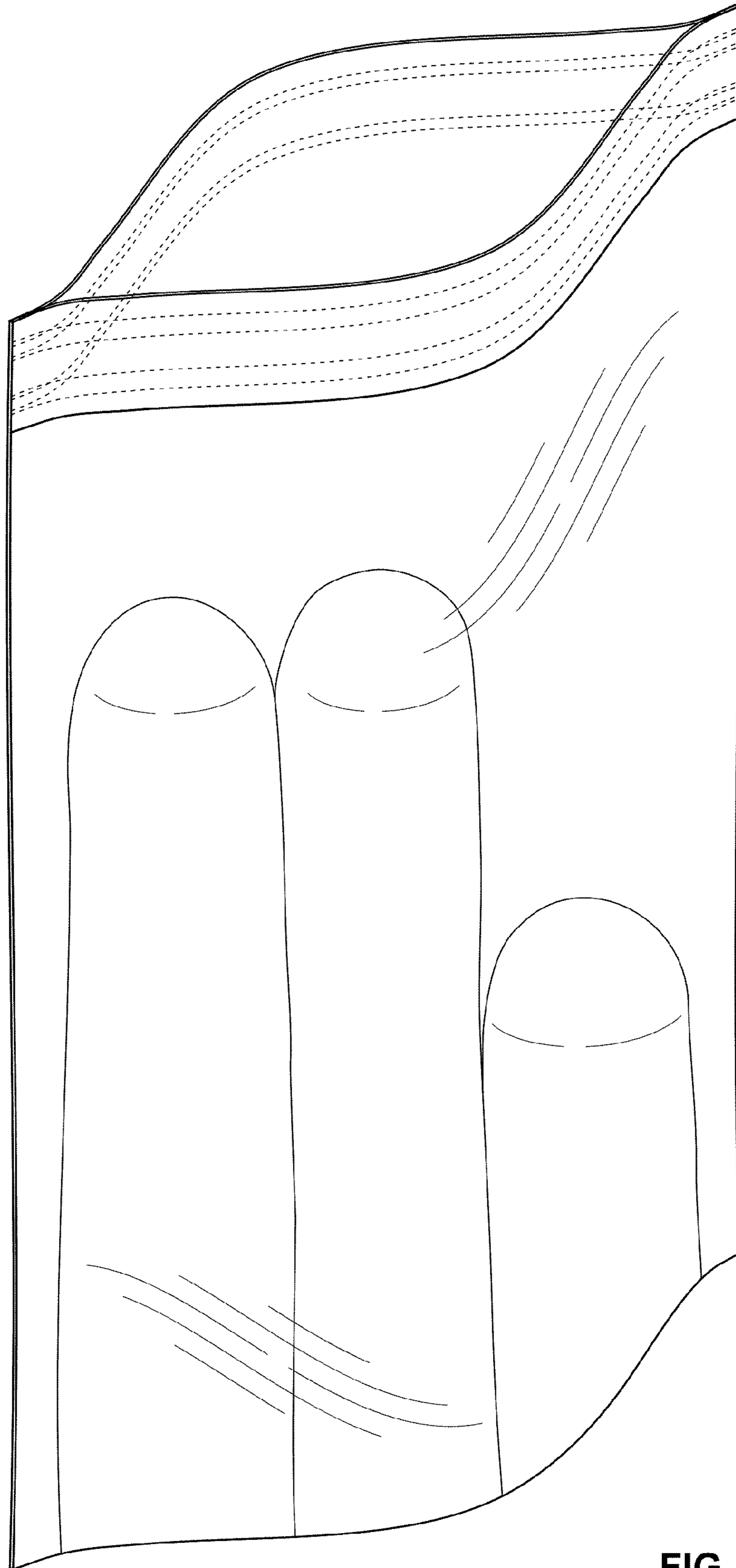

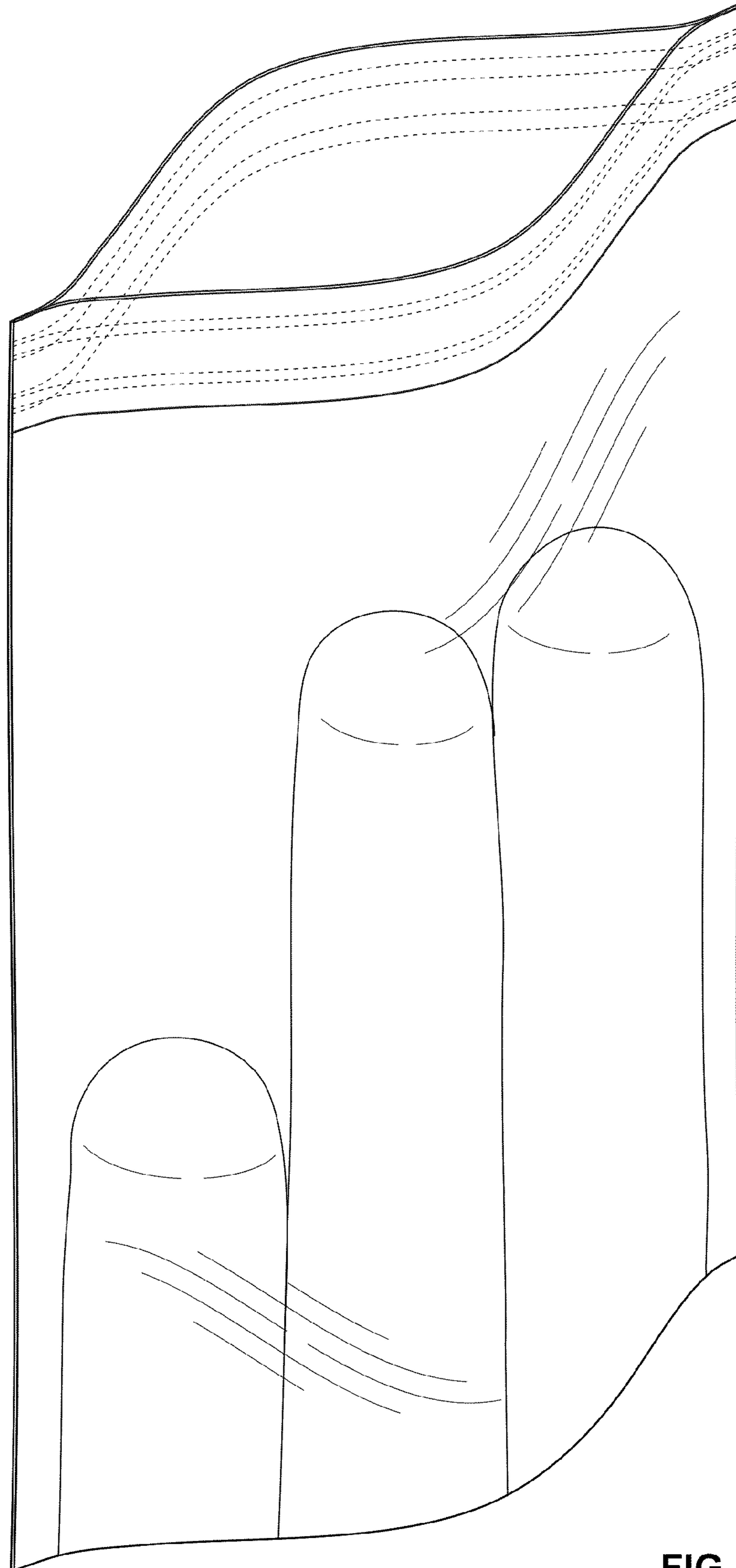

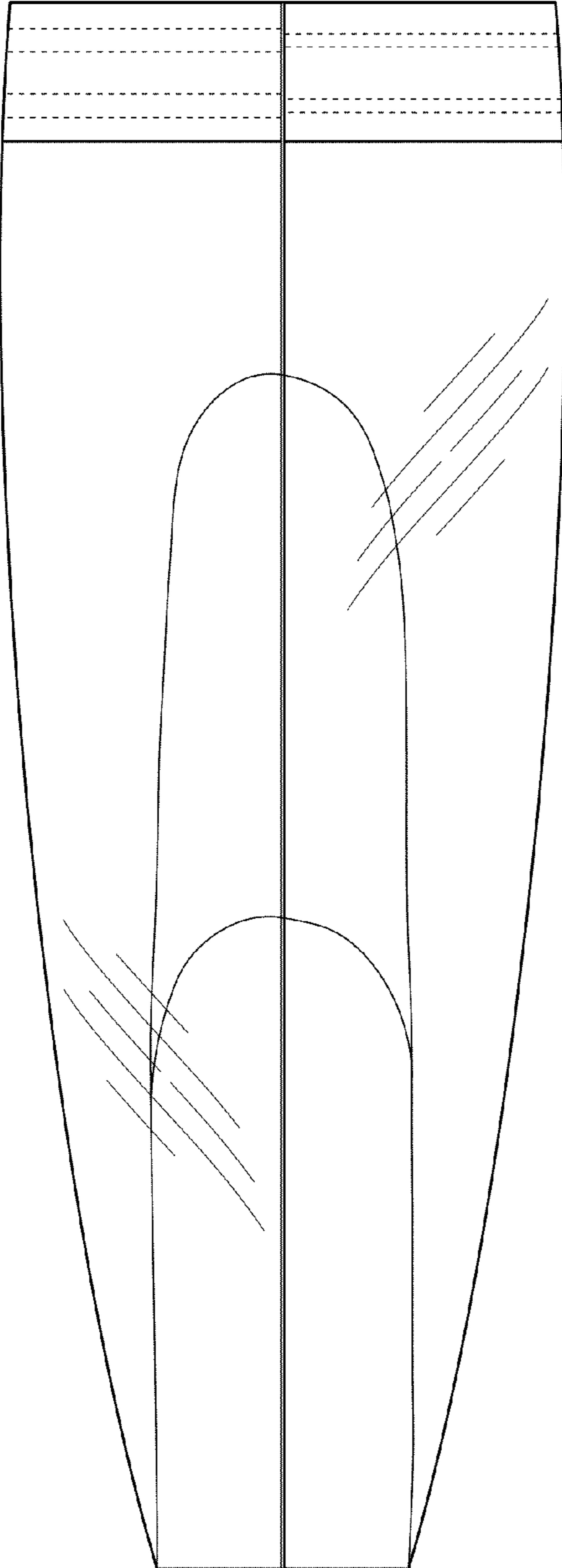

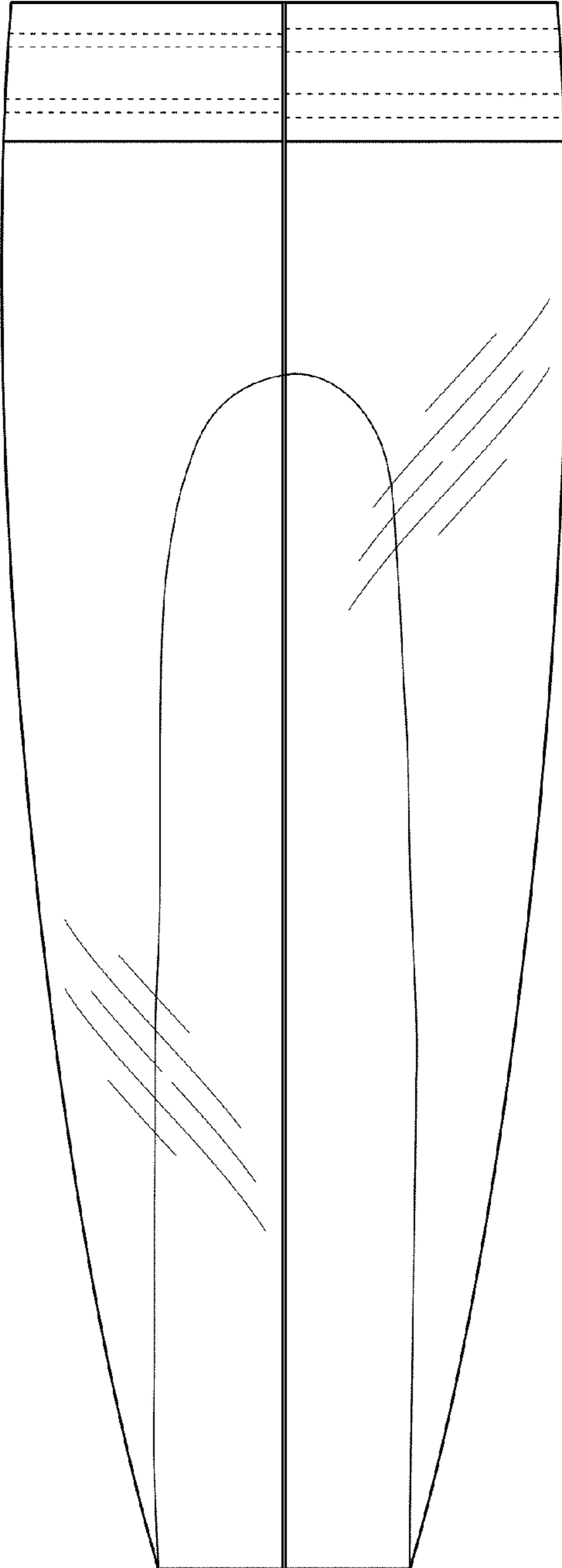

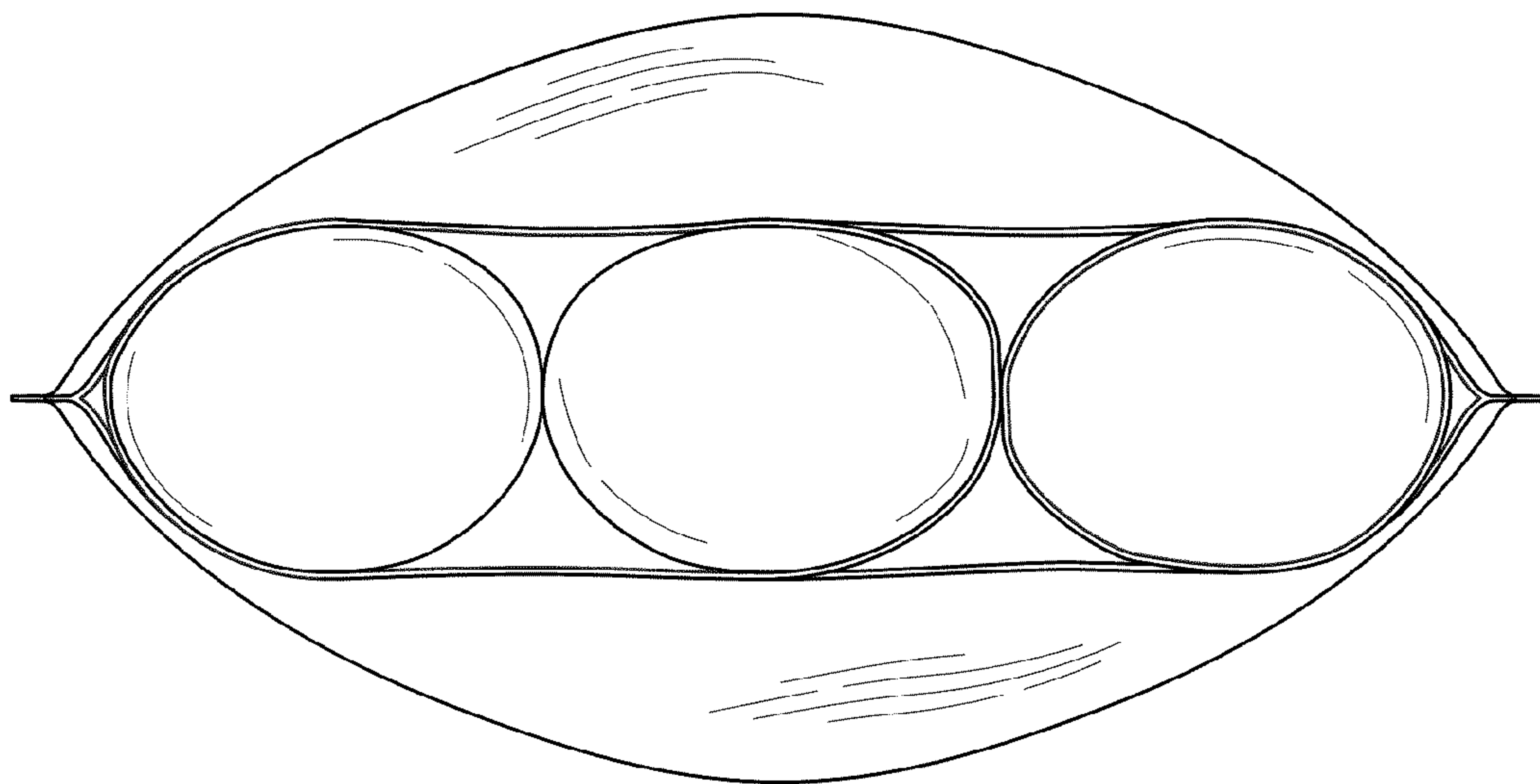

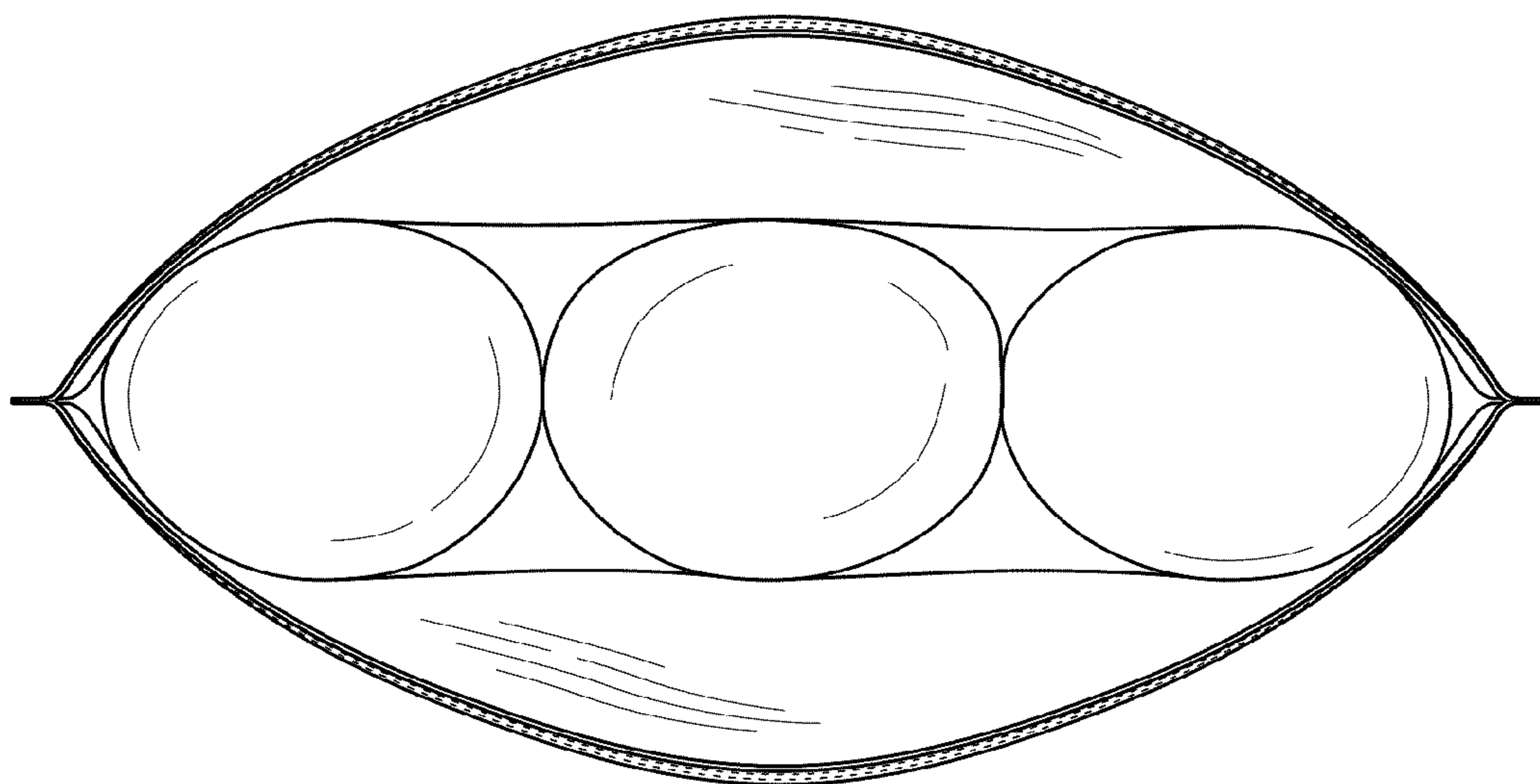

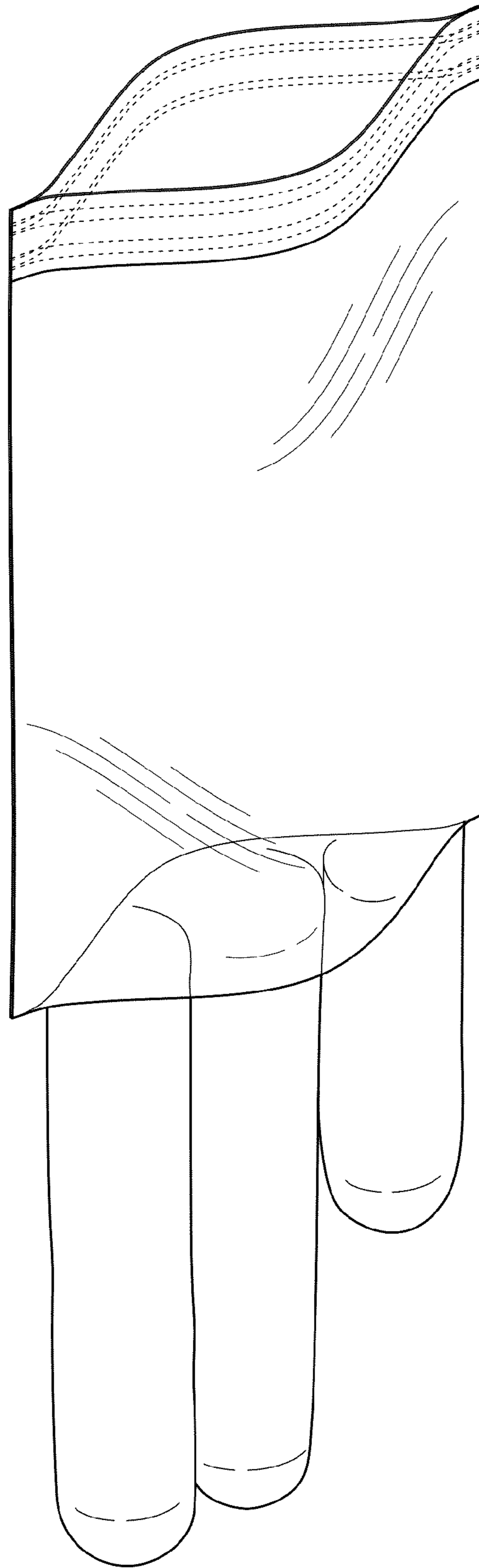

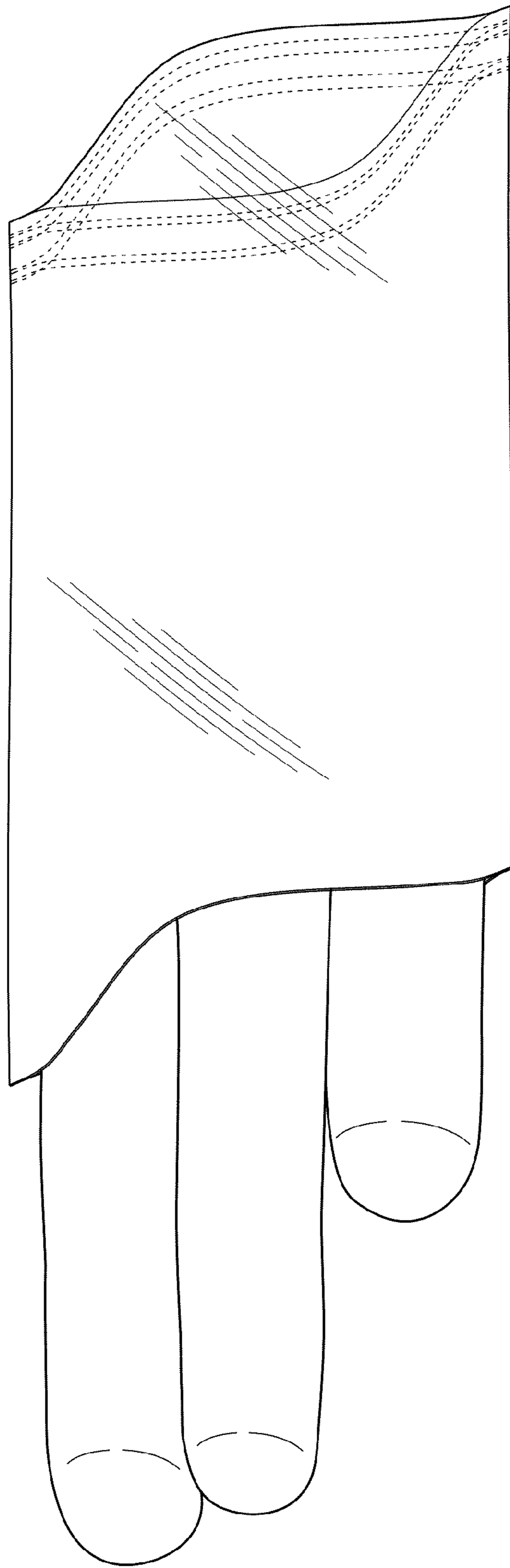

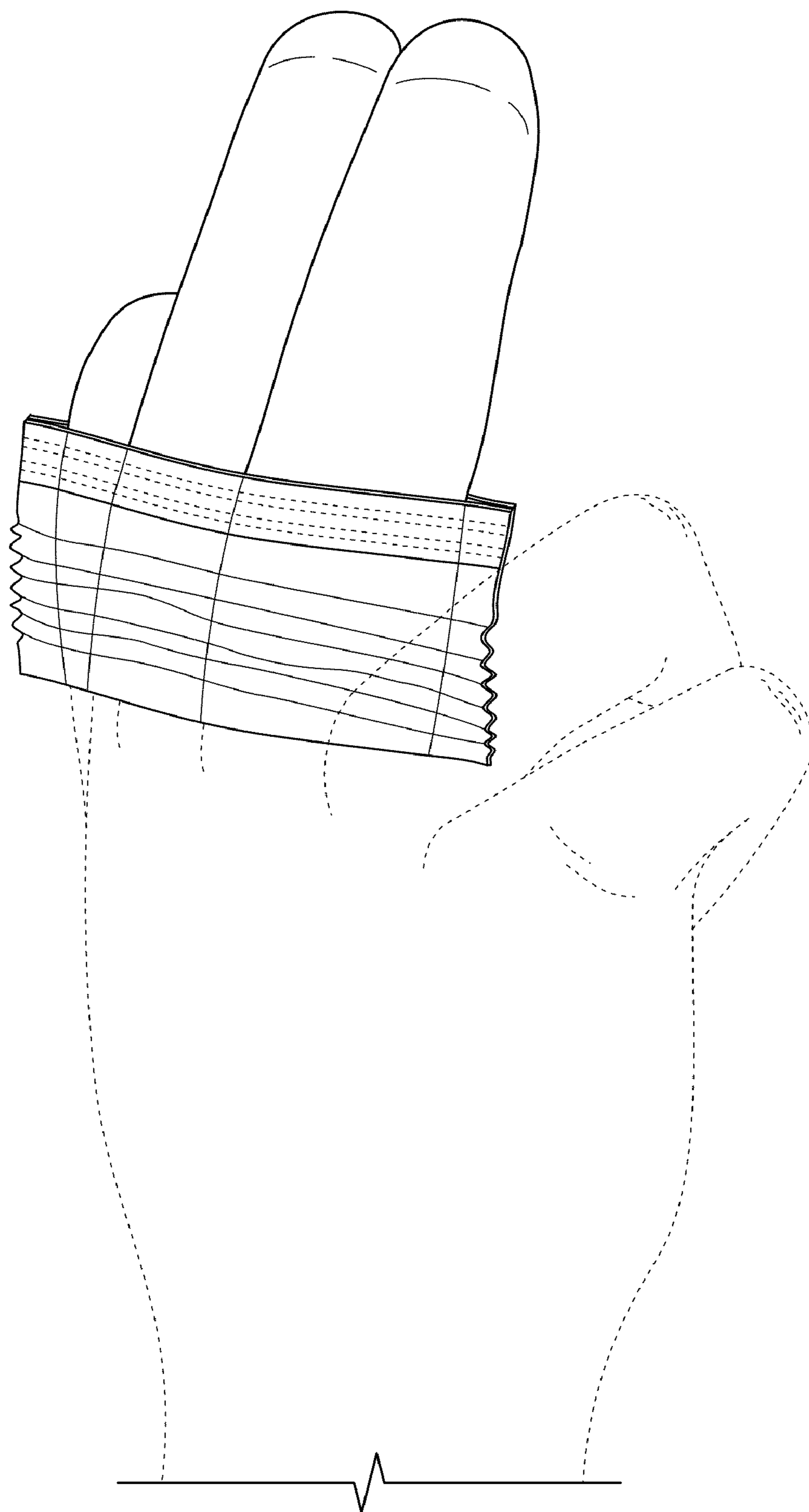

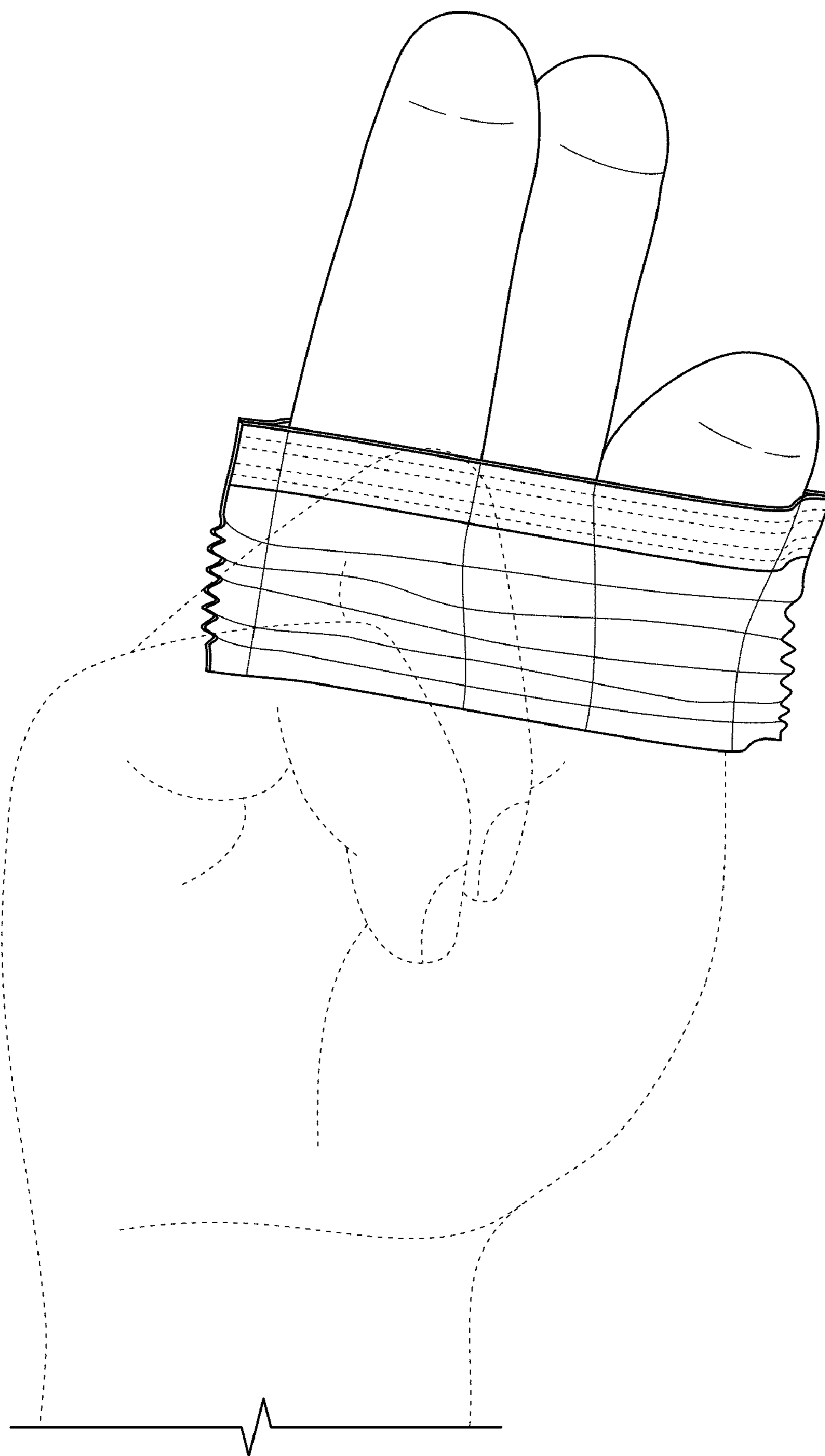

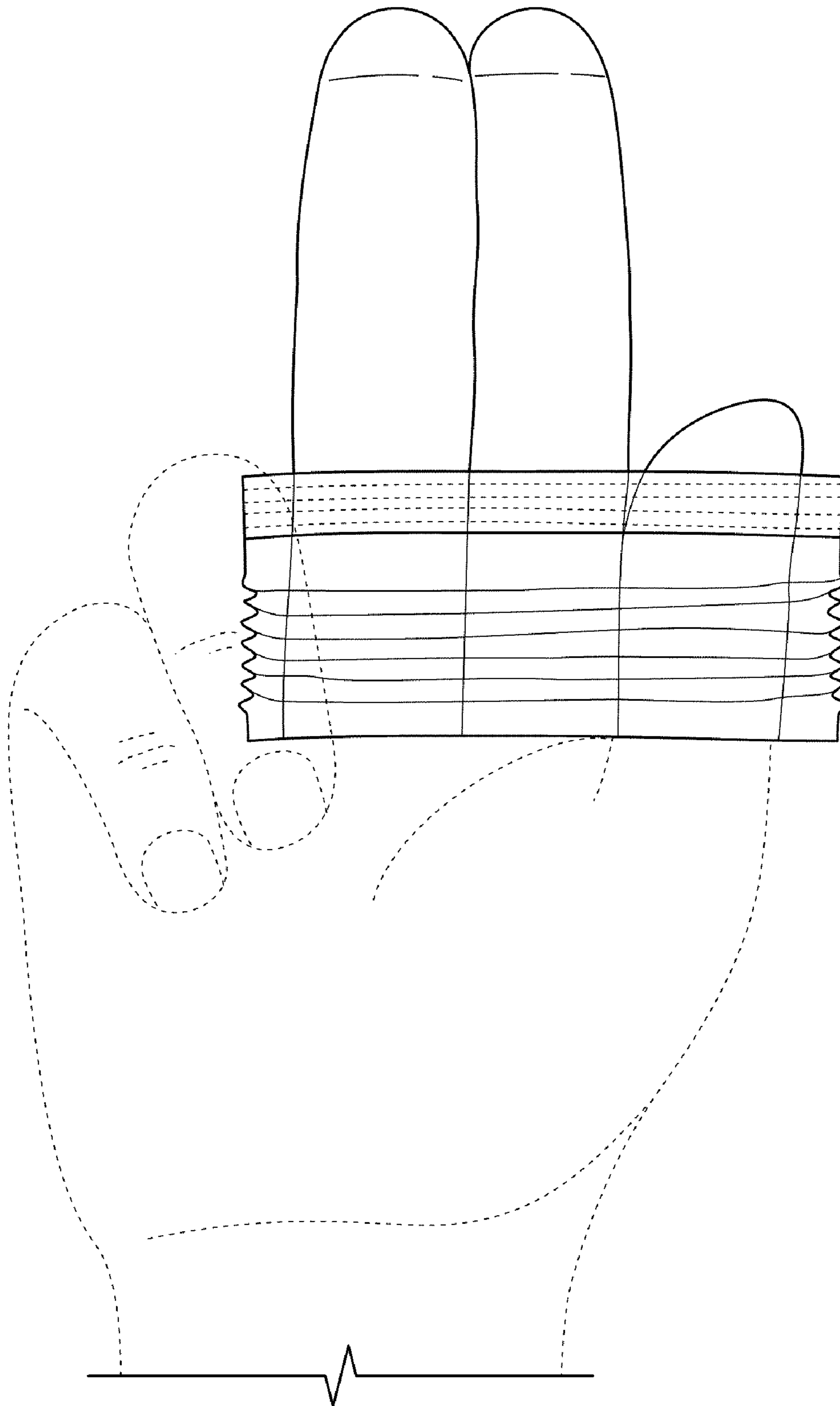

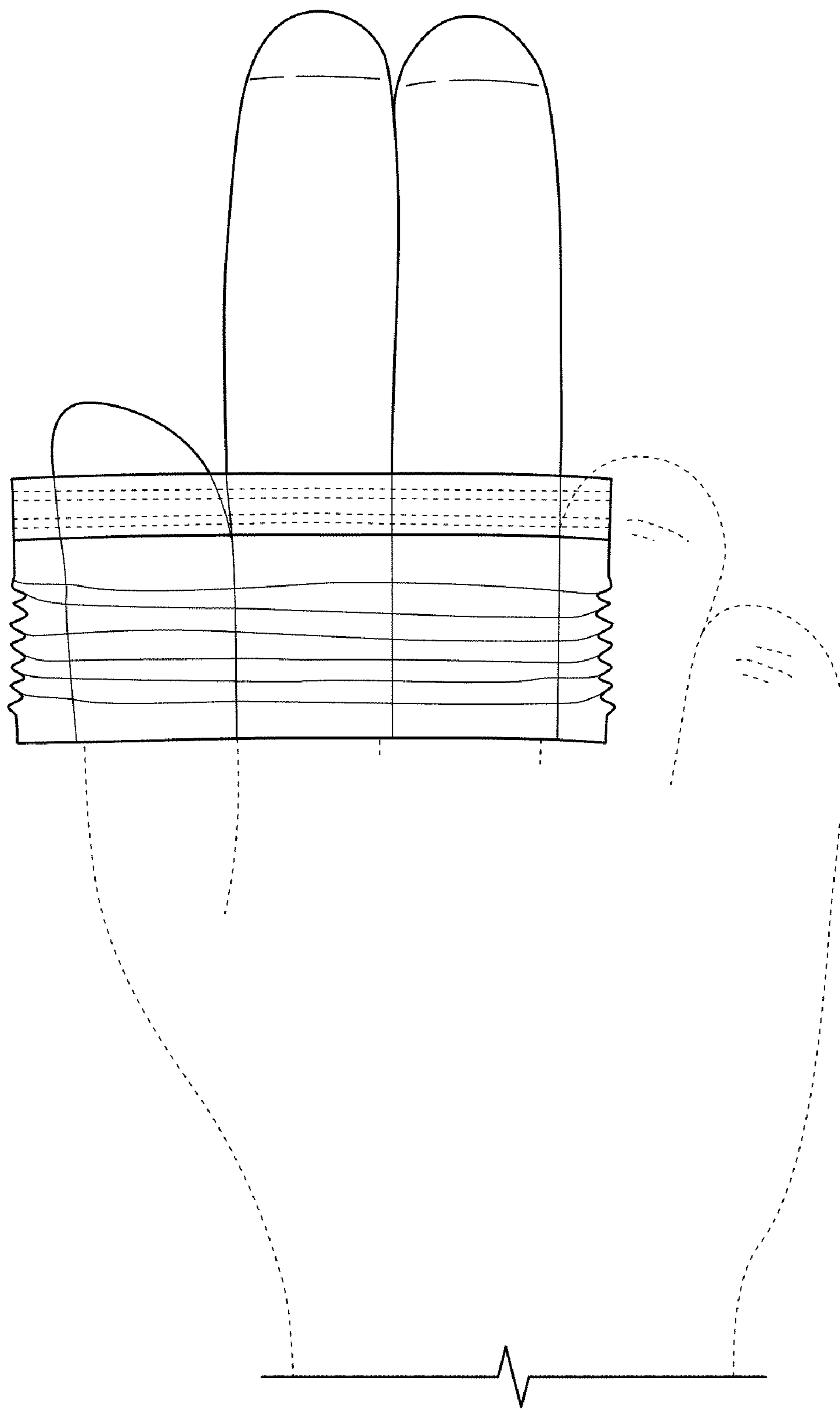

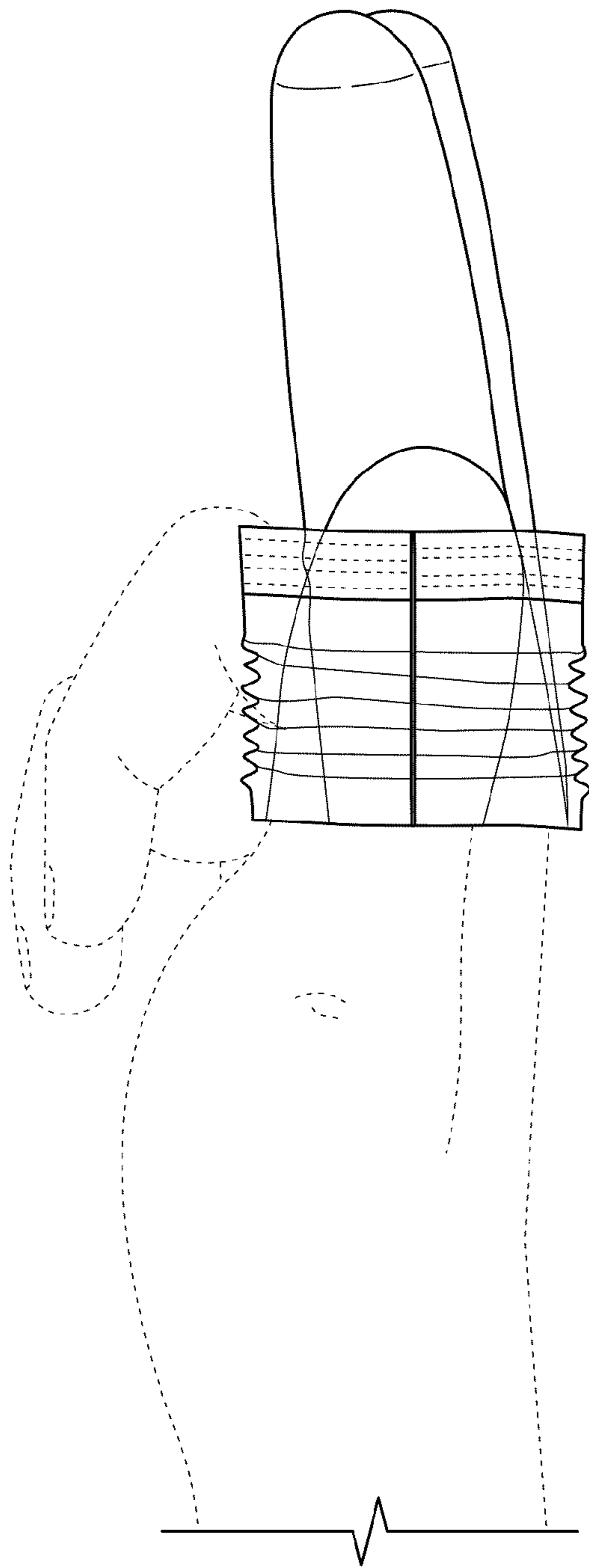

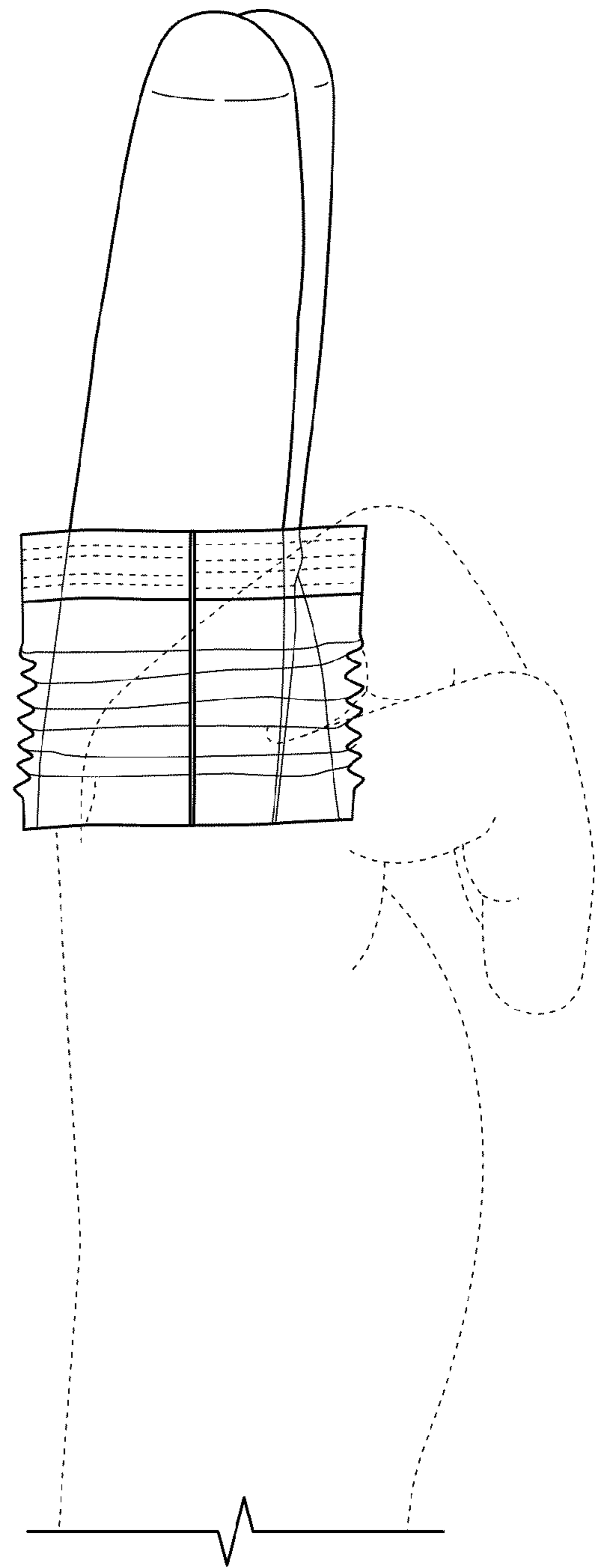

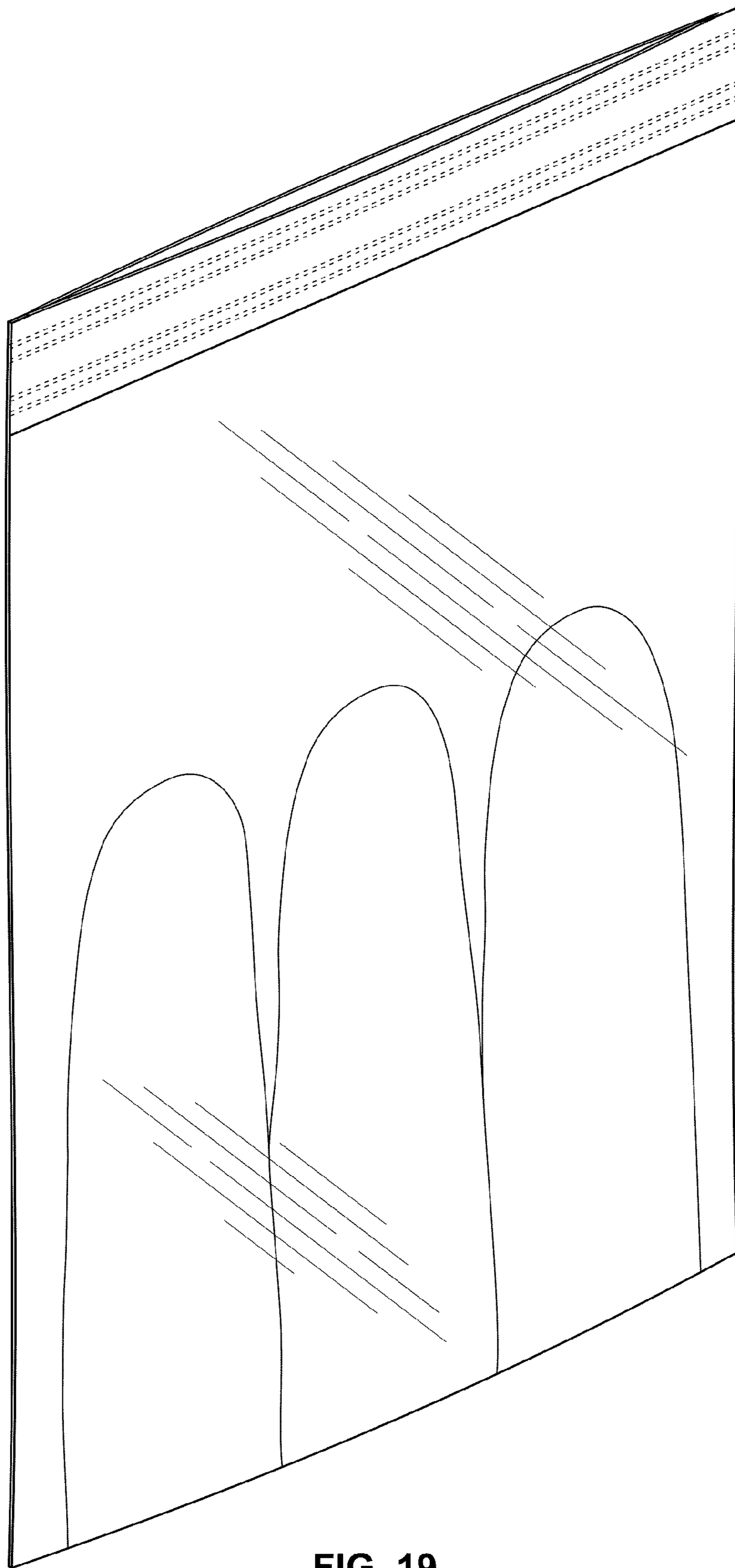

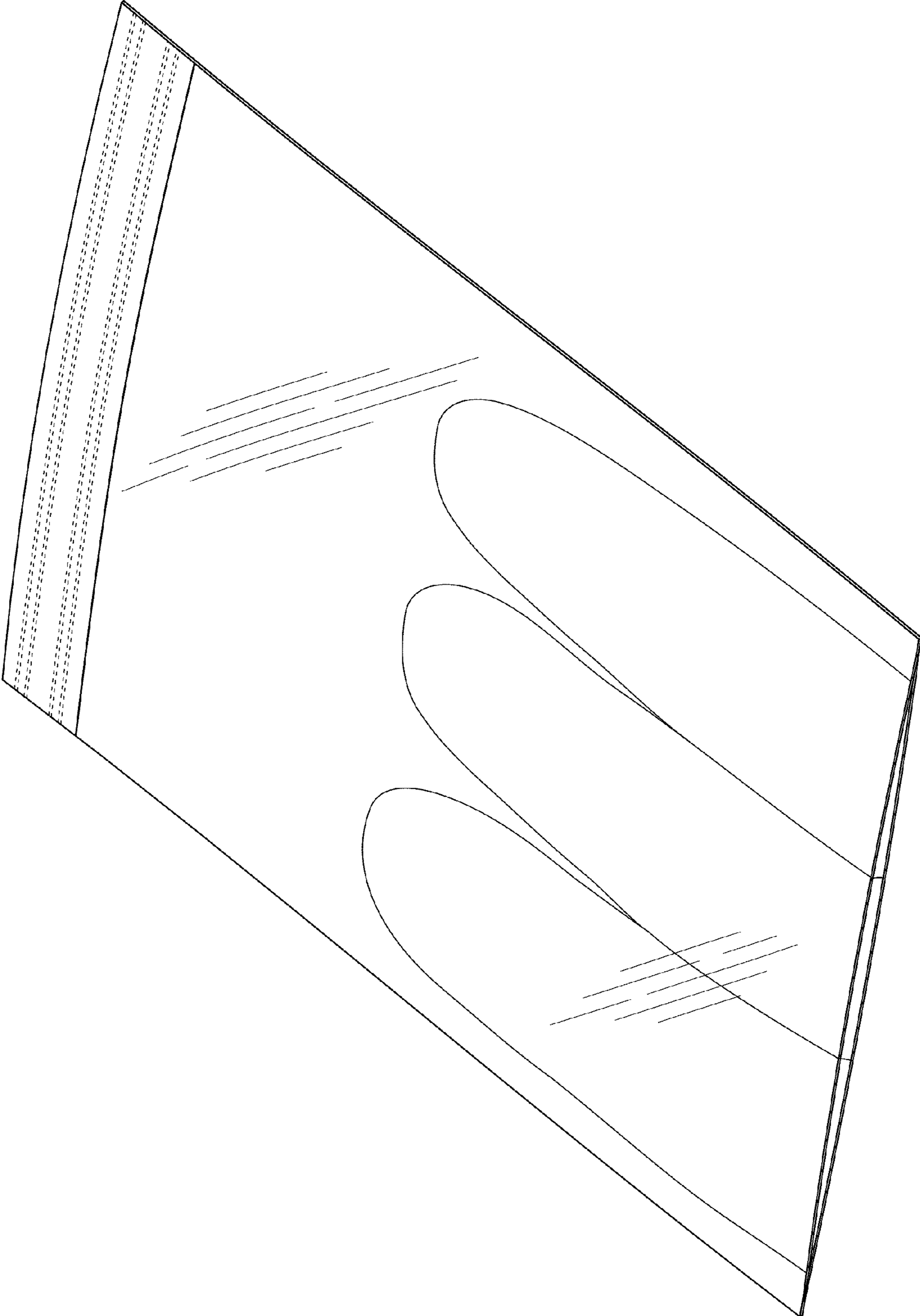

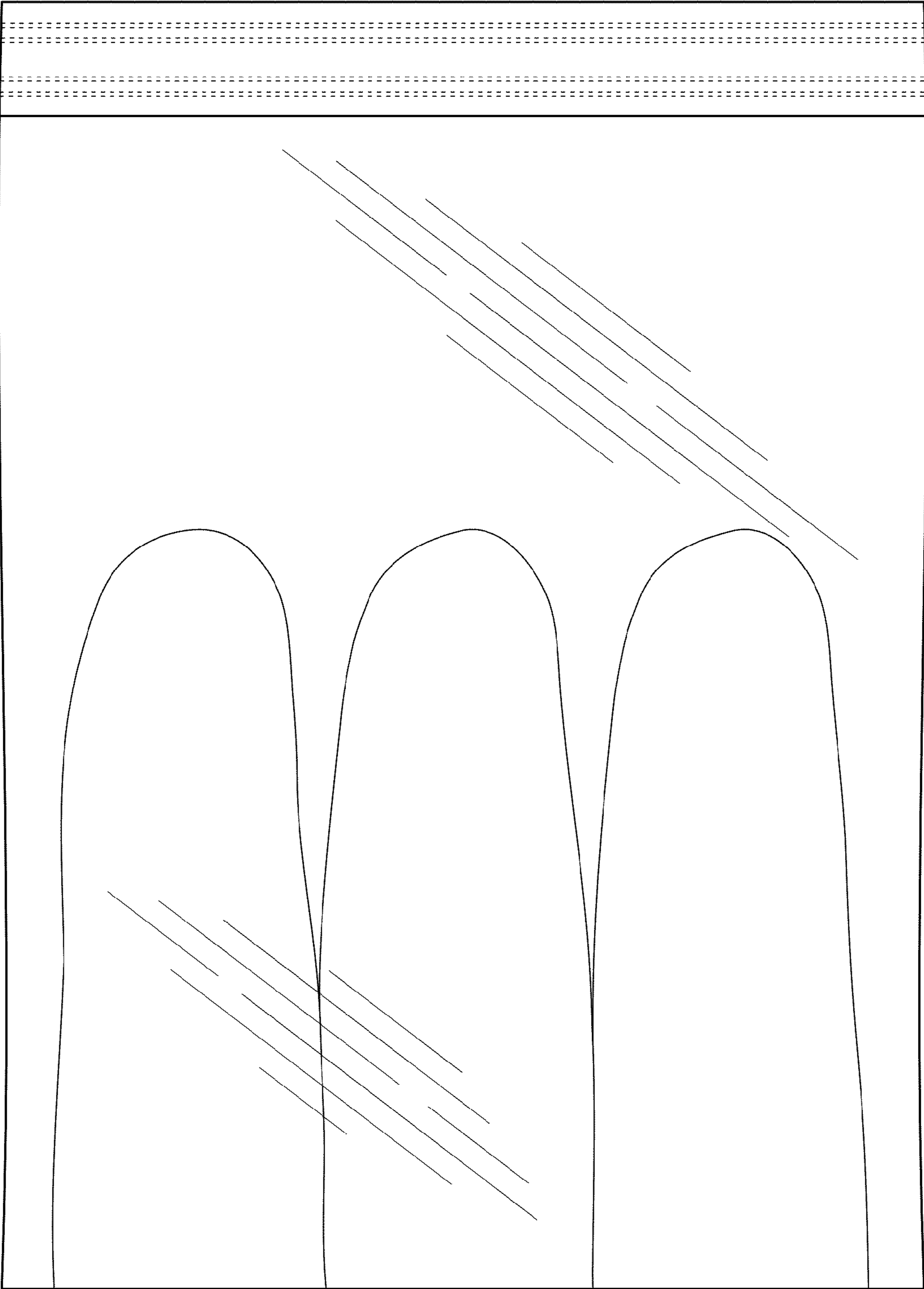

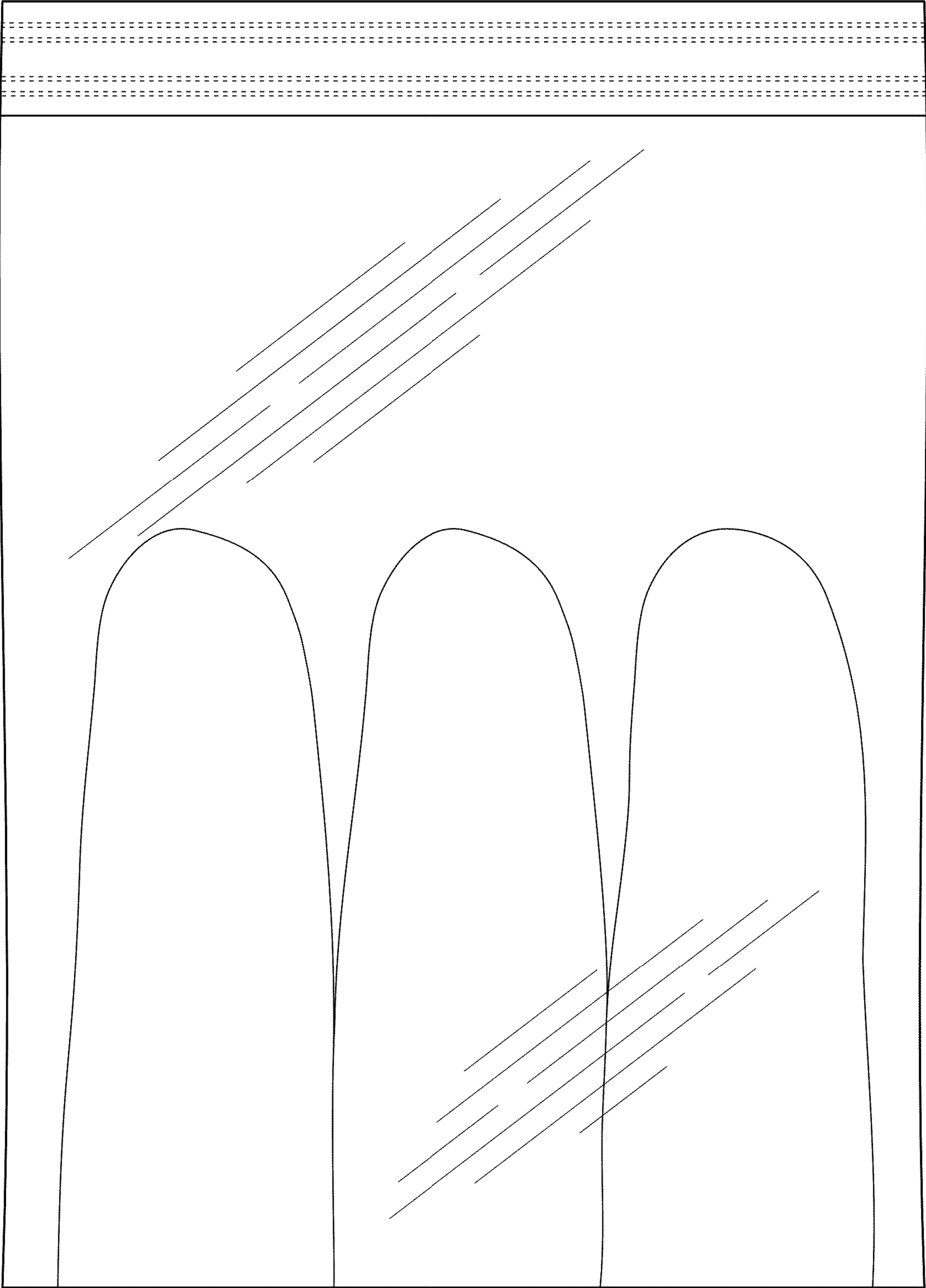

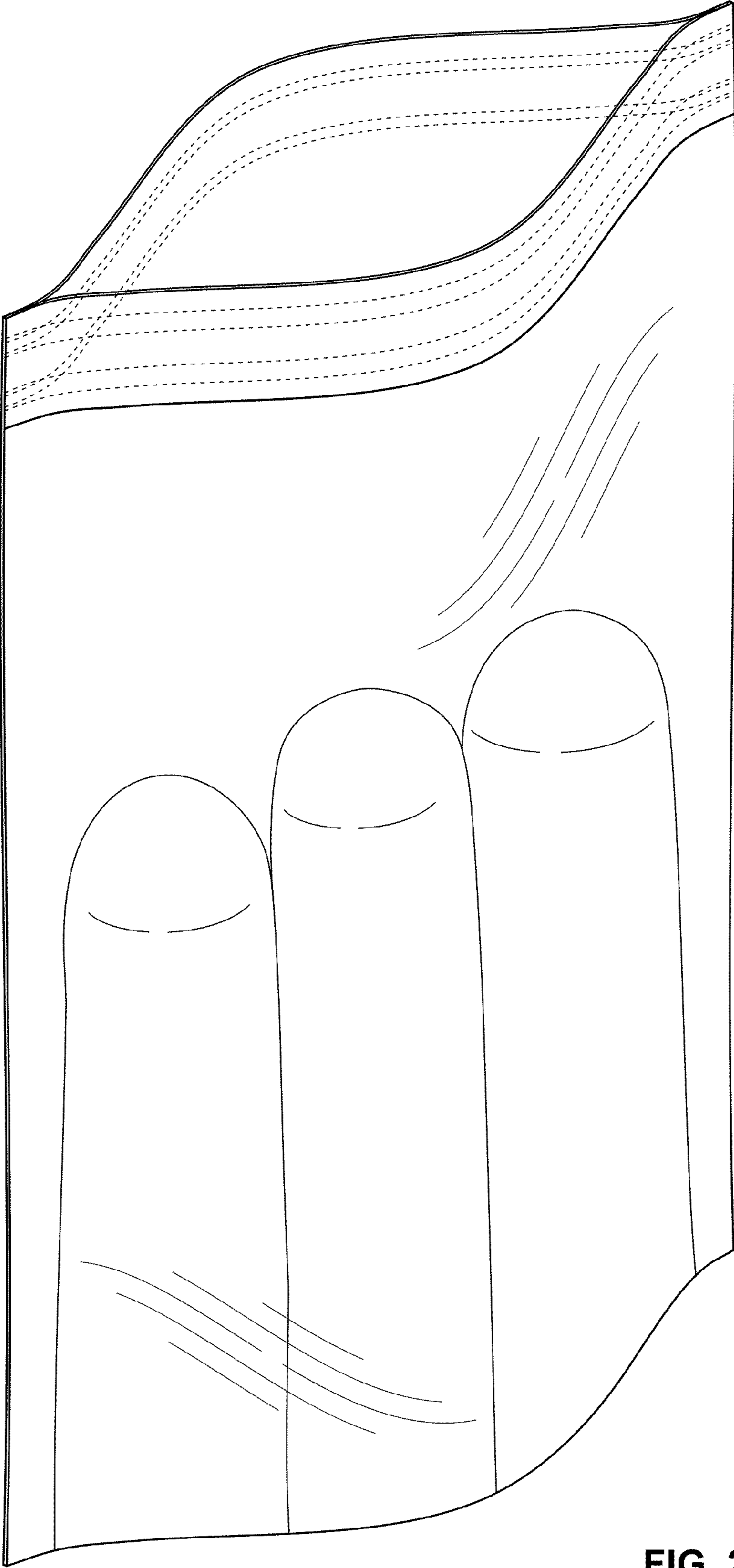

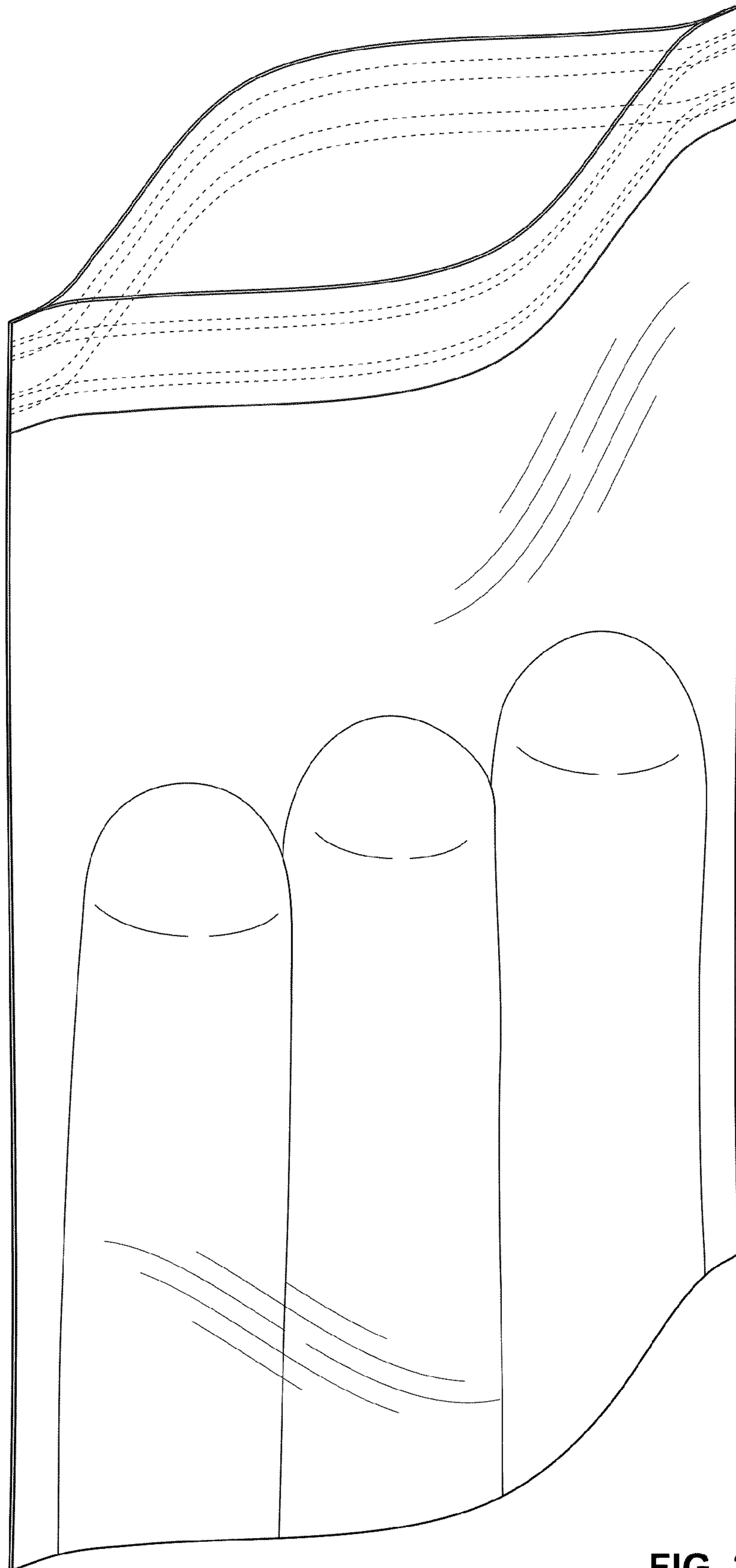

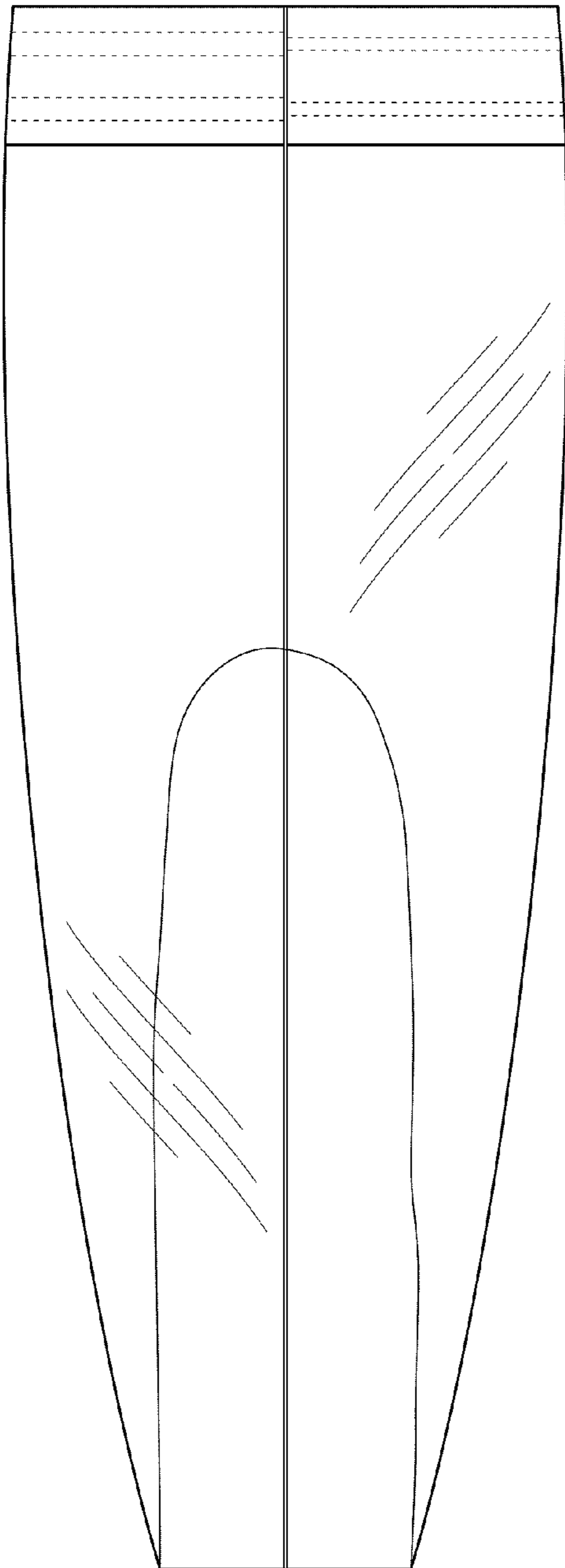

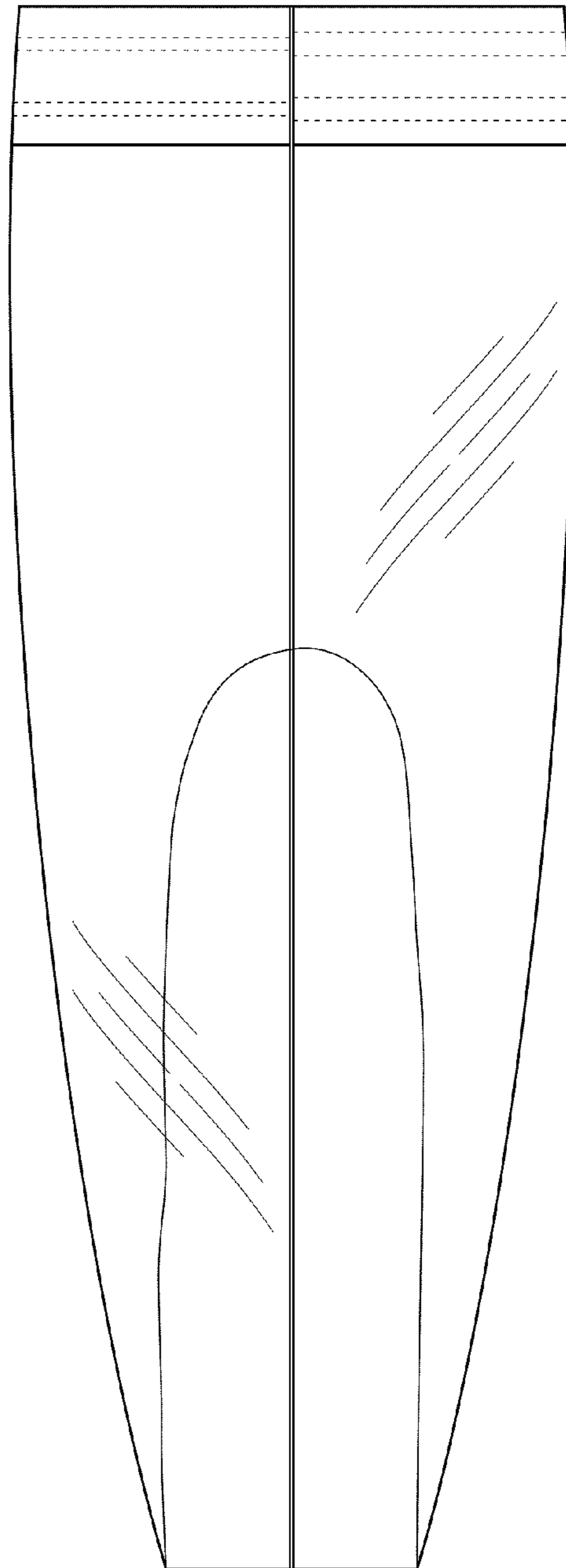

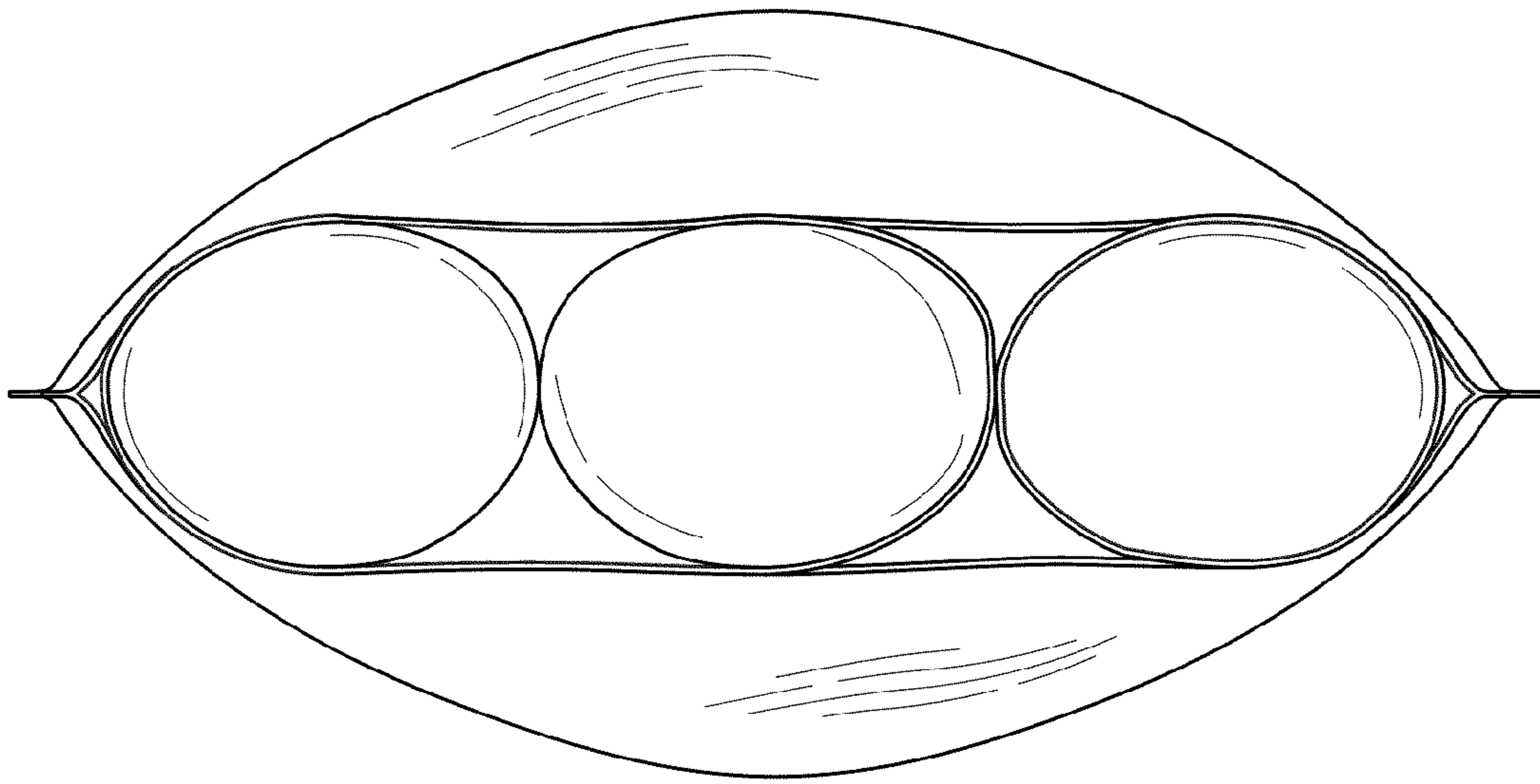

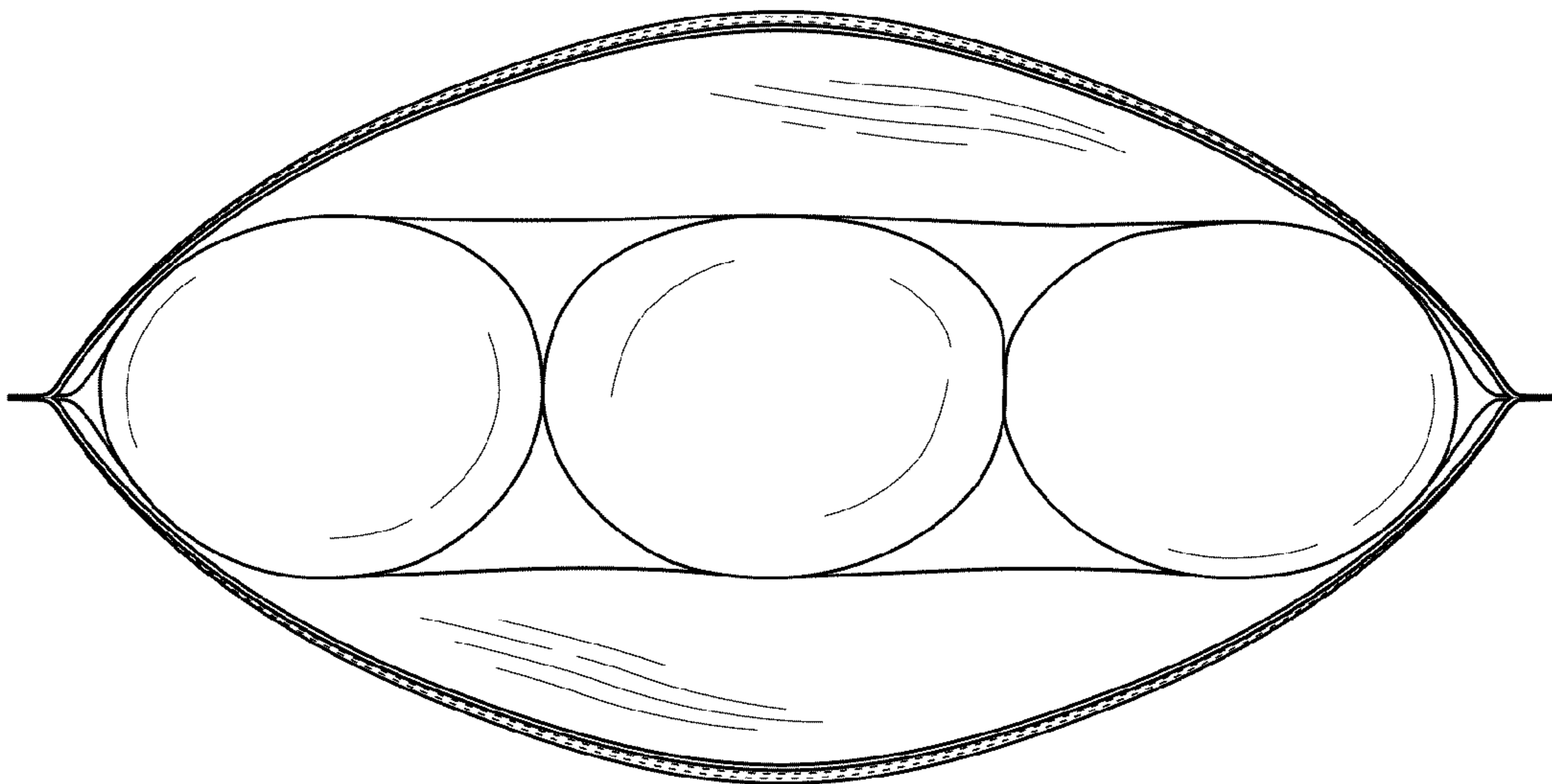

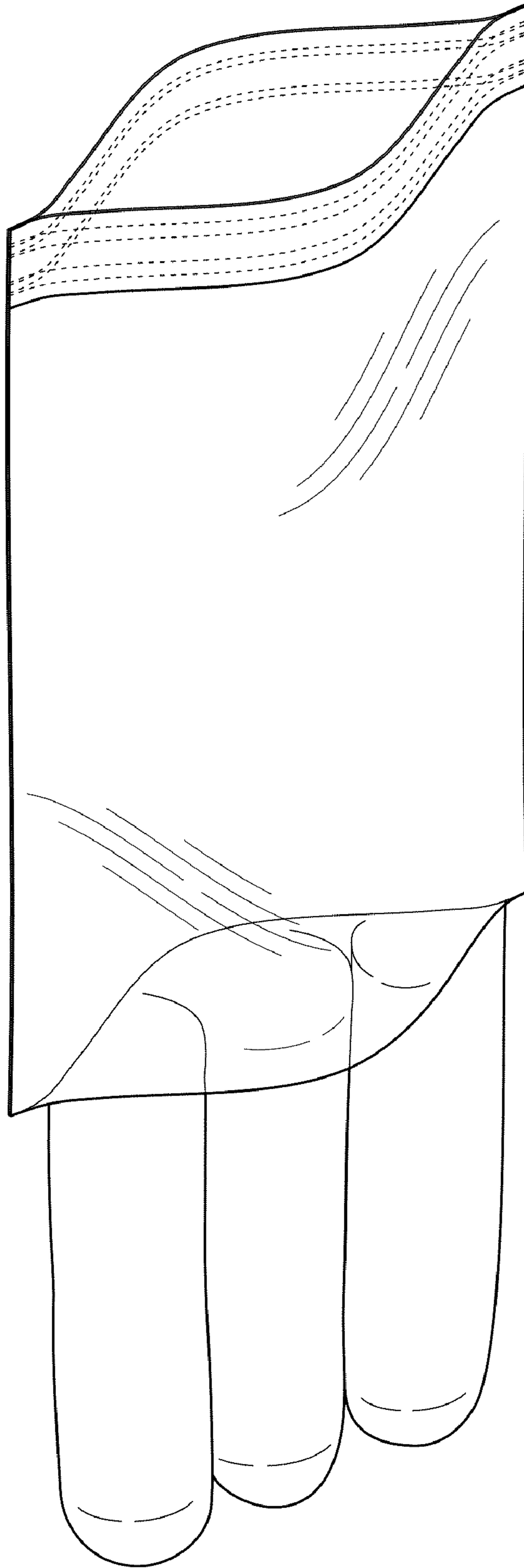

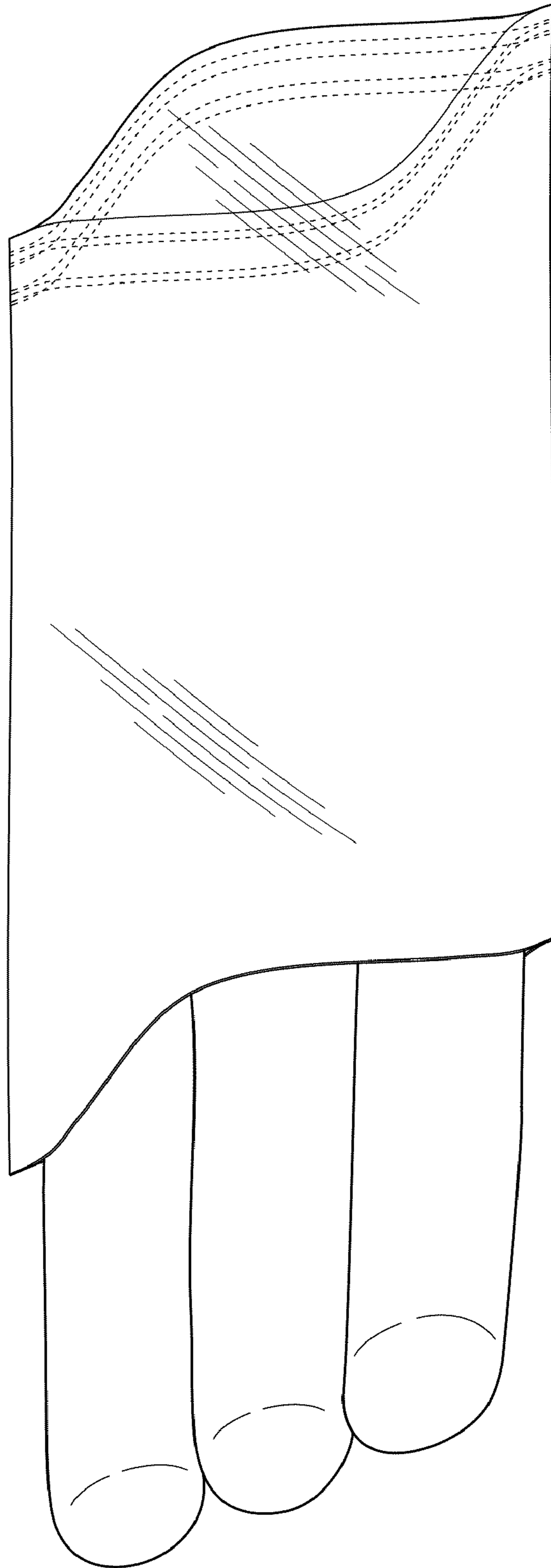
