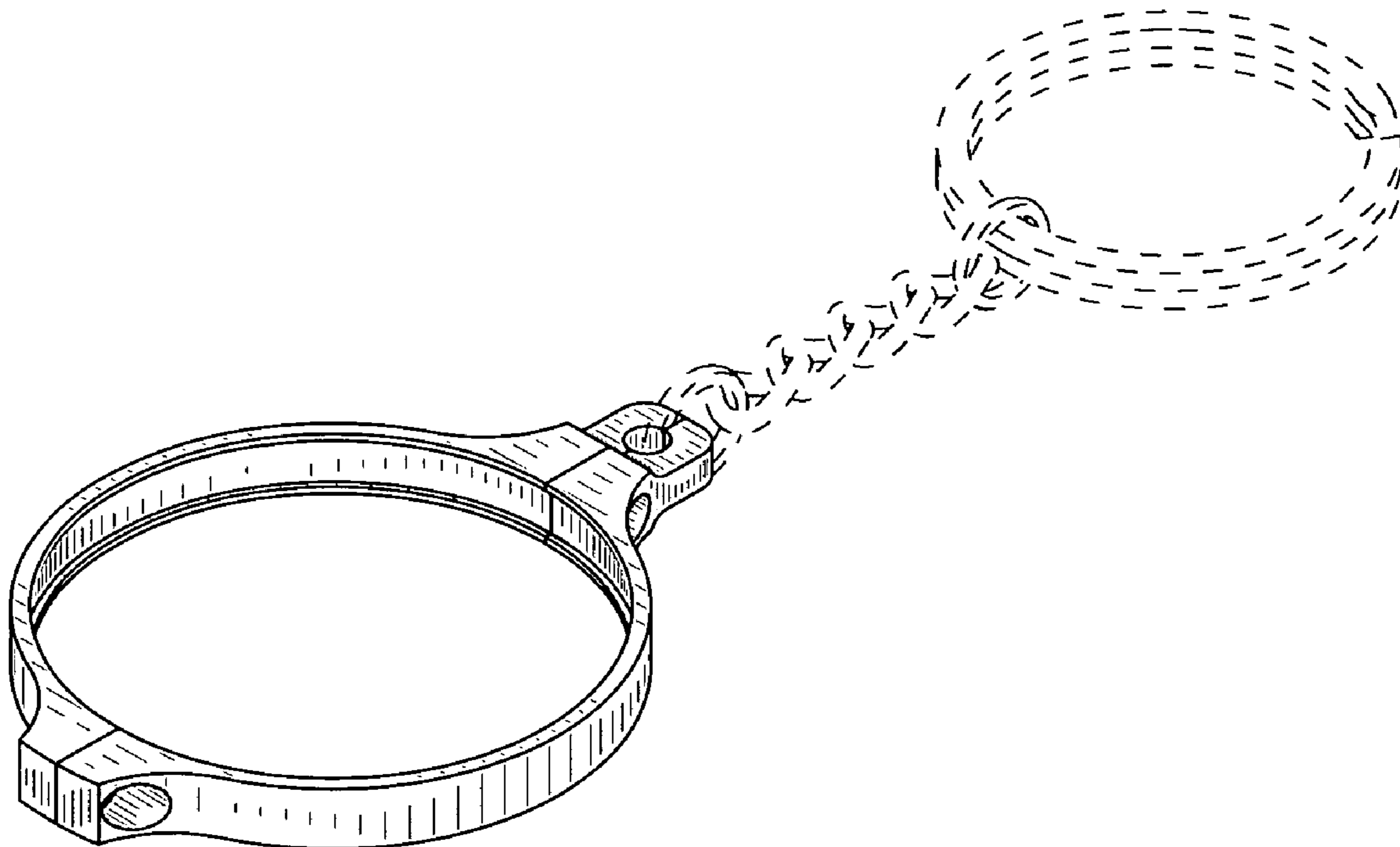
(57) **CLAIM**

The ornamental design for a combined poker fob and zipper pull, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined poker fob and zipper pull showing my new design; FIG. 2 is a top view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view, the opposite rear being a mirror image thereof; FIG. 5 is a right side view thereof; and, FIG. 6 is a bottom view thereof. The broken lines in the figures showing a chain and ring illustrate environmental structure and form no part of the claimed design.

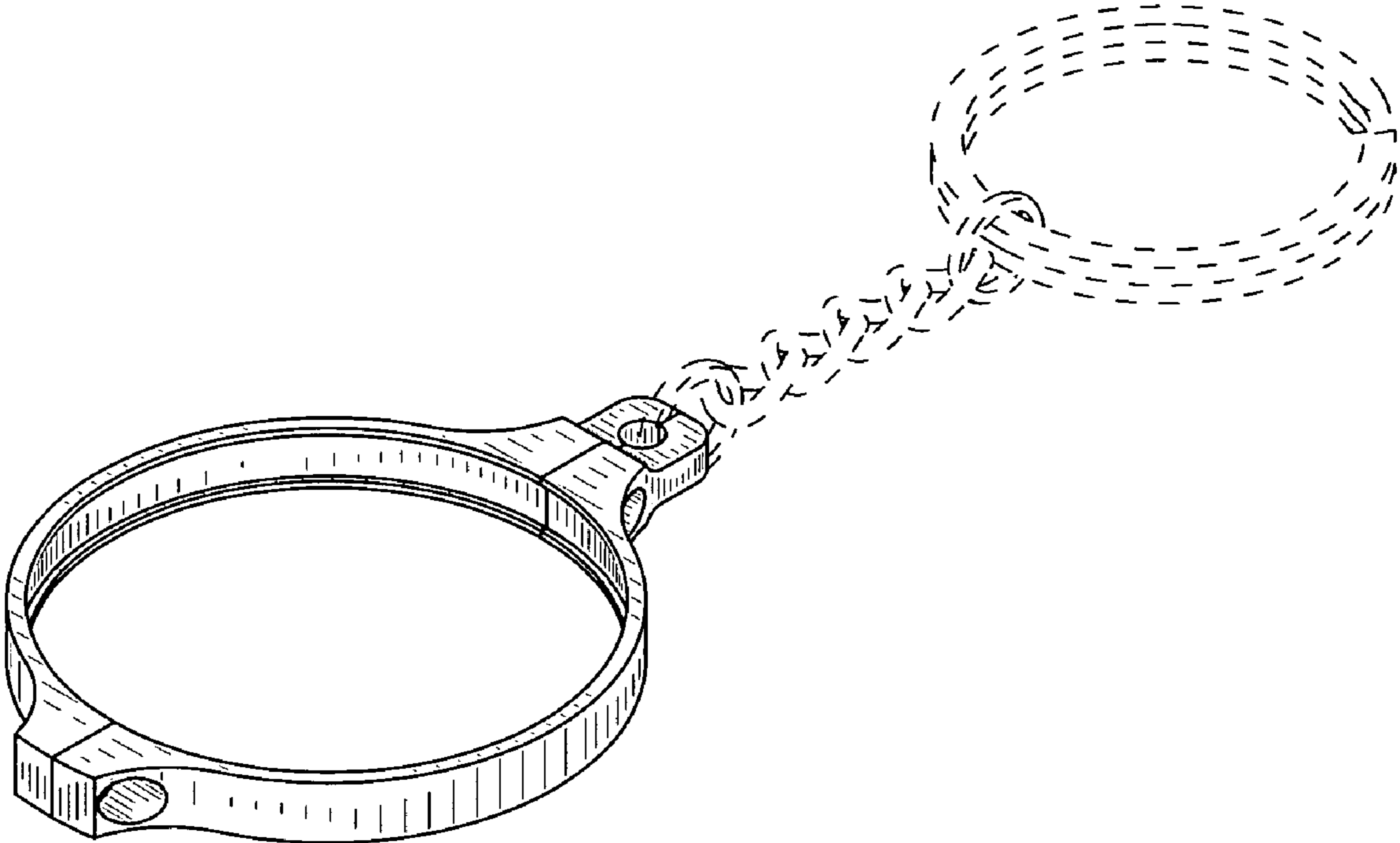

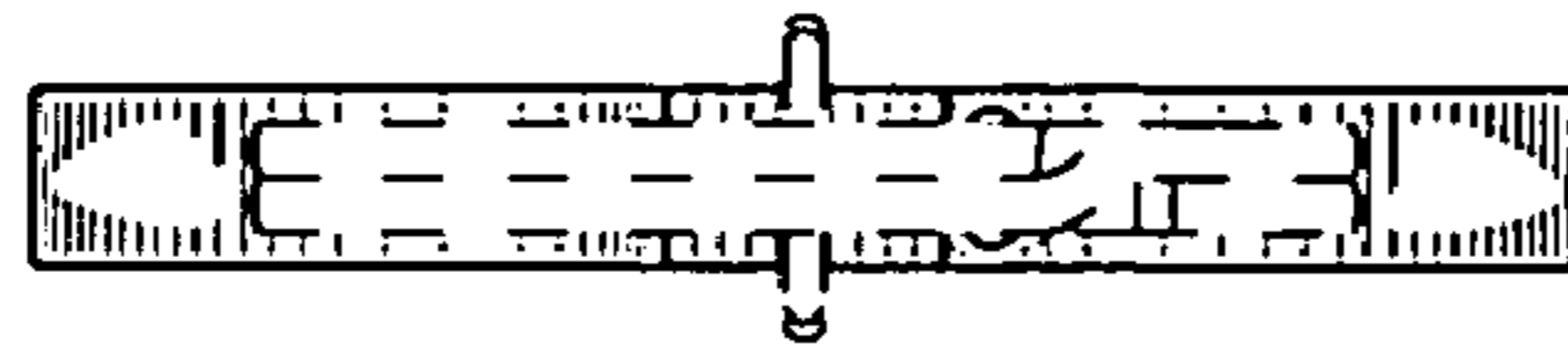

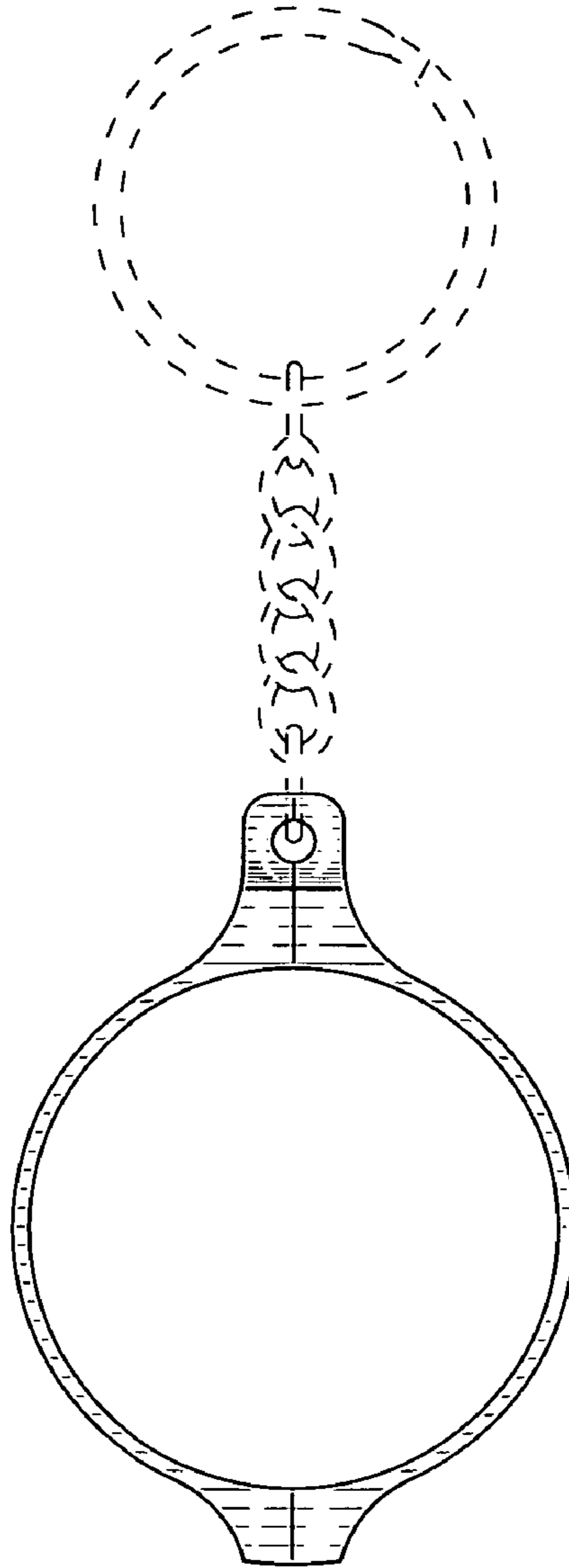

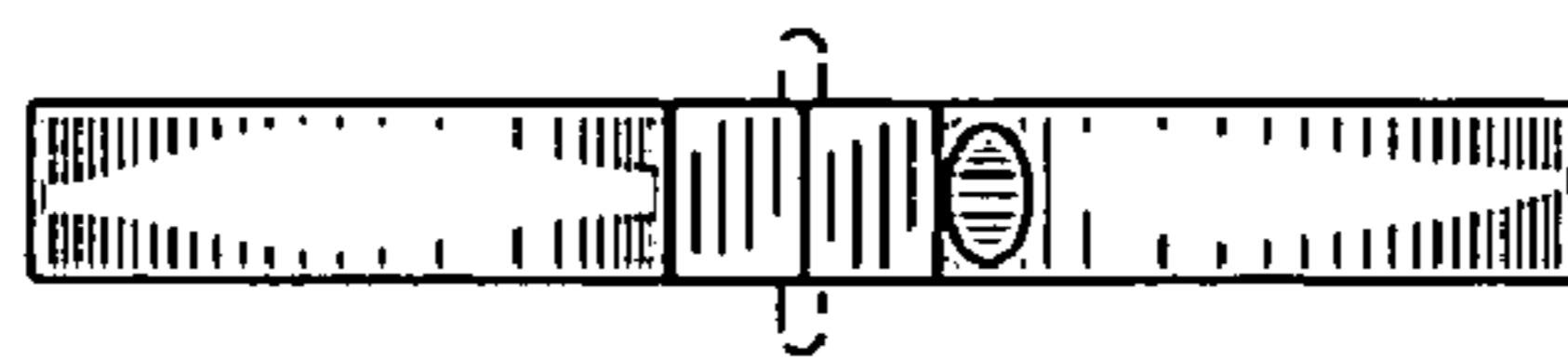
