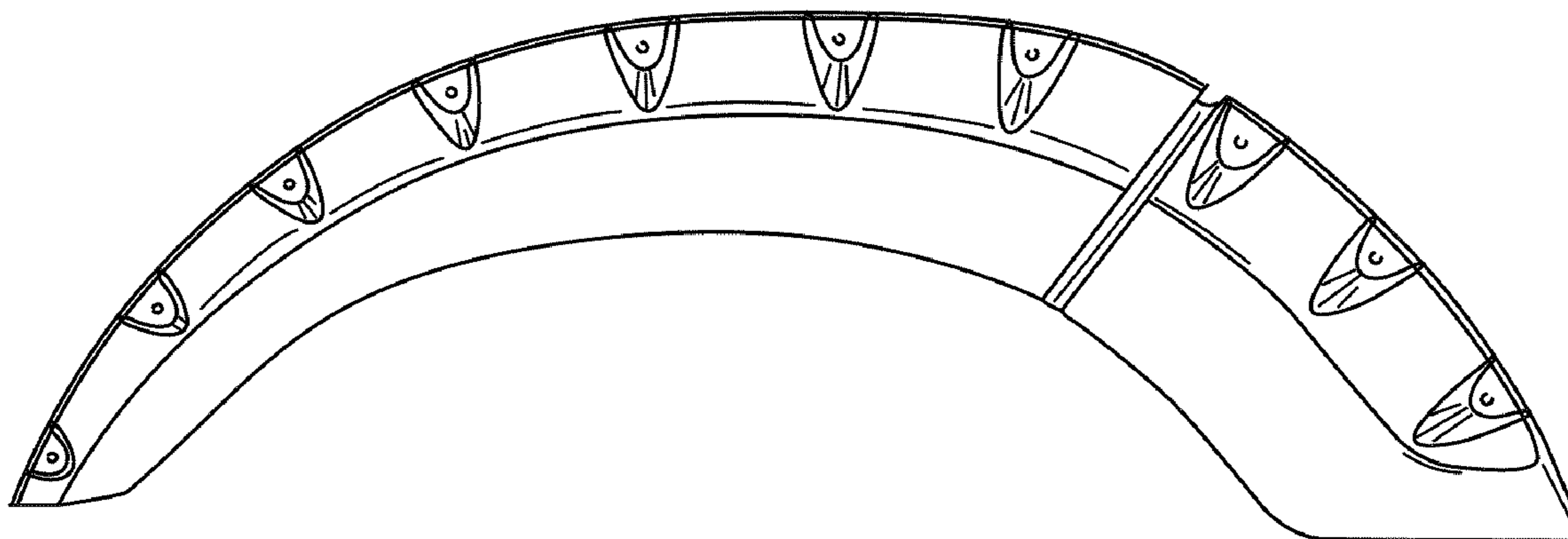
(57) **CLAIM**

The ornamental design for a fender flare of a truck vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a FRONT LEFT view of a fender flare of a truck vehicle showing our new design; FIG. 2 is a RIGHT view thereof; FIG. 3 is a LEFT view thereof; FIG. 4 is a FRONT view thereof; FIG. 5 is a TOP view thereof; and, FIG. 6 is a REAR view thereof.

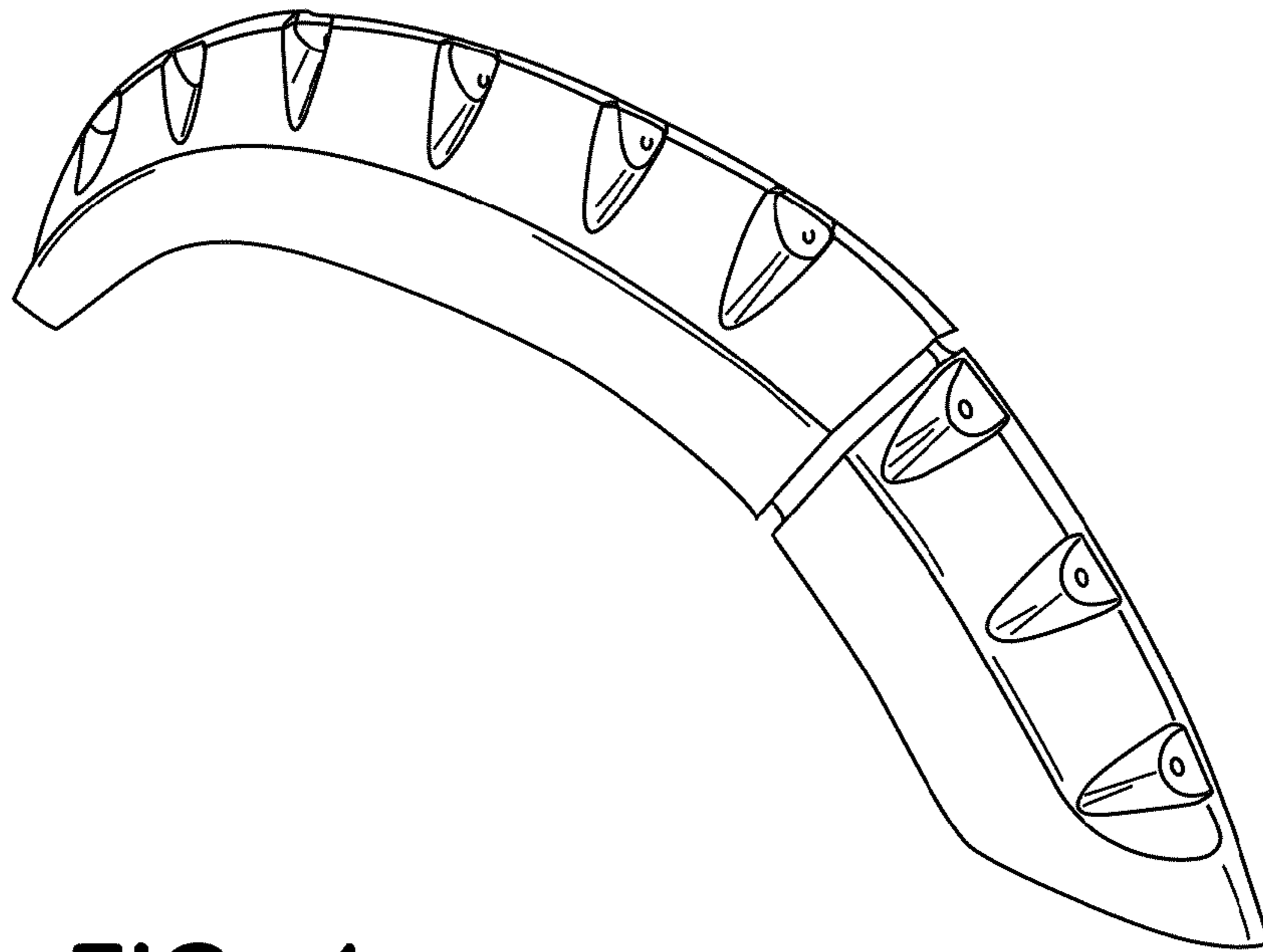

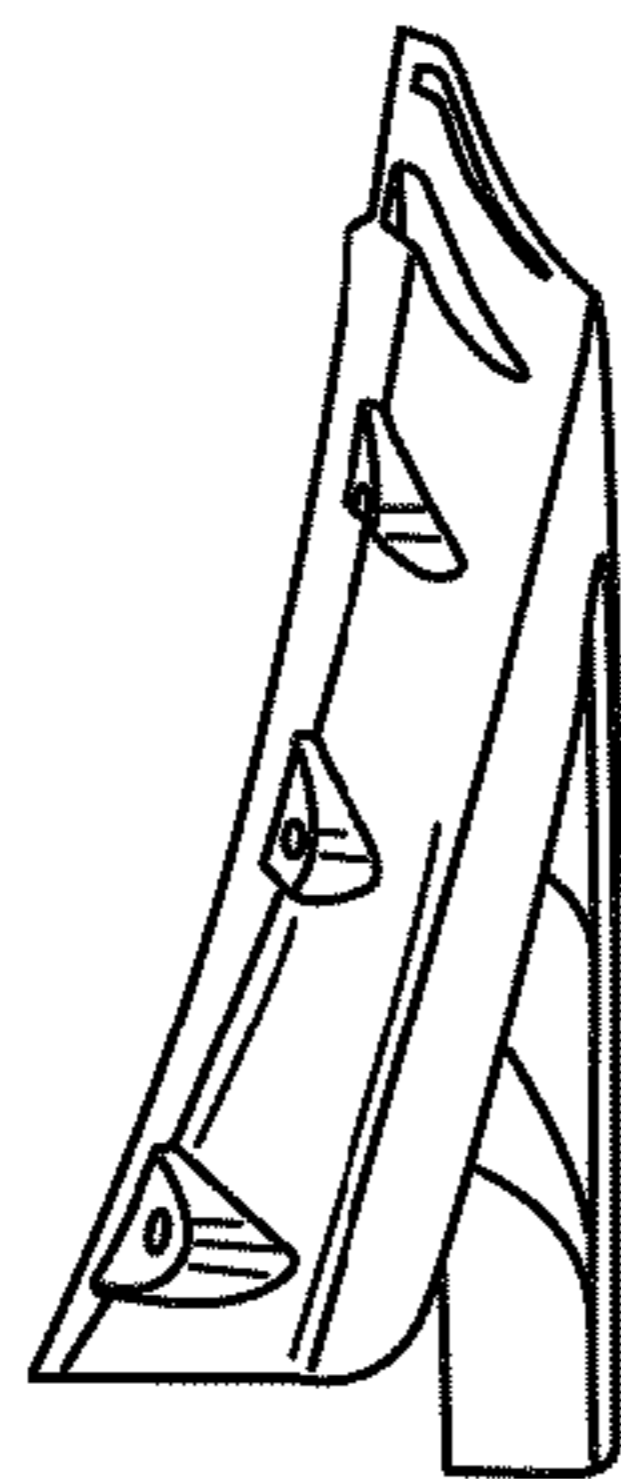

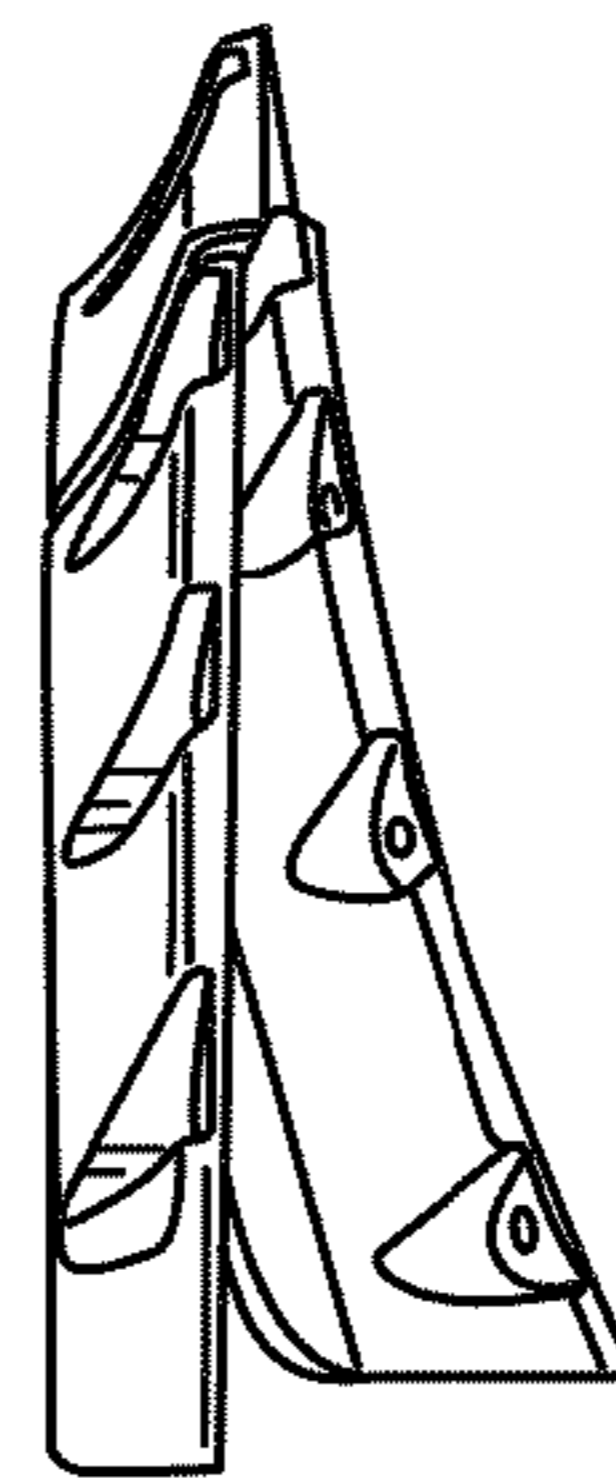

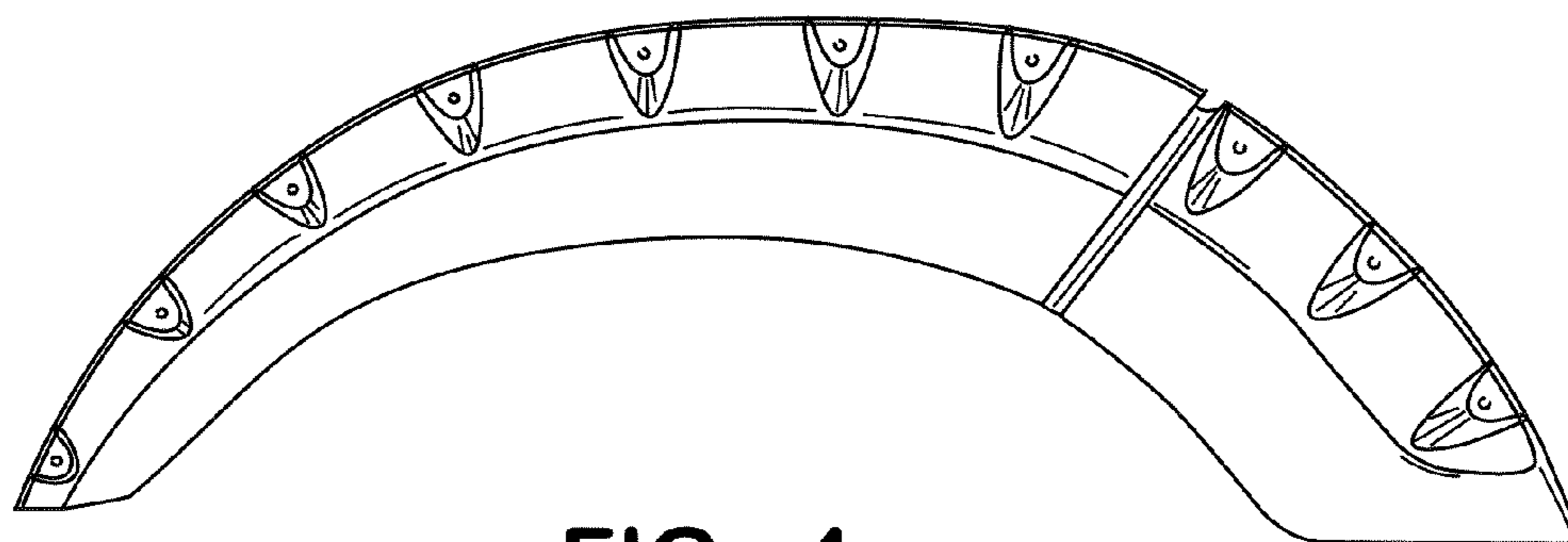

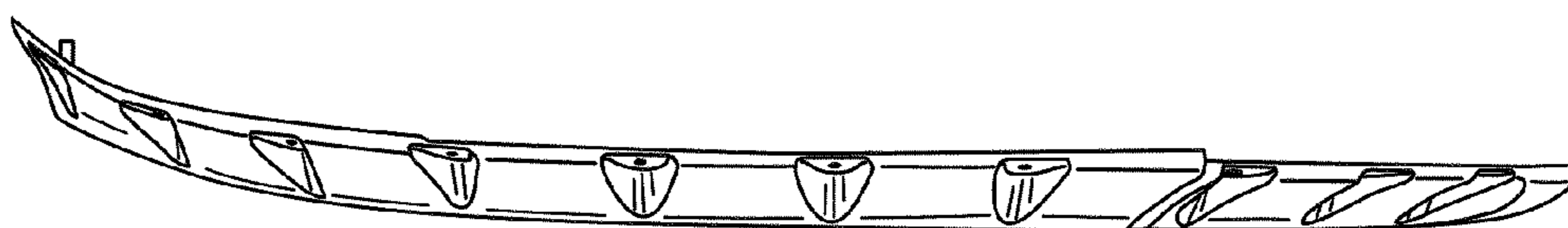

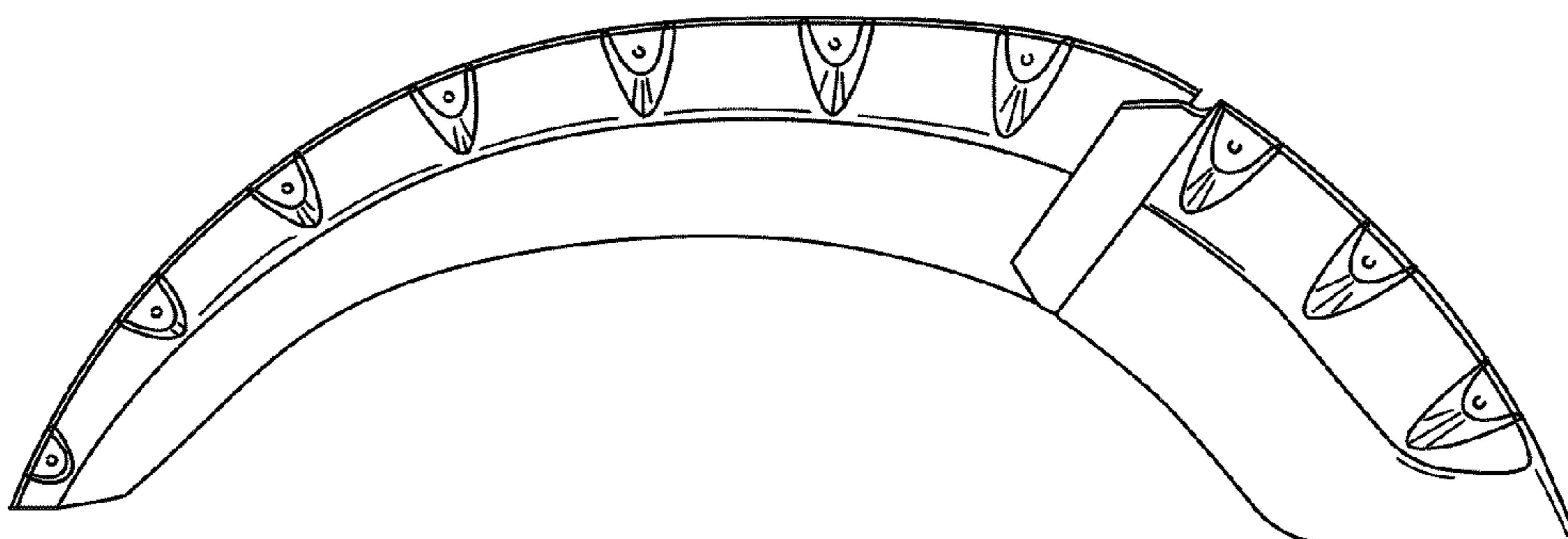
