(57) **CLAIM**

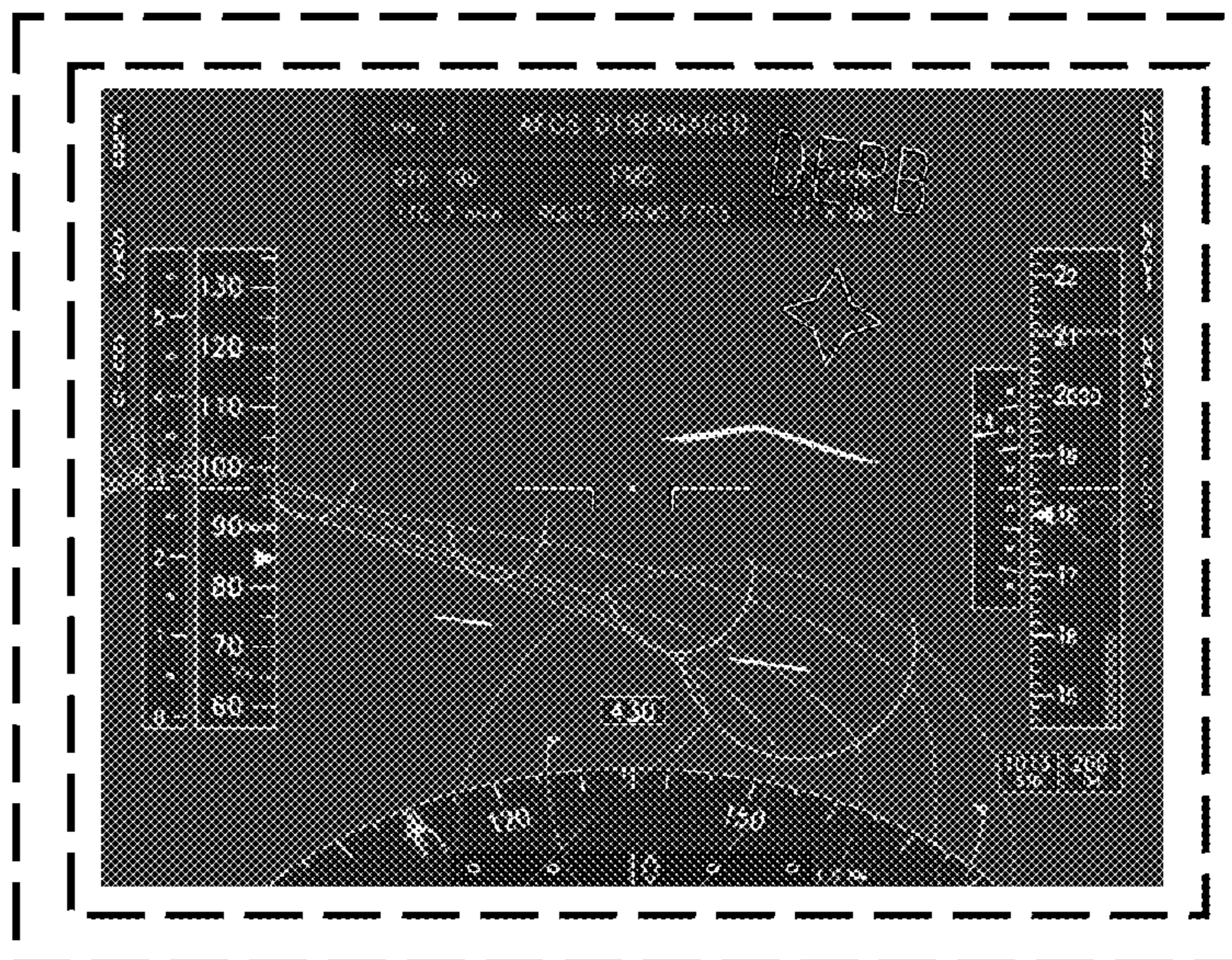
The ornamental design for a graphical user interface for an image for a cockpit display screen, as shown and described.

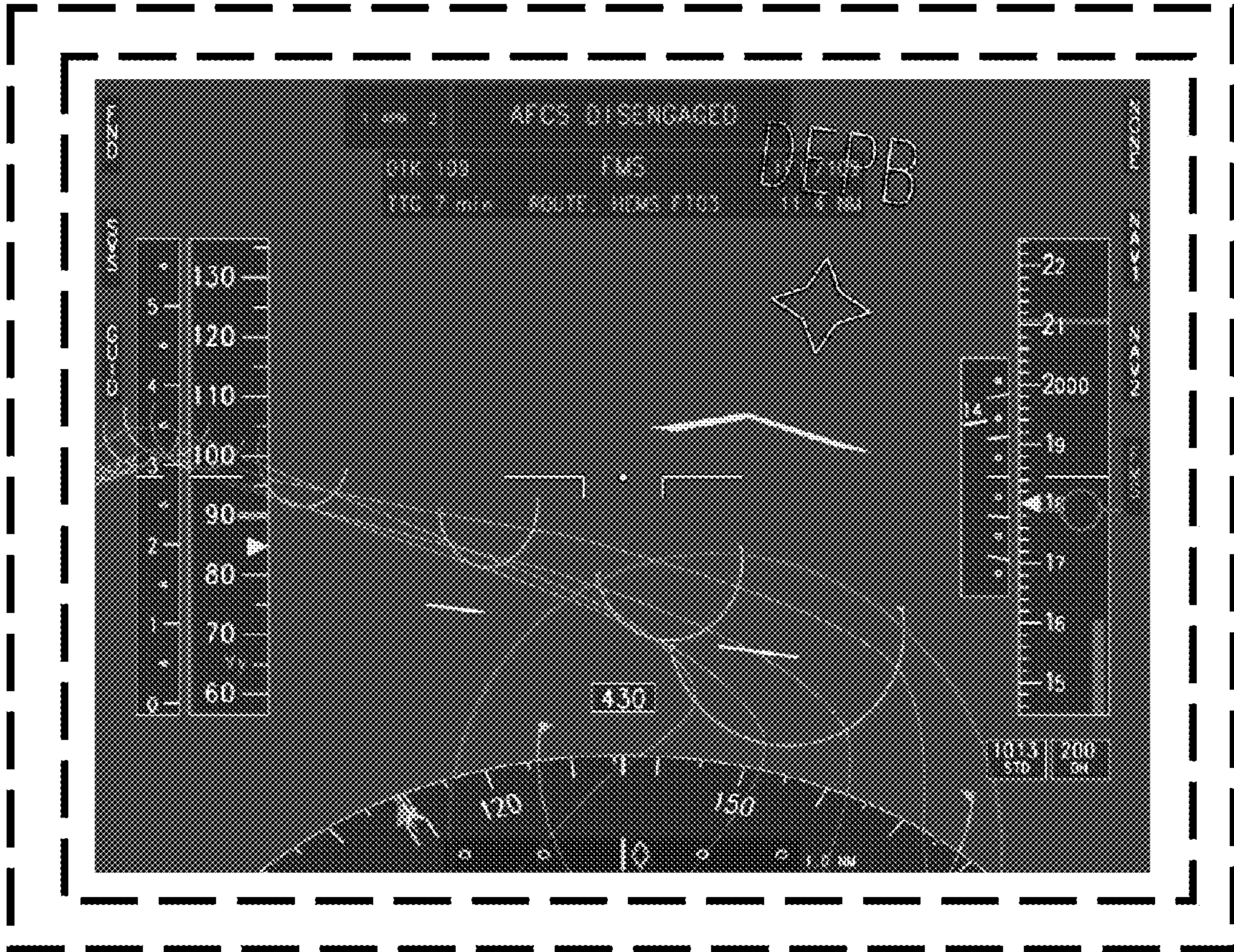
DESCRIPTION
