FIG. 13 is the thirteenth image thereof;

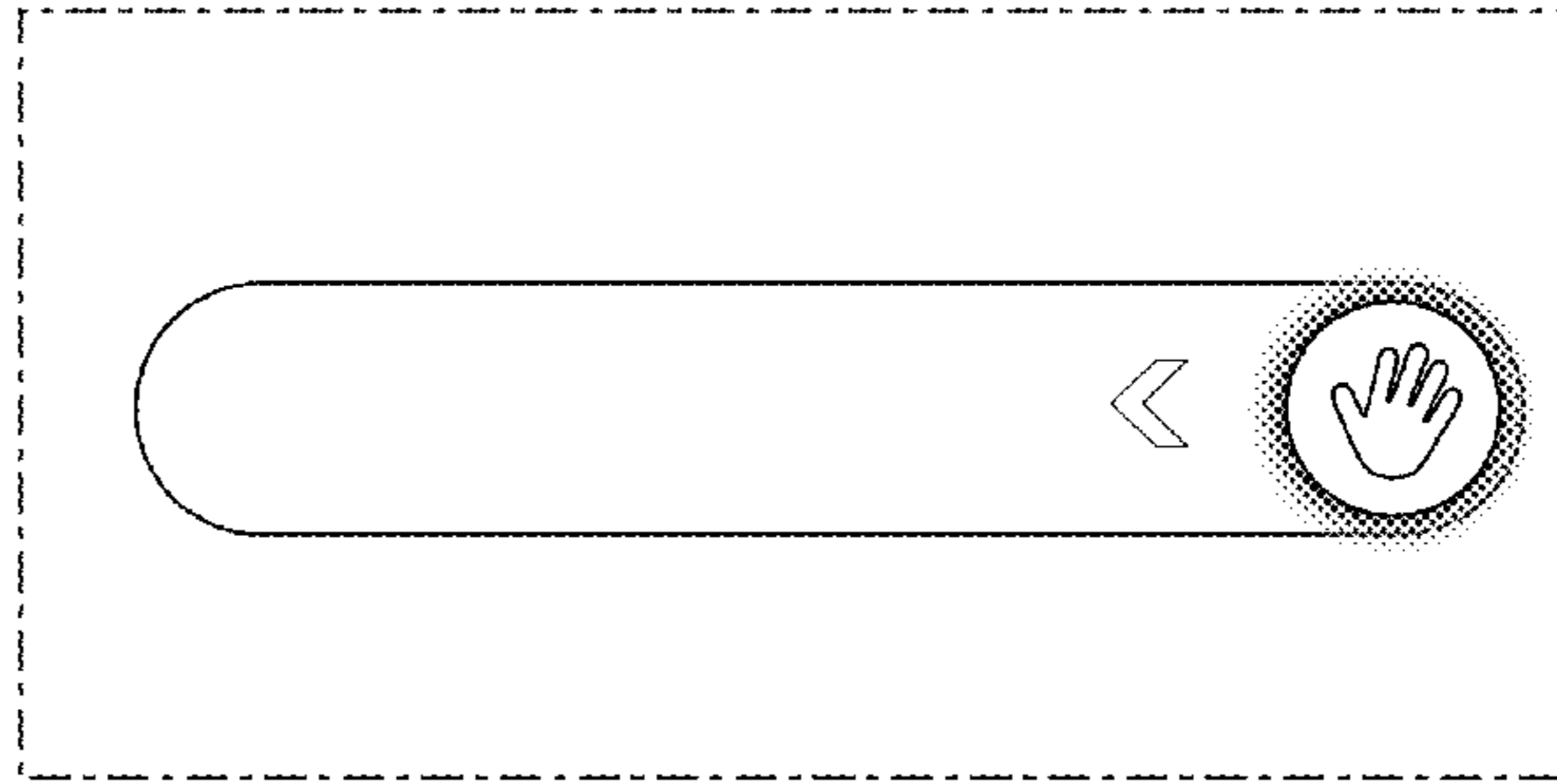
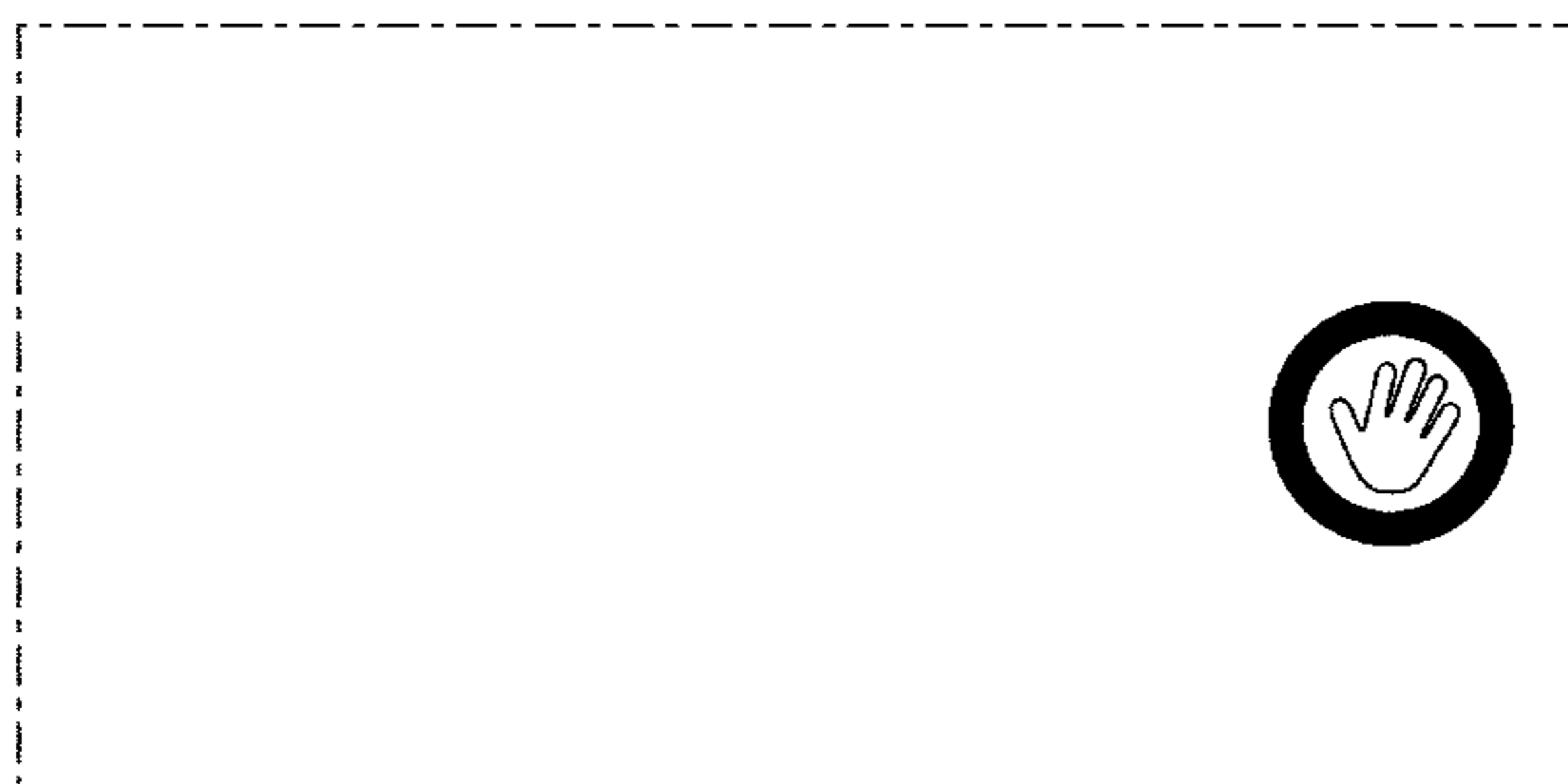
FIG. 14 is the fourteenth image thereof;

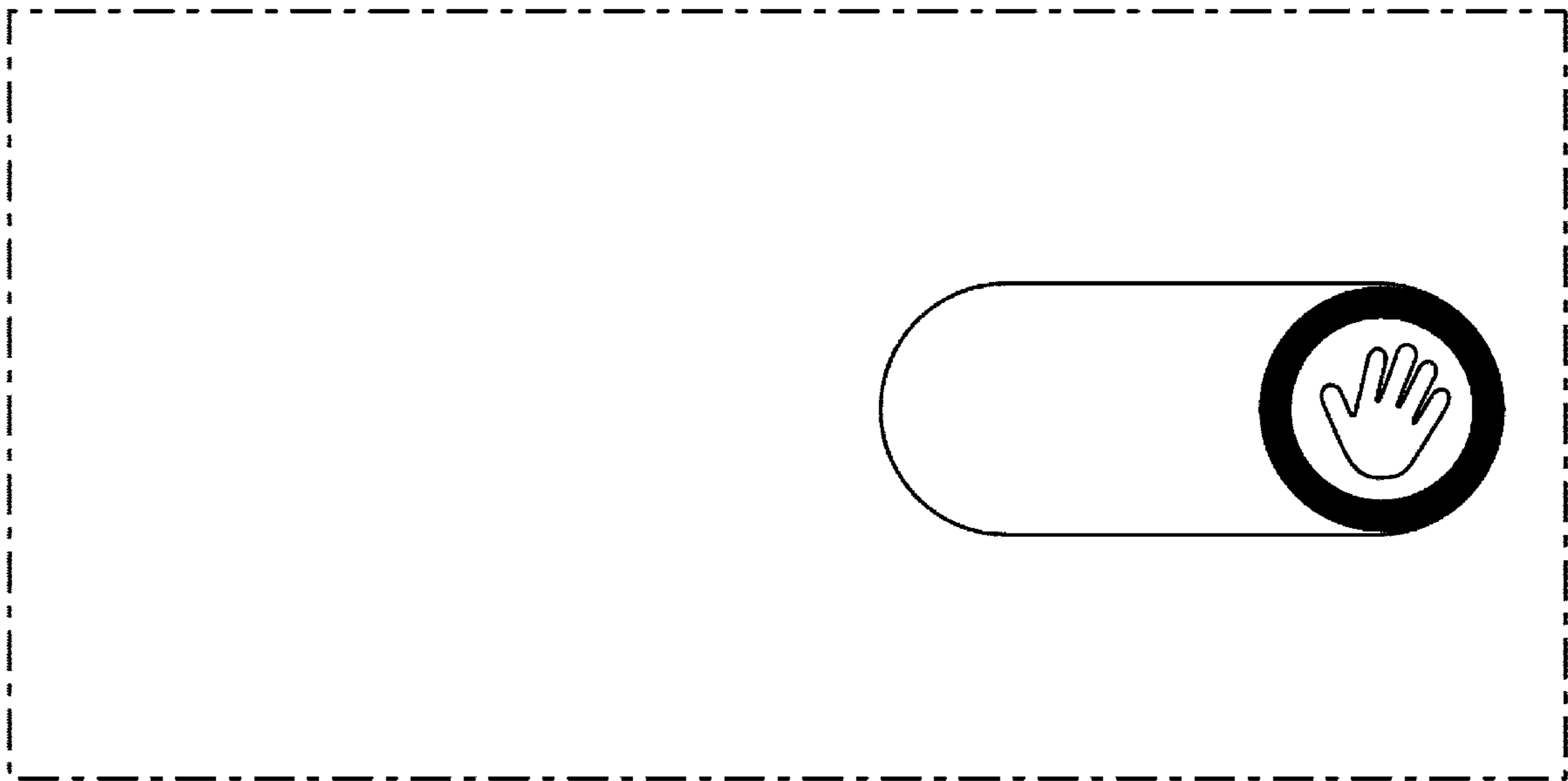

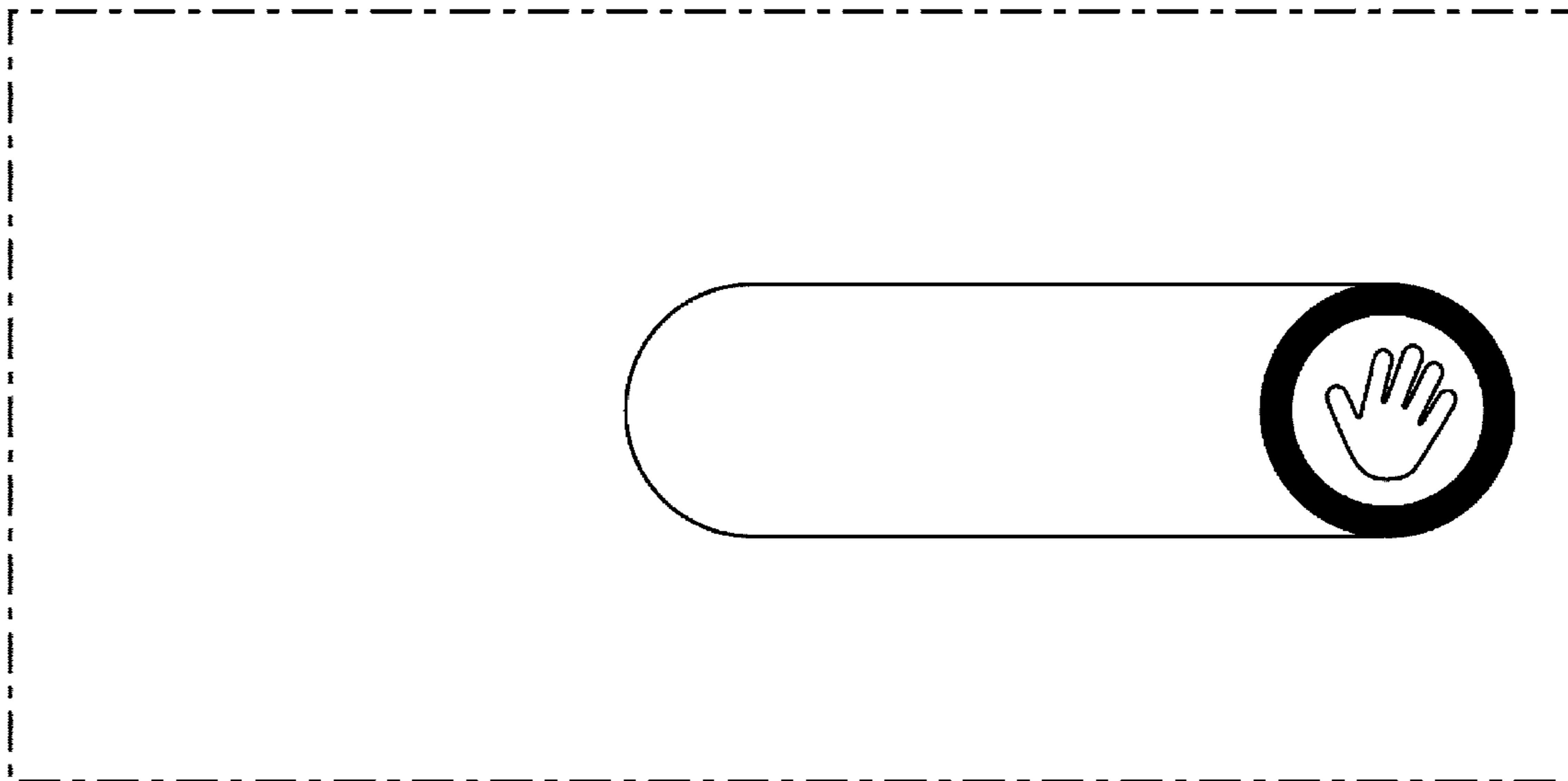

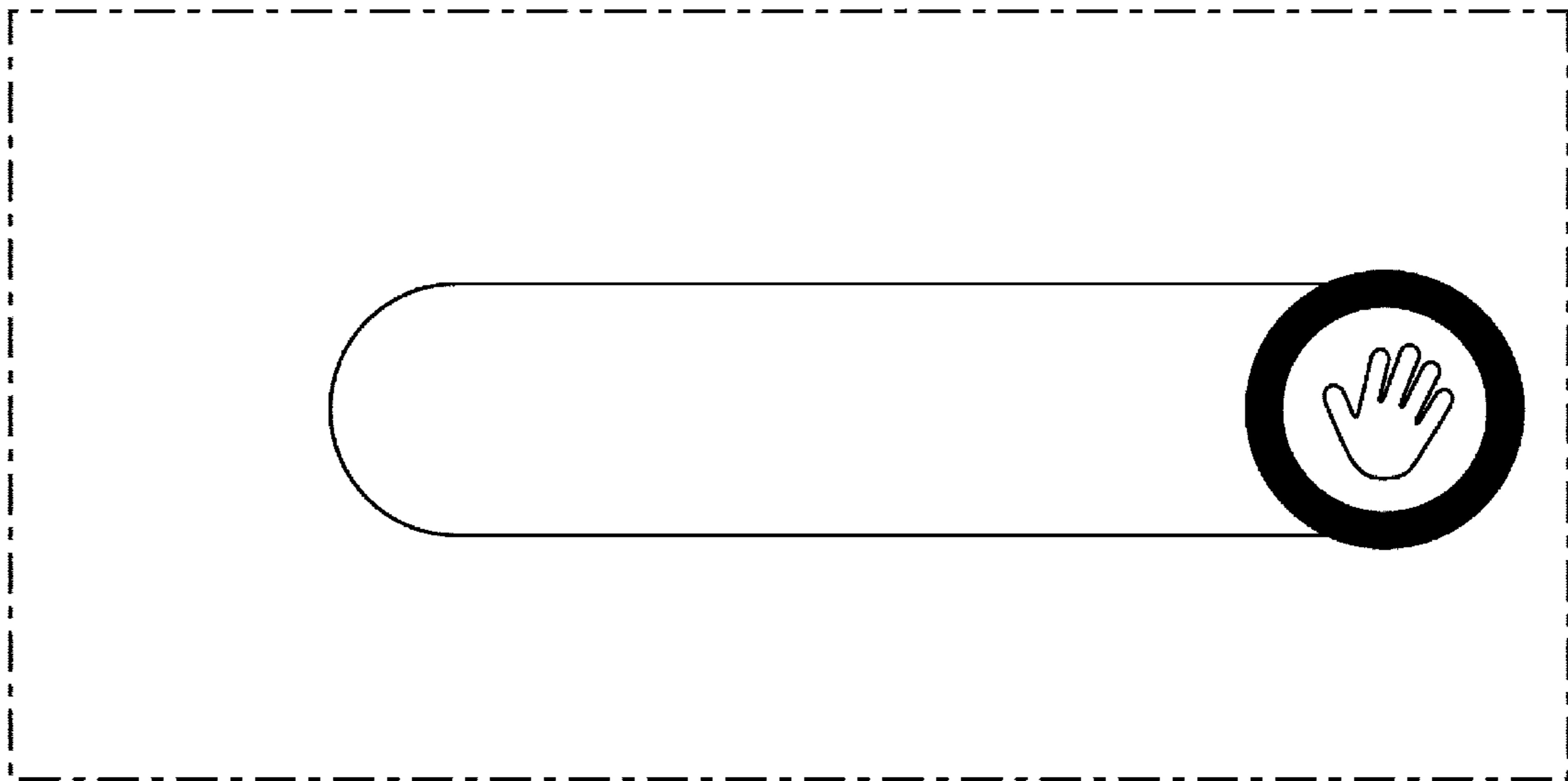

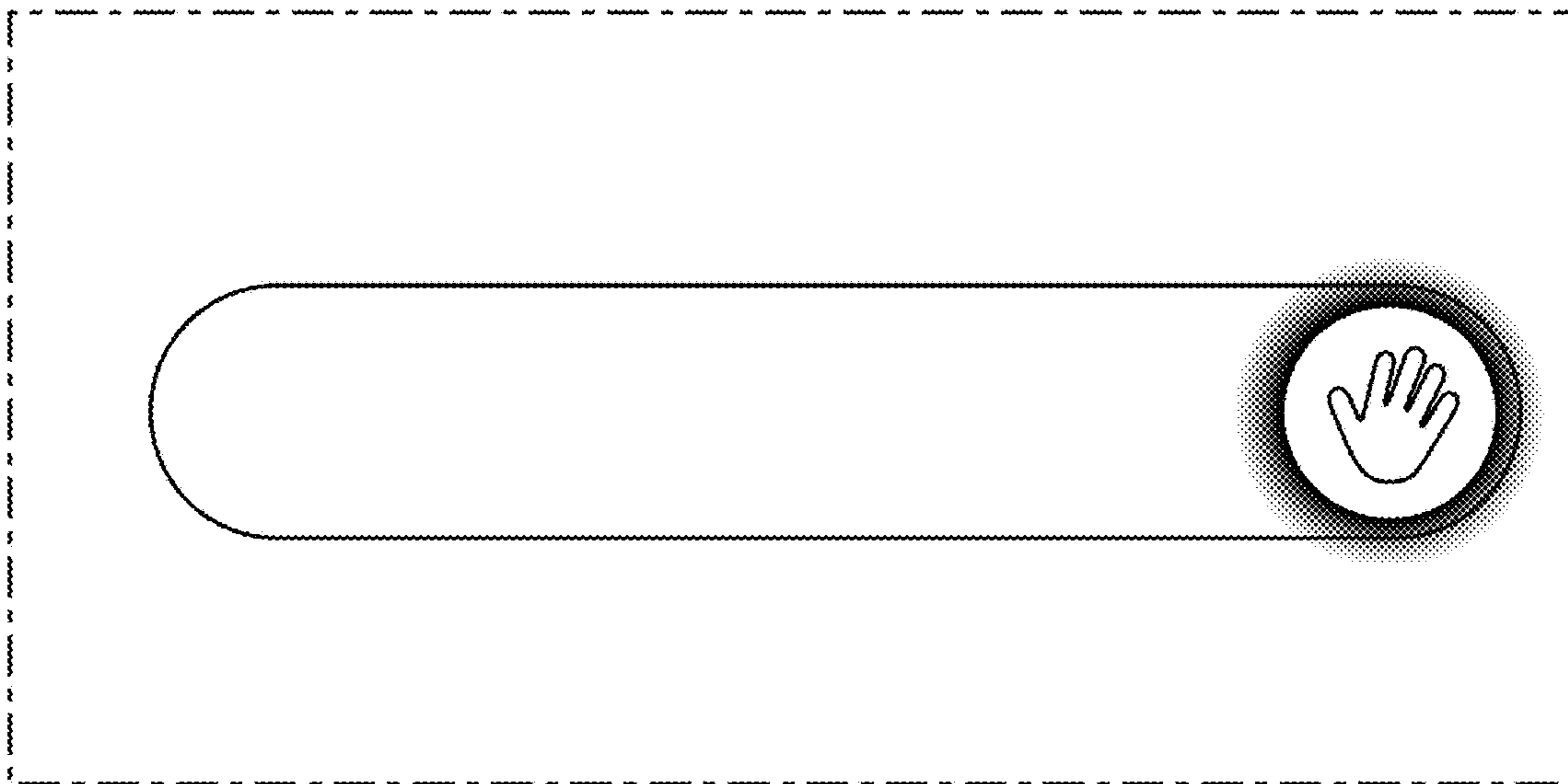

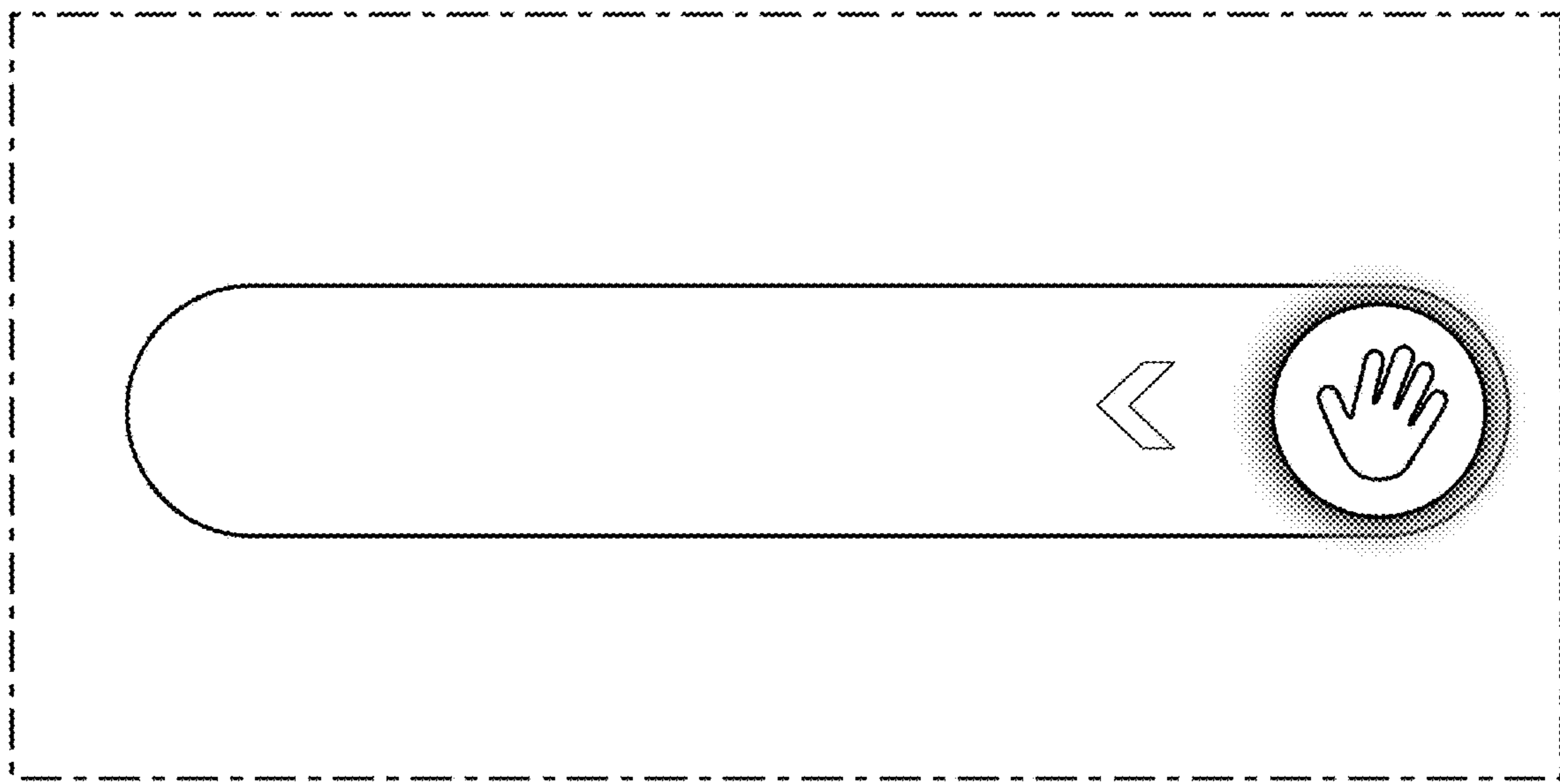

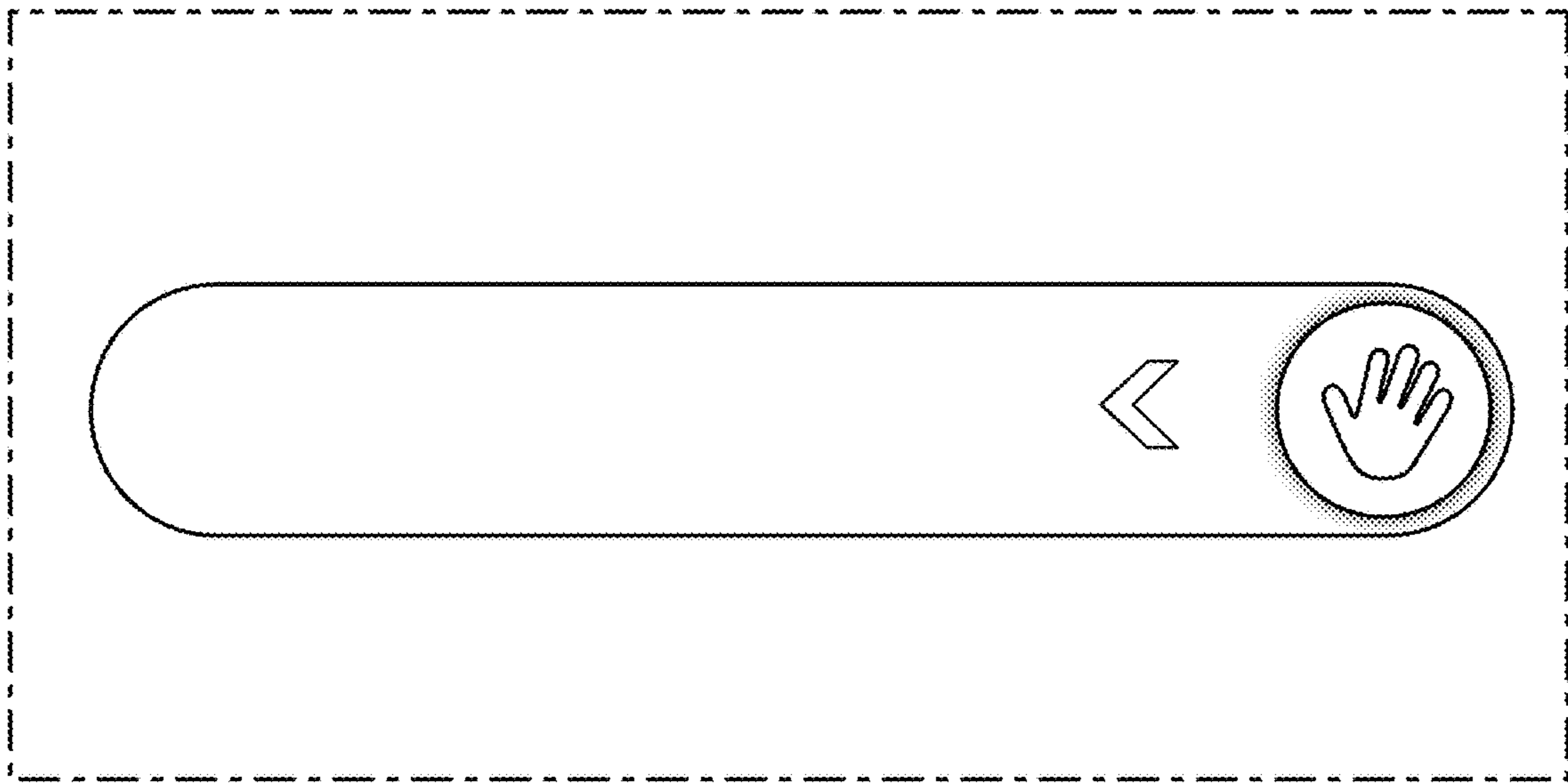

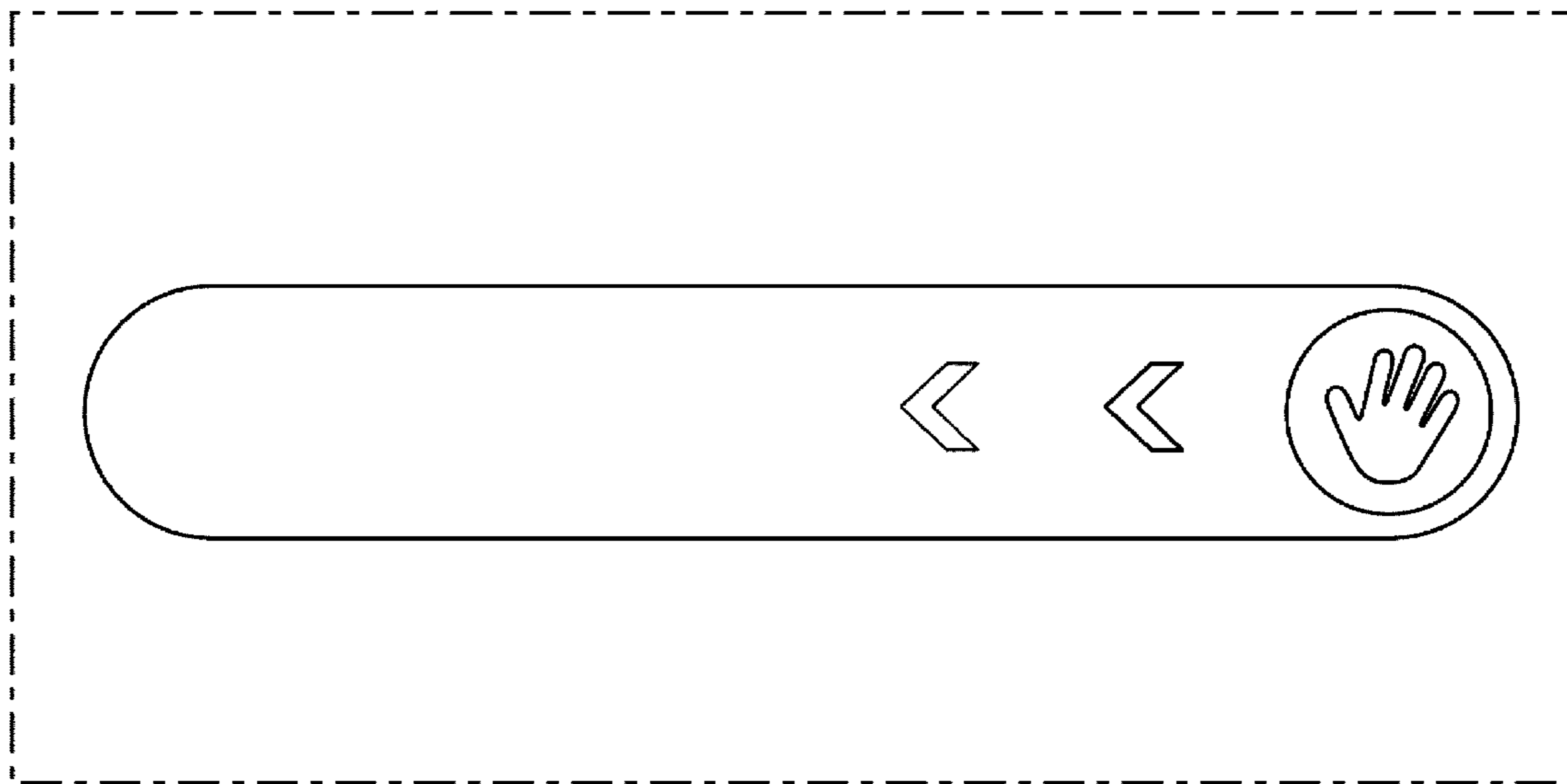

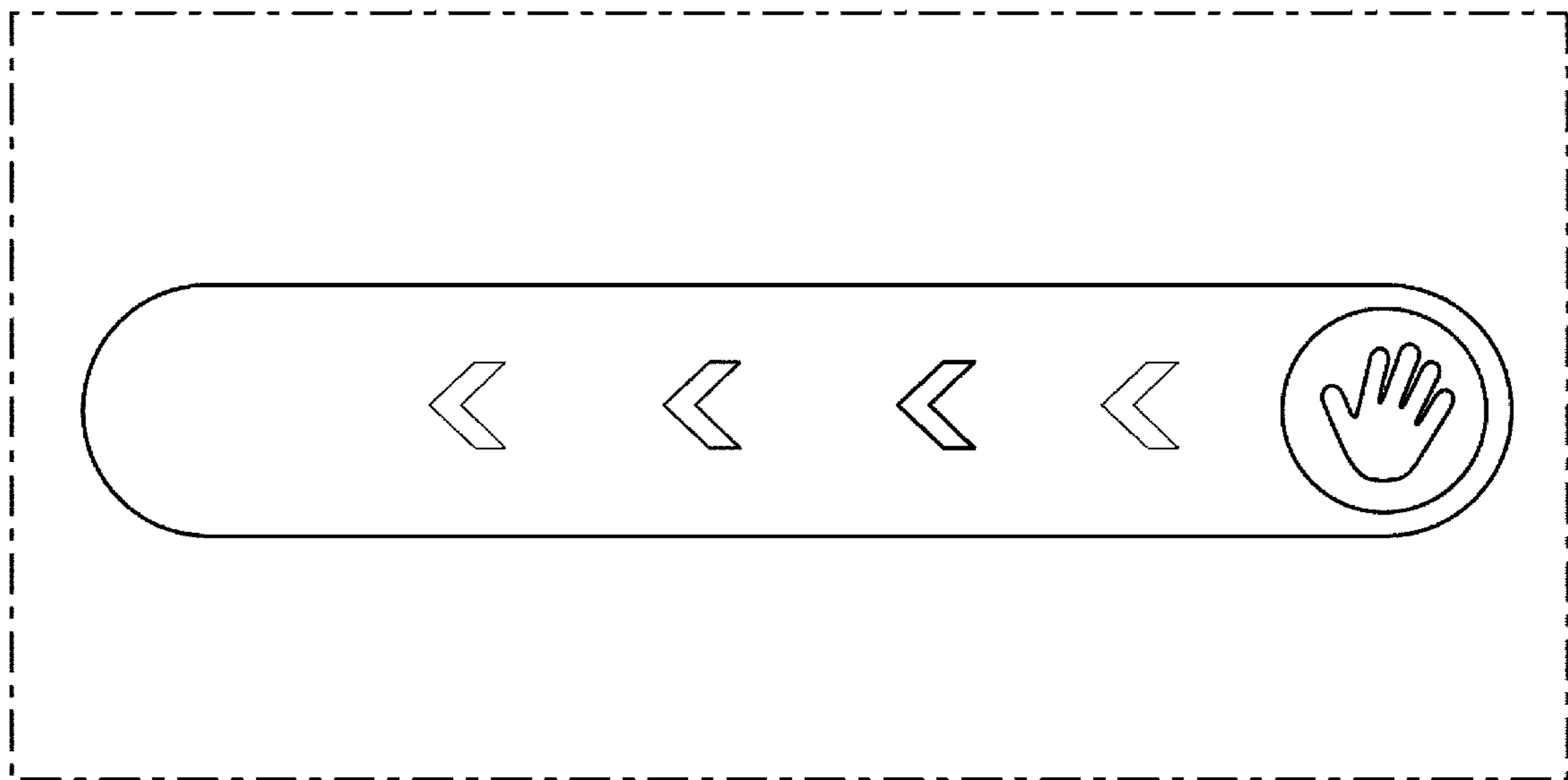

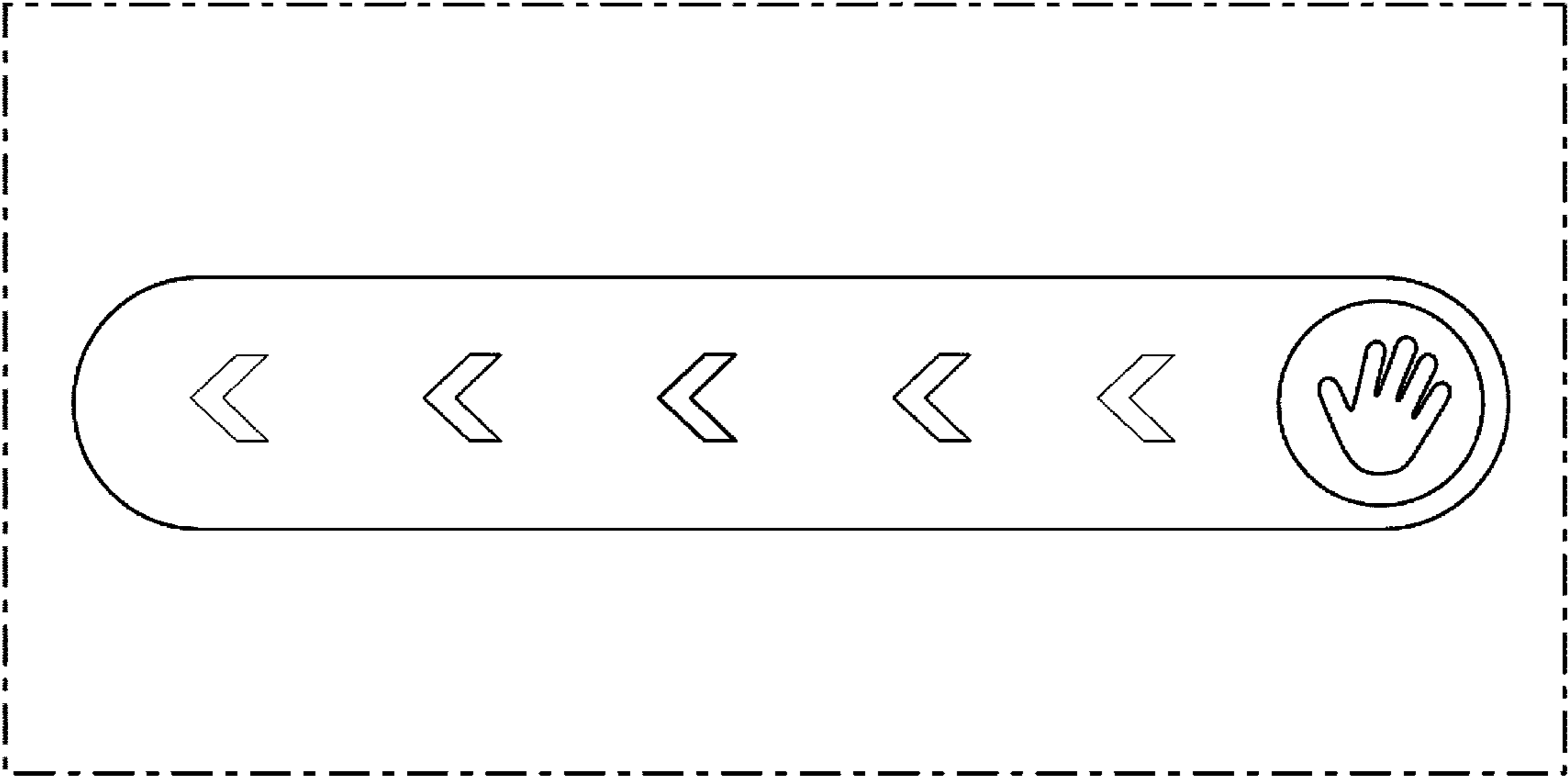

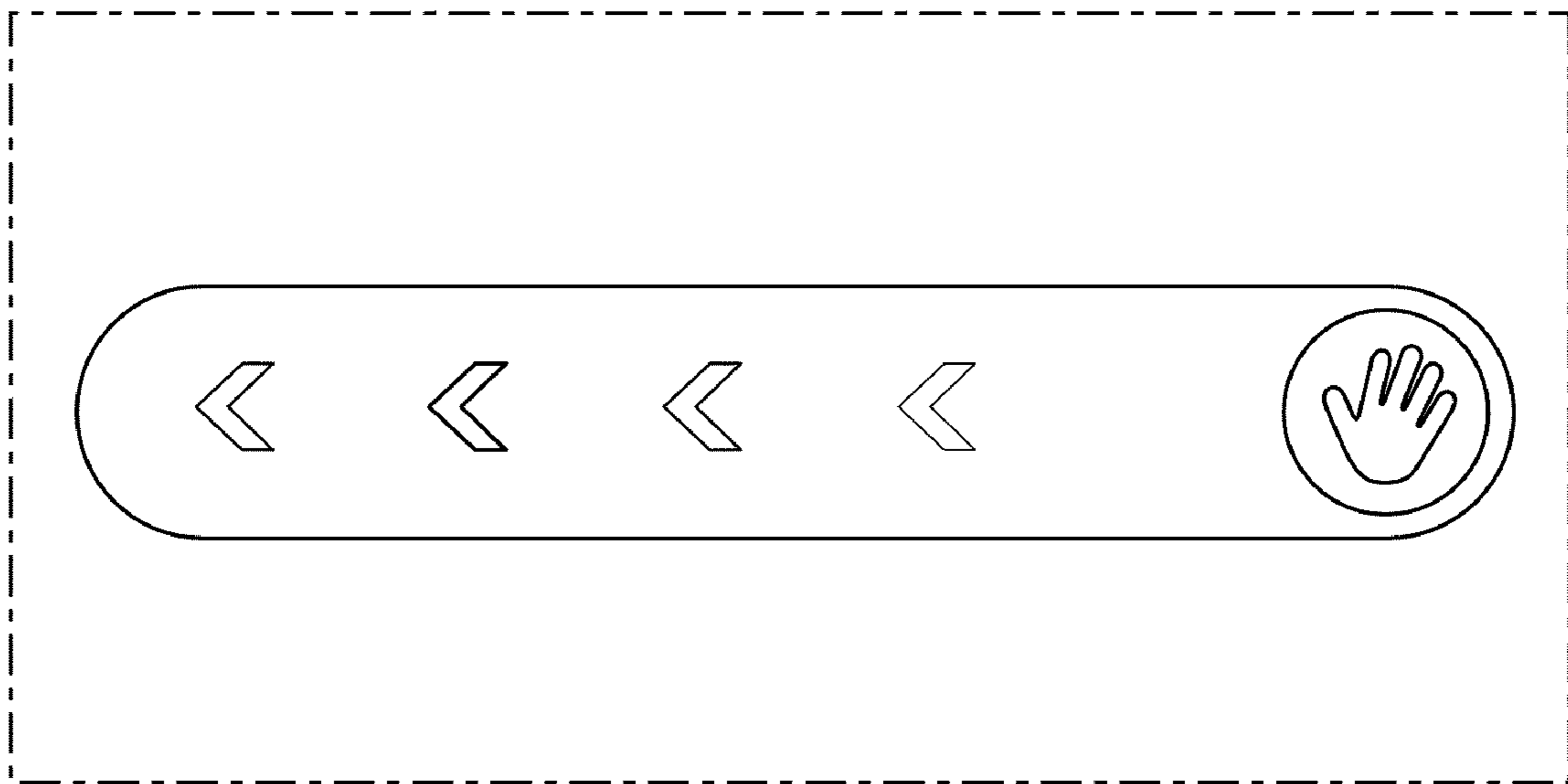

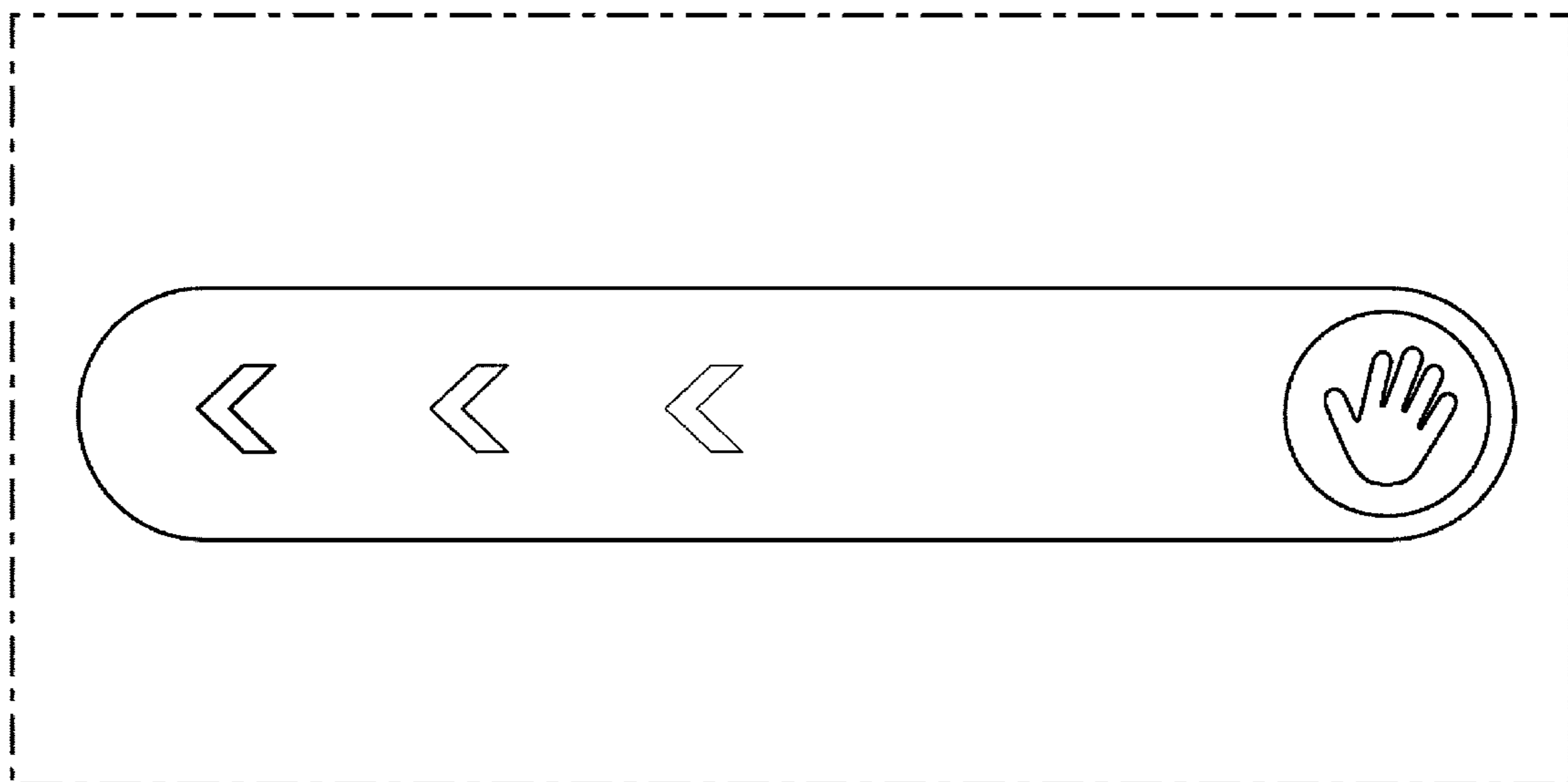

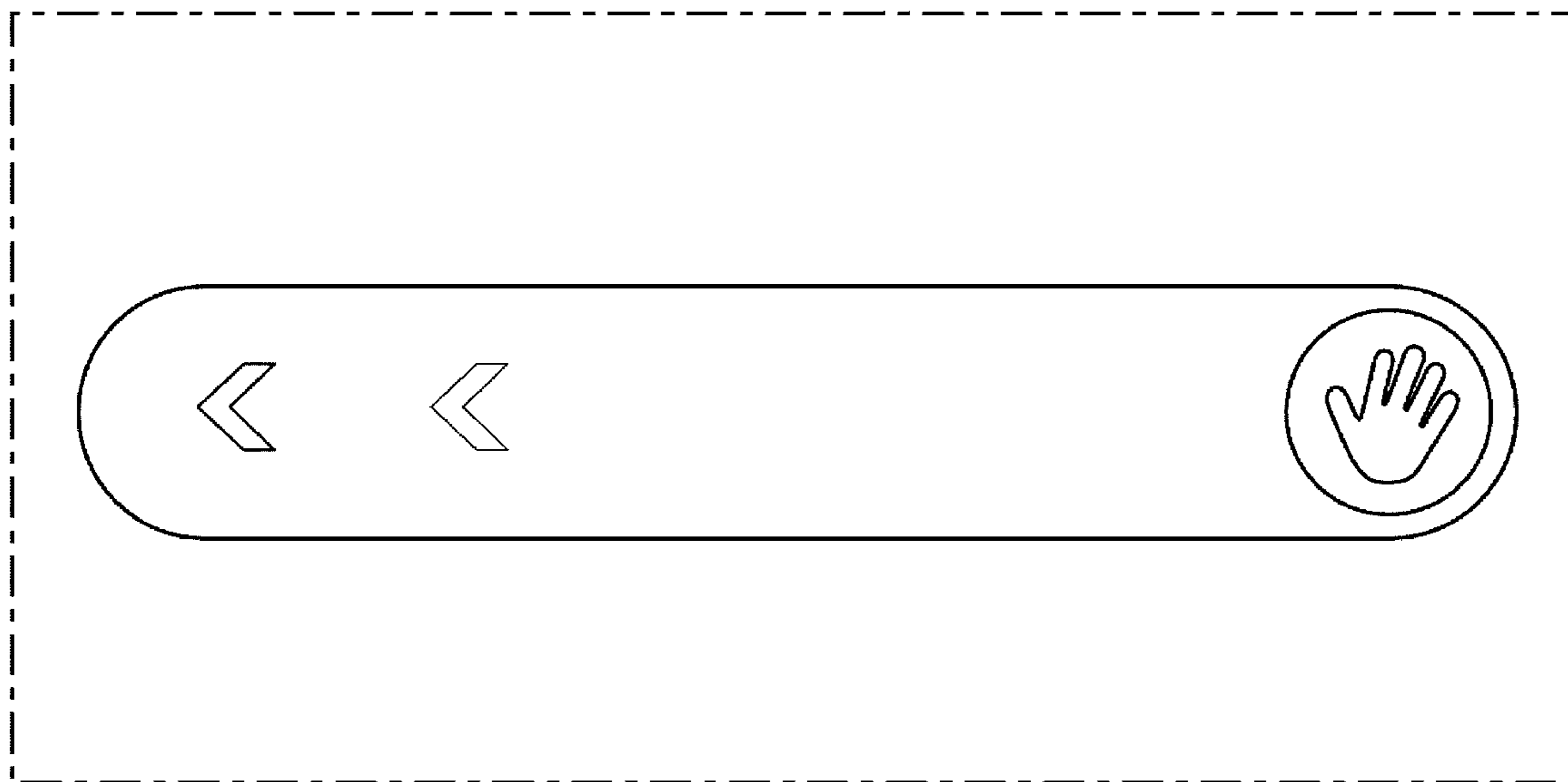

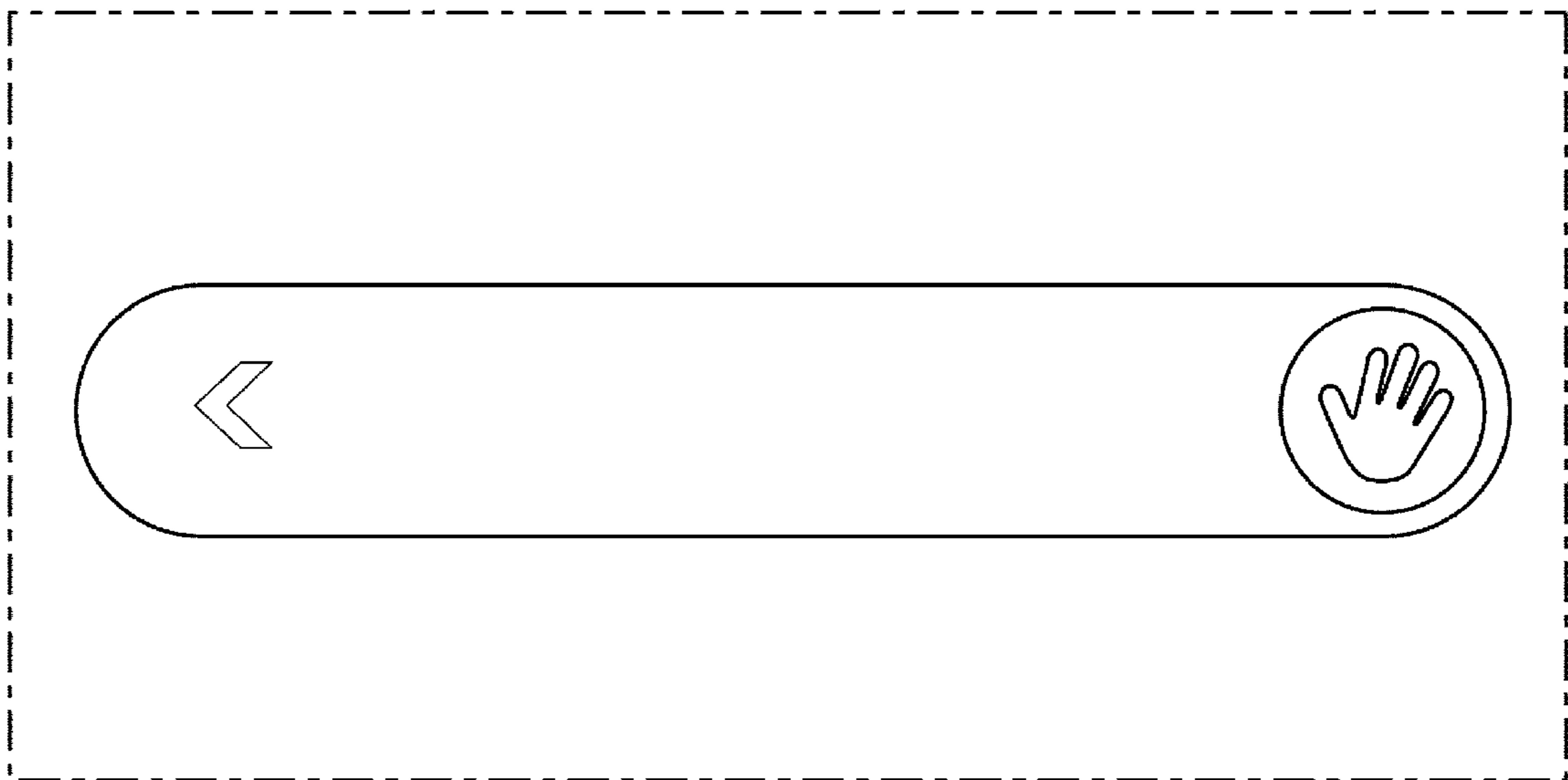

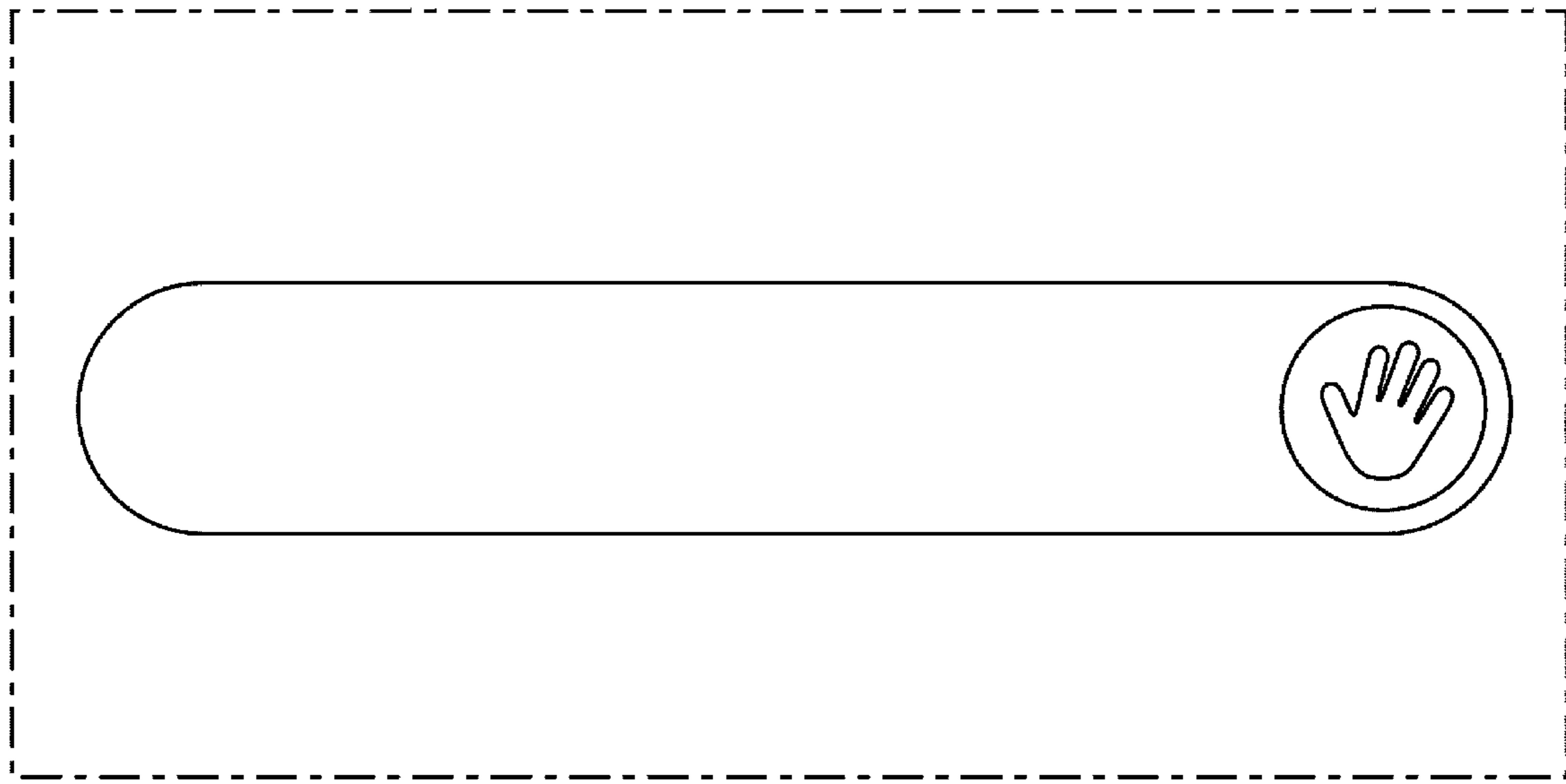
