(57) **CLAIM**

The ornamental design for a book cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of our new design for a book cover.

FIG. 2 is an front elevational view of the book cover shown in FIG. 1.

FIG. 3 is an elevational view of the left side of the book cover shown in FIG. 1.

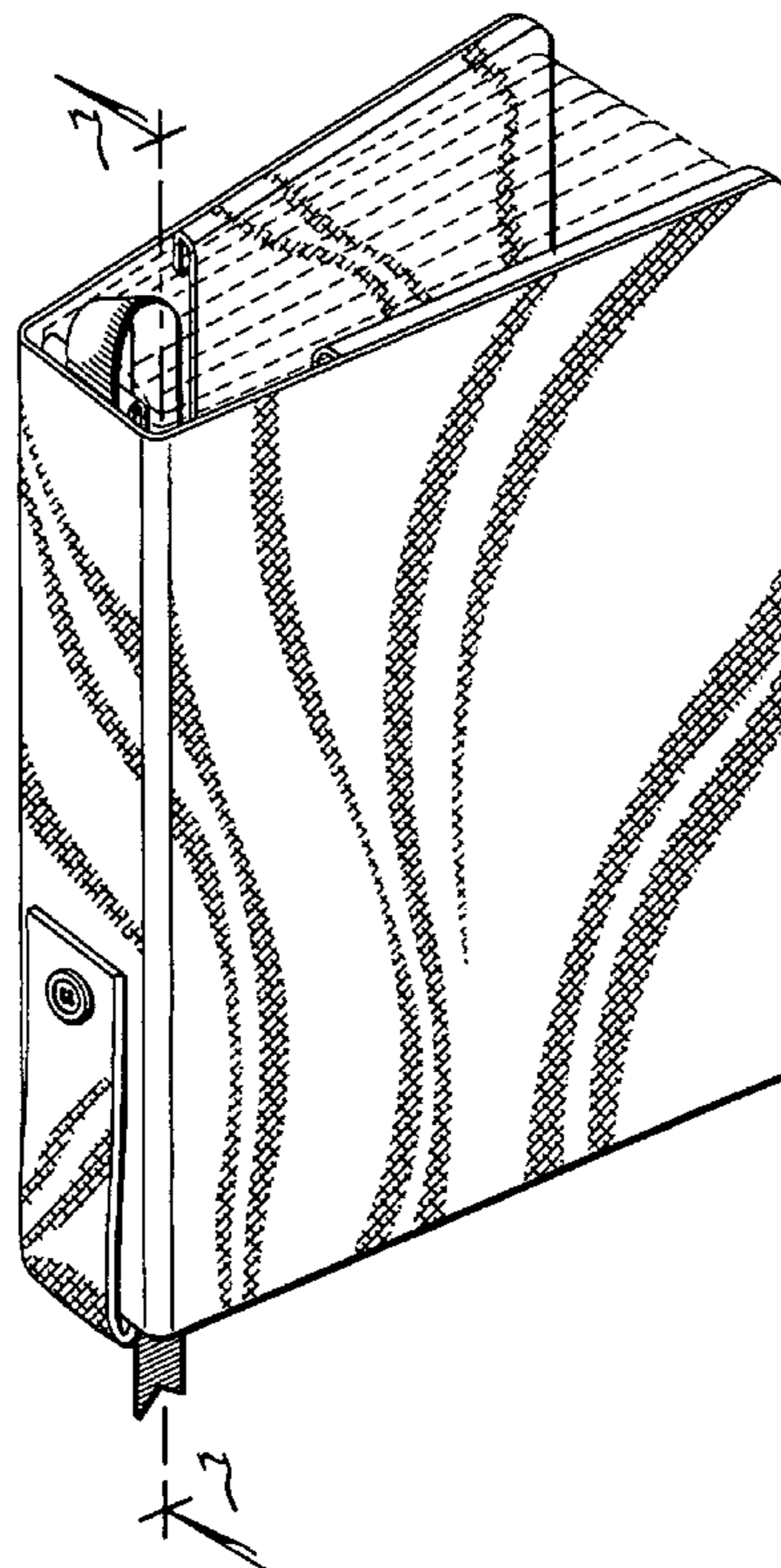
FIG. 4 is an elevational view of the interior spine of the book cover shown in FIG. 1.

FIG. 5 is a top plan view of the book cover shown in FIG. 1. FIG. 6 is a bottom plan view of the book cover shown in FIG. 1; and,

FIG. 7 is an elevational view along the lines 7-7 of the book cover of FIG. 1. with the front and back sides shown in an open position.

The broken line elements of FIGS. 1, and 7, representing pages of a book, are environmental, and form no part of the invention.

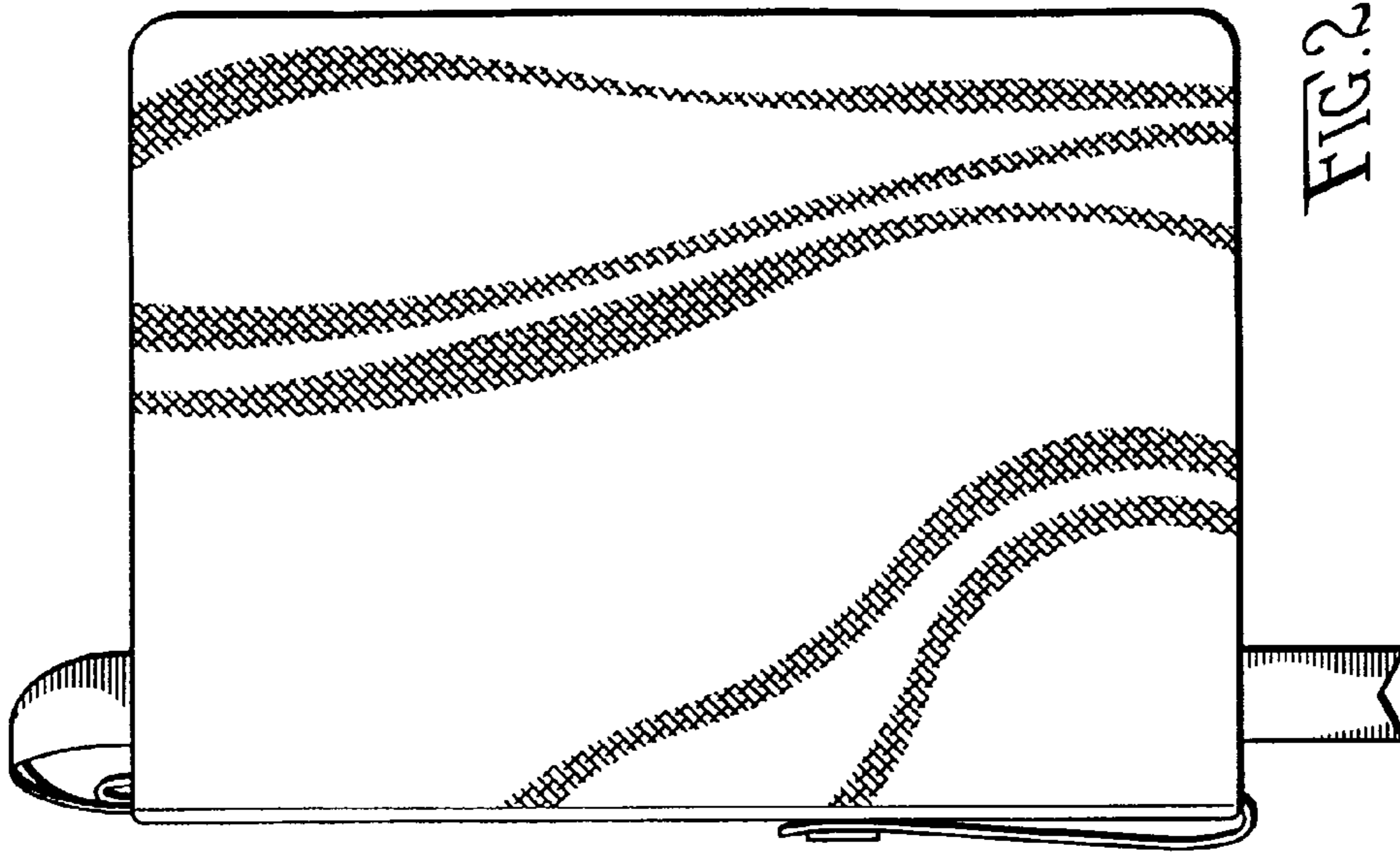

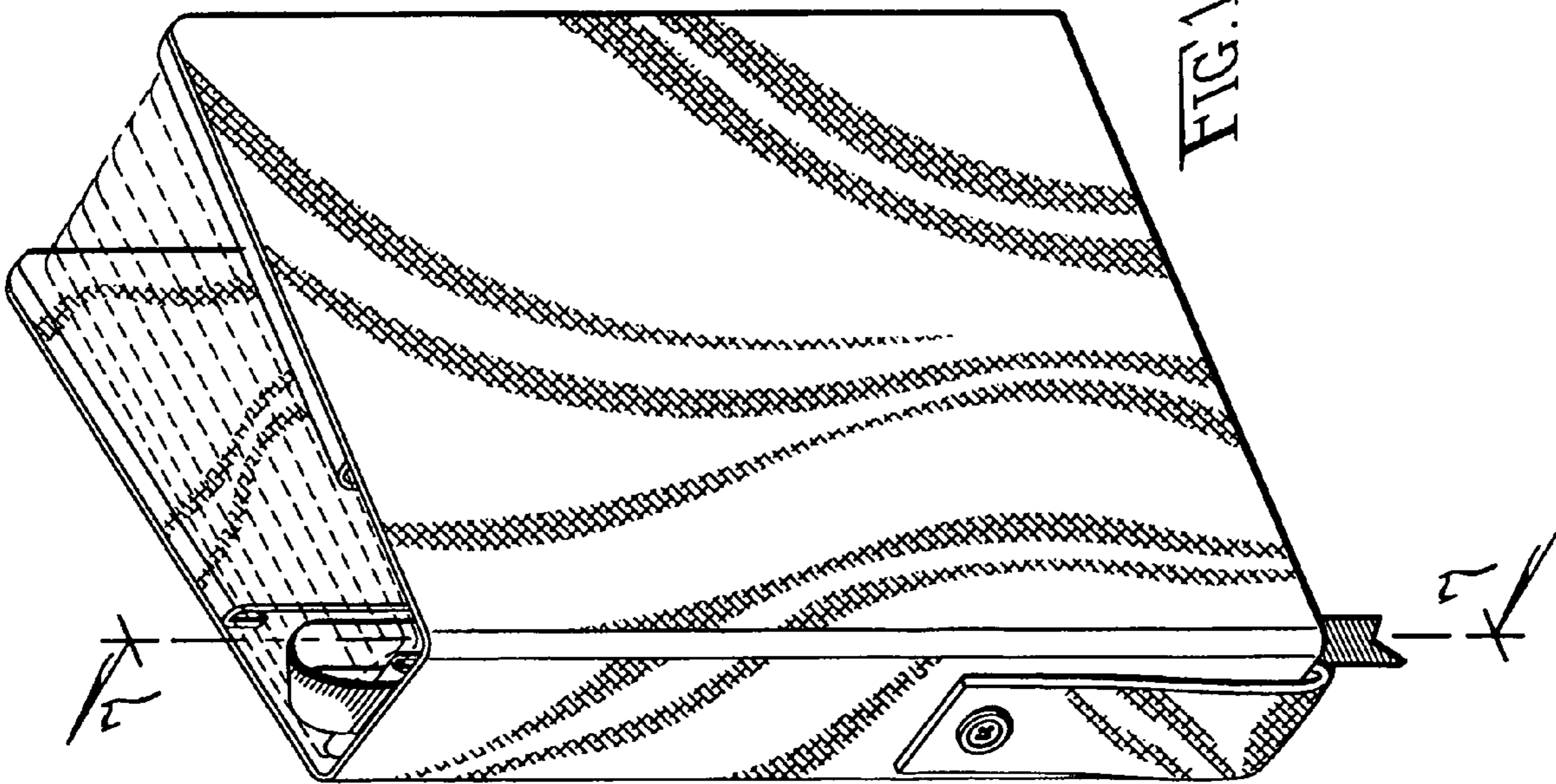
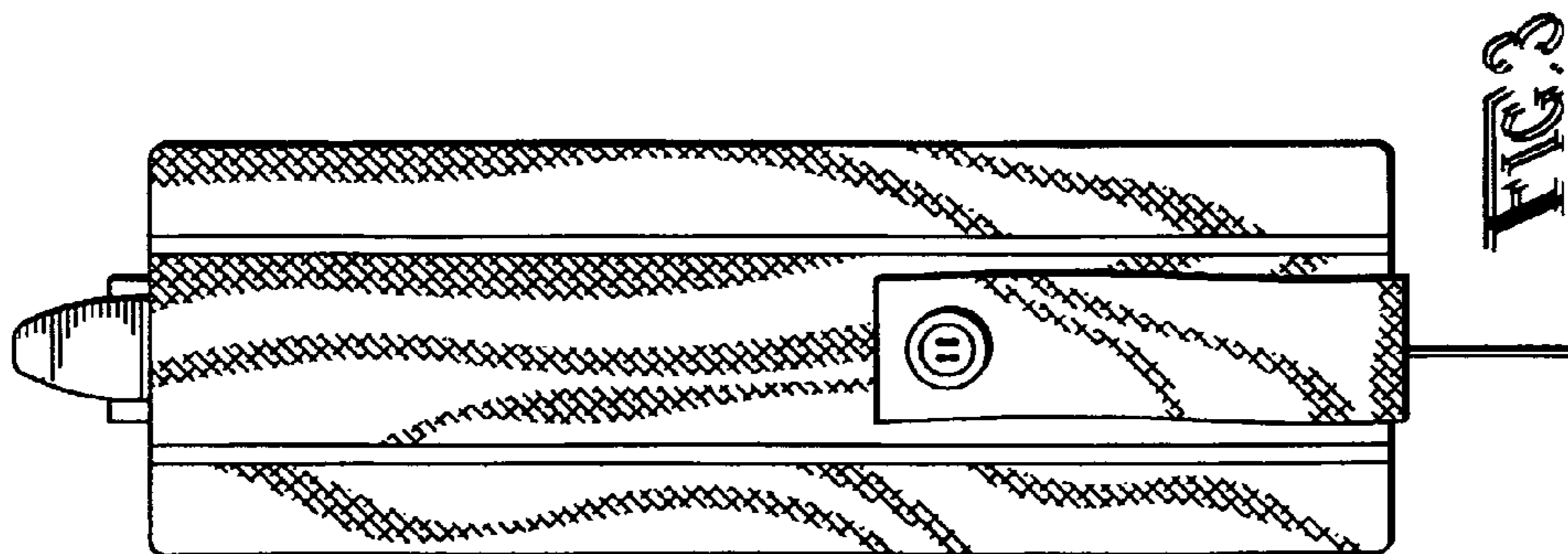
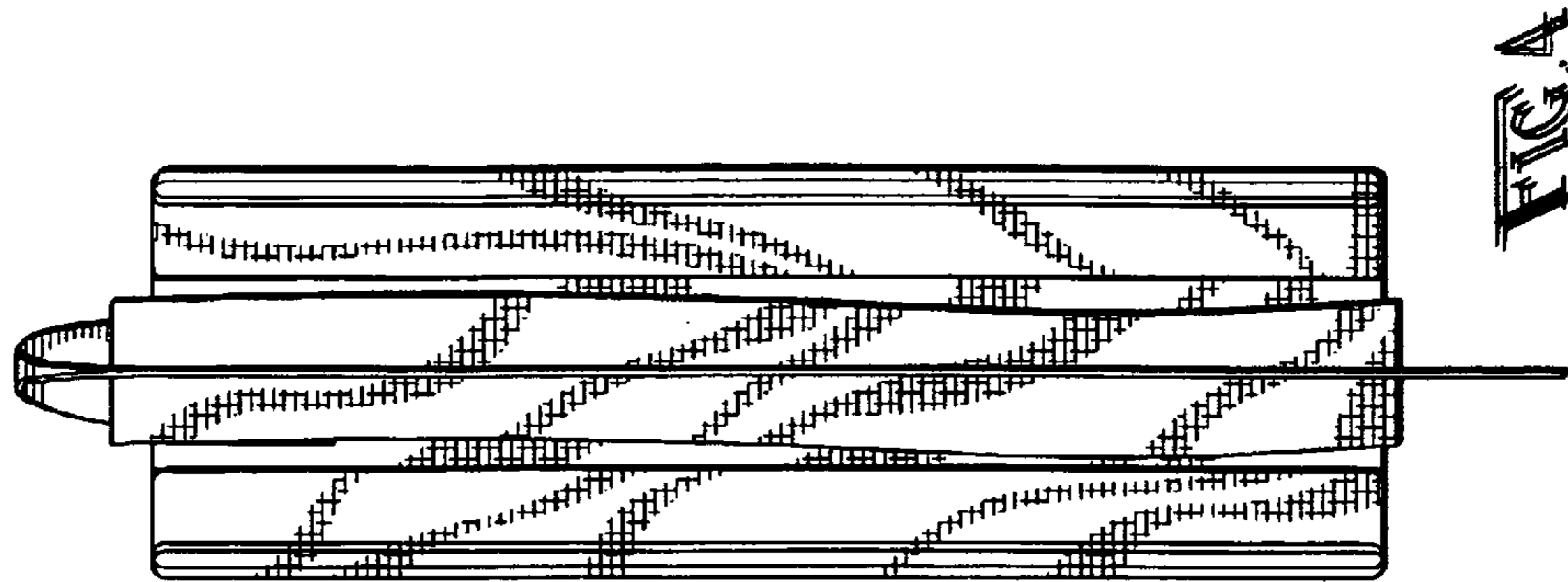

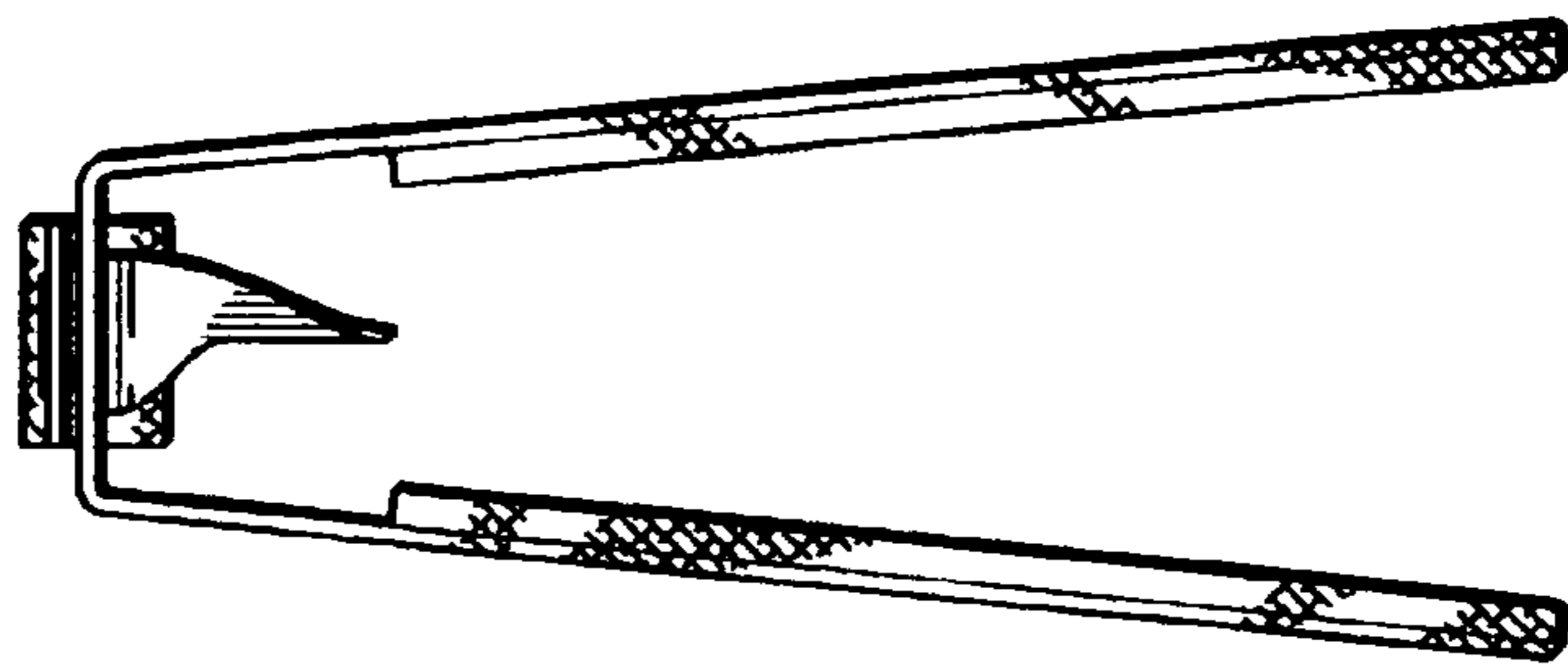

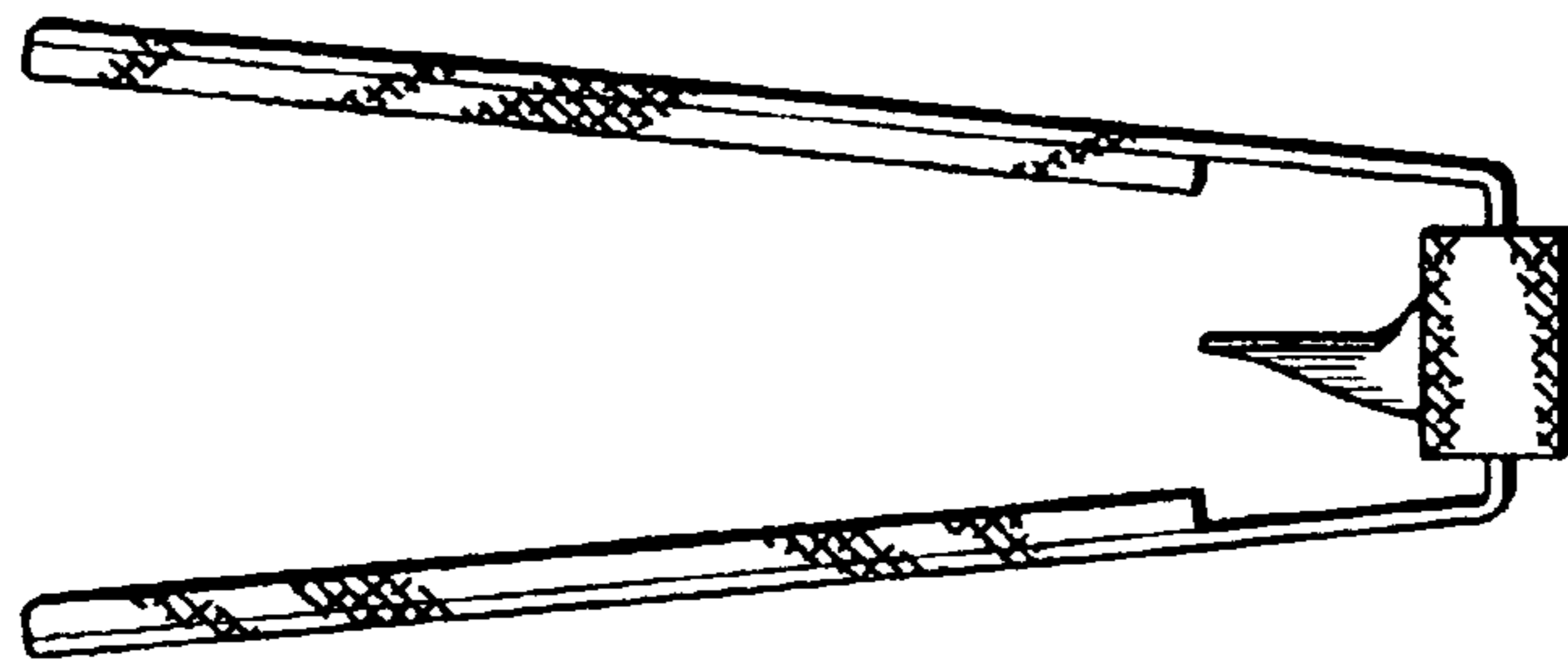
