(57) **CLAIM**

I claim the ornamental design for an electronic probe head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electronic probe head with the electrical cable and connector used with said electronic probe head shown in phantom lines;

FIG. 2 is an upper left perspective view of an electronic probe head thereof;

FIG. 3 is a top view thereof;

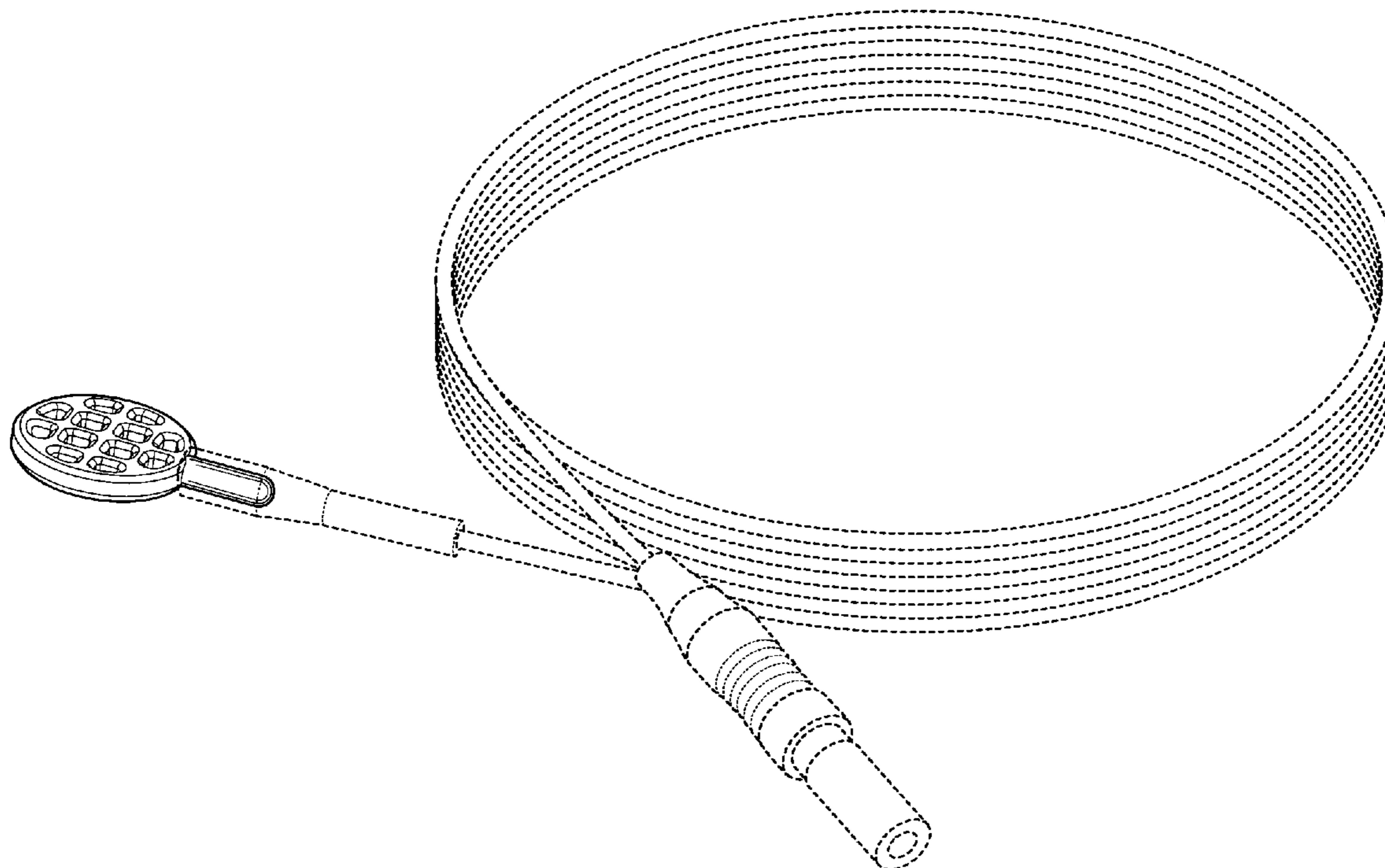
FIG. 4 is a bottom view thereof;

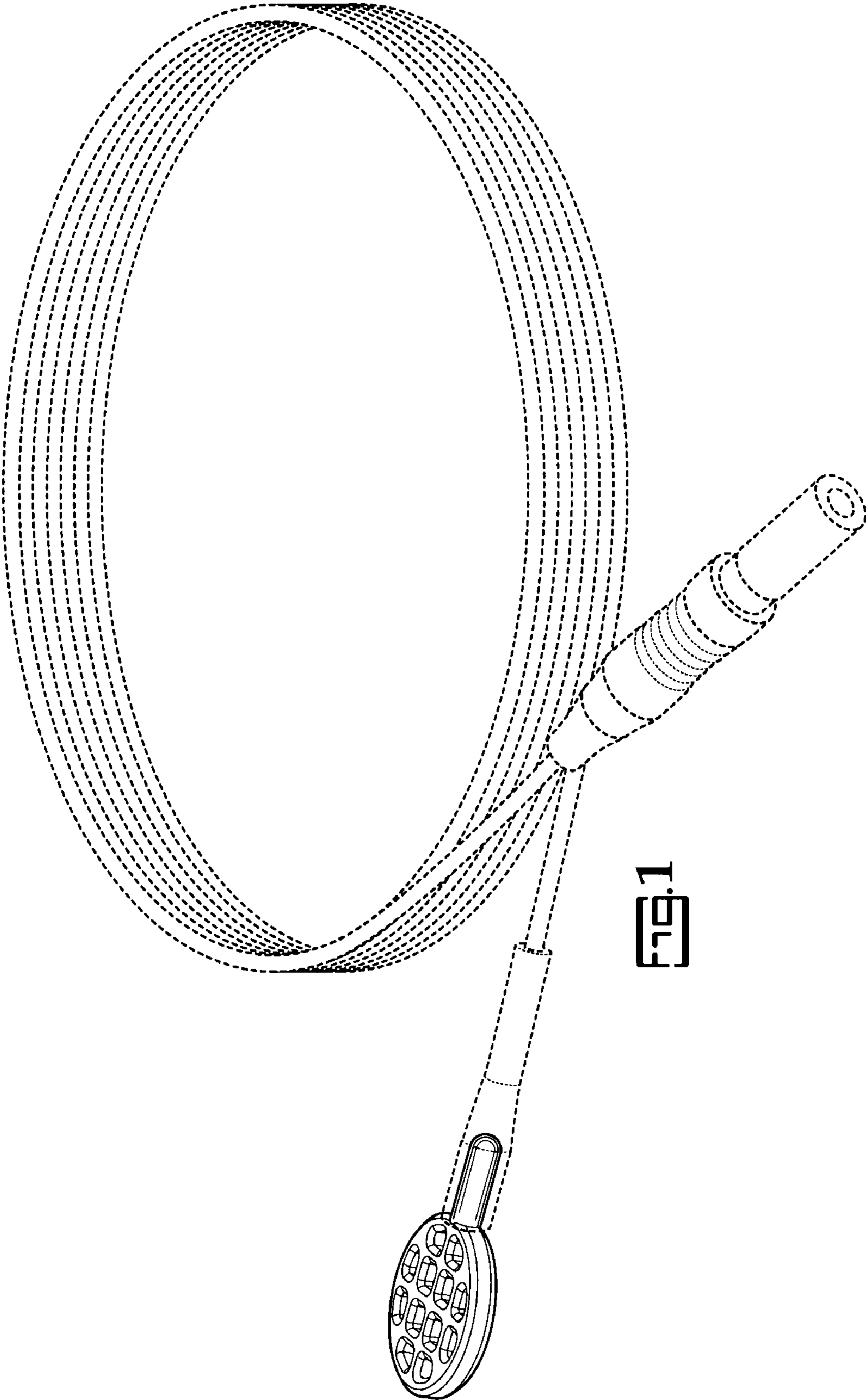
FIG. 5 is a front view thereof with the rear view being a mirror image thereof; and,

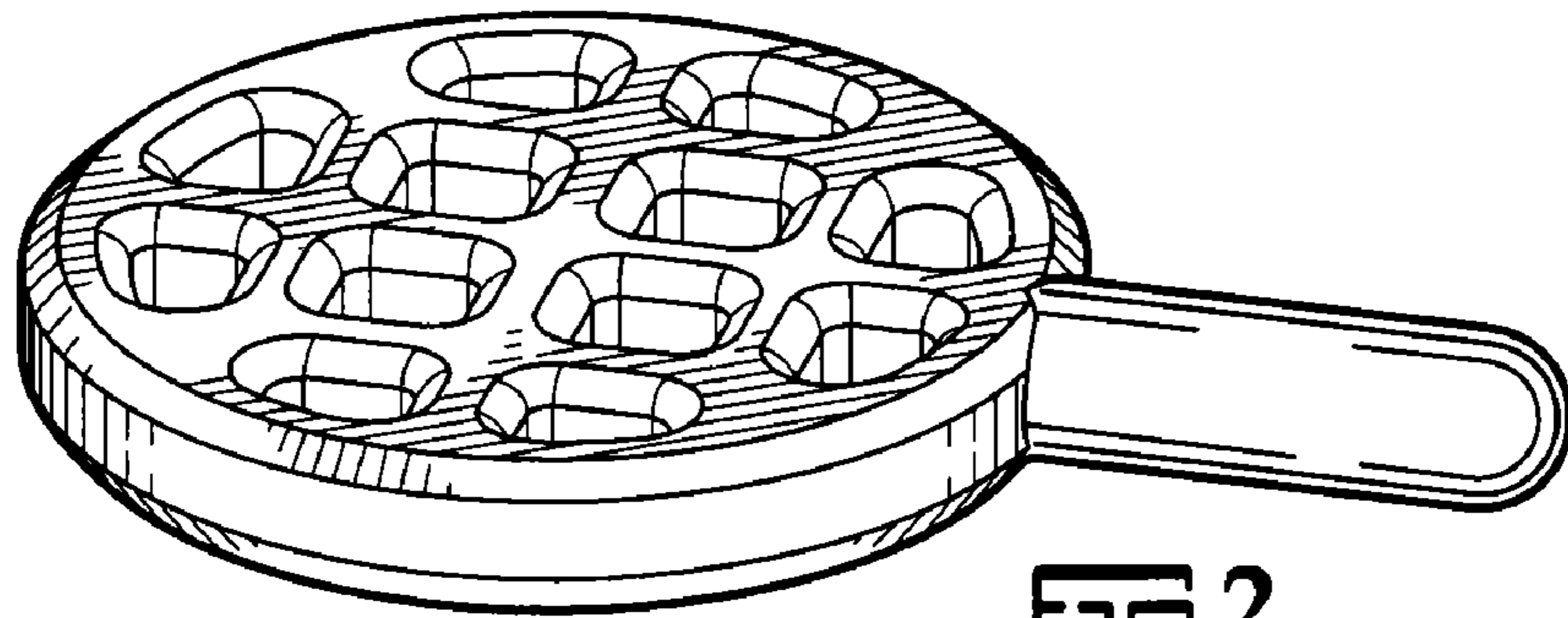

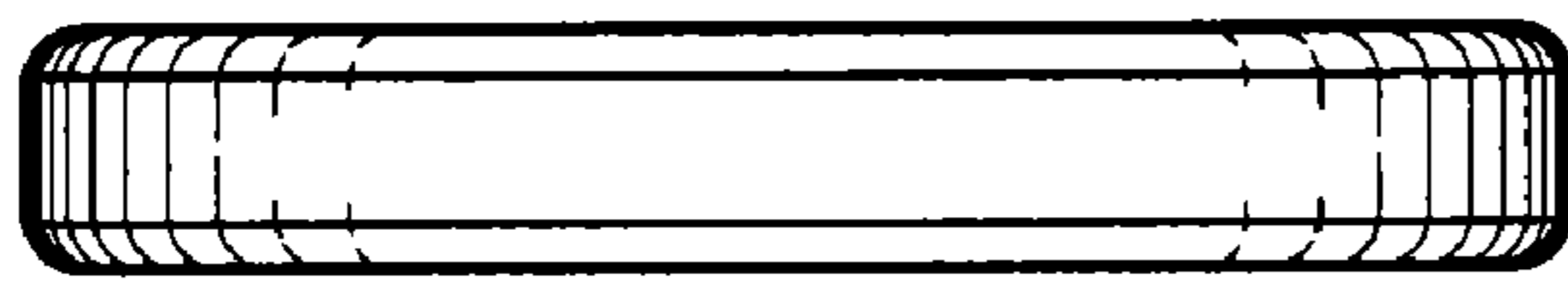

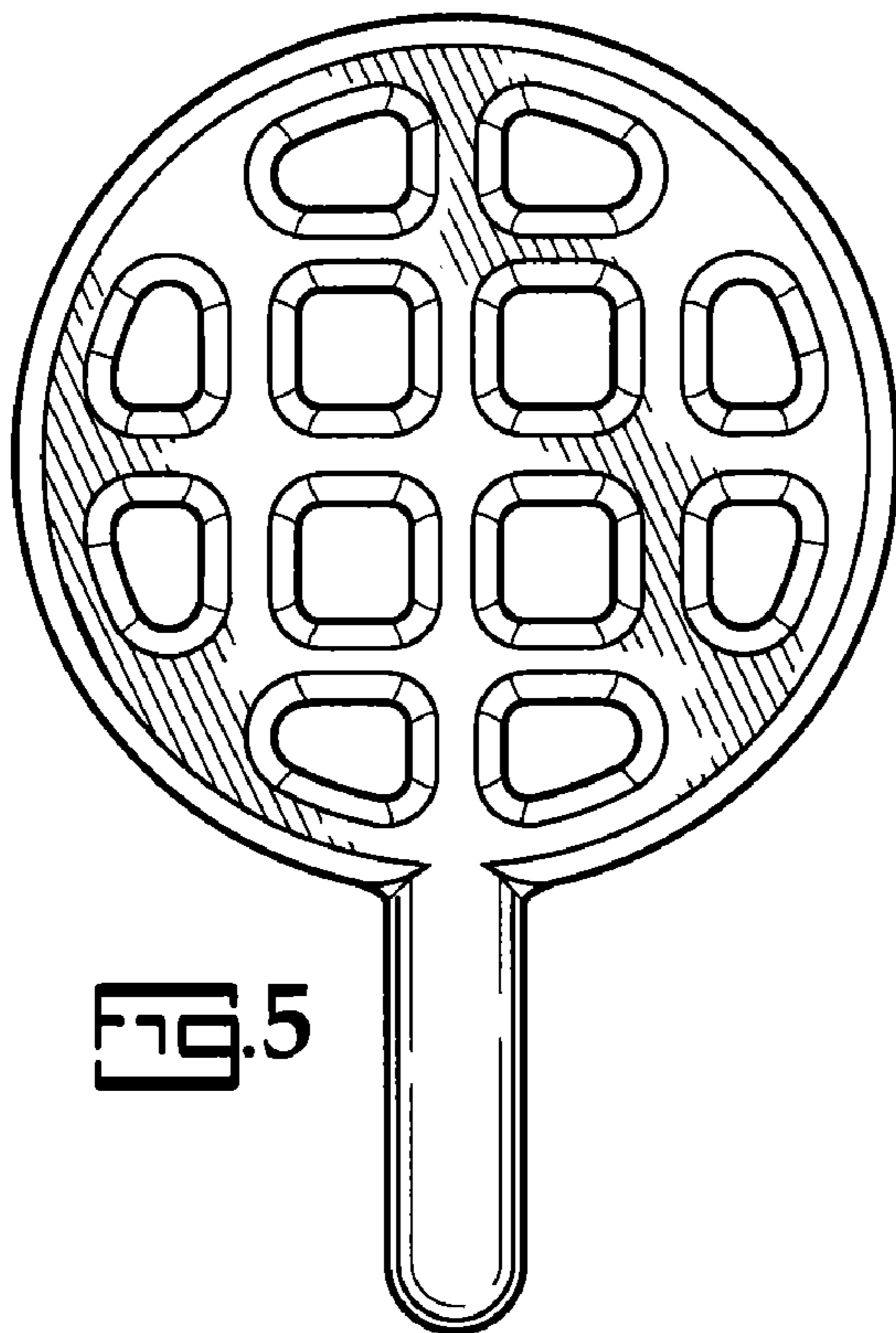

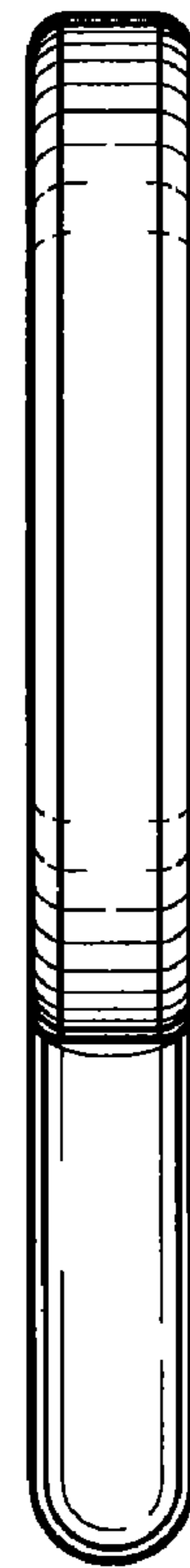
