The ornamental design for an emergency safety night light, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the emergency safety night light according to the present design.

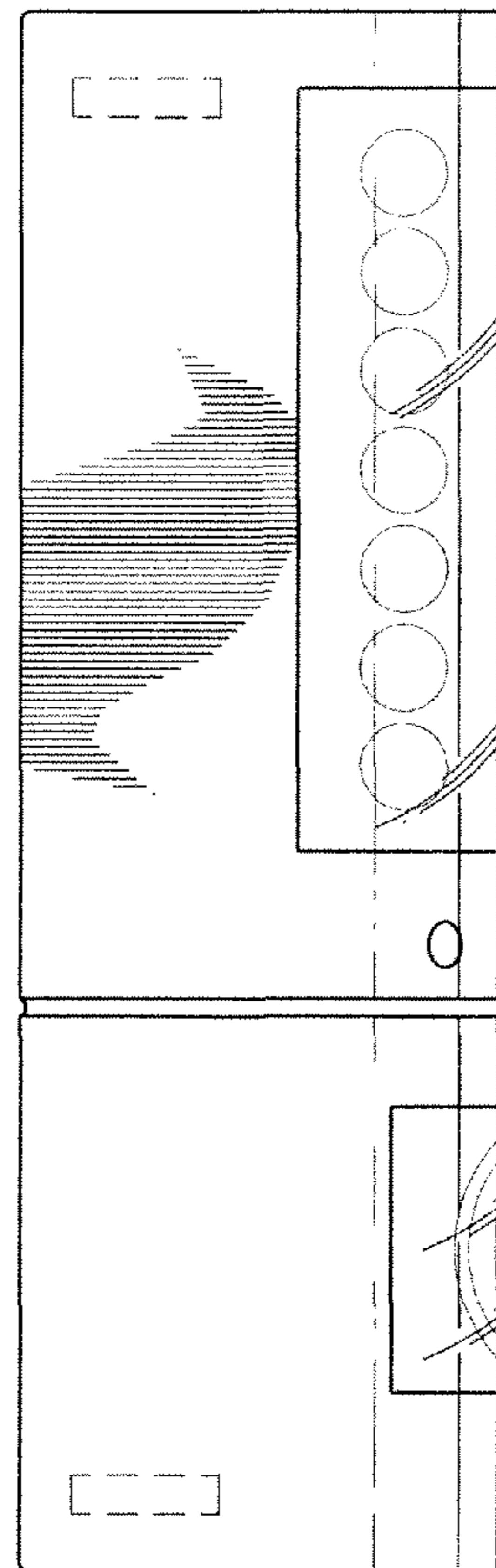
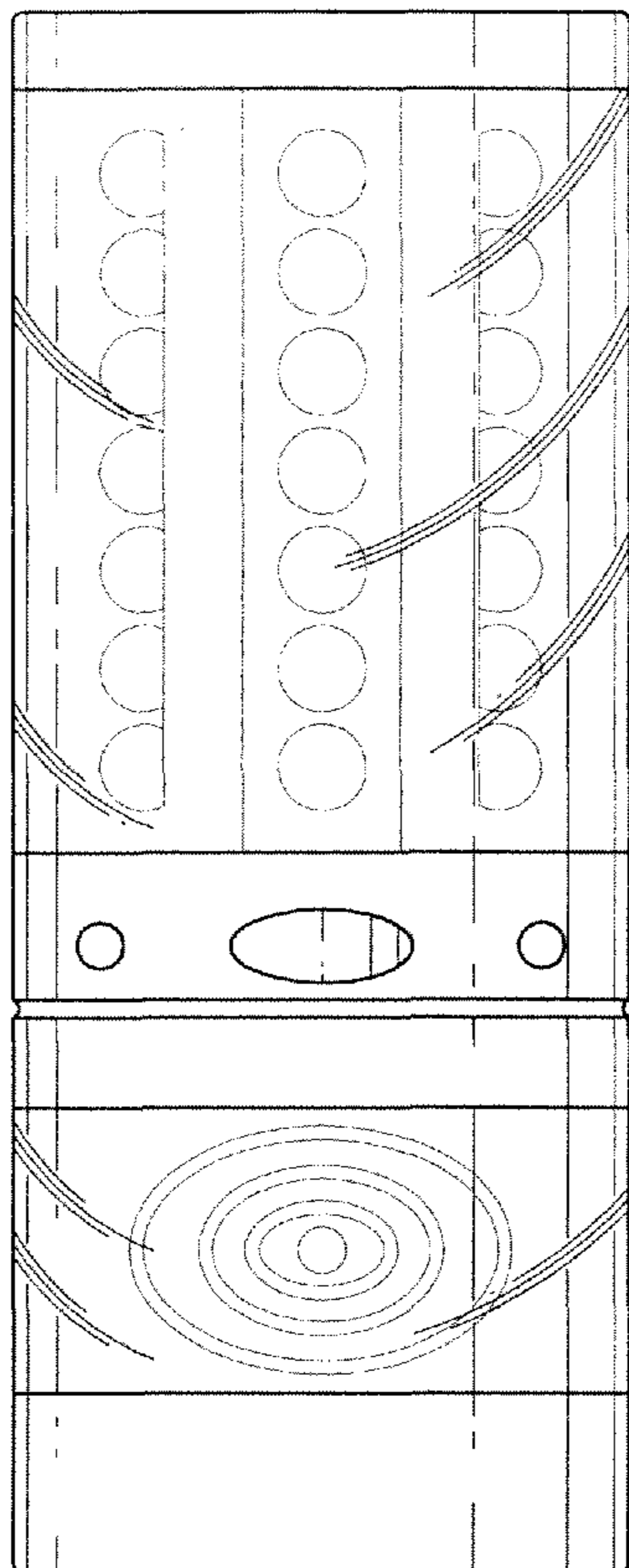
FIG. 2 is a left side view thereof, with the right side being a mirror image.

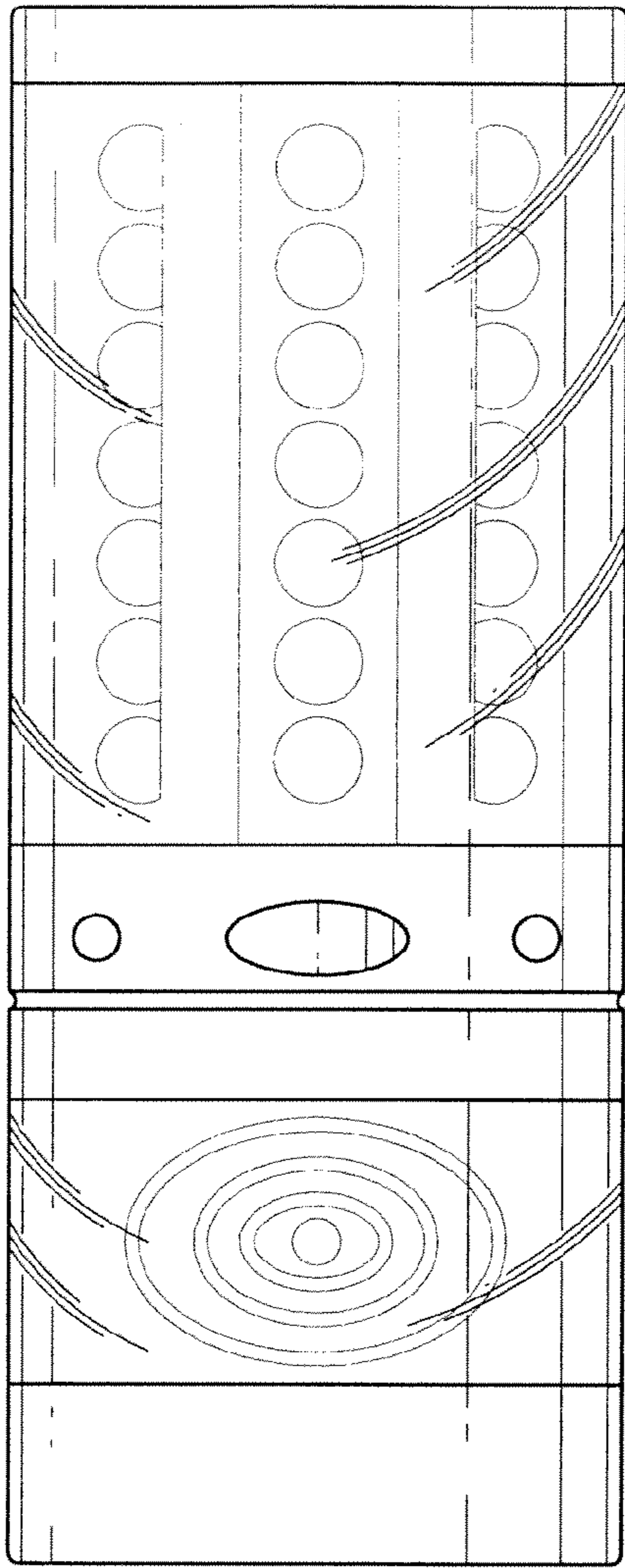

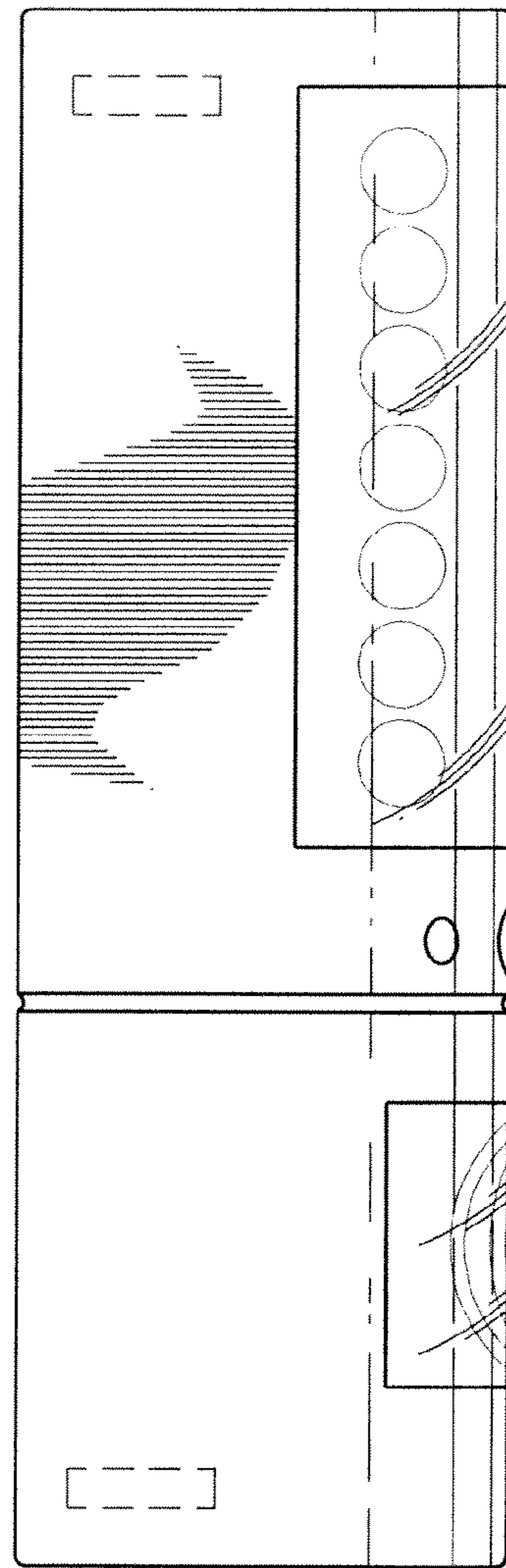

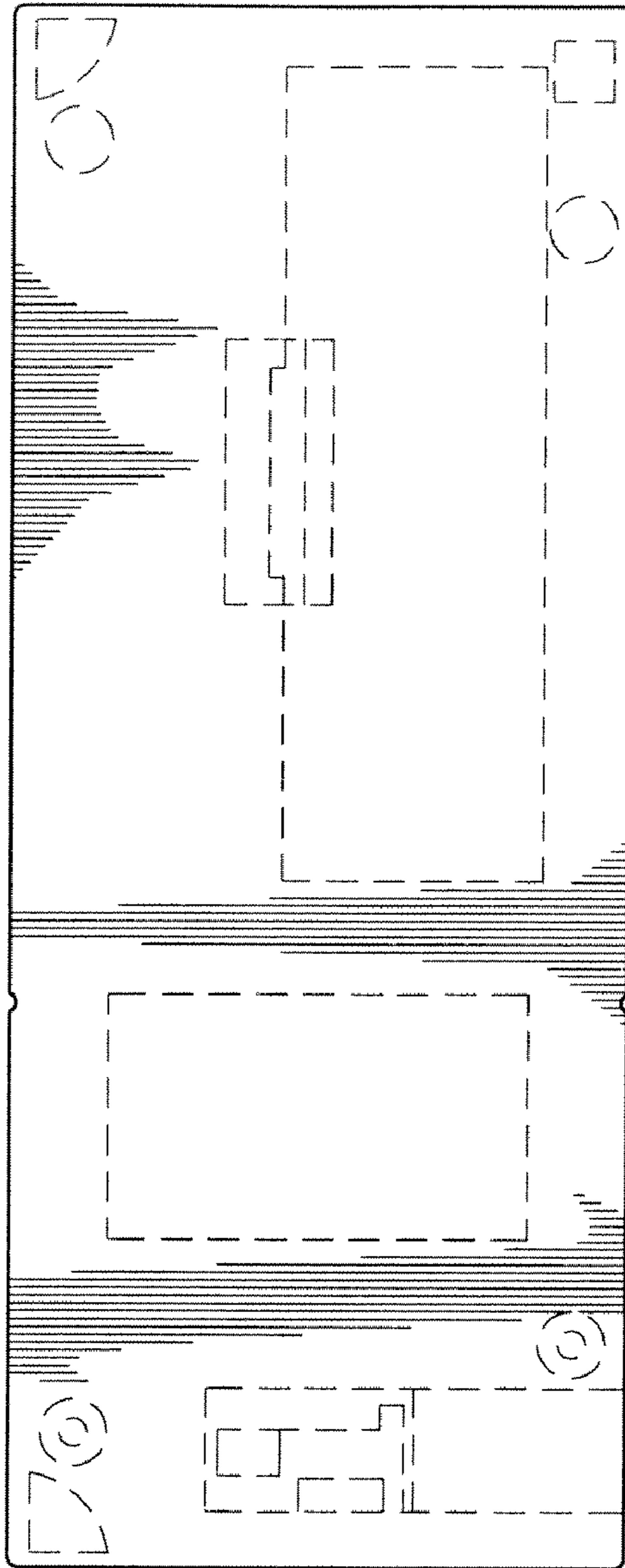

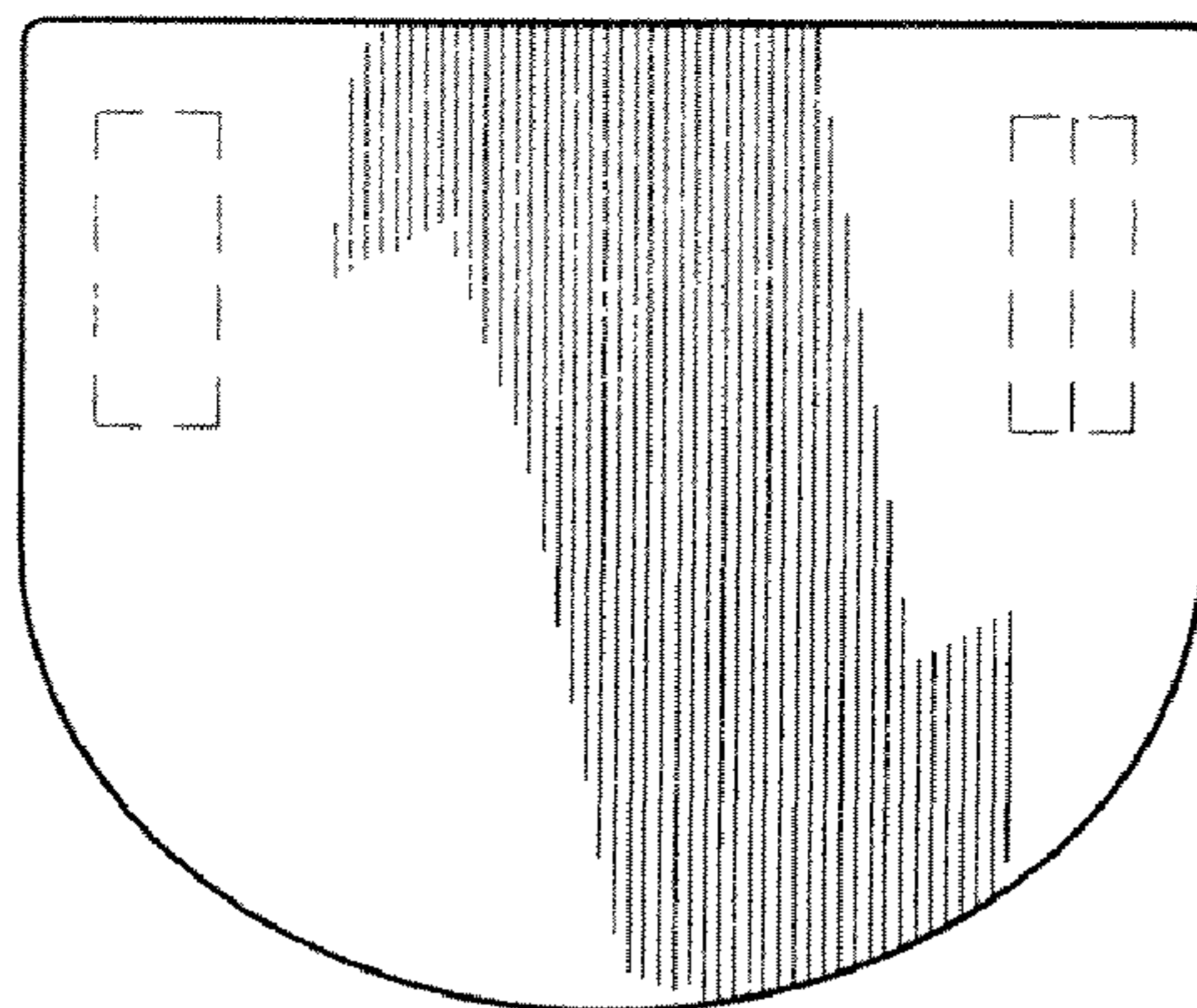
