(57) **CLAIM**

We claim the ornamental design for a steam iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of a steam iron of the present invention;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a first side view thereof;  
 FIG. 5 is a second side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is a top perspective view of a second embodiment of a steam iron of the present invention;  
 FIG. 9 is a front view thereof;  
 FIG. 10 is a rear view thereof;  
 FIG. 11 is a first side view thereof;  
 FIG. 12 is a second side view thereof;  
 FIG. 13 is a top view thereof; and,  
 FIG. 14 is a bottom view thereof.  
 The broken lines shown in FIGS. 7 and 14 represent portions of the iron that form no part of the claimed design.

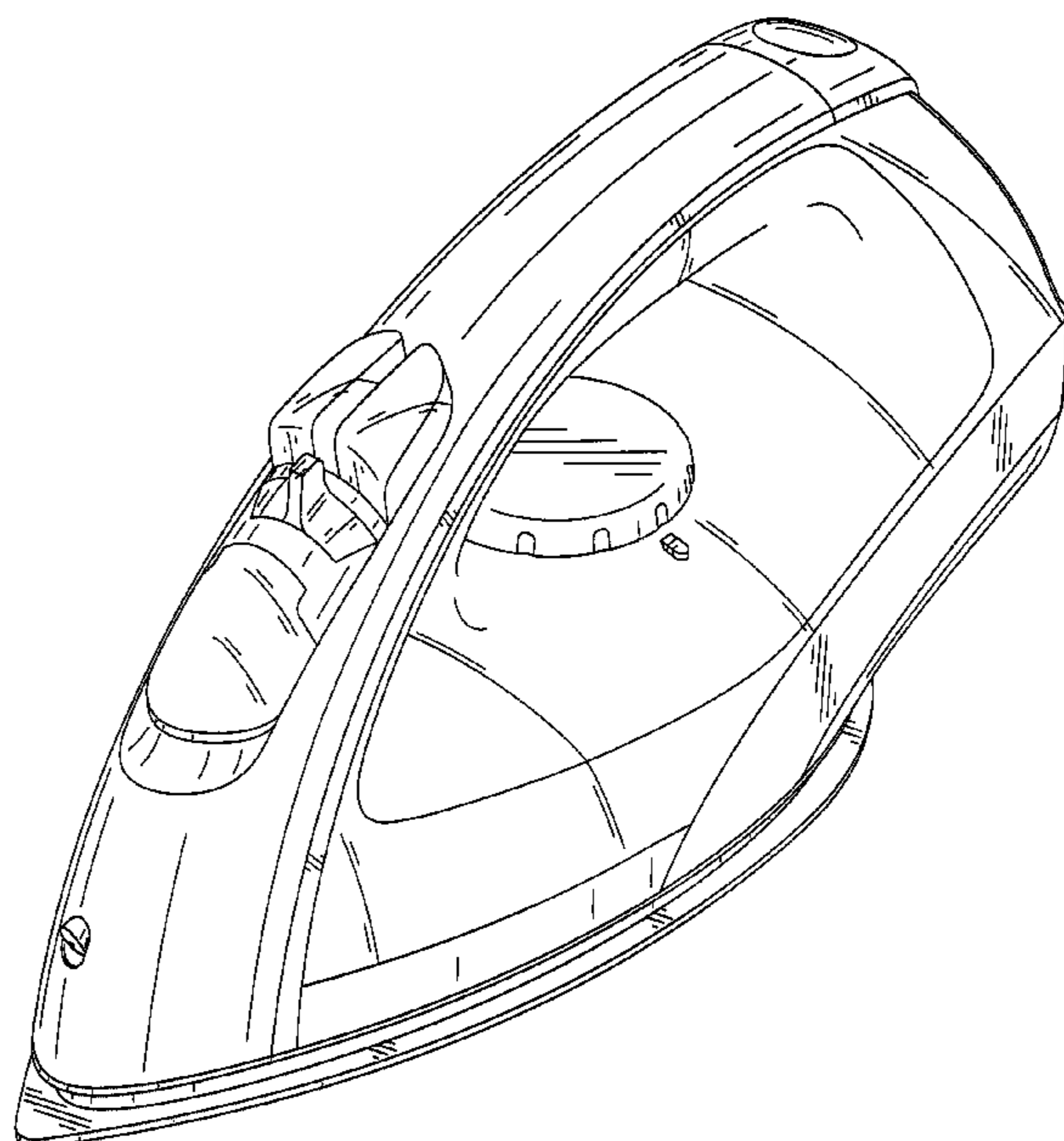
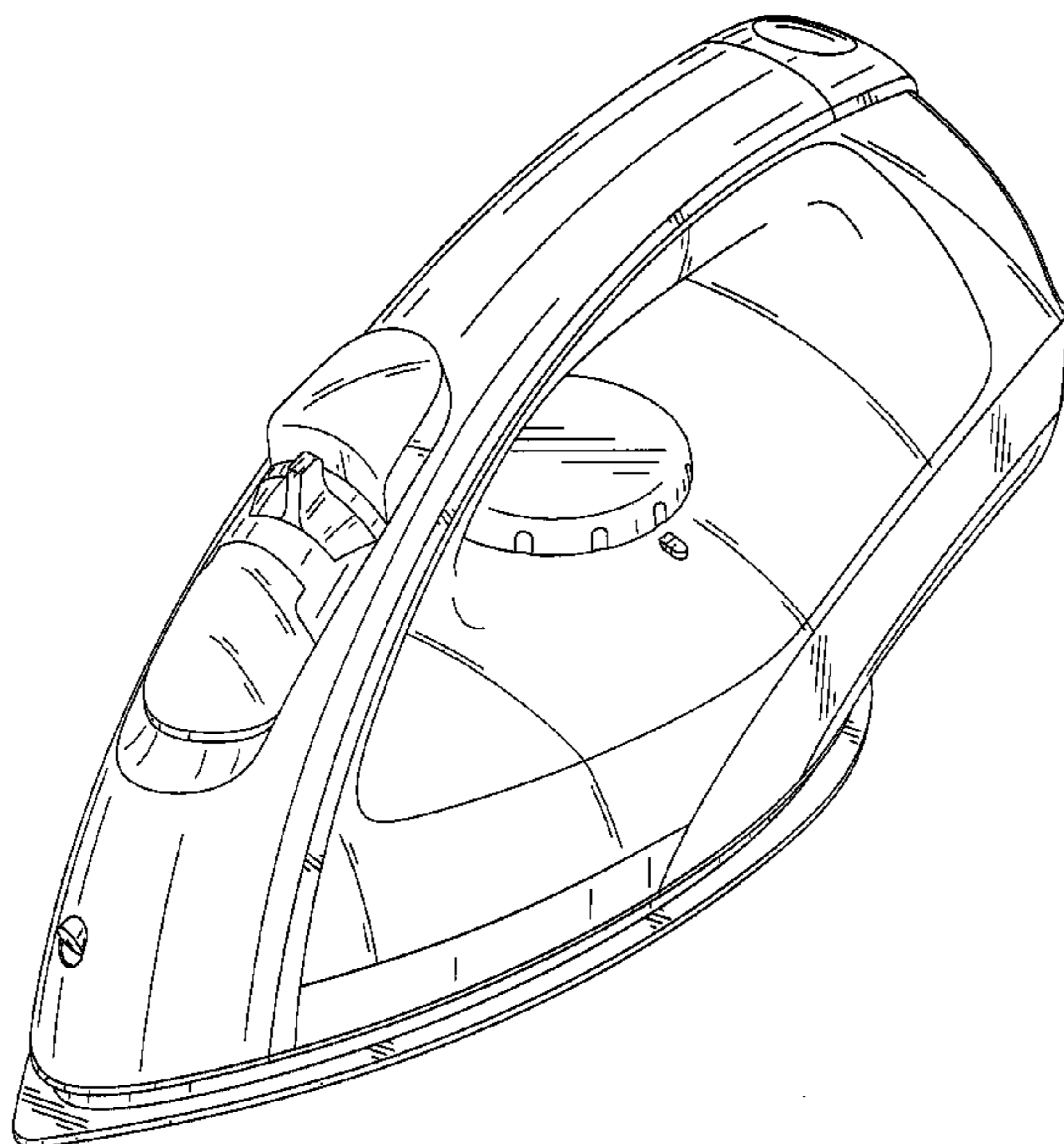

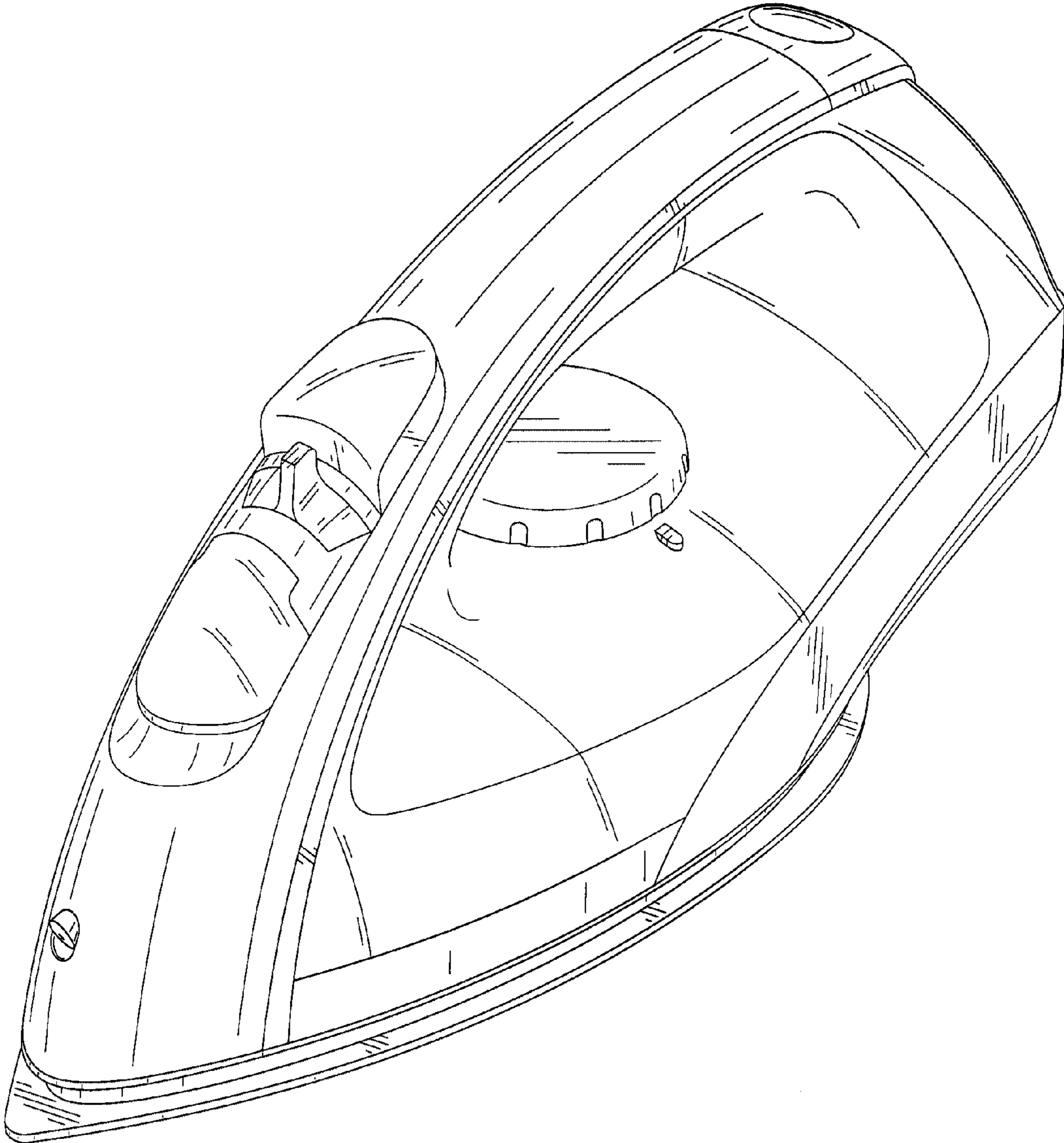

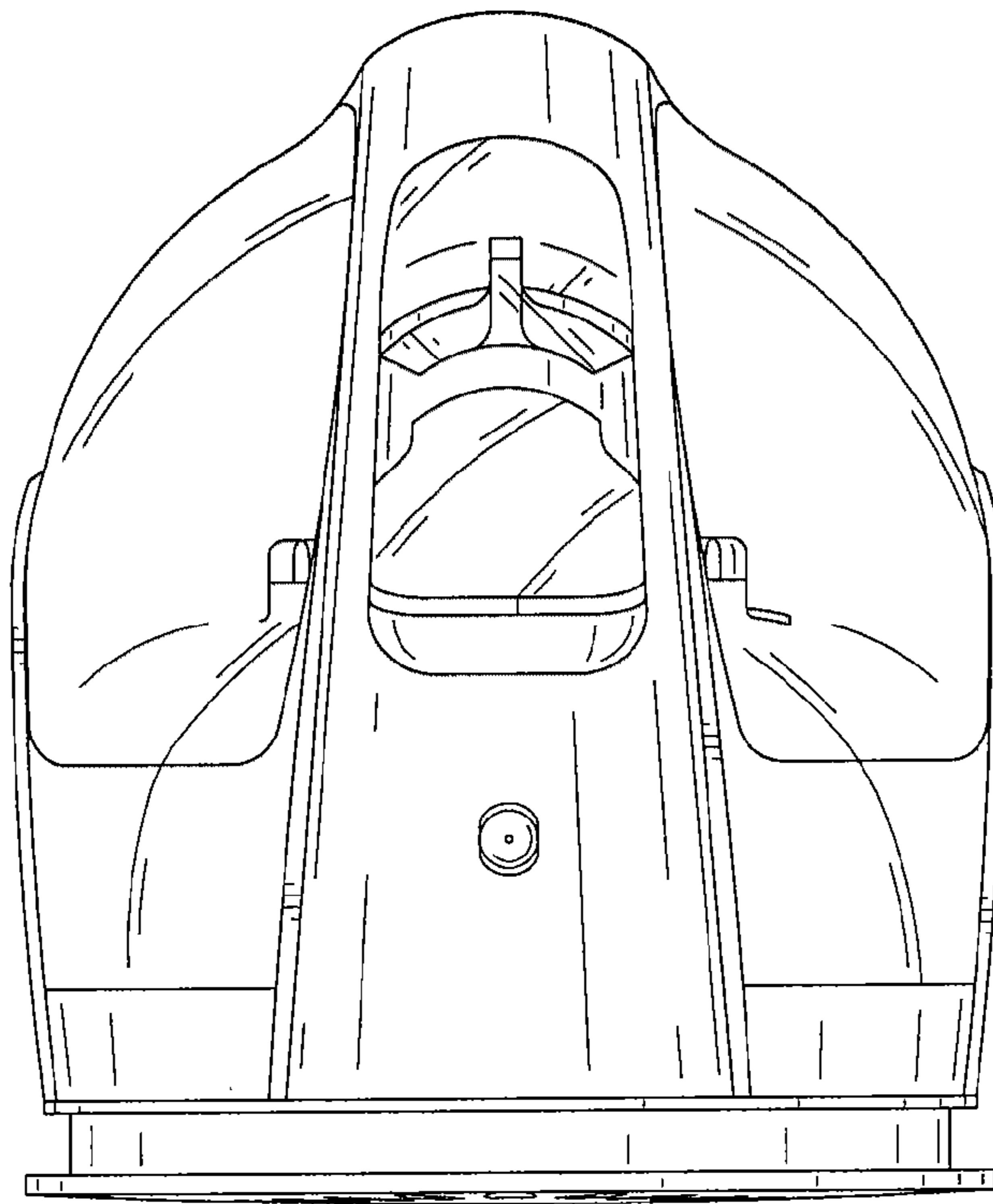

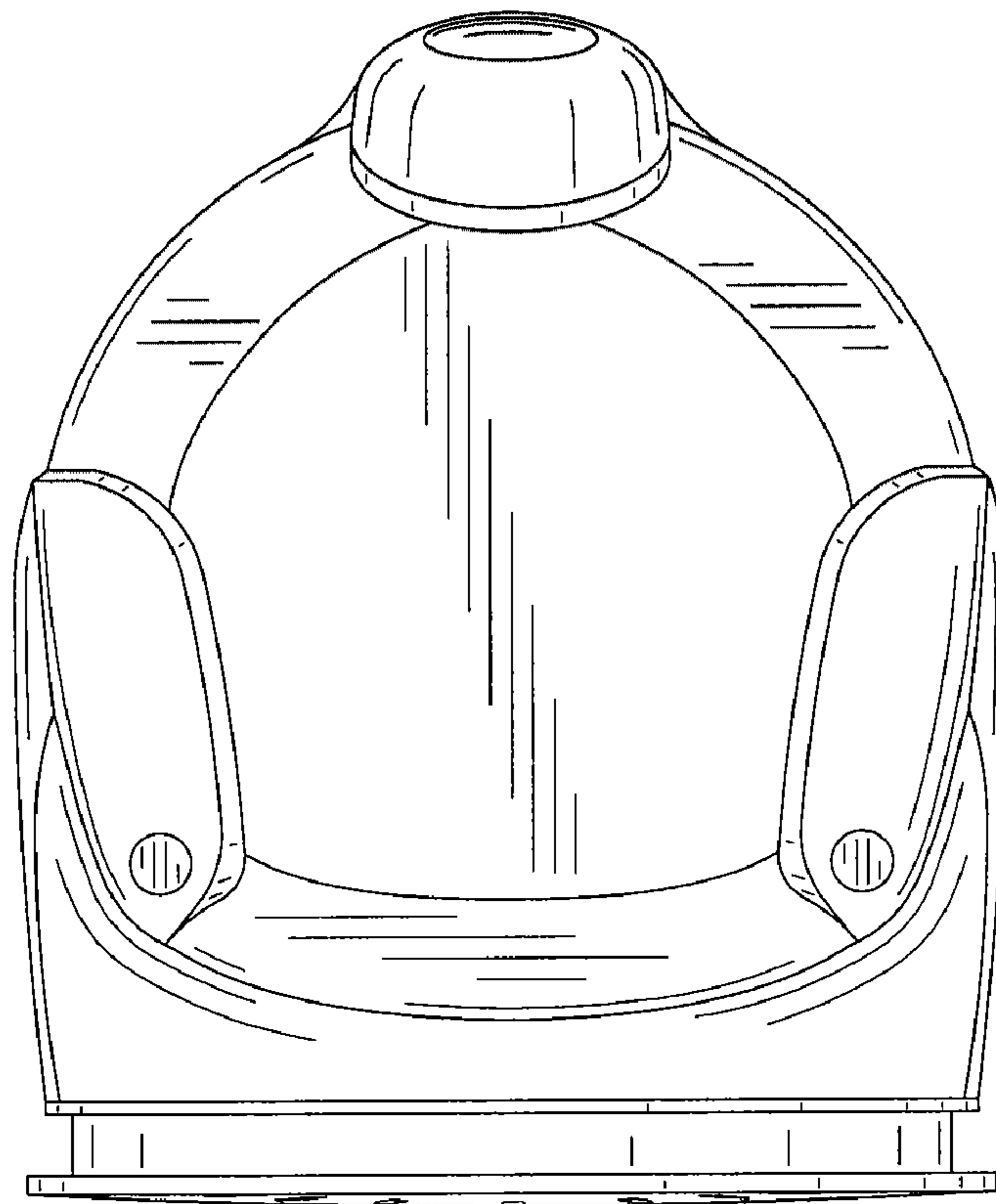

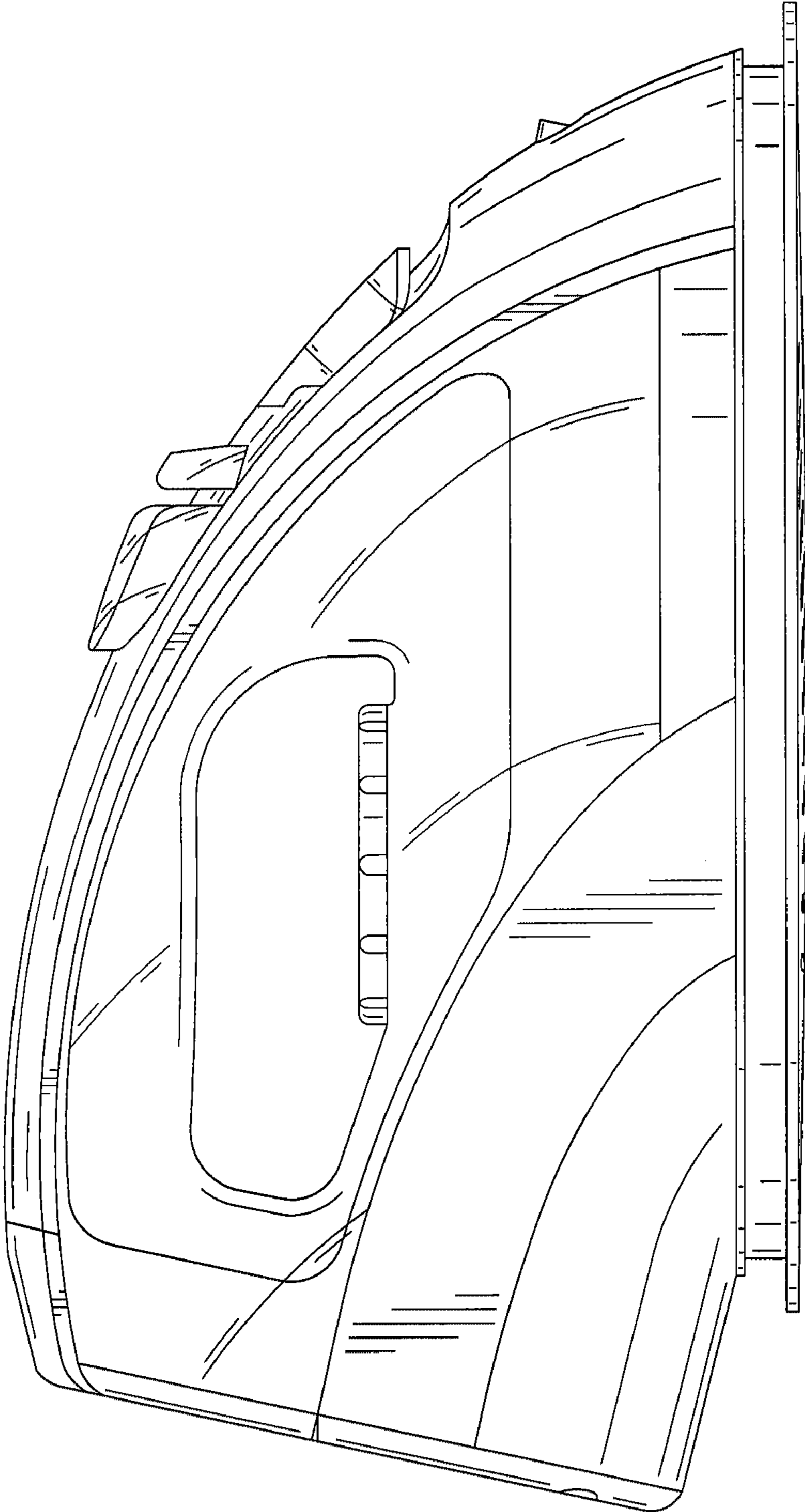

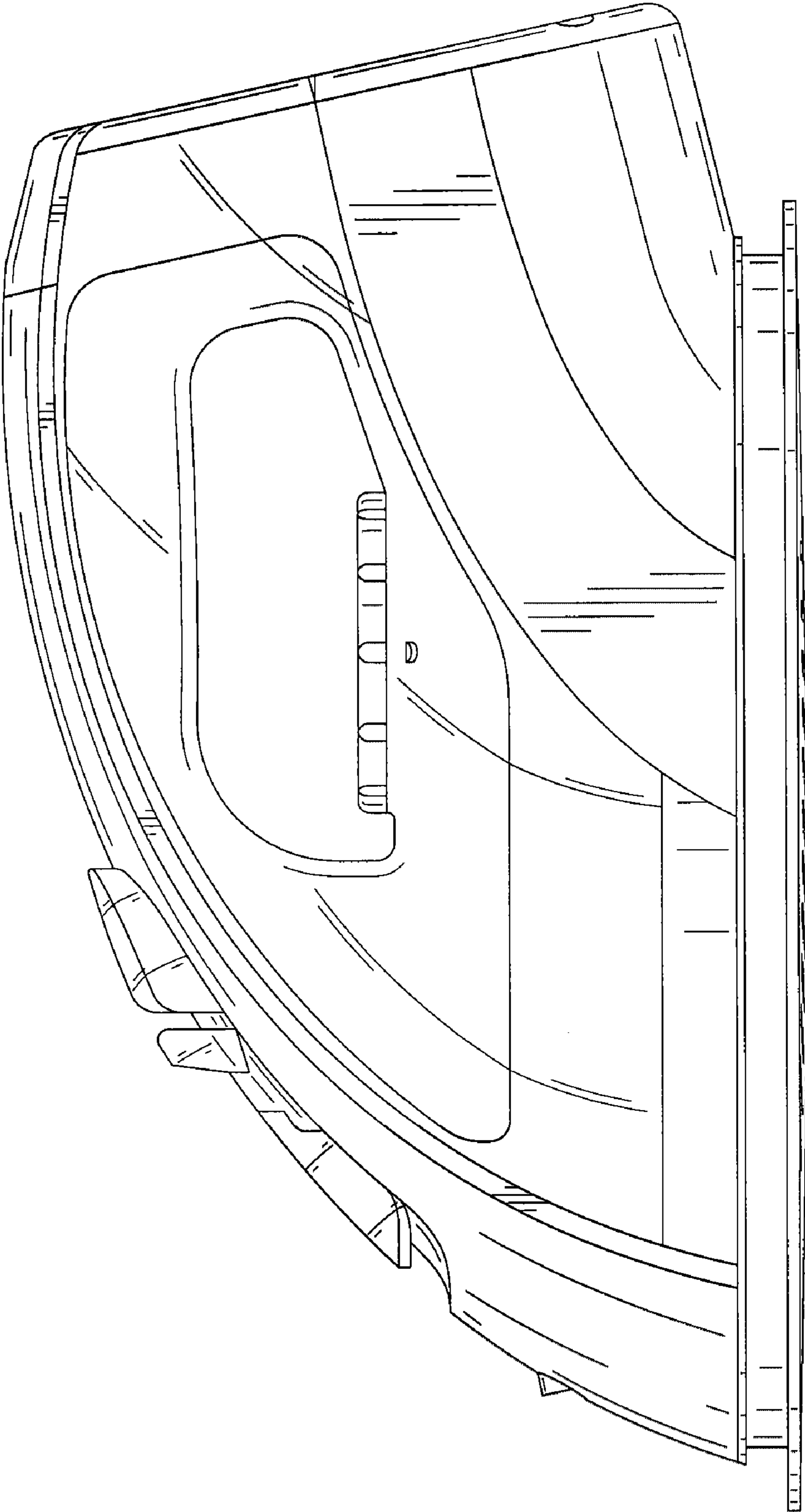

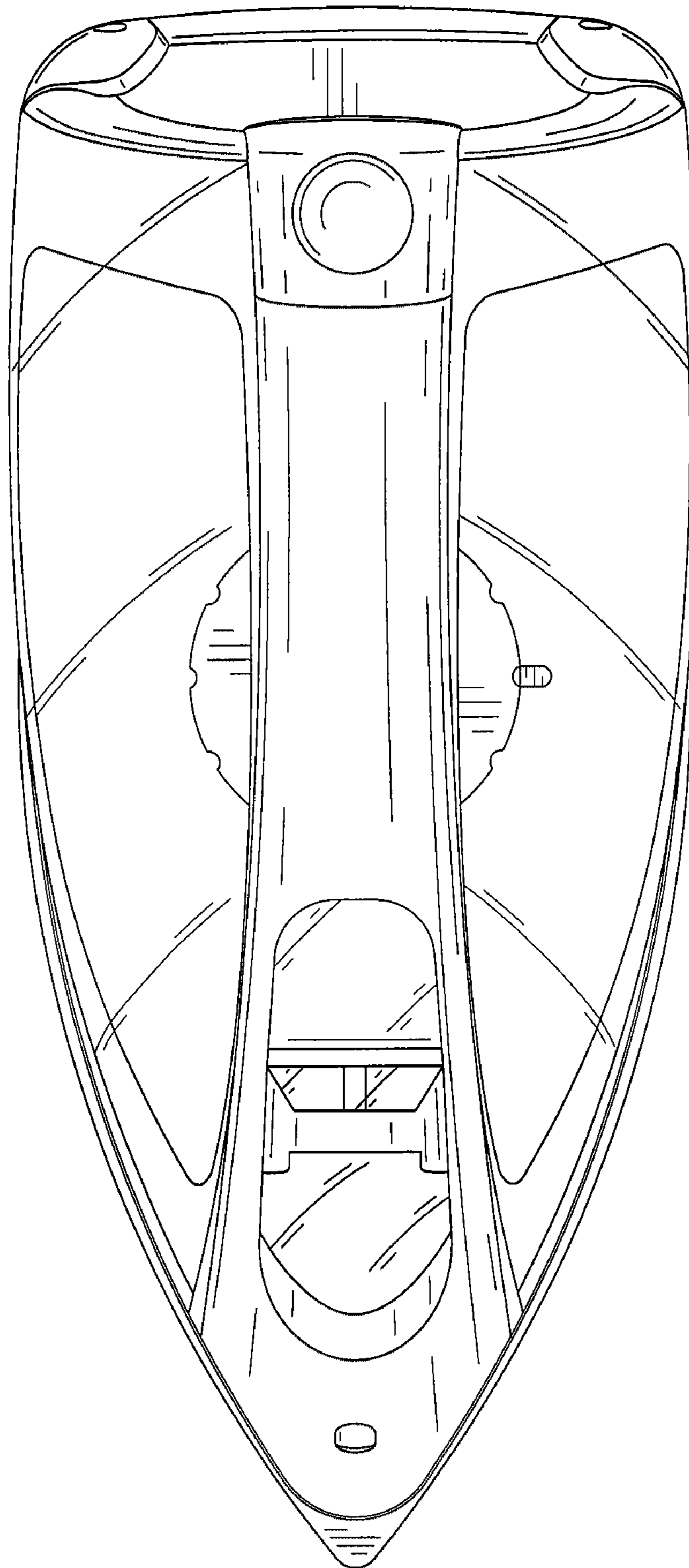

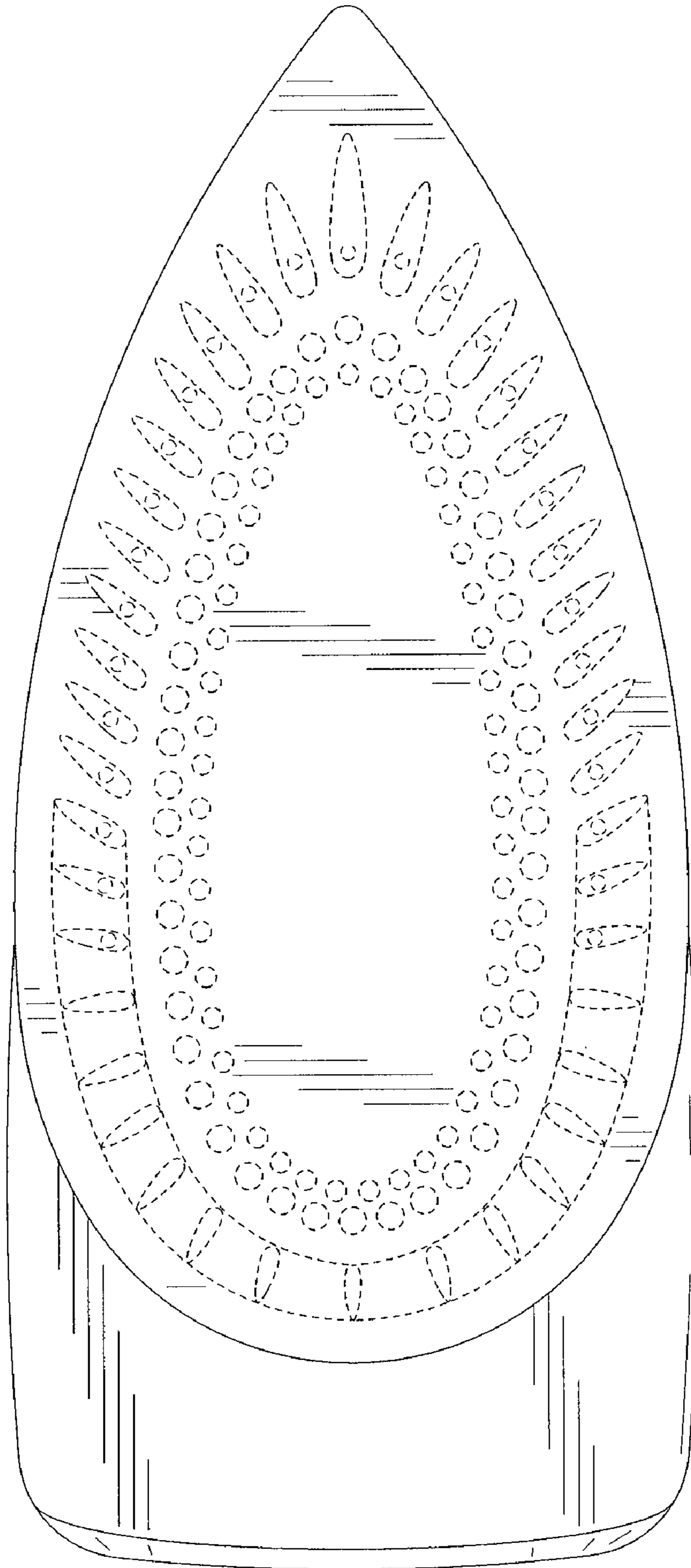

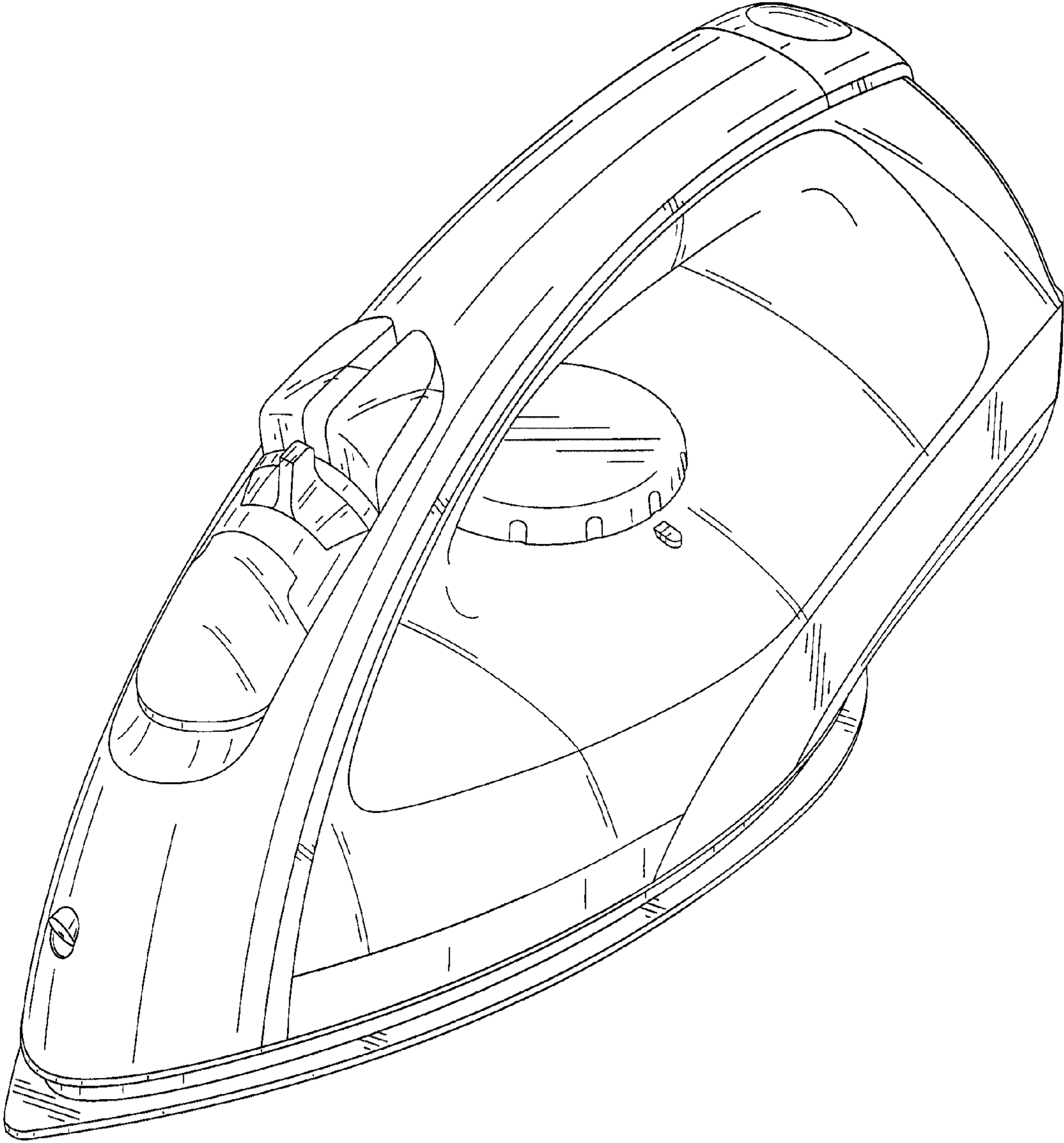

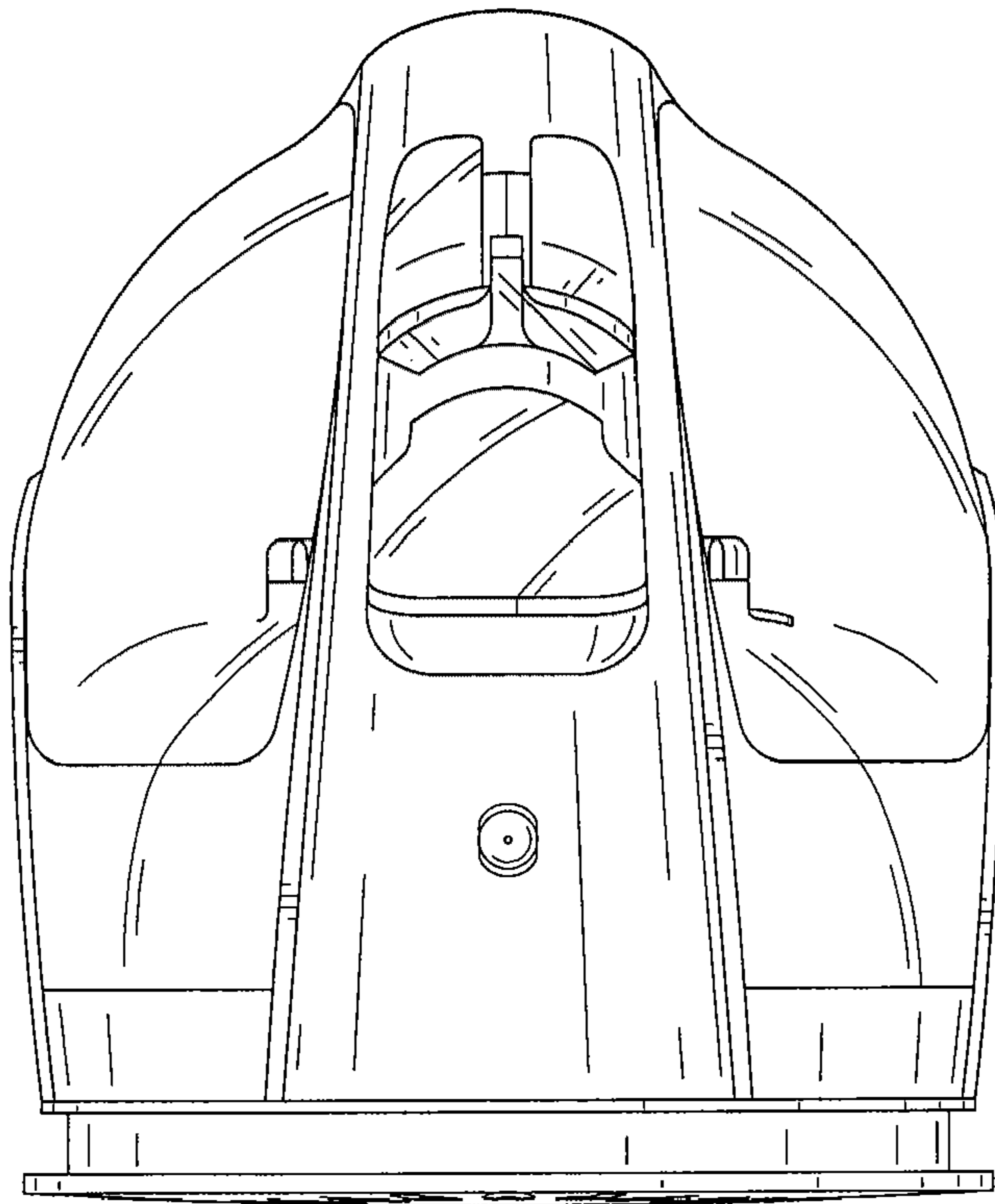

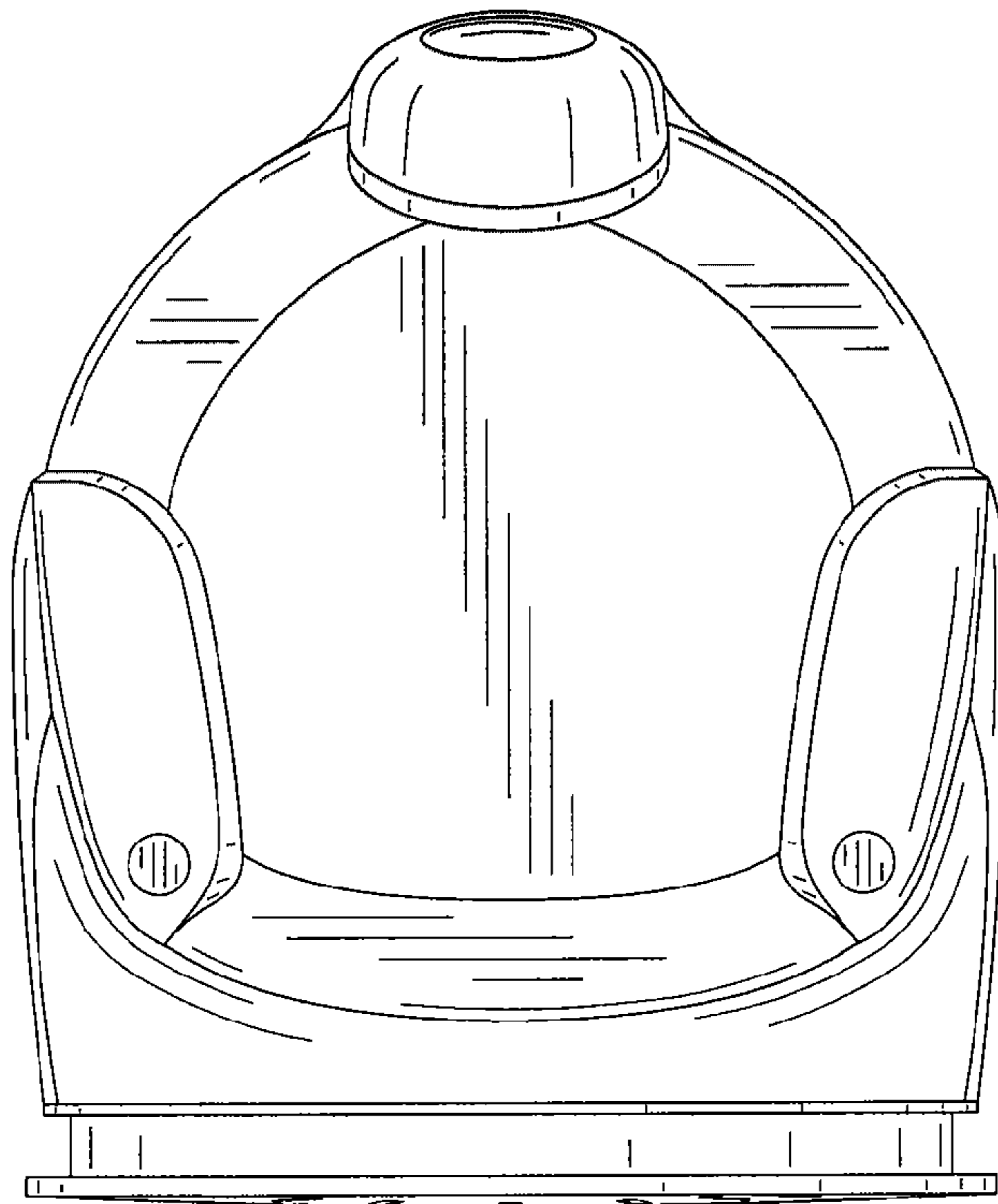

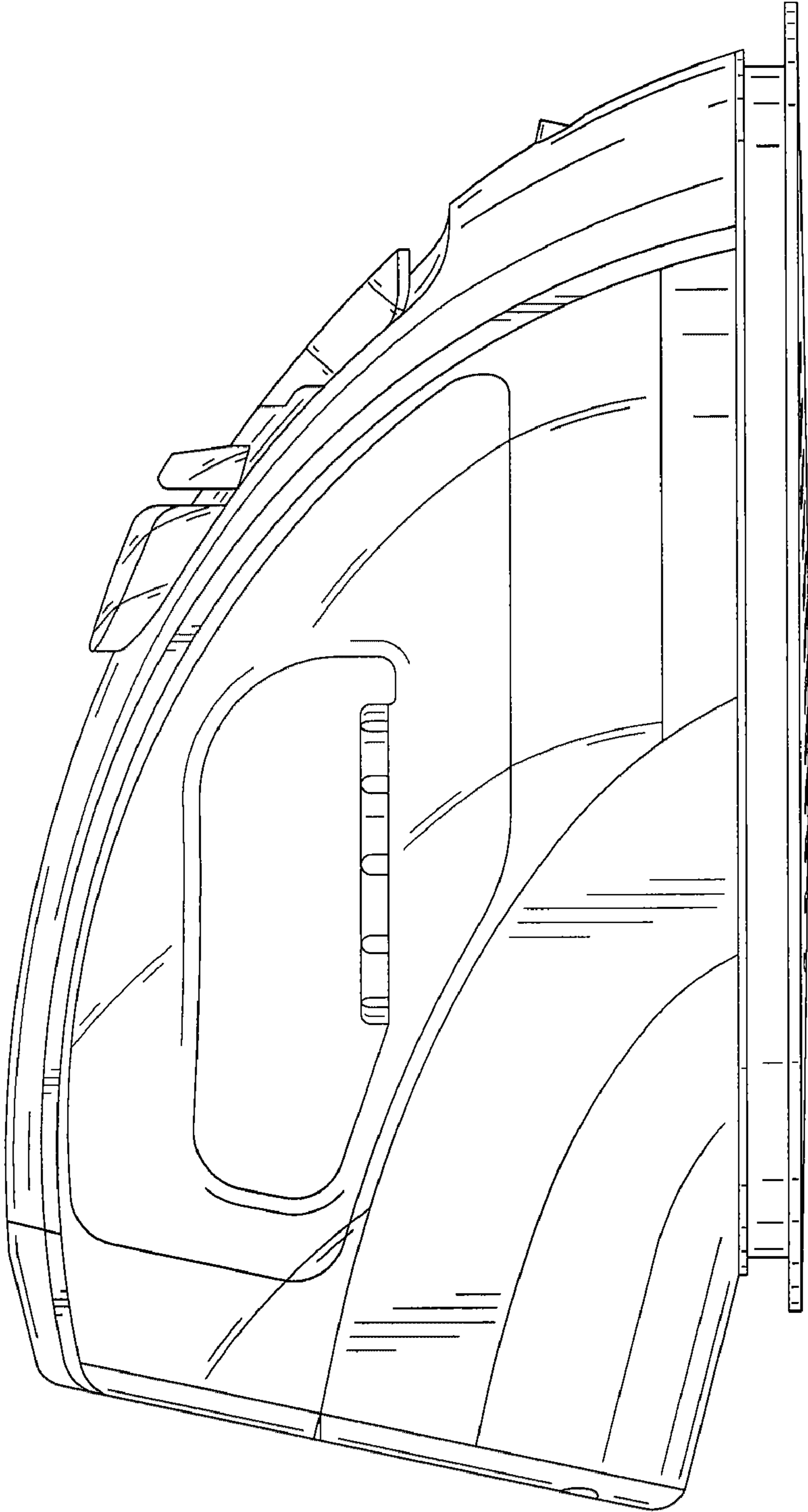

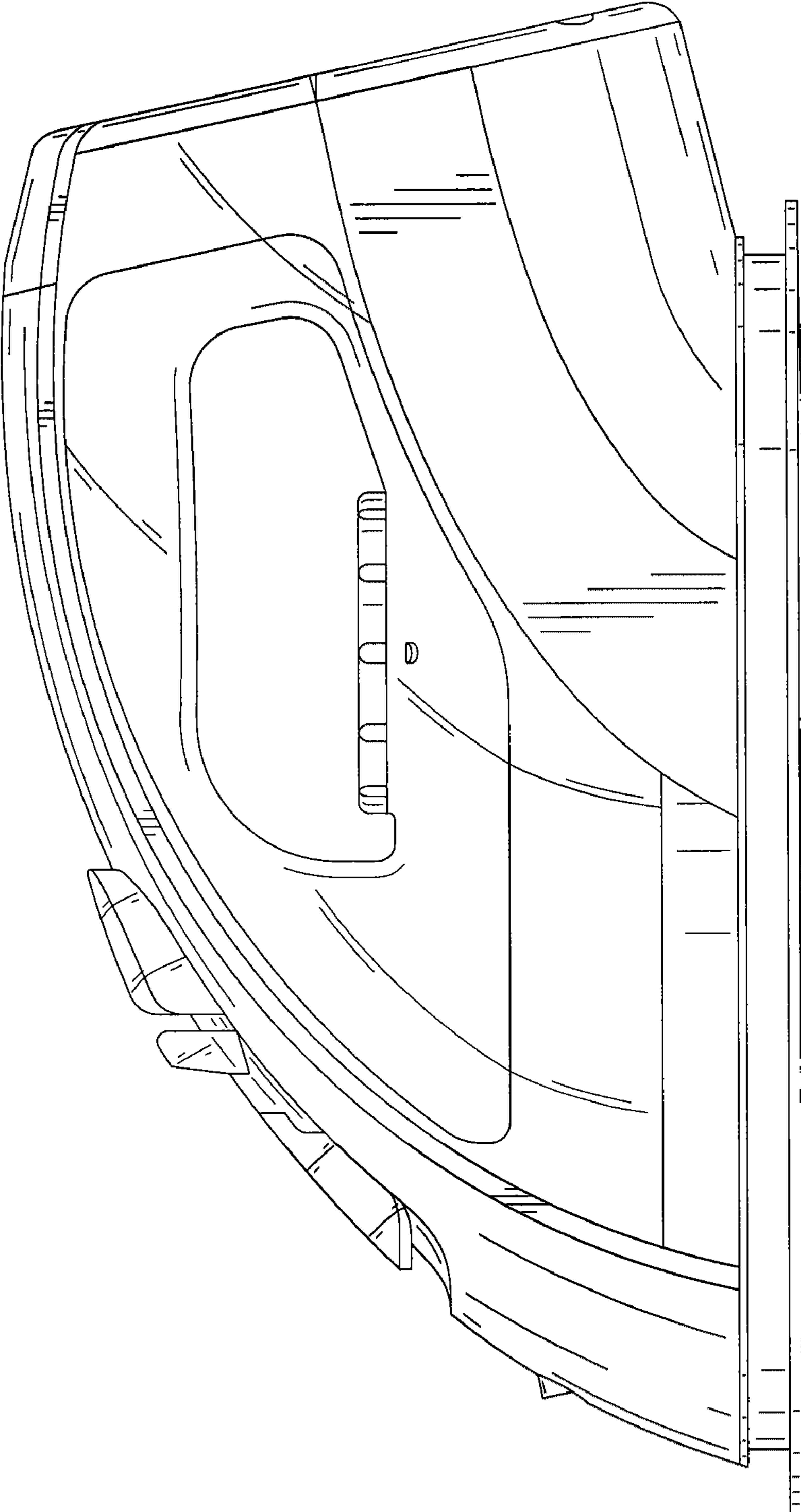

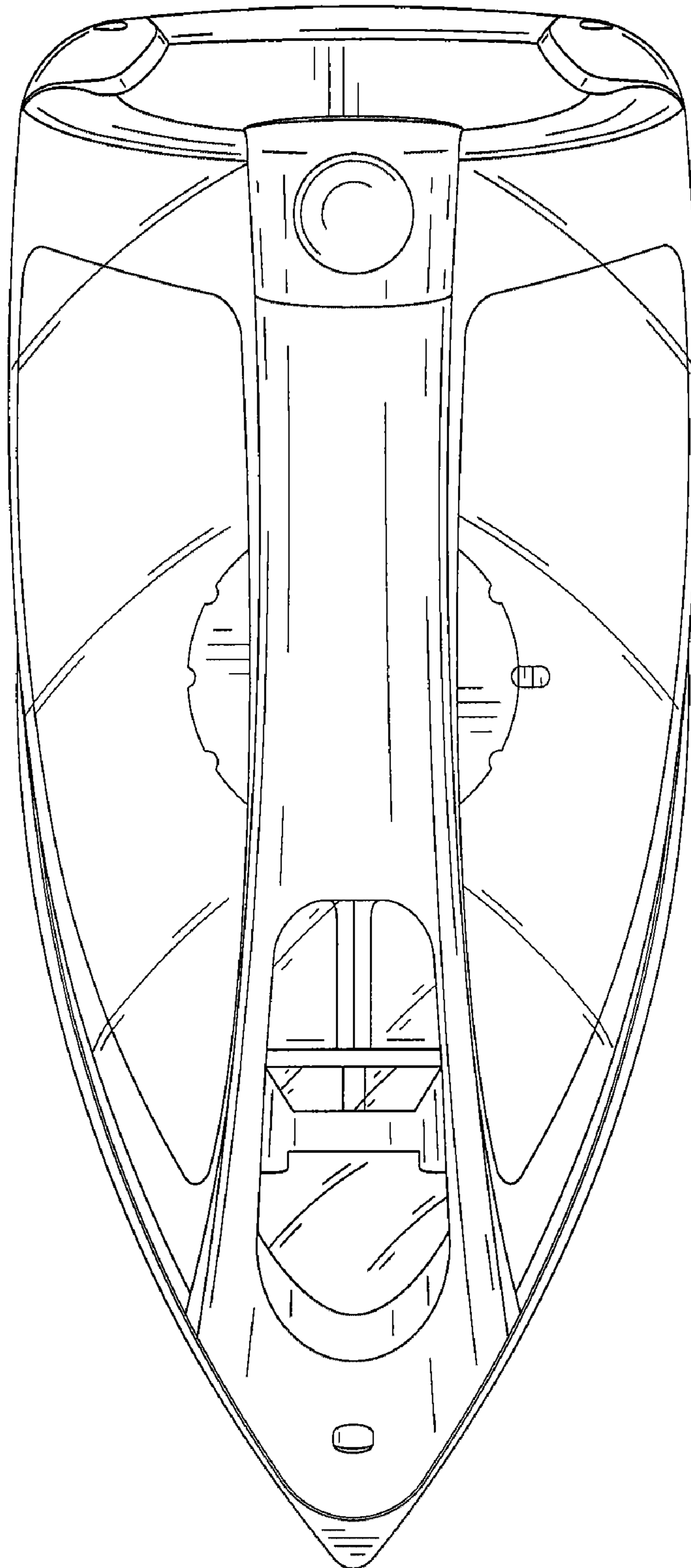
