(57) **CLAIM**

The ornamental design for a chocolate santa with stars, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the chocolate santa with stars design;

FIG. 2 is a front view of the chocolate santa with stars design;

FIG. 3 is a left side view of the chocolate santa with stars design;

FIG. 4 is back view of the chocolate santa with stars design;

FIG. 5 is a right side view of the chocolate santa with stars design; and,

FIG. 6 is a top view of the chocolate santa with stars design, the bottom not being a part of the claimed design.

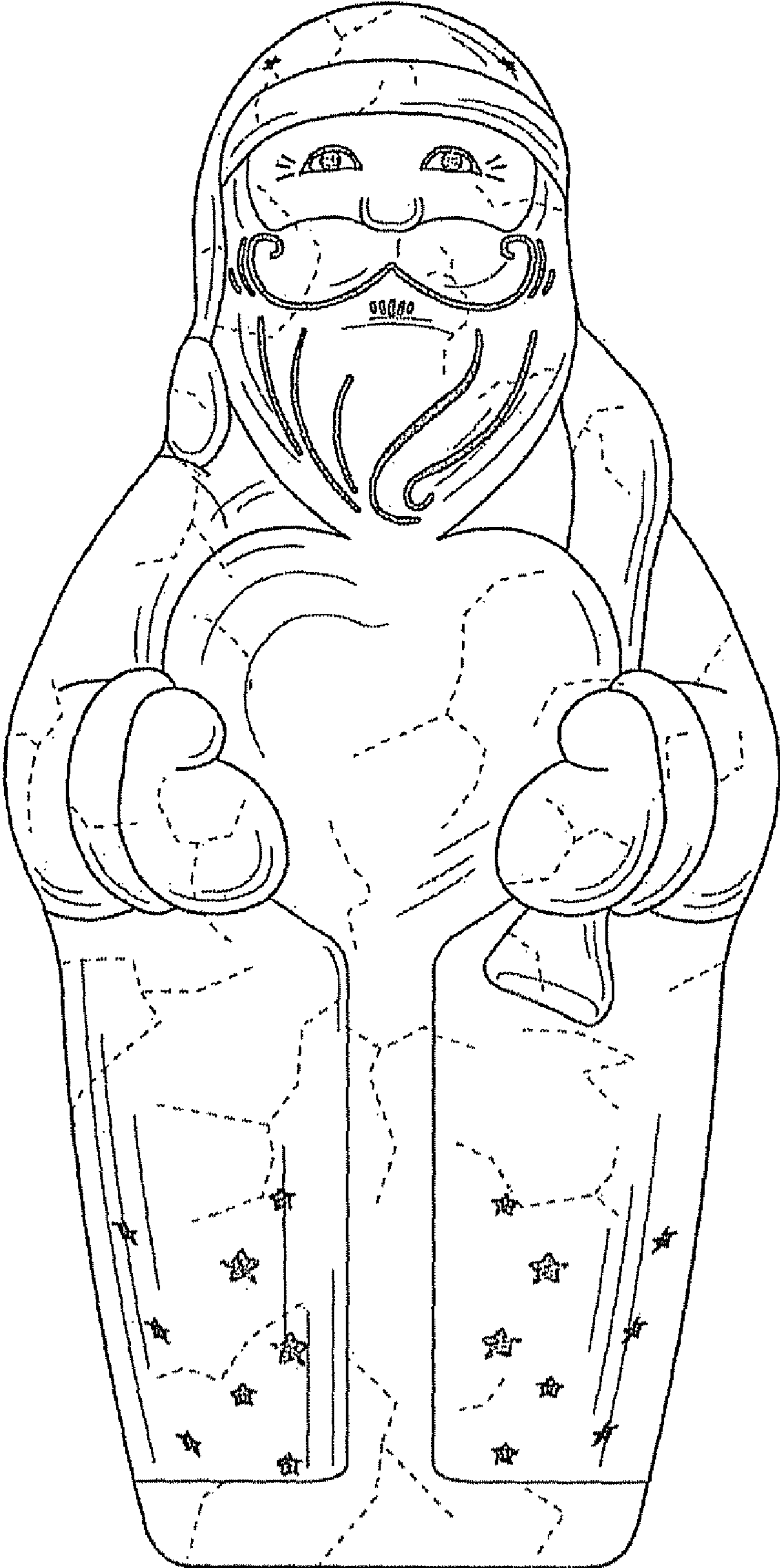

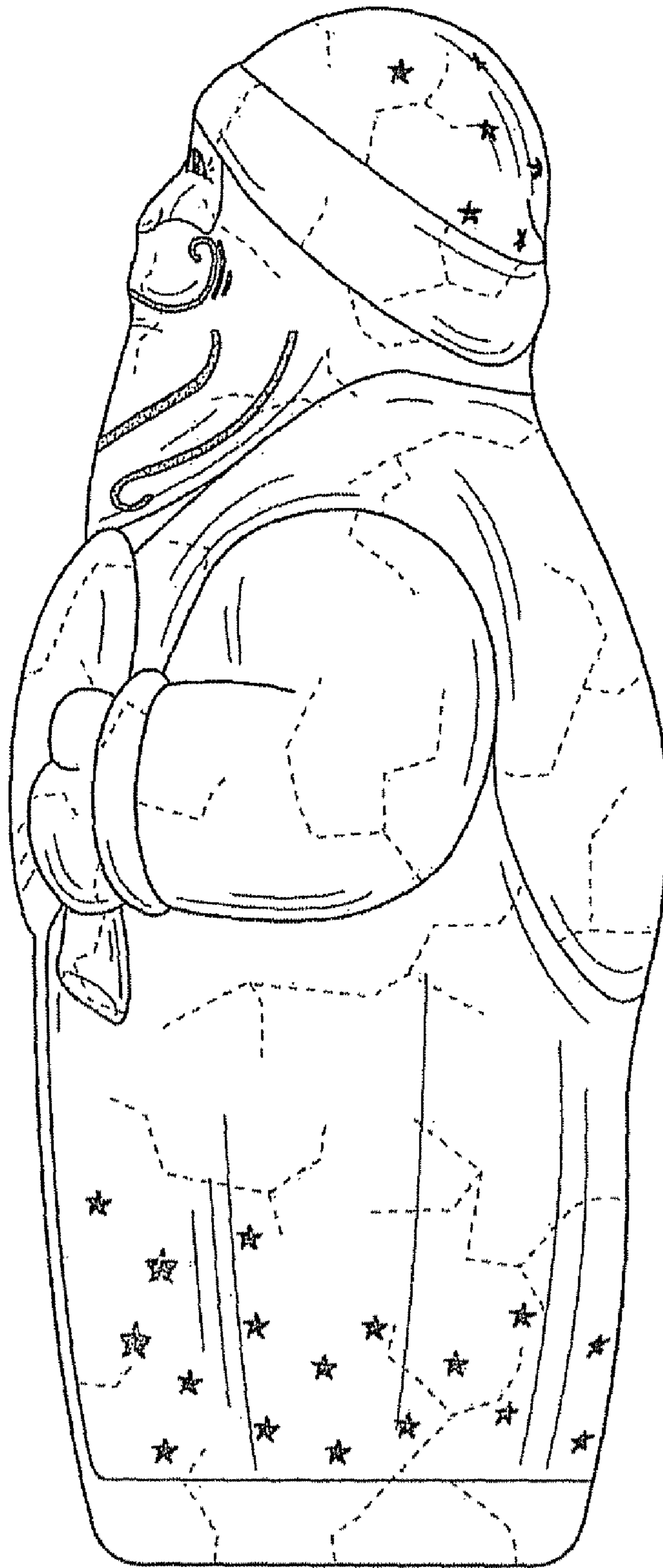

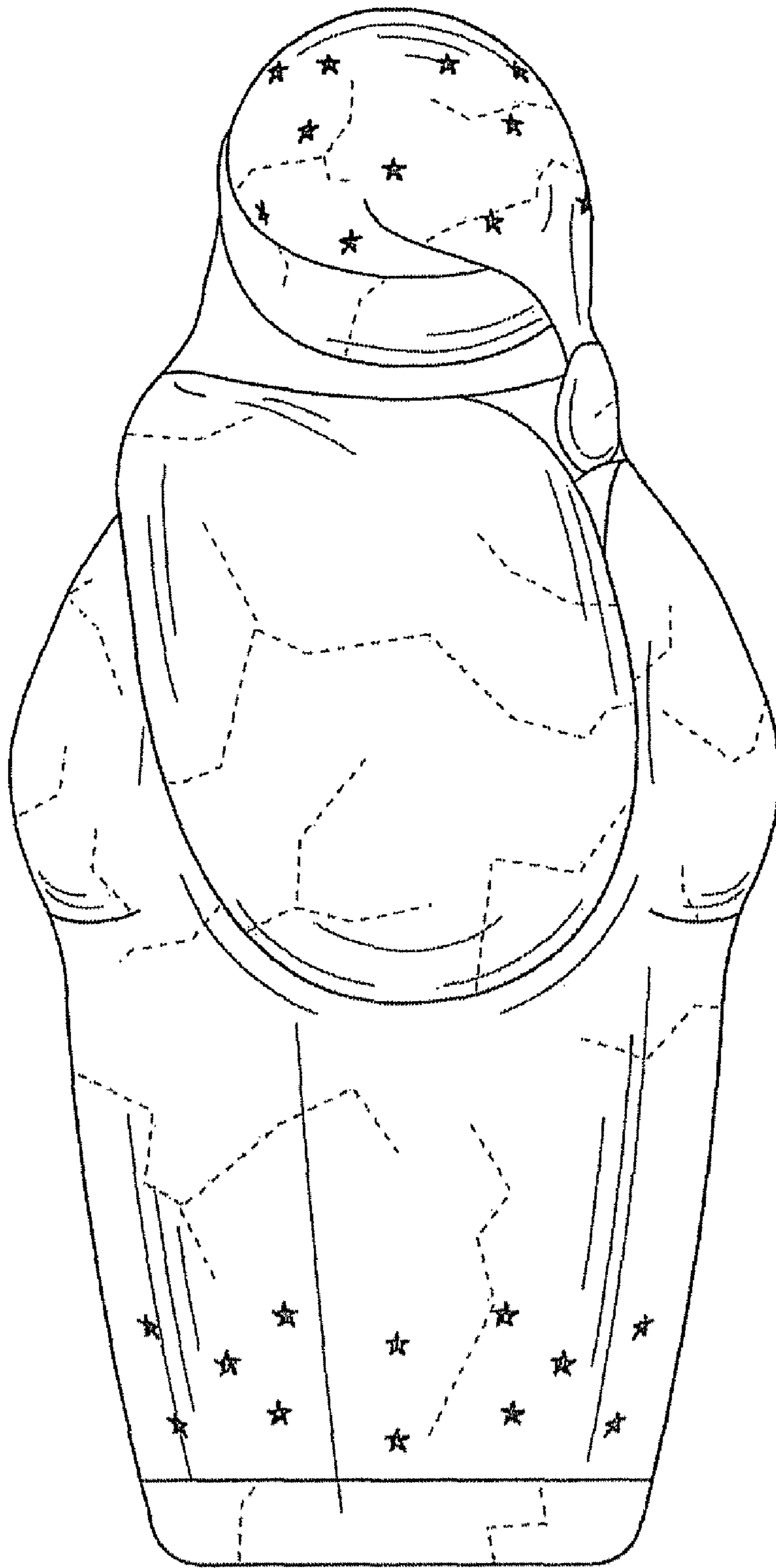

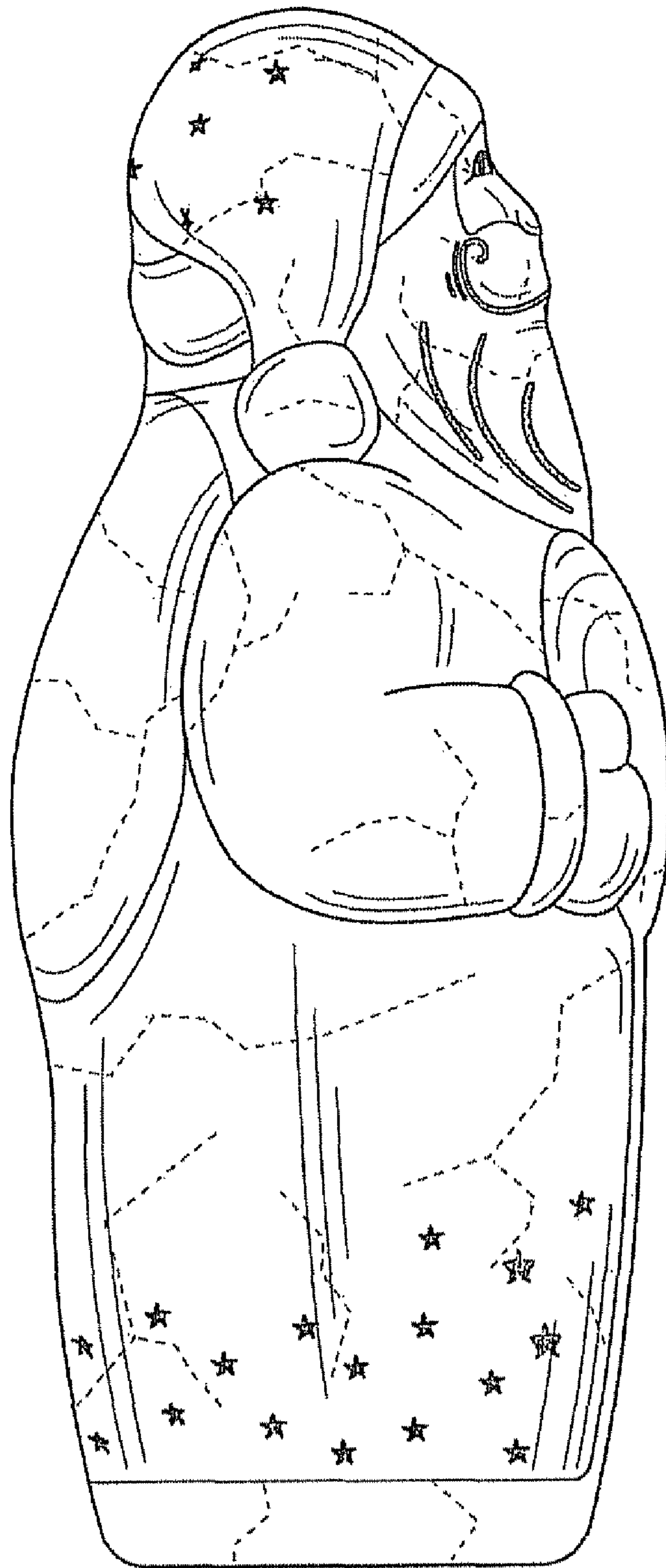

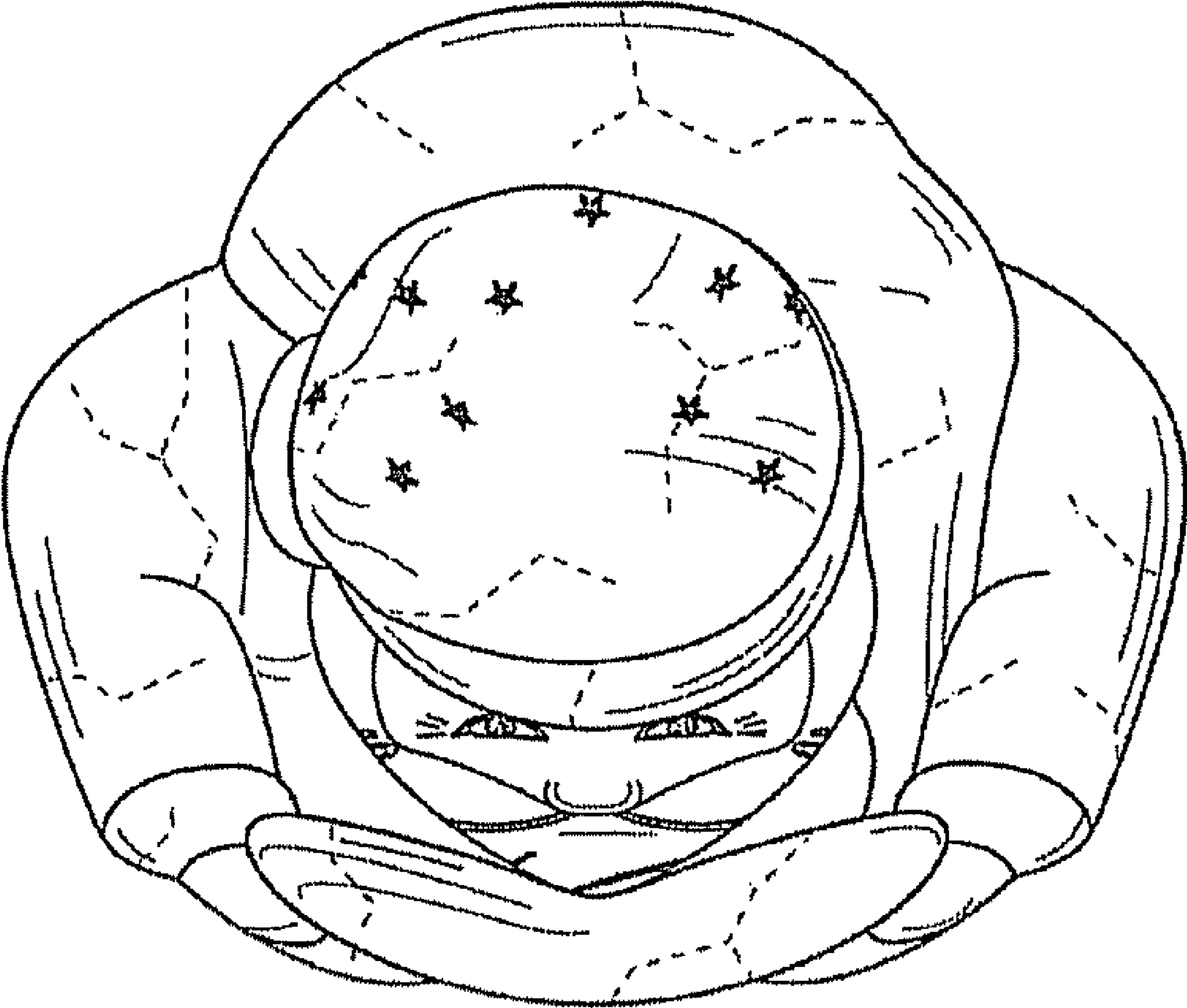
