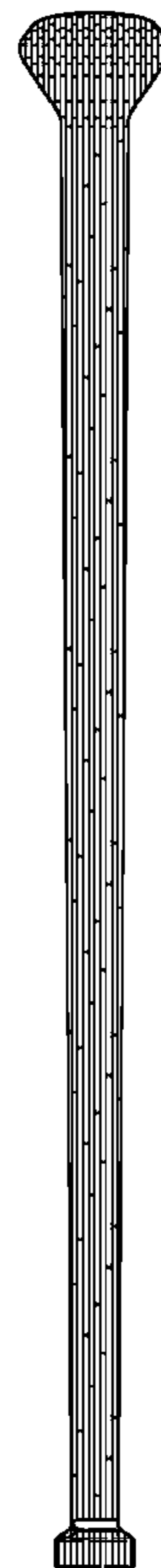
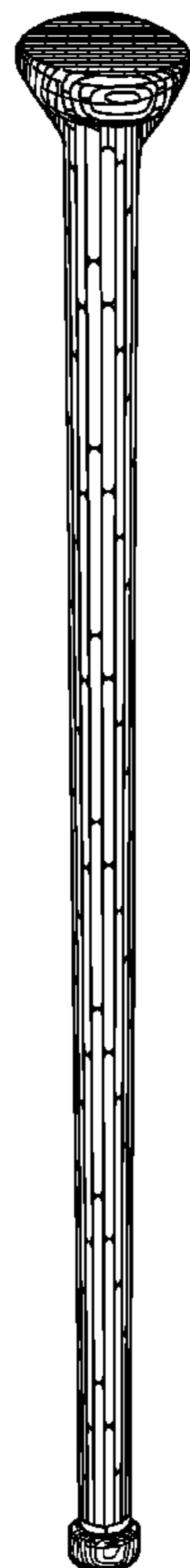
(57) **CLAIM**

What is claimed is the ornamental design for a walking cane, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a walking cane, showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

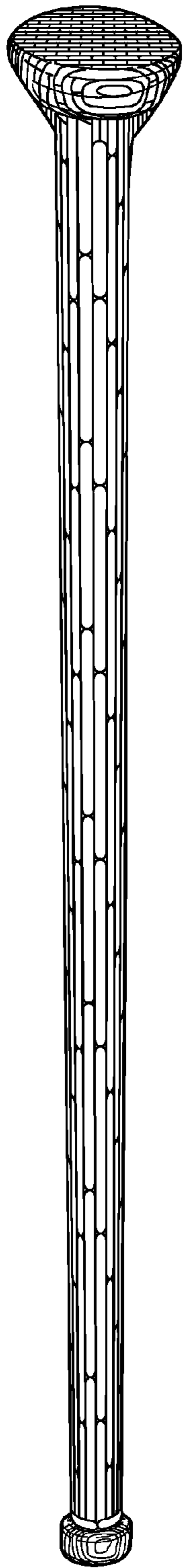

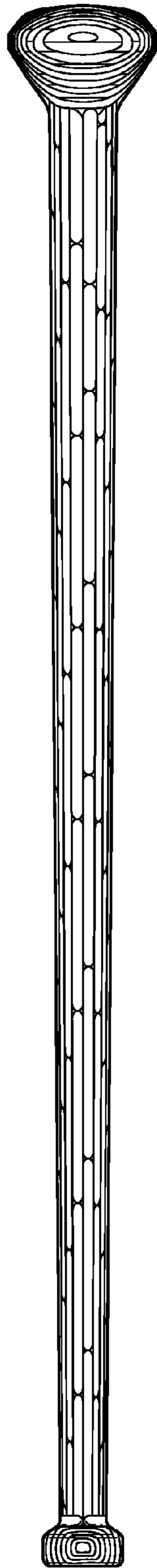

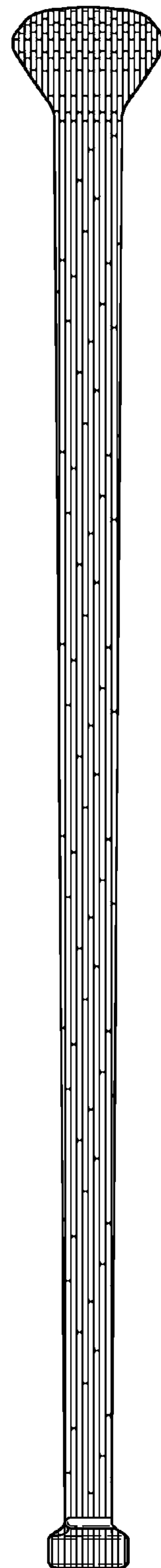

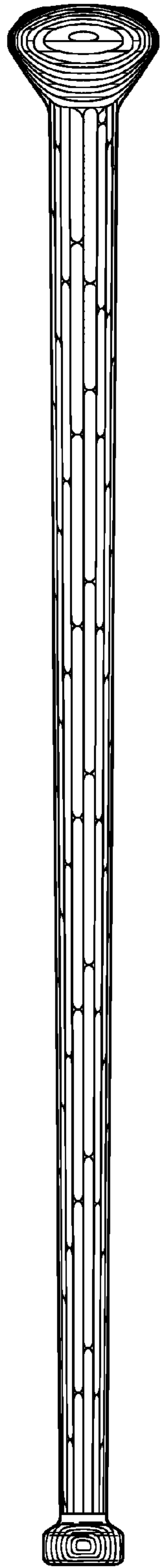

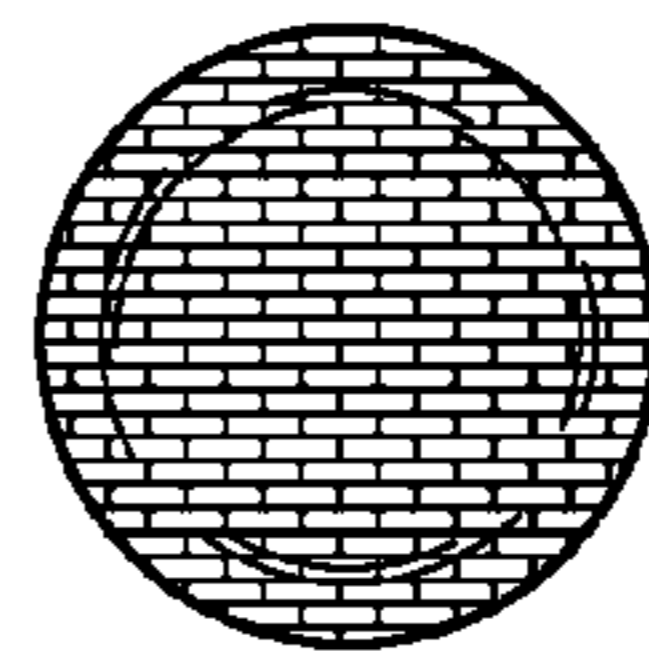

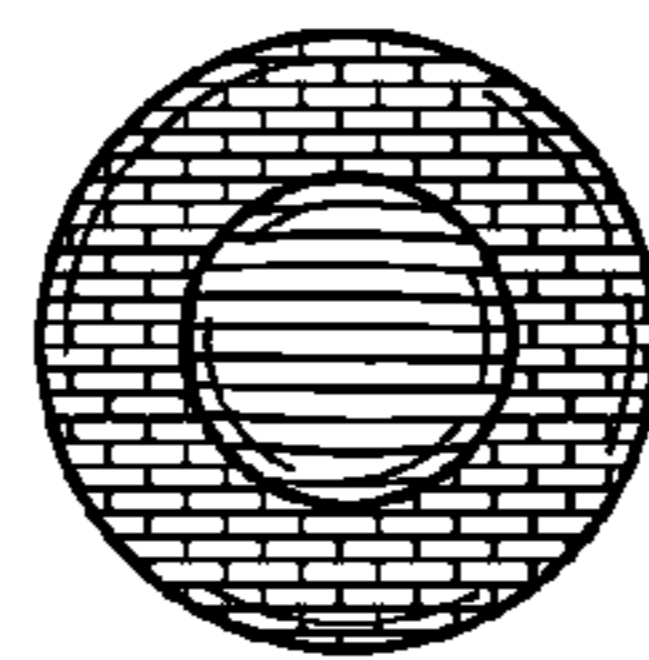
