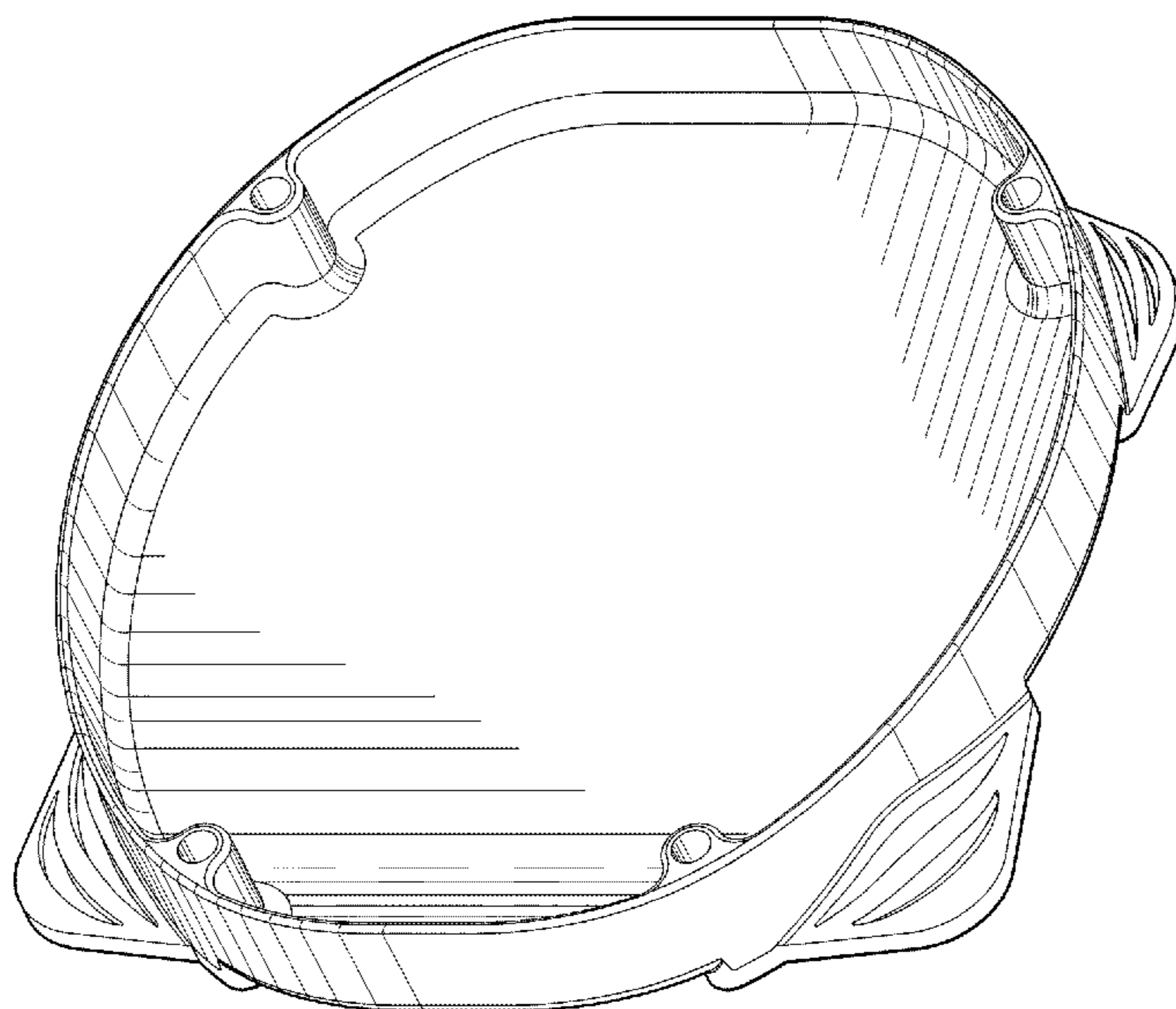
(57) **CLAIM**

The ornamental design for a golf bag bottom, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a golf bag bottom; FIG. 2 is a bottom perspective view of the golf bag bottom of FIG. 1; FIG. 3 is a front view of the golf bag bottom of FIG. 1; FIG. 4 is a rear view of the golf bag bottom of FIG. 1; FIG. 5 is a top view of the golf bag bottom of FIG. 1; FIG. 6 is a bottom view of the golf bag bottom of FIG. 1; FIG. 7 is a left view of the golf bag bottom of FIG. 1; and FIG. 8 is a right view of the golf bag bottom of FIG. 1.

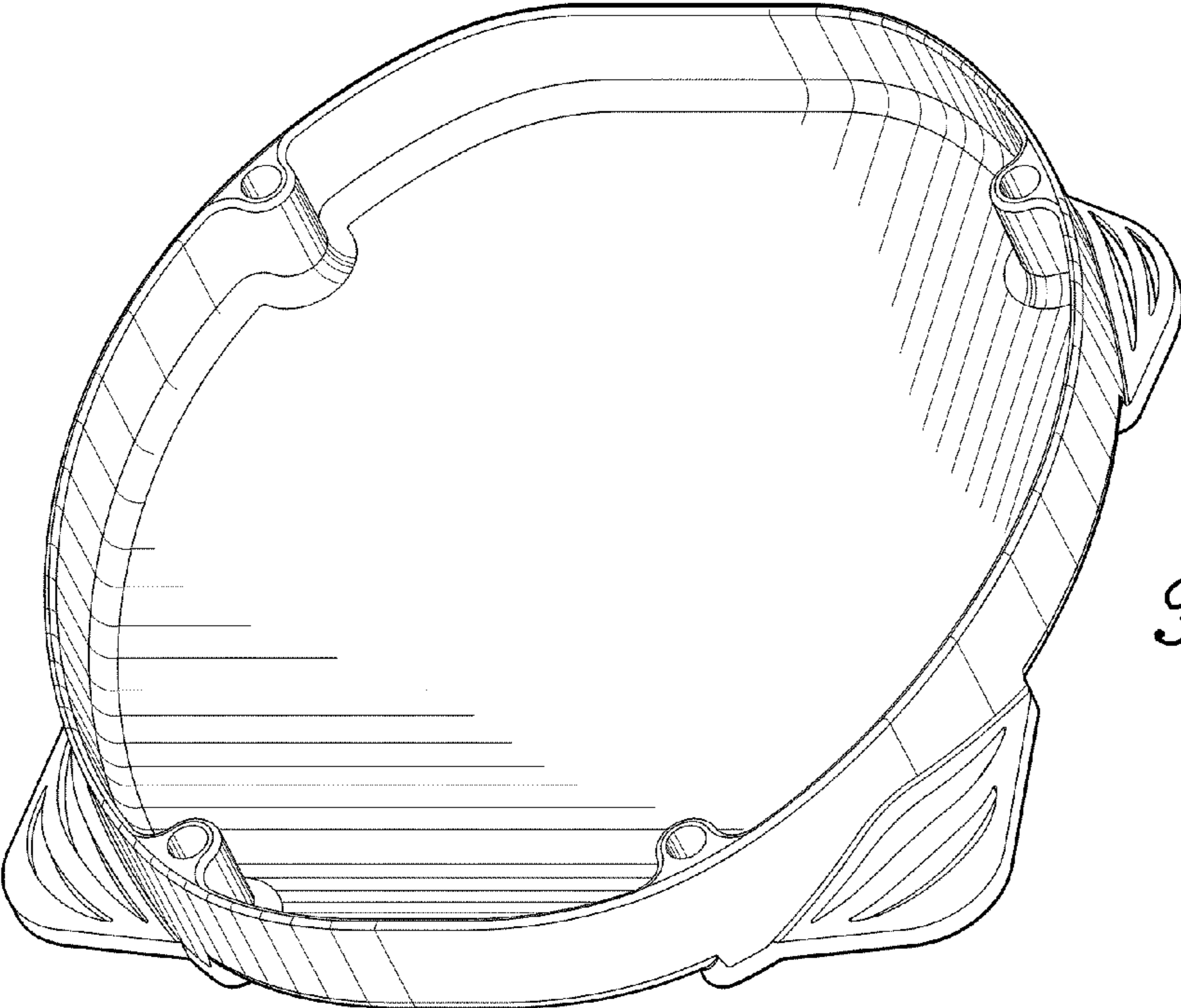

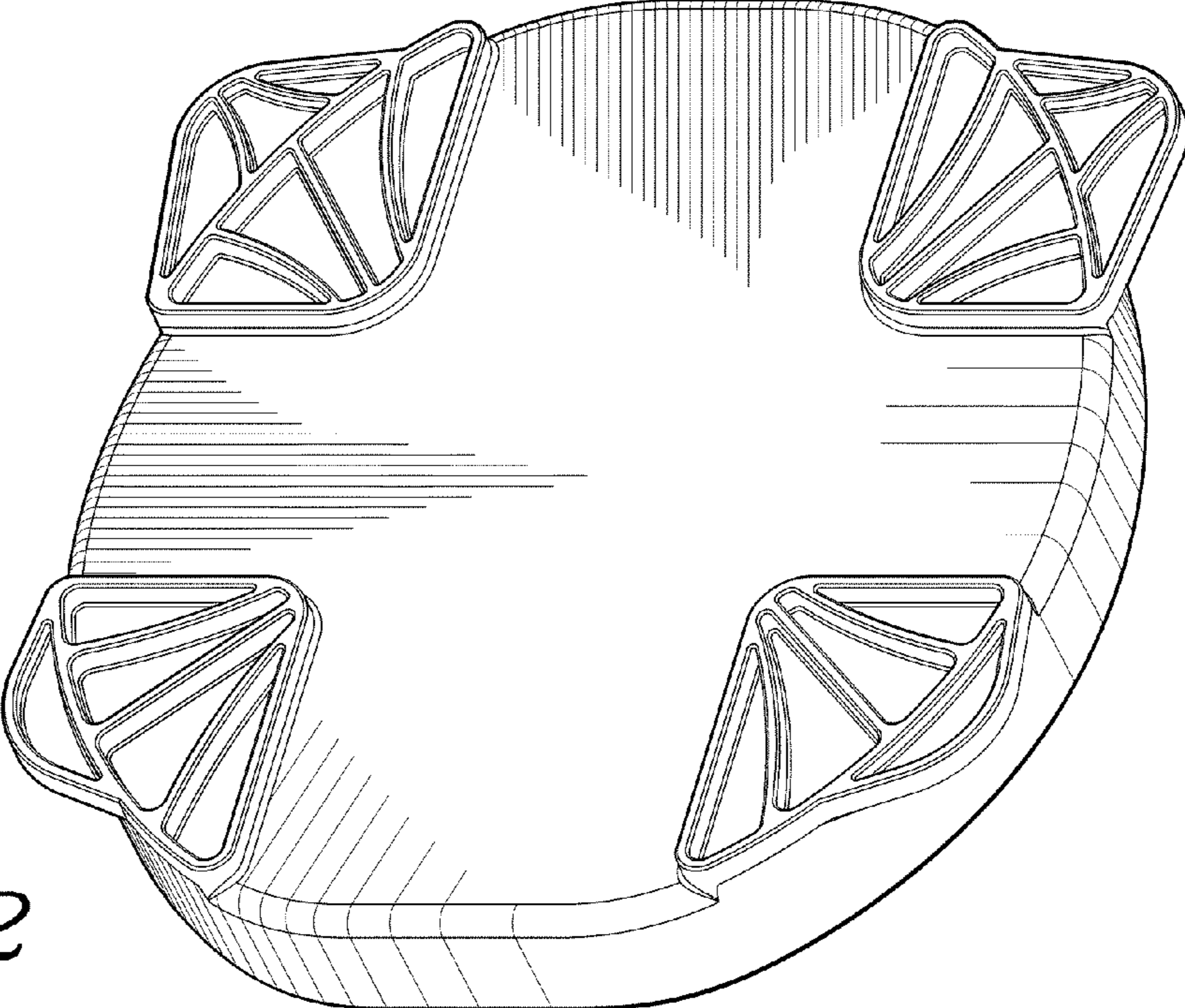

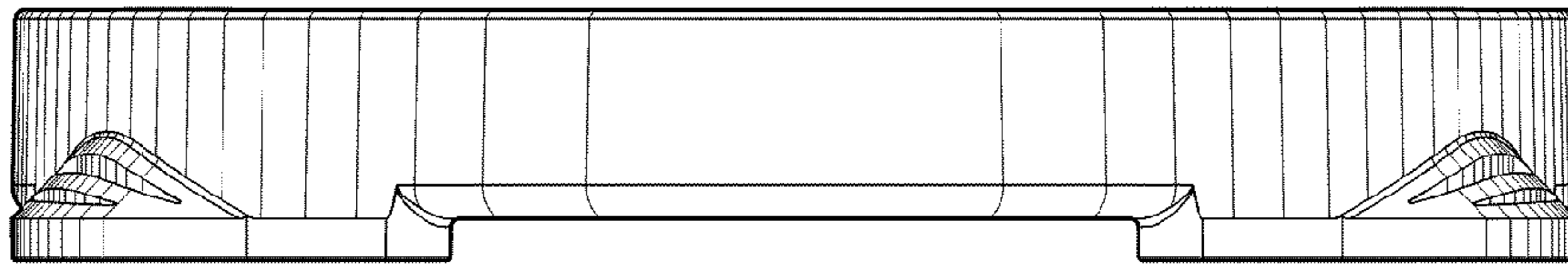

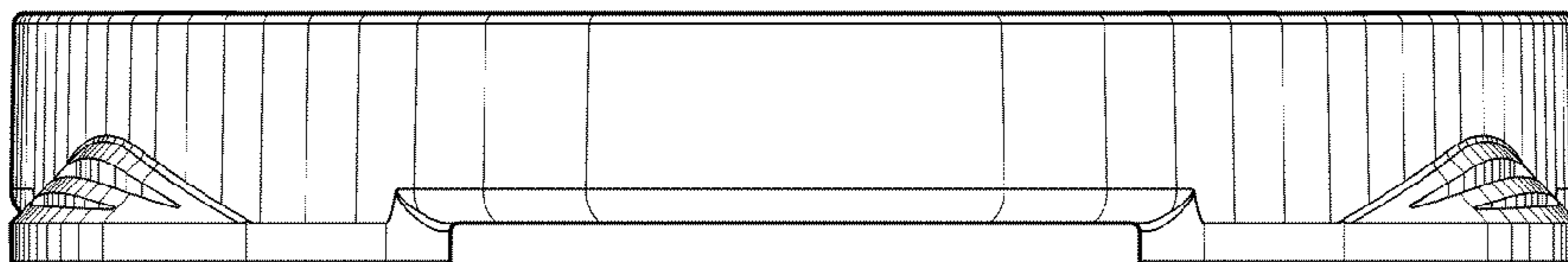

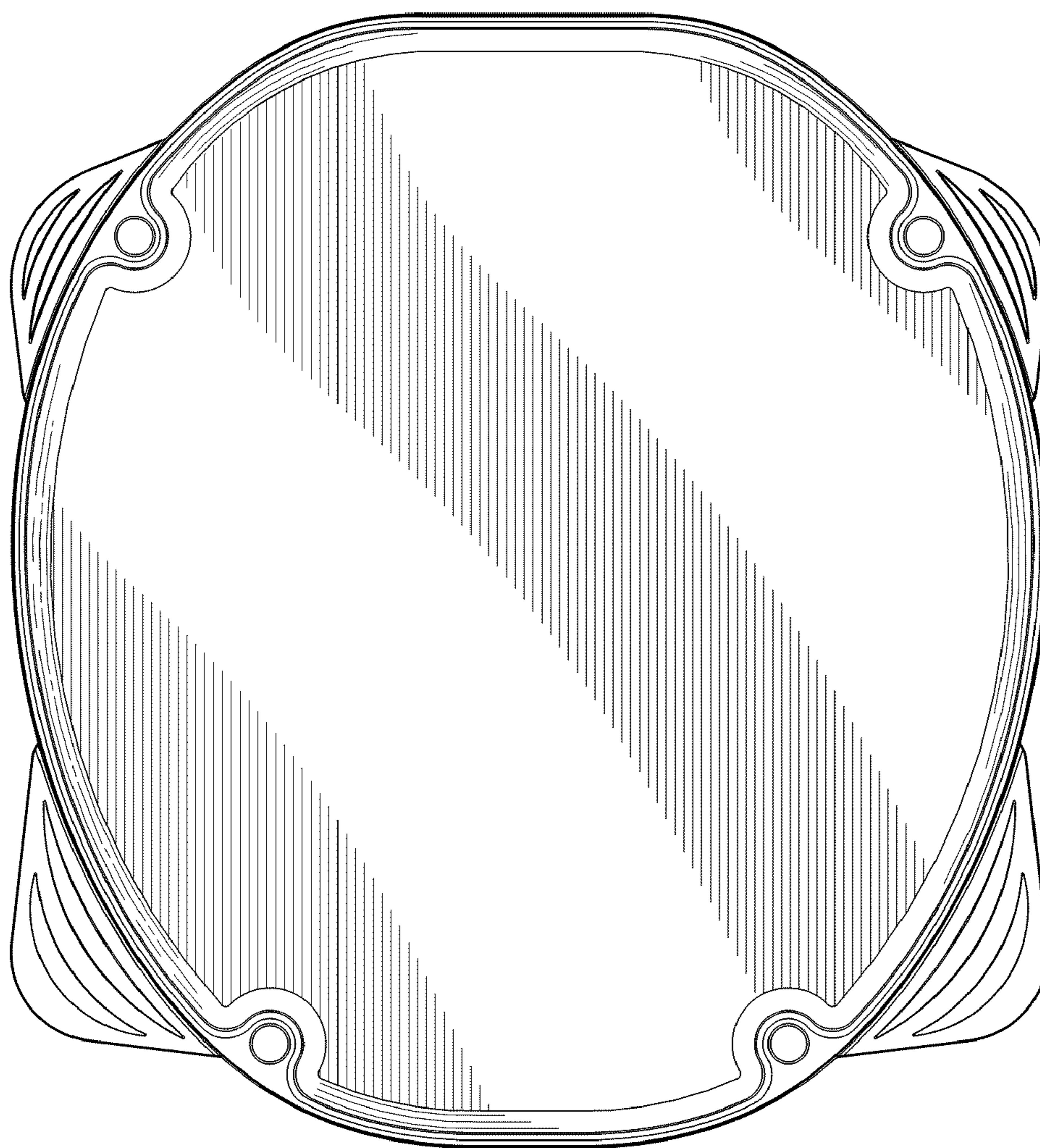

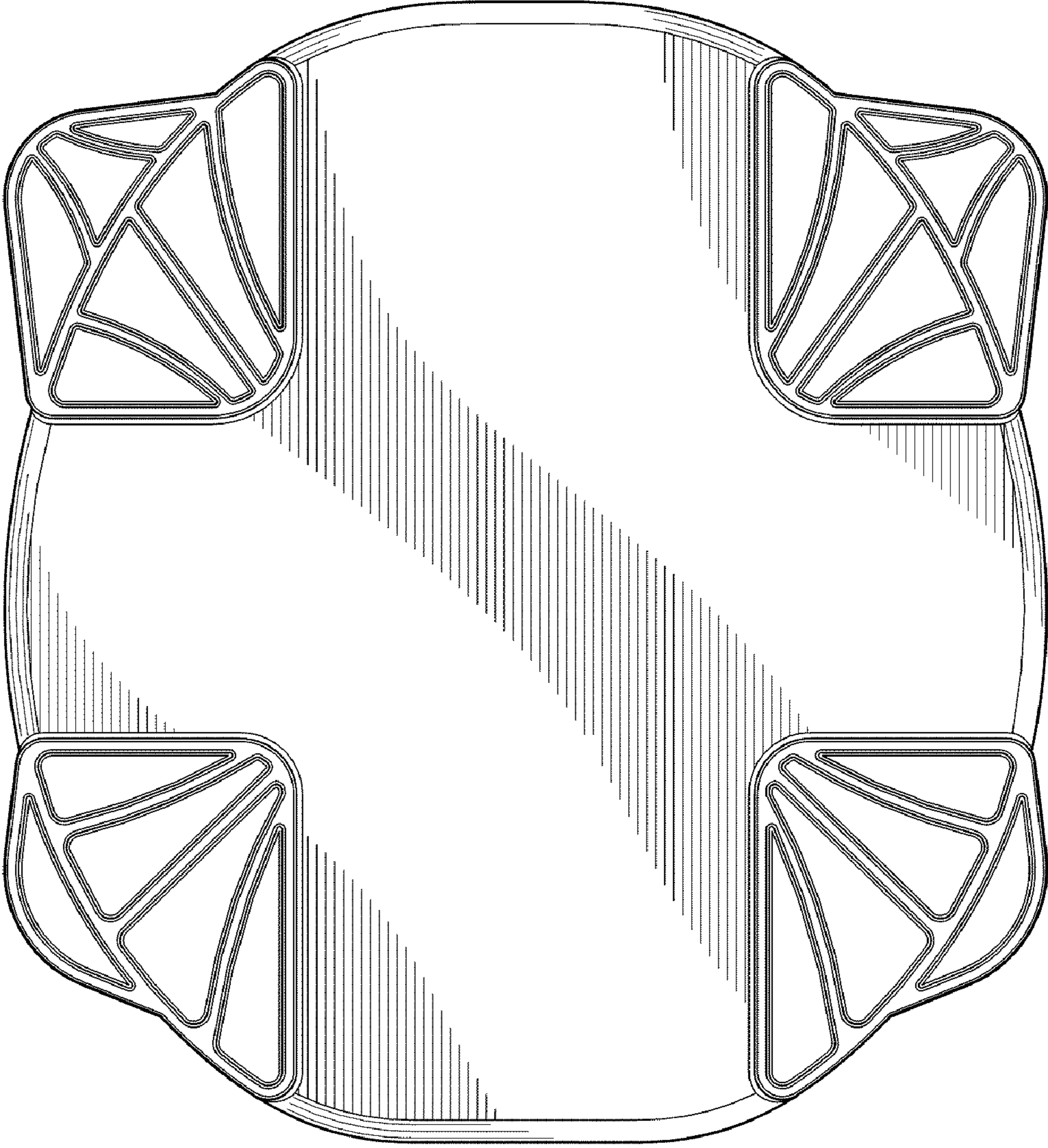

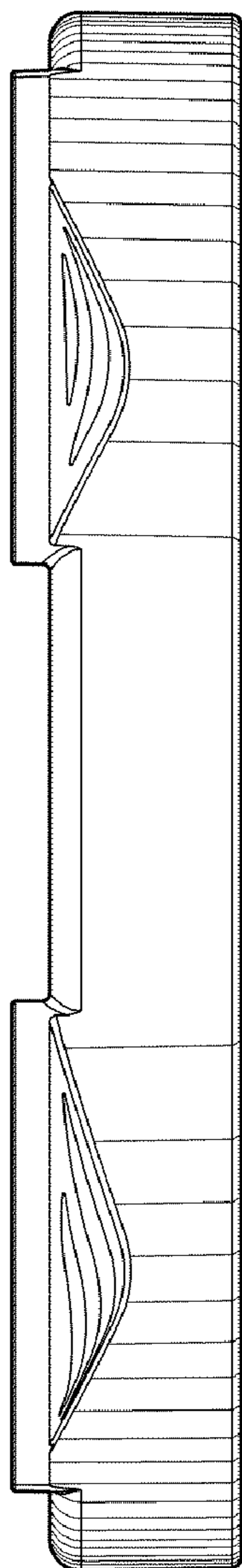

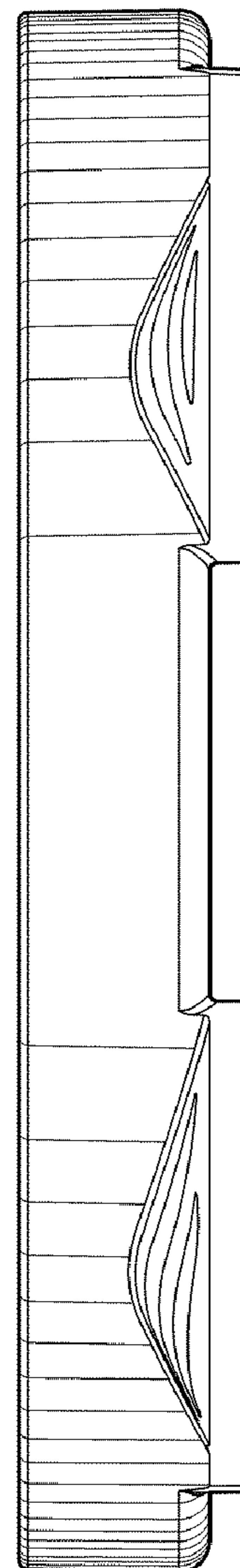
