(57) **CLAIM**

The ornamental design for a produce bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, perspective view of a produce bag showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

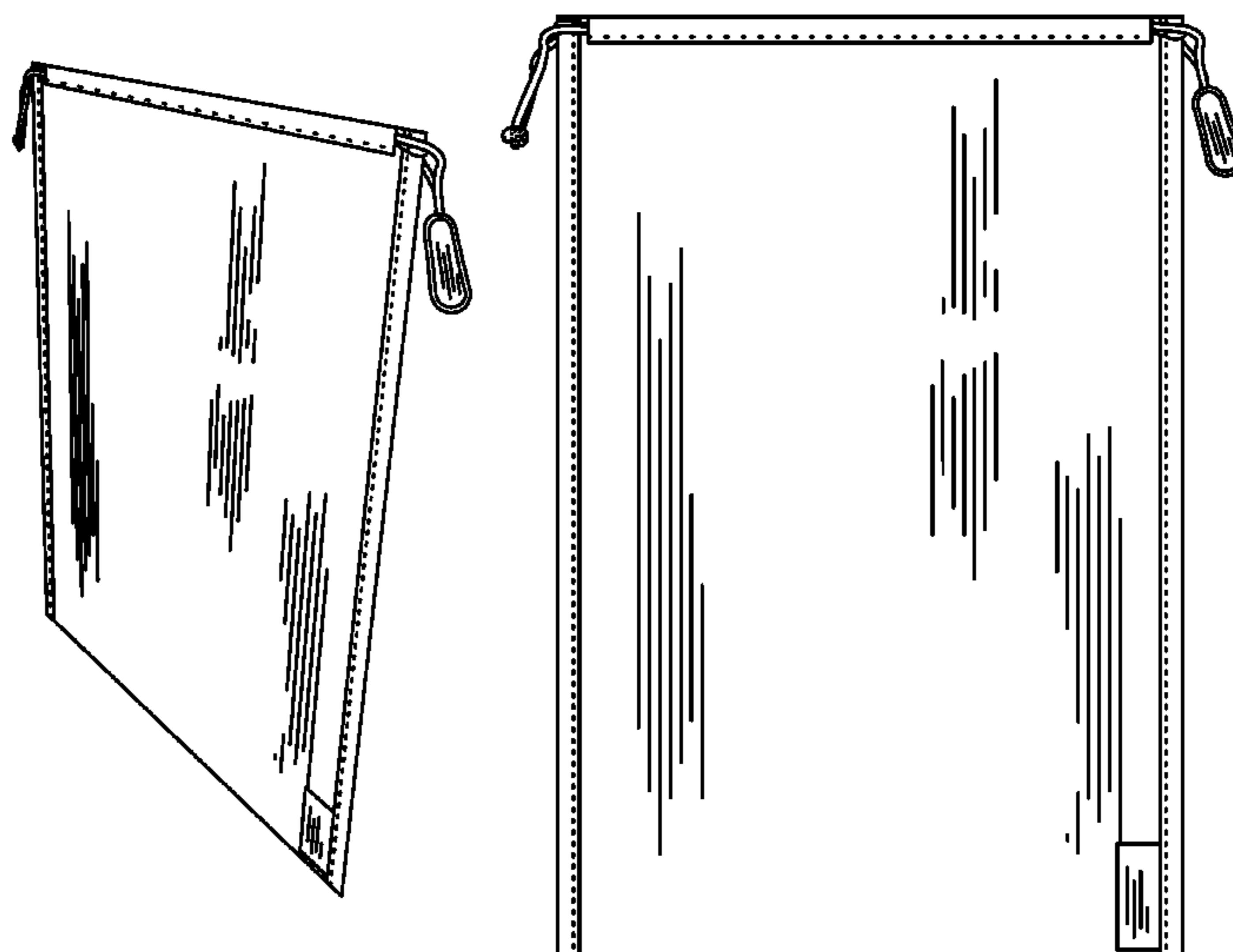
FIG. 6 is a bottom view thereof; and,

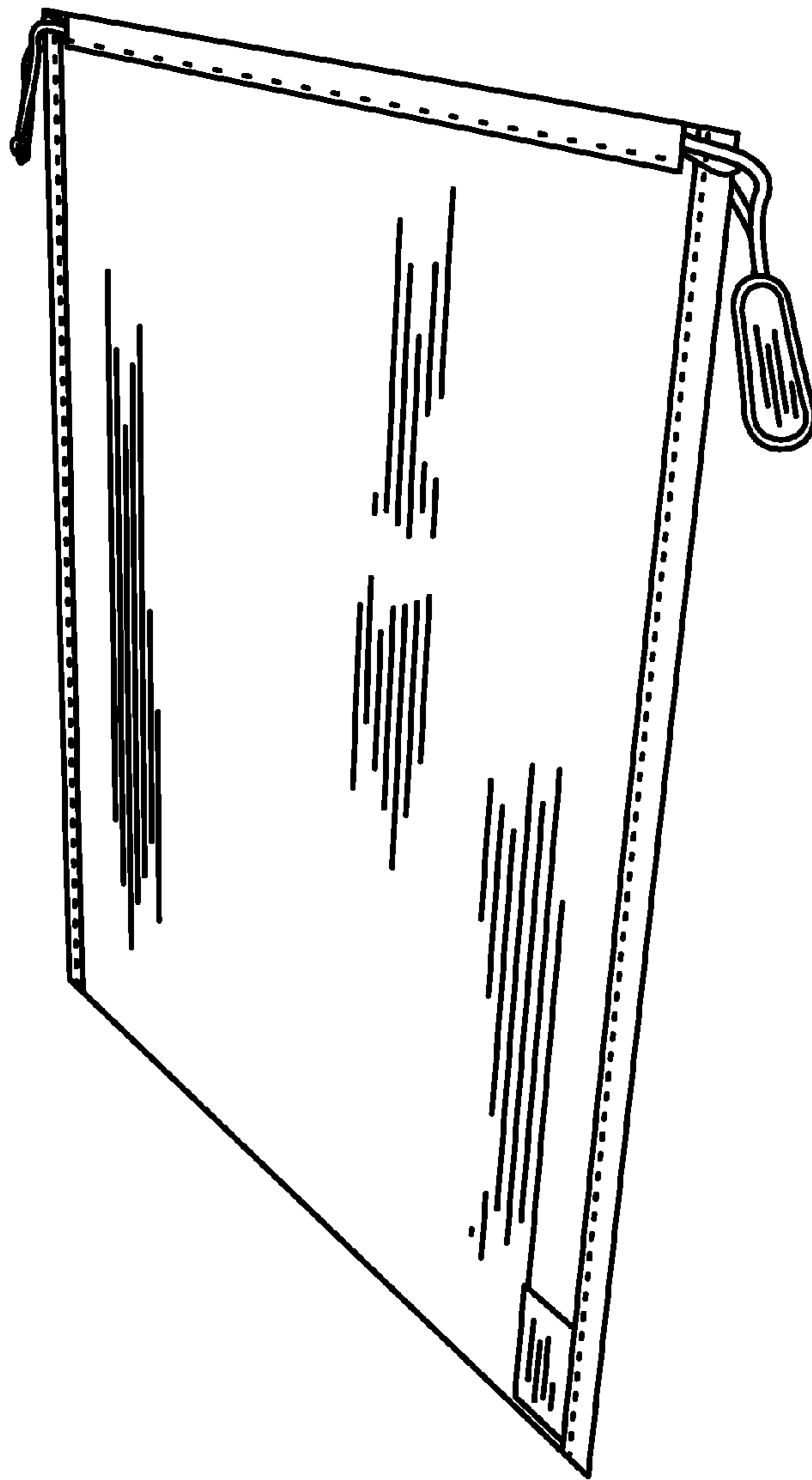

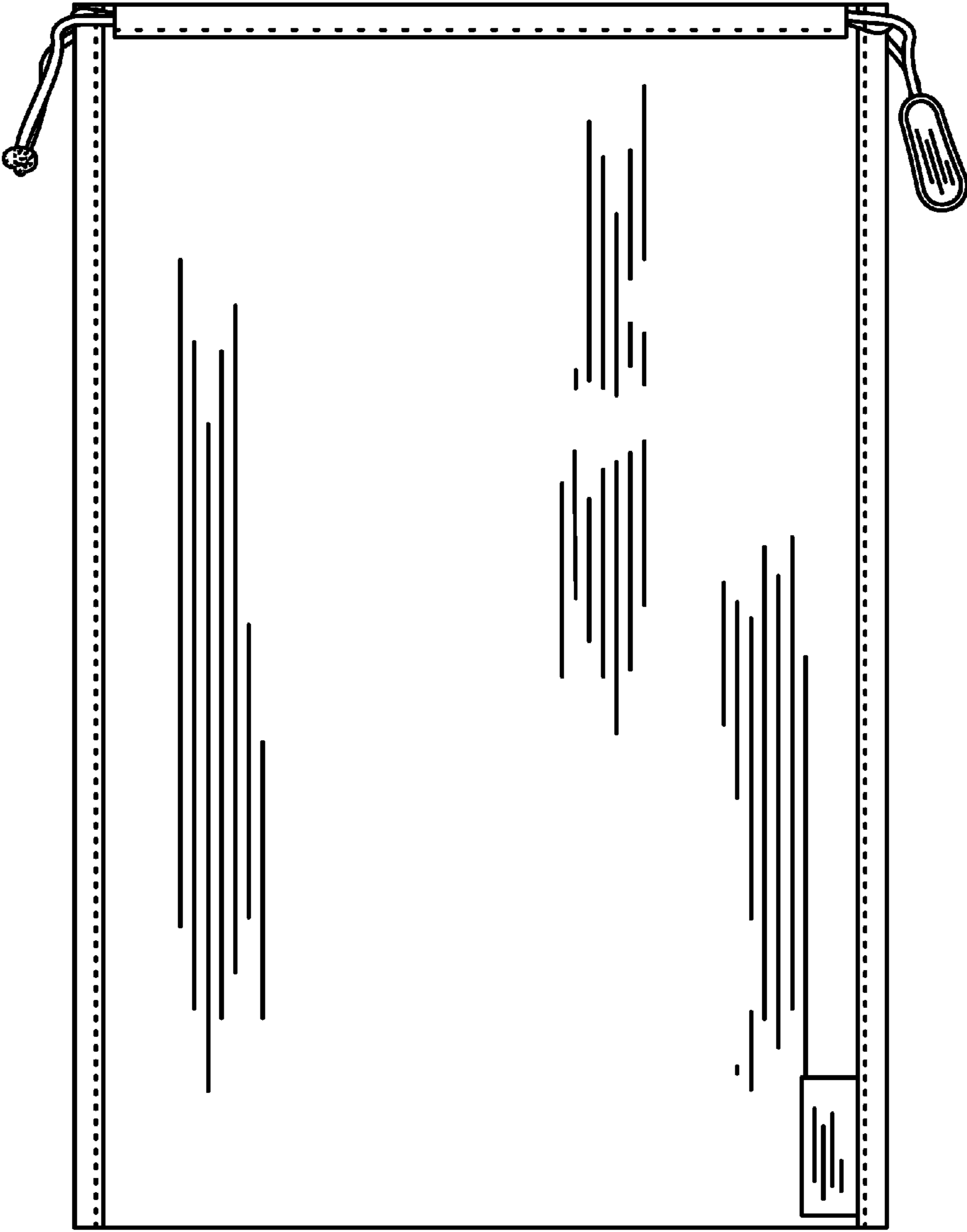

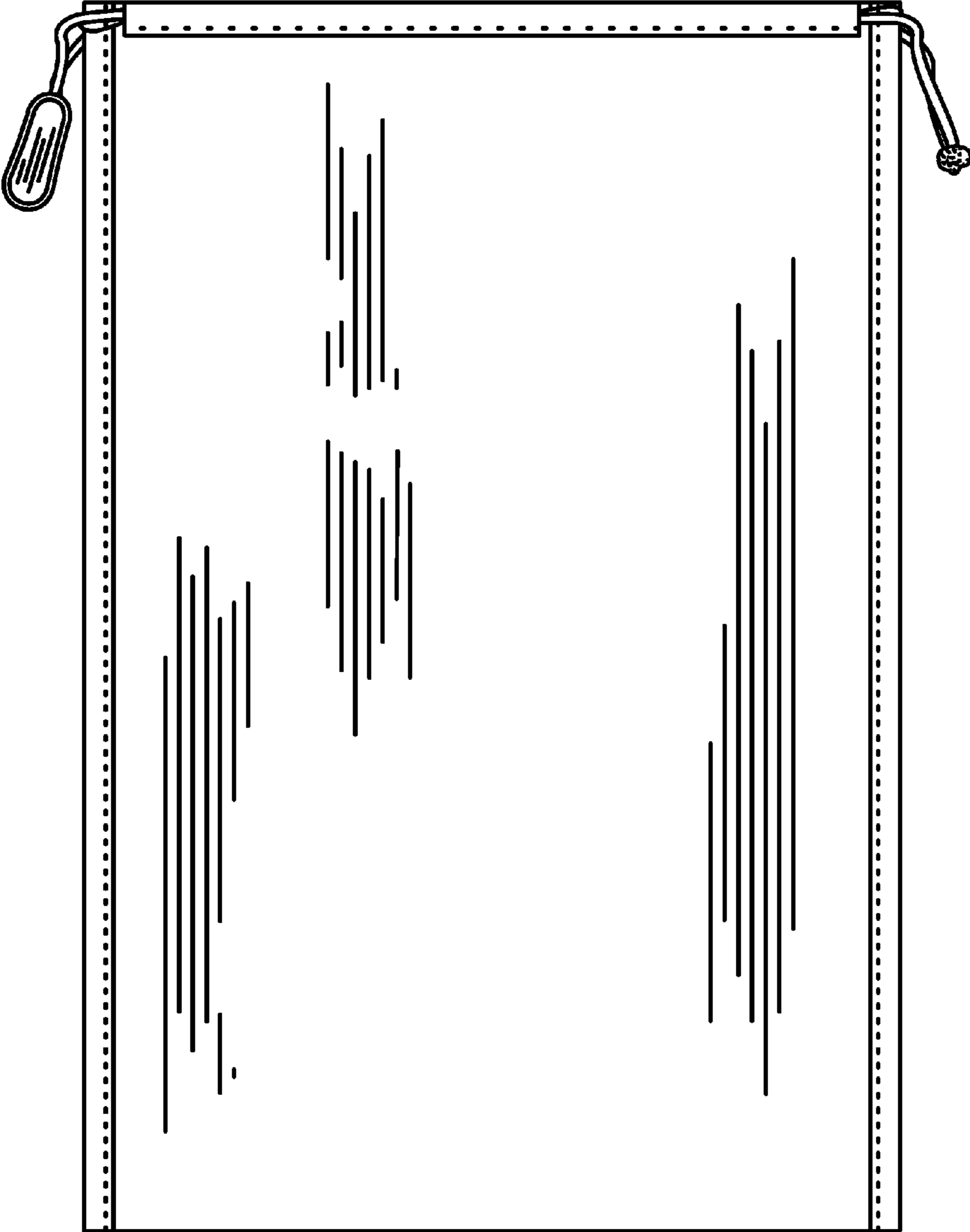
