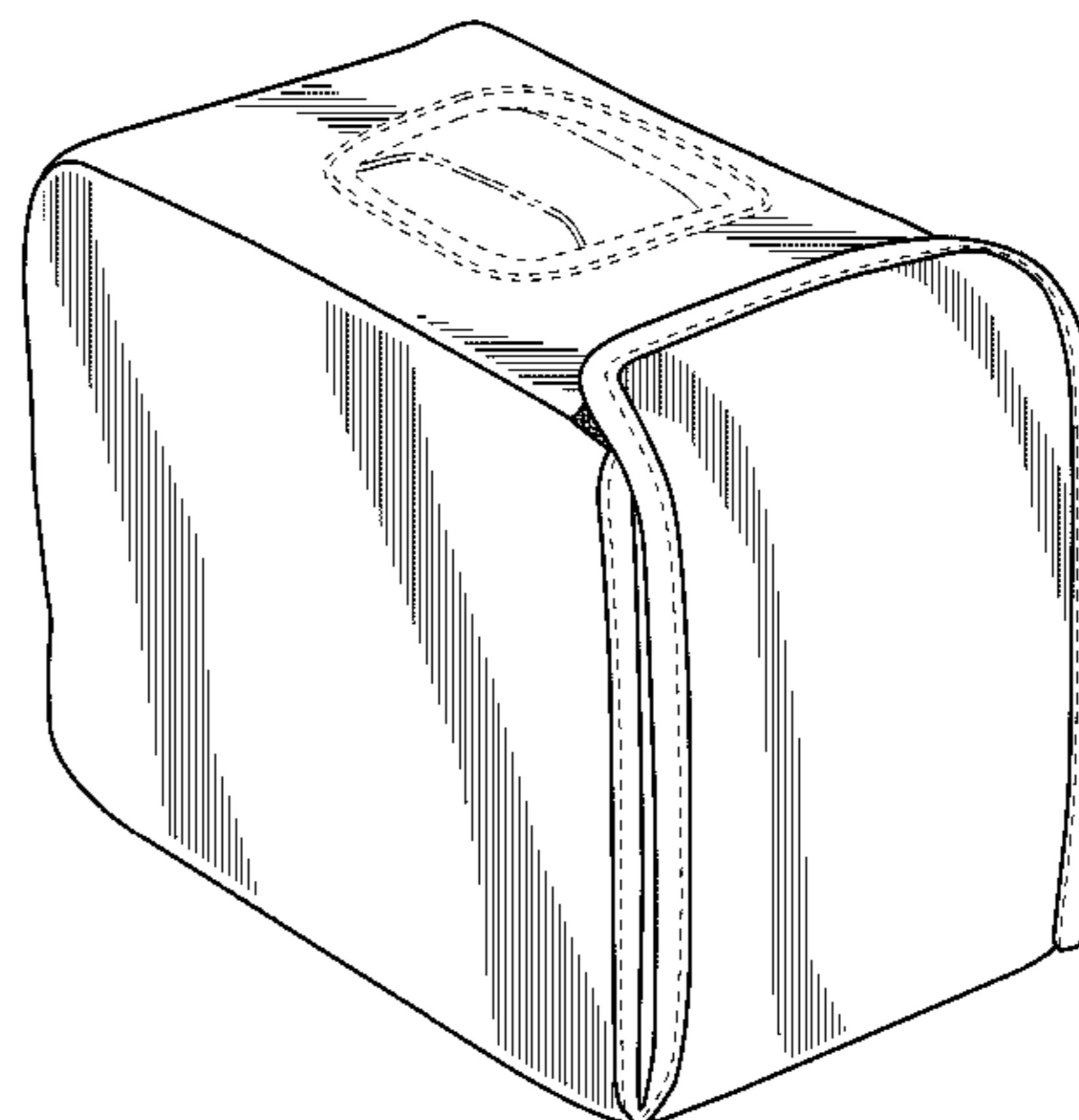
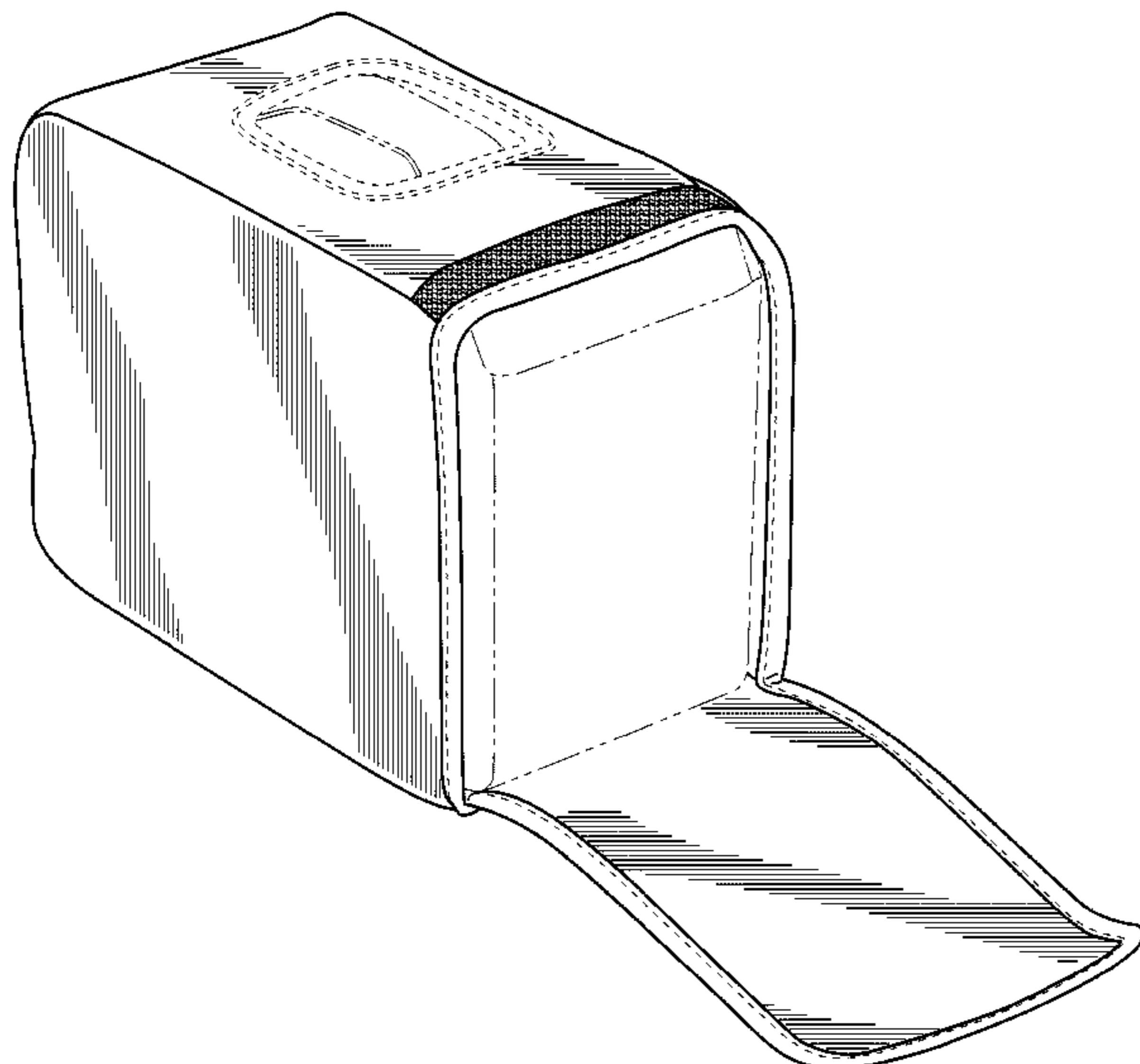
The ornamental design for a beverage case coolie, as shown and described.

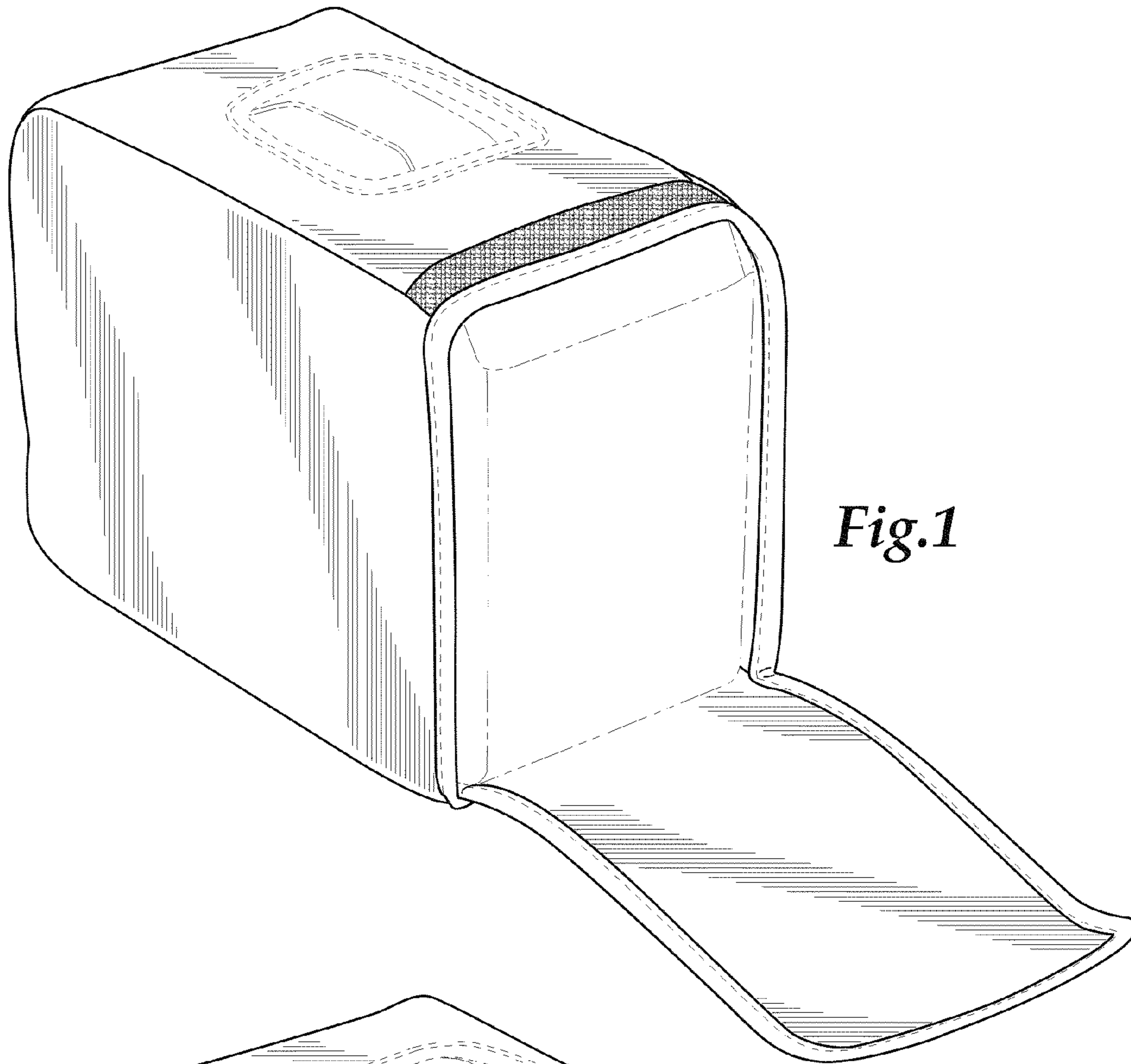
**DESCRIPTION**

FIG. 1 is a front perspective view of a beverage case coolie pictured in an open configuration showing my new design; FIG. 2 is a front perspective view of the beverage case coolie pictured in FIG. 1 in a closed configuration; FIG. 3 is a side elevation view of the beverage case coolie pictured in FIG. 1; FIG. 4 is a rear elevation view of the beverage case coolie pictured in FIG. 1; FIG. 5 is a front elevation view of the beverage case coolie pictured in FIG. 1; FIG. 6 is a top plan view of the beverage case coolie pictured in FIG. 1; and, FIG. 7 is a bottom plan view of the beverage case coolie pictured in FIG. 1.

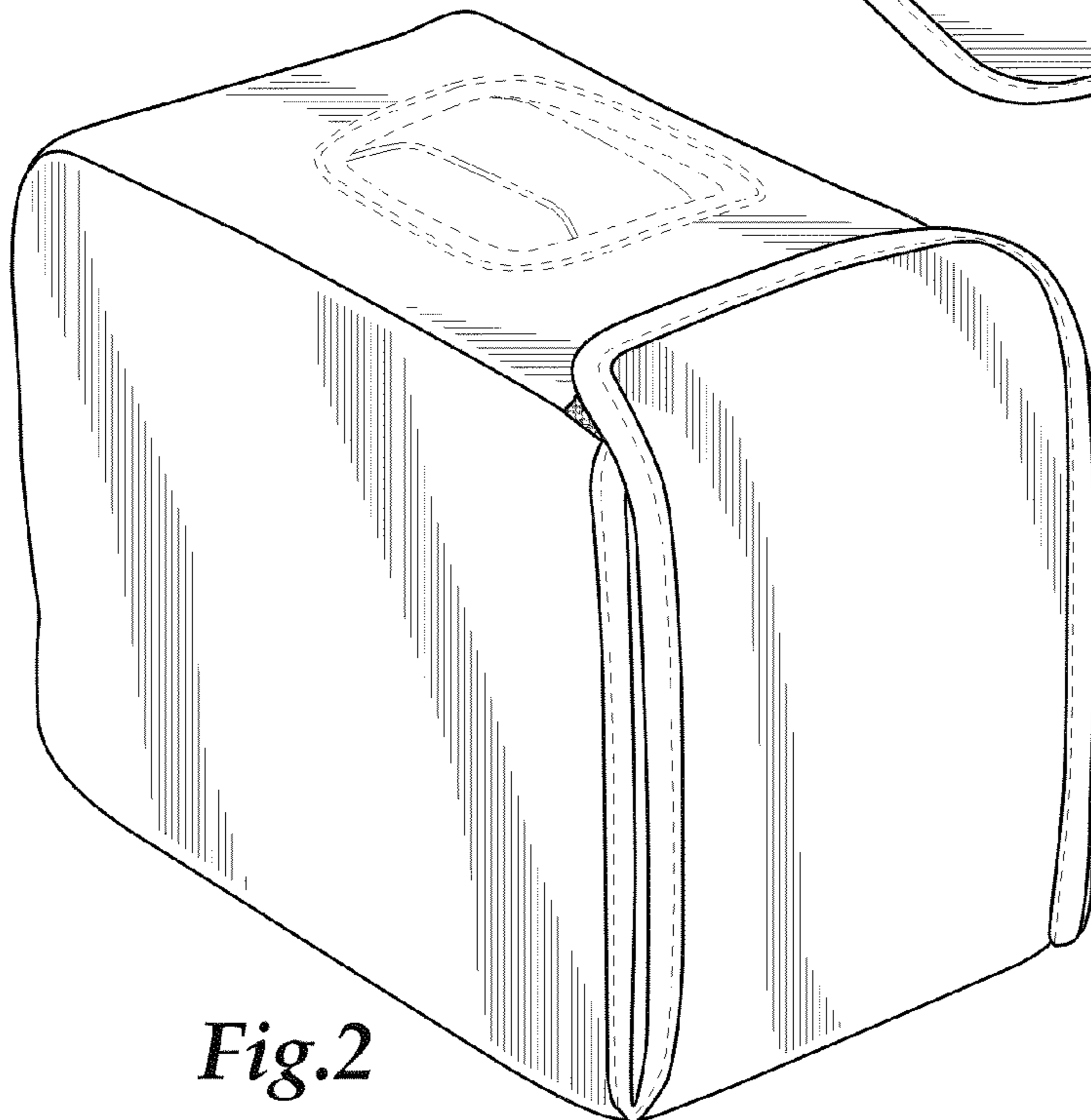
All side views not shown form no part of the claimed design. The dashed-dot-dashed lines showing of the opening in FIG. 1 and the center square panel in FIGS. 1-2 and 6 is included for the purpose of illustrating only and forms no part of the claimed design. The dashed lines shown around the trim of the beverage coolie and square panel are stitch marks.

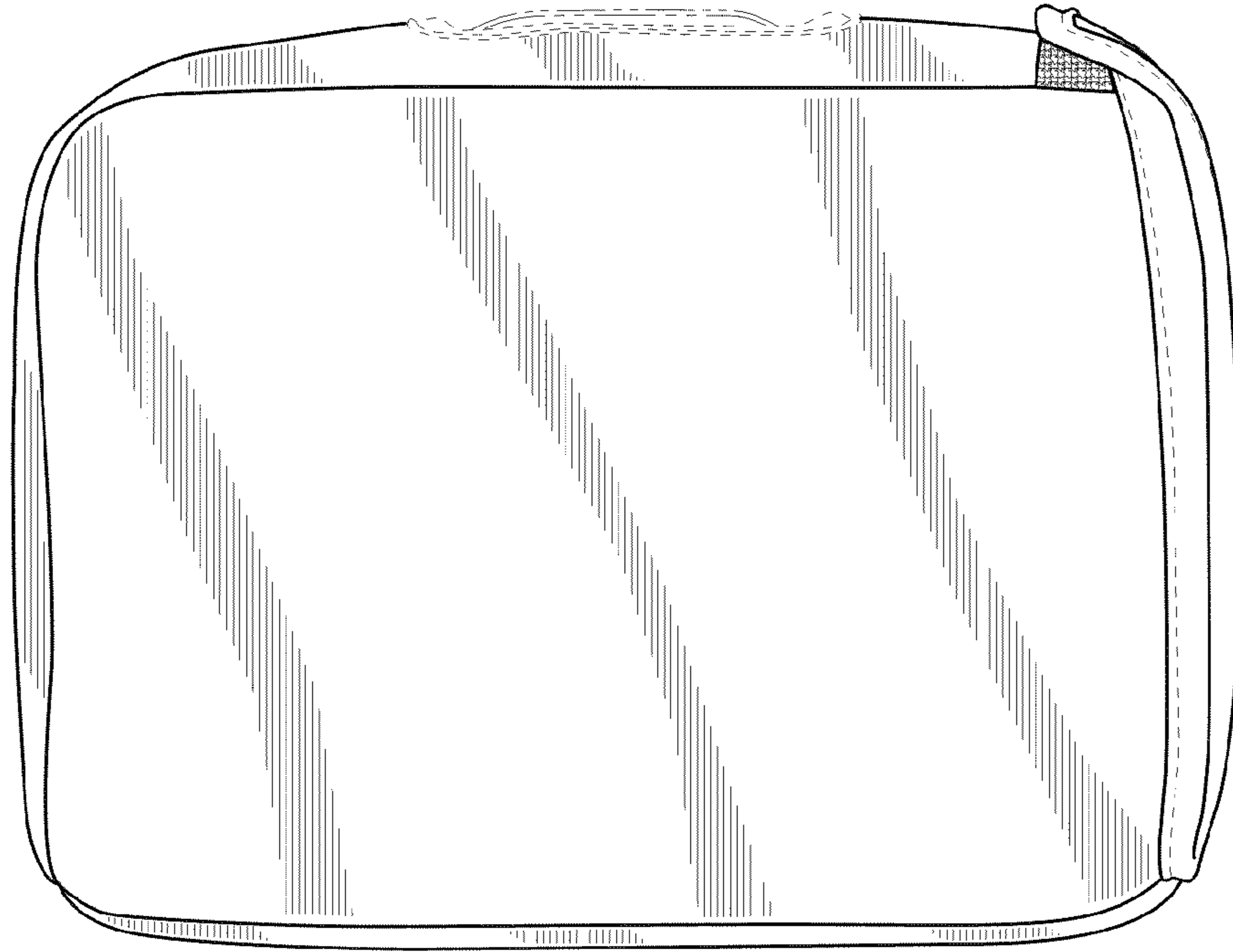




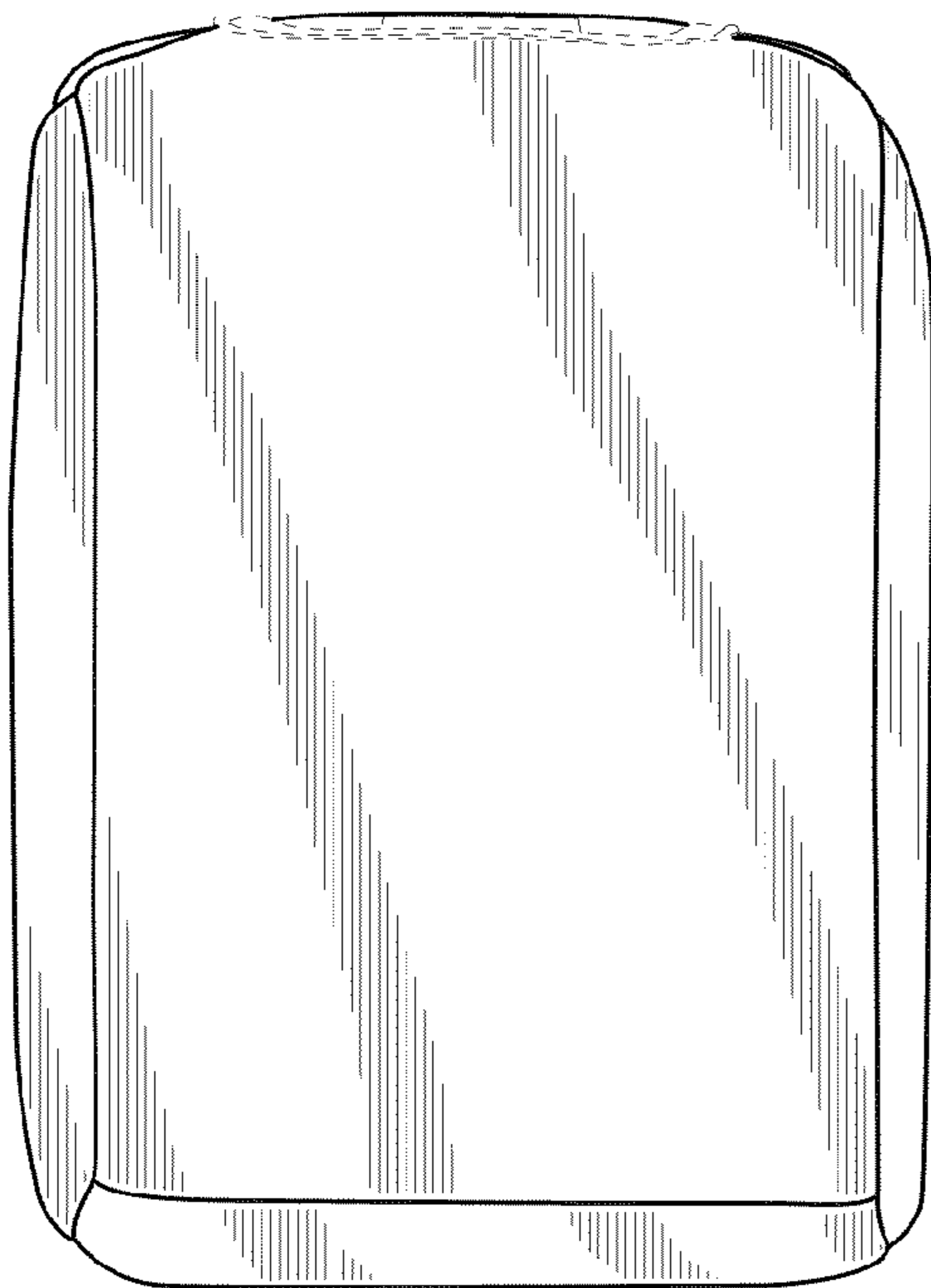

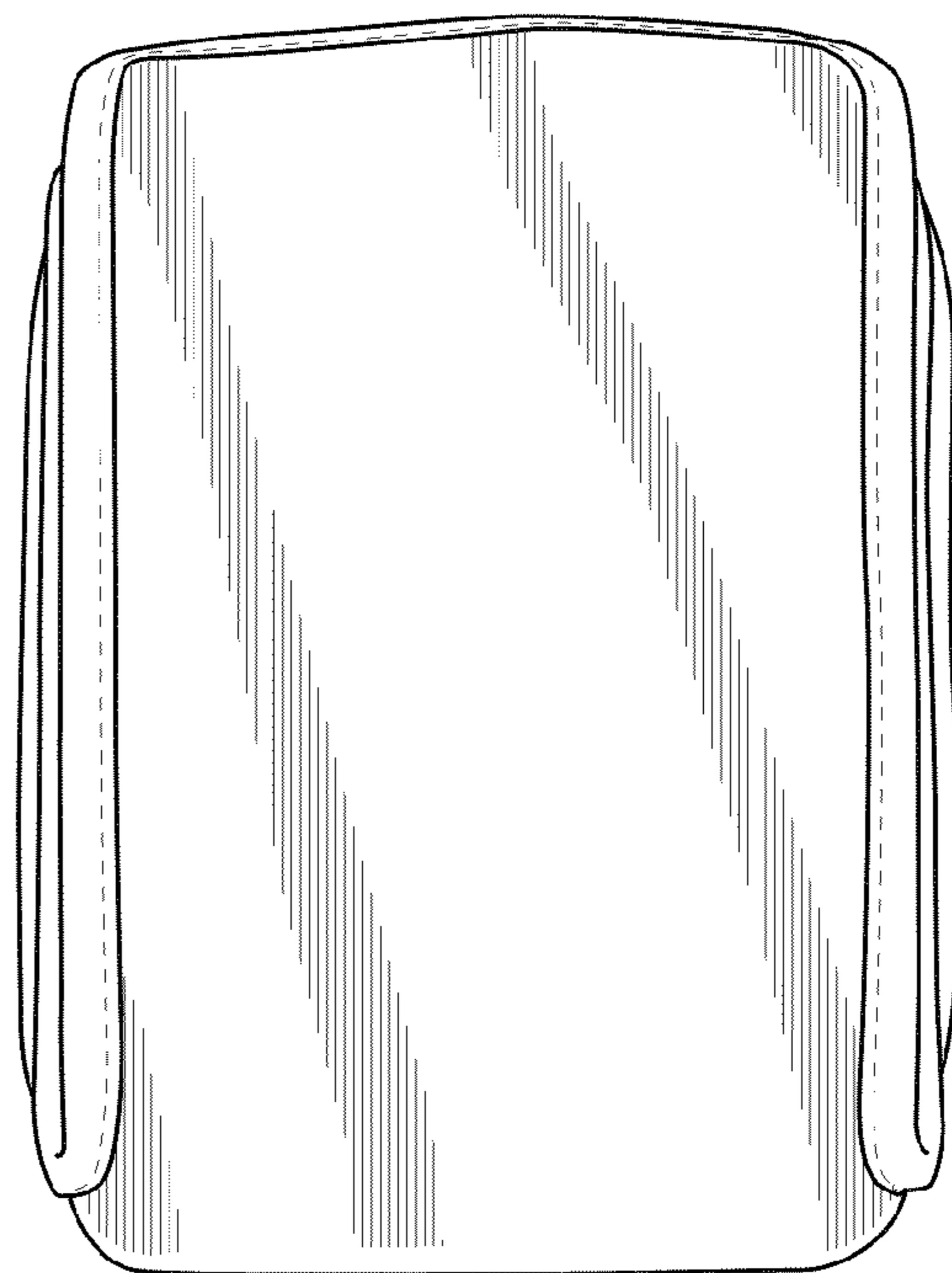

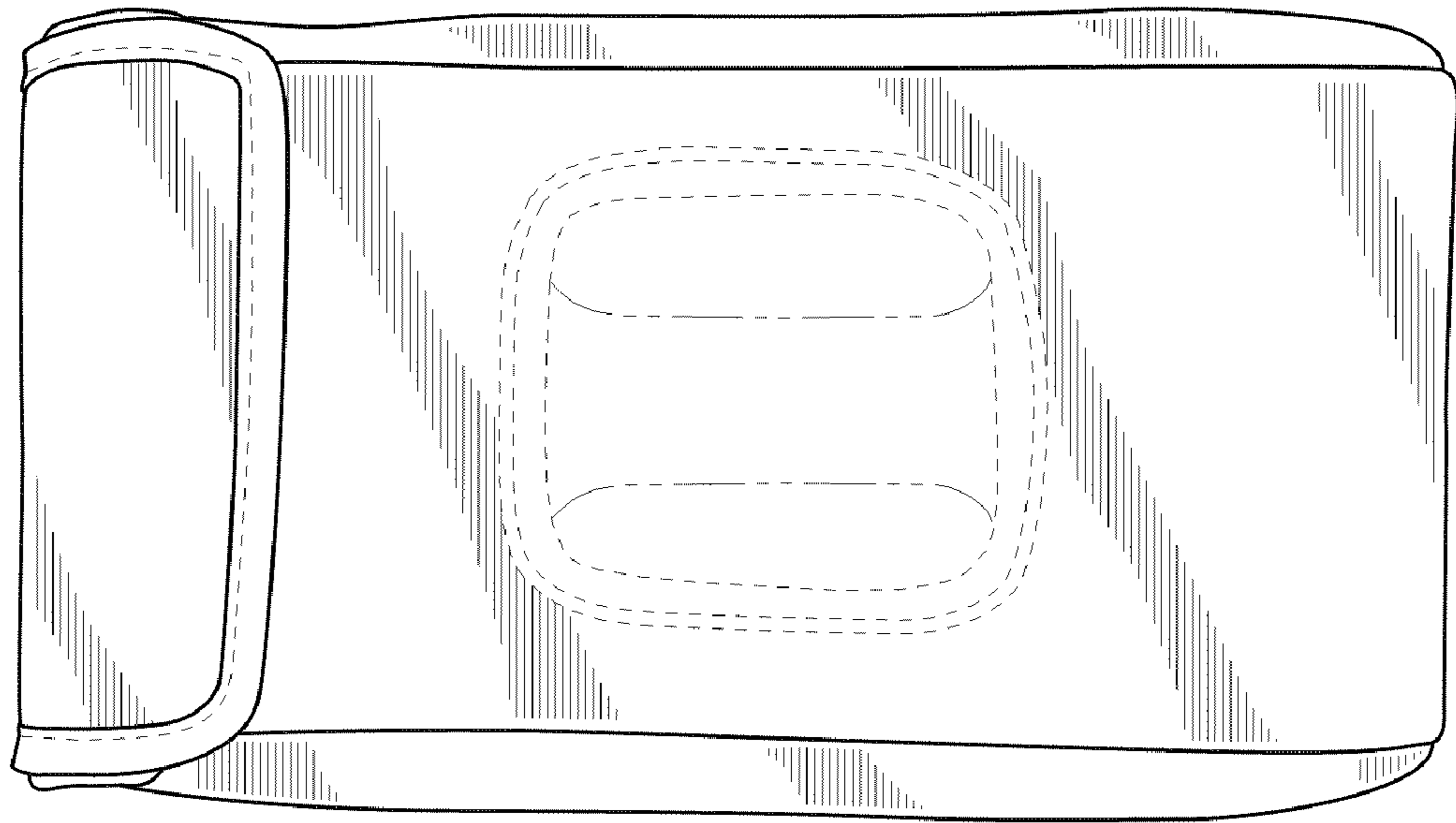

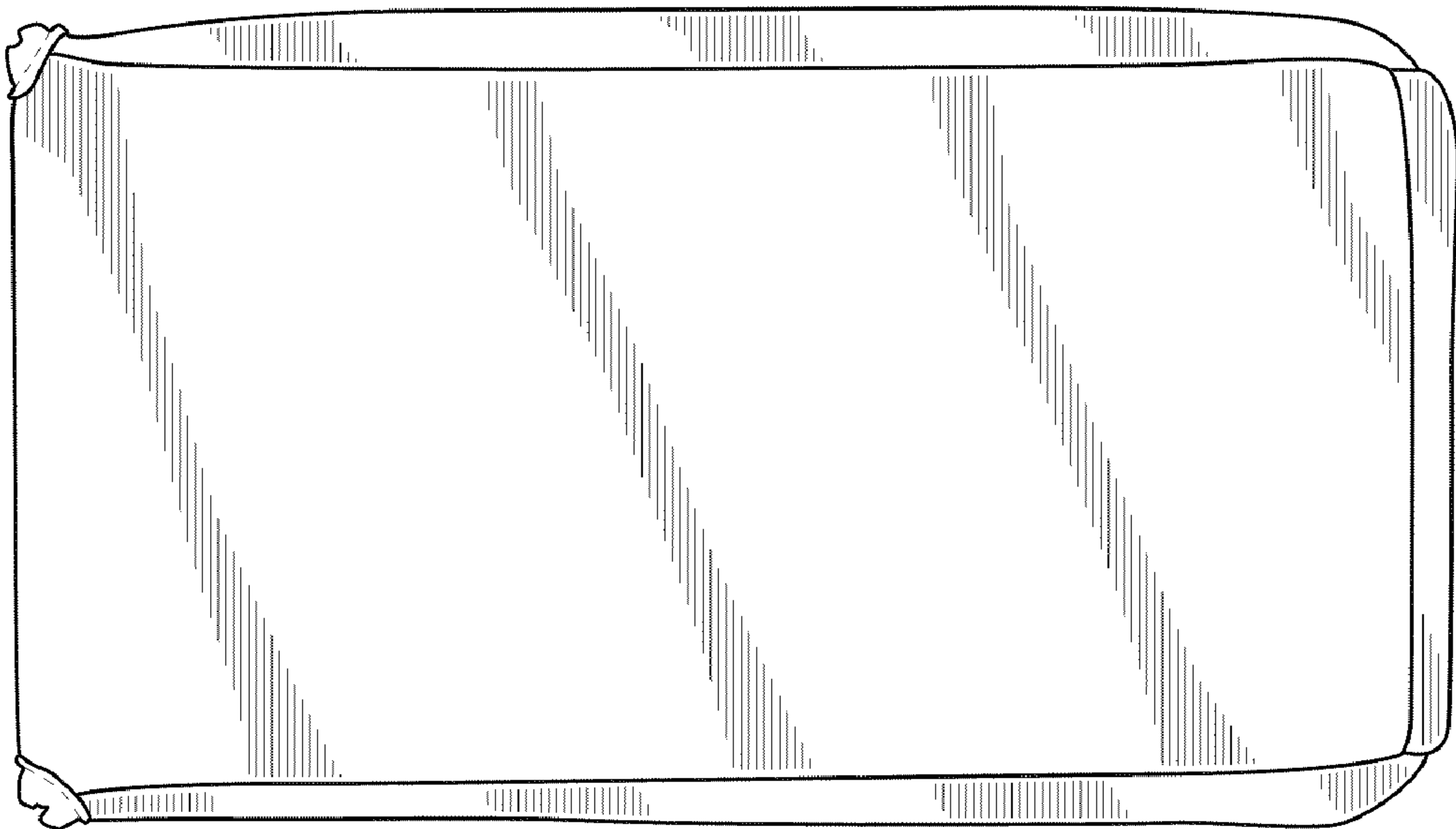
