(57) **CLAIM**

The ornamental design for a flip top container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flip top container with the flip tops shown in an open position and the broken line portions forming no part of the claim;
FIG. 2 is a perspective view with the flip tops shown in a closed position;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

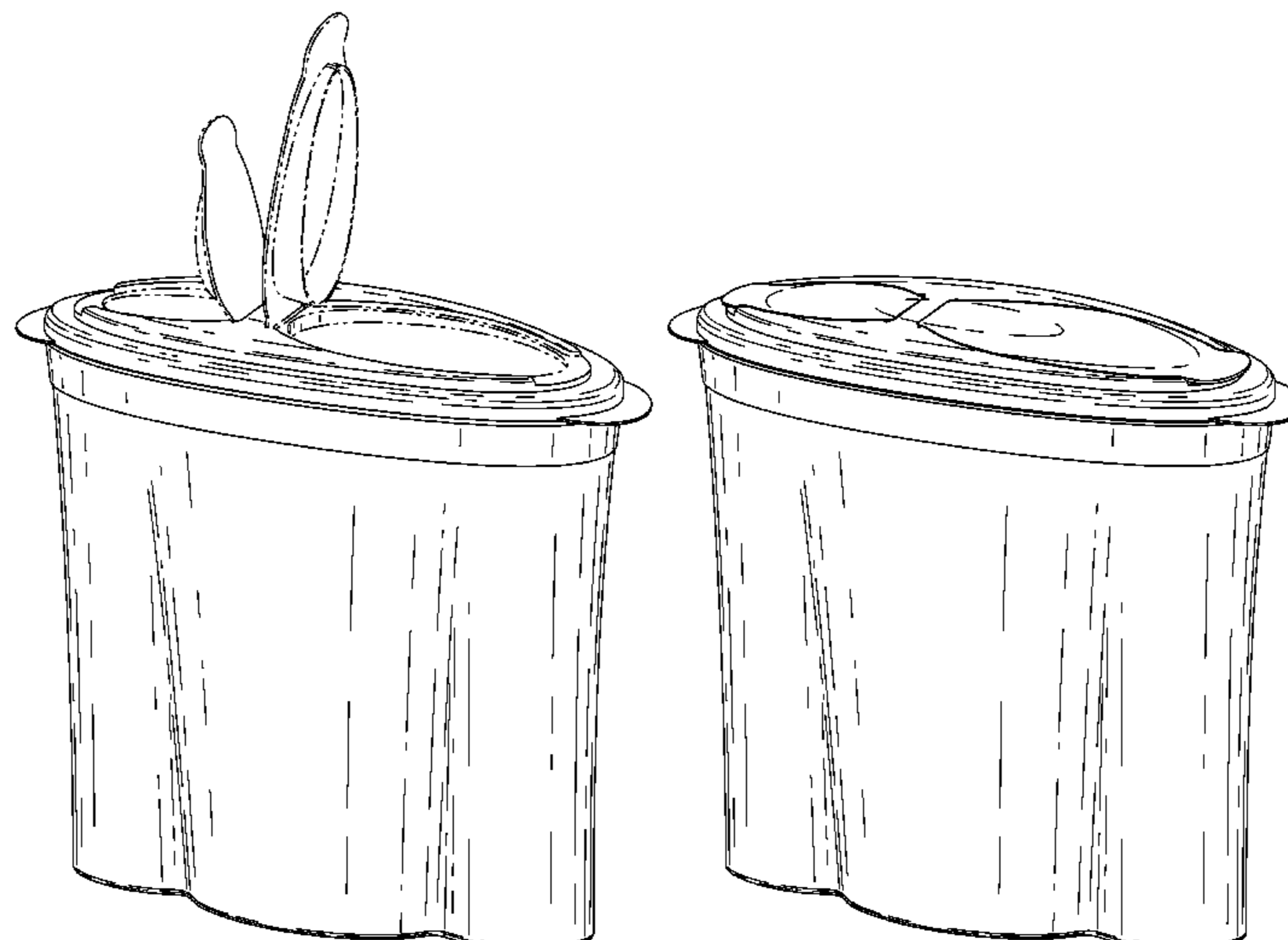

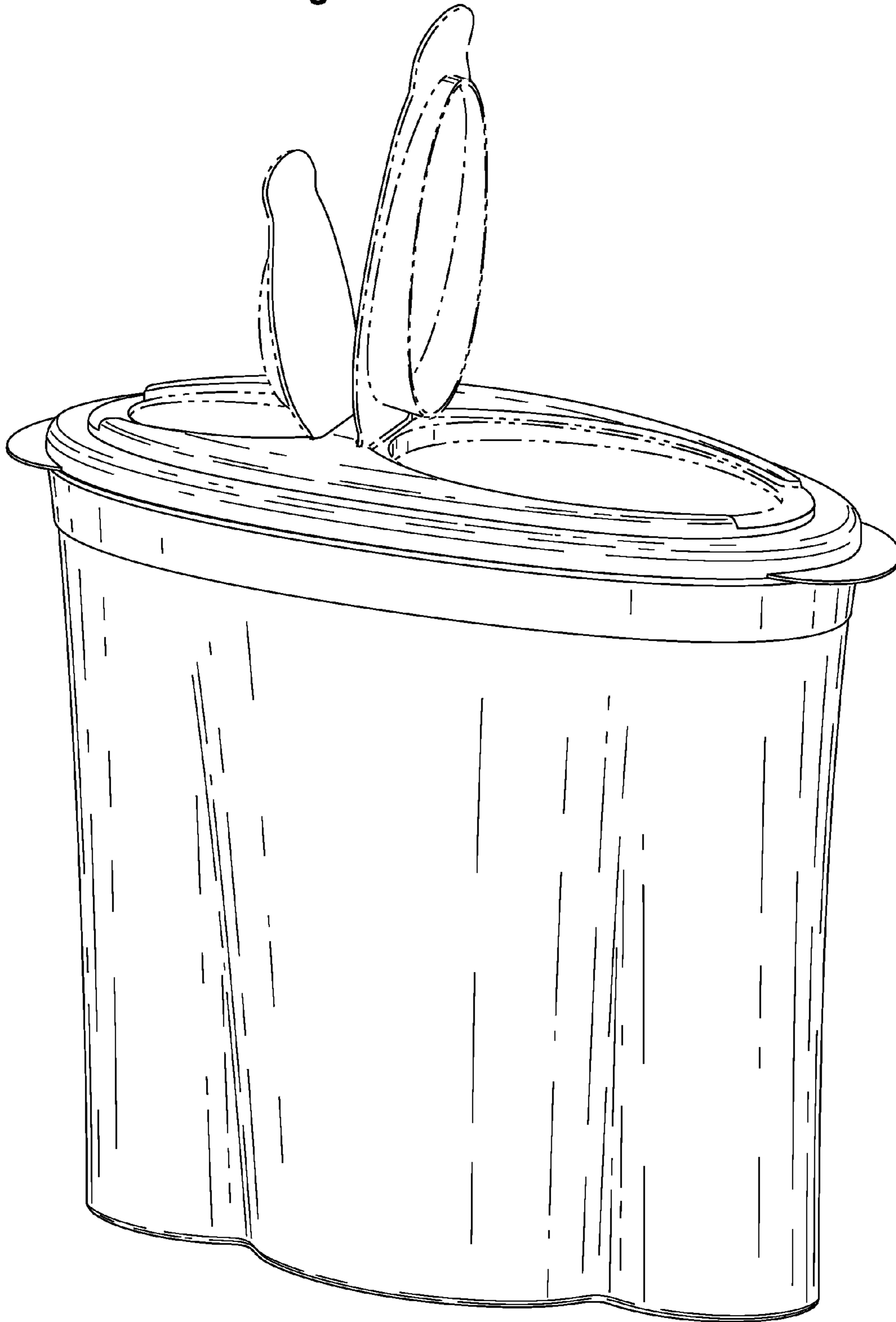

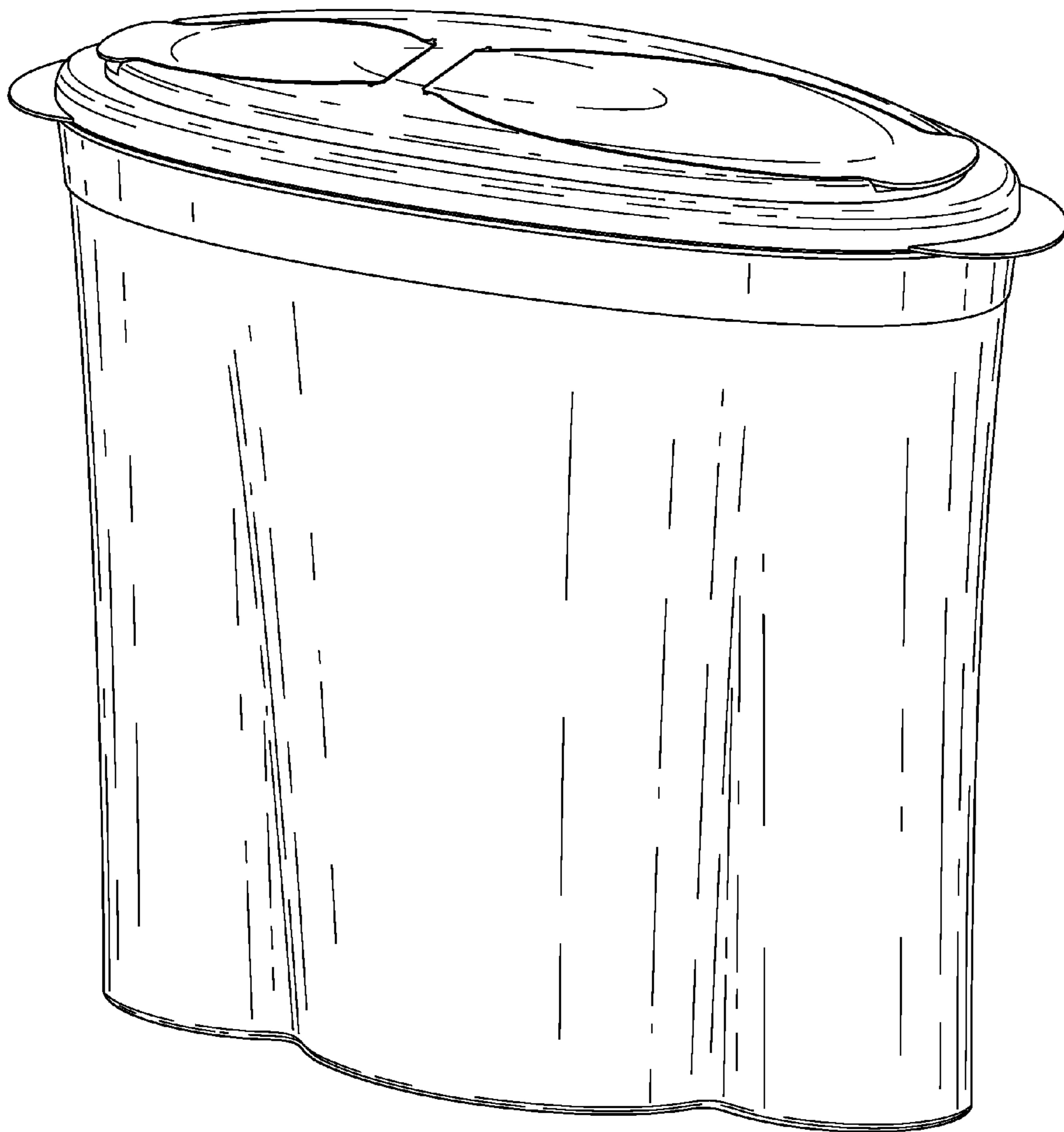

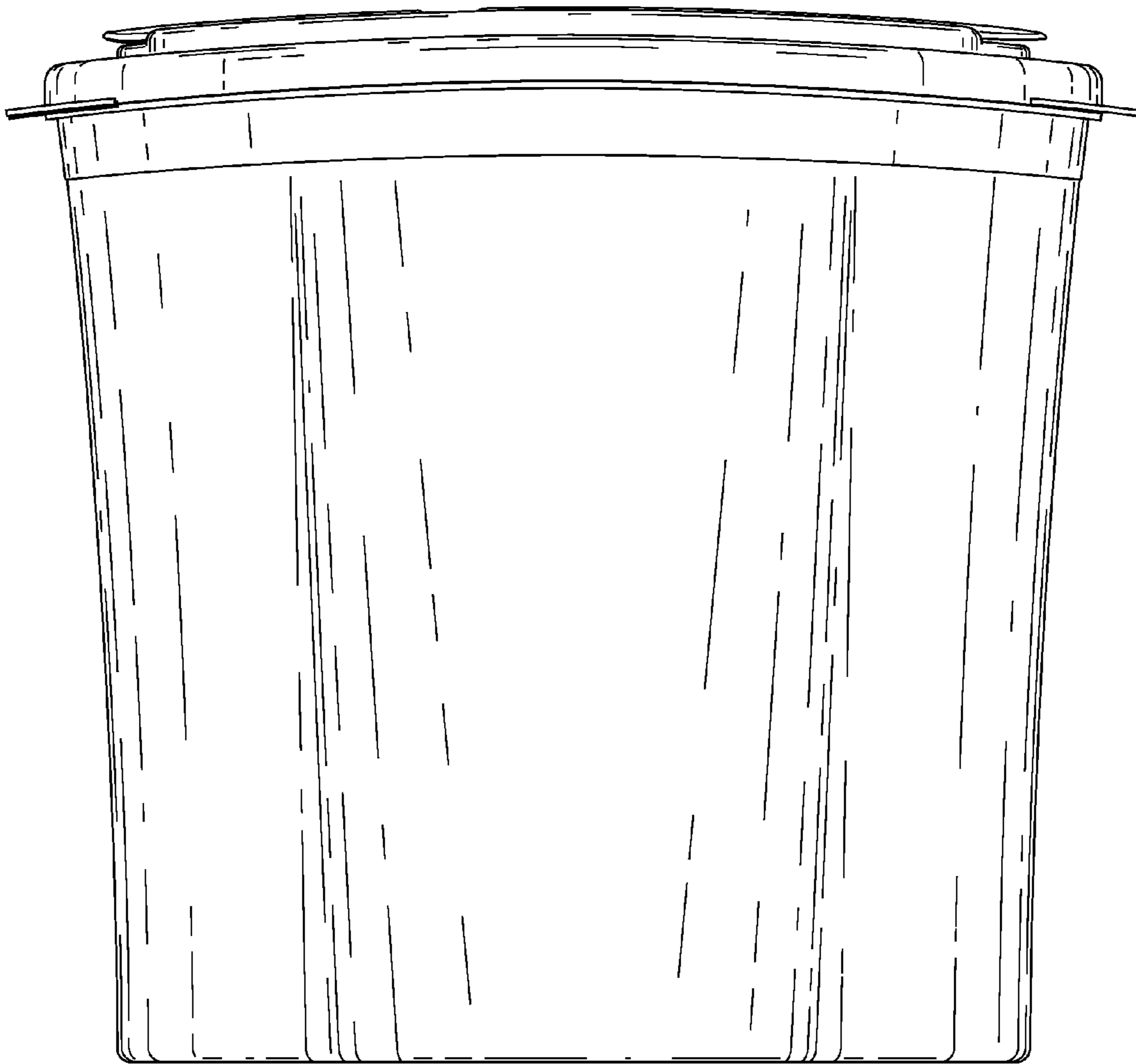

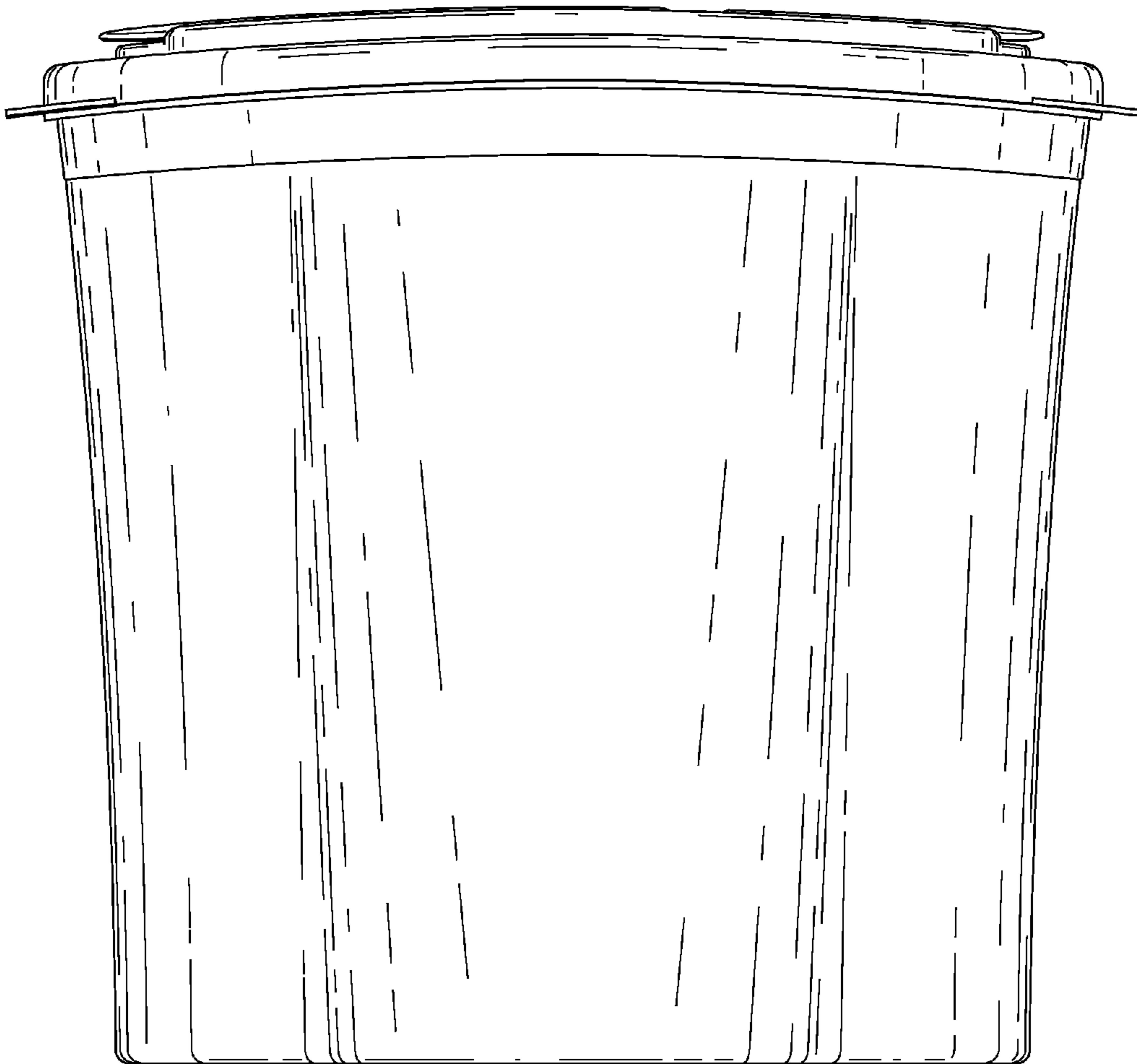

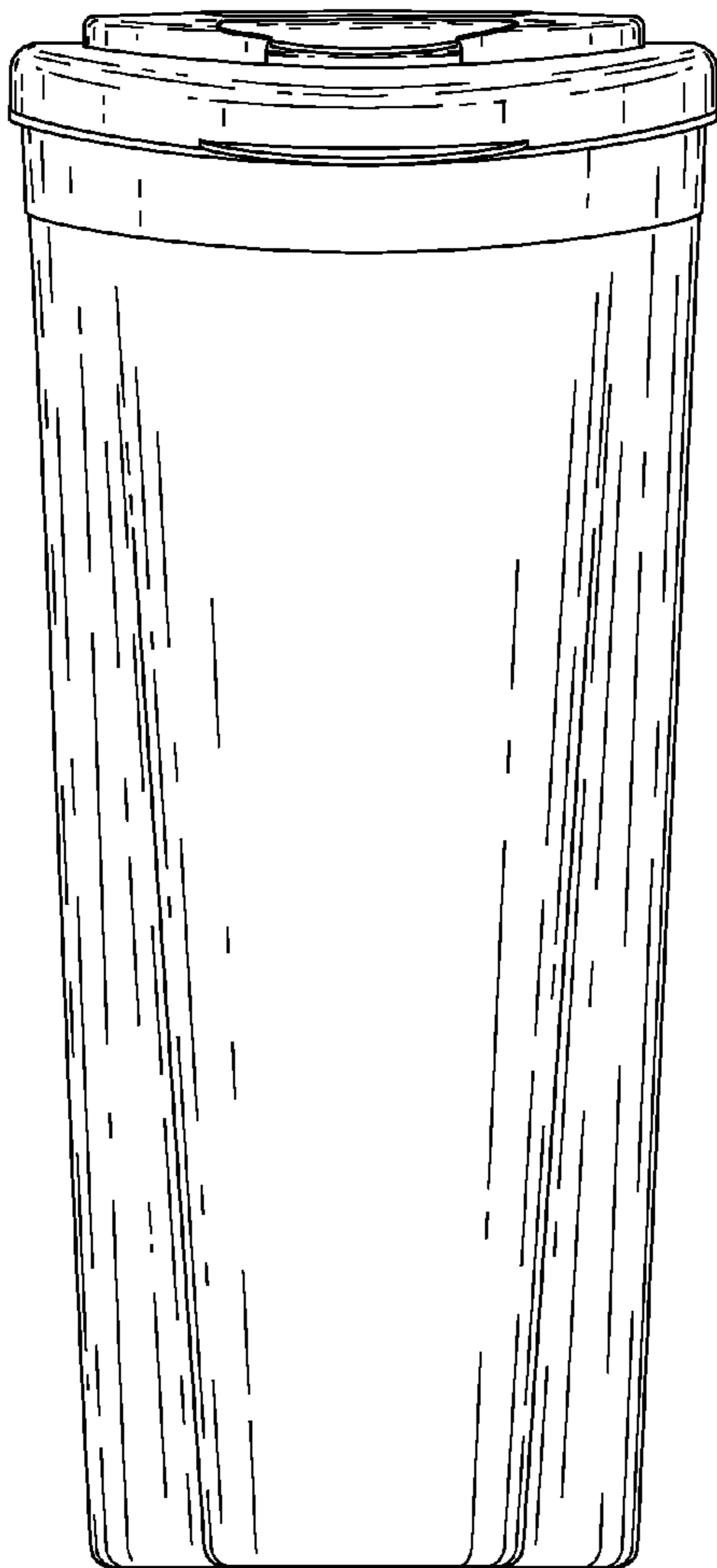

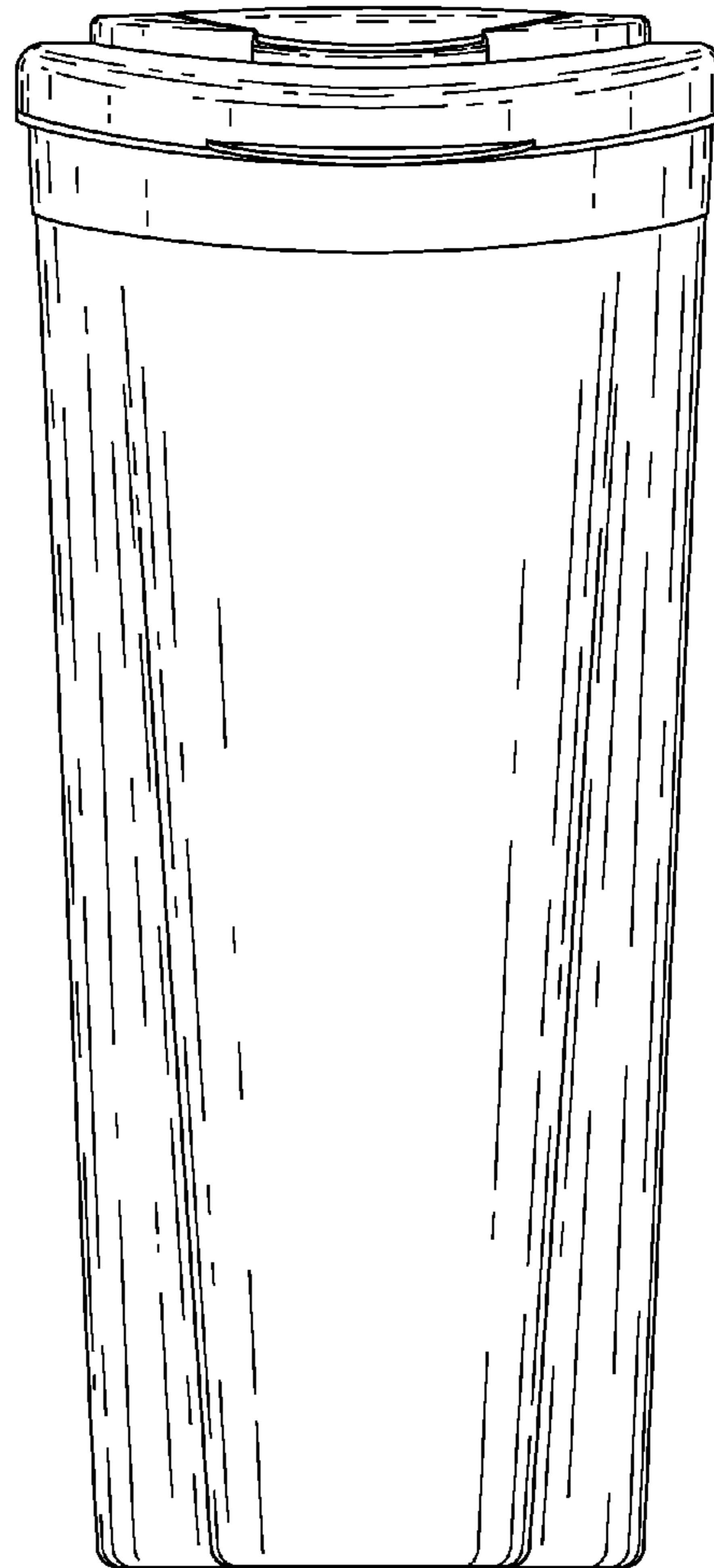

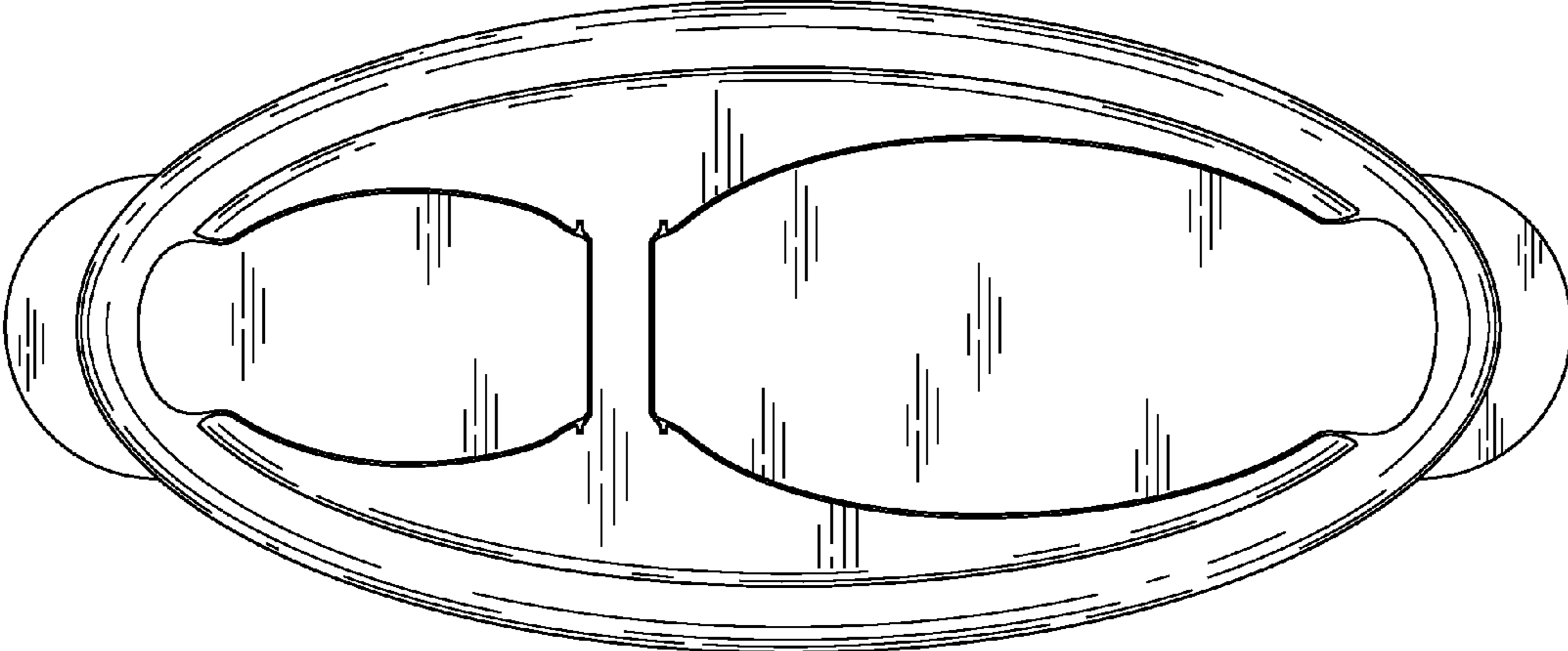
