I claim the ornamental design for a T-handle assembly, as shown and described.

DESCRIPTION

T-Handle (U.S. Design patent application Ser. No. 29/356, 302)

Latch Housing (U.S. Design patent application Ser. No. 29/356,301)

FIG. 1 is a top plan view of the T-handle assembly showing my new ornamental design:

FIG. 2 is a left front perspective view;

FIG. 3 is a bottom perspective view;

FIG. 4 is a left side elevational view;

FIG. 5 is a rear elevational view; and,

FIG. 6 is a left front elevational view, the right side elevational view being the same.

Those features depicted with dashed lines do not form a part of the disclosed design.

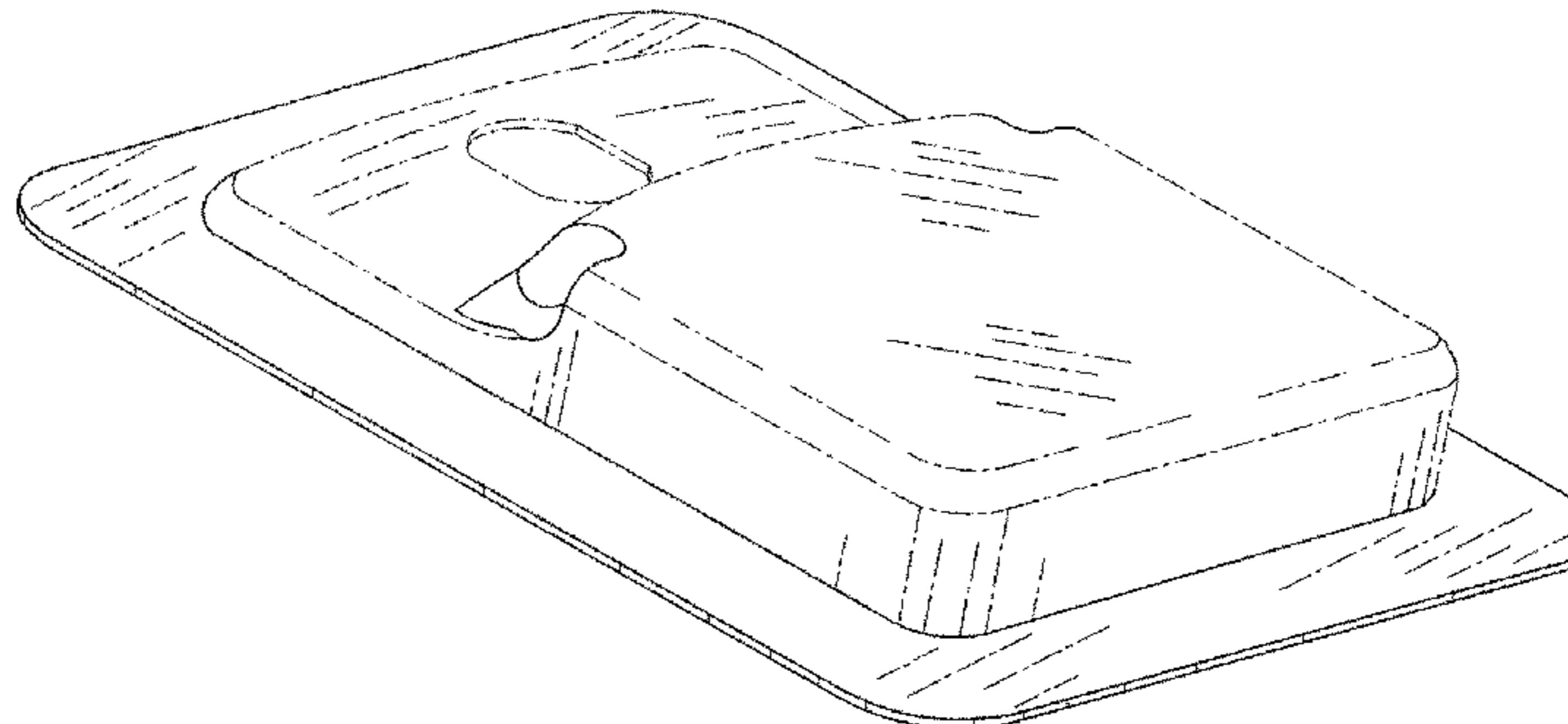
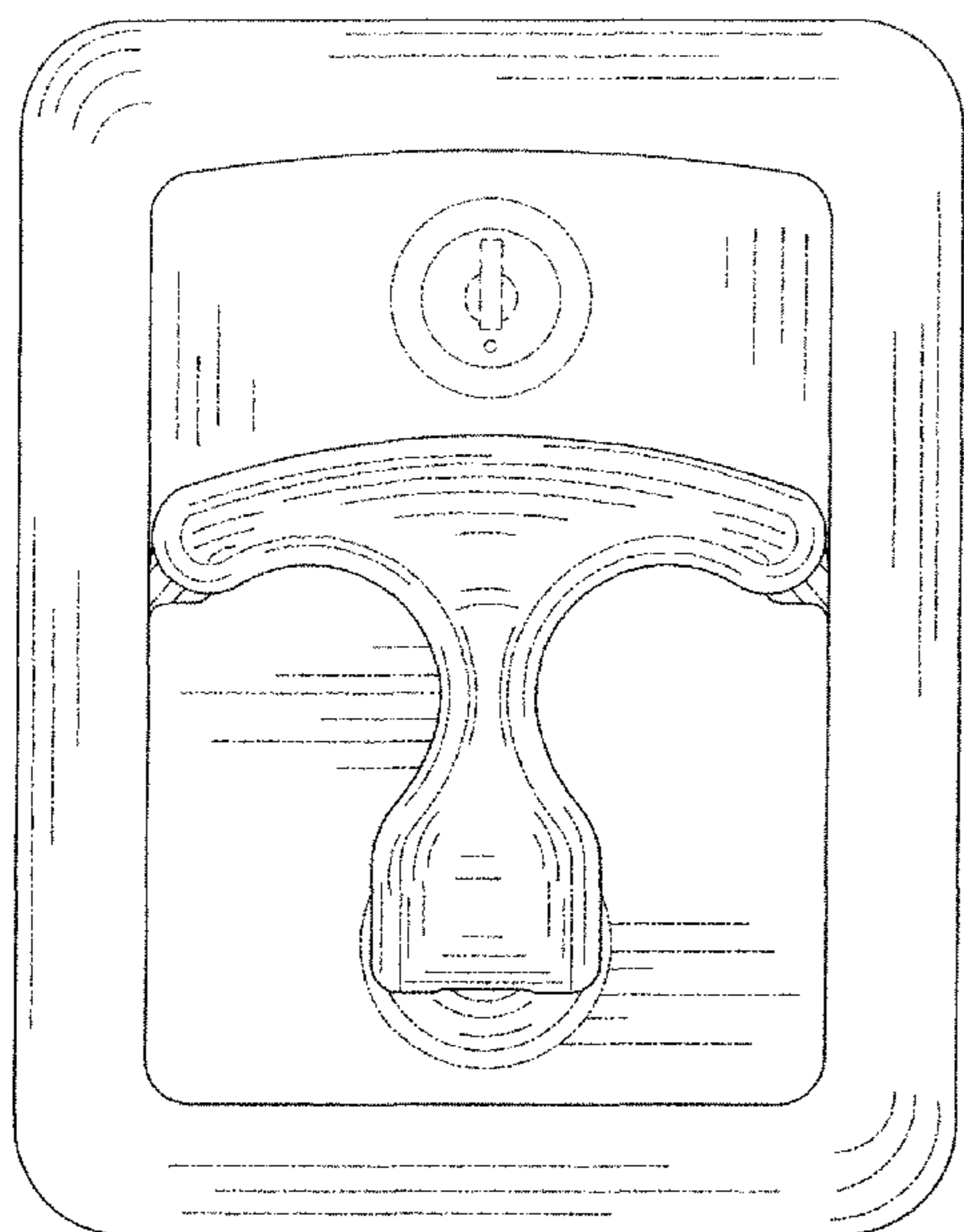

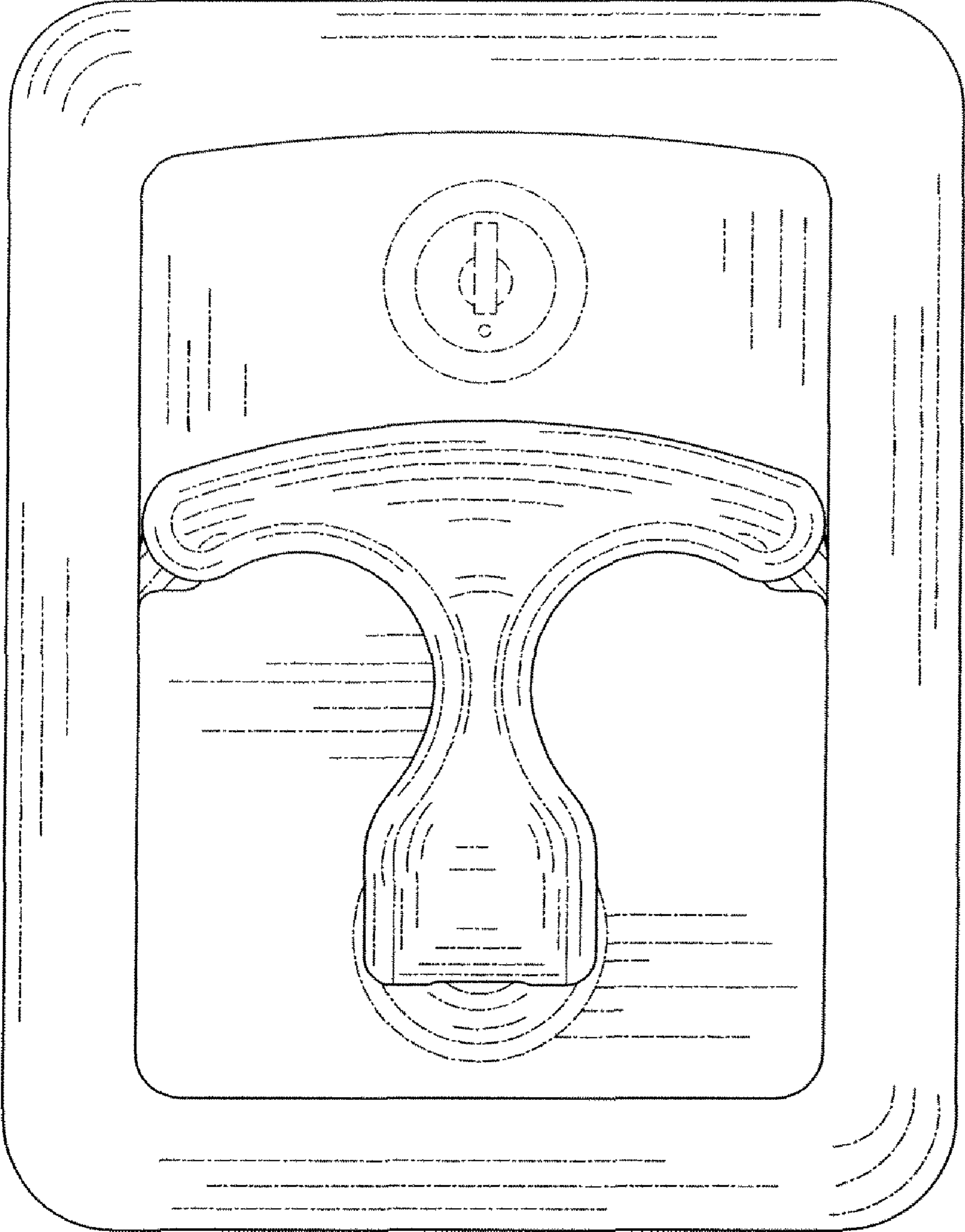

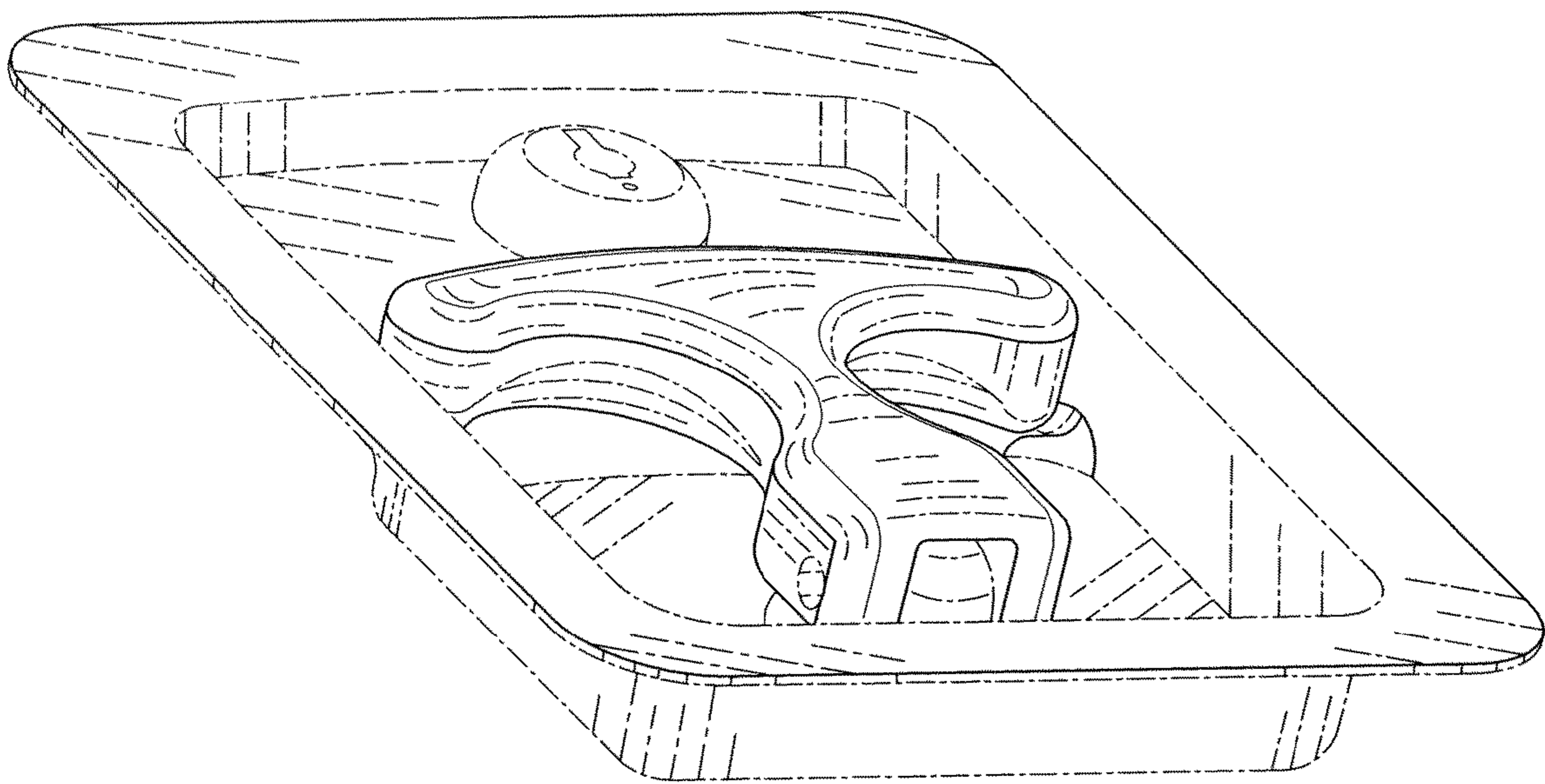

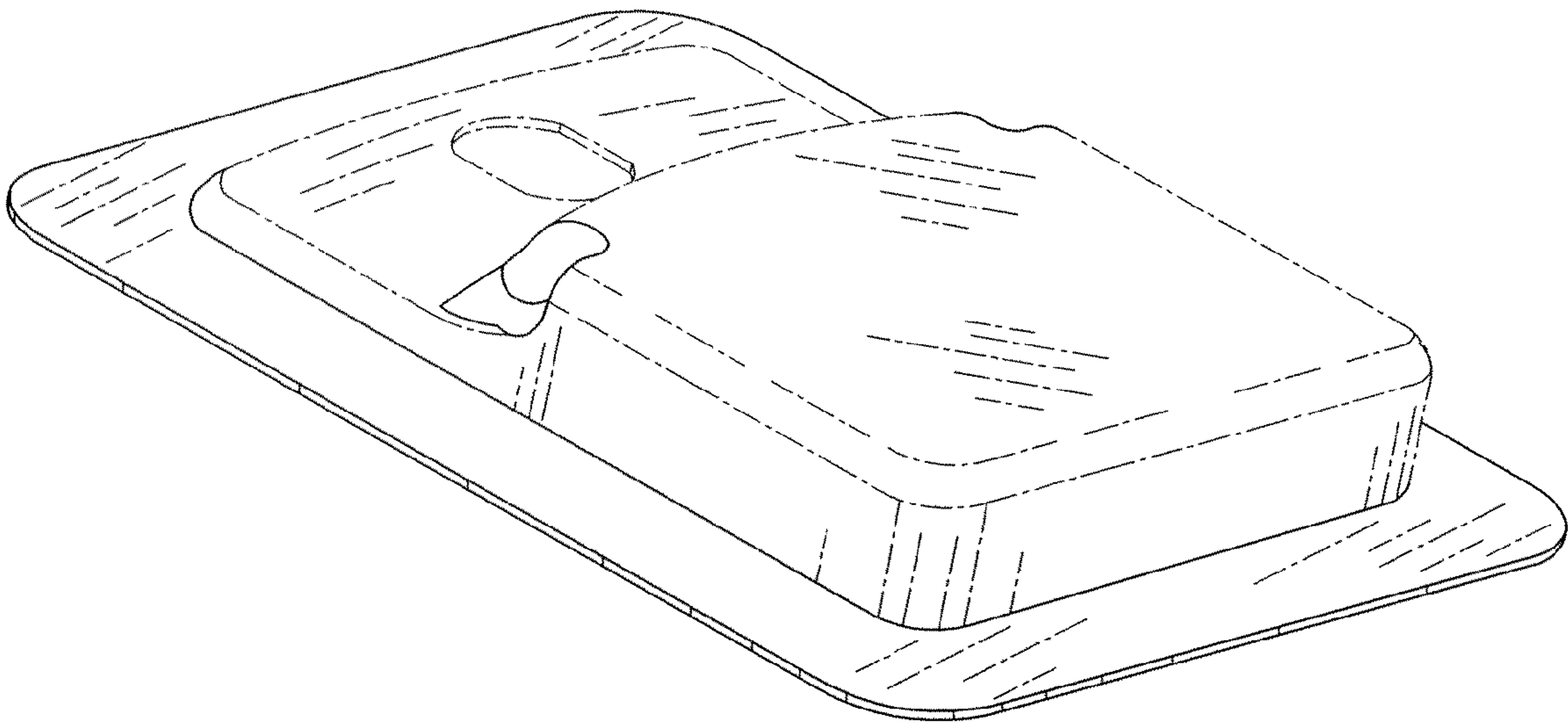

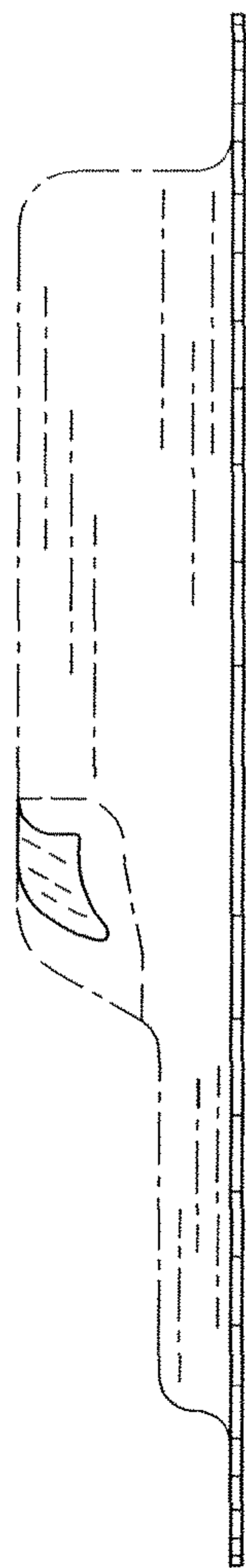

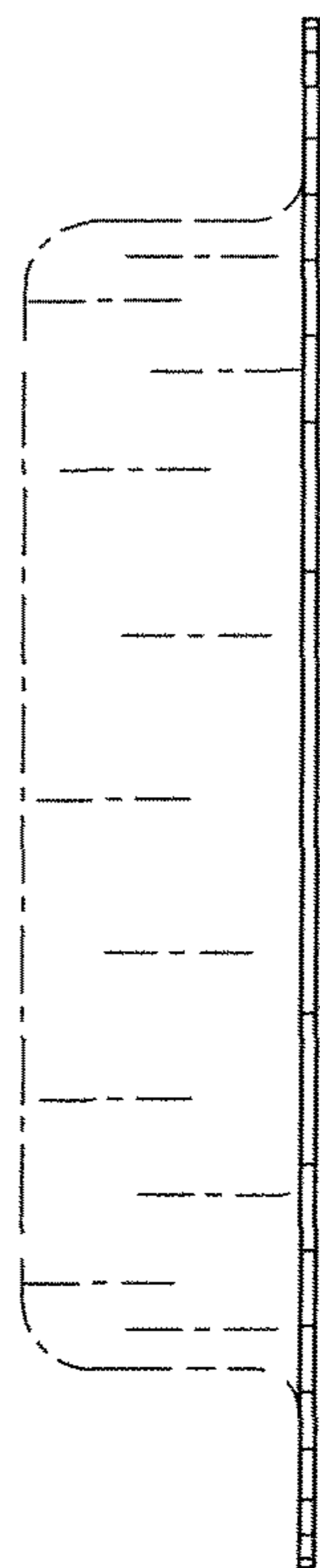
