The ornamental design for a carton for stain treatment implements, as shown and described.

**DESCRIPTION**

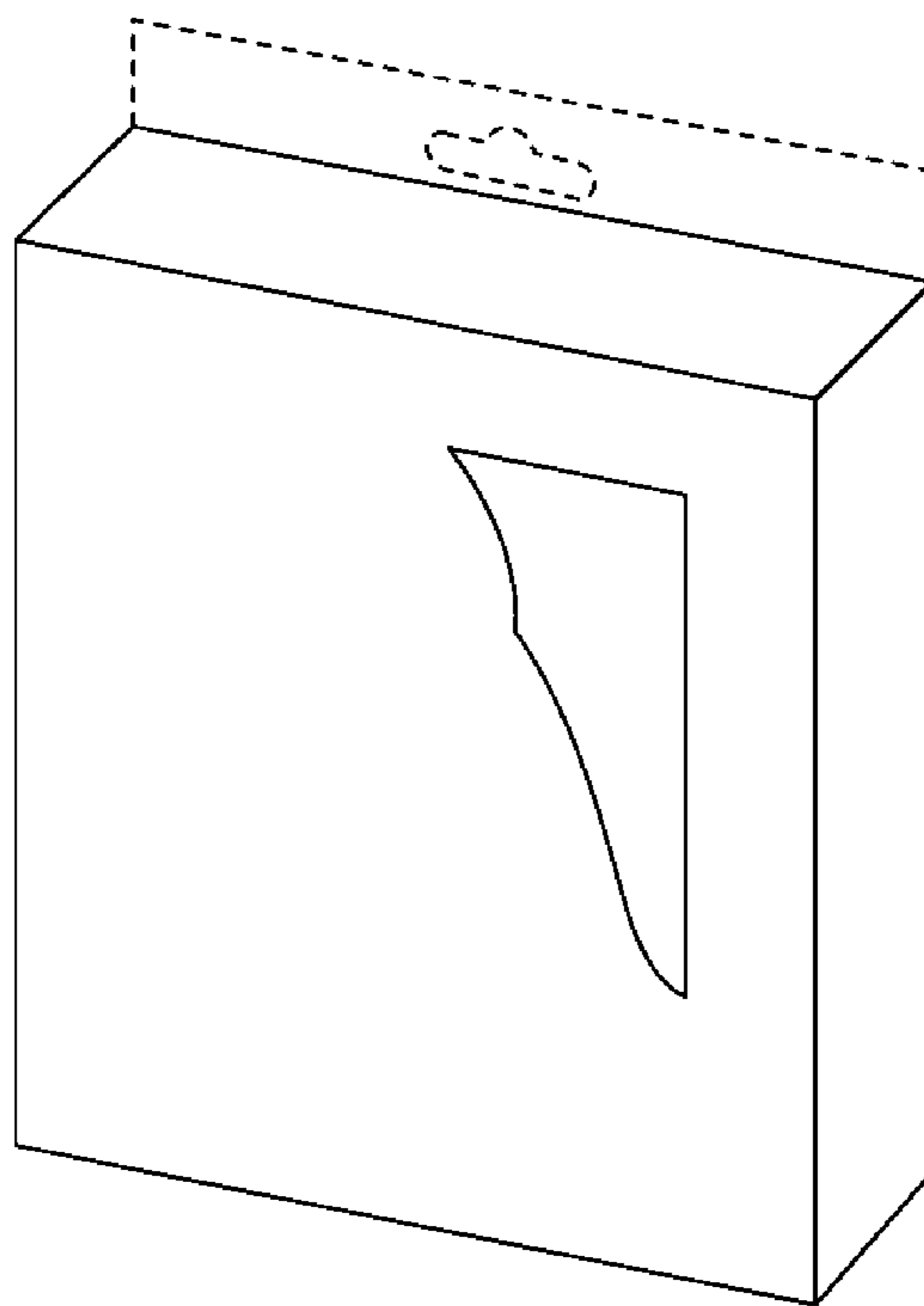
FIG. 1 is a perspective view of a carton for stain treatment implements showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a side elevation view thereof; FIG. 5 is a side elevation view thereof, being opposite the side view shown in FIG. 4;

FIG. 6 is top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

The broken line portion of the figures is included to show an unclaimed hanger panel tab and forms no part of the claimed design; and, the special dot-dash line in FIG. 3 shows the claim boundary which is, itself, no part of the claimed design.

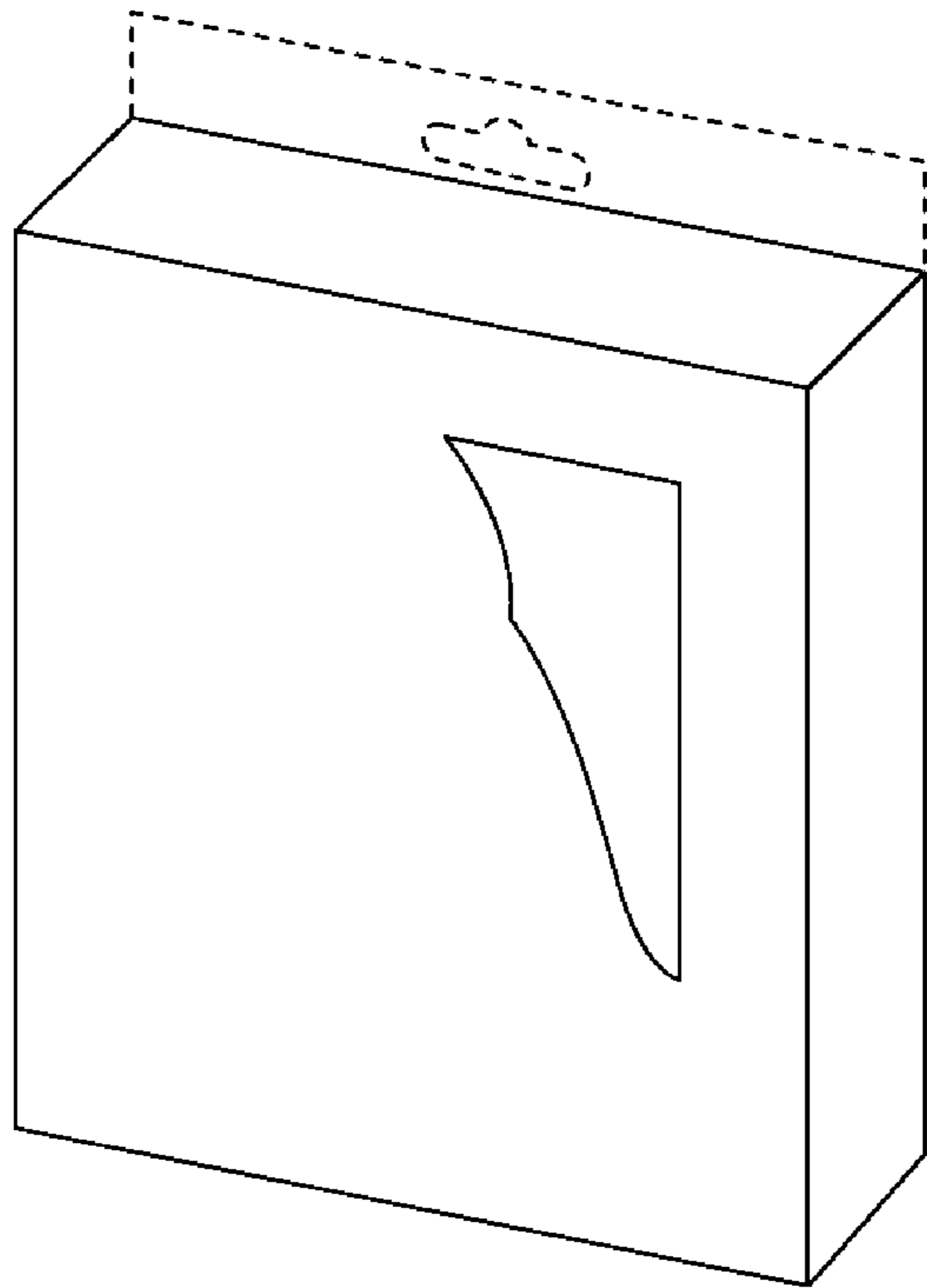

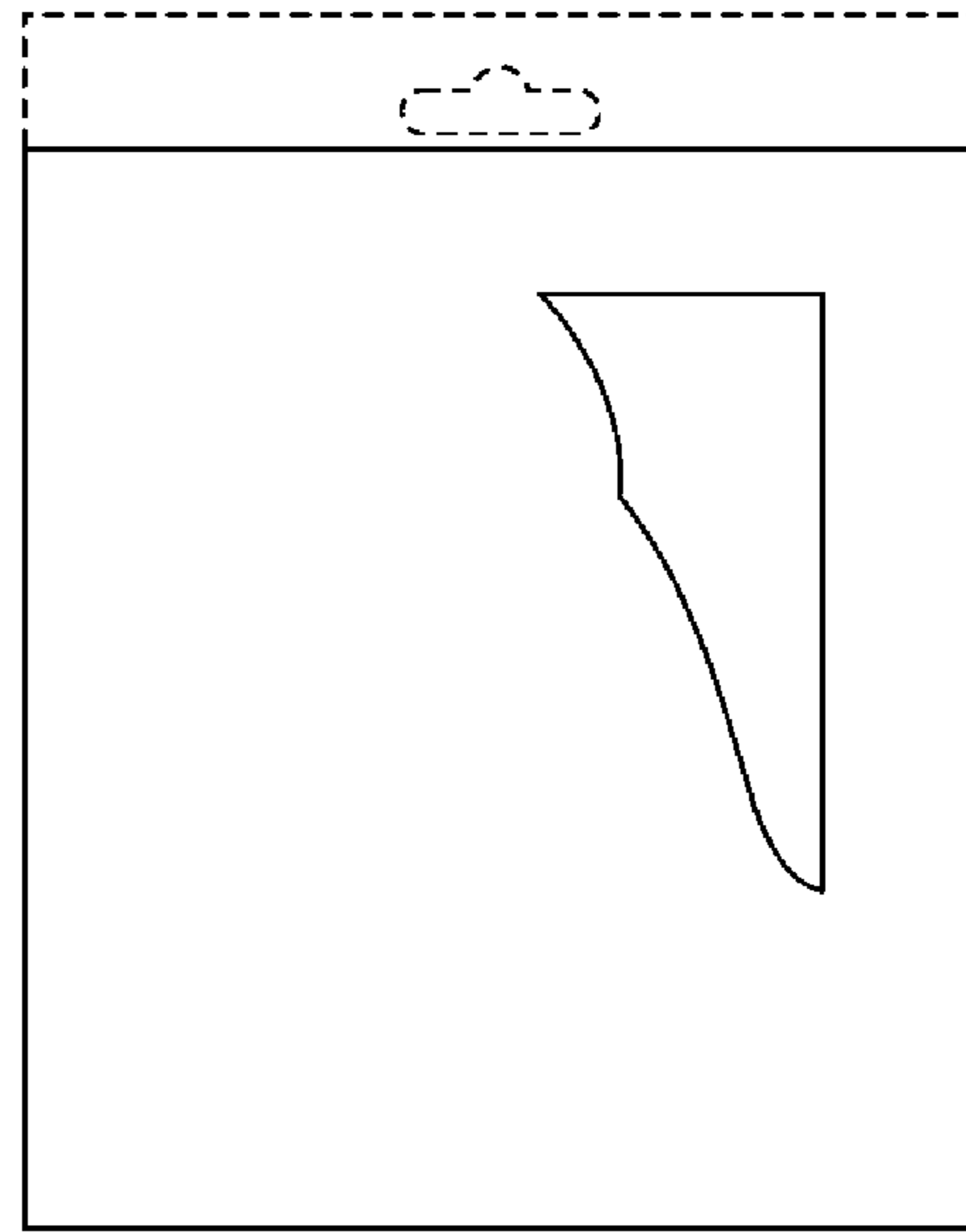

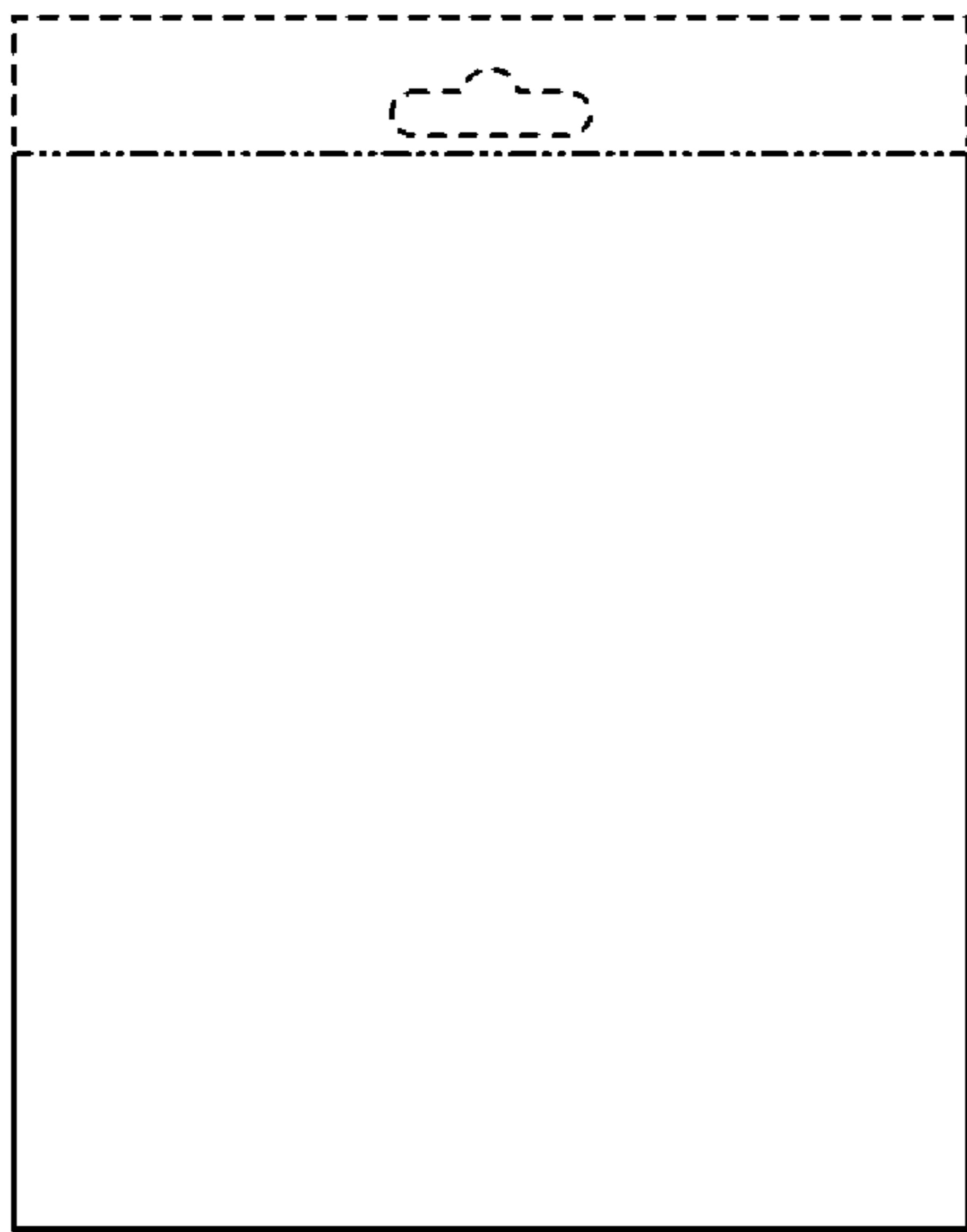

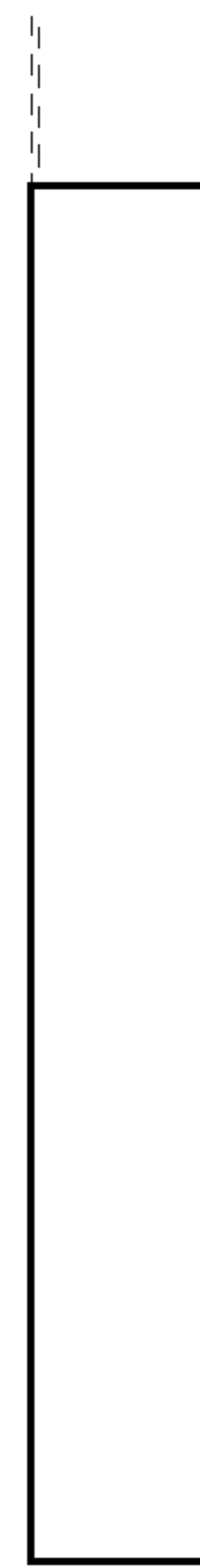

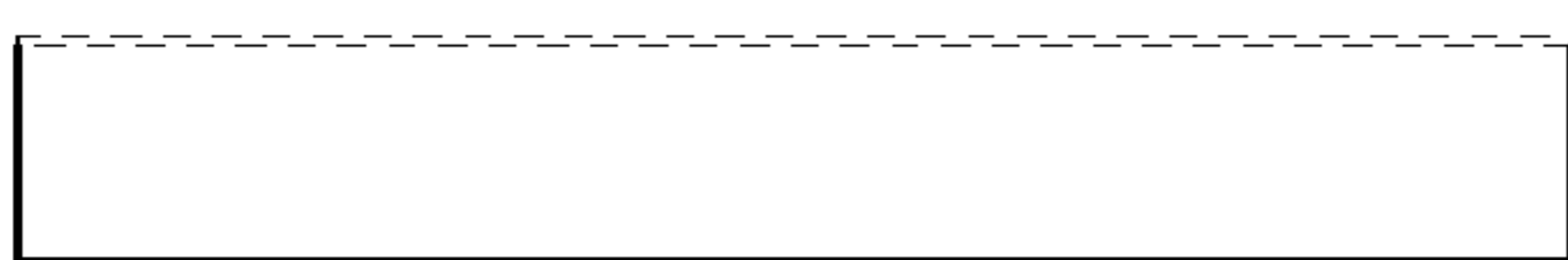
