(57) **CLAIM**

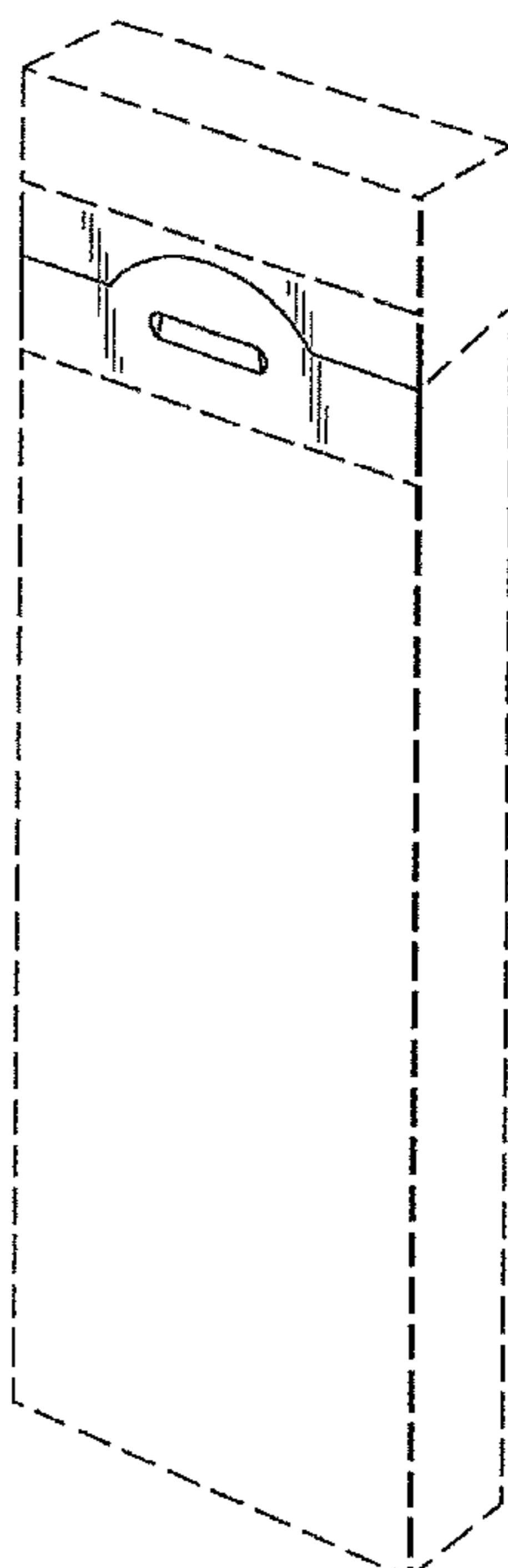
The ornamental design for a box for cubes, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from above and right side, of a box for cubes showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a back elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front perspective view thereof from above and right side, in an open position;
 FIG. 9 is a front view thereof in a re-closed position after being opened;
 FIG. 10 is a bottom plan view thereof in a re-closed position after being opened;
 FIG. 11 is a left side view thereof, in a re-closed position after being opened;
 FIG. 12 is a right side view thereof in a re-closed position after being opened; and,
 FIG. 13 is a plan view thereof.

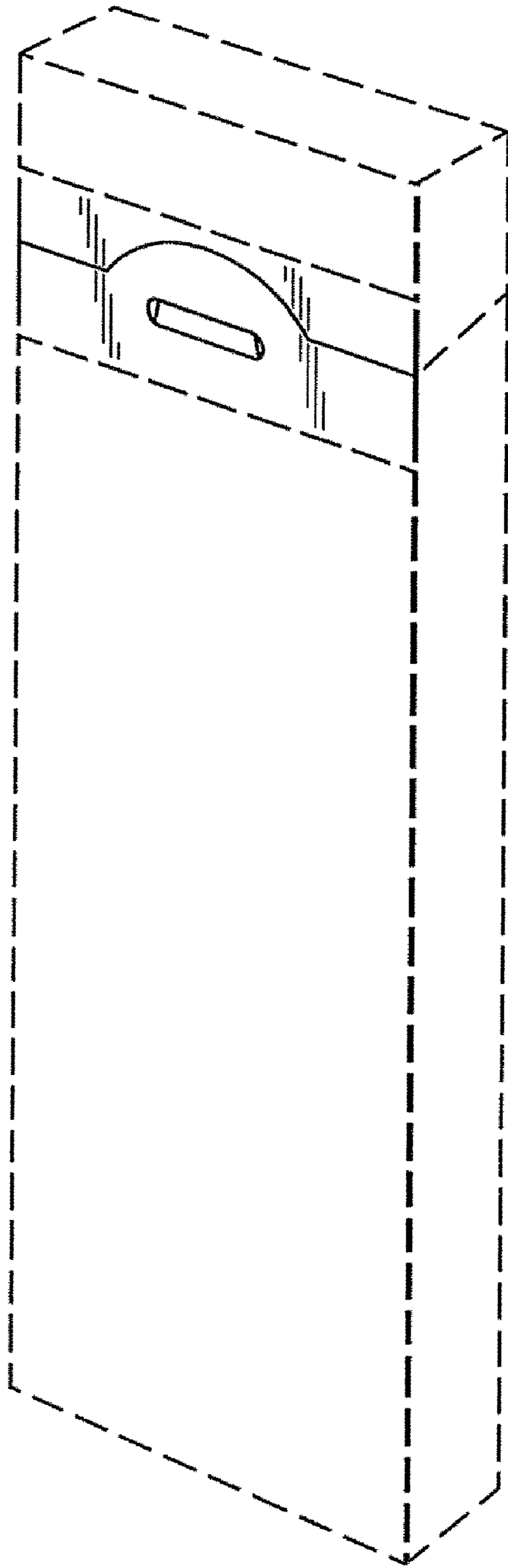

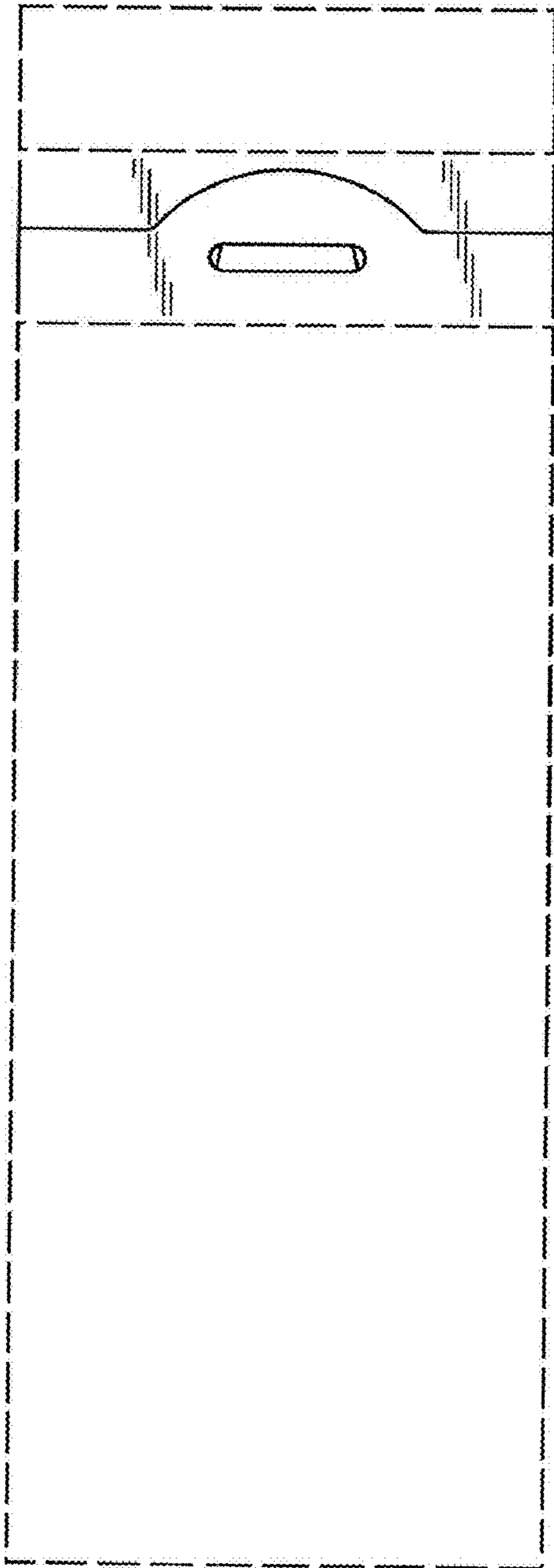

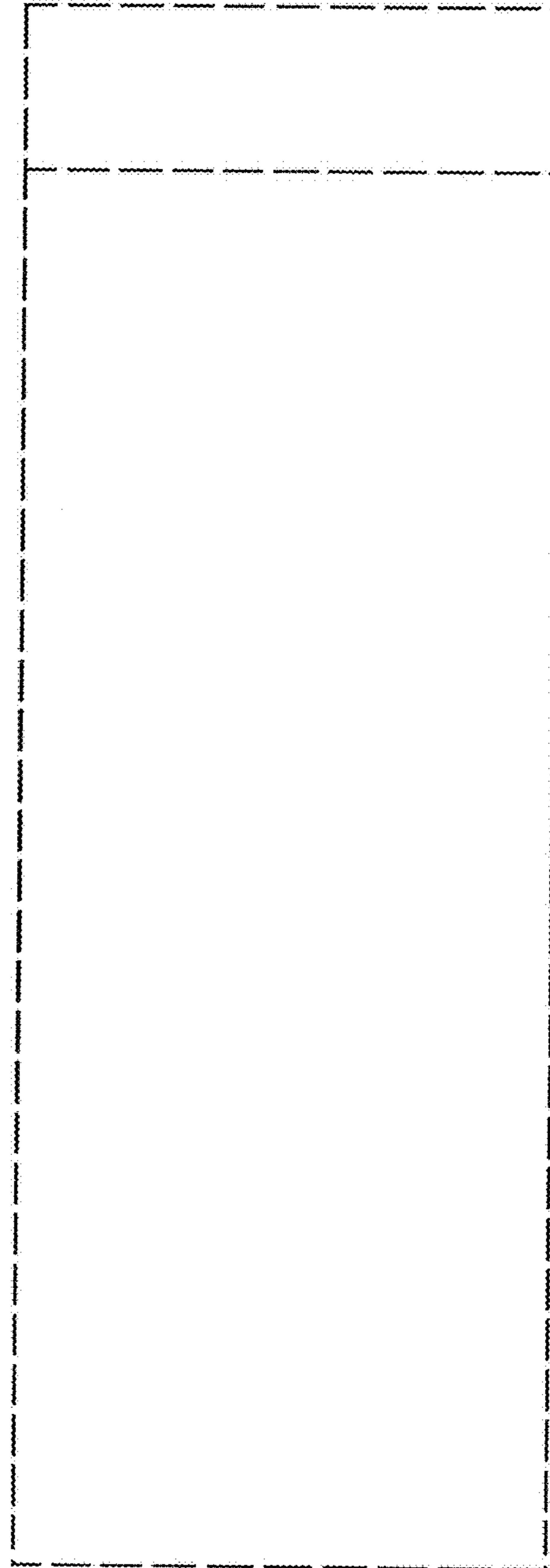

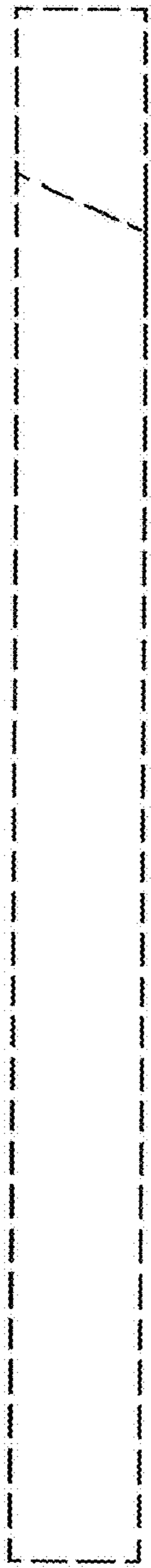

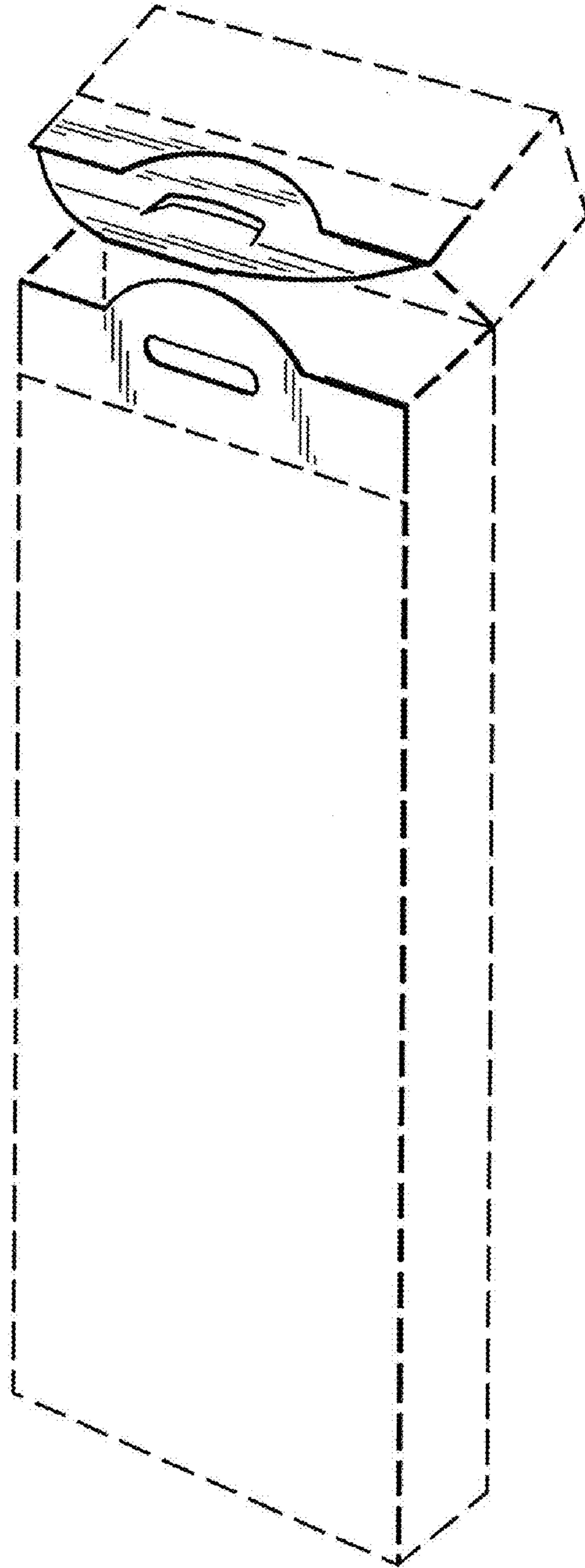

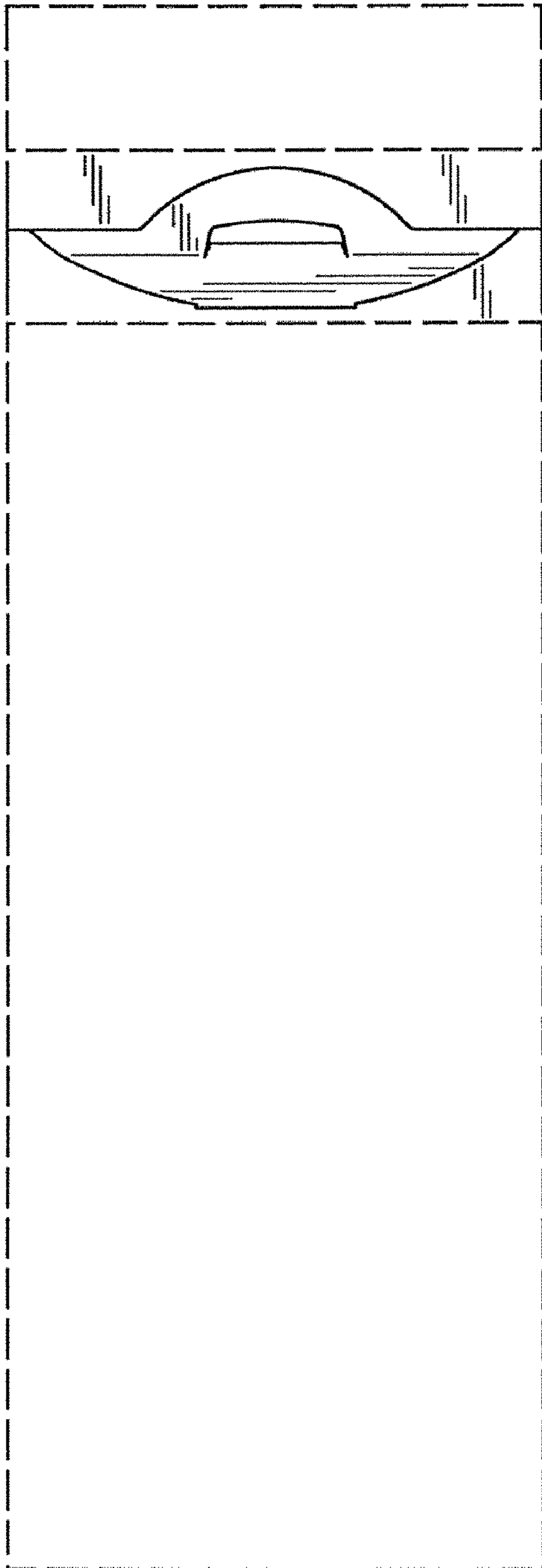

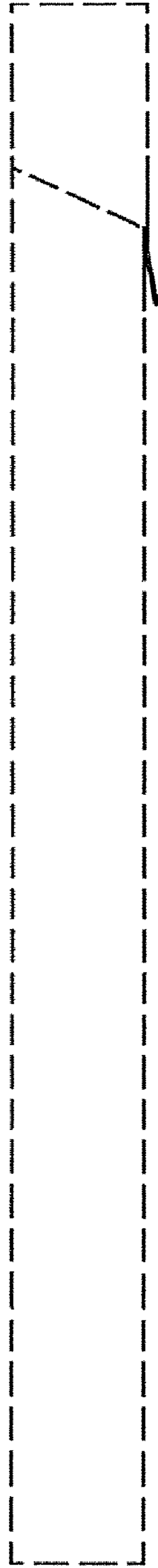

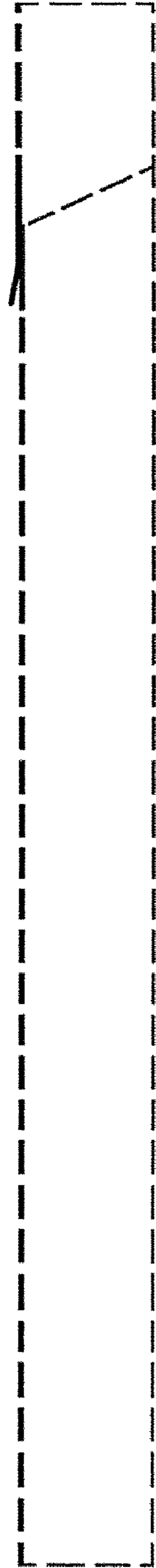

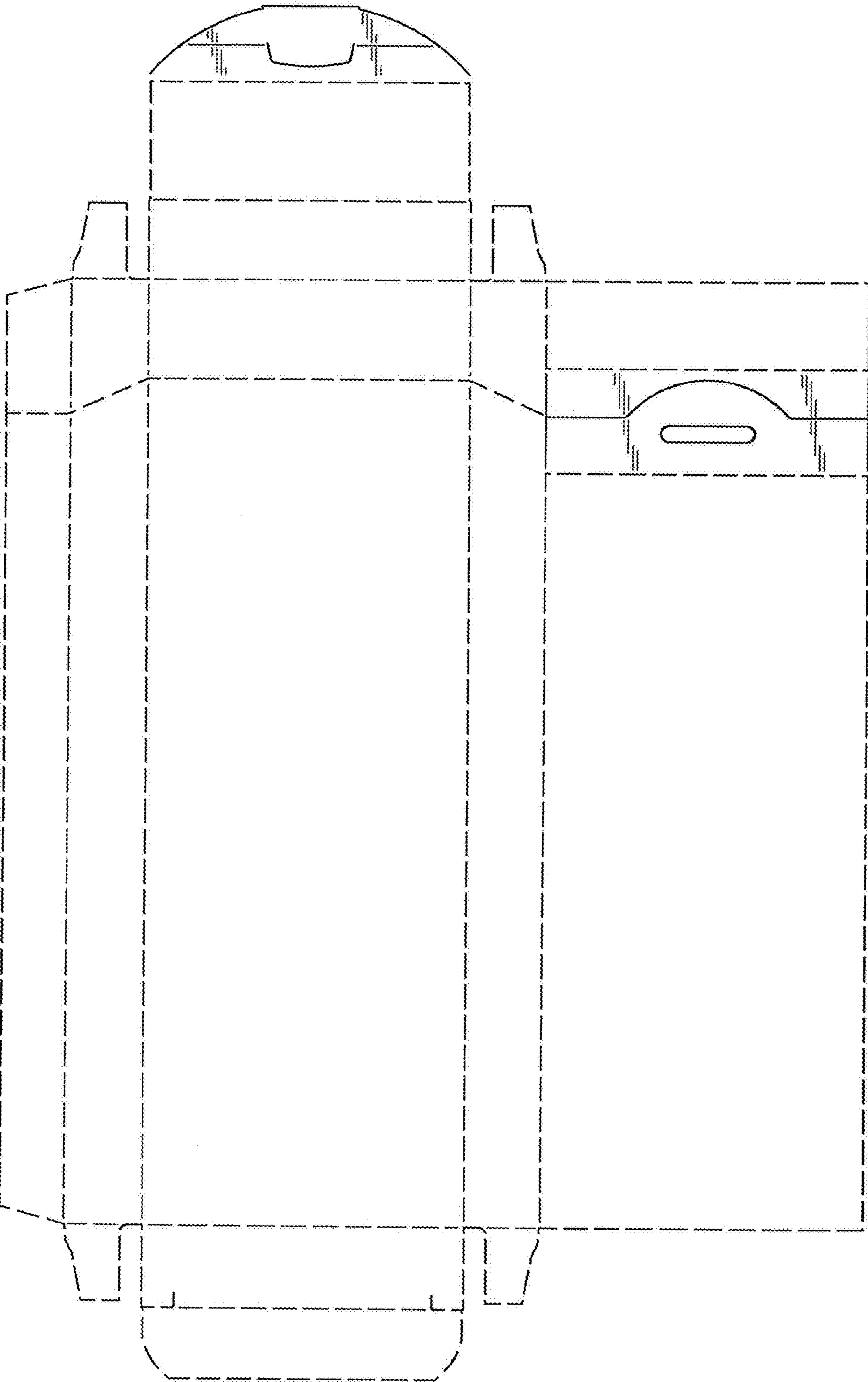
