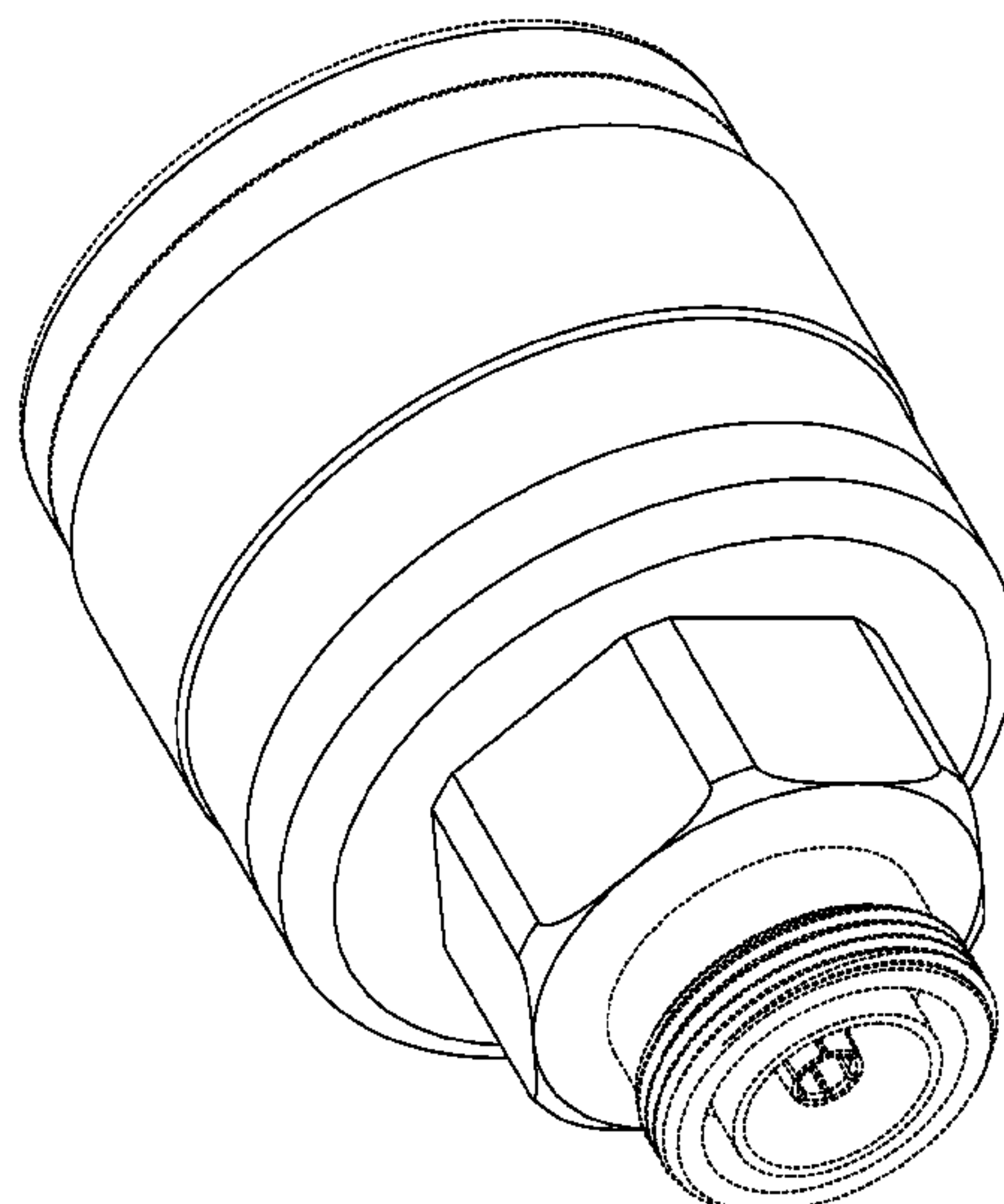
(57) **CLAIM**

The ornamental design for a closed compression-type coaxial cable connector, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the present invention showing our design for a closed compression-type coaxial cable connector;
FIG. 2 is a back perspective view thereof;
FIG. 3 is a top view thereof, the claimed portion of which is a mirror image to a bottom view;
FIG. 4 is a right side view thereof, the claimed portion of which is a mirror image to a left side view;
FIG. 5 is a front view thereof;
FIG. 6 is a back view thereof; and,
FIG. 7 is a front perspective view thereof, in use condition.
The broken line portion of the figure drawings is included for the purpose of illustrating environment and forms no part of the claimed design.

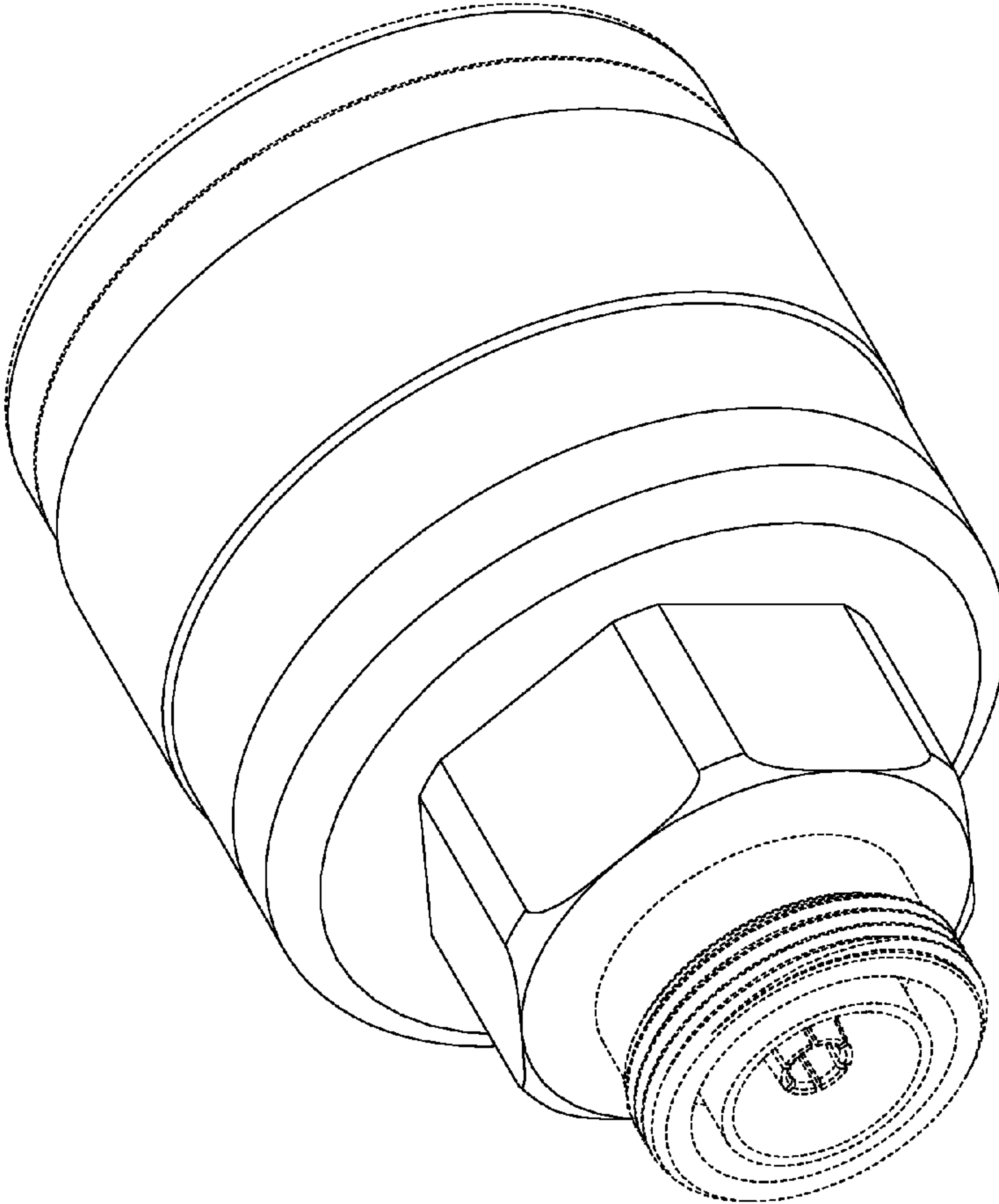

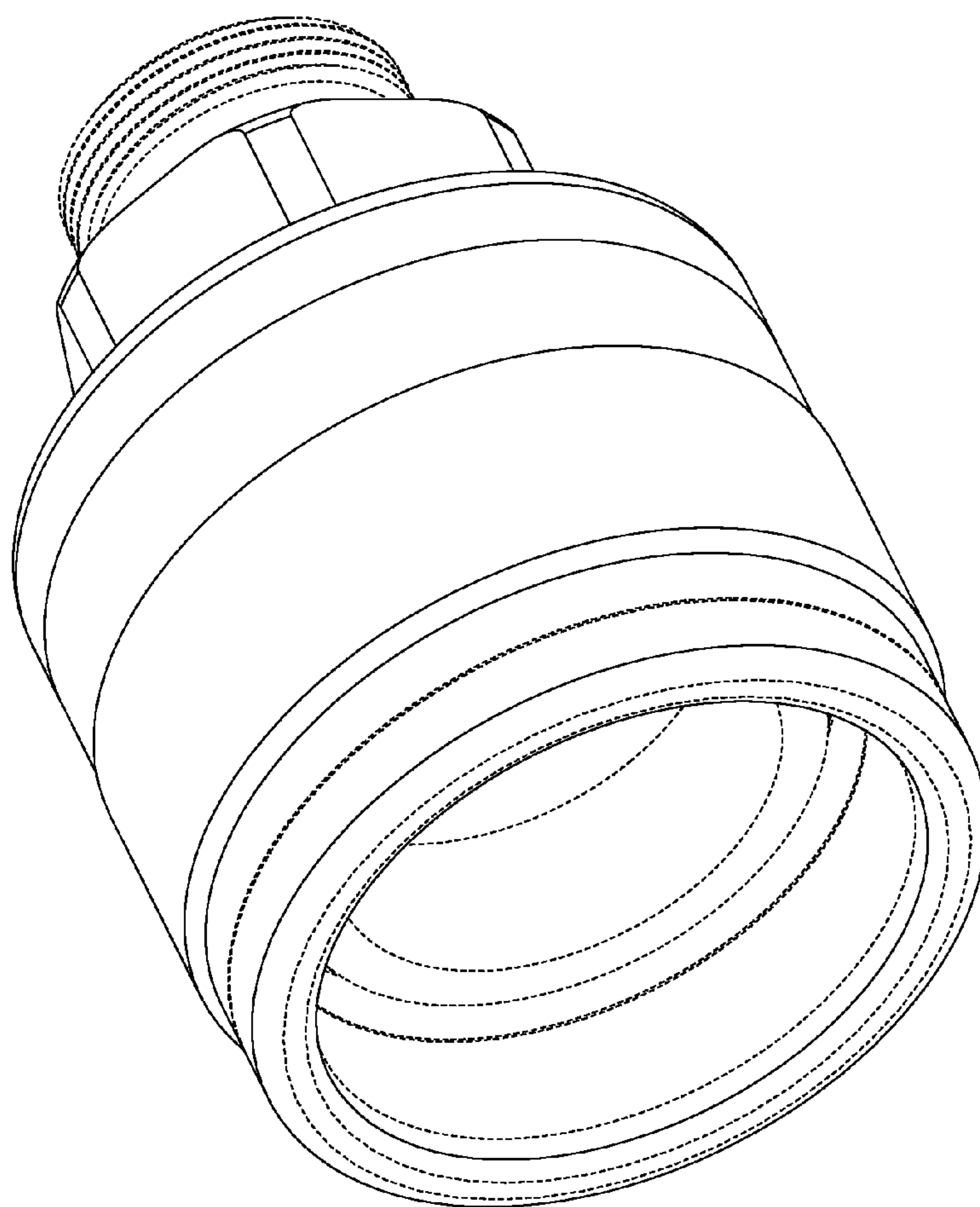

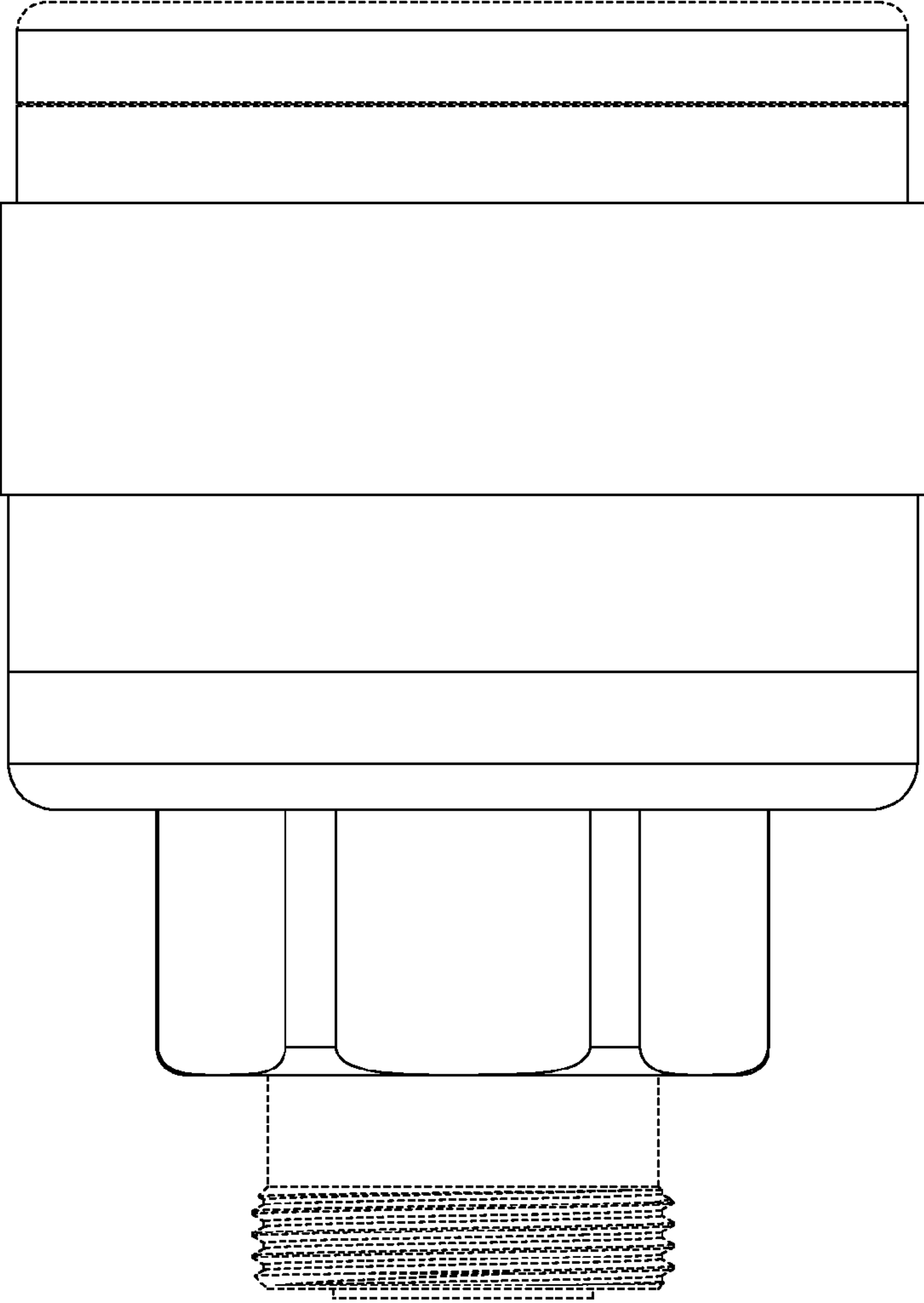

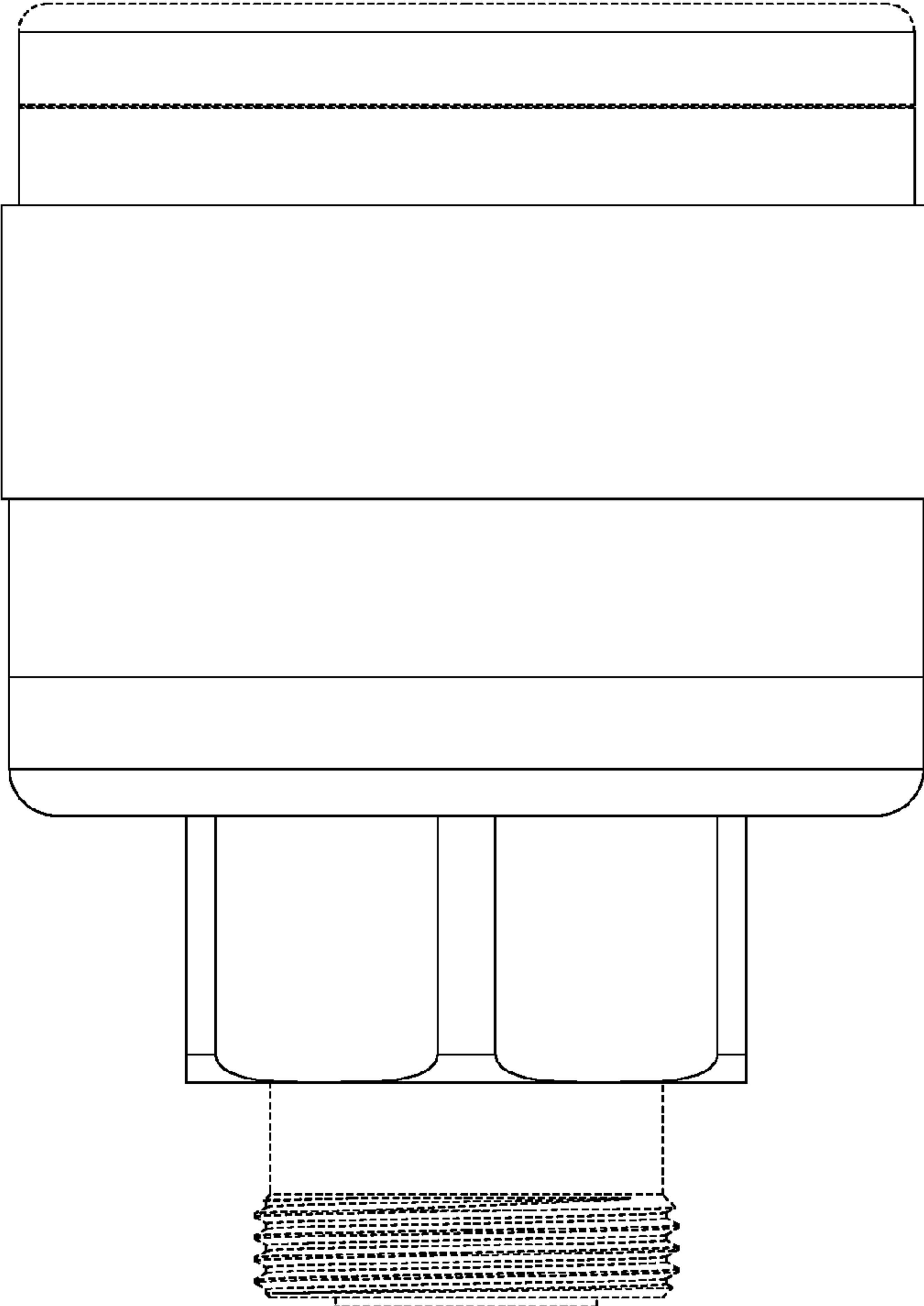

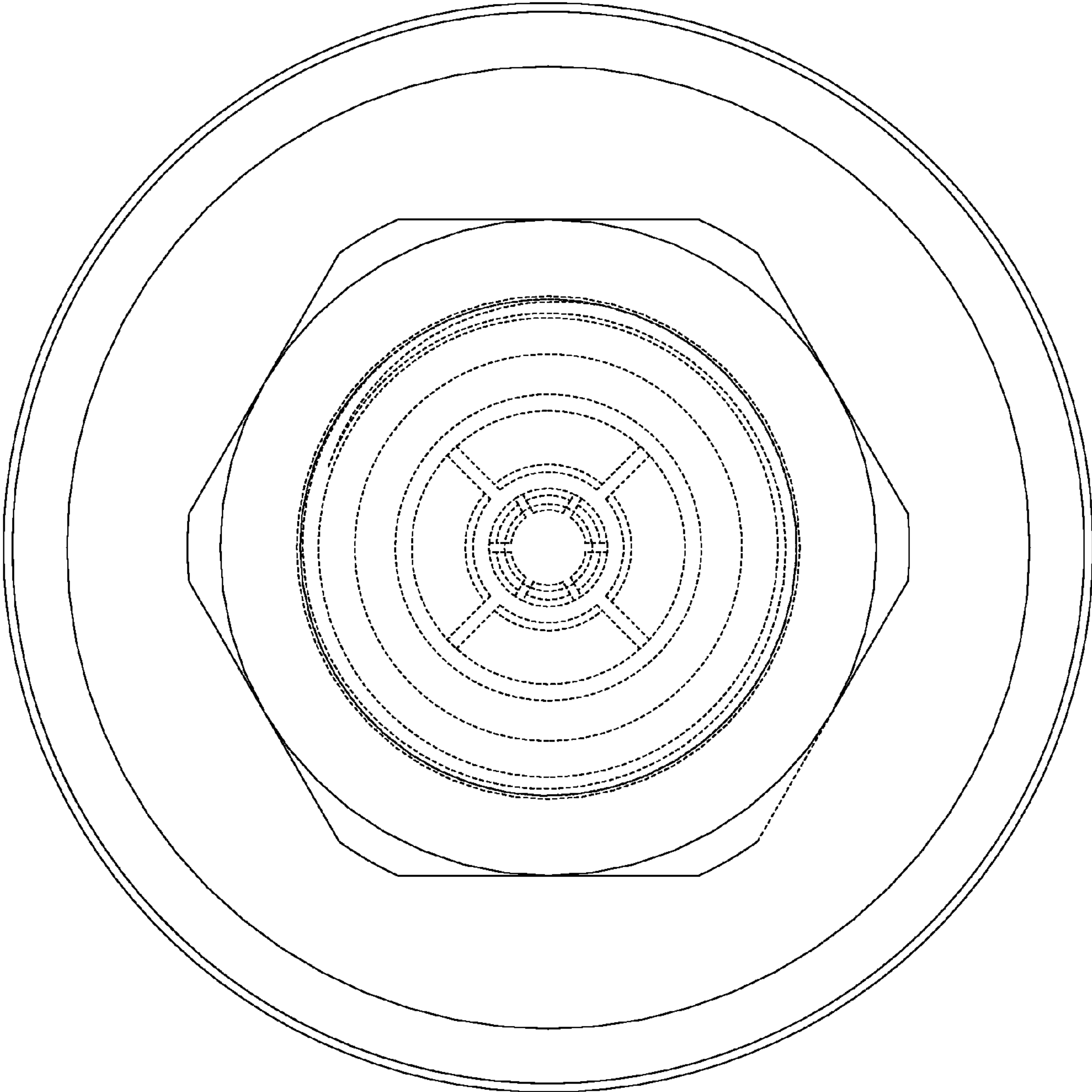

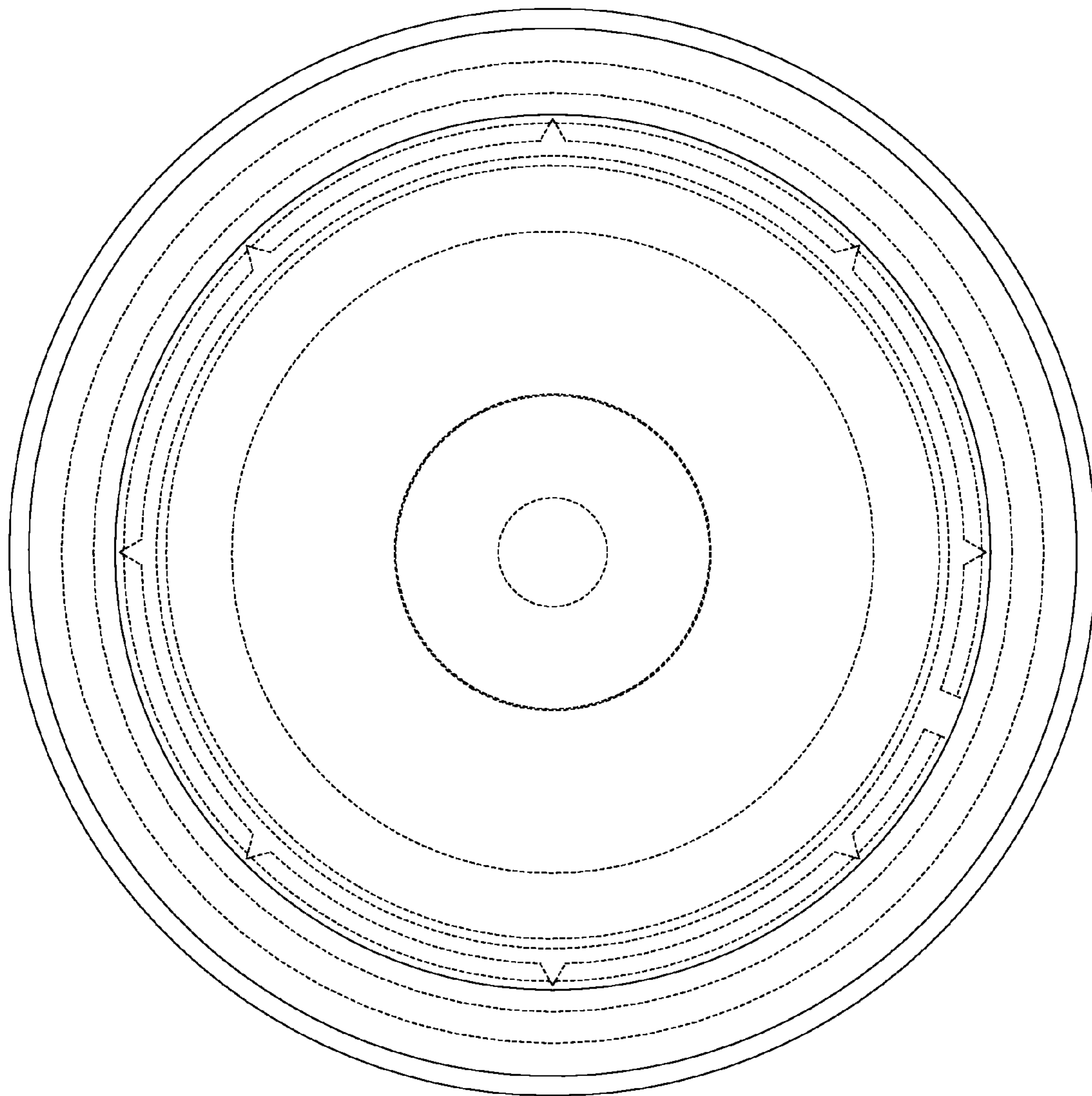

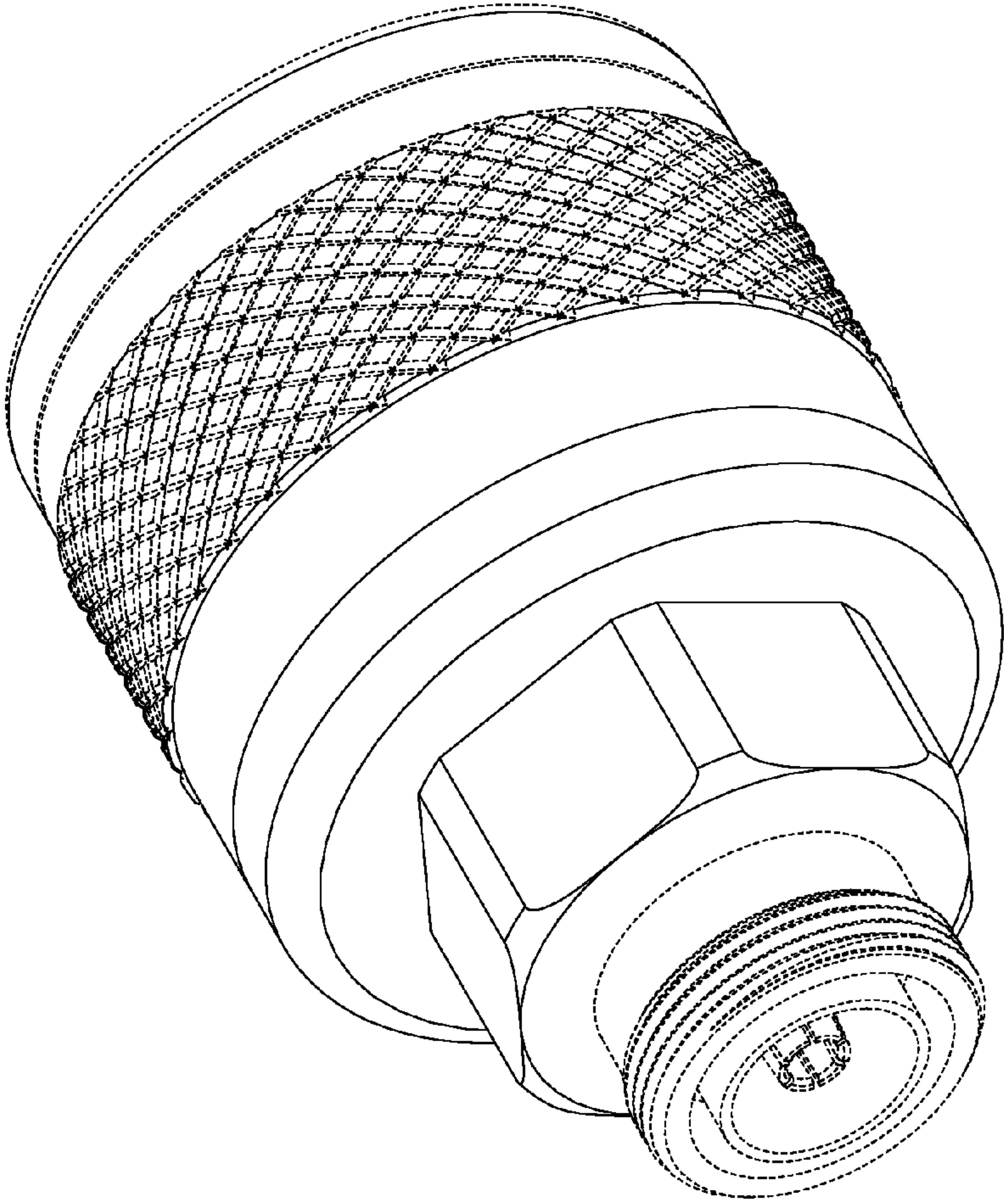
