FIG. 5 is a top orthographic view thereof;

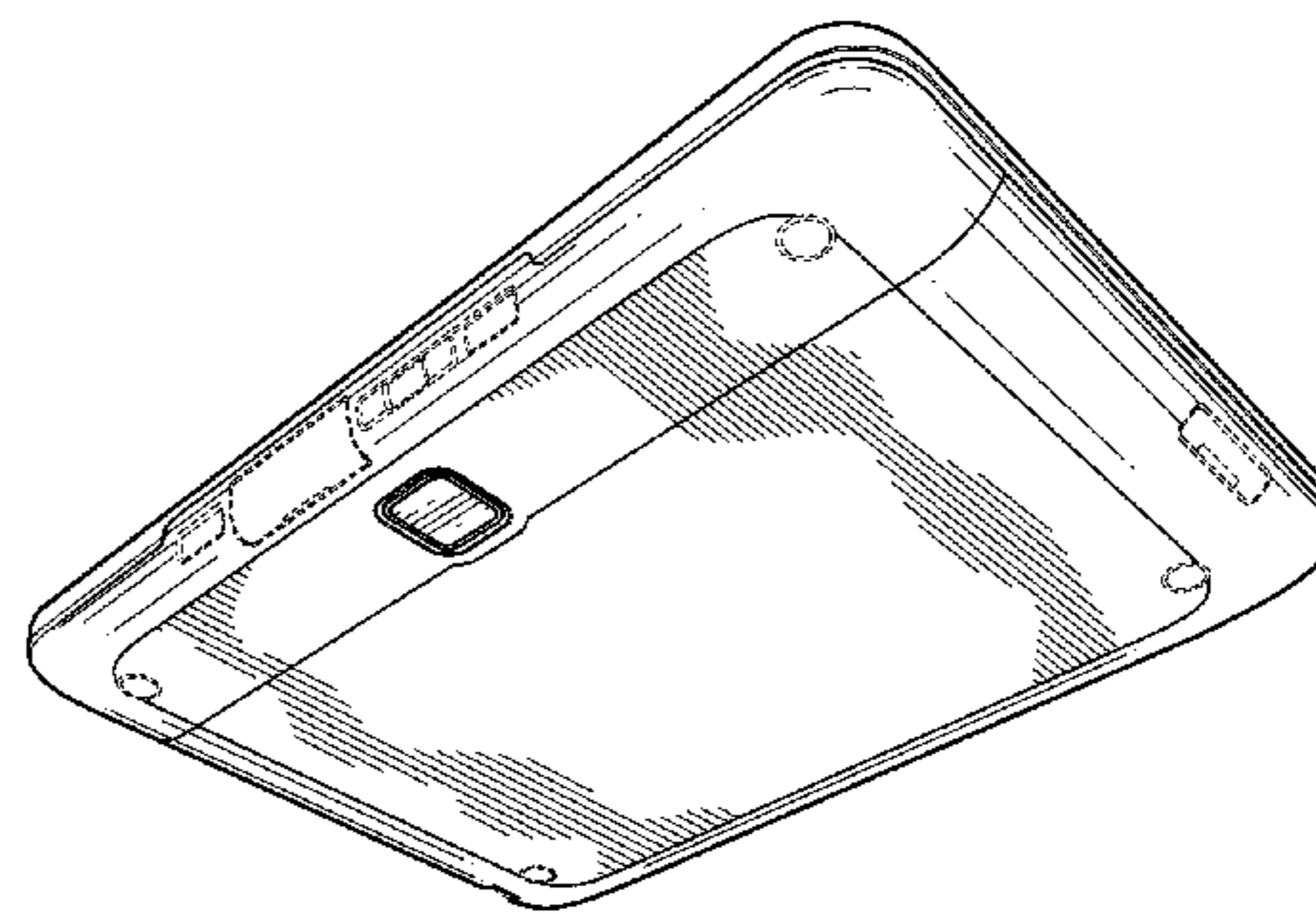
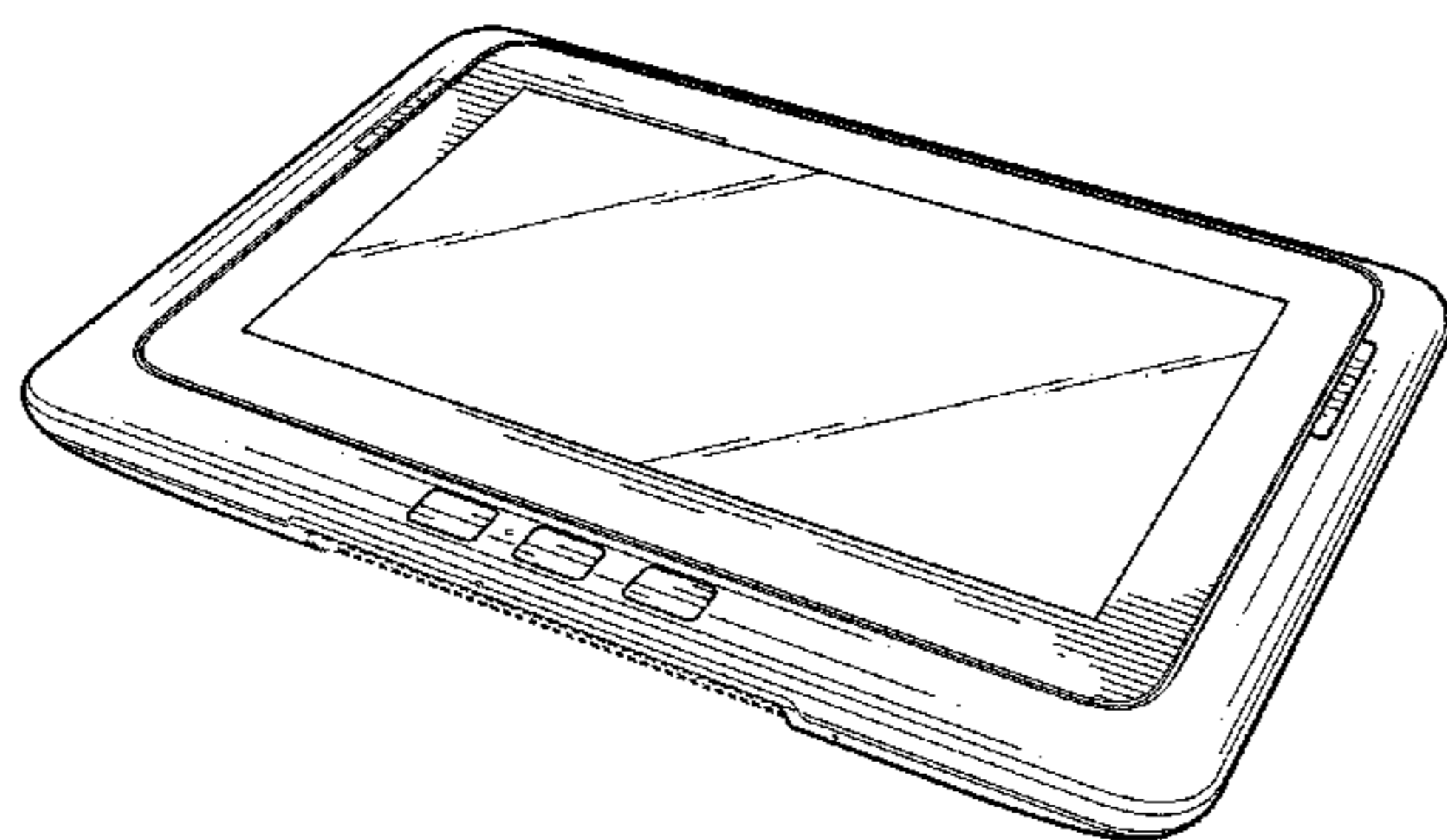
FIG. 6 is a bottom orthographic view thereof;

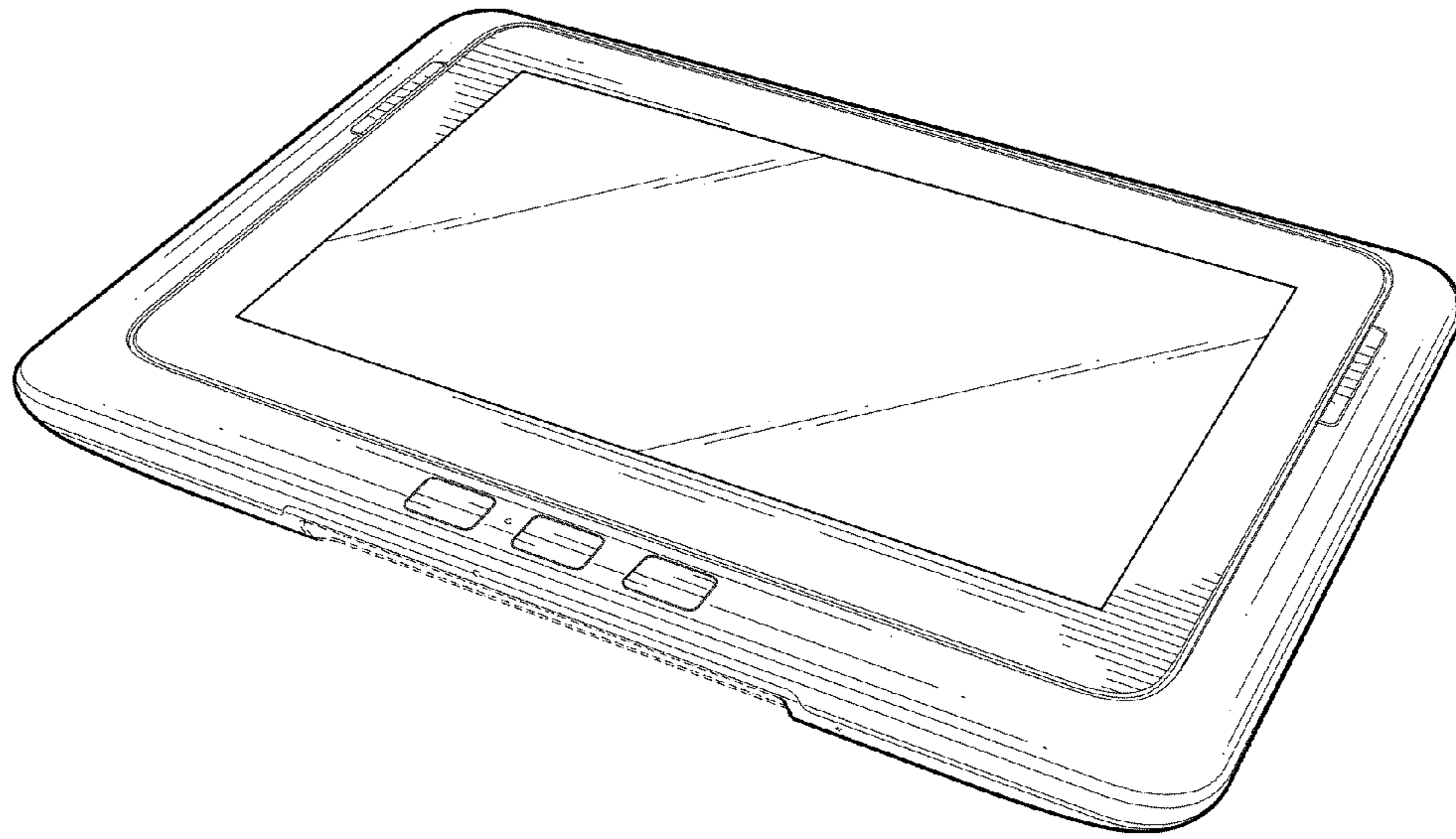

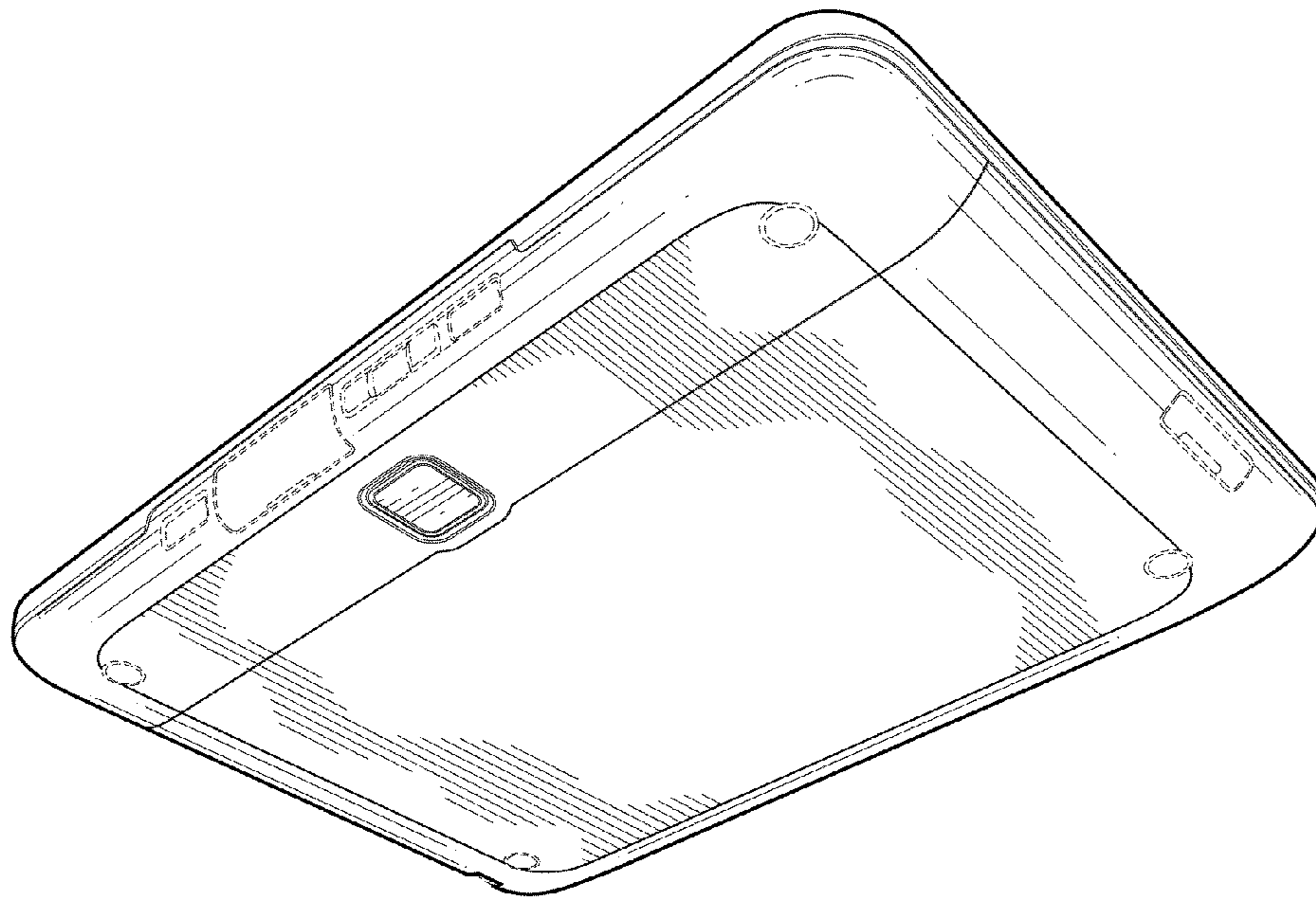

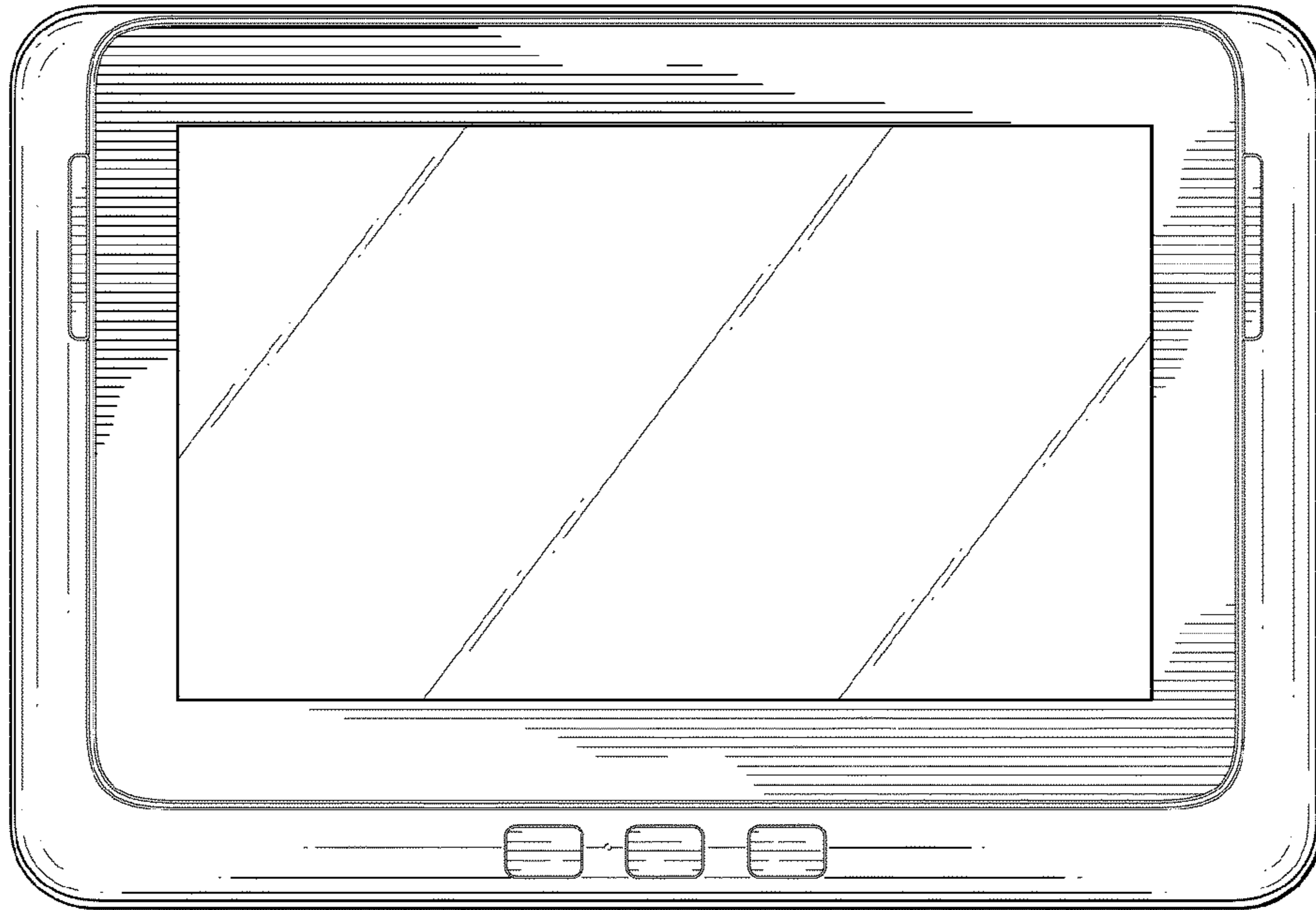

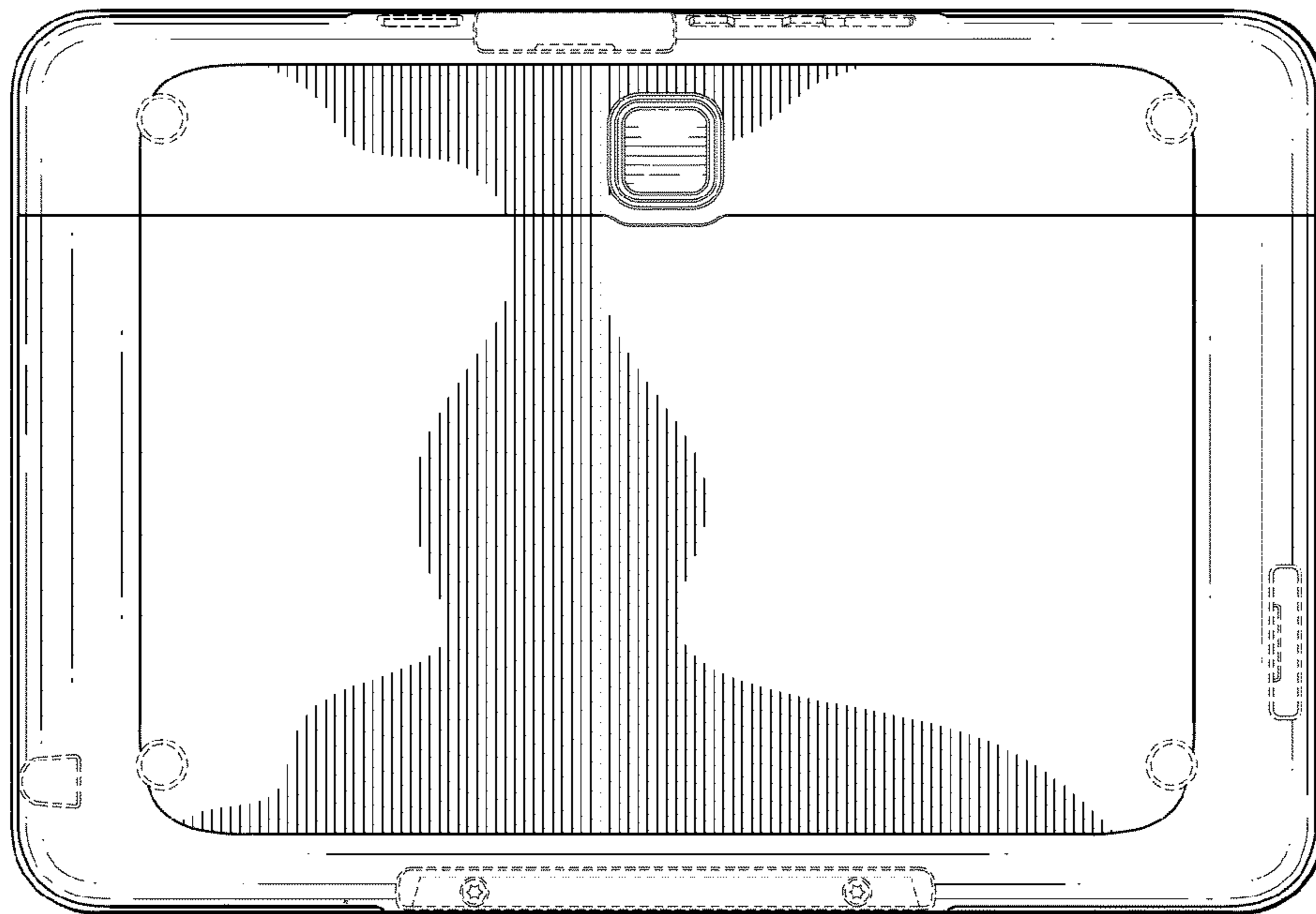

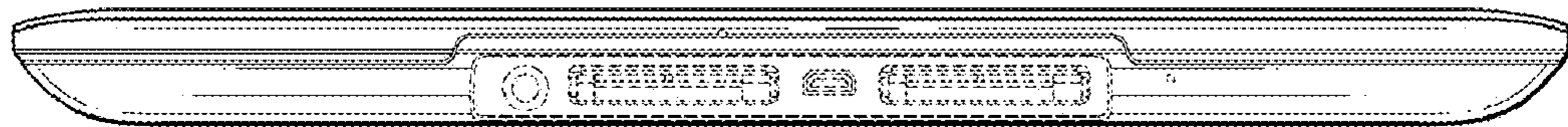

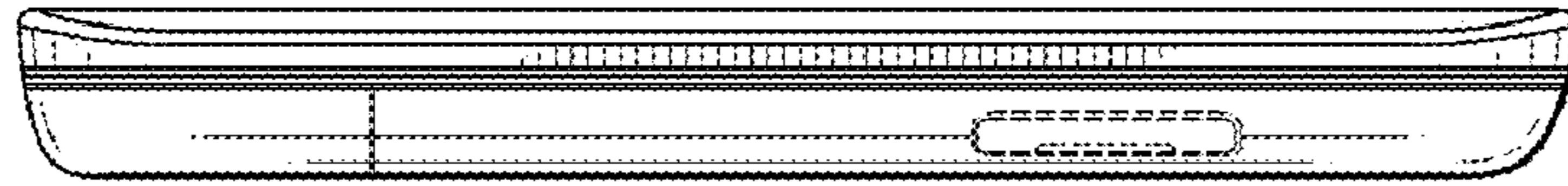

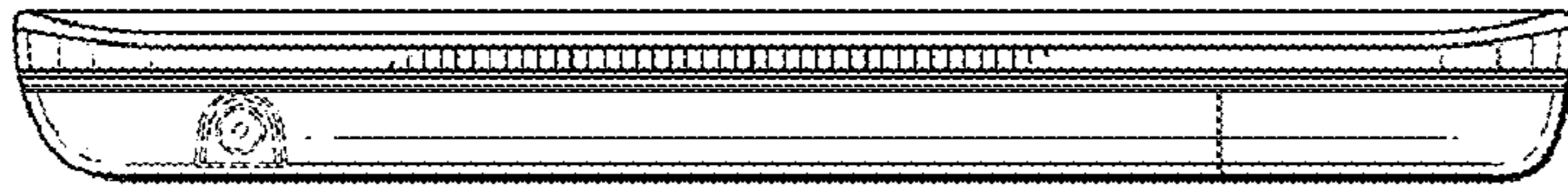
