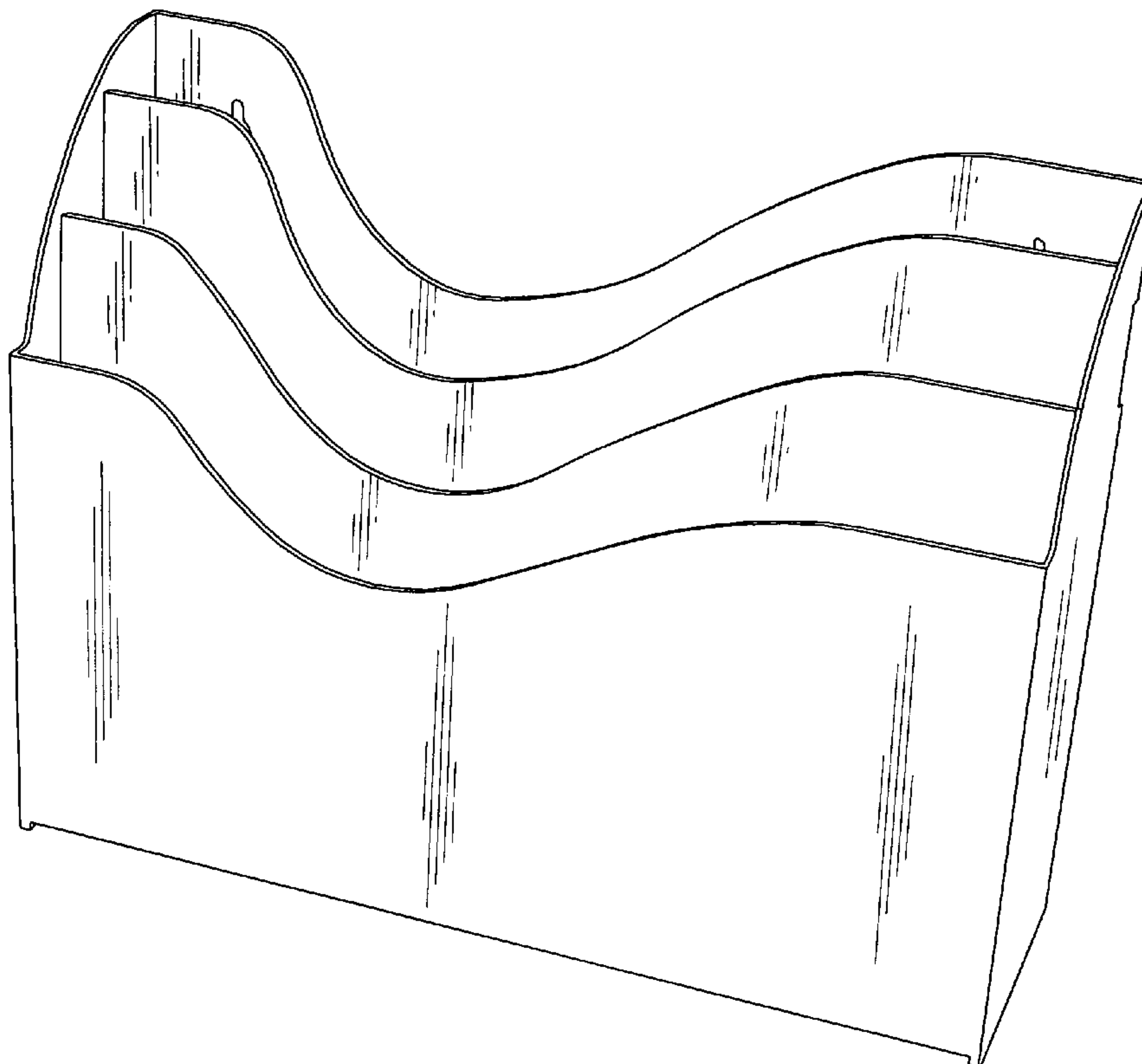
(57) **CLAIM**

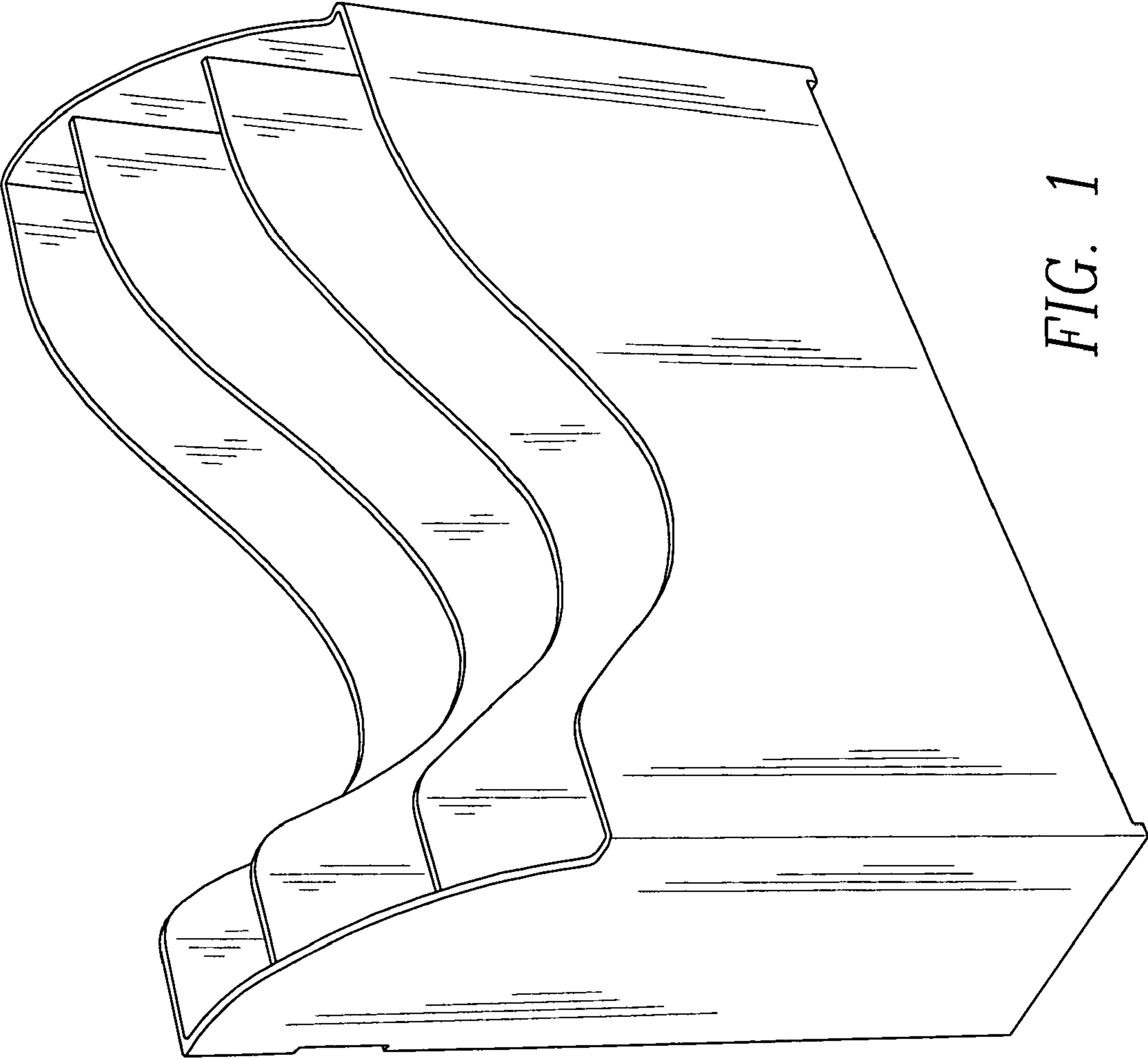
The ornamental design for a paper organizer, as shown and described.

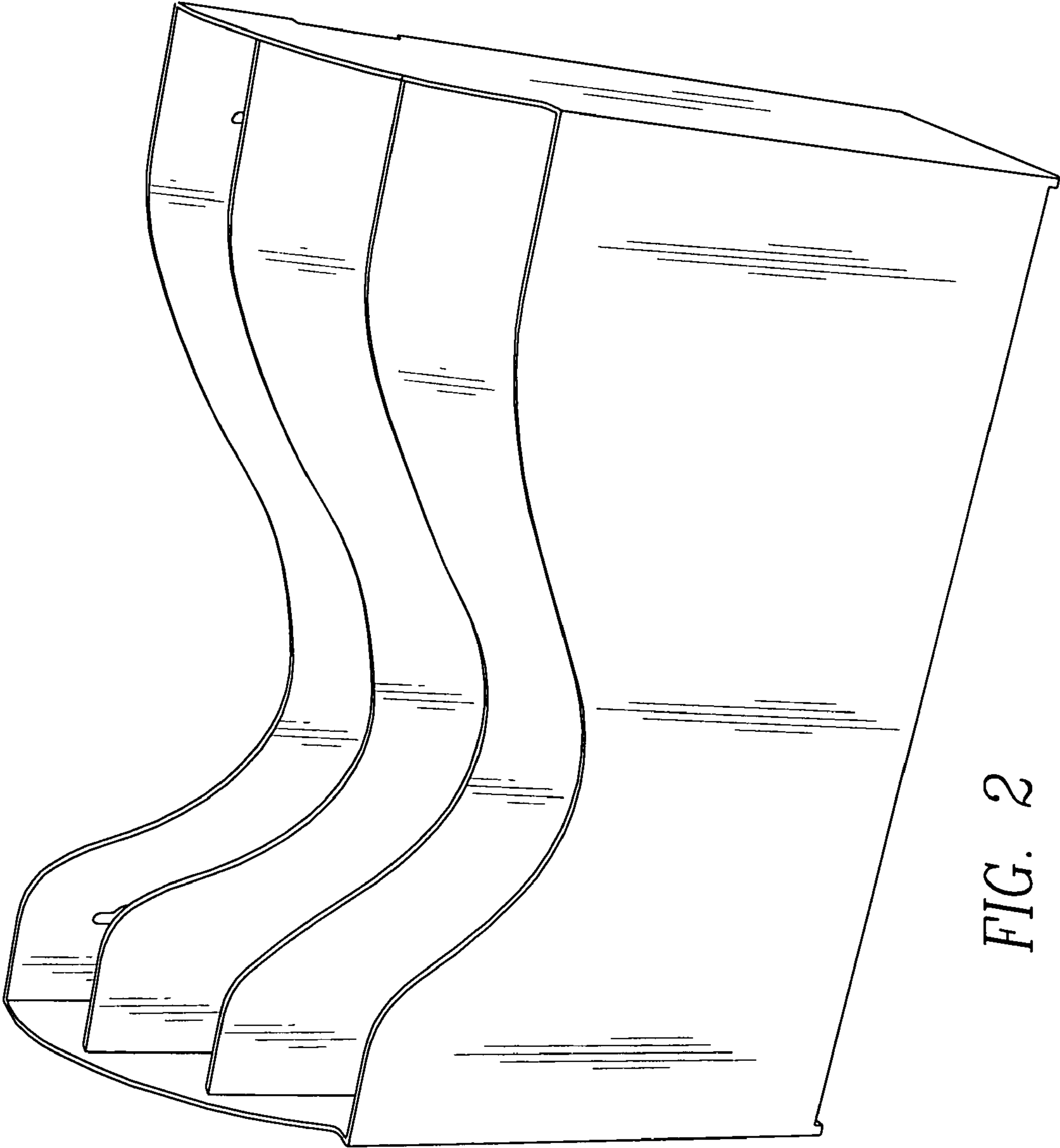

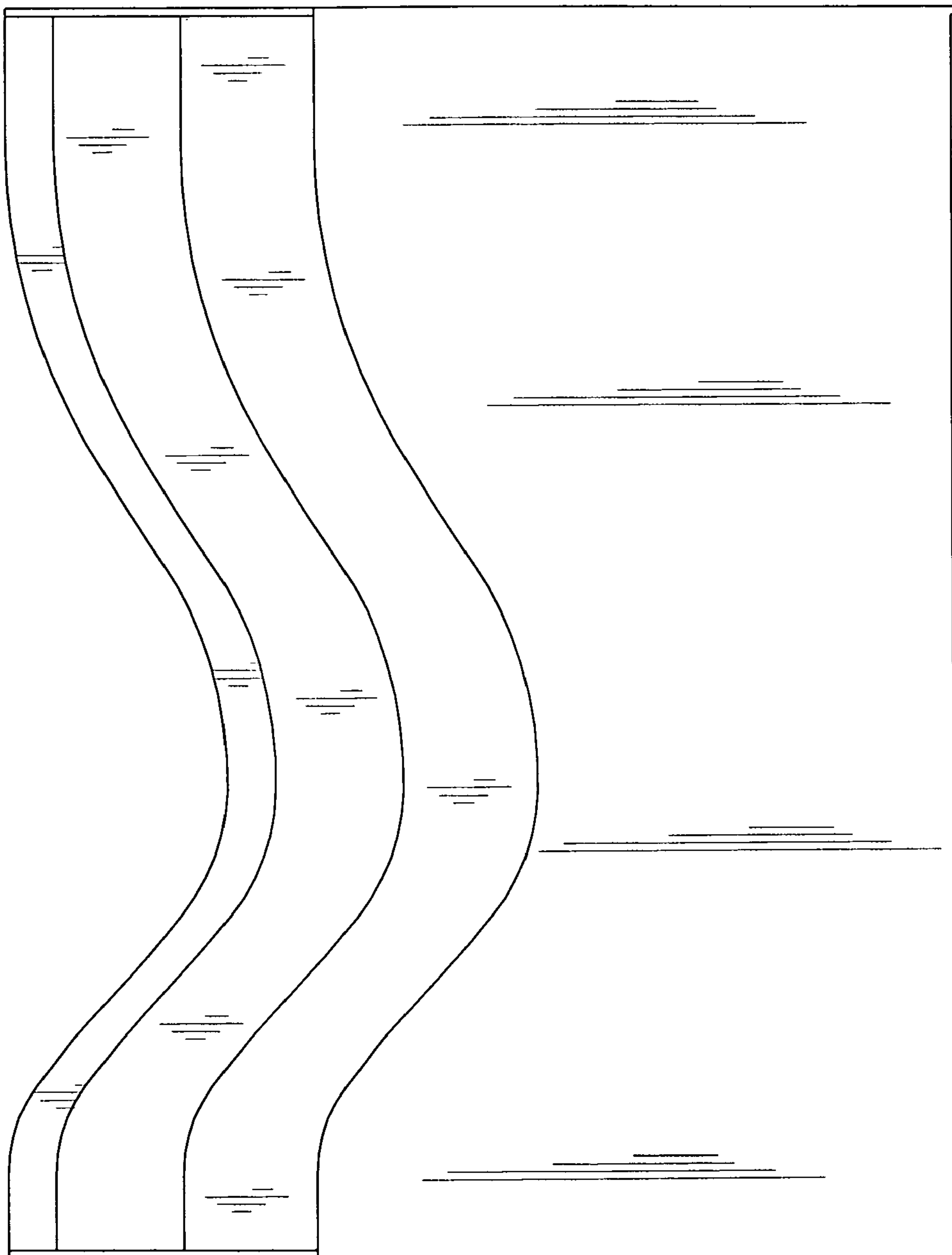

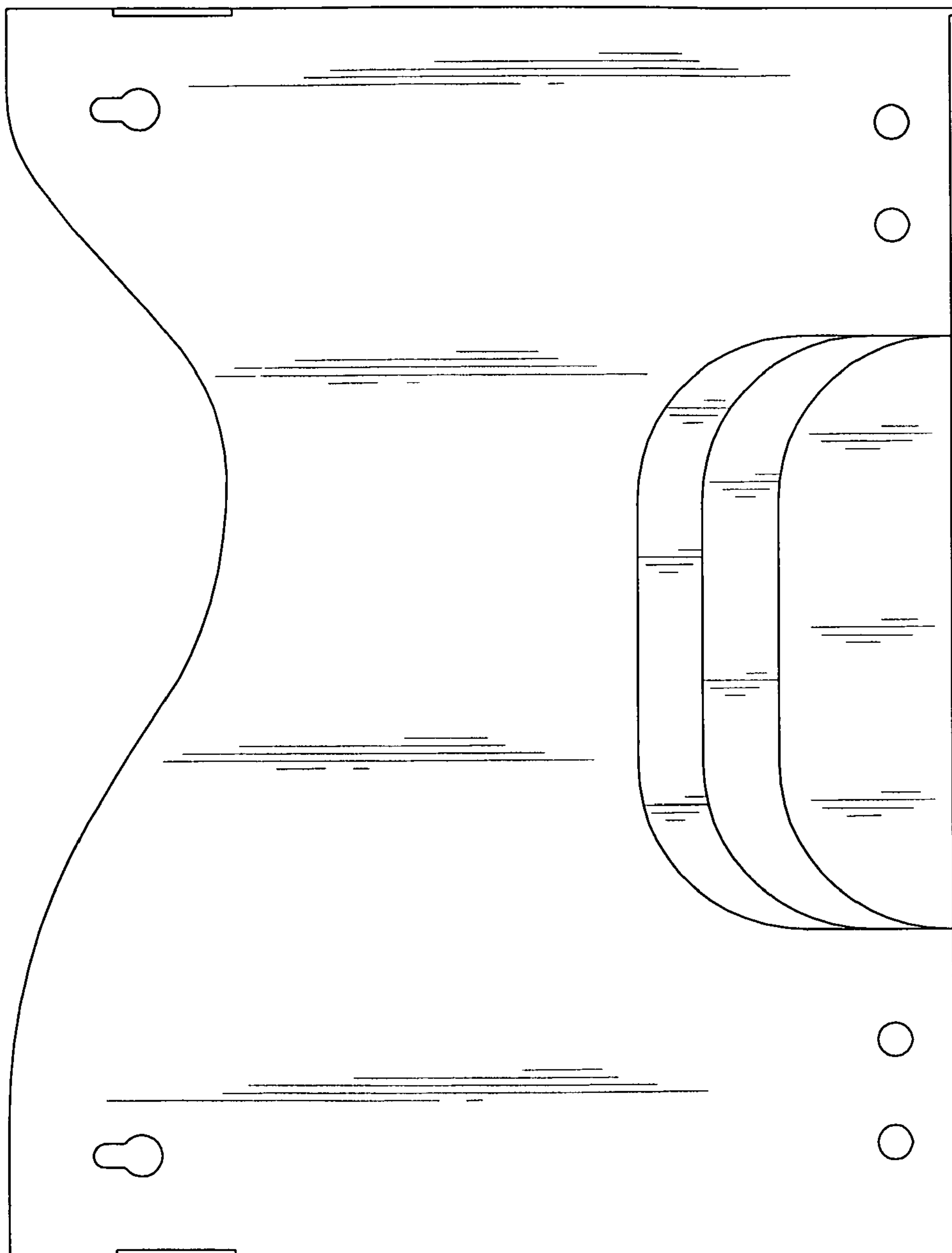

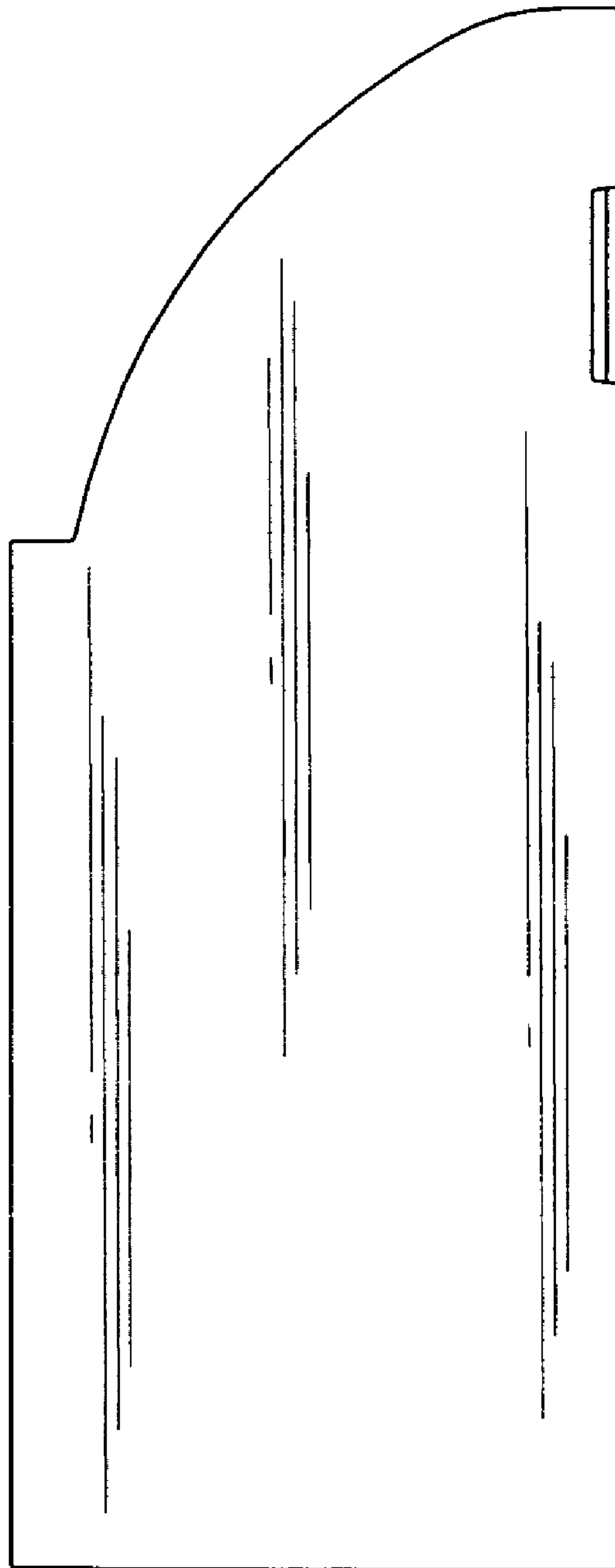

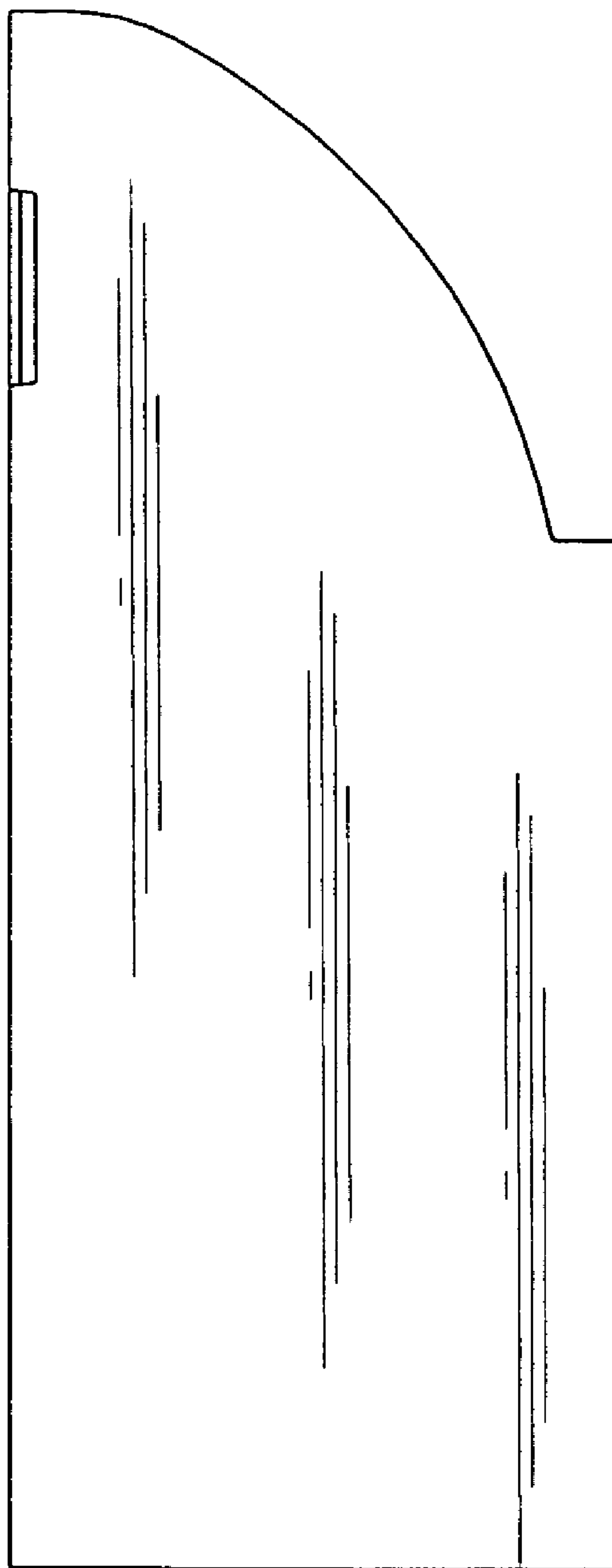

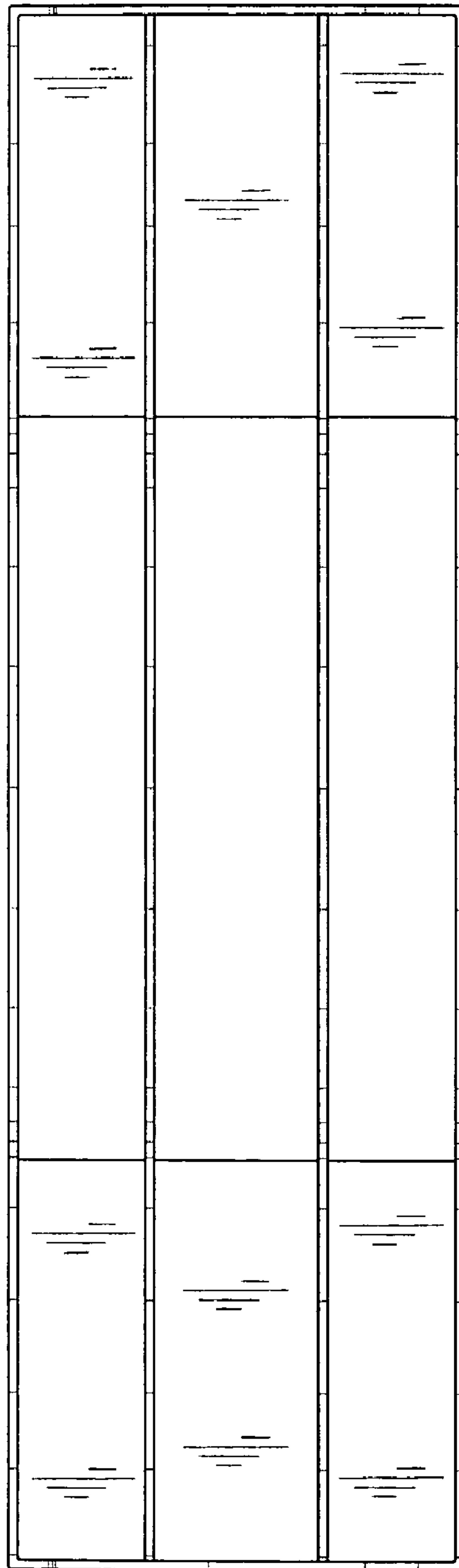

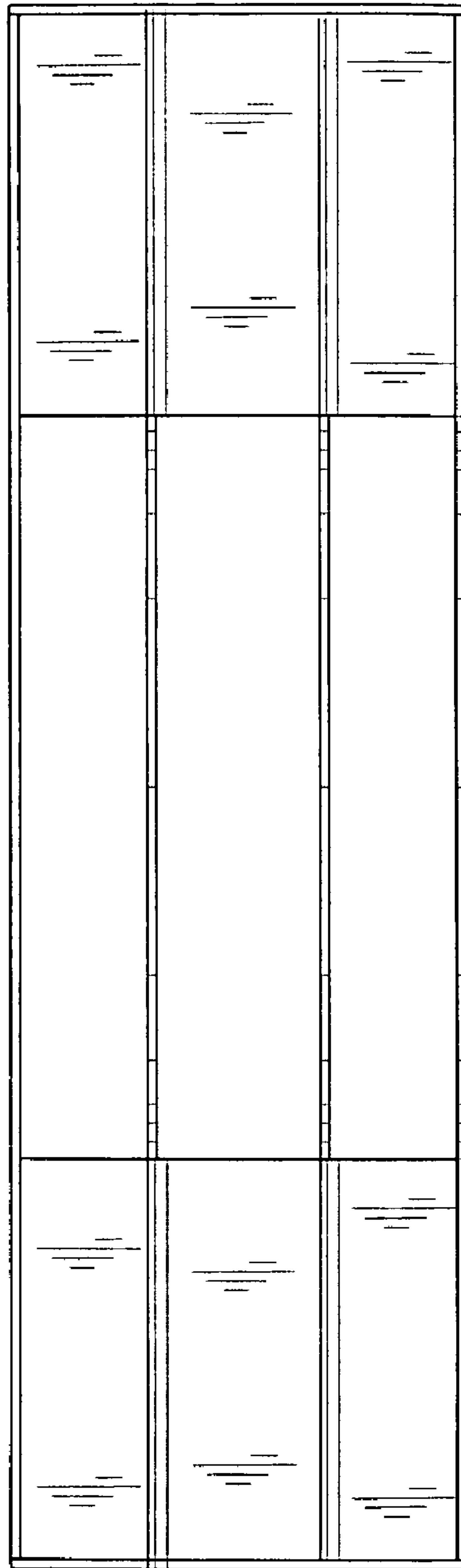
