DESCRIPTION

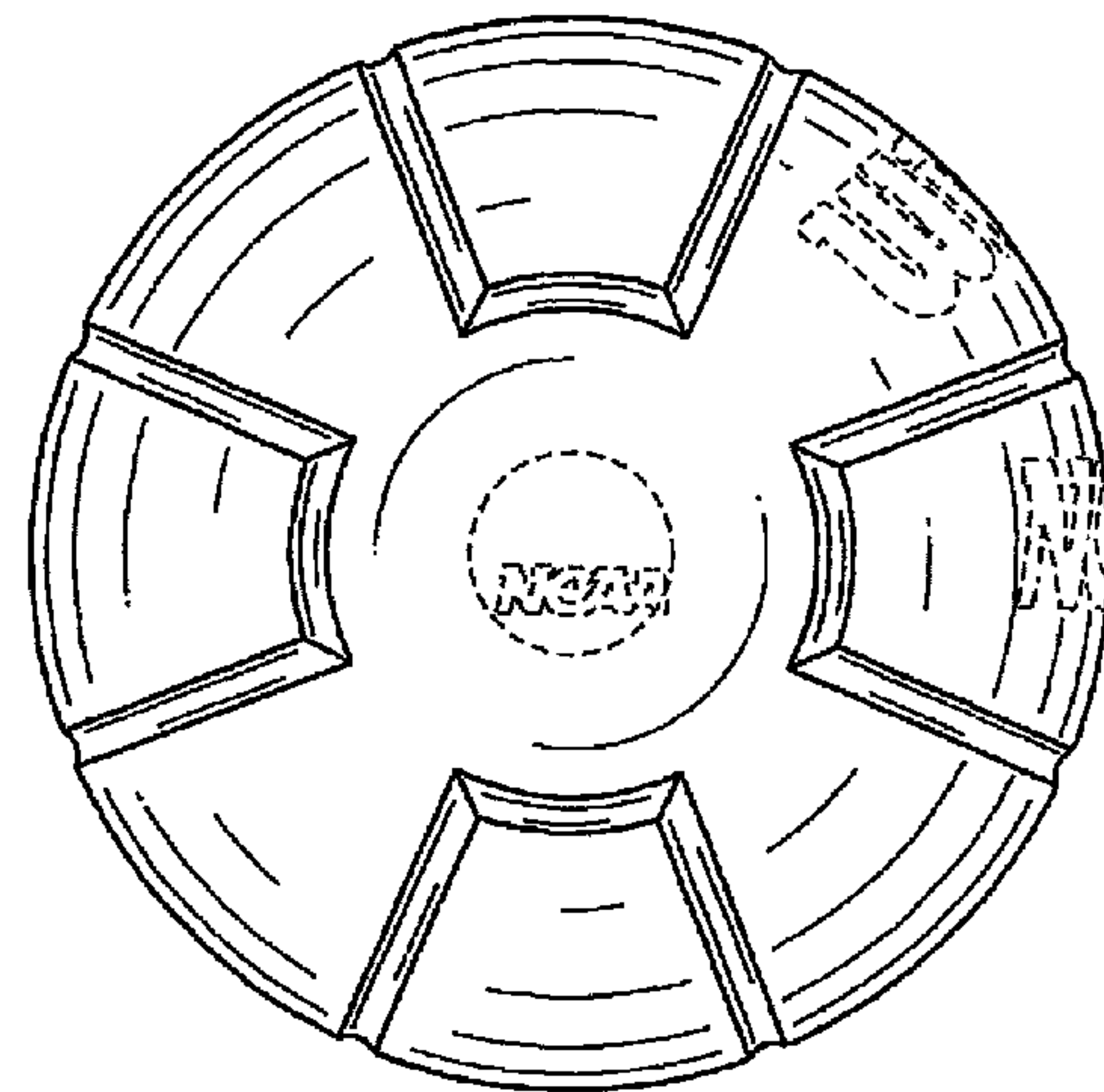
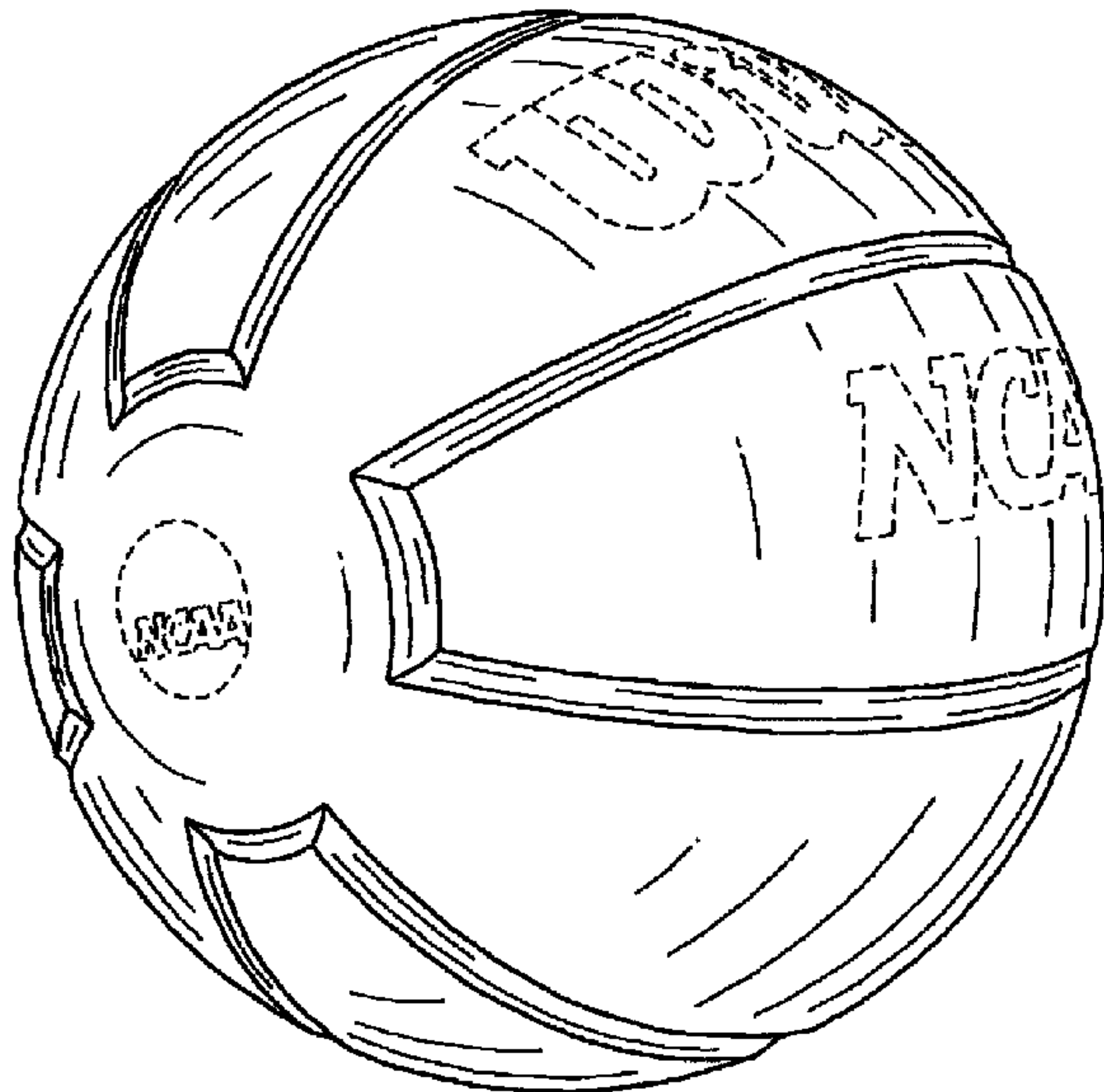
FIG. 1 is a side perspective view of a basketball showing my new design;

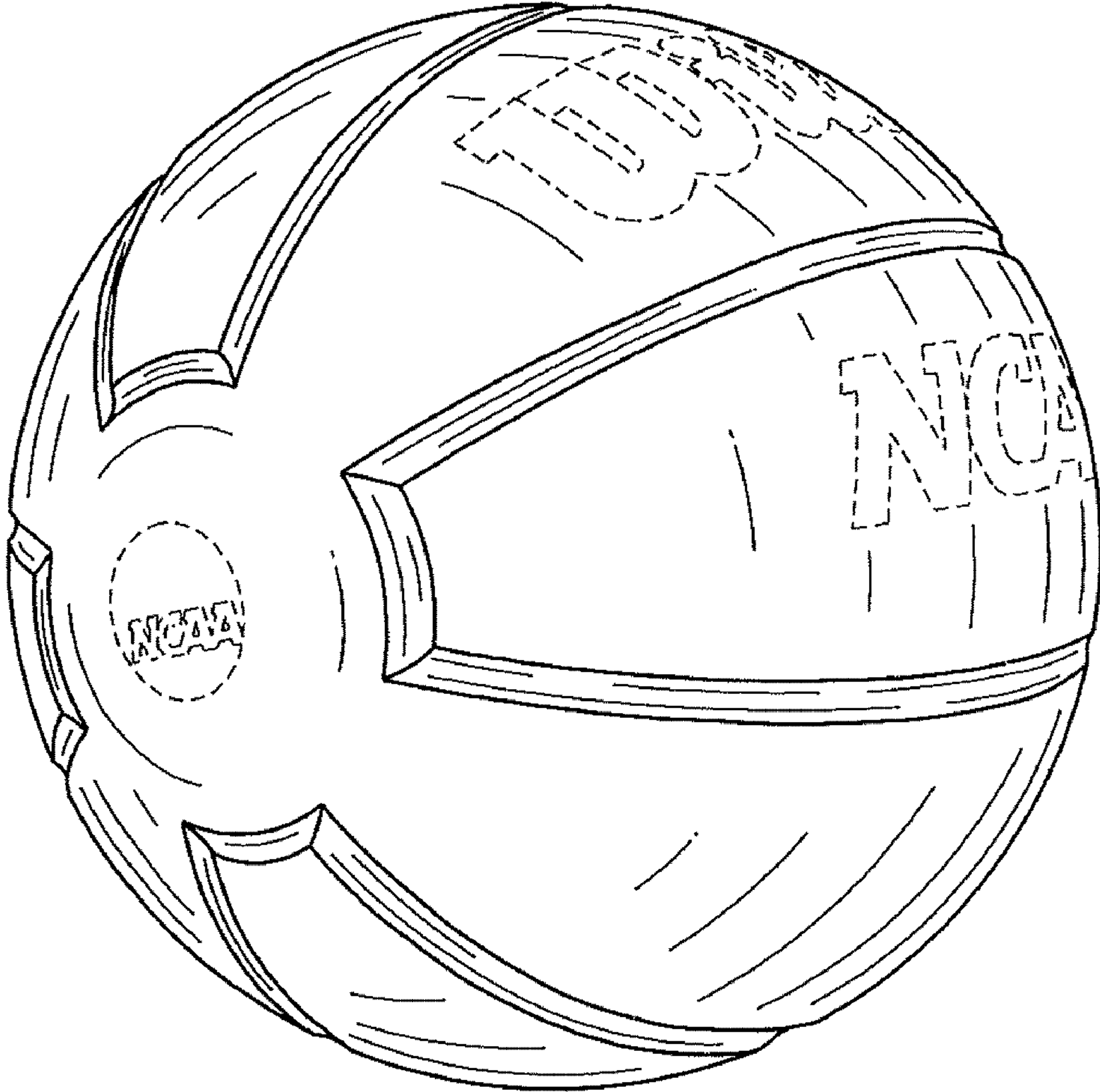

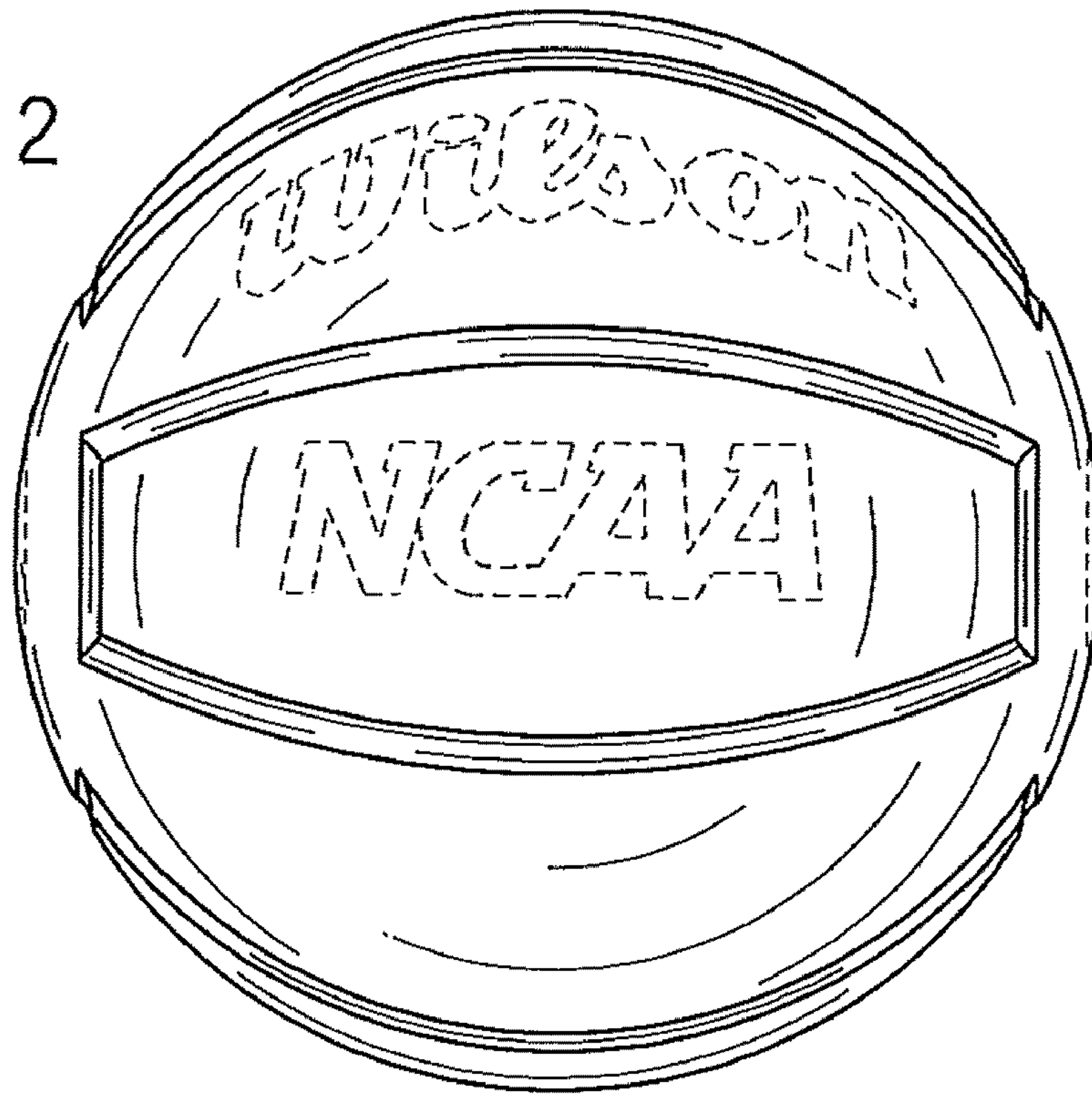
