FIG. 6 is front elevation of the magazine follower.

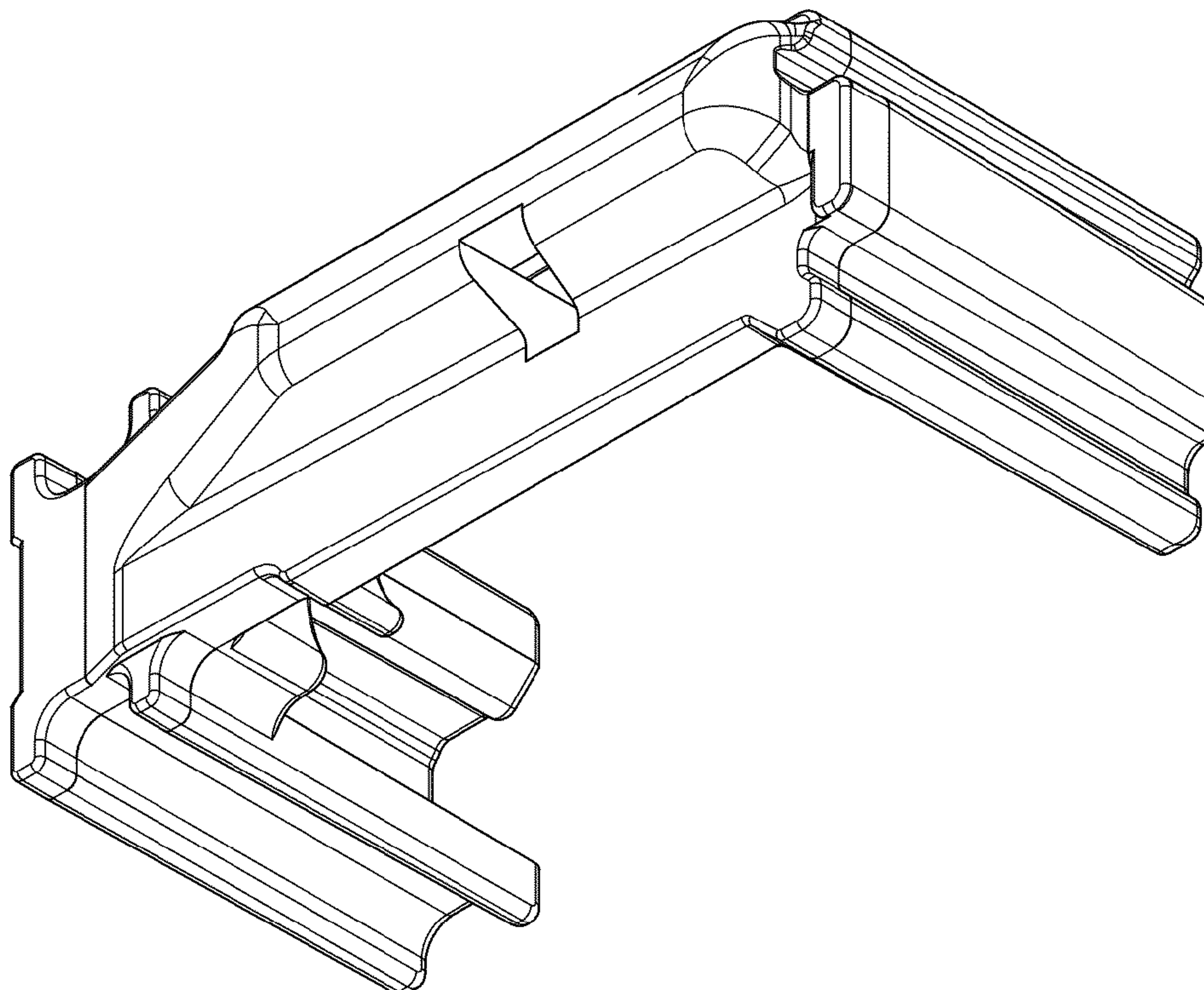
FIG. 7 is a rear elevation of the magazine follower.

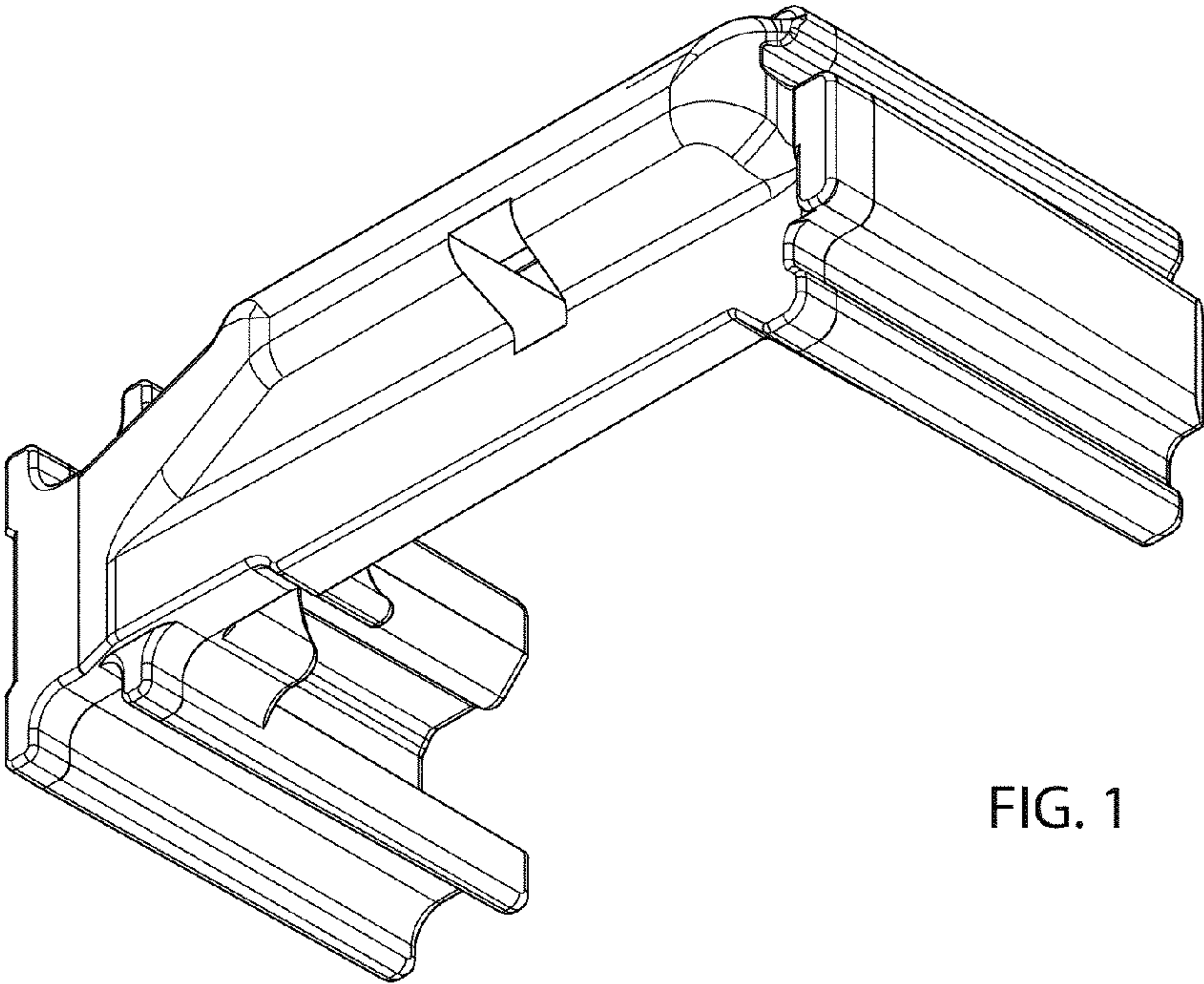

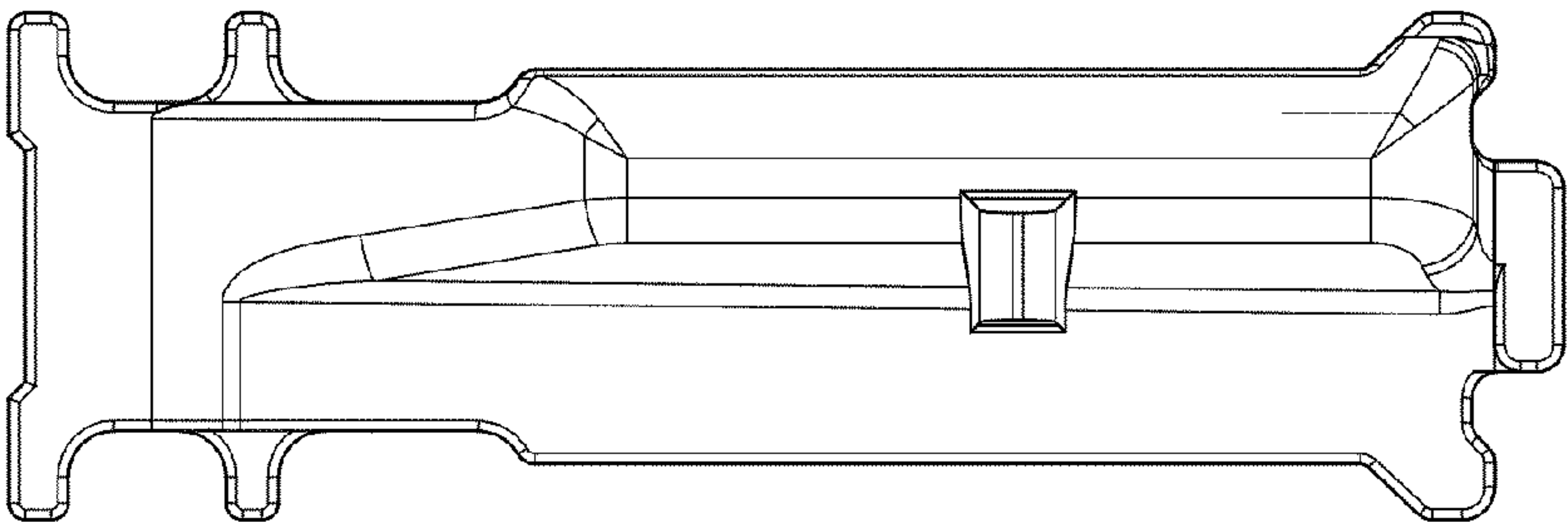

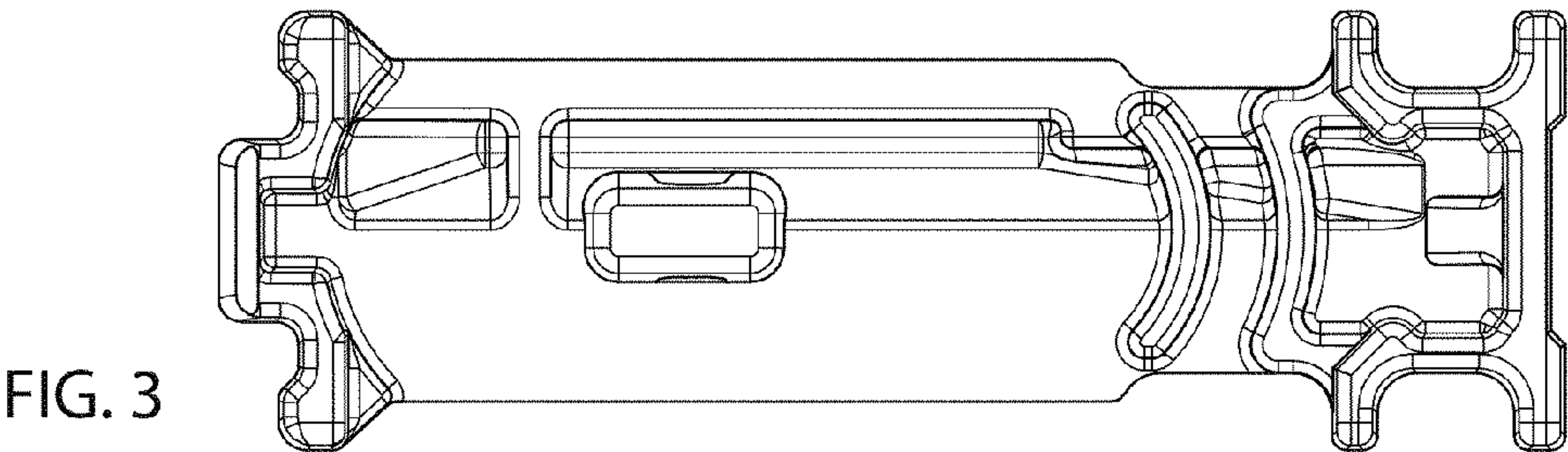

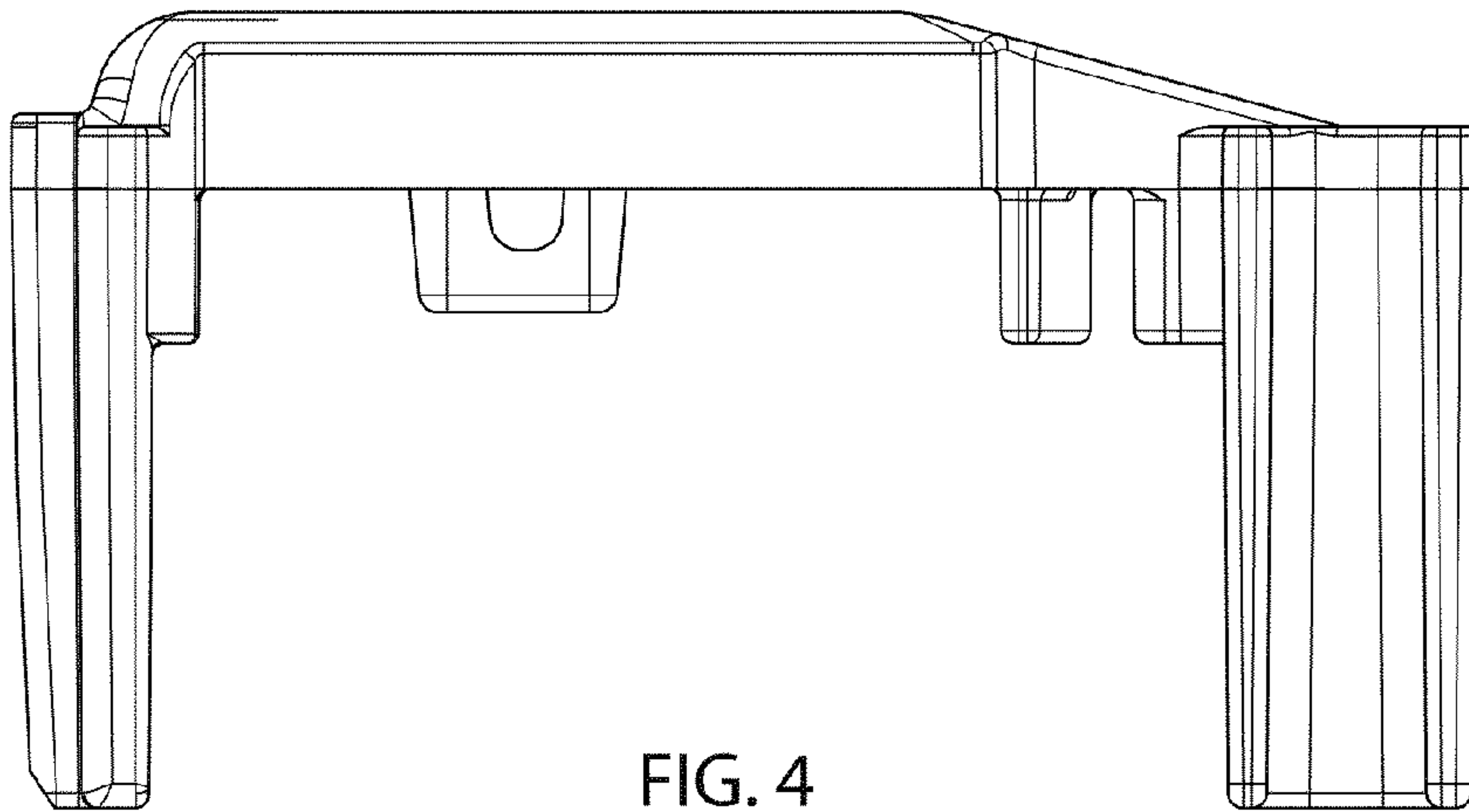

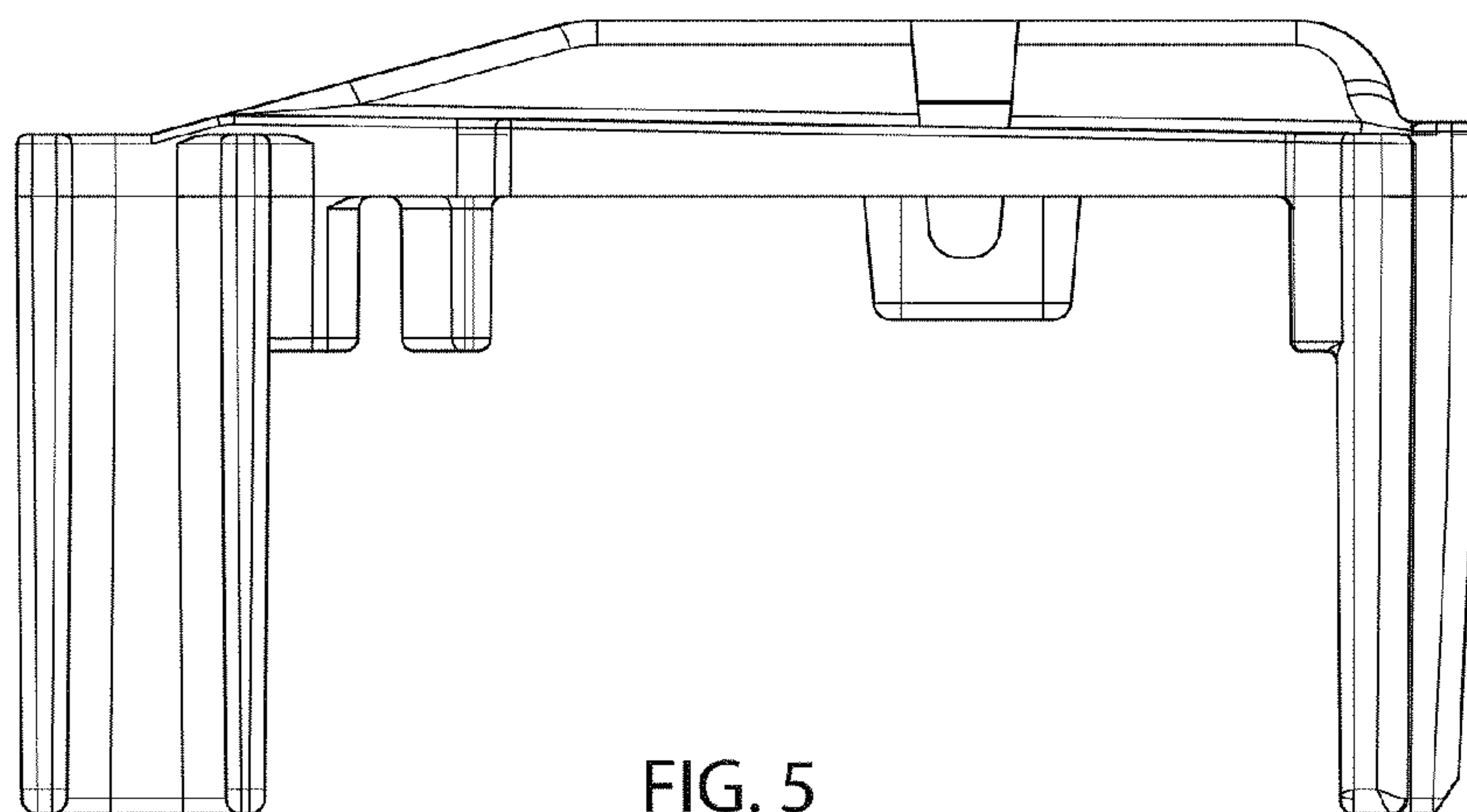

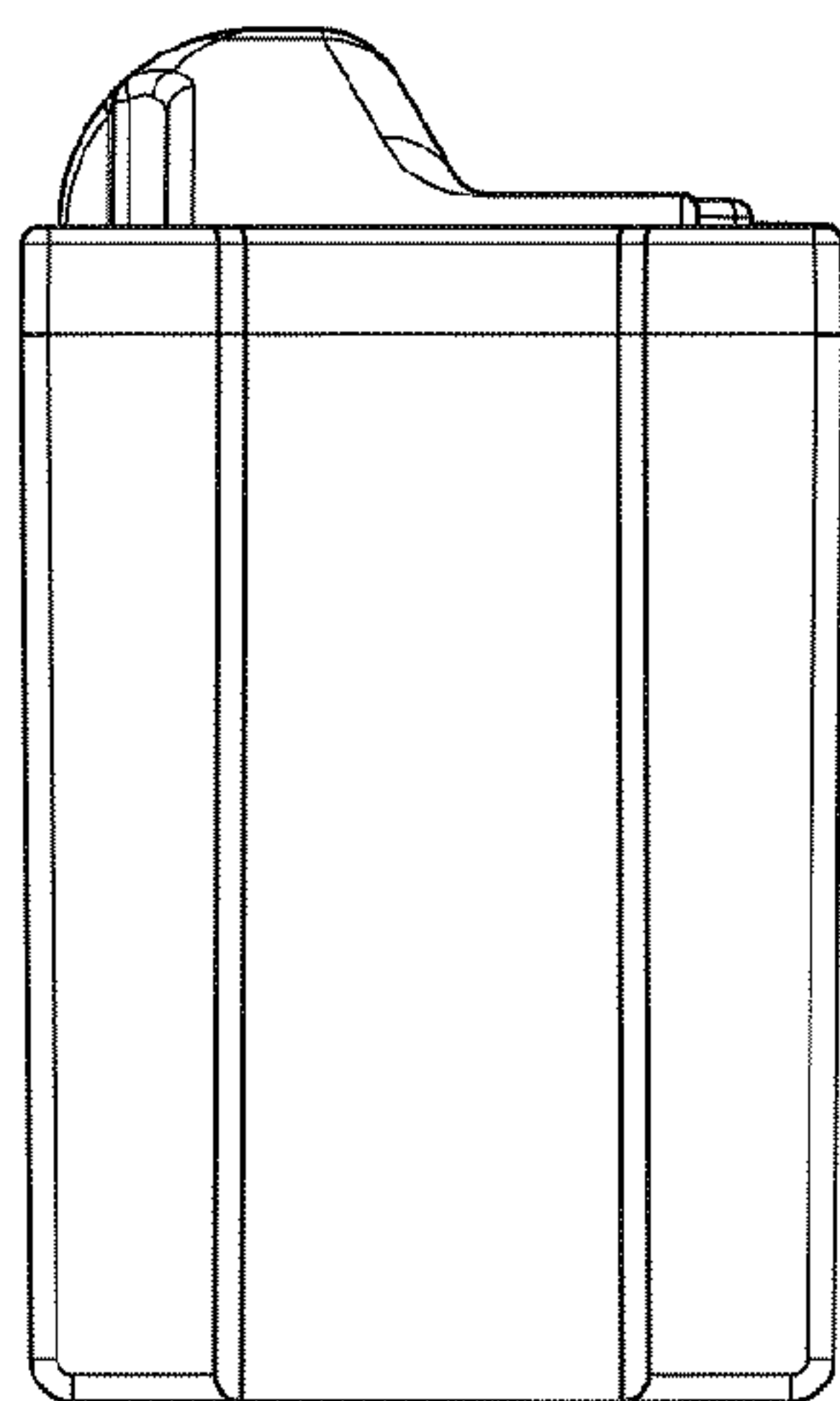

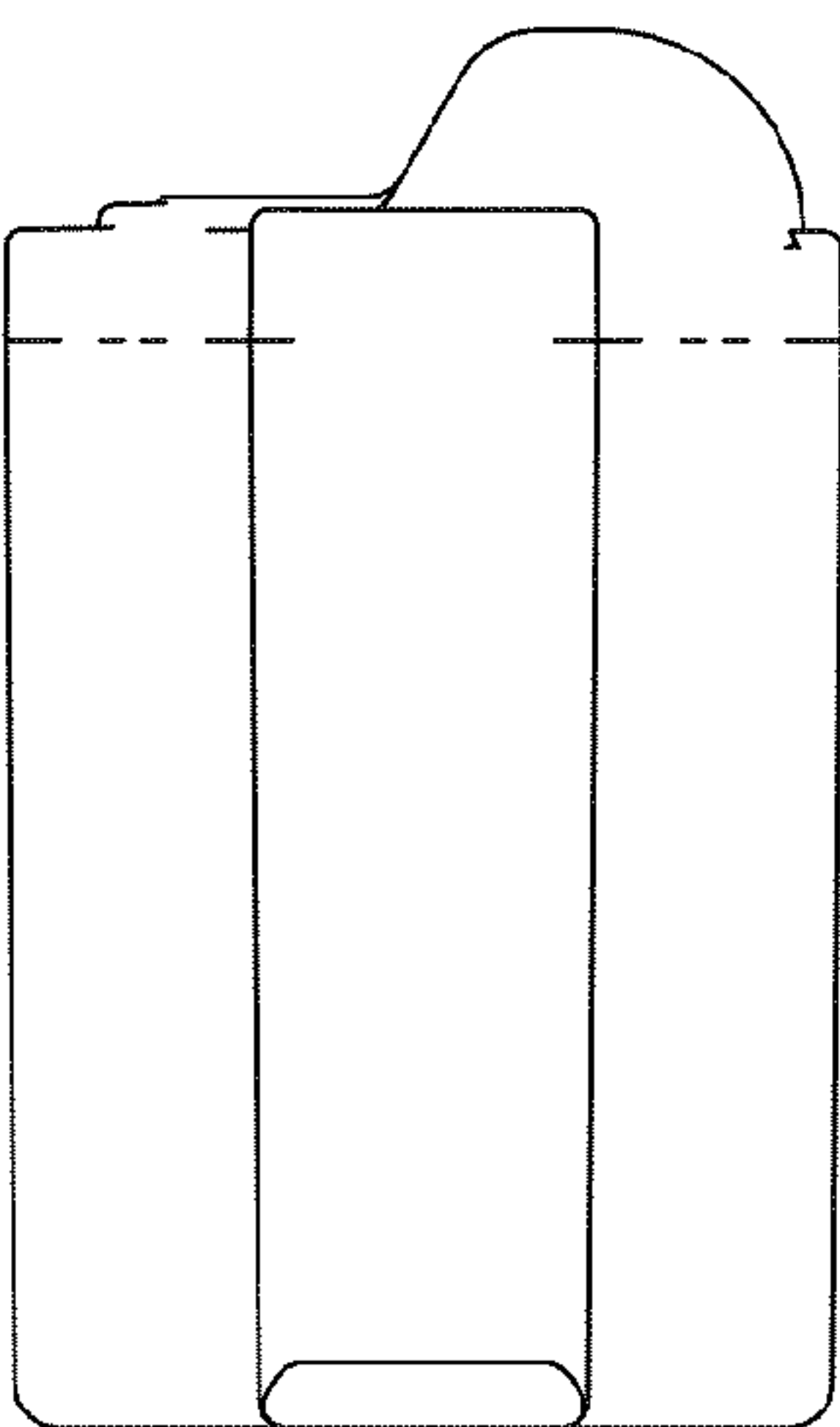

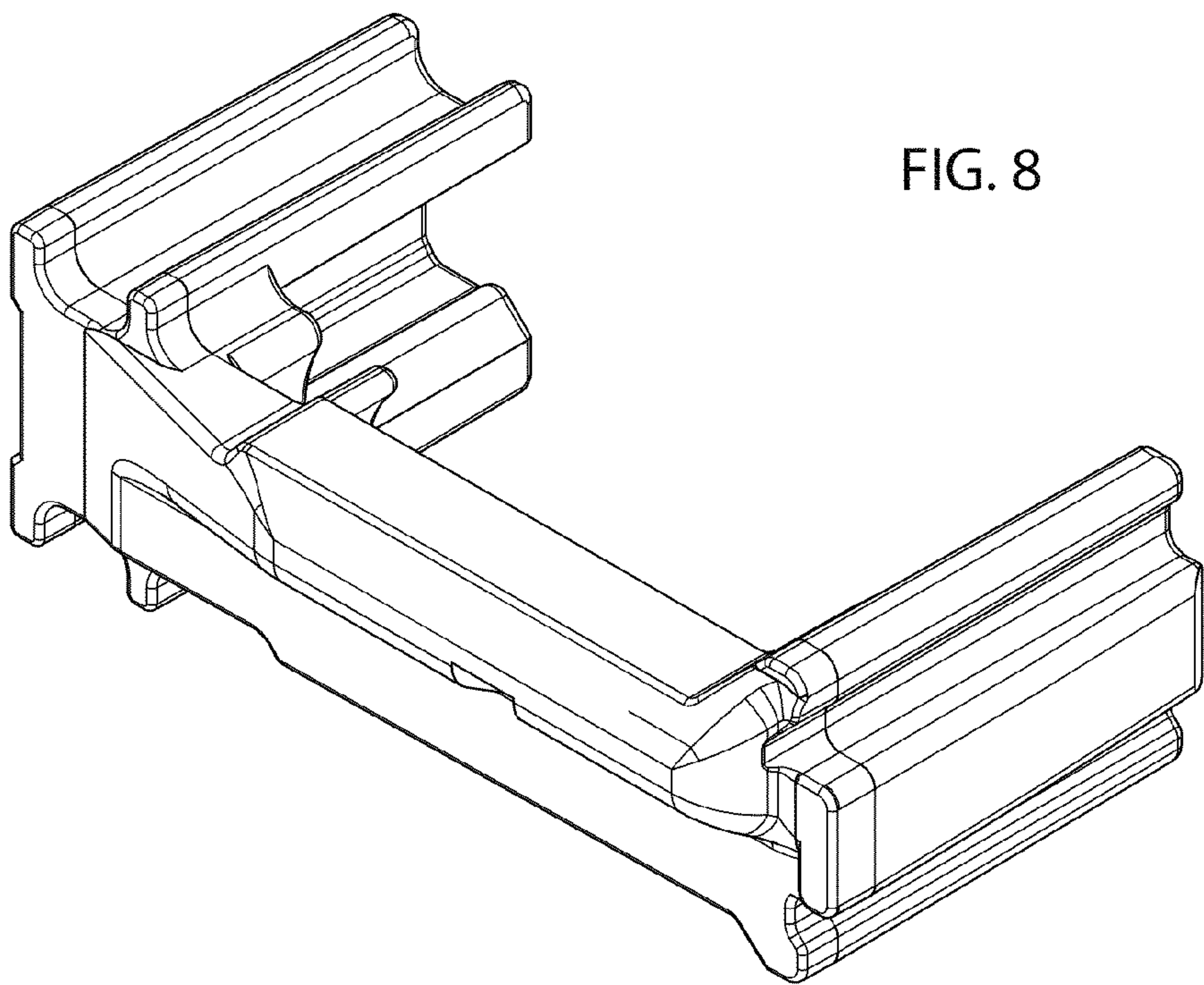

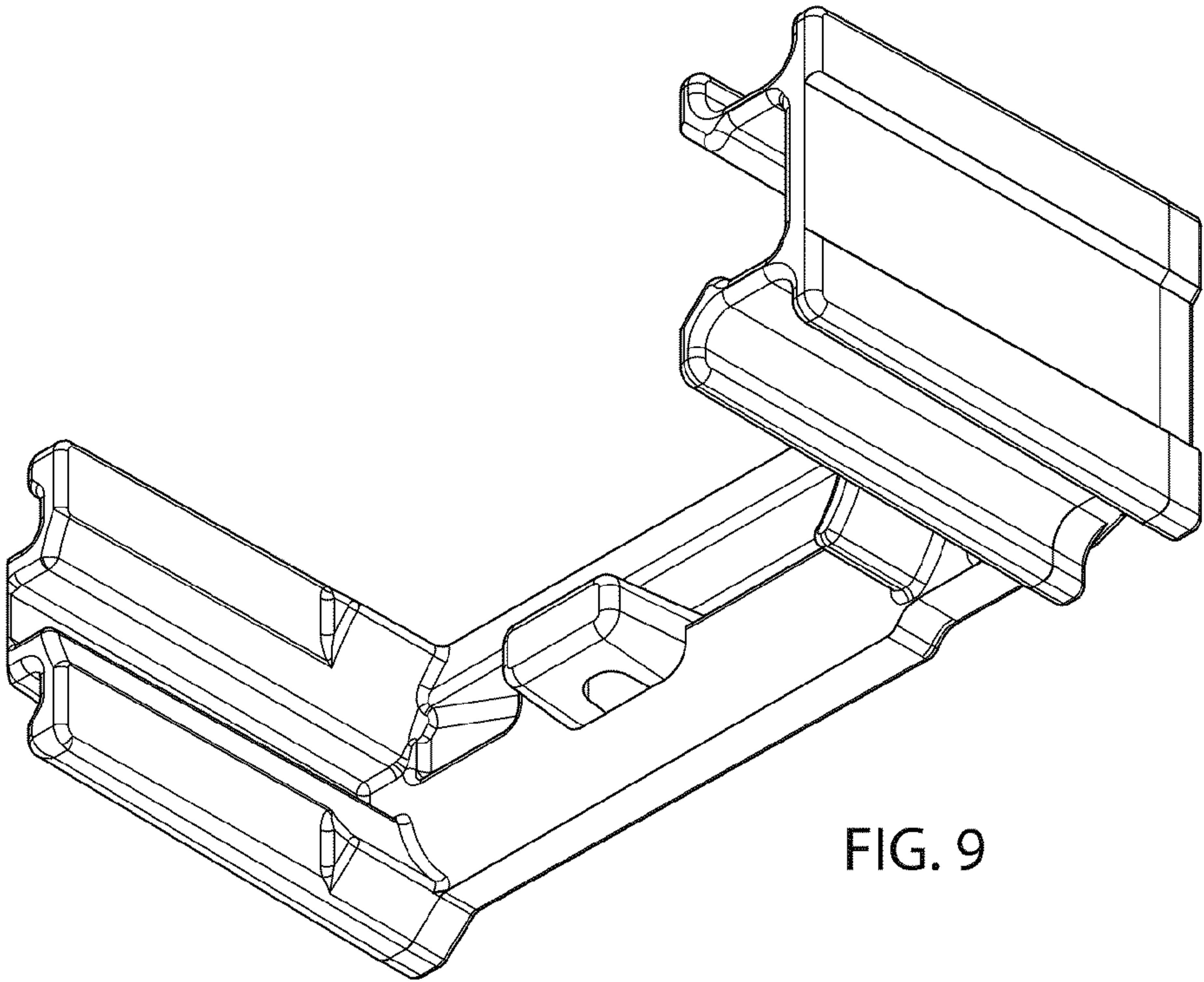

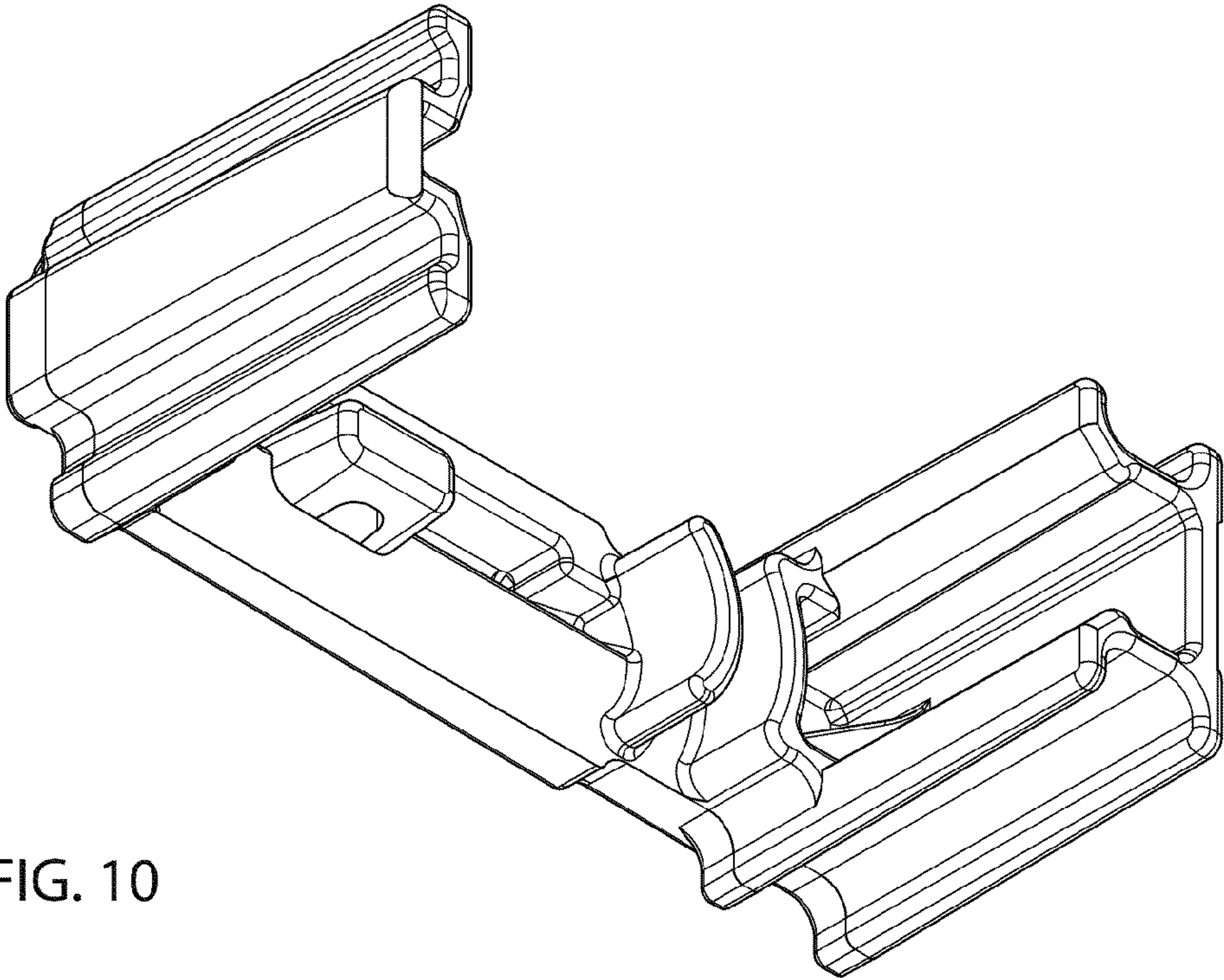
