DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a lighting apparatus showing the new design;

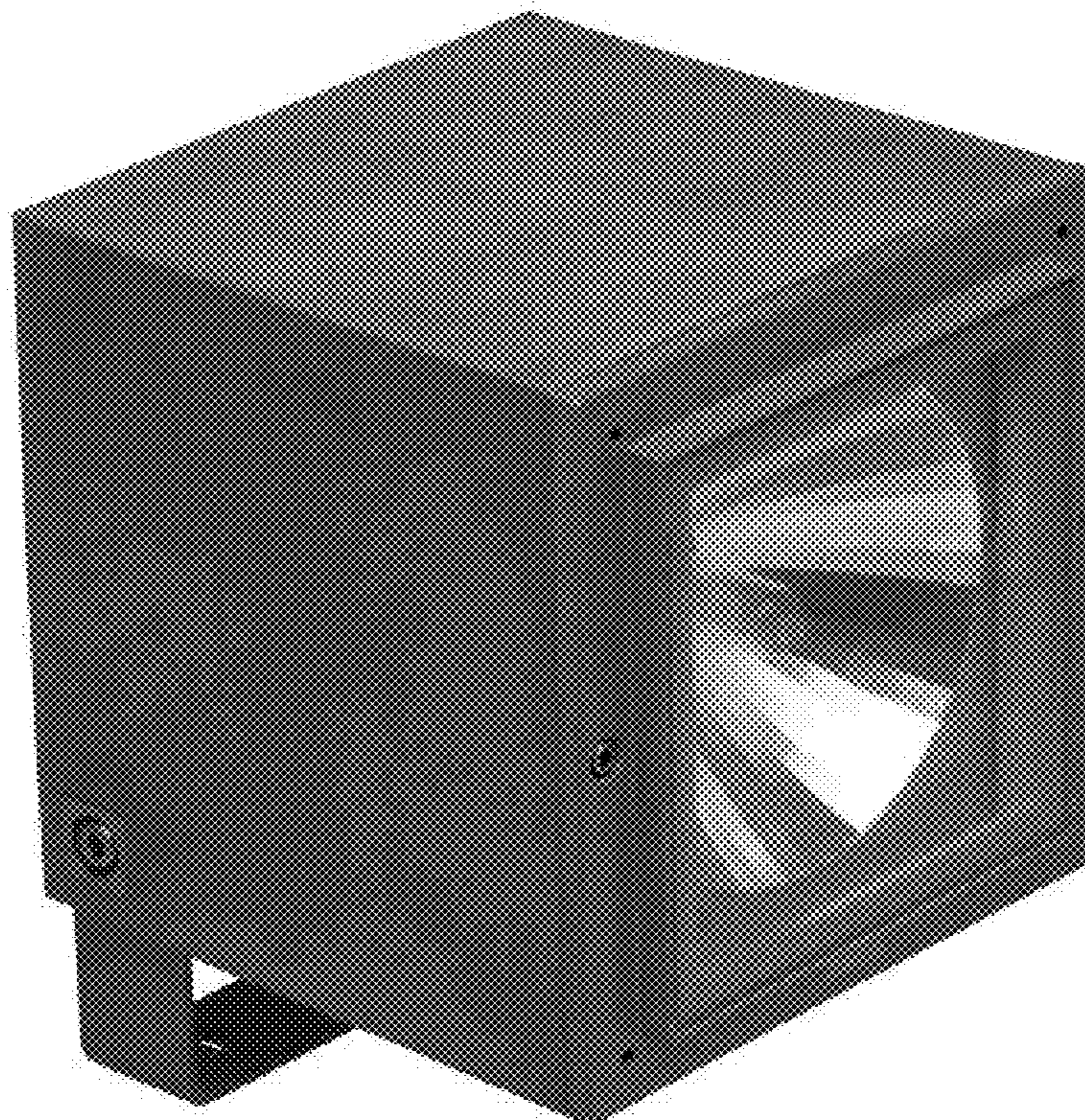

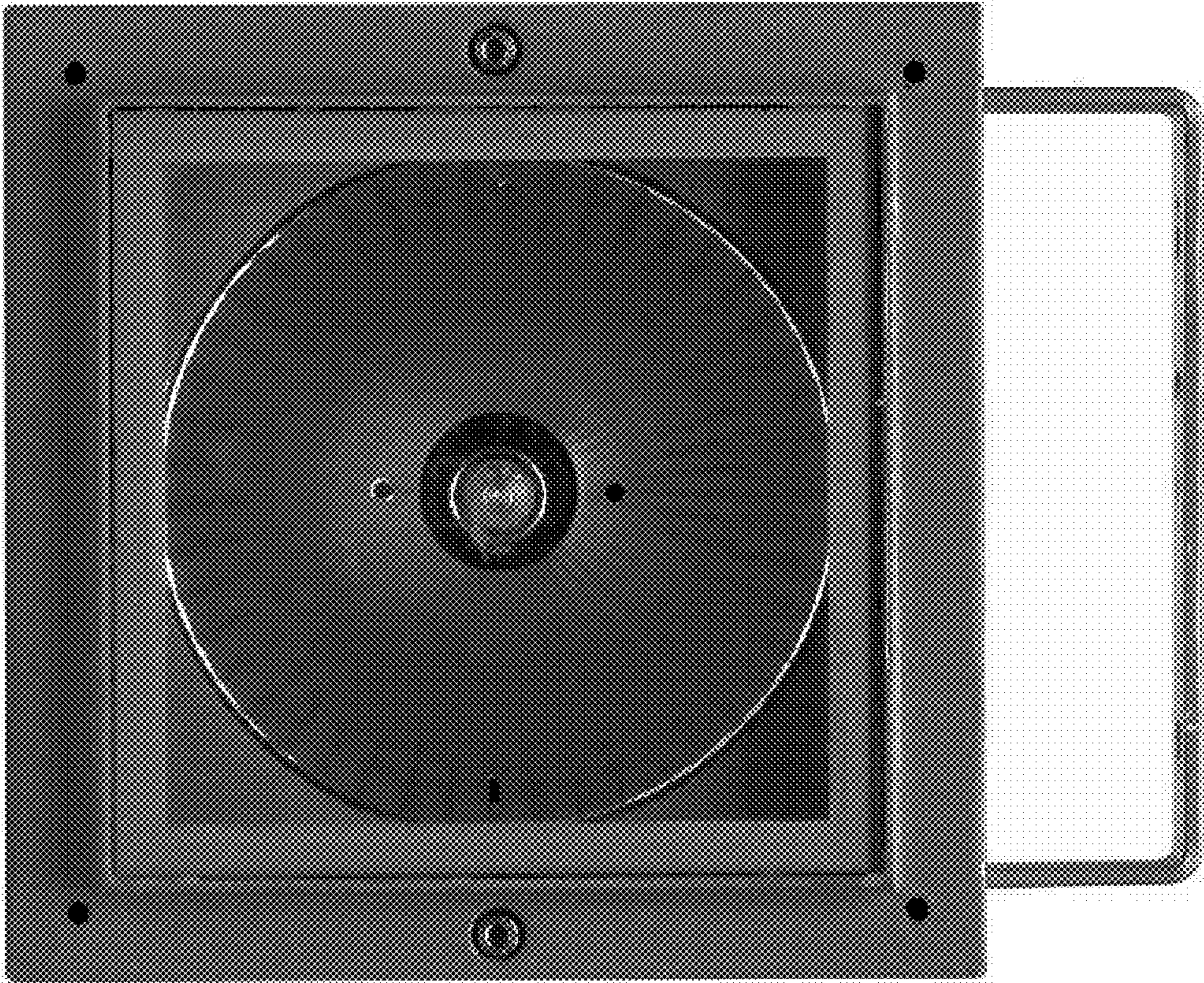

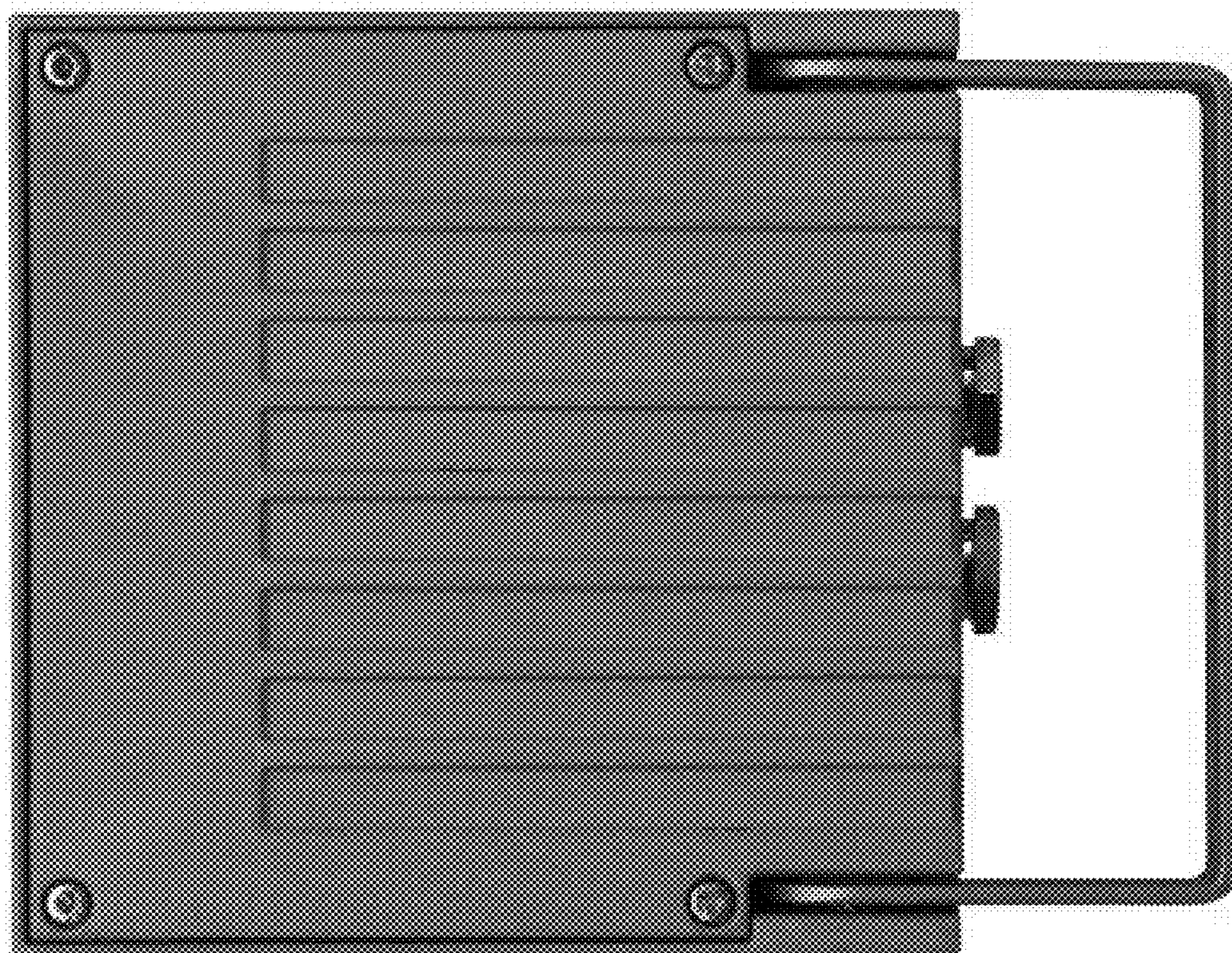

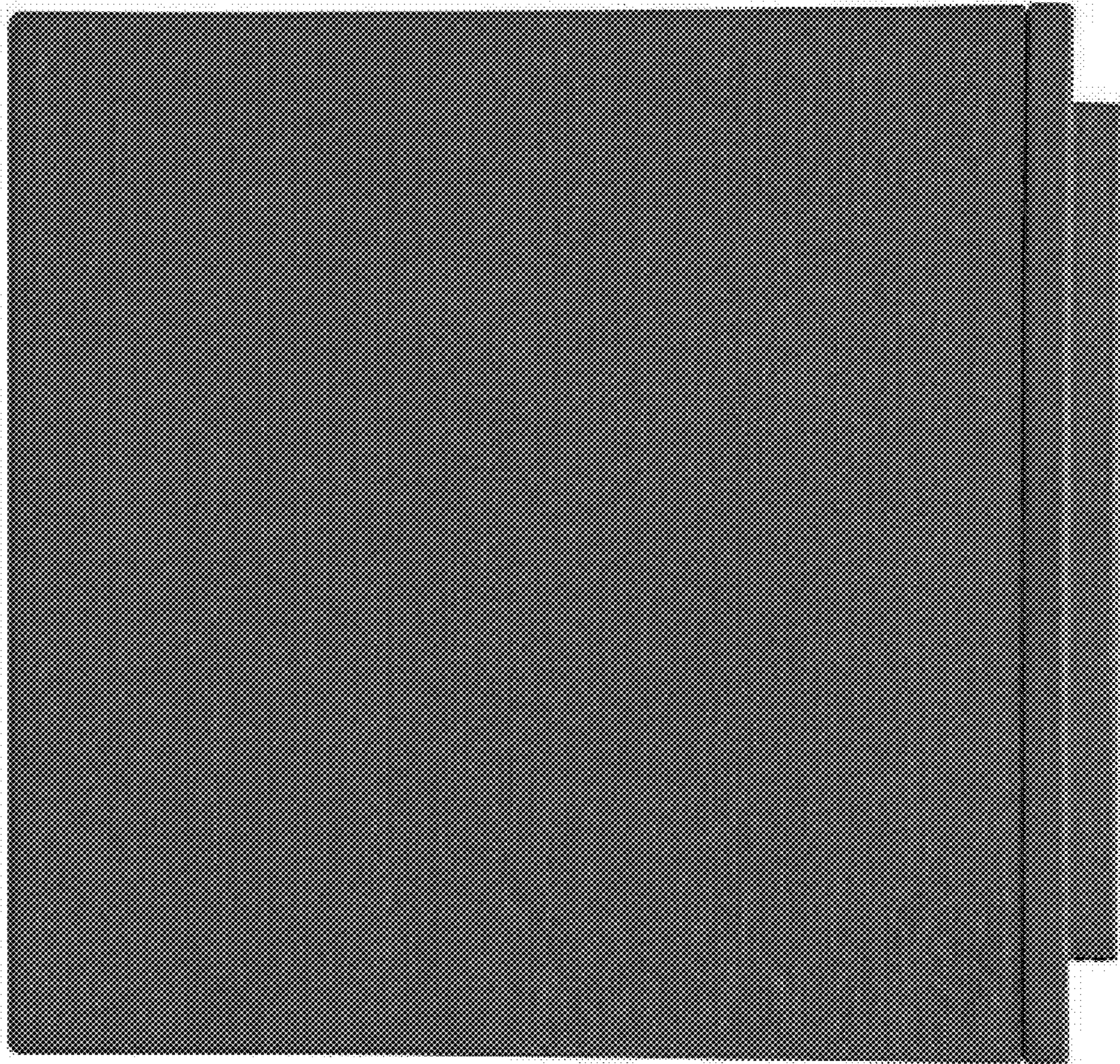

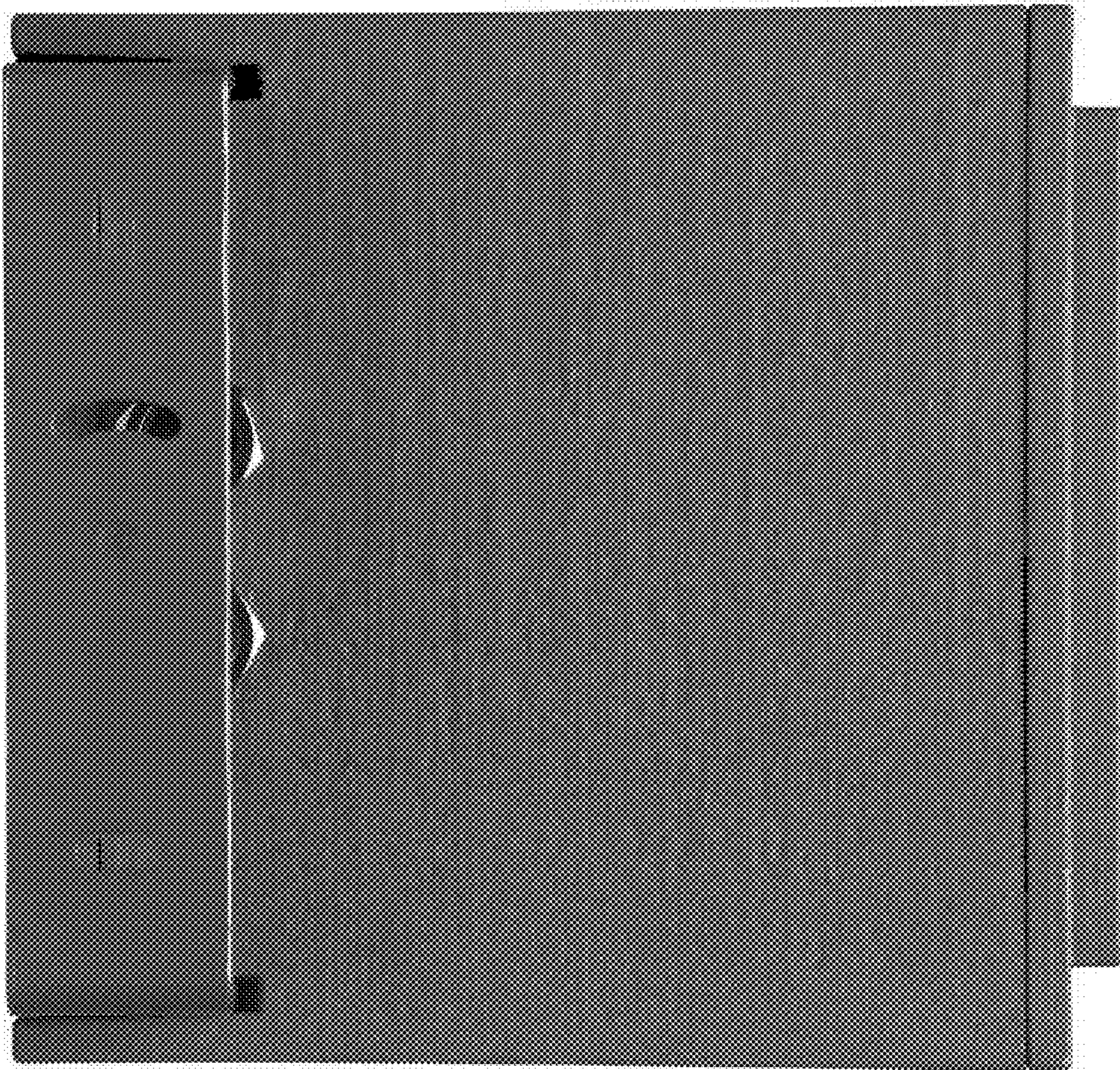

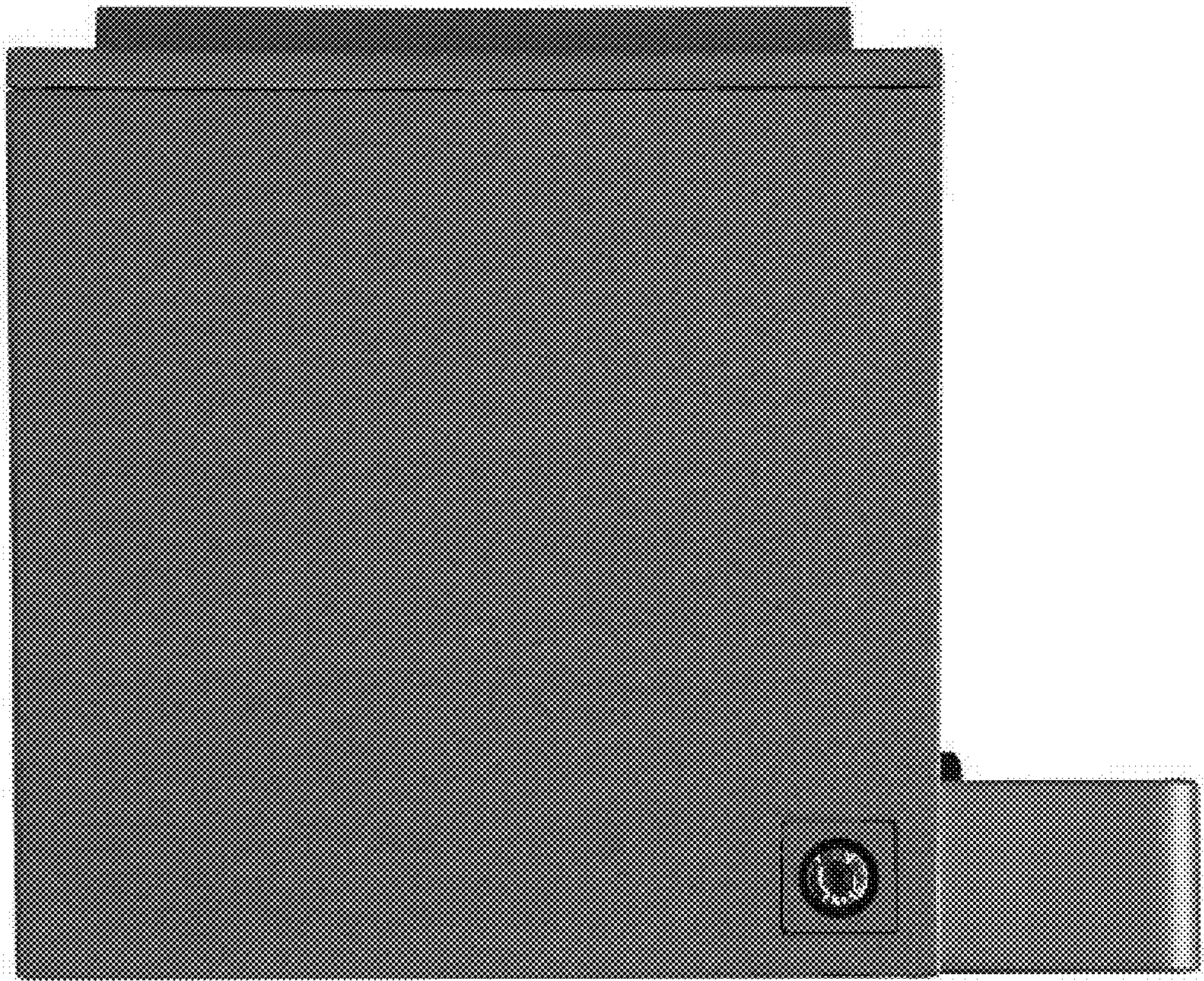
