(57) **CLAIM**

The ornamental design for a helmet face shield, as shown and described above.

DESCRIPTION

FIG. 1 is a perspective view of the helmet face shield according to the present design;
FIG. 2 is a front view of the helmet face shield according to the present design;
FIG. 3 is a rear view of the helmet face shield according to the present design;
FIG. 4 is a right side view of the helmet face shield according to the present design;
FIG. 5 is a left side view of the helmet face shield according to the present design;
FIG. 6 is a top plan view of the helmet face shield according to the present design; and,
FIG. 7 is a bottom plan view of the helmet face shield according to the present design.

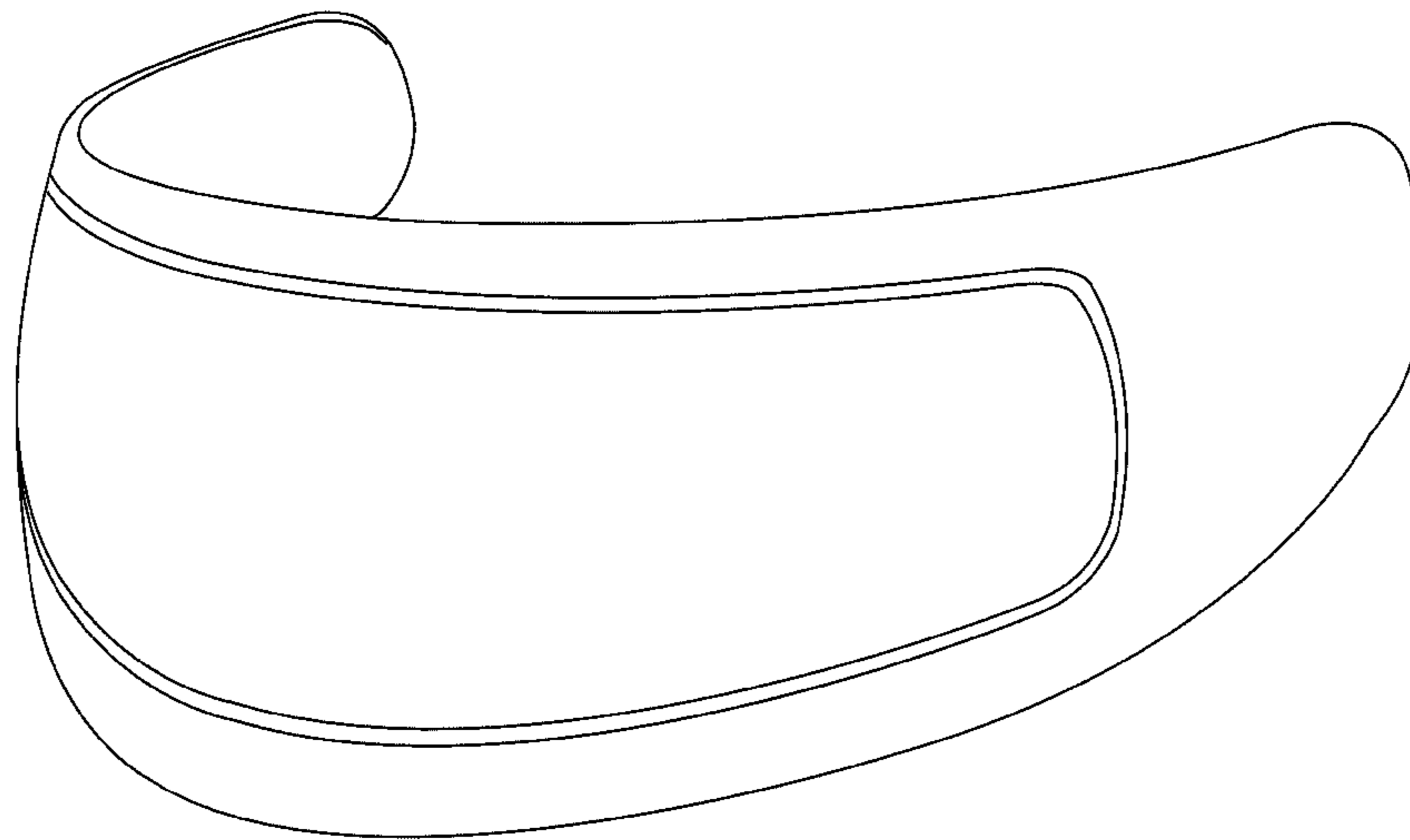

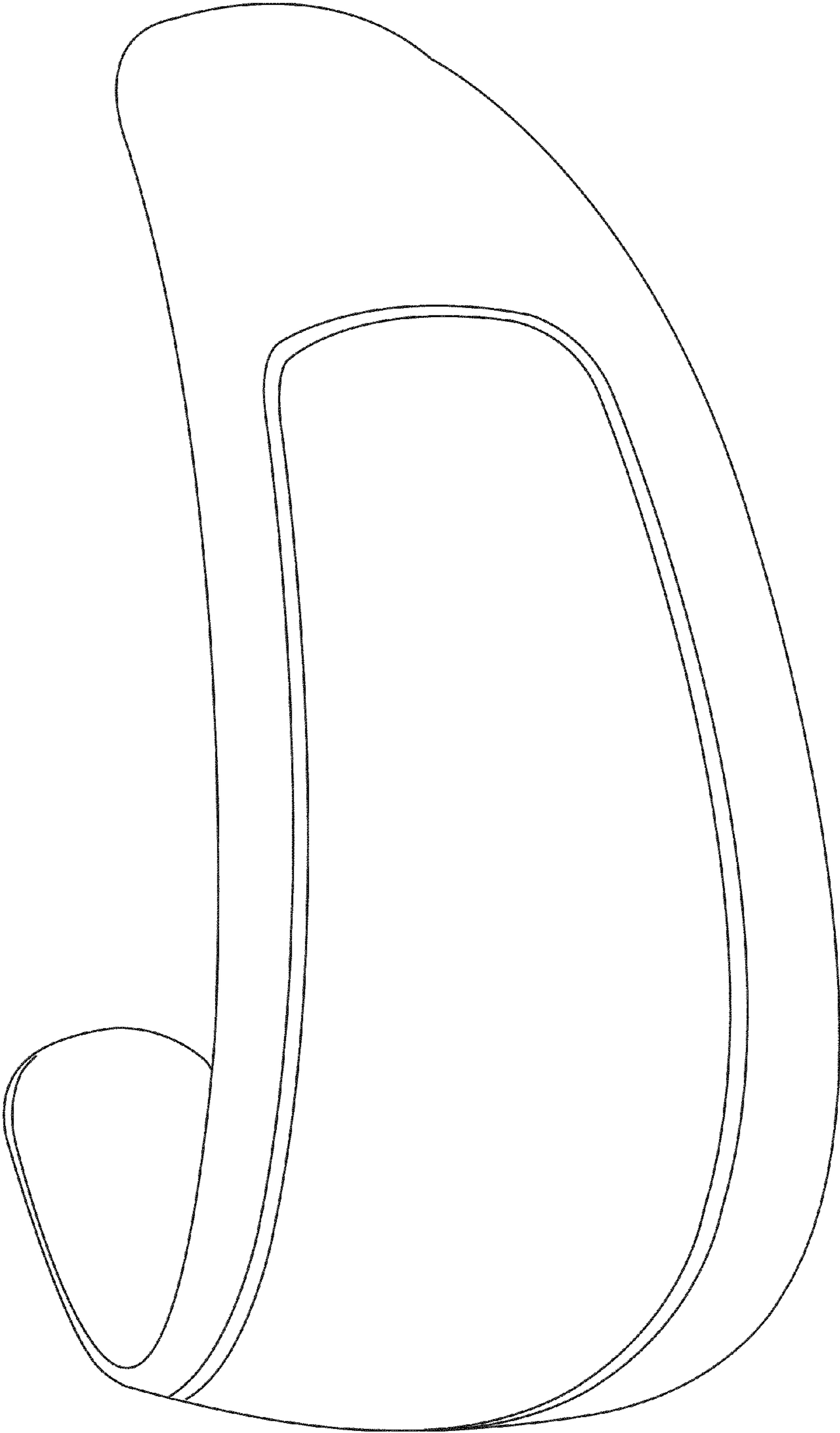

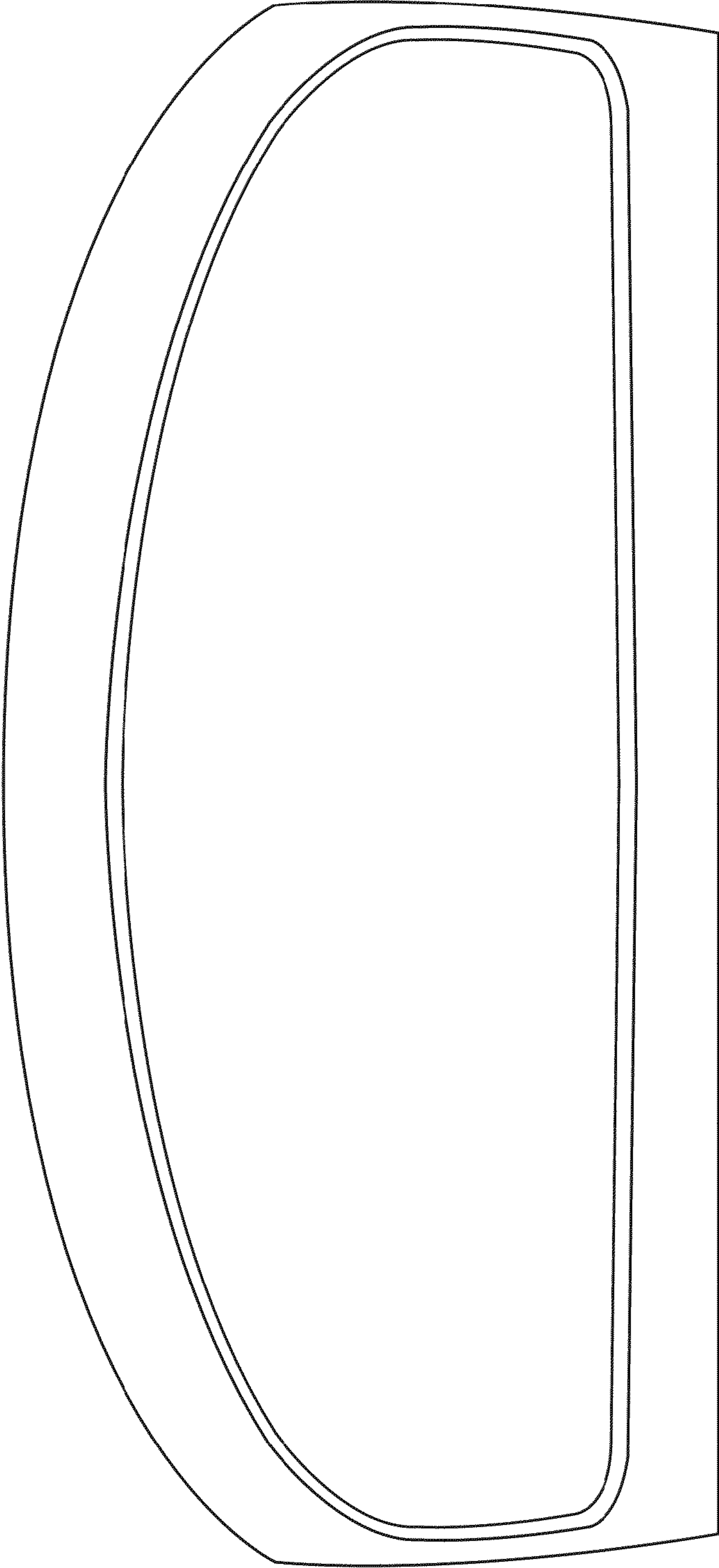

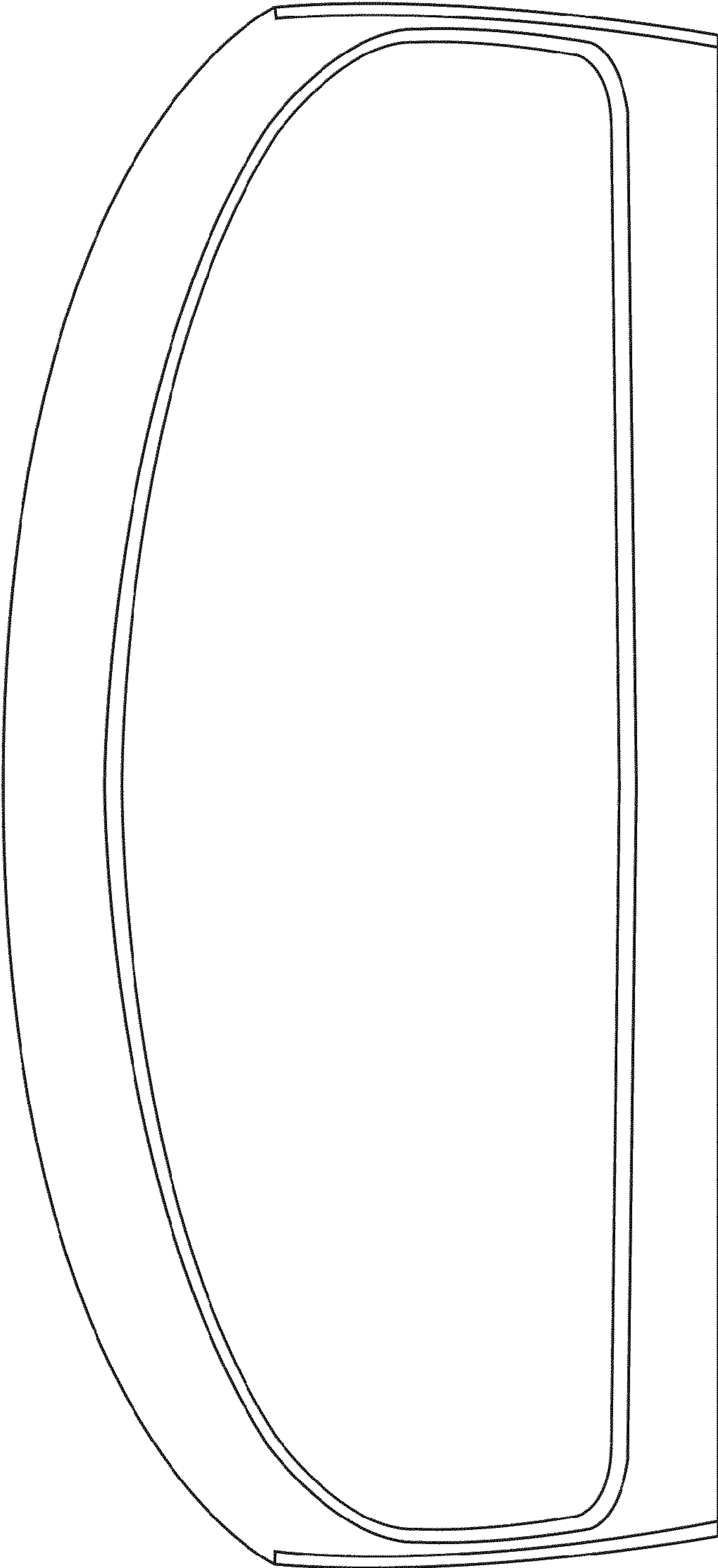

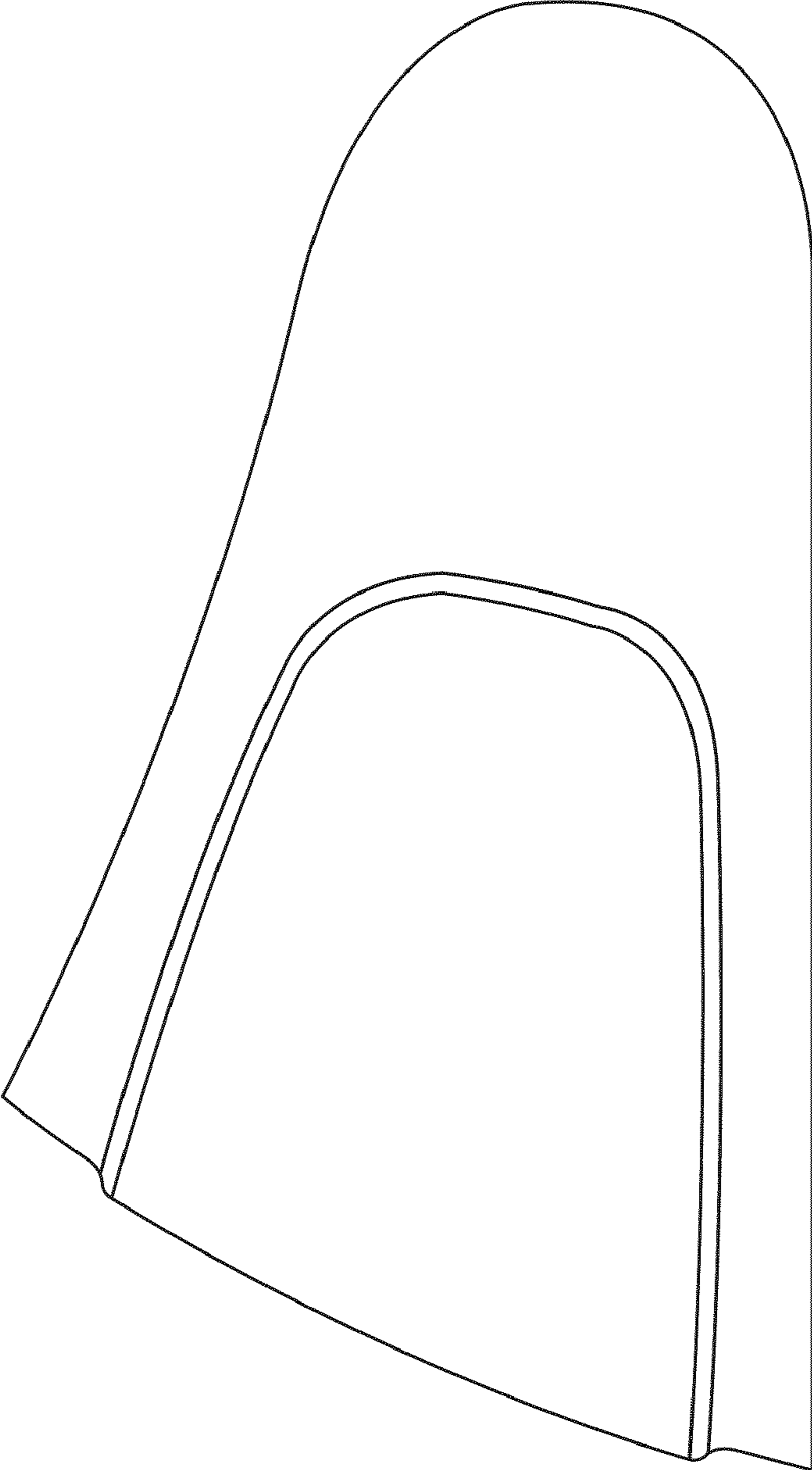
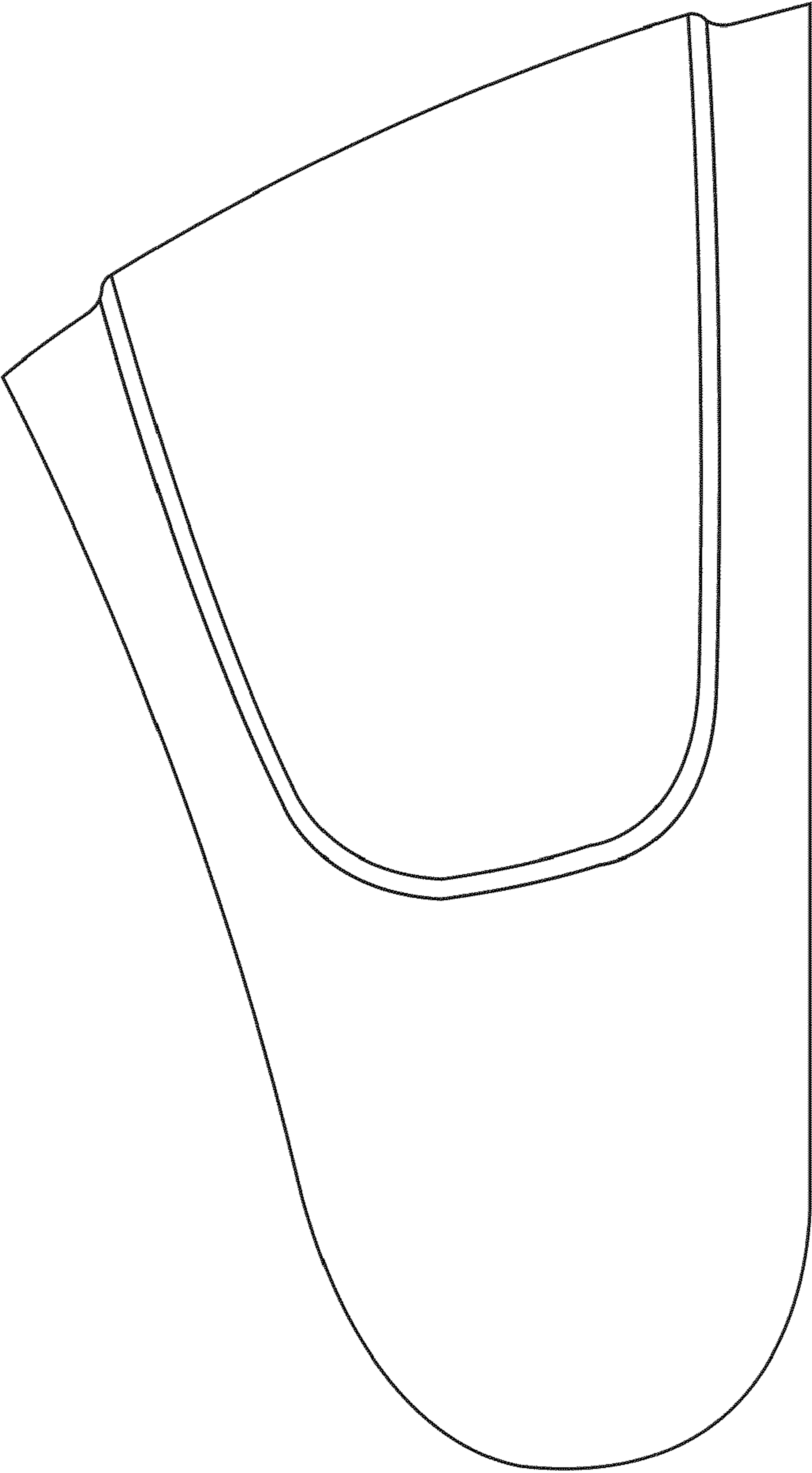

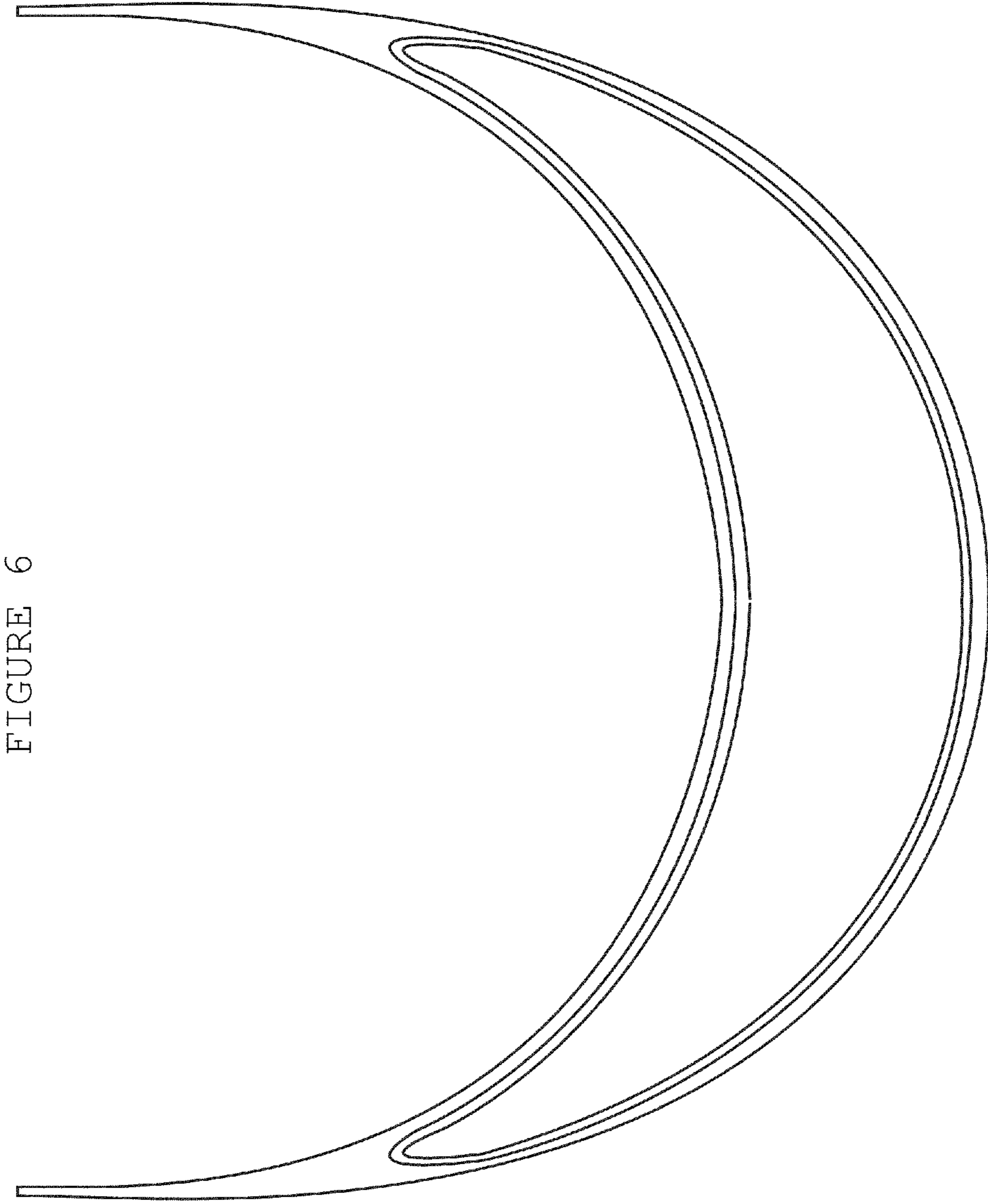
