(57) **CLAIM**

The ornamental design for reflective scarf, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the reflective scarf of the present invention.

FIG. 2 is an enlarged cross-sectional view taken along Line 2-2 of FIG. 1.

FIG. 3A is an enlarged left side elevation view of half of the invention of FIG. 1.

FIG. 3B is an enlarged left side elevation view of the other half of the invention of FIG. 1.

FIG. 4A is an enlarged right side elevation view of half of the invention of FIG. 1.

FIG. 4B is an enlarged right side elevation view of the other half of the invention of FIG. 1.

FIG. 5 is an enlarged front elevation view thereof.

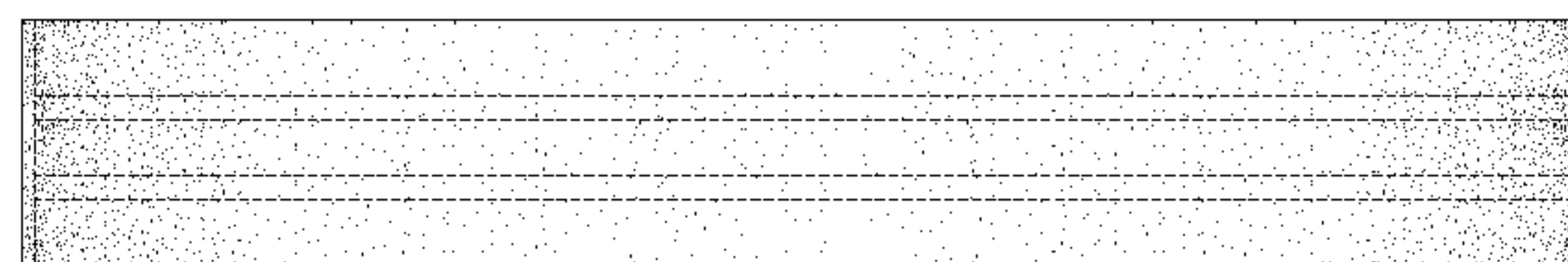
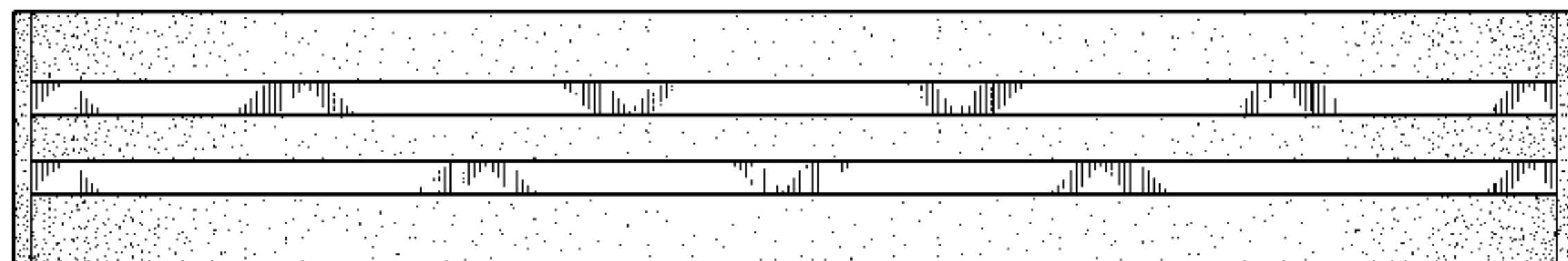
FIG. 6 is an enlarged rear elevation view thereof.

FIG. 8 is a bottom plan view thereof.

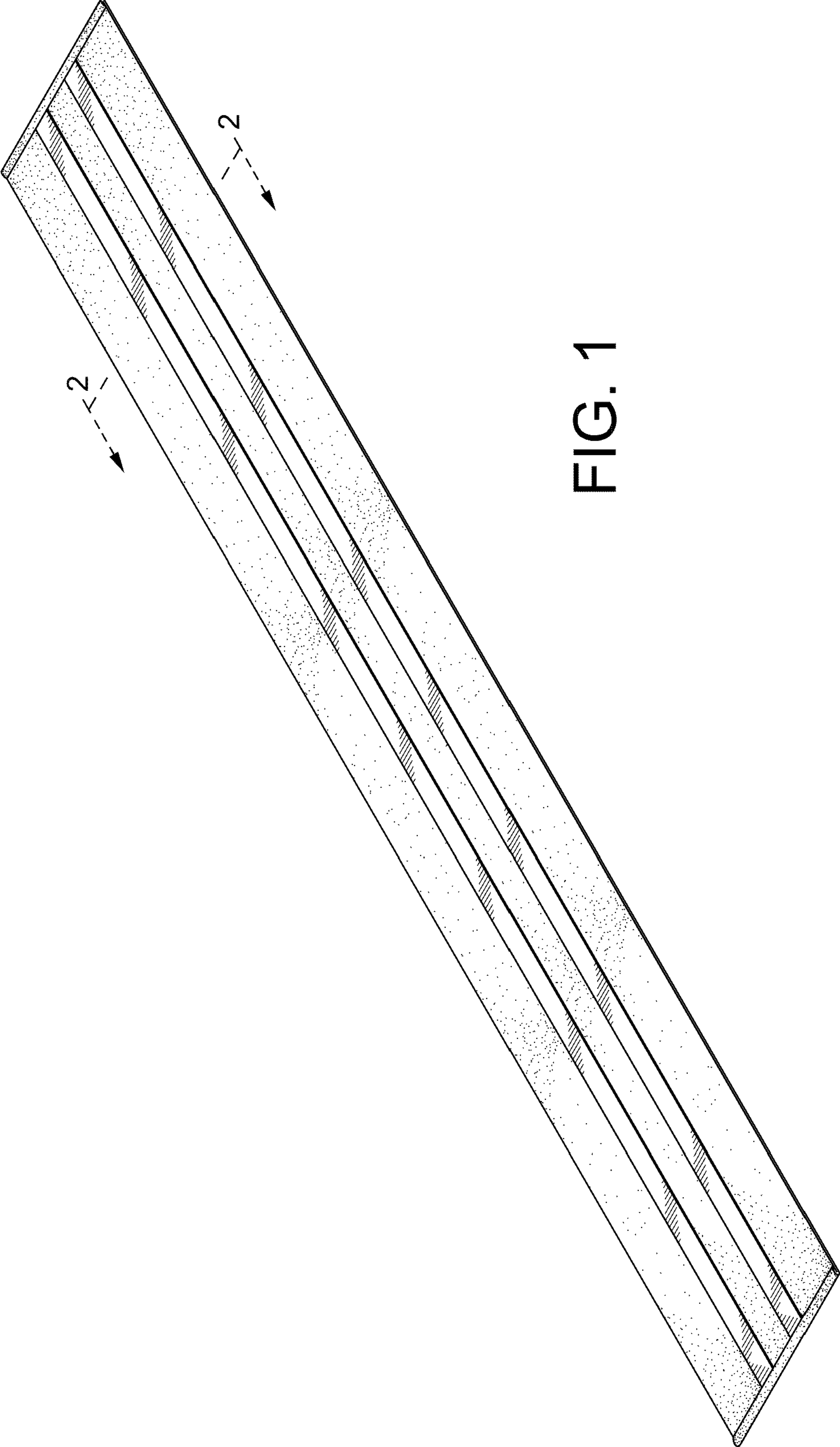

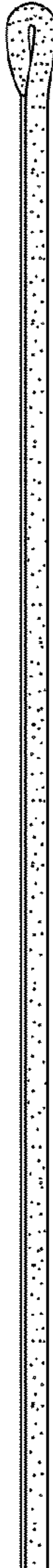

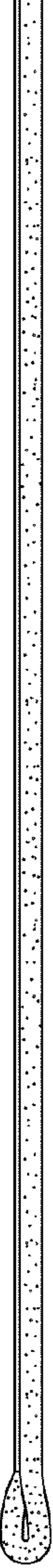

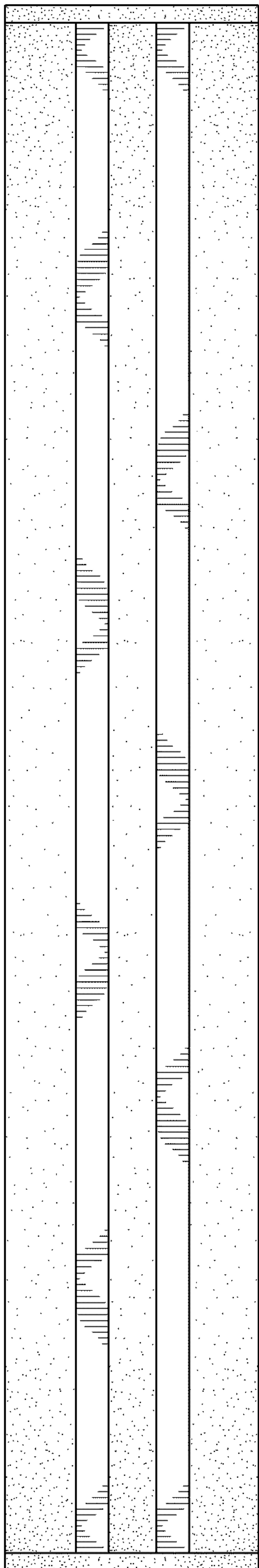

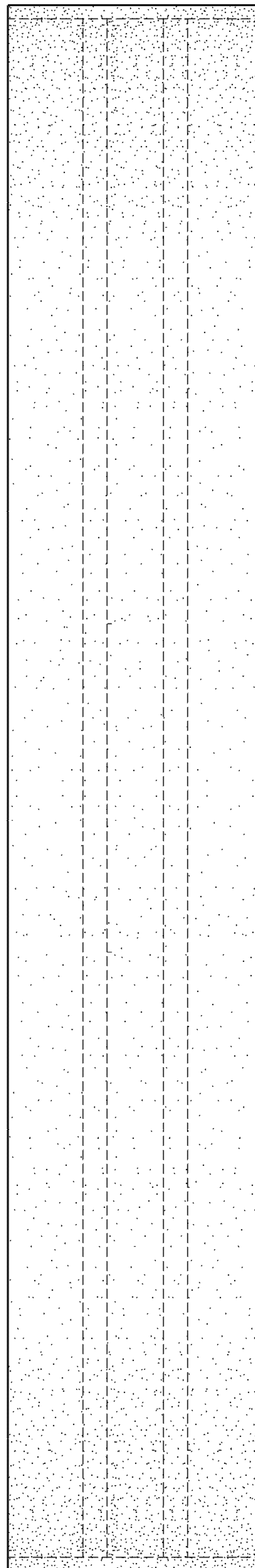
