**DESCRIPTION**

FIG. 9 is a right side view of the alternative embodiment of the footwear shown in FIG. 7;

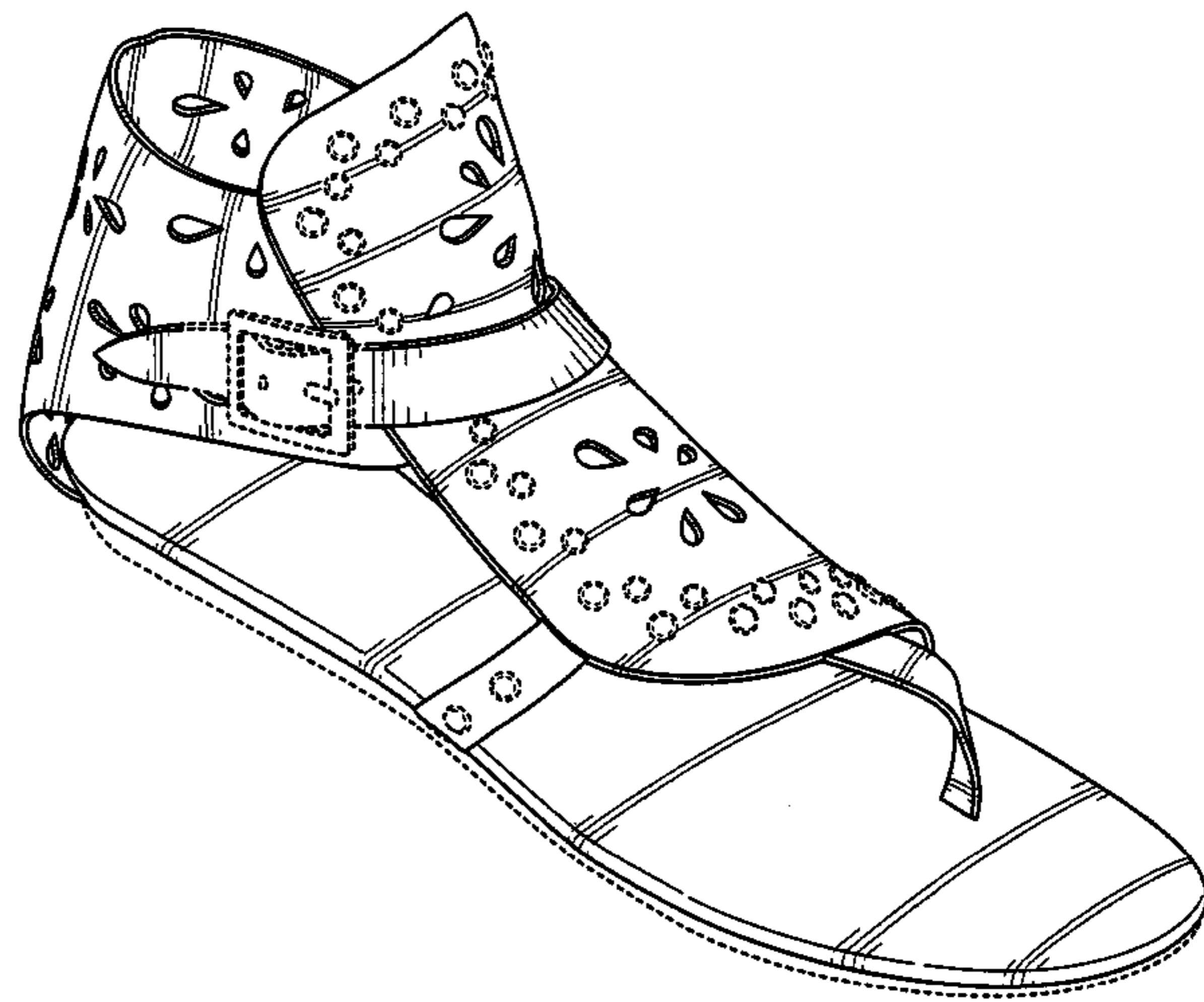
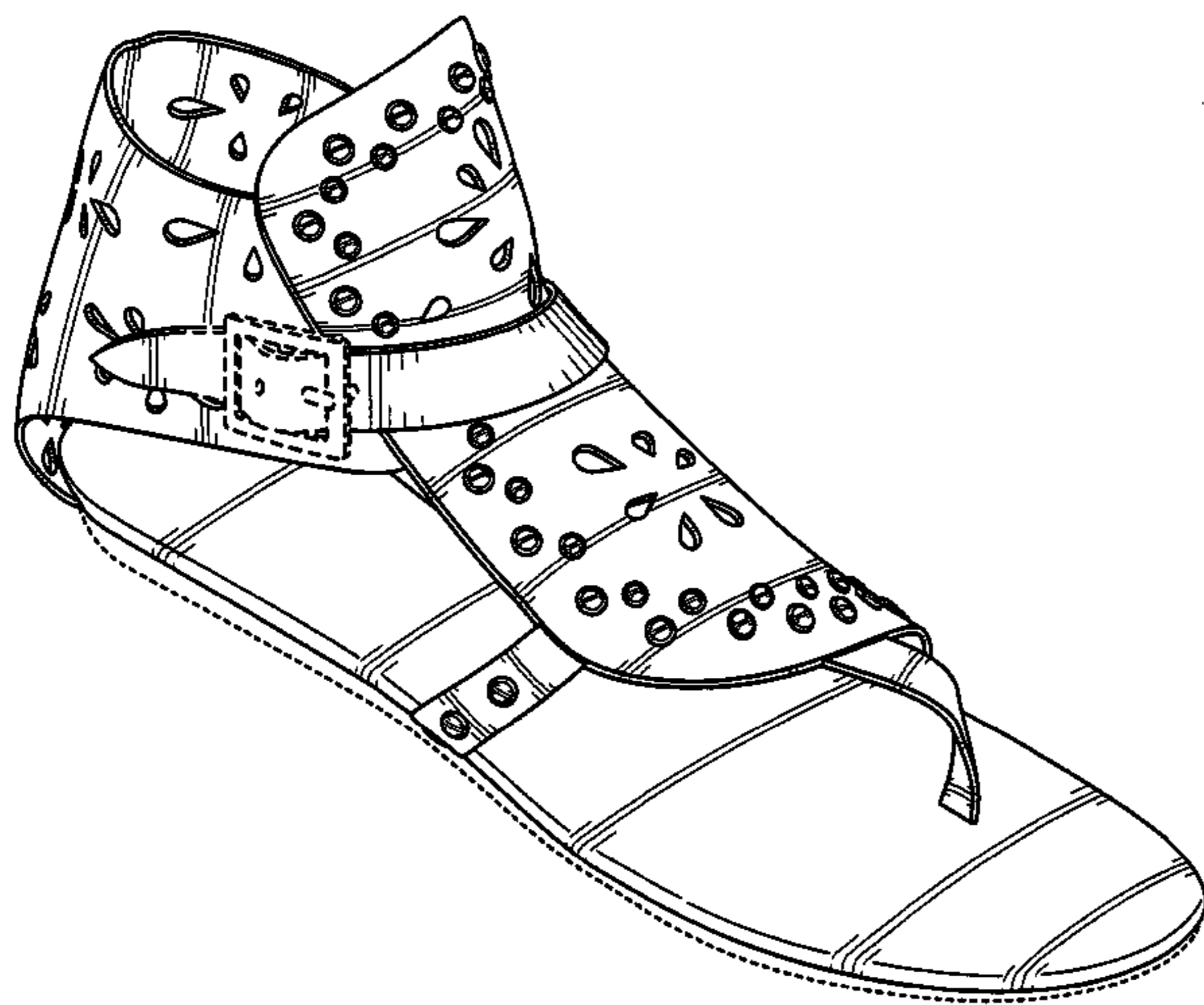
FIG. 10 is a front view of the alternative embodiment of the footwear shown in FIG. 7;

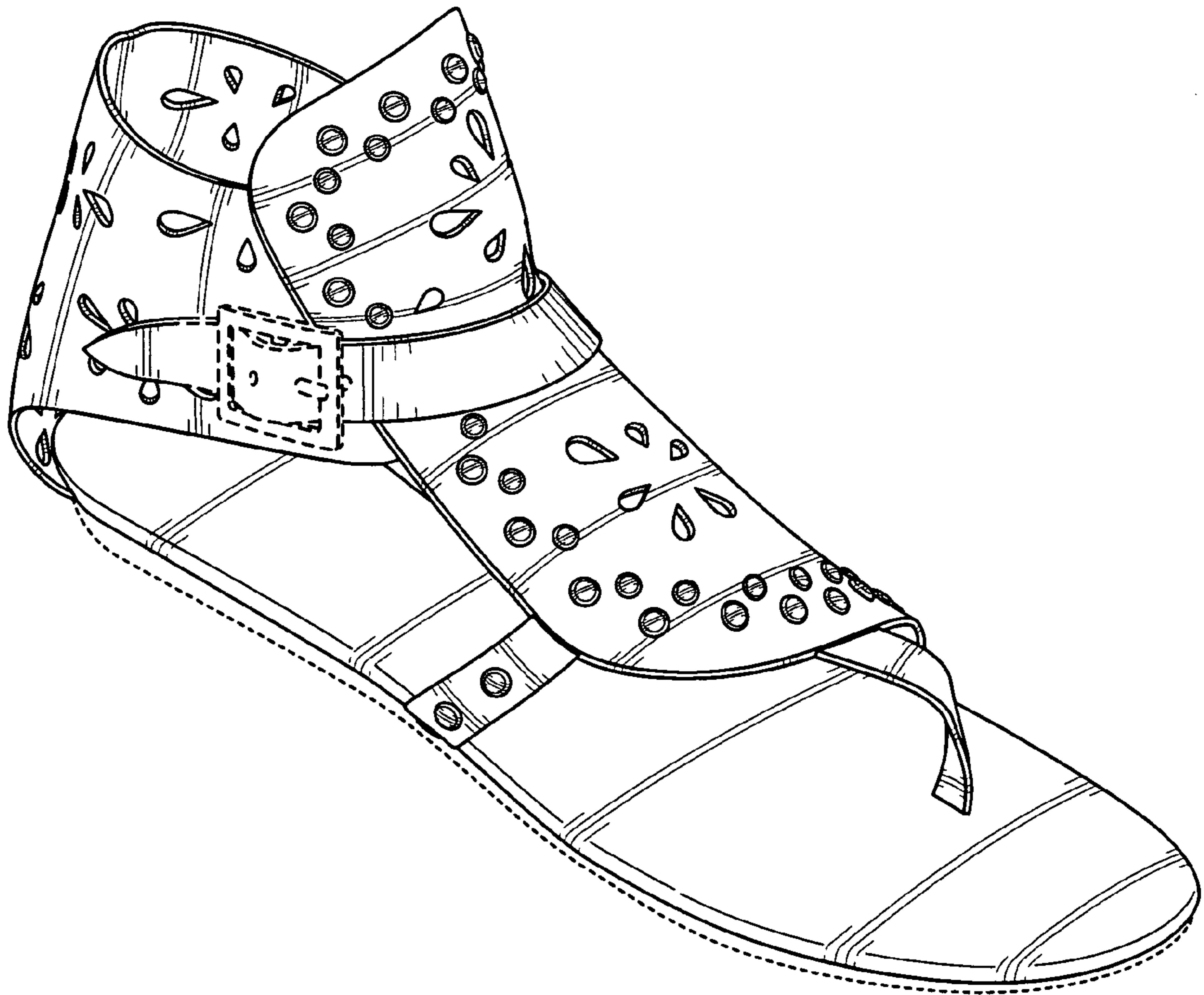

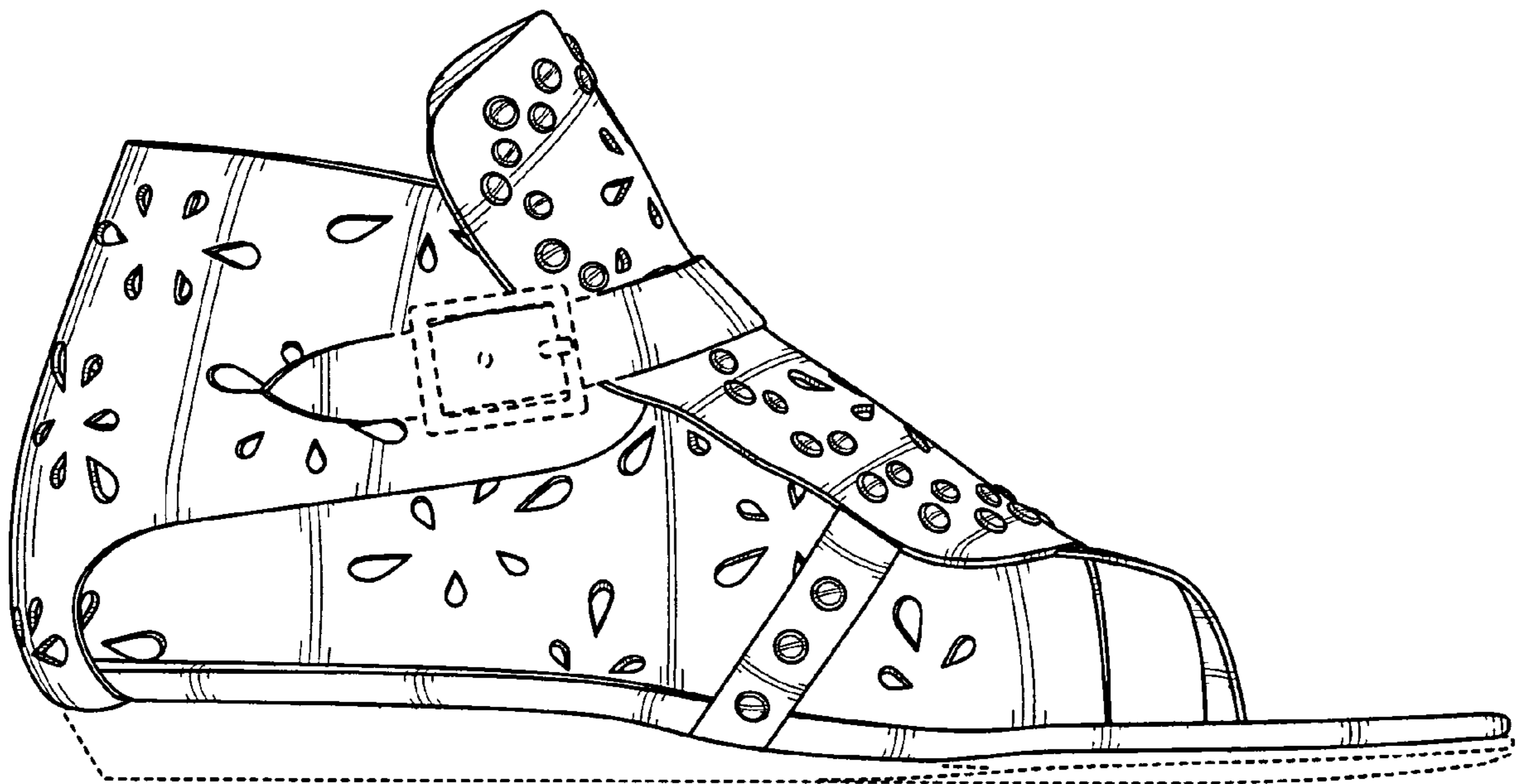

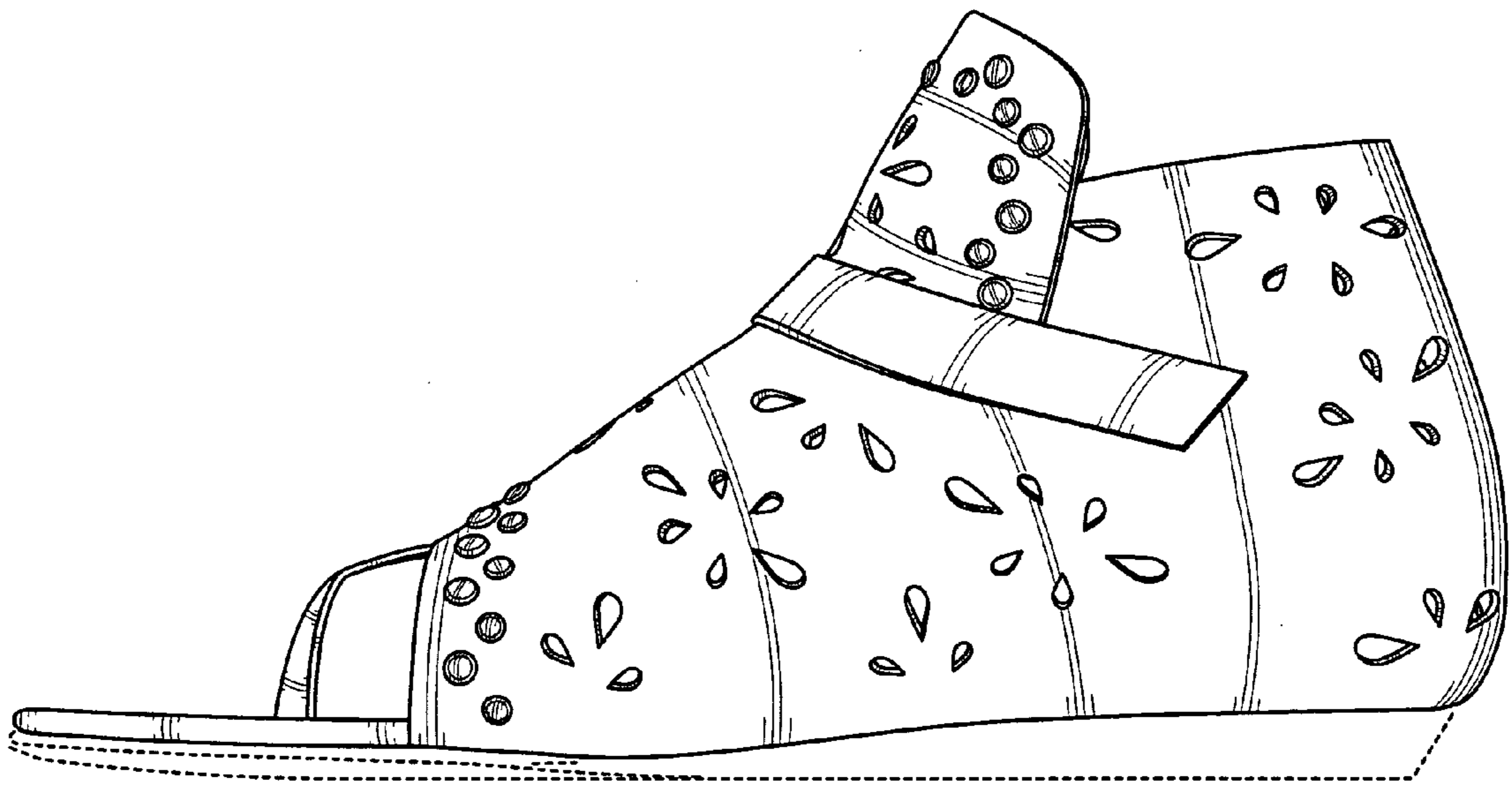

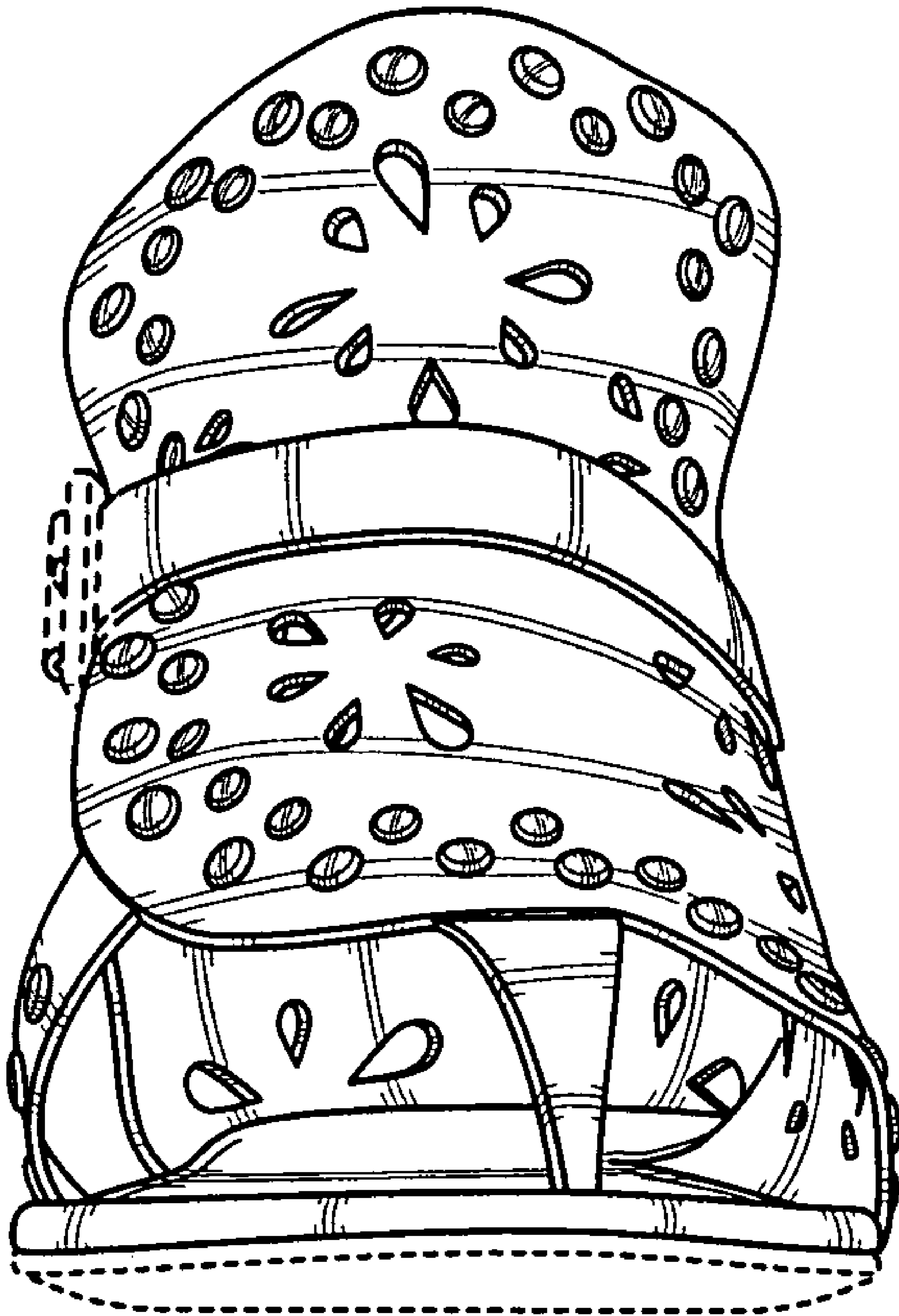

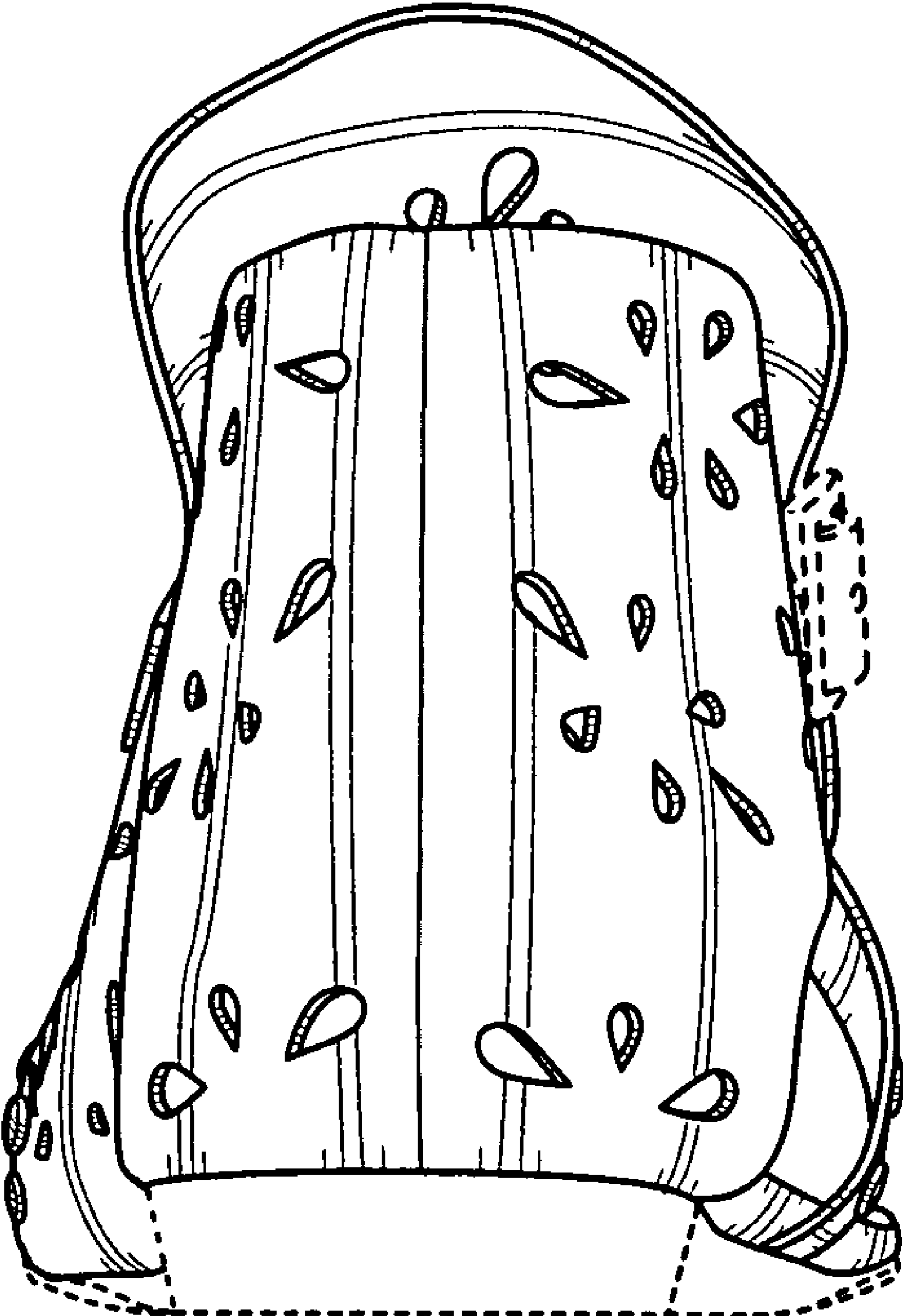

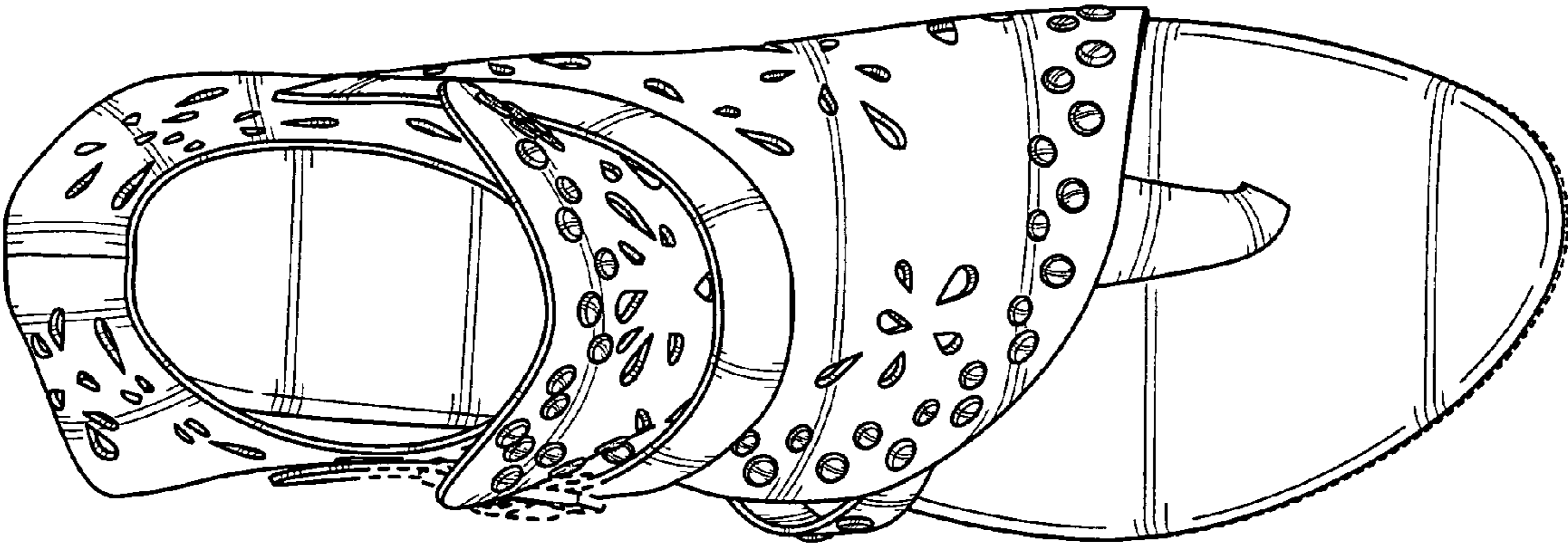

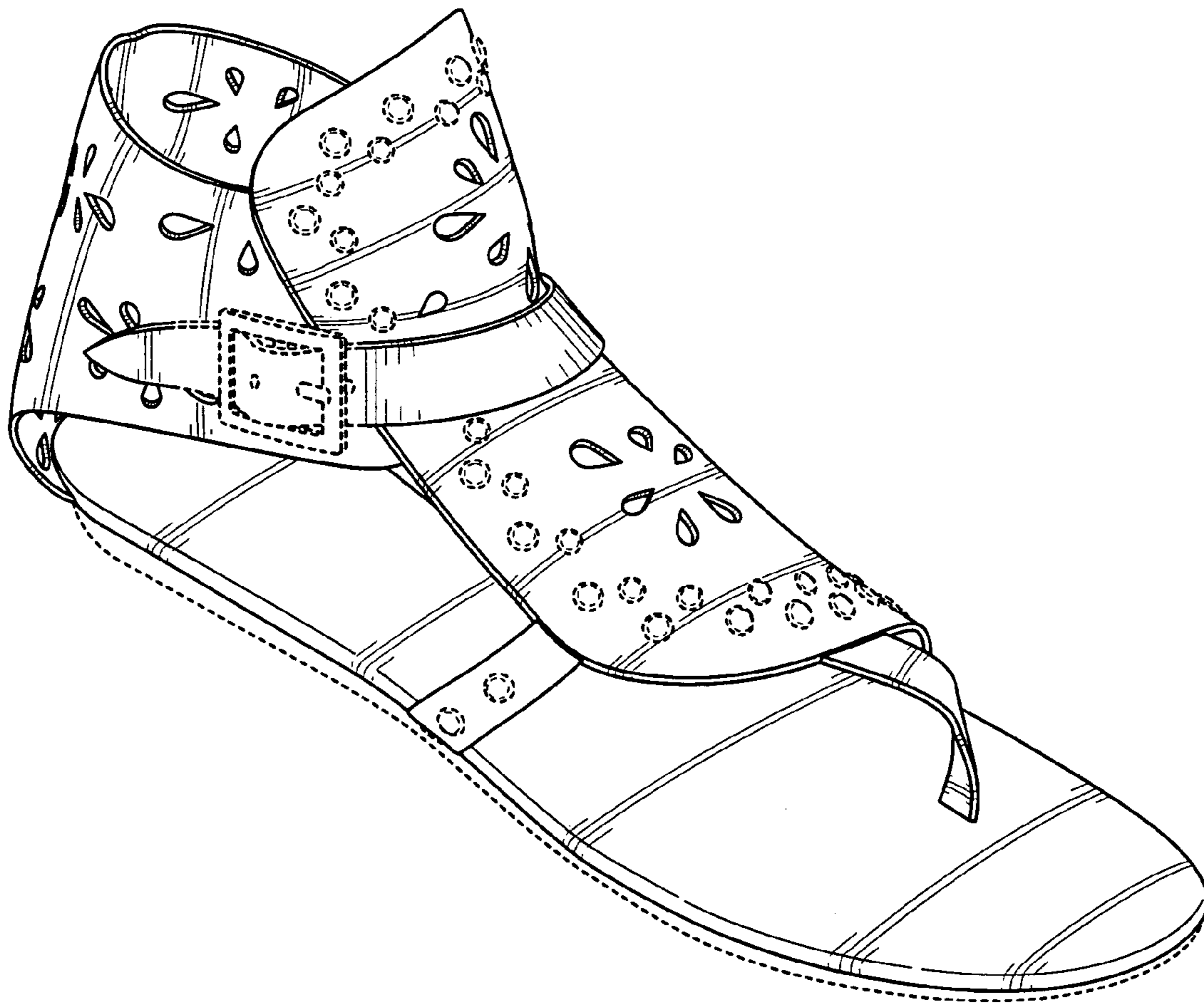

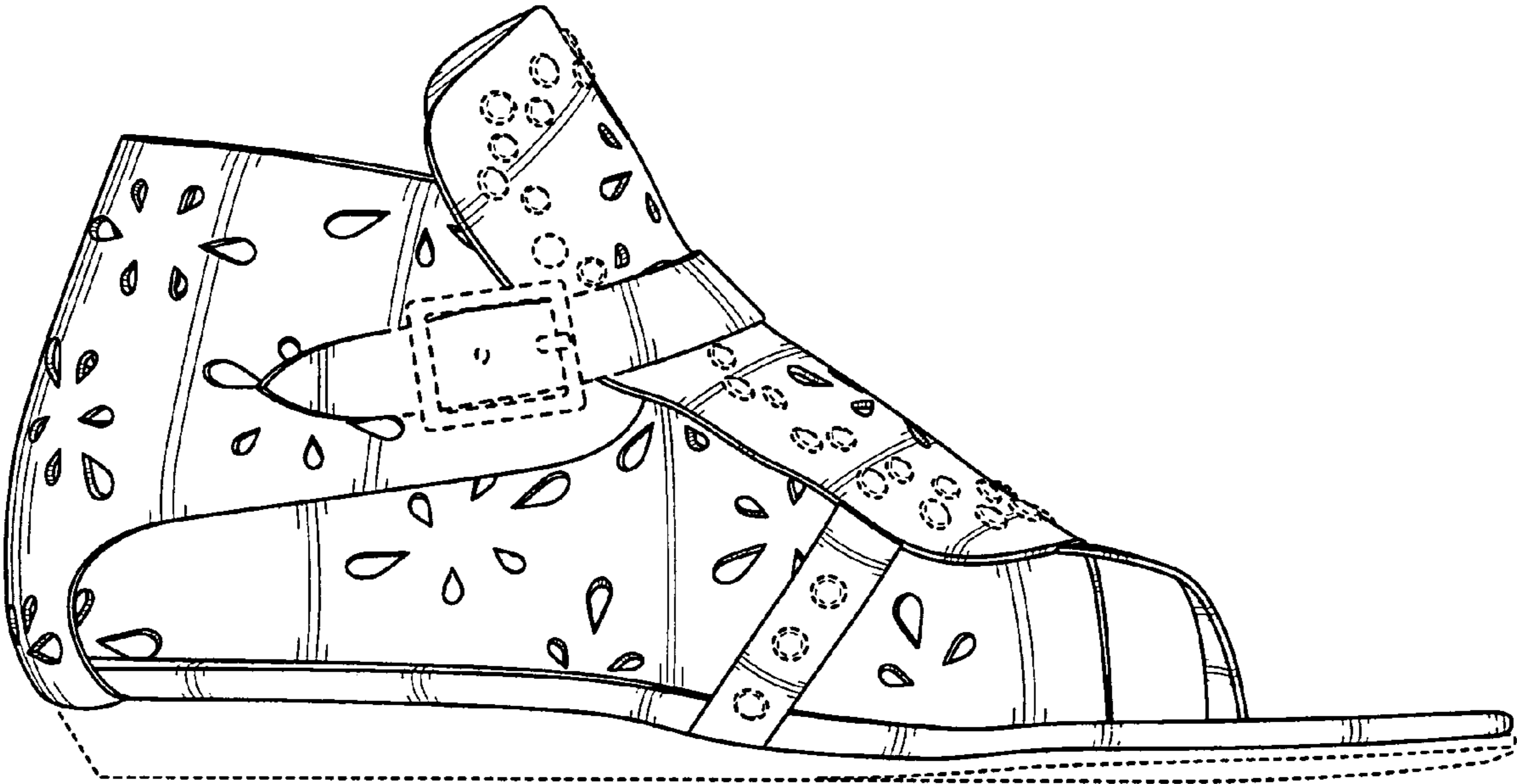

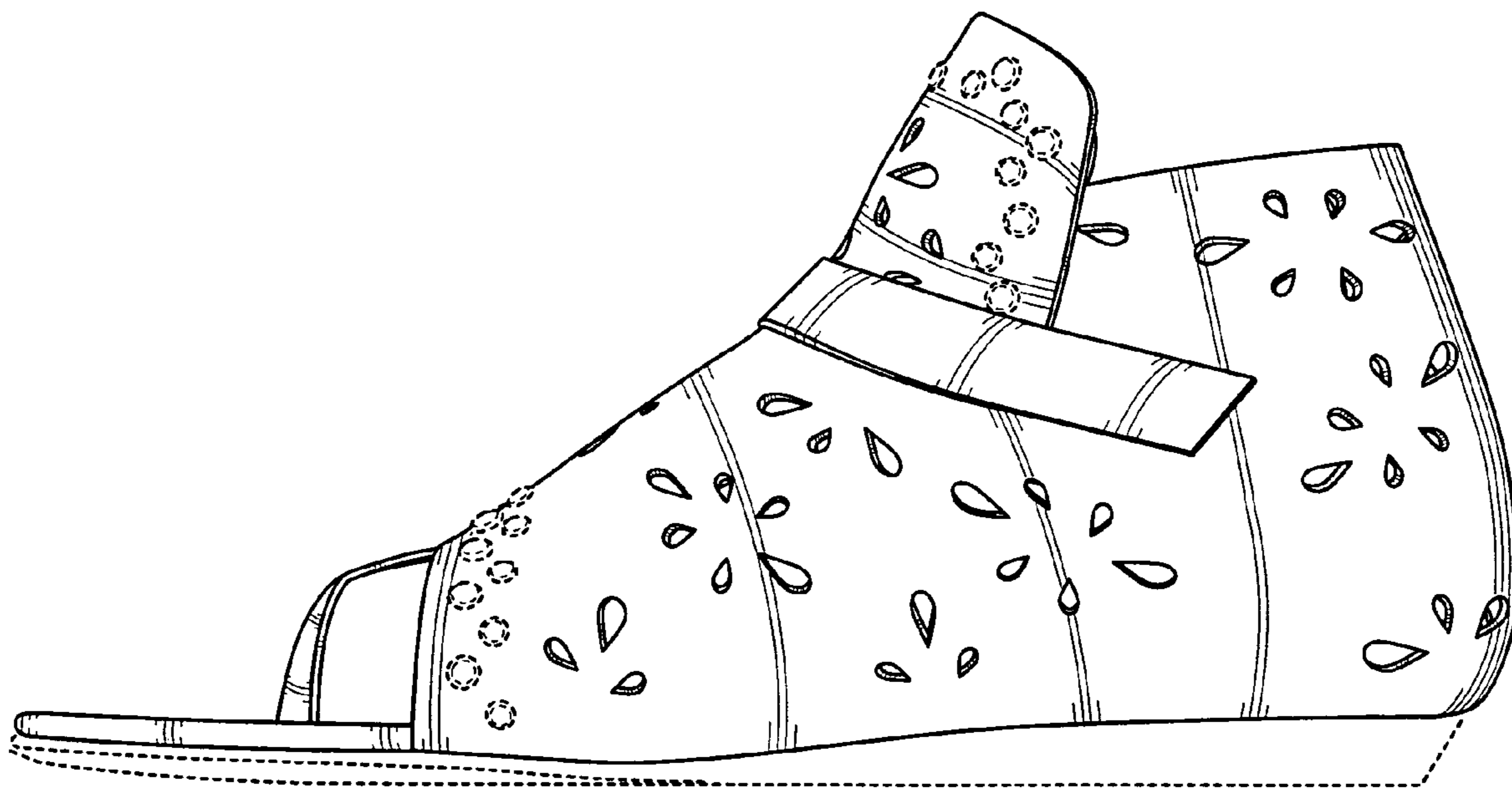

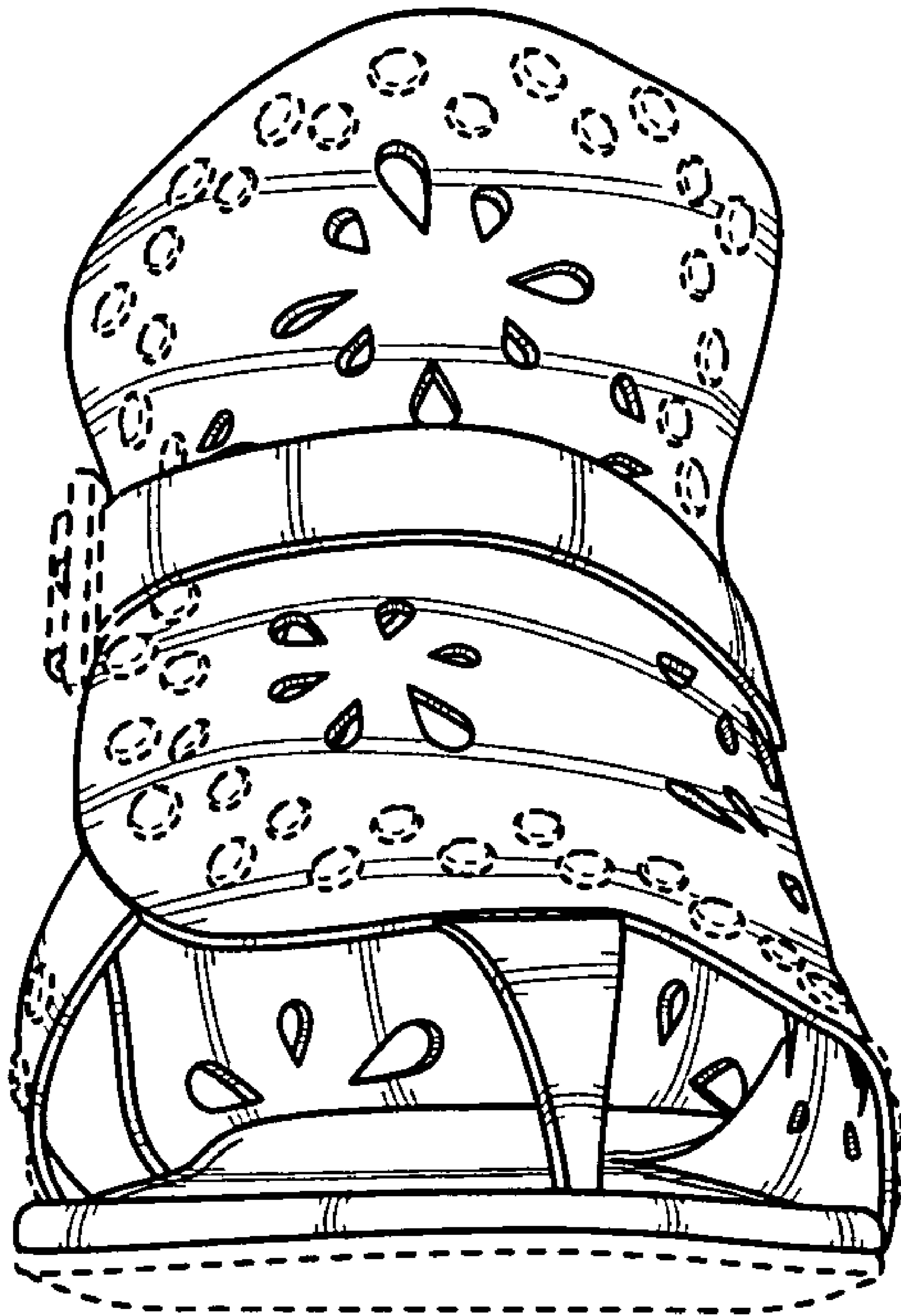

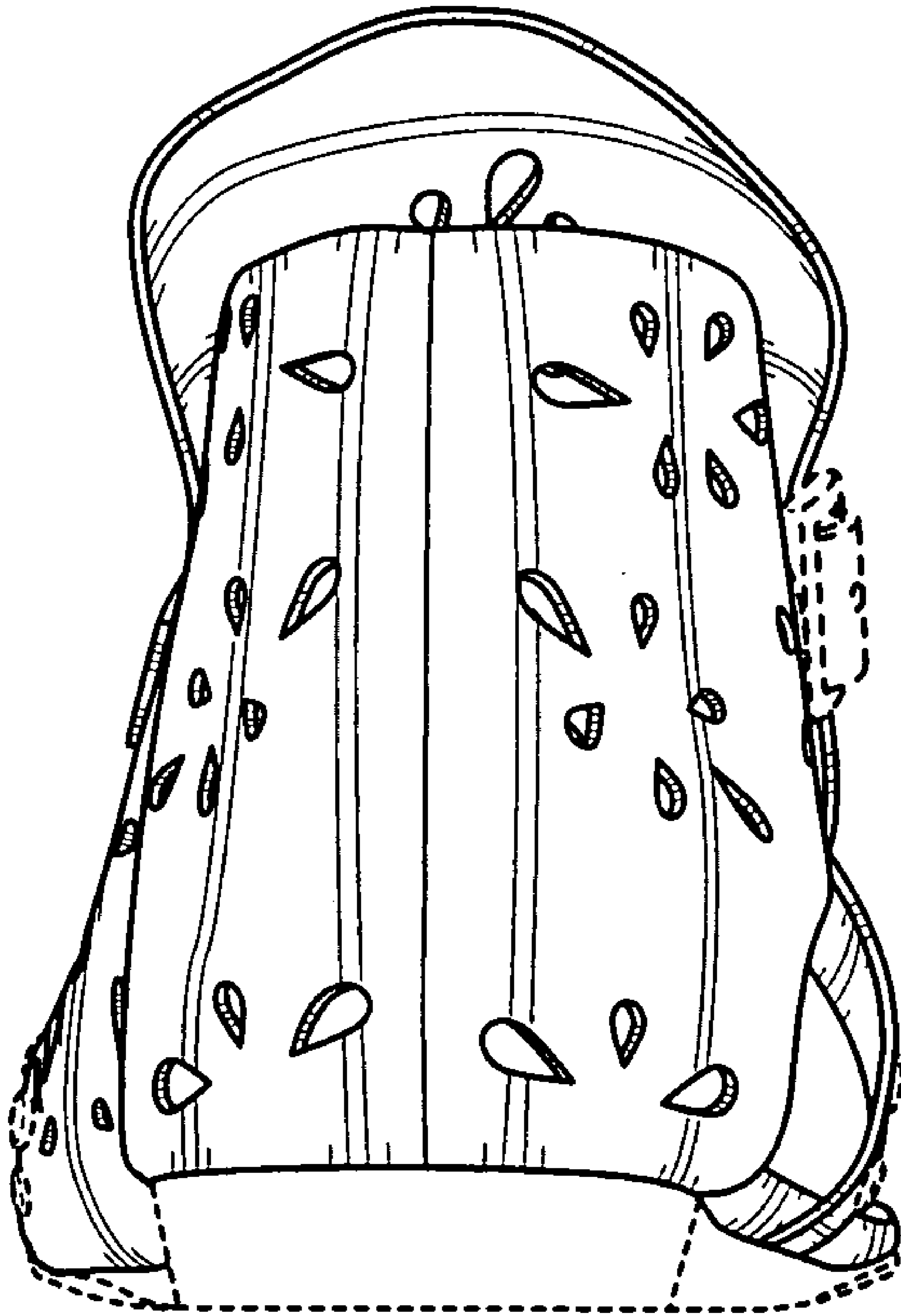

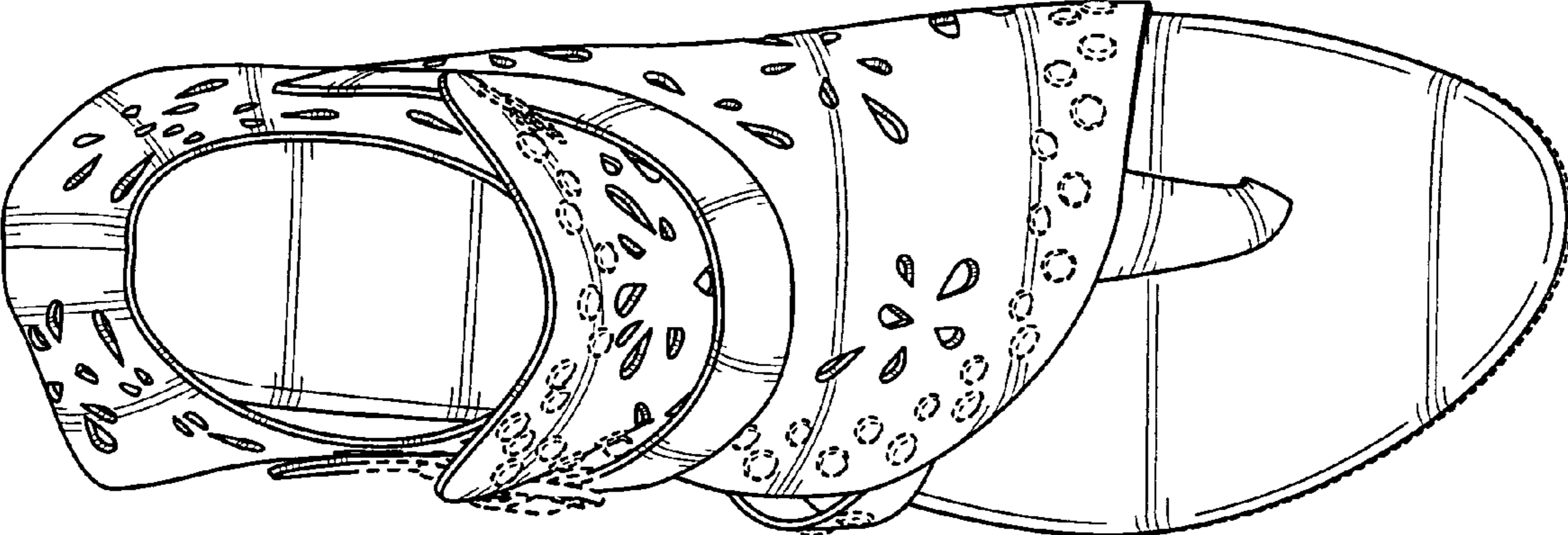
