DESCRIPTION

FIG. 1 is a right perspective view of a clog with a decorative foxing showing the new design;

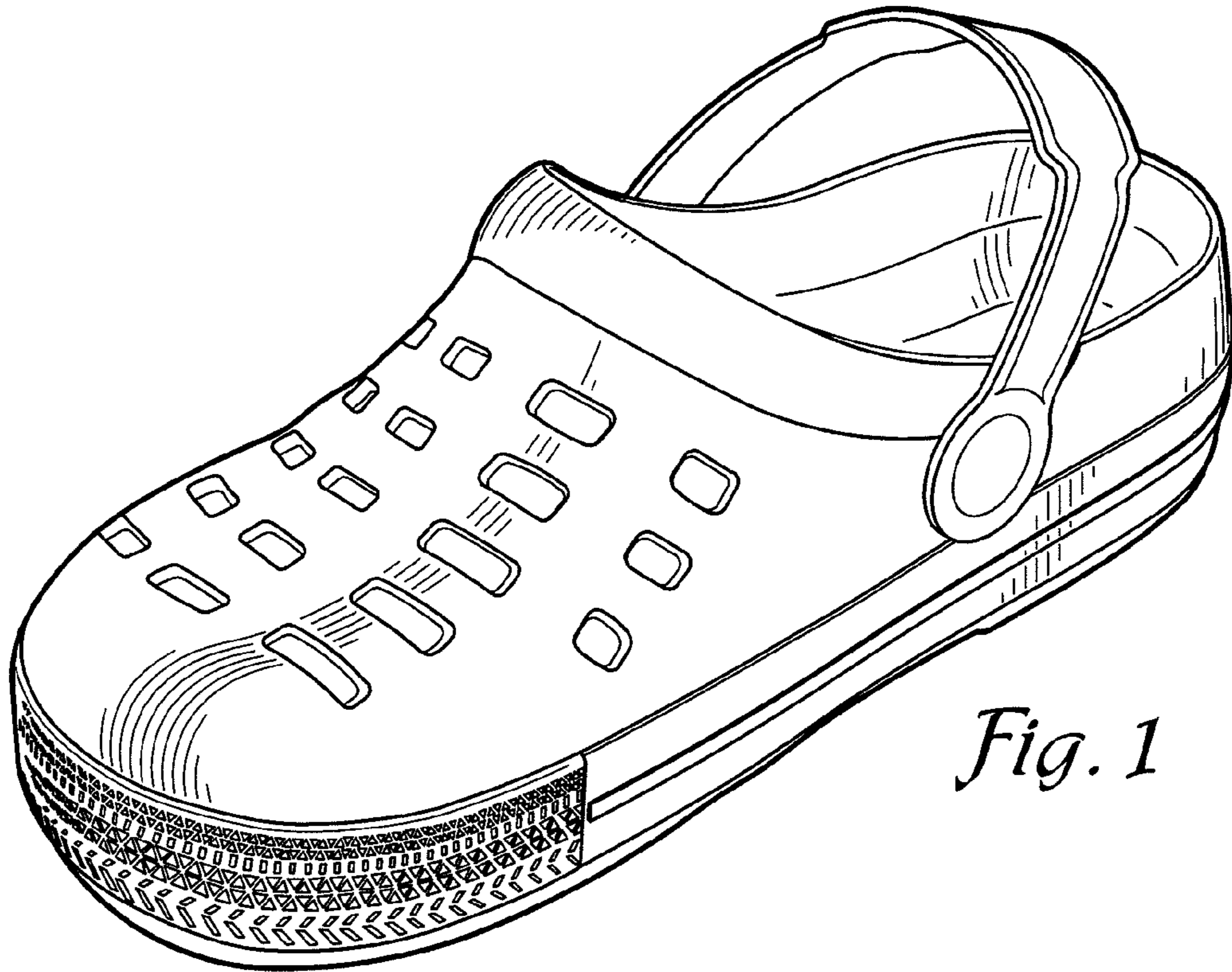

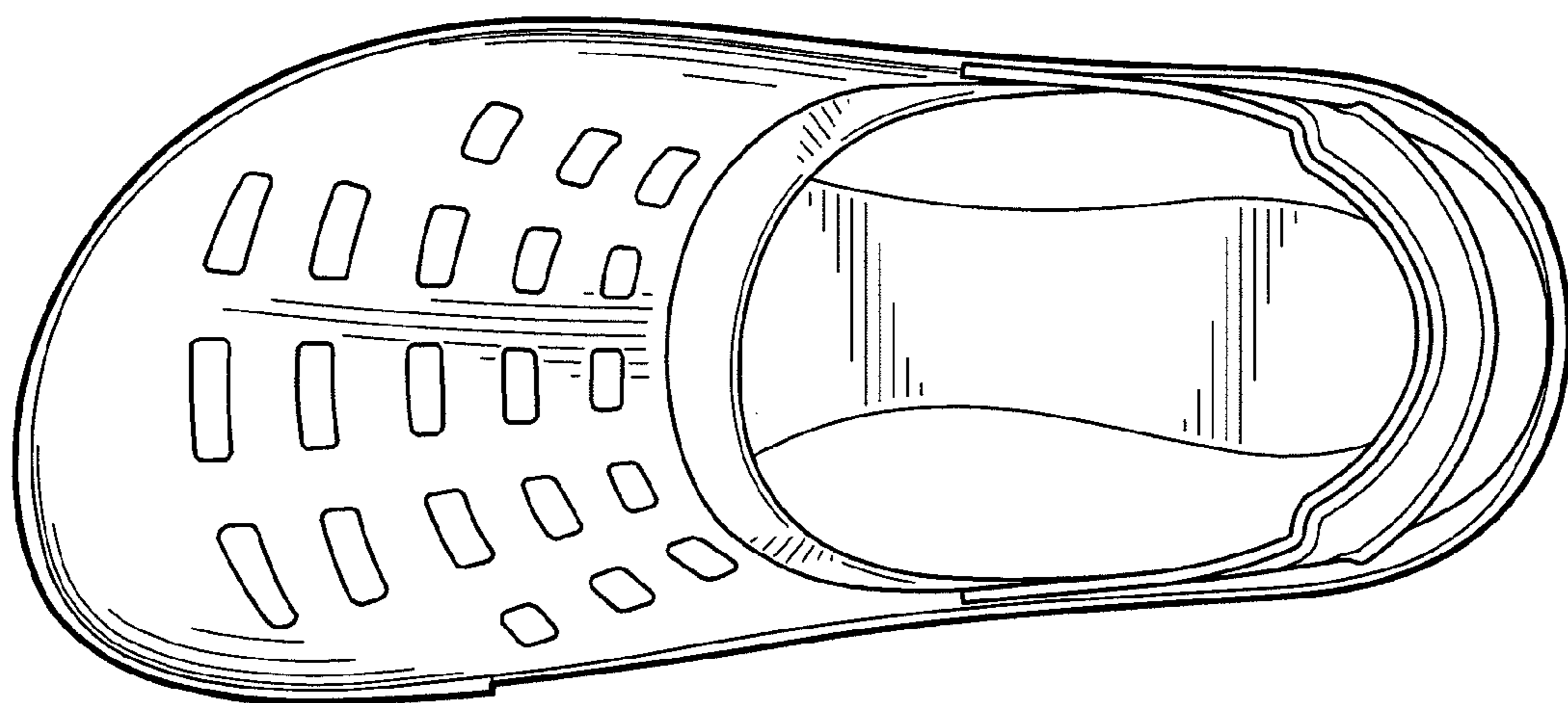

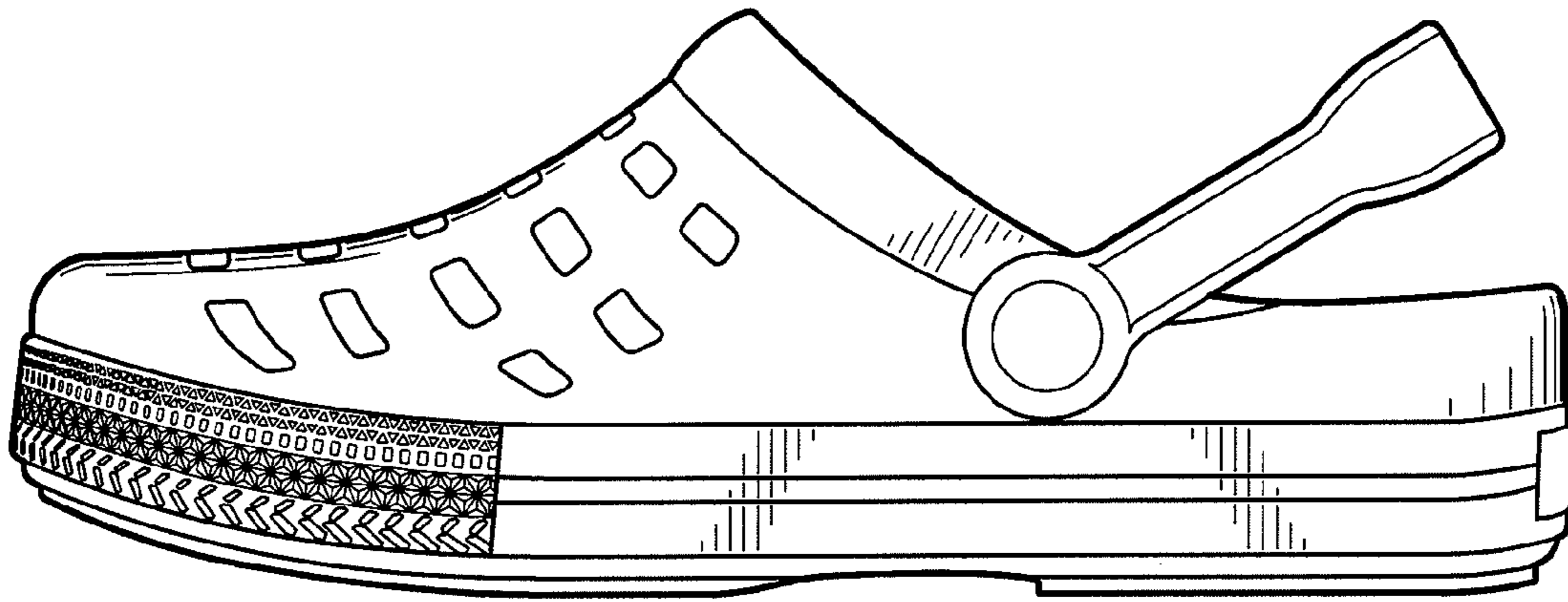

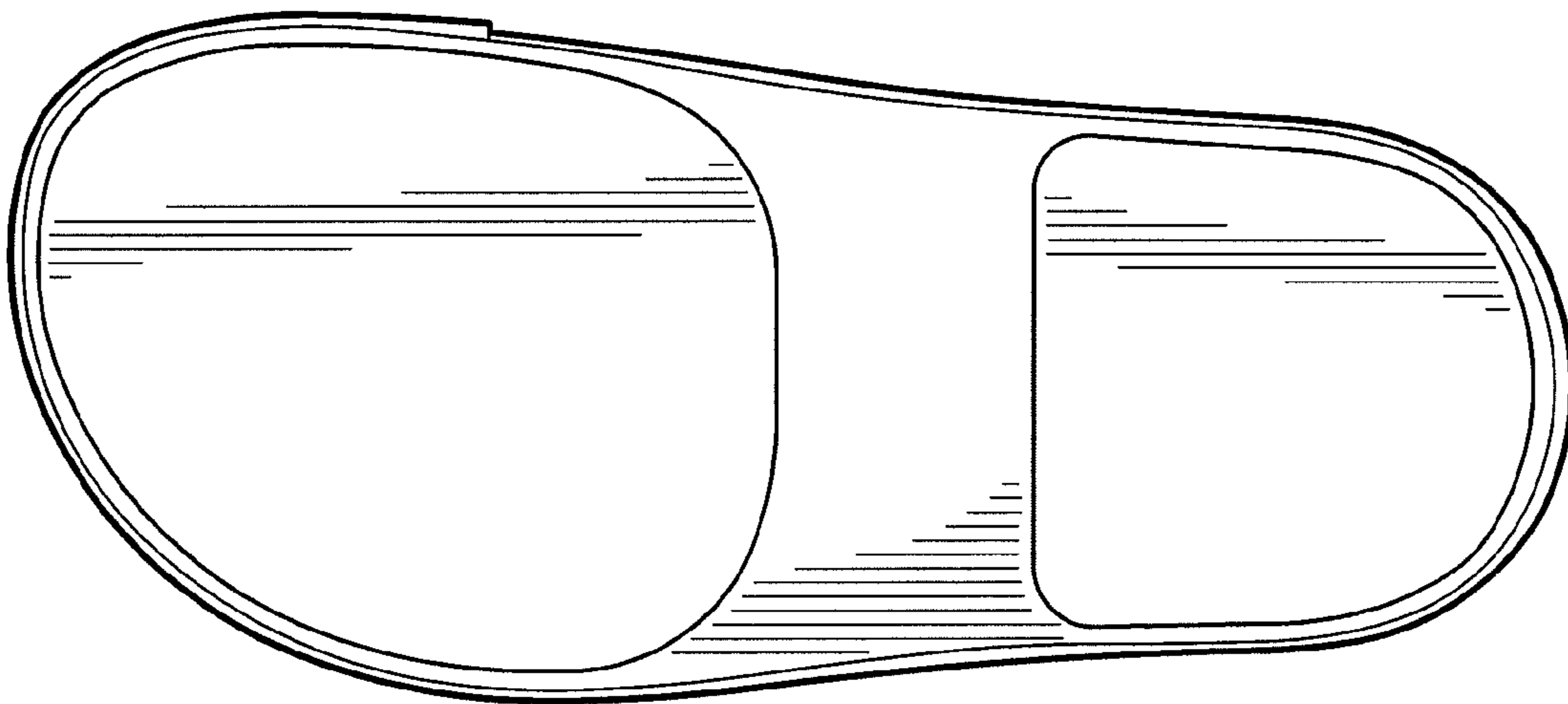

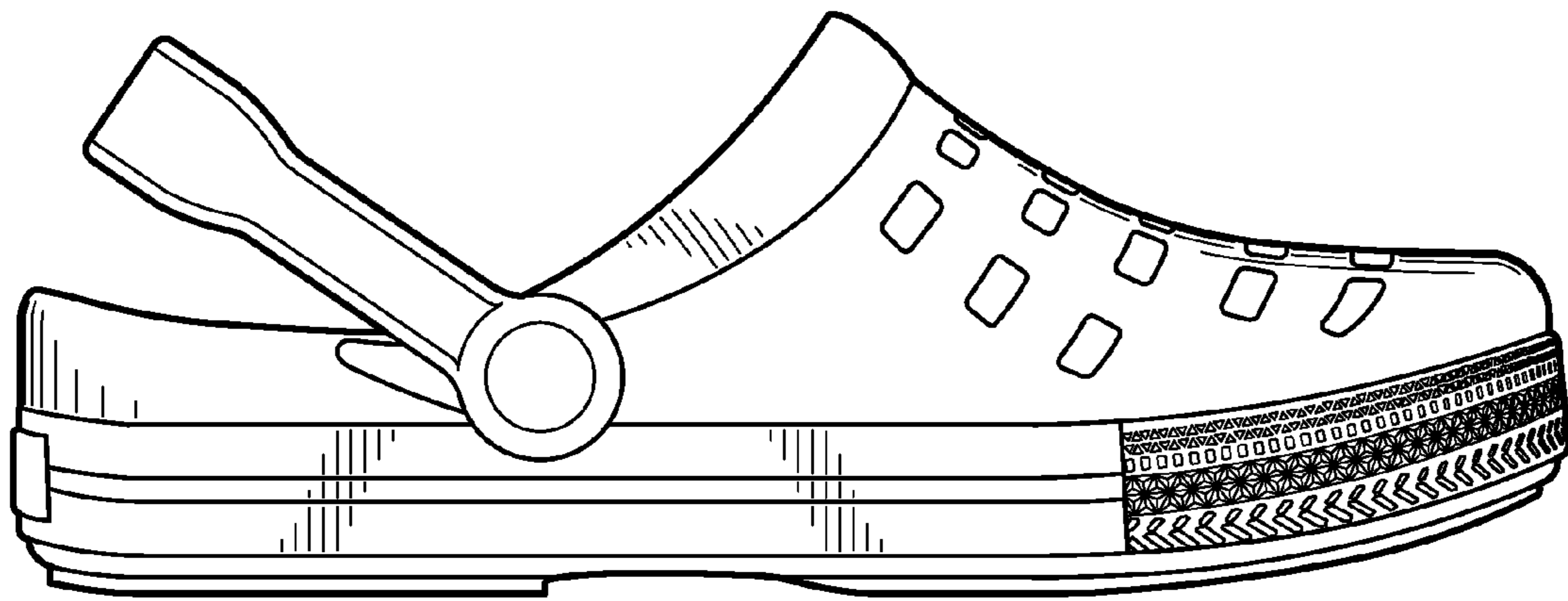

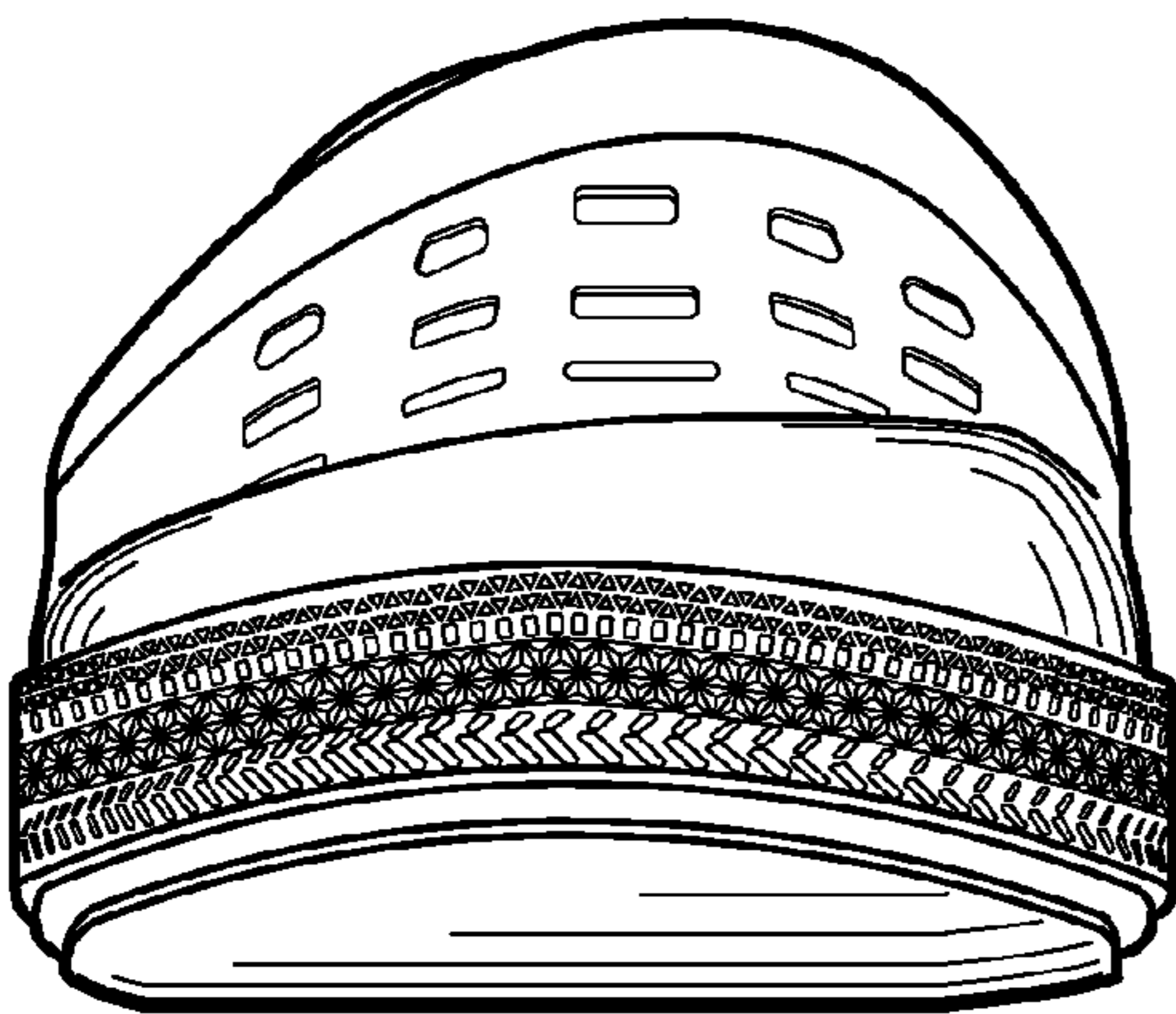

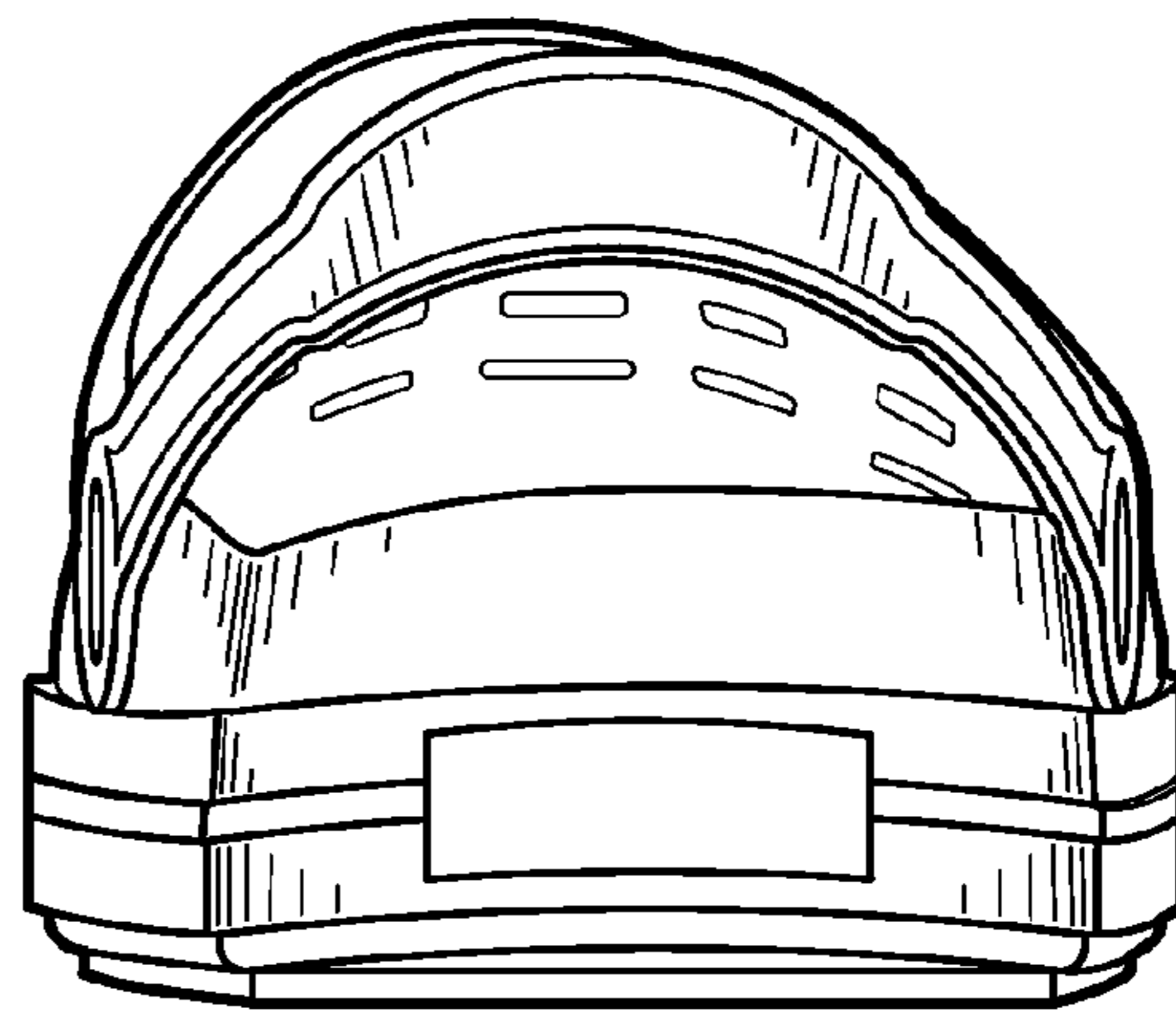
