DESCRIPTION

FIG. 1 is a bottom perspective view of a shoe in accordance with the new design;

FIG. 4 is a right side view thereof;

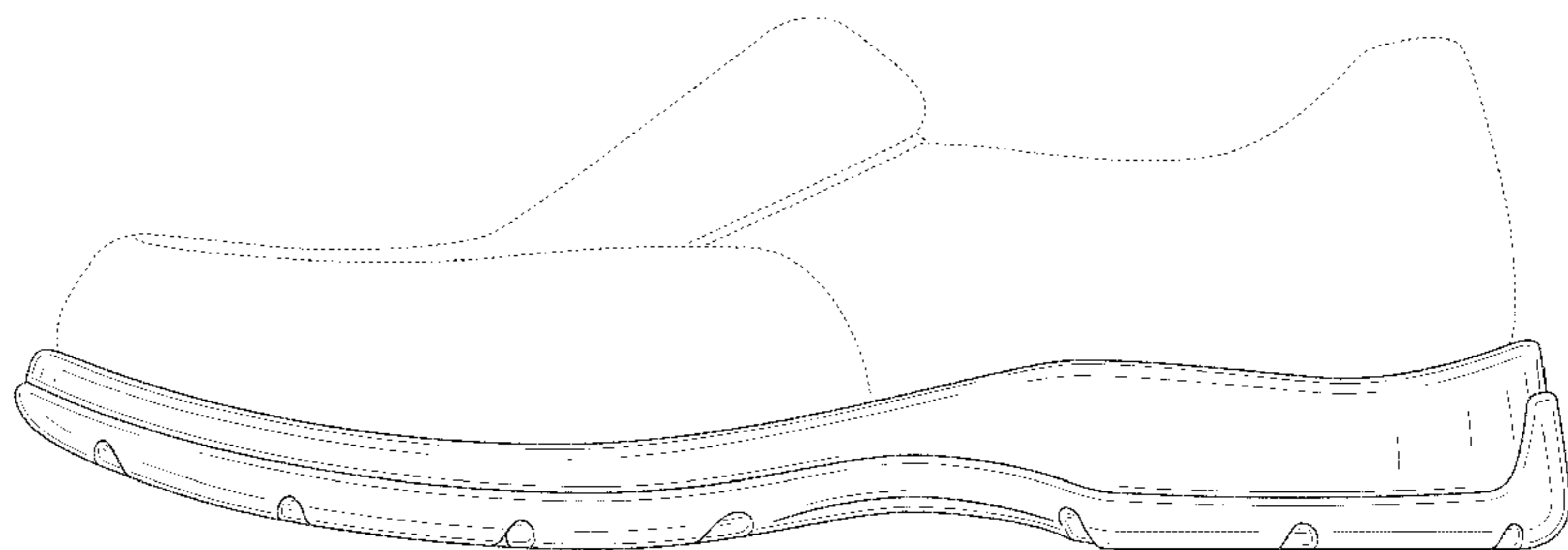
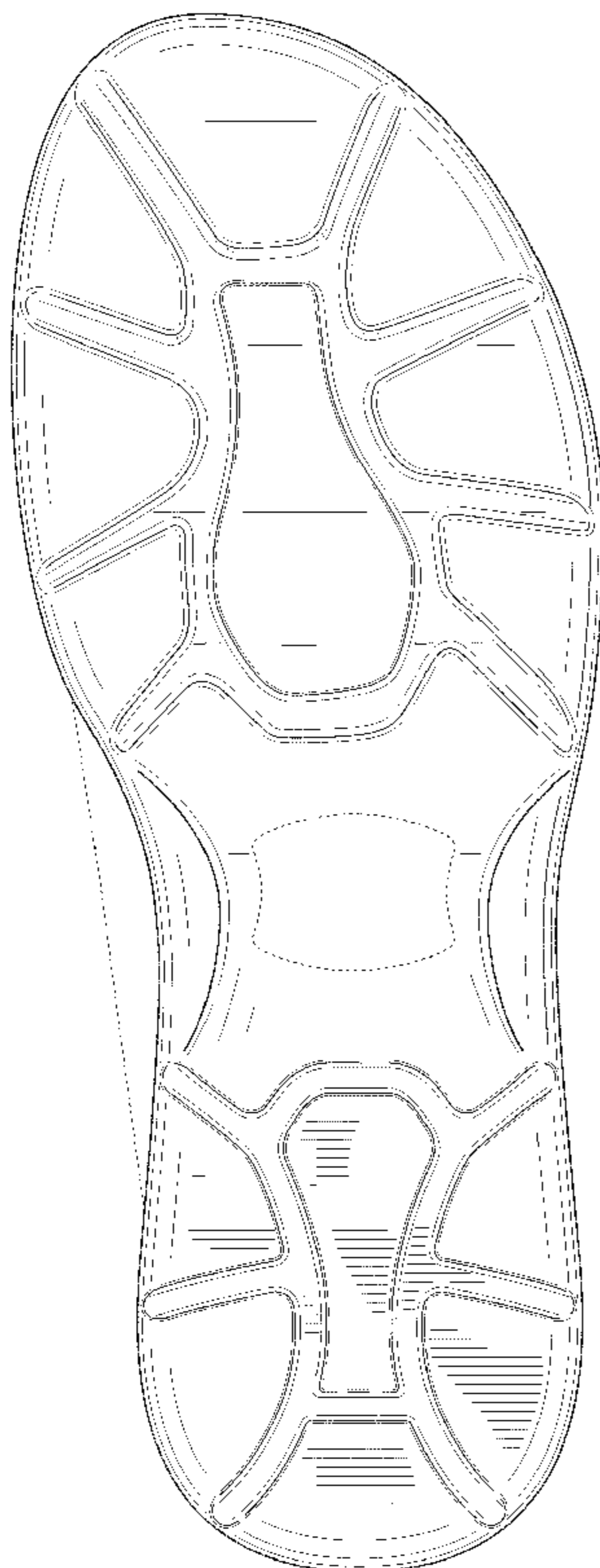
FIG. 5 is a left side view thereof;

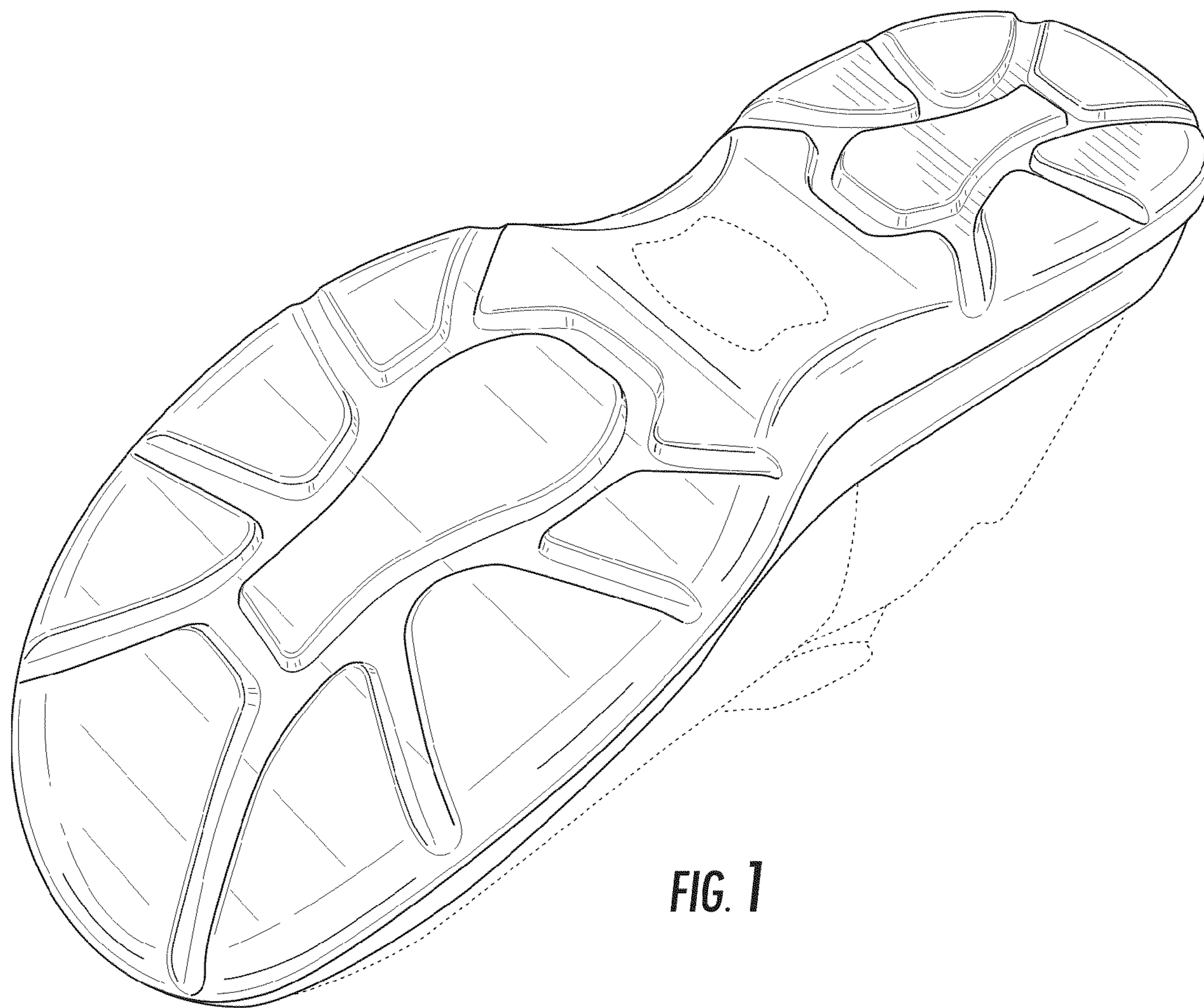
FIG. 6 is a front view thereof; and,

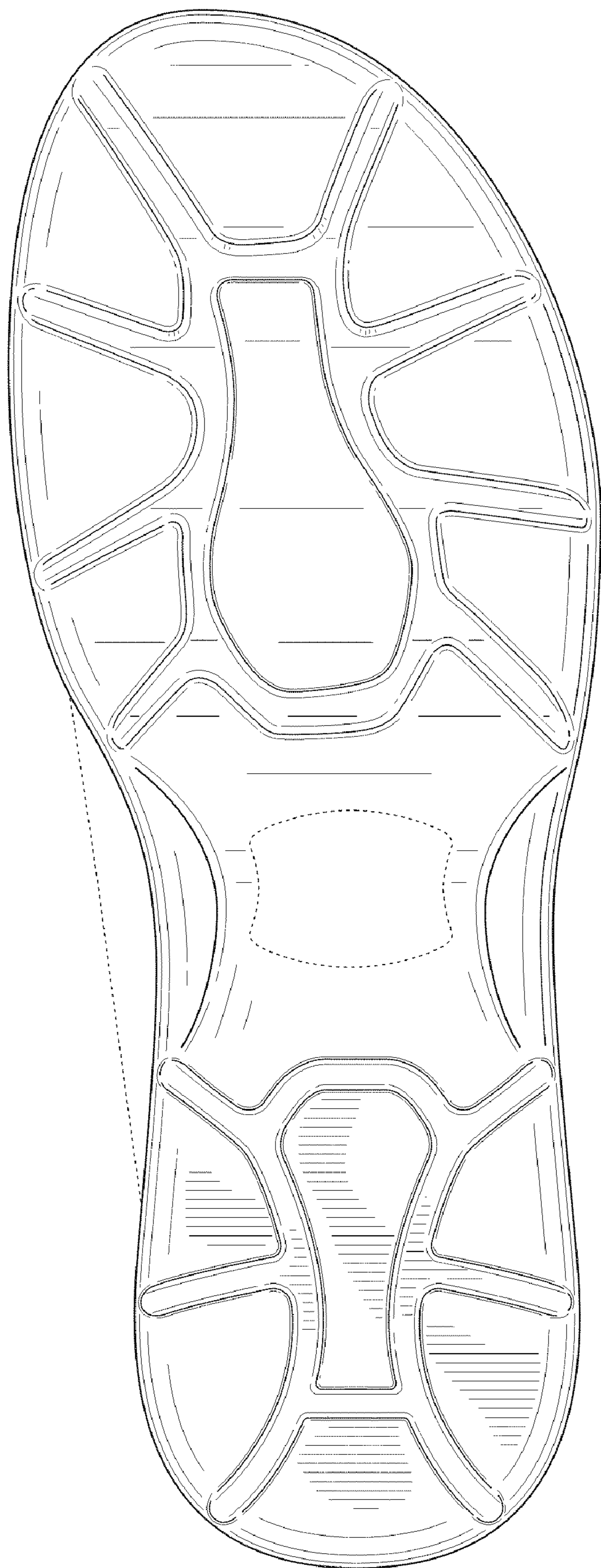

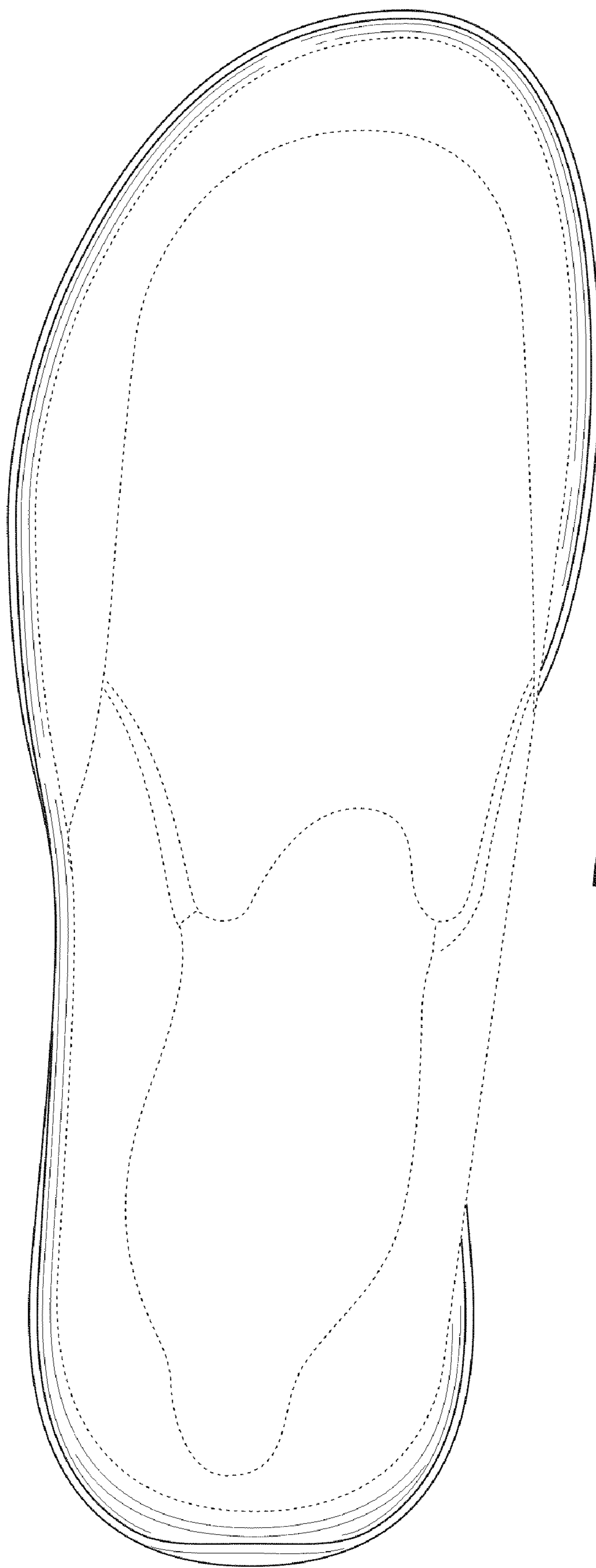

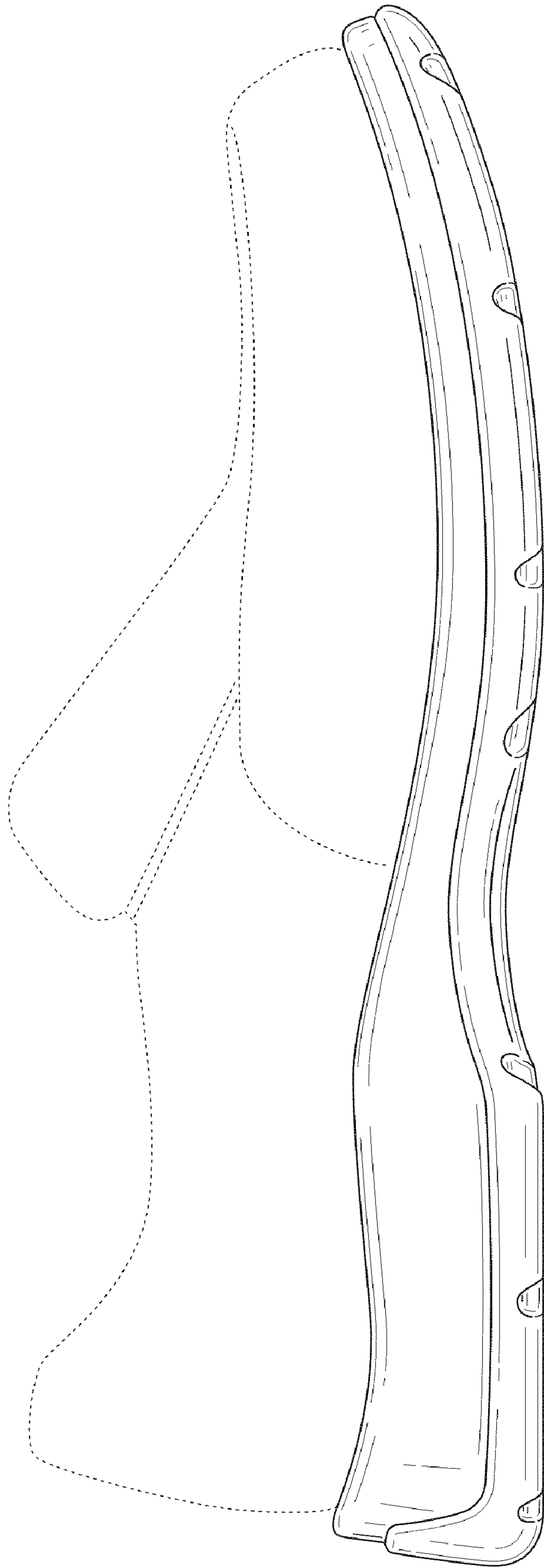

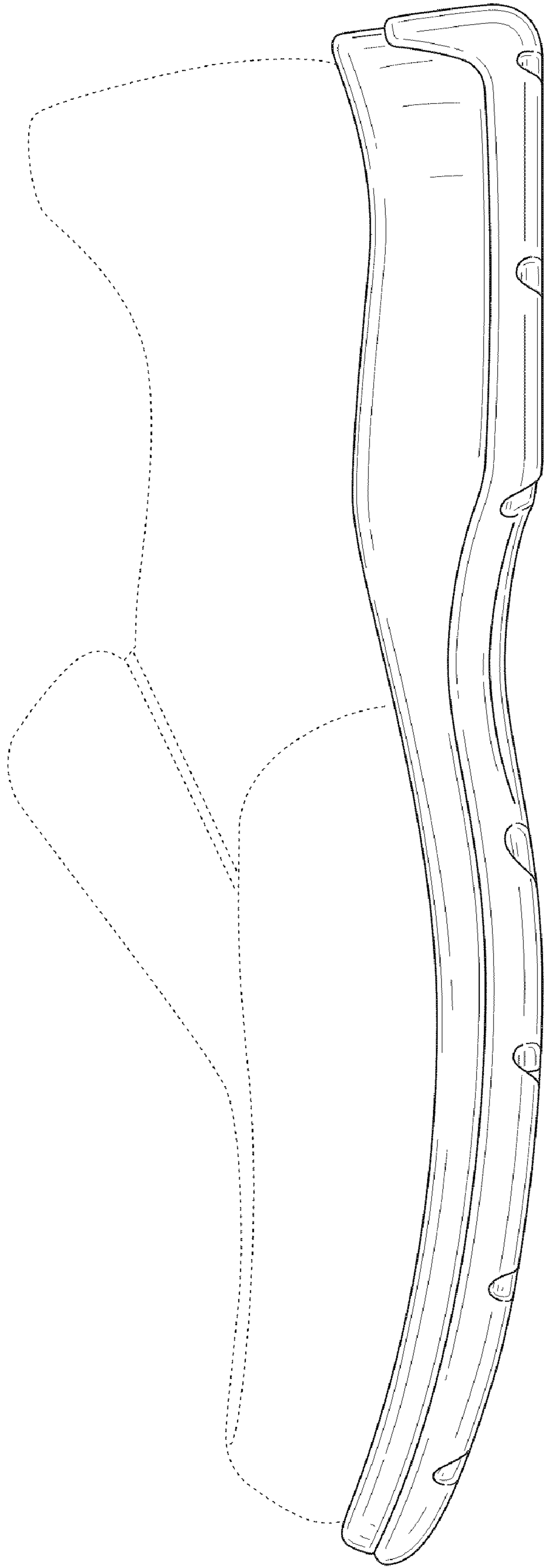

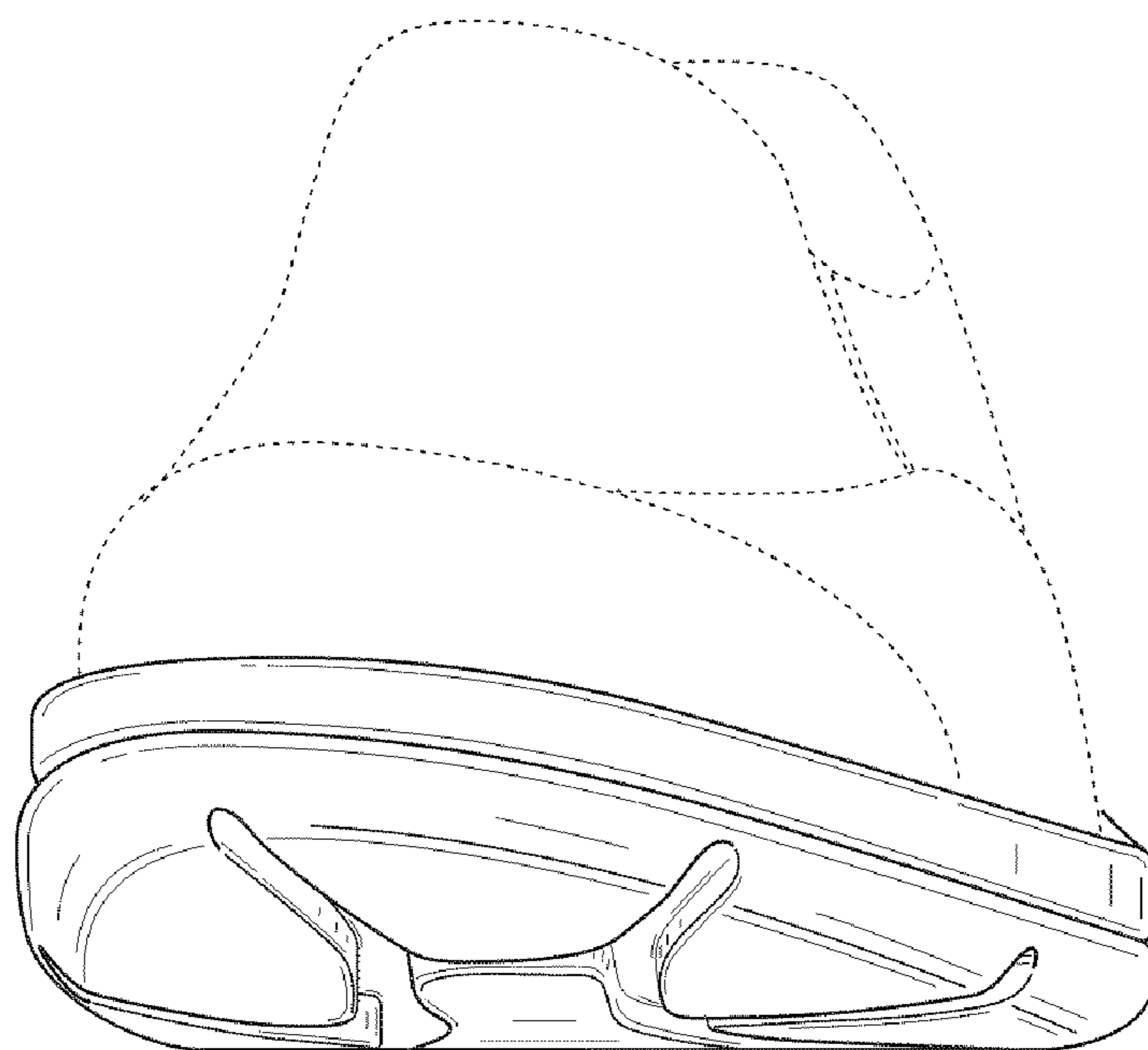

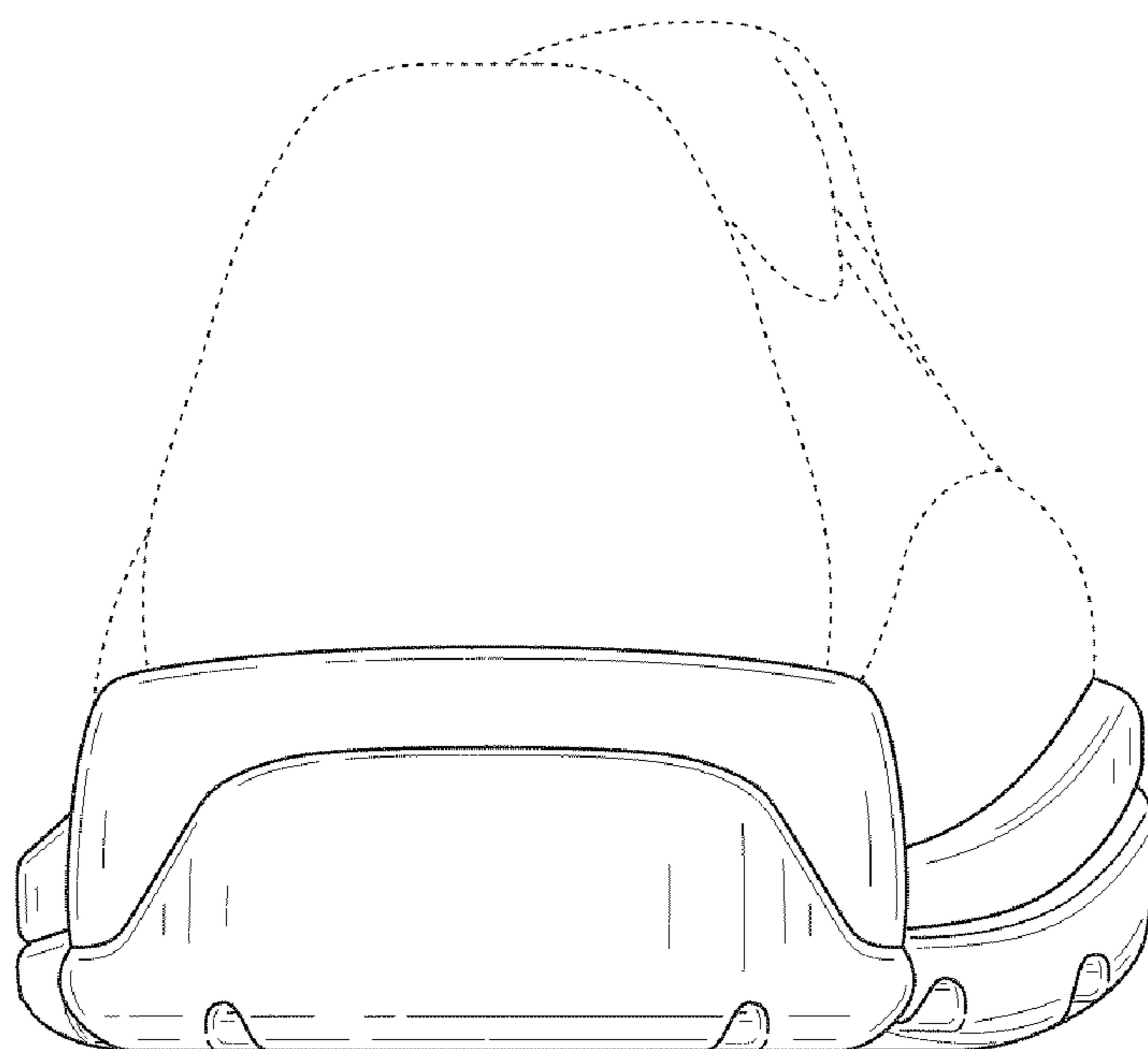
