(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a shoe upper showing my new design;

FIG. 2 is a side view thereof;

FIG. 3 is a rear perspective view thereof;

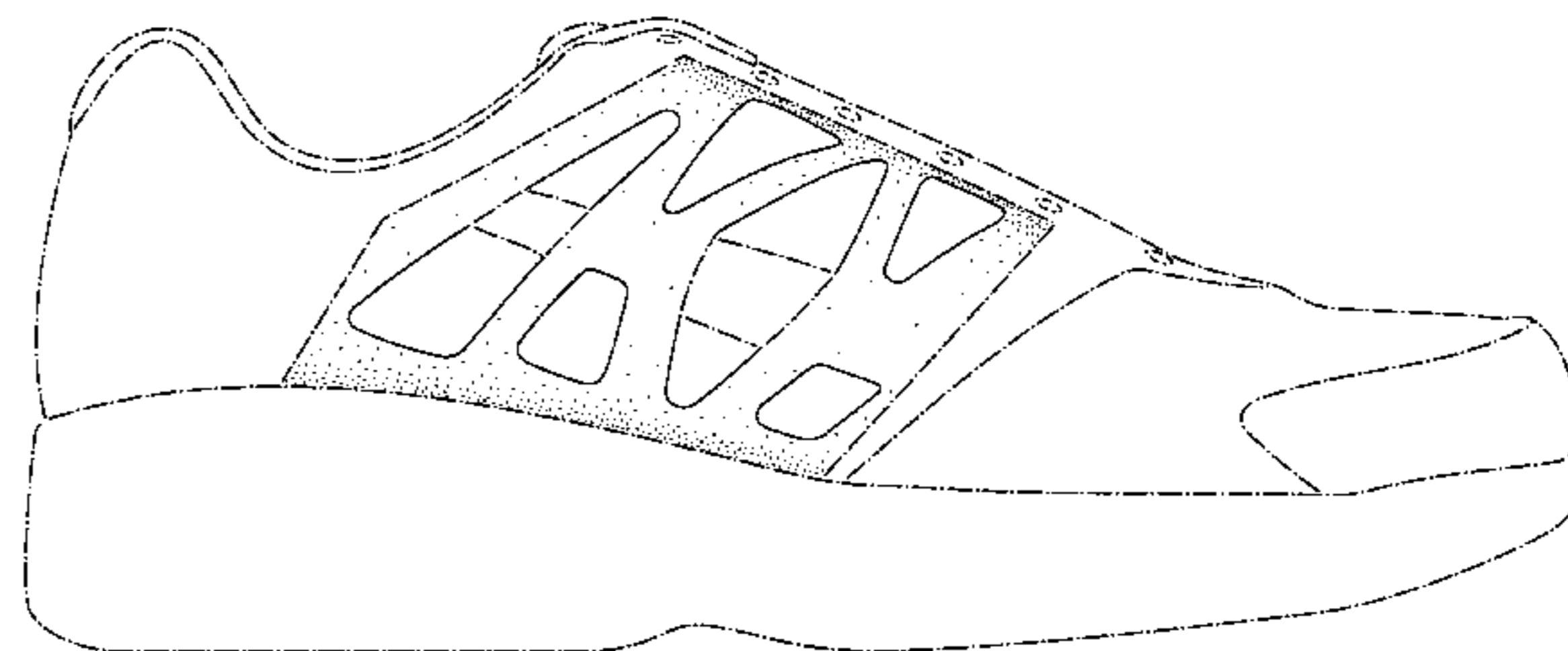
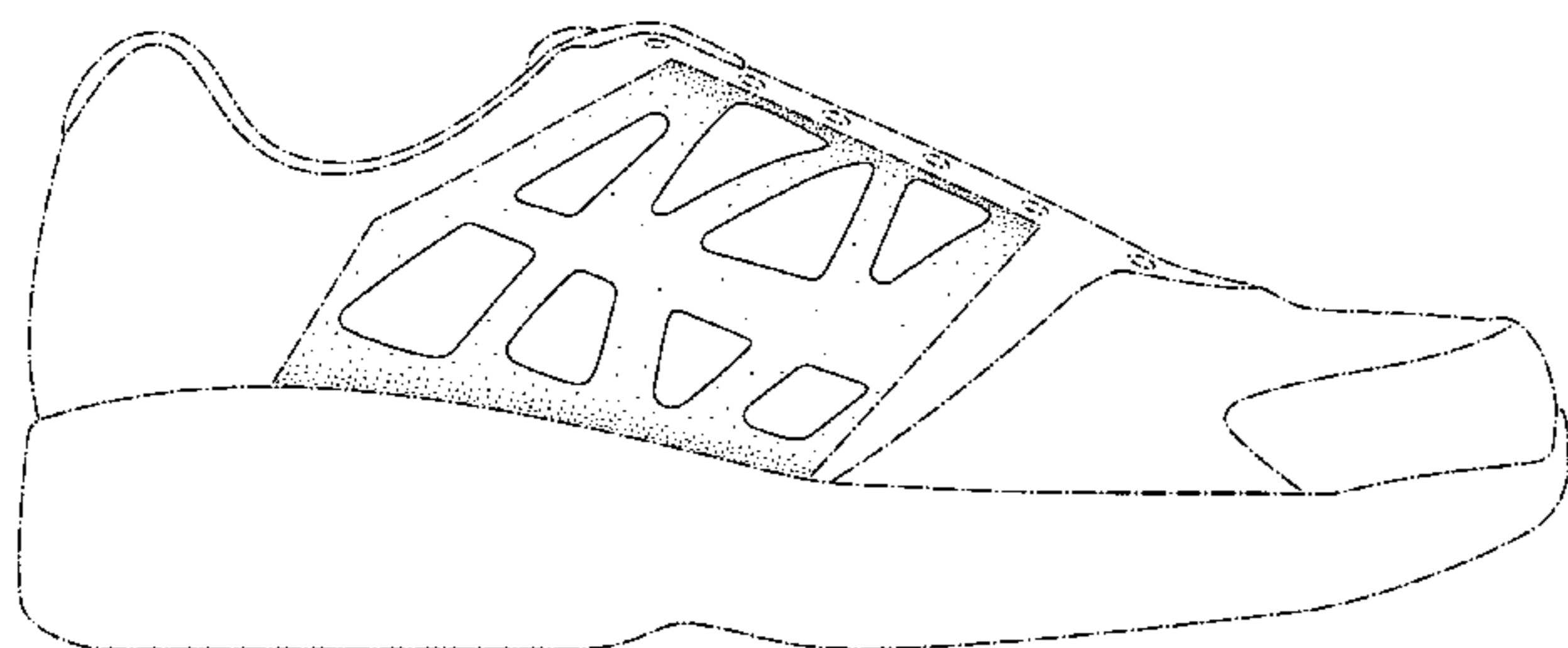
FIG. 4 is a front perspective view of a second embodiment of a shoe upper showing my new design;

FIG. 5 is a side view thereof; and,

FIG. 6 is a rear perspective view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded areas inside of the eight geometric regions demarcated by solid lines in FIGS. 1-3 form no part of the claimed design. The unshaded areas inside of the four geometric regions demarcated by solid lines in FIGS. 4-6 form no part of the claimed design. The unshaded areas inside of the two geometric regions demarcated by solid and broken lines in FIGS. 4-6 form no part of the claimed design. The broken lines showing the remainder of the shoe in FIGS. 1-6 are for environmental purposes only and form no part of the claimed design.

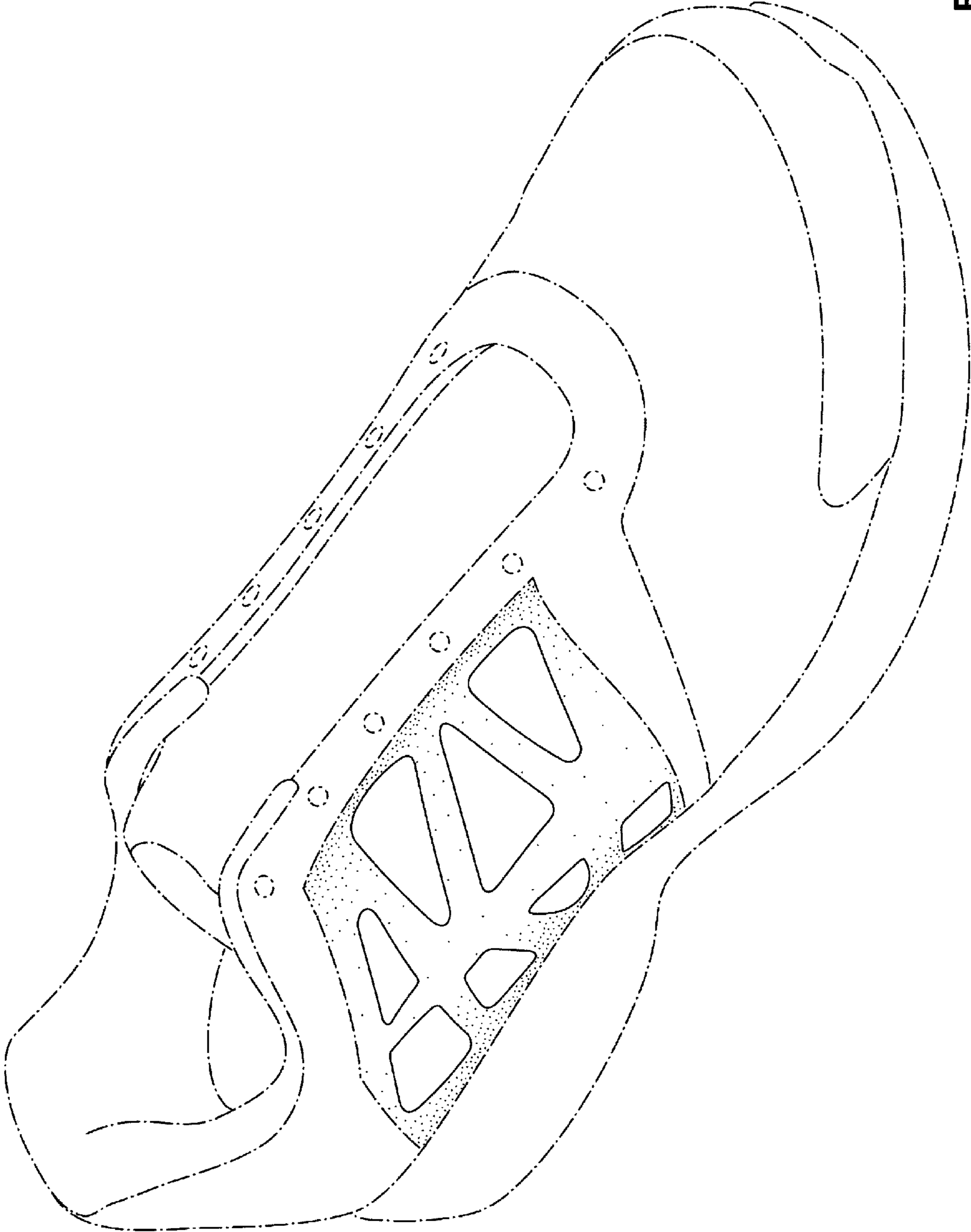

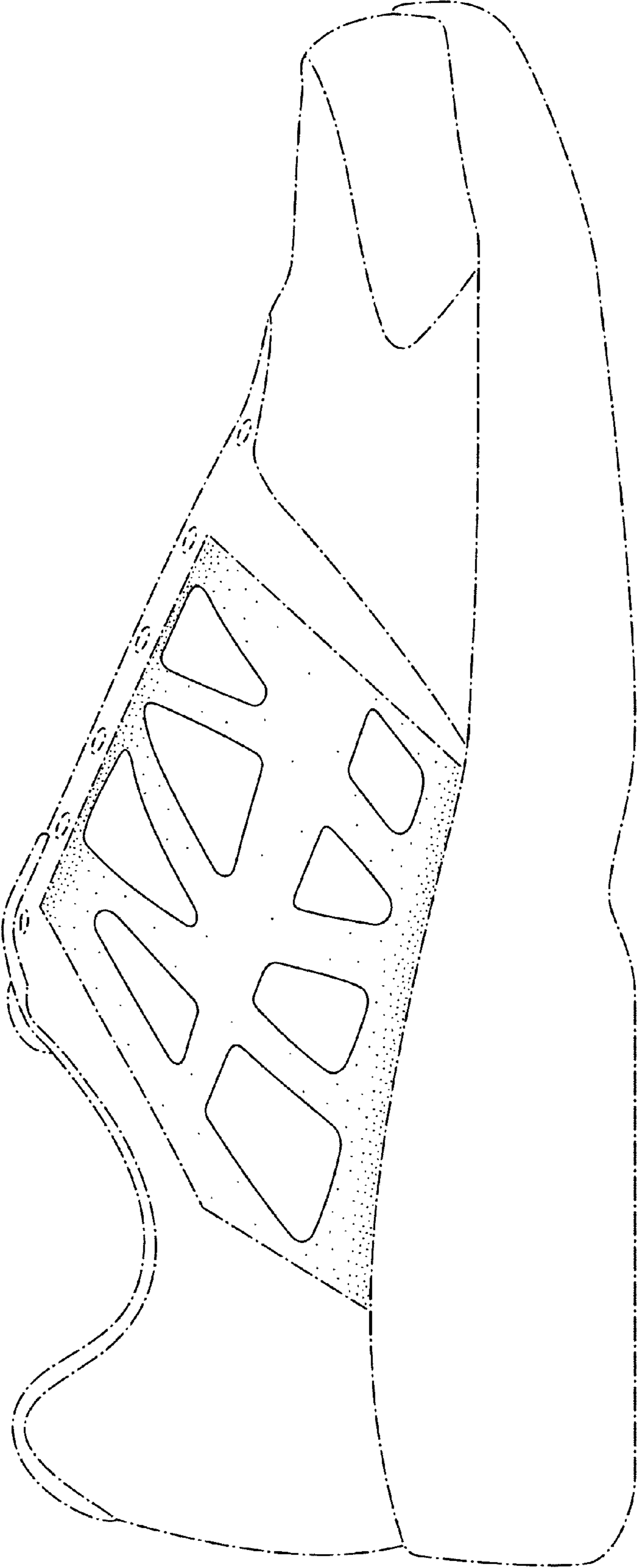

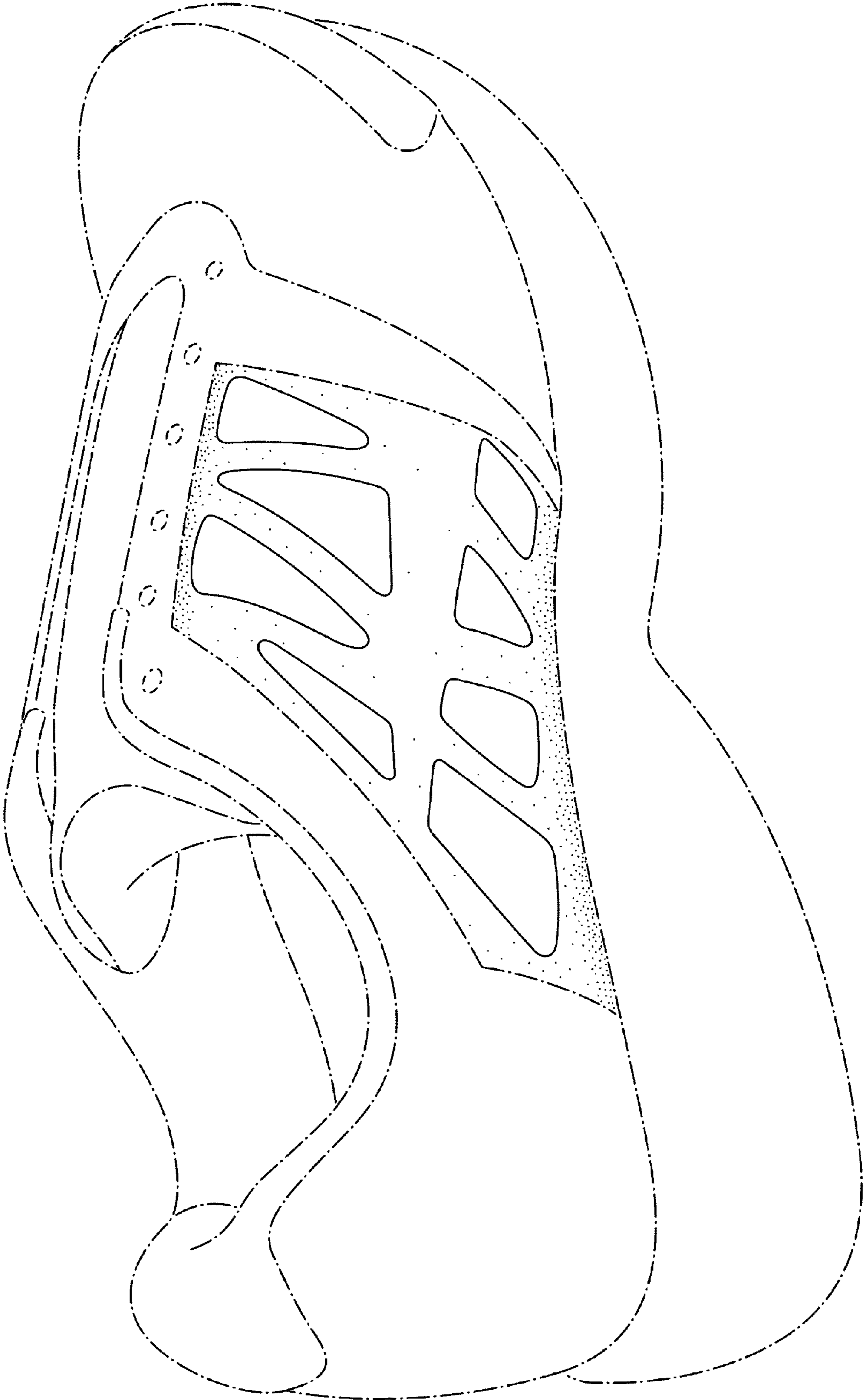

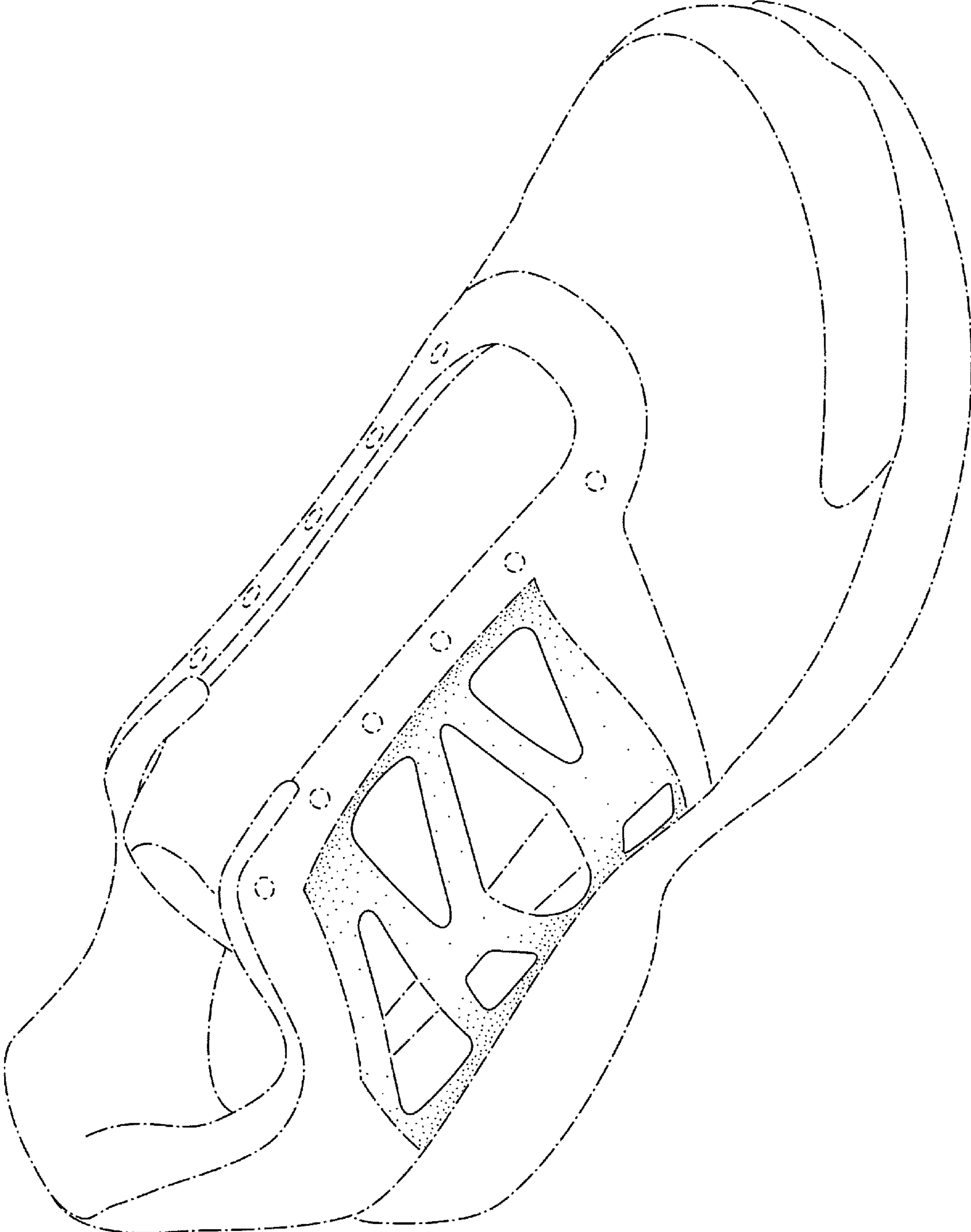

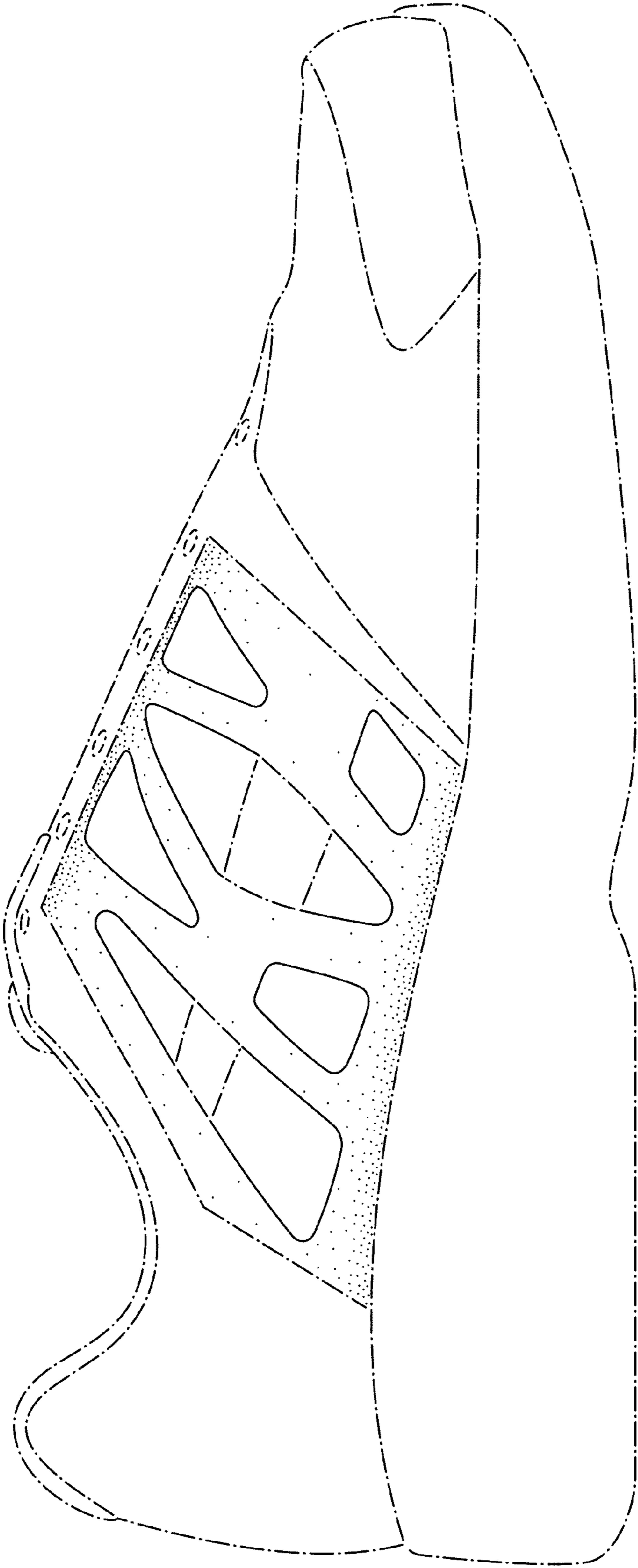

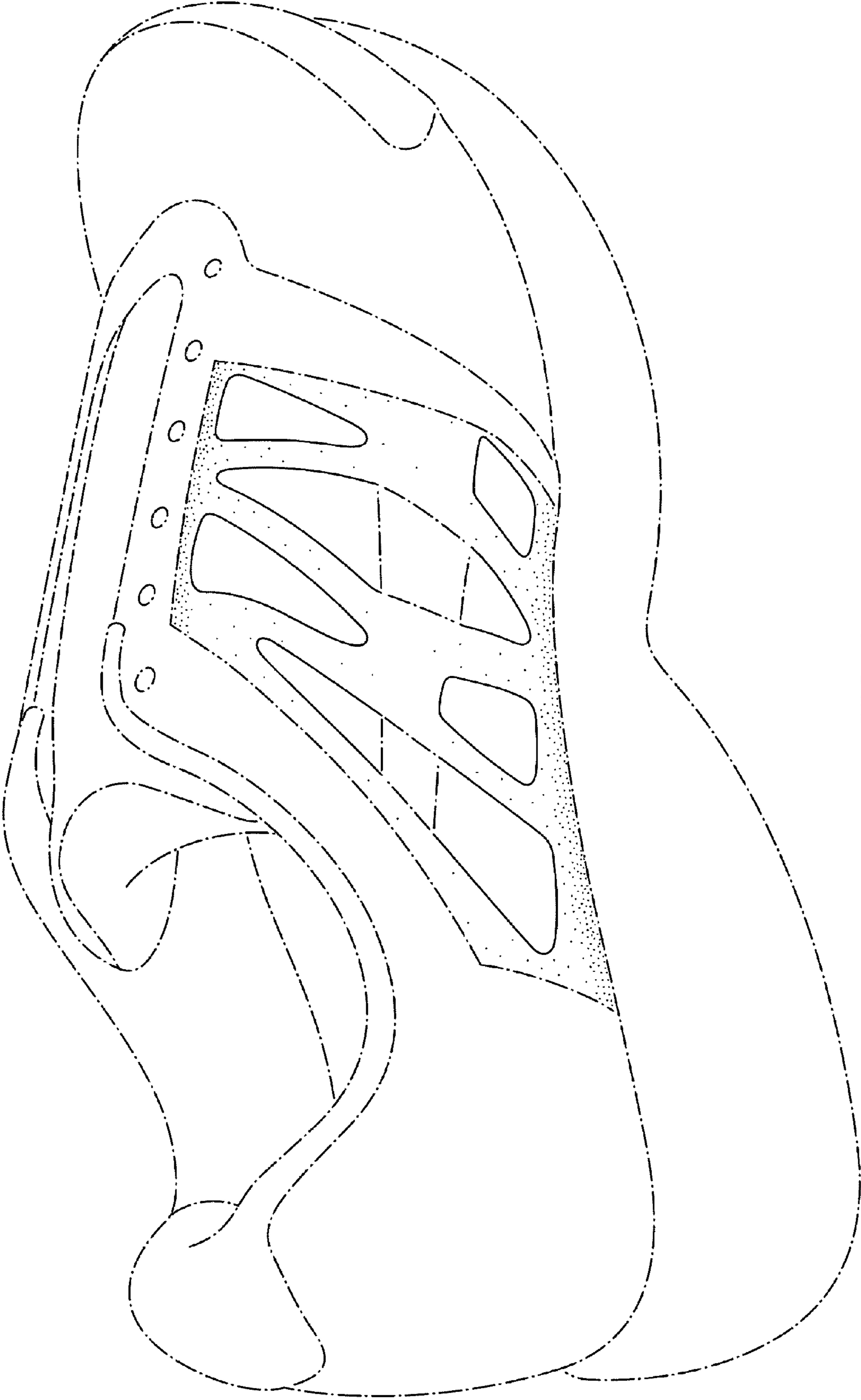
