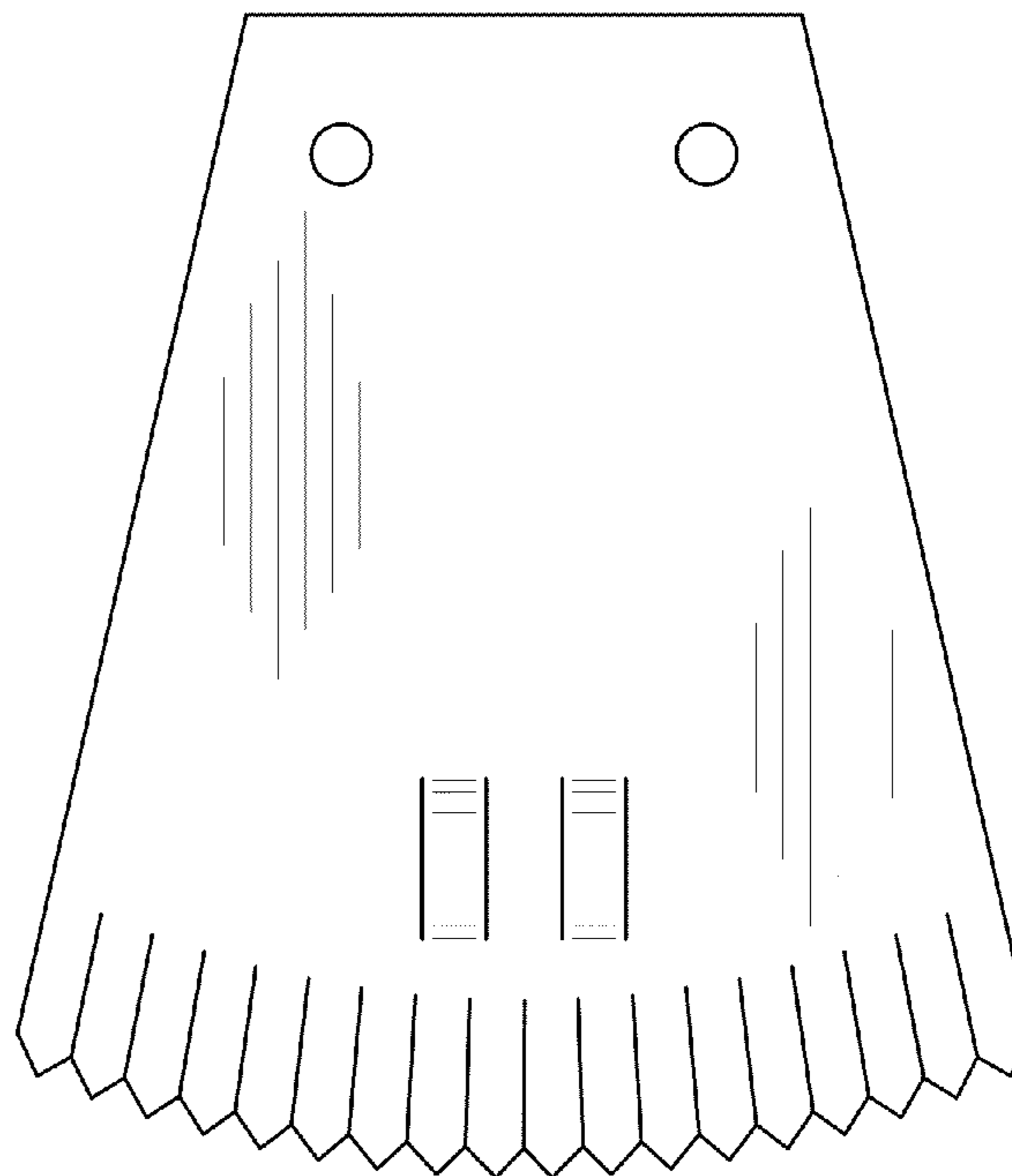
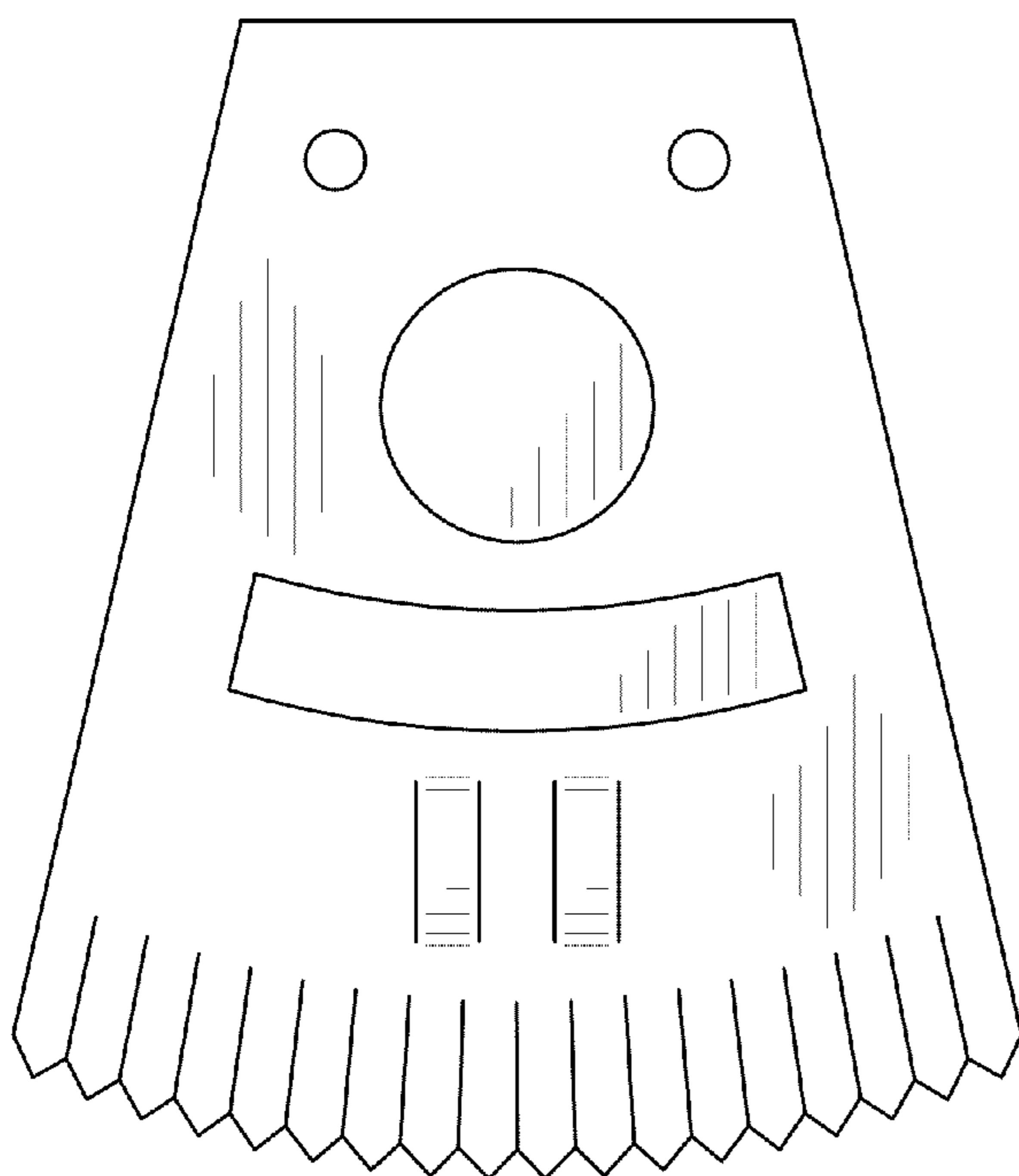
(57) **CLAIM**

The ornamental design for a decorative shoe lace flap, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a decorative shoe lace flap;
FIG. 2 is a rear view of the decorative shoe lace flap;
FIG. 3 is a side left side view and a mirror image of a right side view of the decorative shoe lace flap; and
FIG. 4 is a top view of the decorative shoe lace flap; and
FIG. 5 is a bottom view of the decorative shoe lace flap.

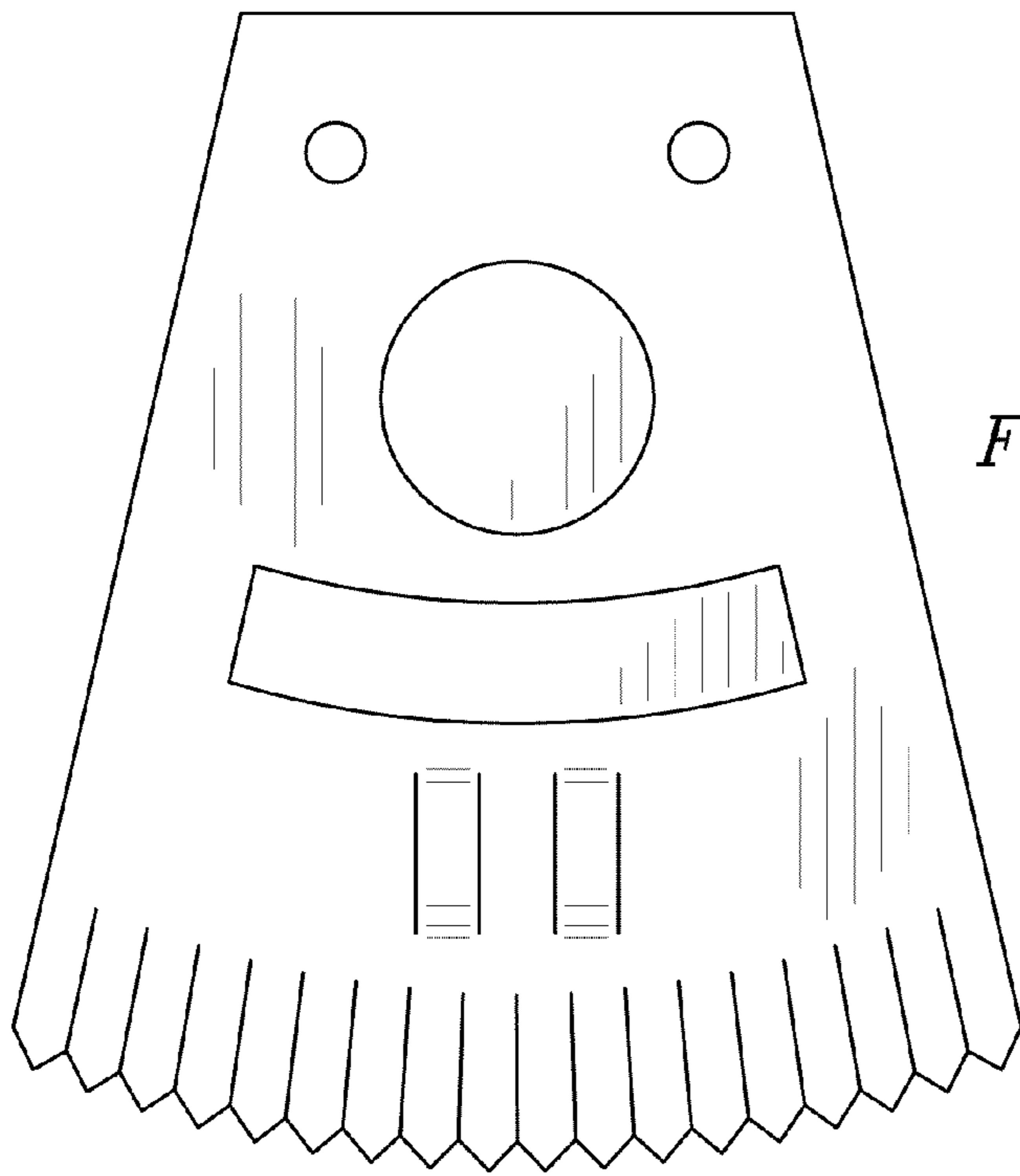

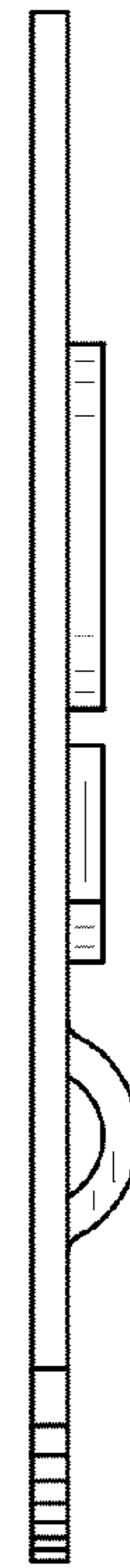

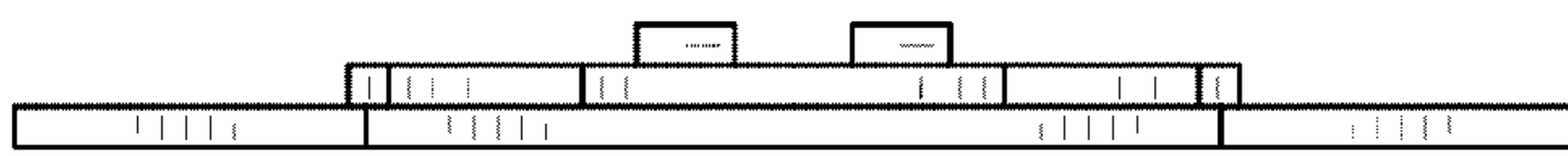

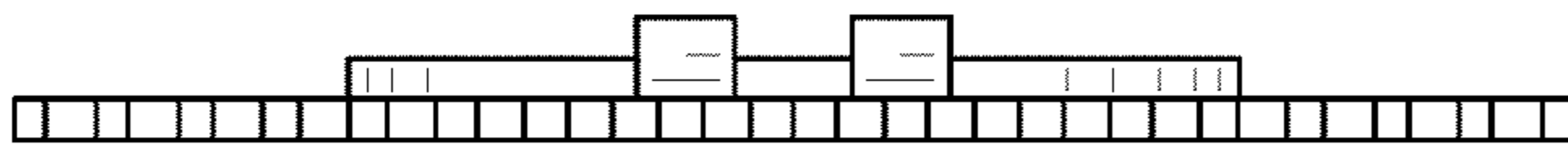
