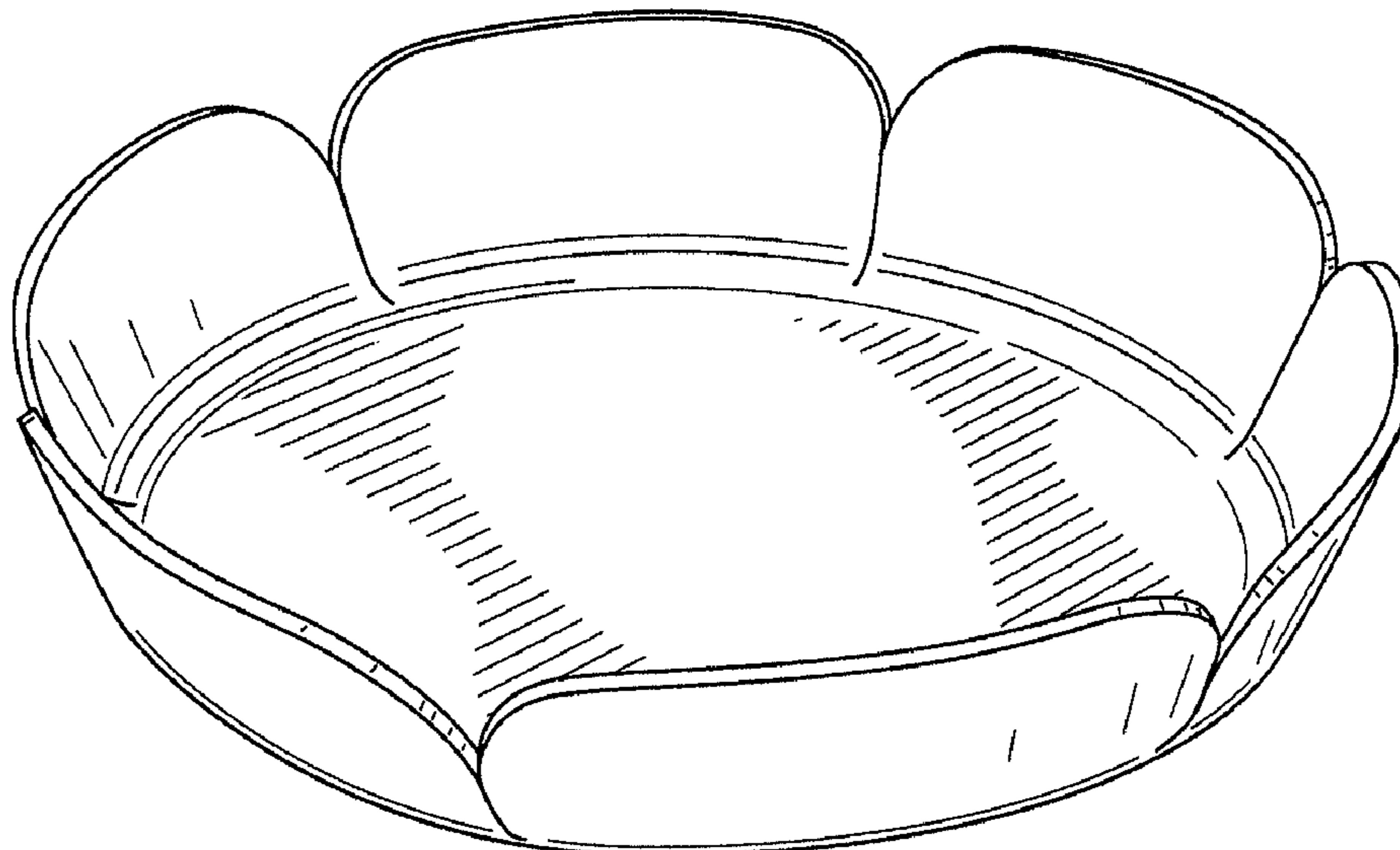
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a flower shaped wood cheese container in accordance with my design;

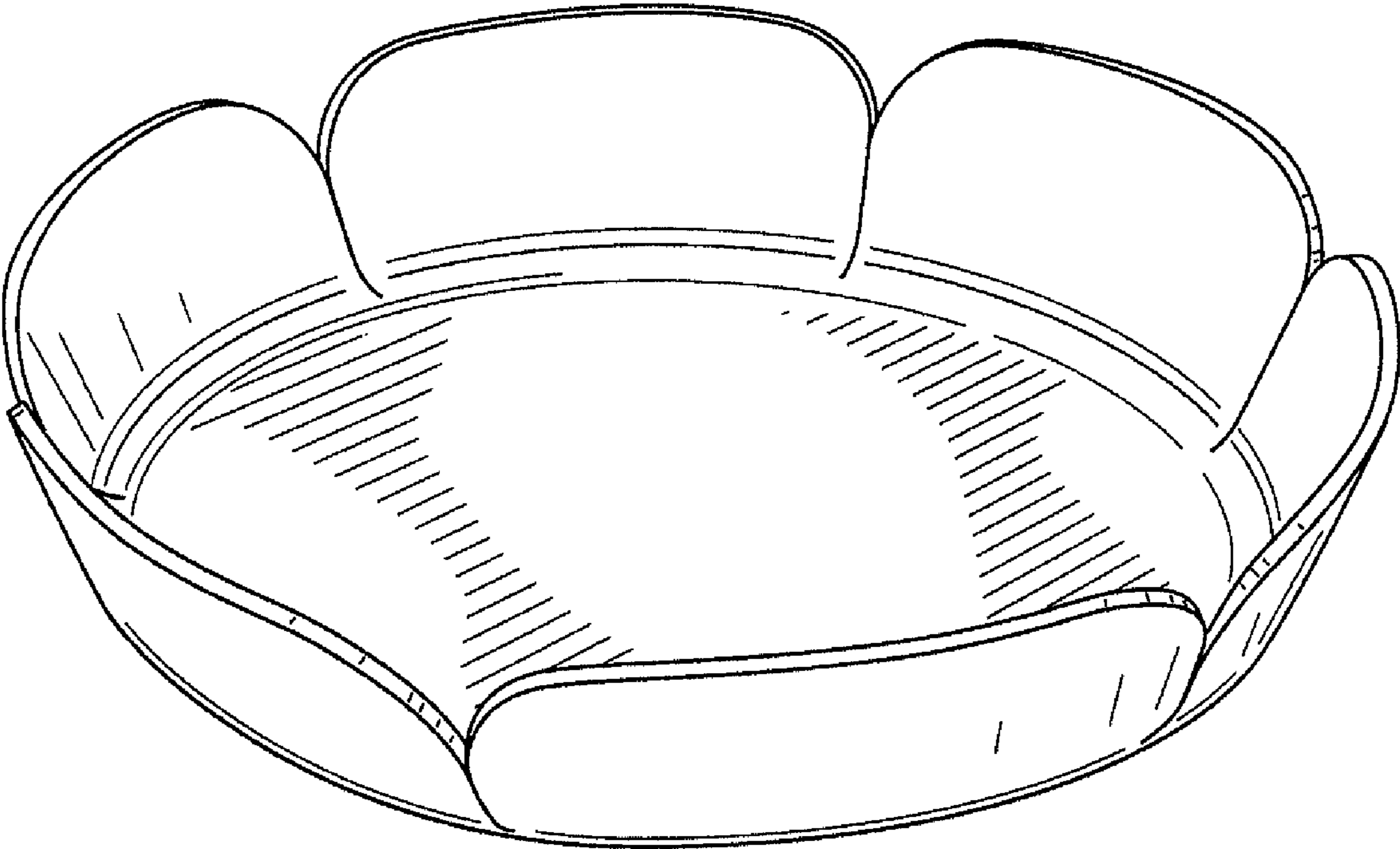

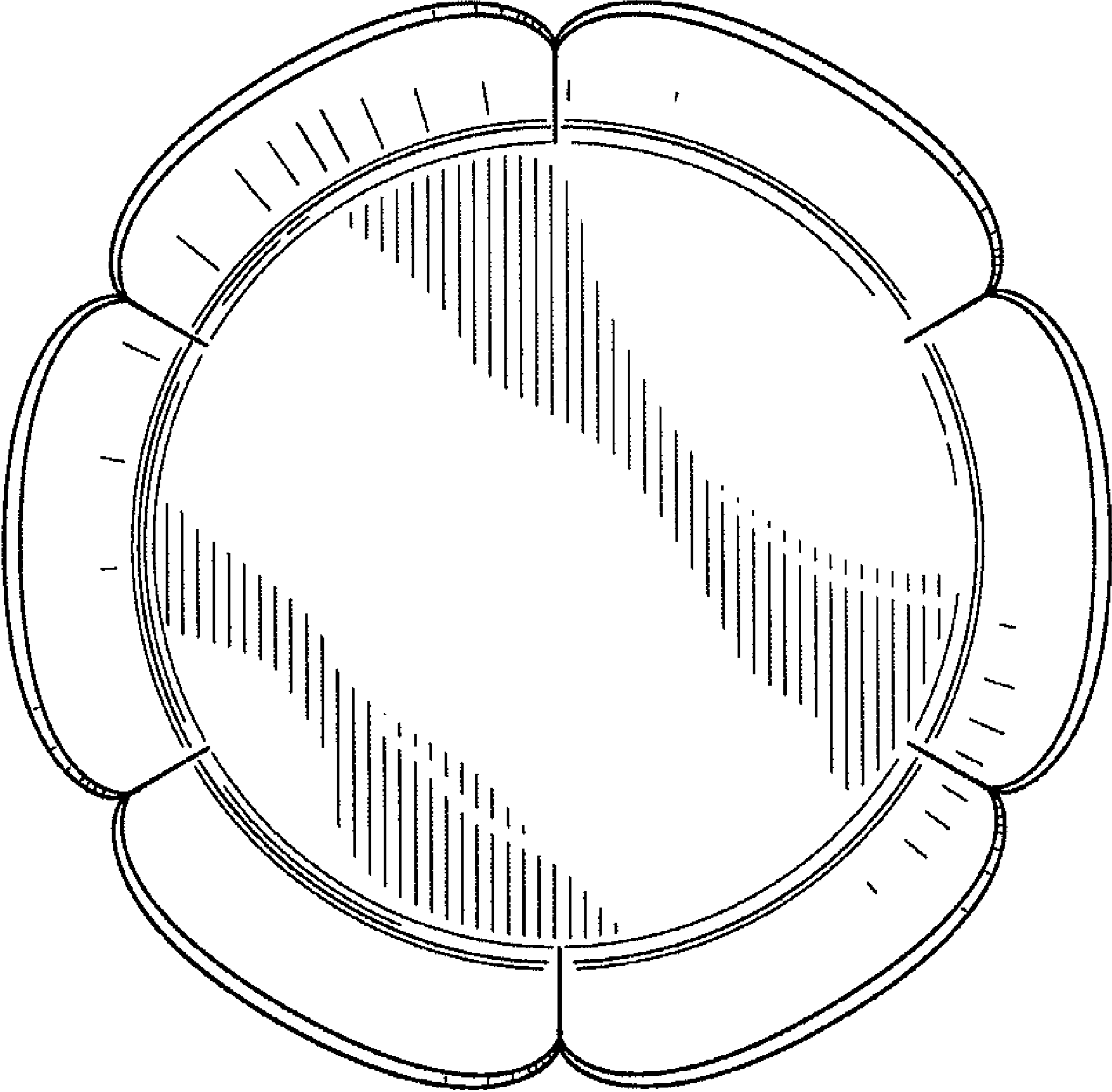

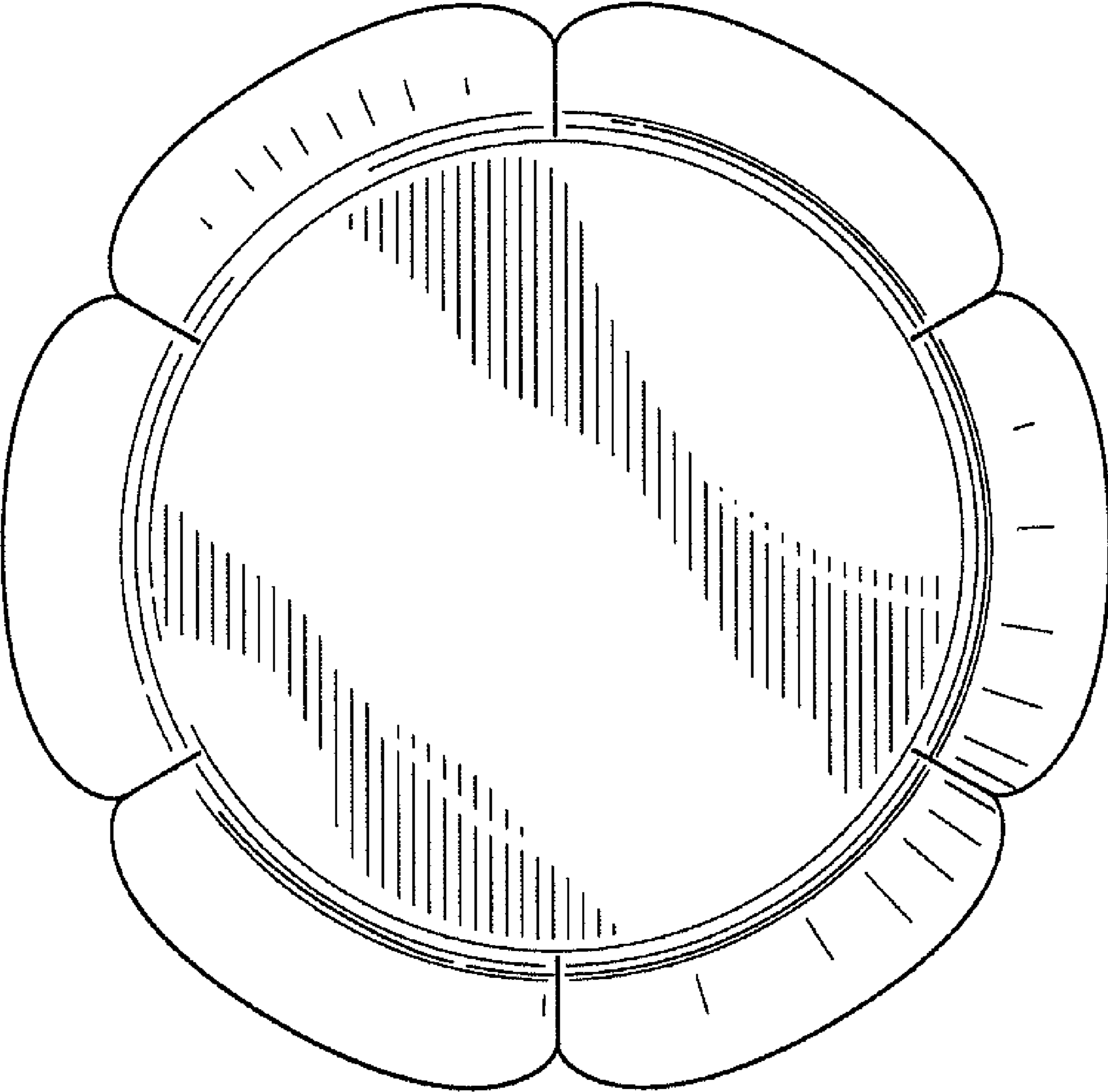

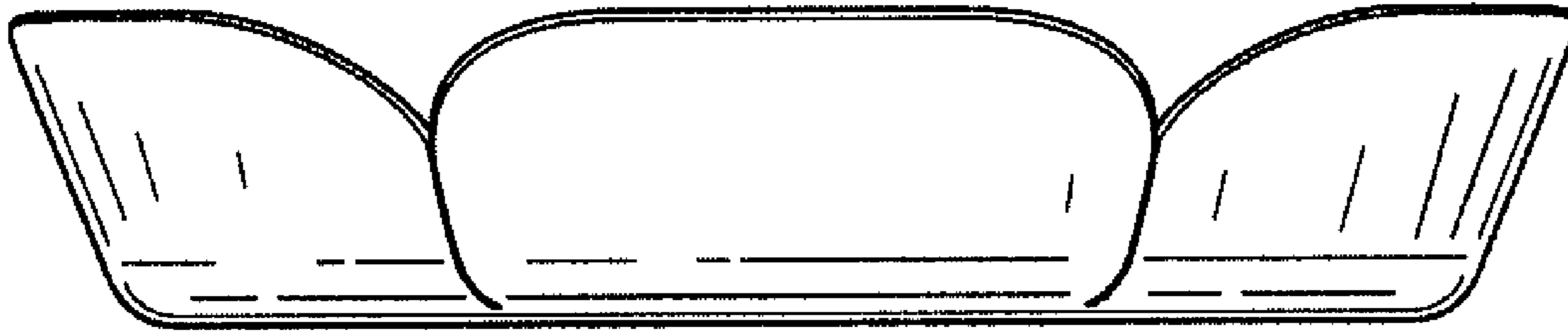

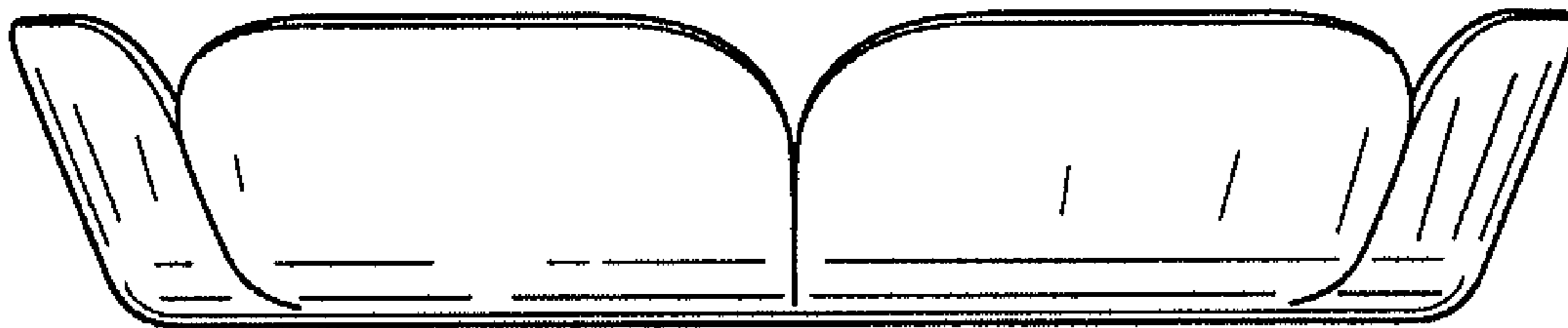

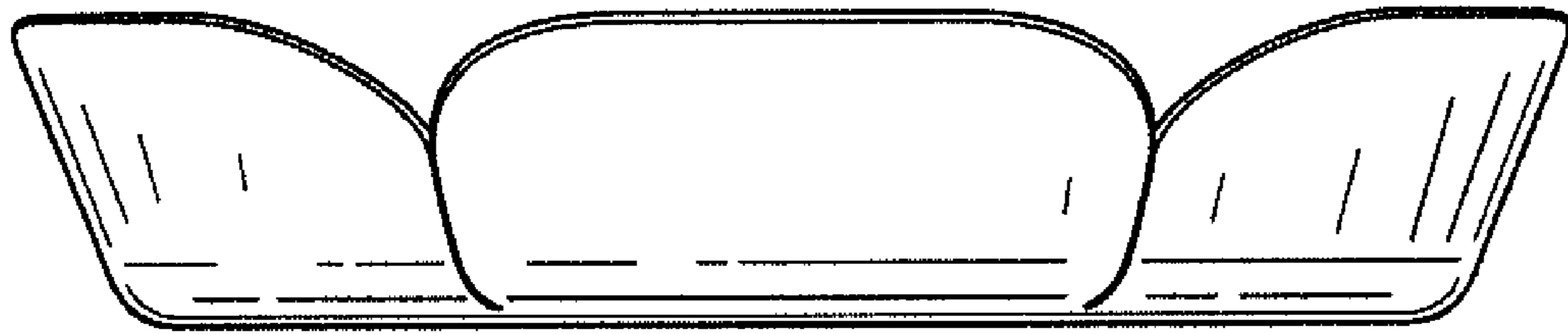

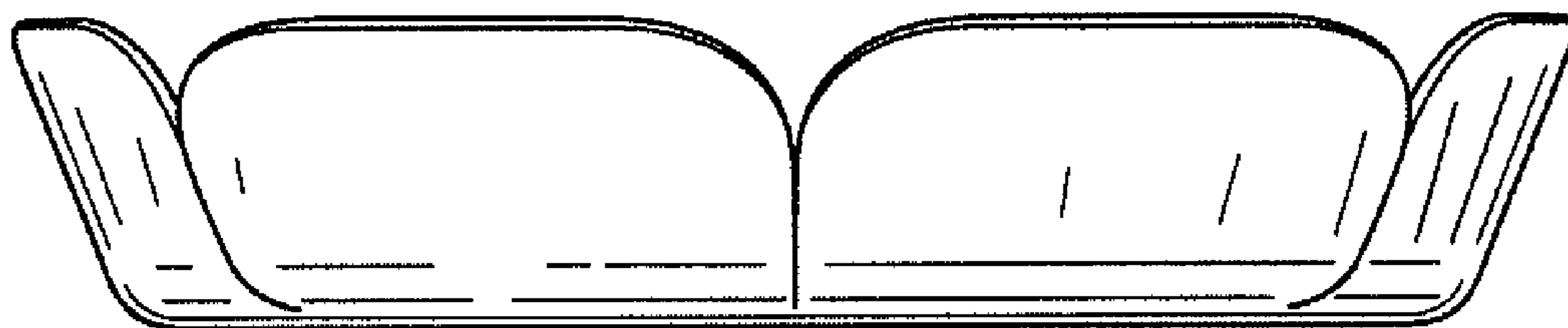
