(57) **CLAIM**

The ornamental design for tenon saw, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the left side of the design for the tenon saw of this invention.

FIG. 2 is a right side view of the design for the tenon saw shown in FIG. 1.

FIG. 3 is a left side view of the design for the tenon saw shown in FIG. 1.

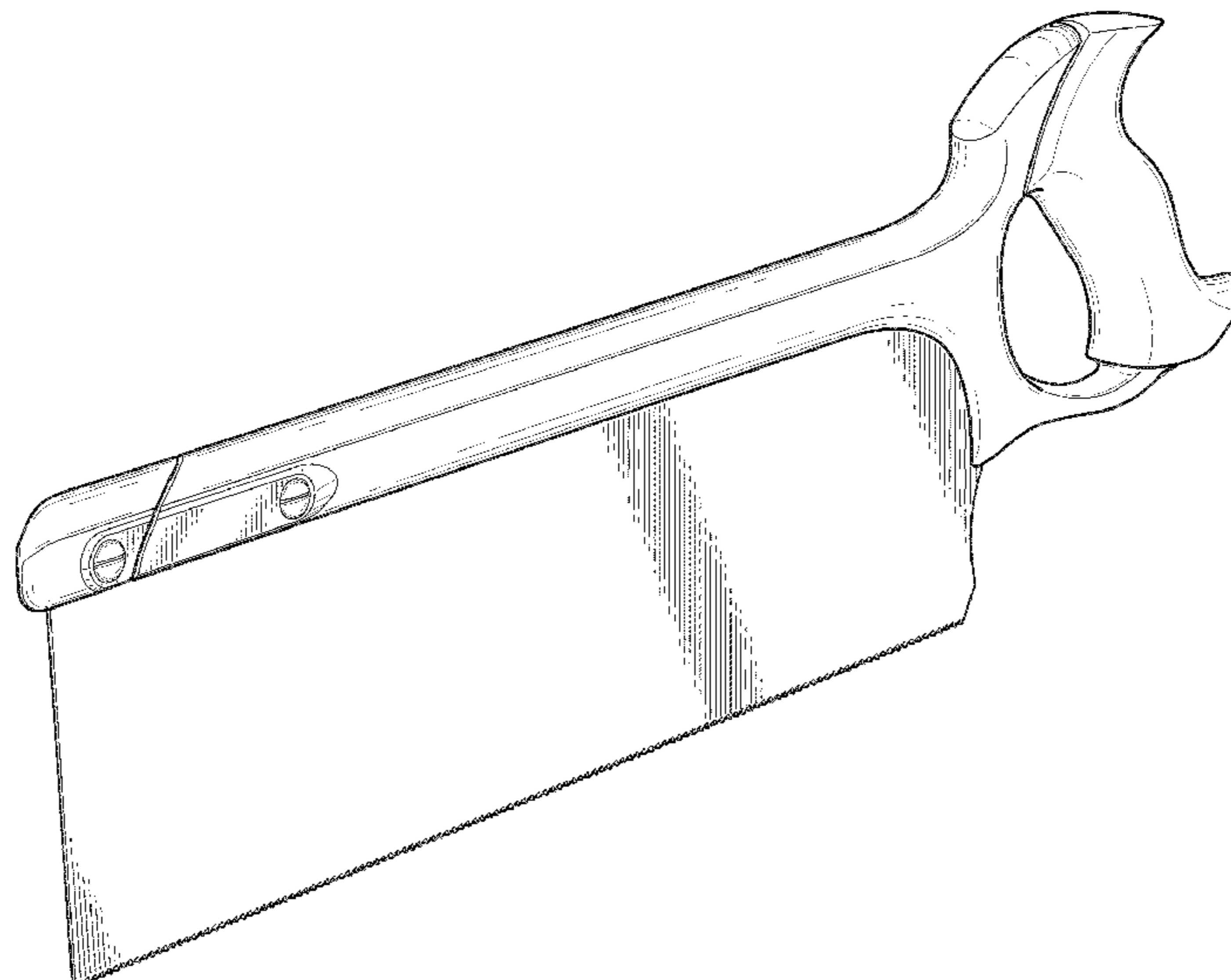
FIG. 4 is a view of the end of the saw remote from the handle of the design for the tenon saw shown in FIG. 1.

FIG. 5 is a view of the handle end of the design for the tenon saw shown in FIG. 1.

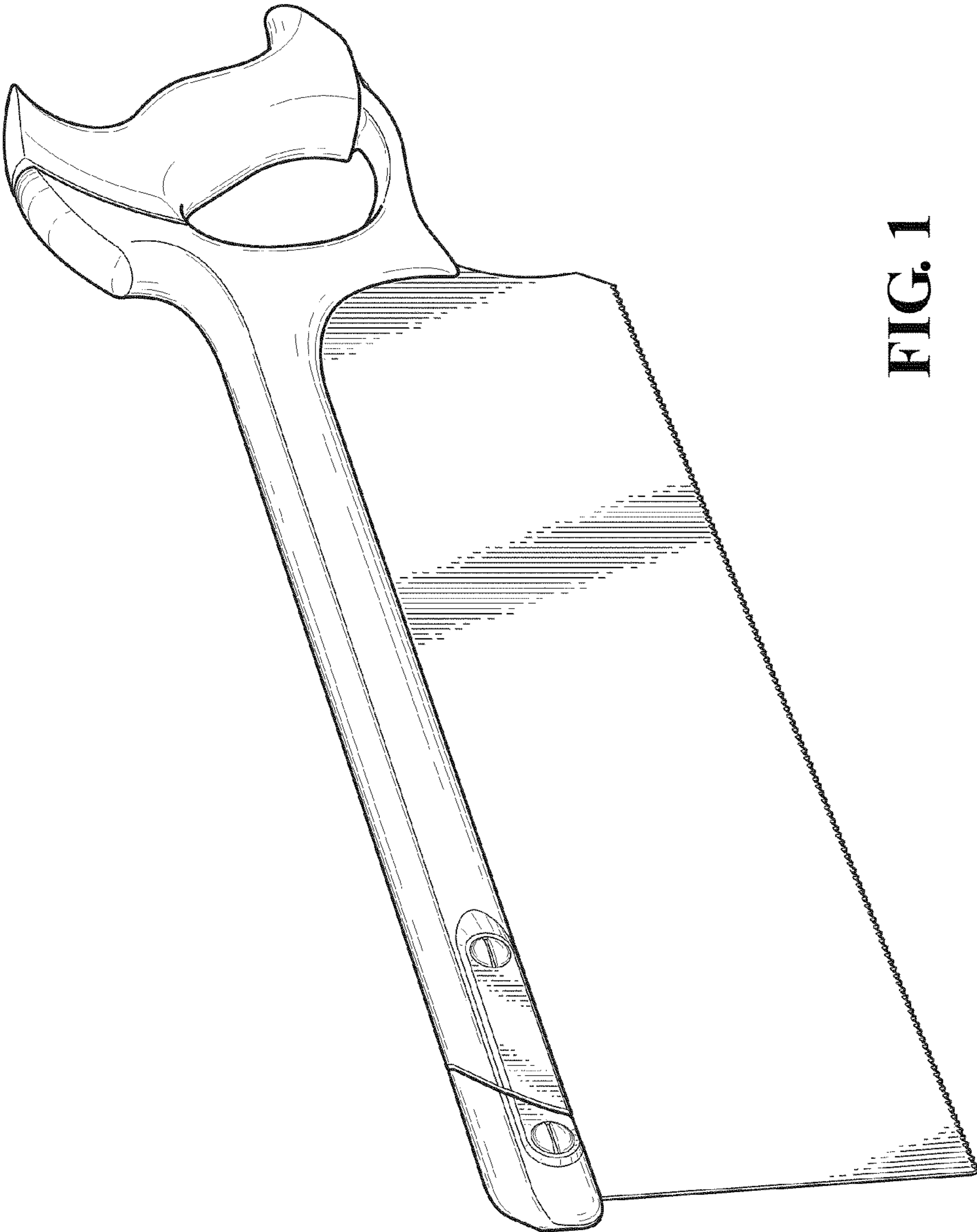

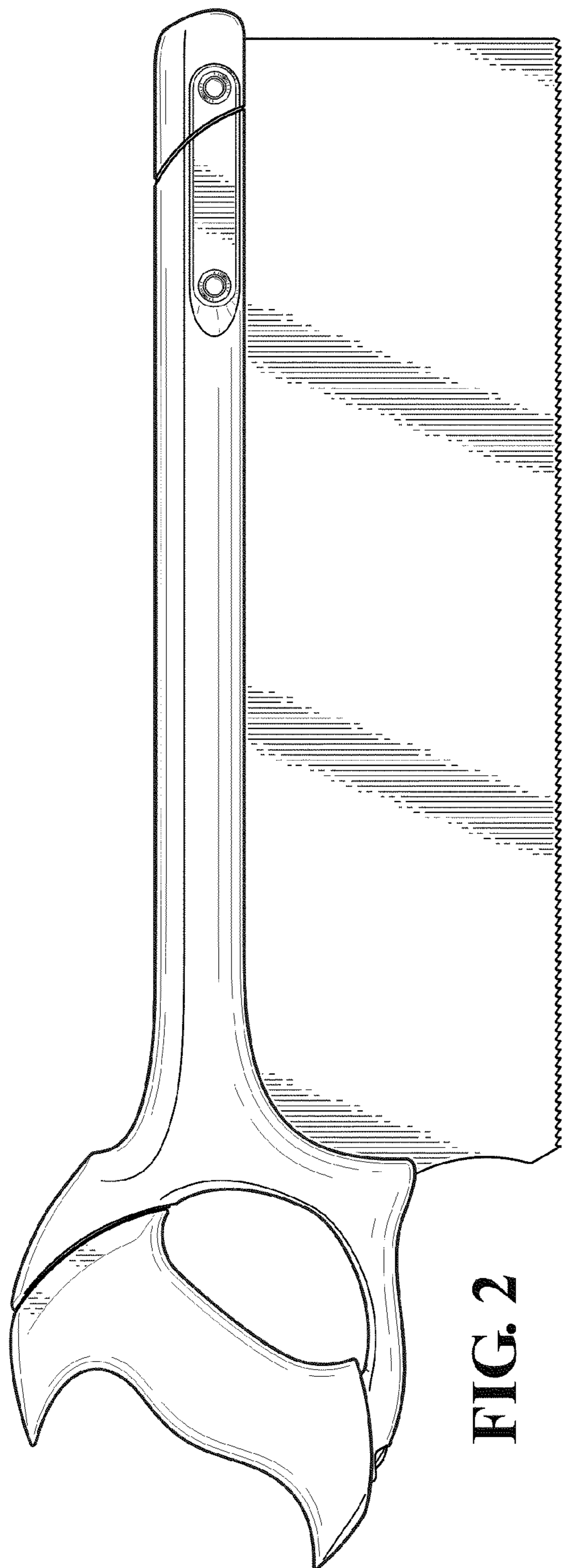

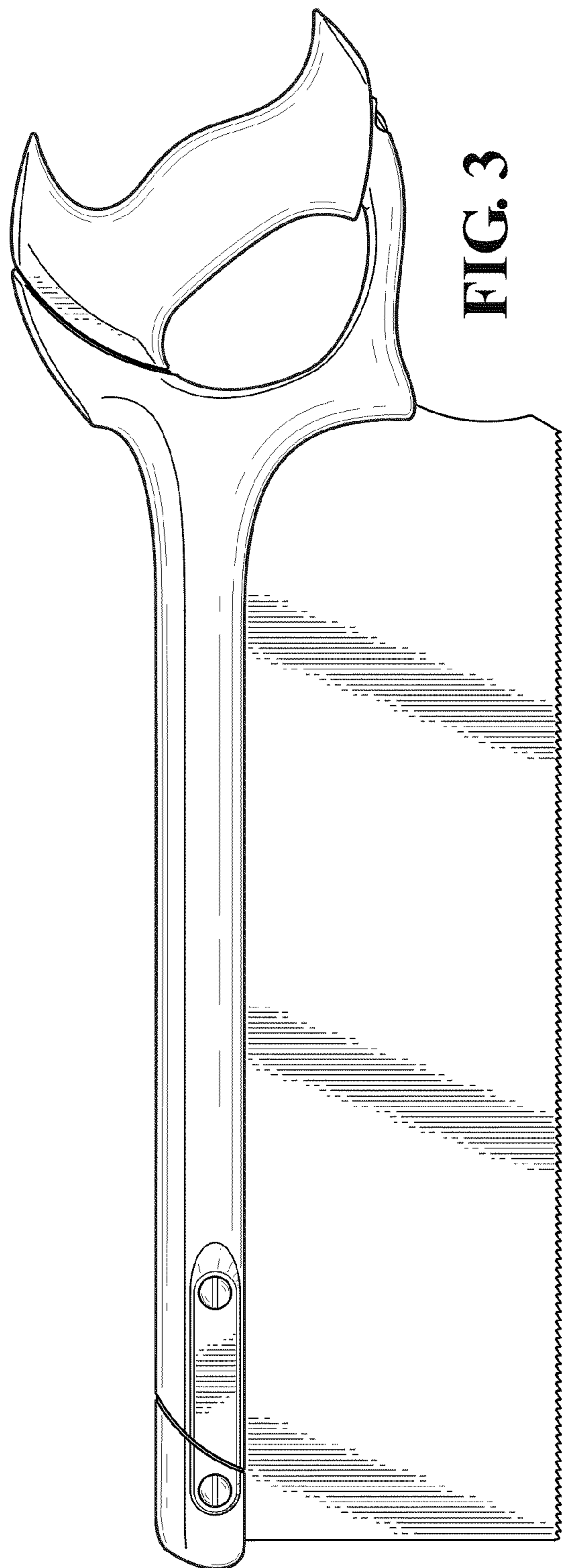

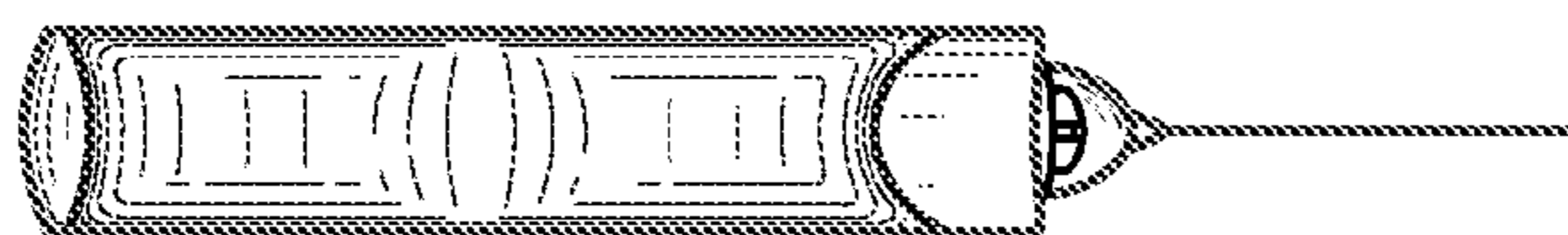

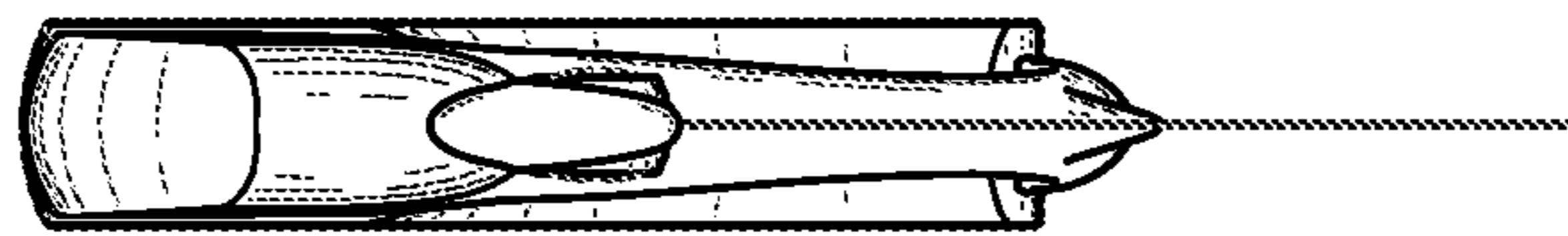

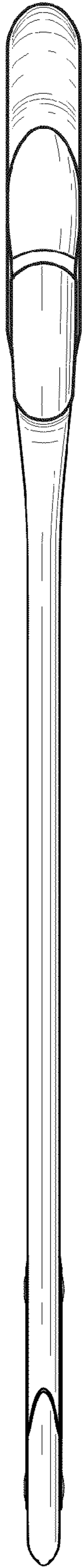

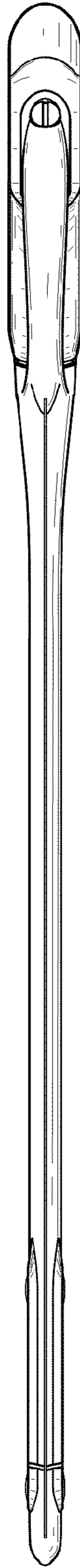
