FIG. 2 is a perspective view of a small washer according to the present invention;

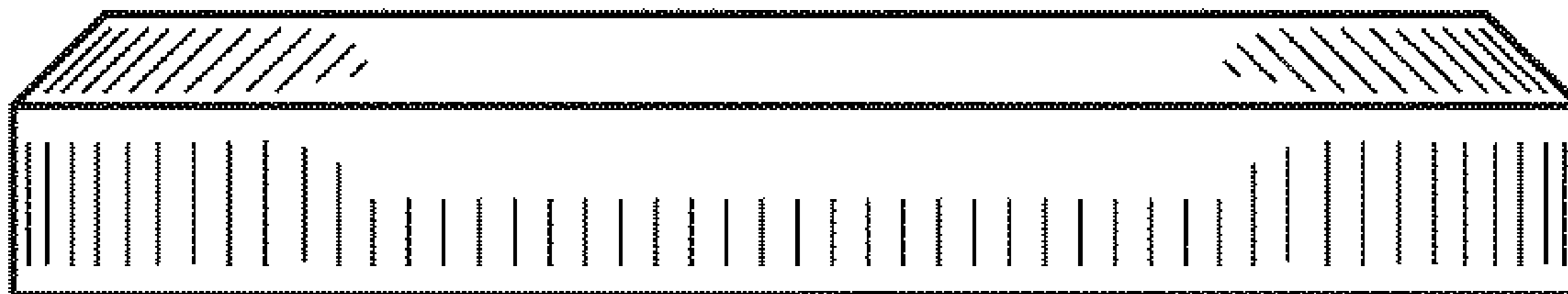
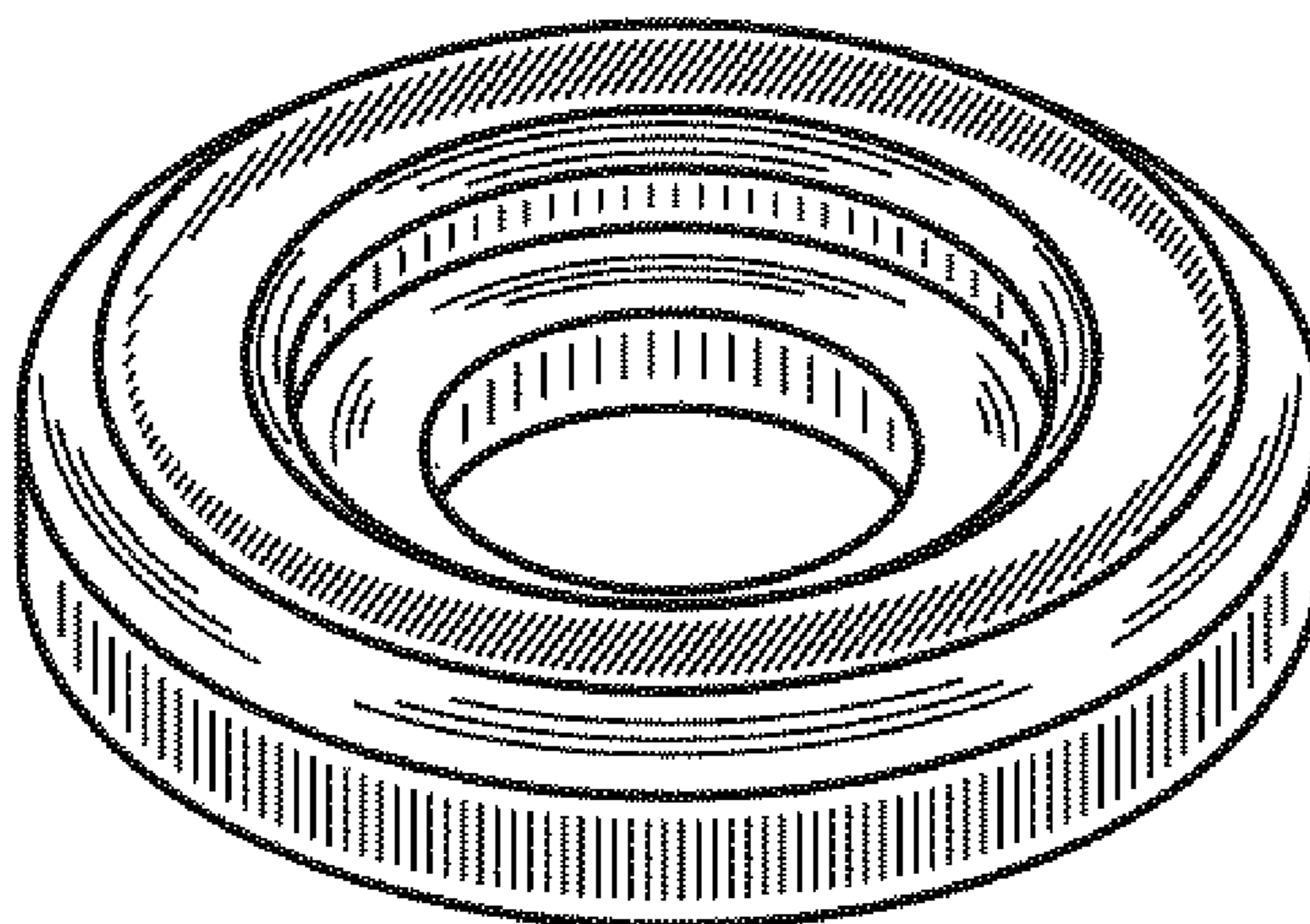
FIG. 3 is a top plan view thereof;

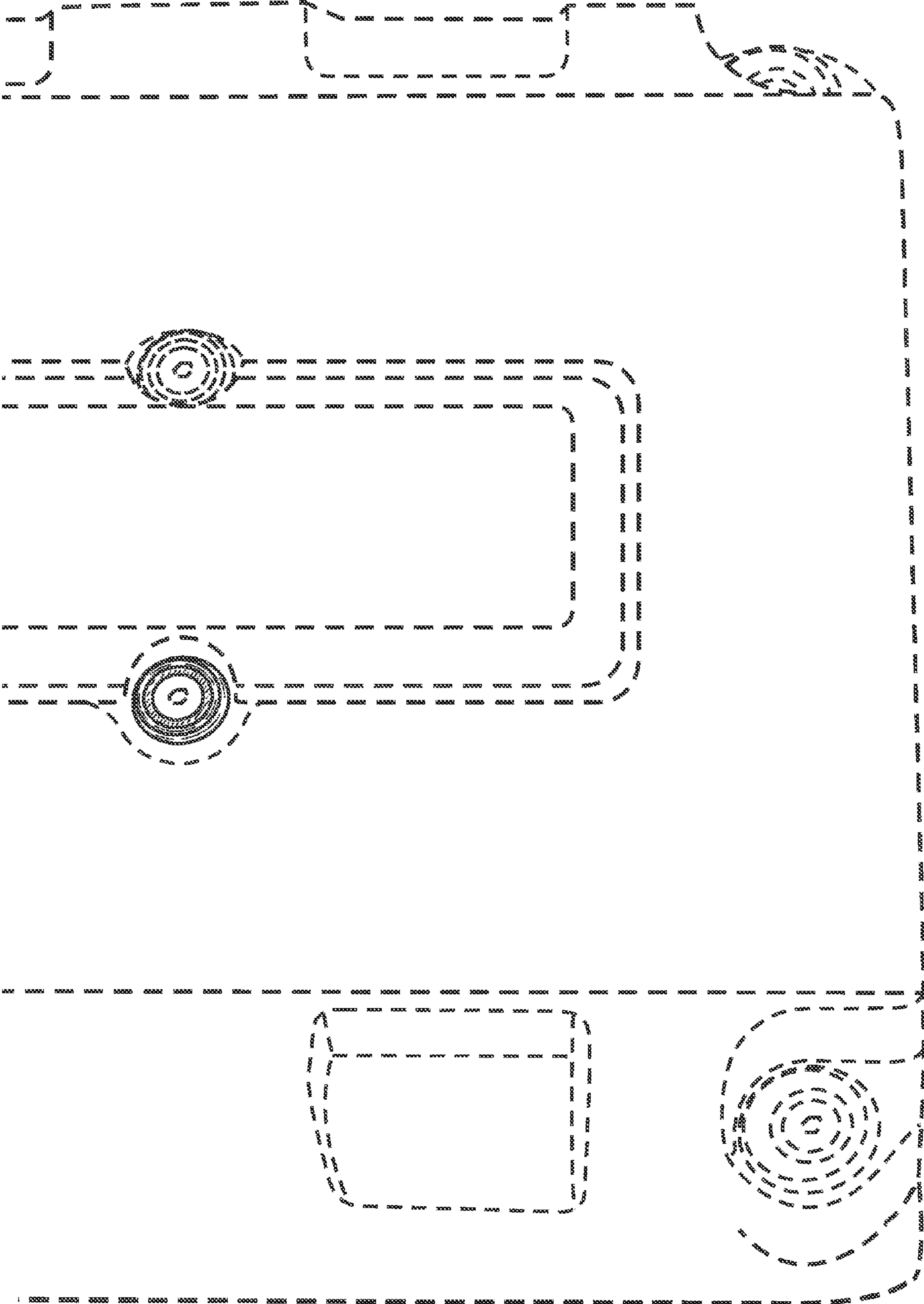

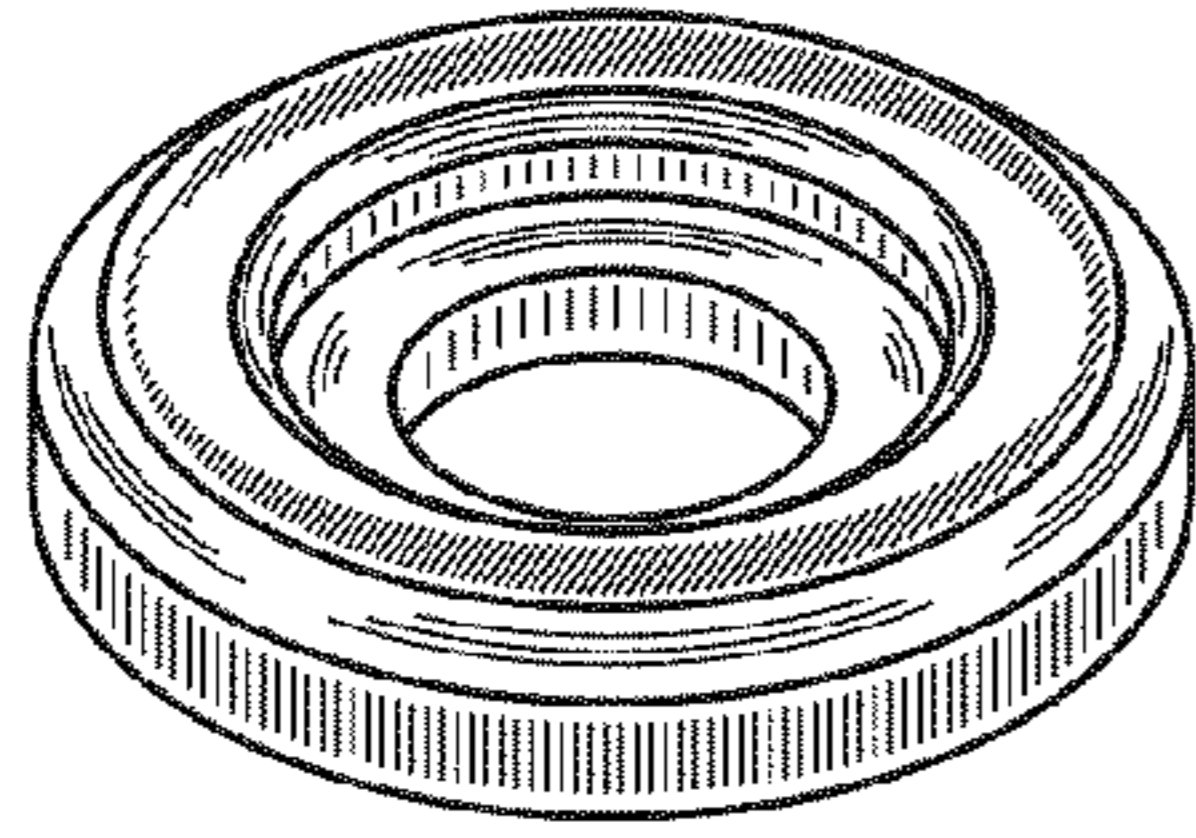

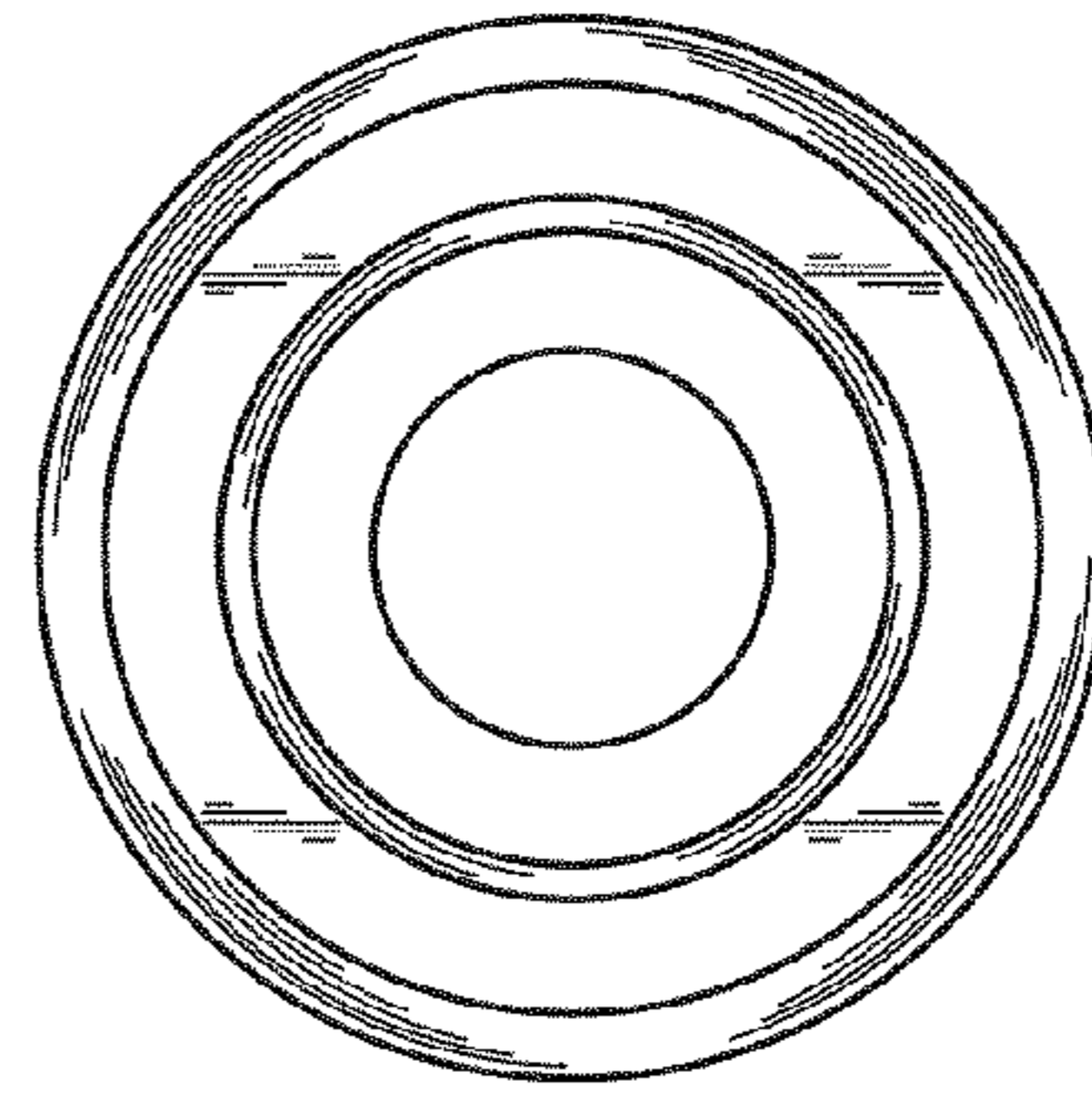

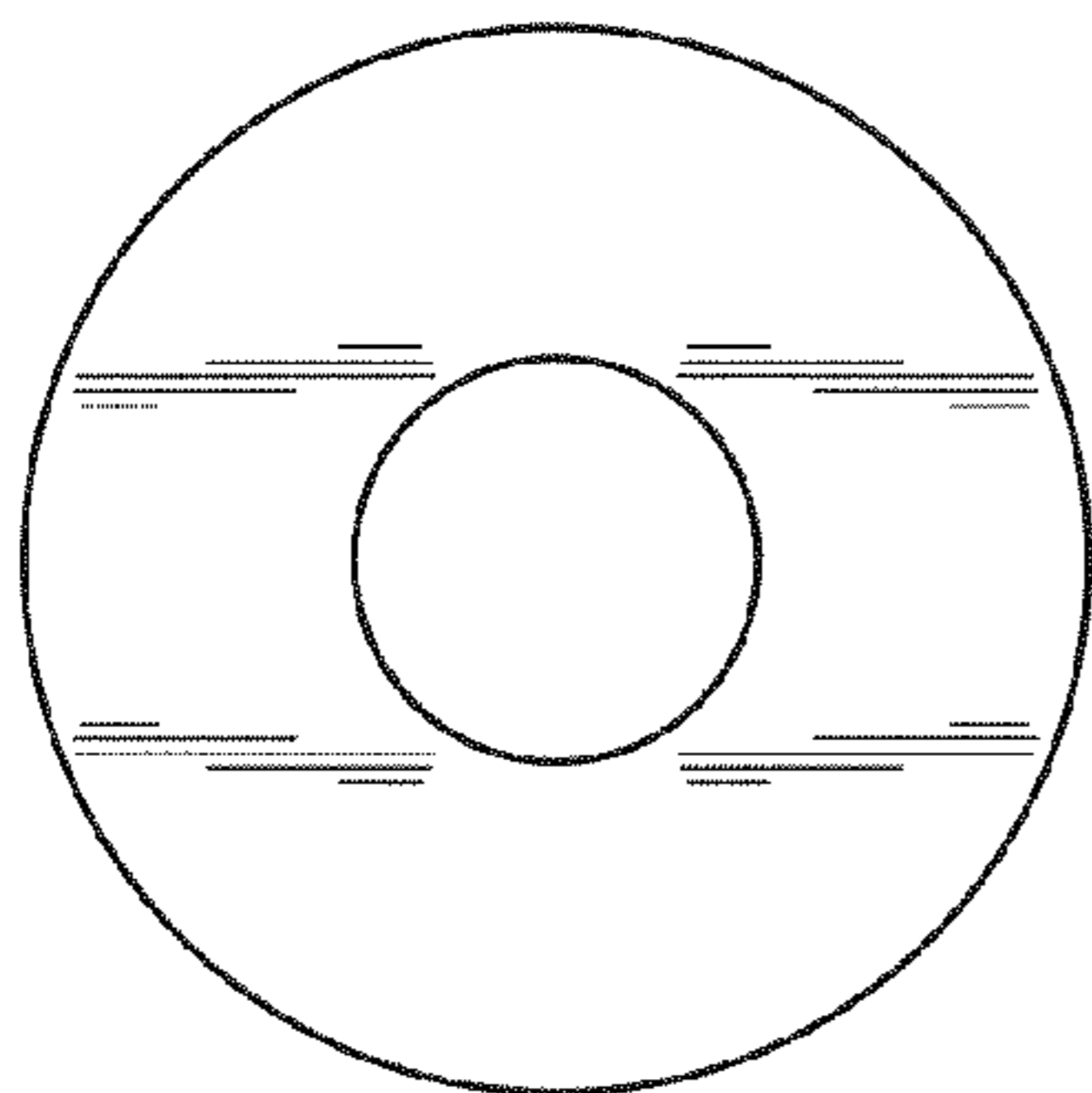

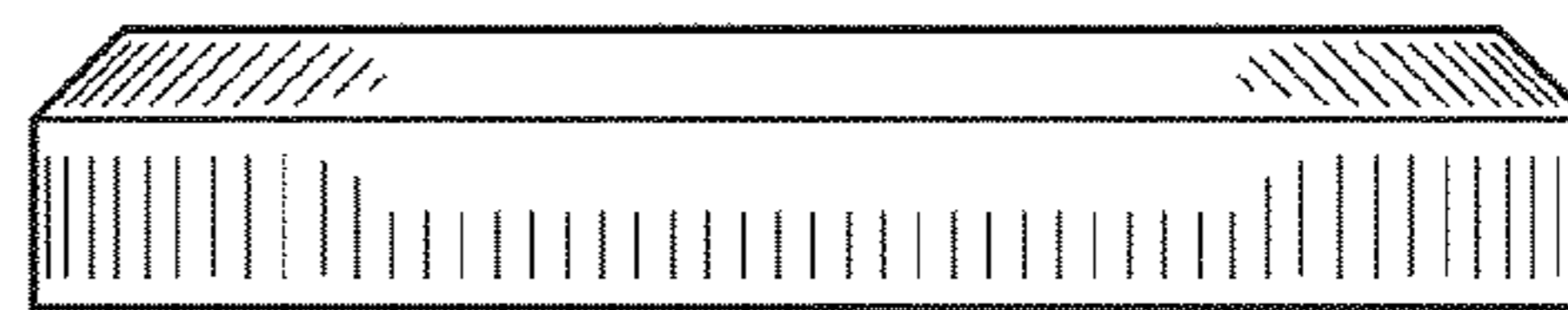
