**DESCRIPTION**

FIG. 25 is a left side elevational view of the fourth embodiment thereof;

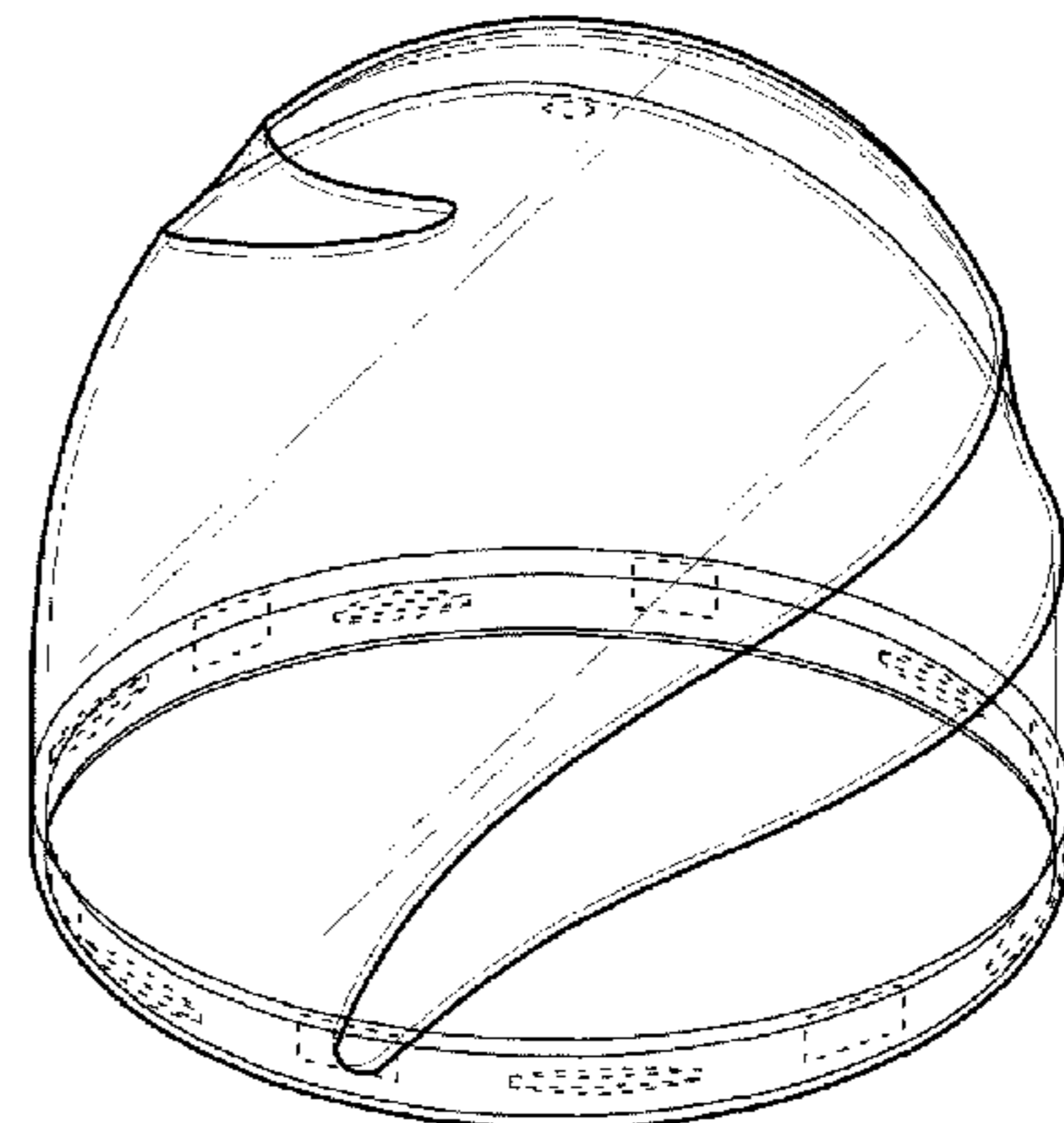
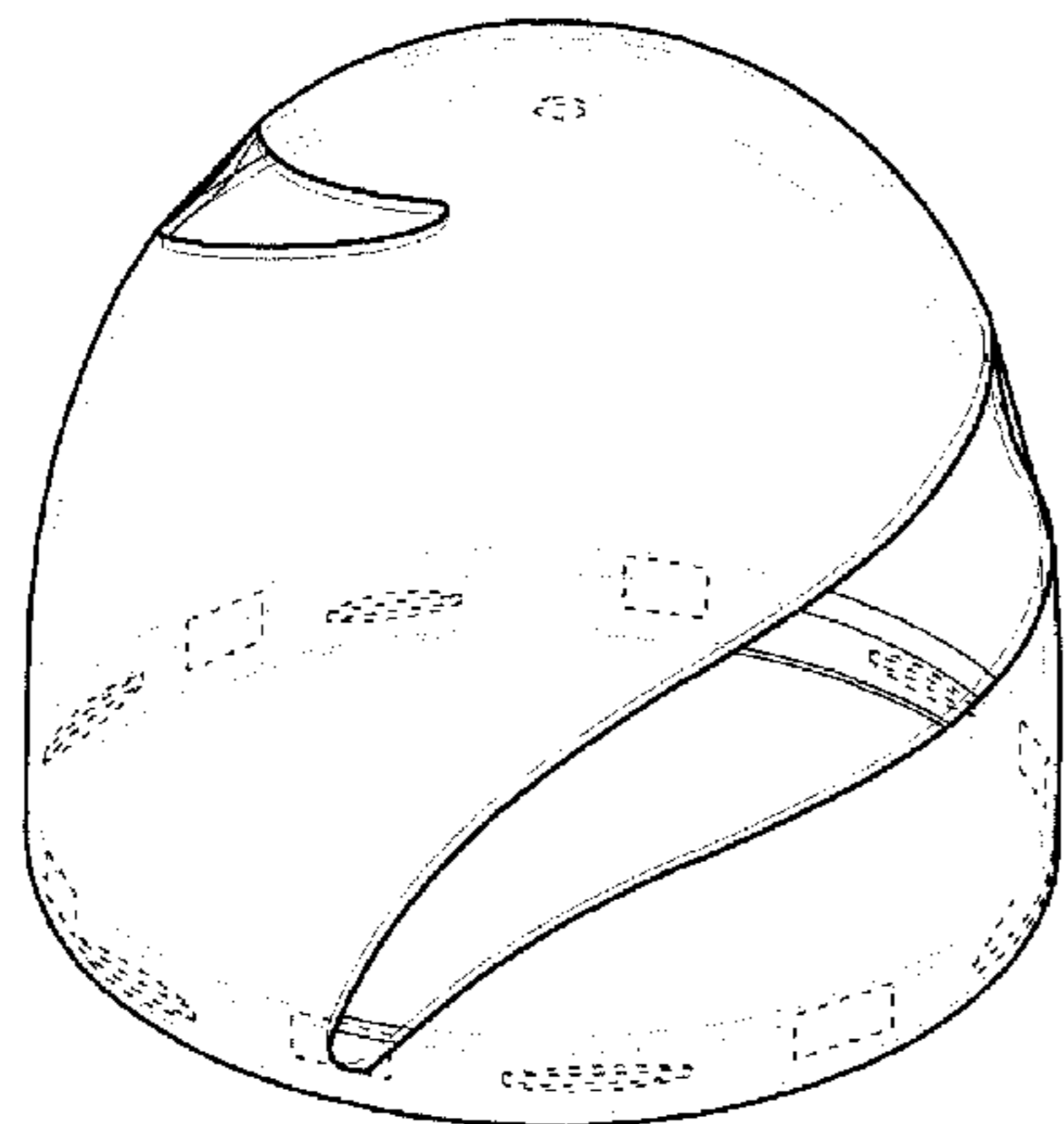
FIG. 26 is a right side elevational view of the fourth embodiment thereof;

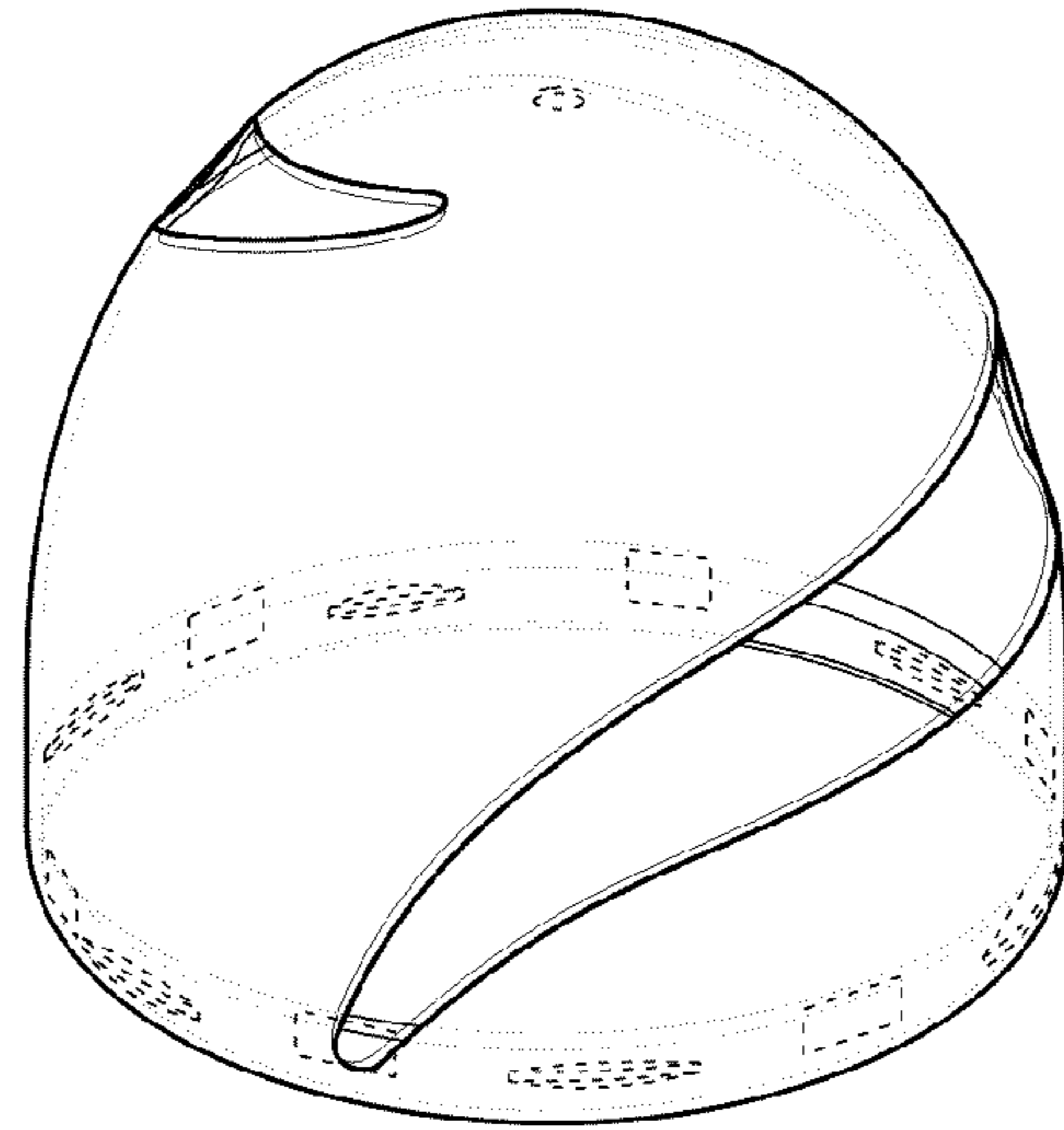

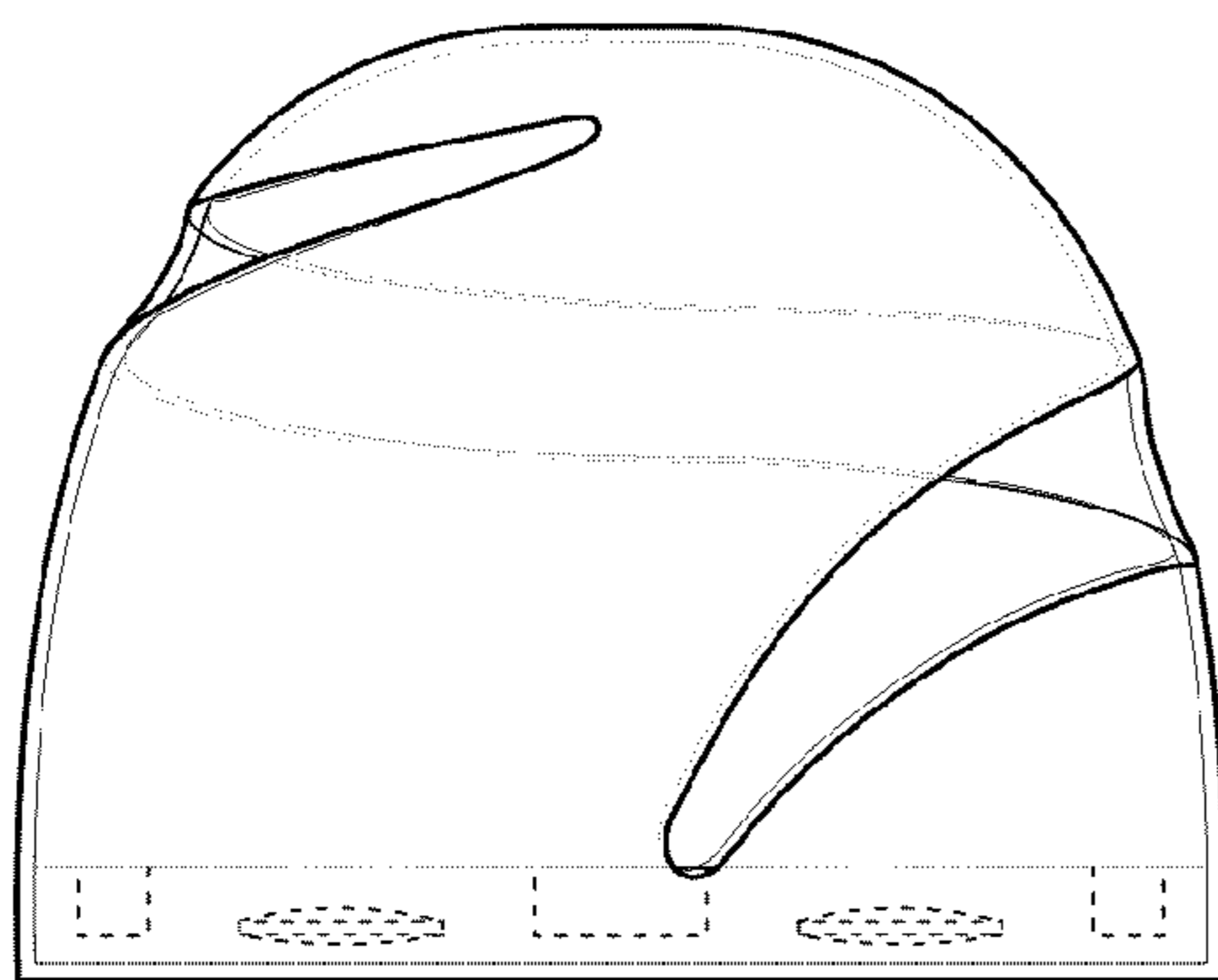

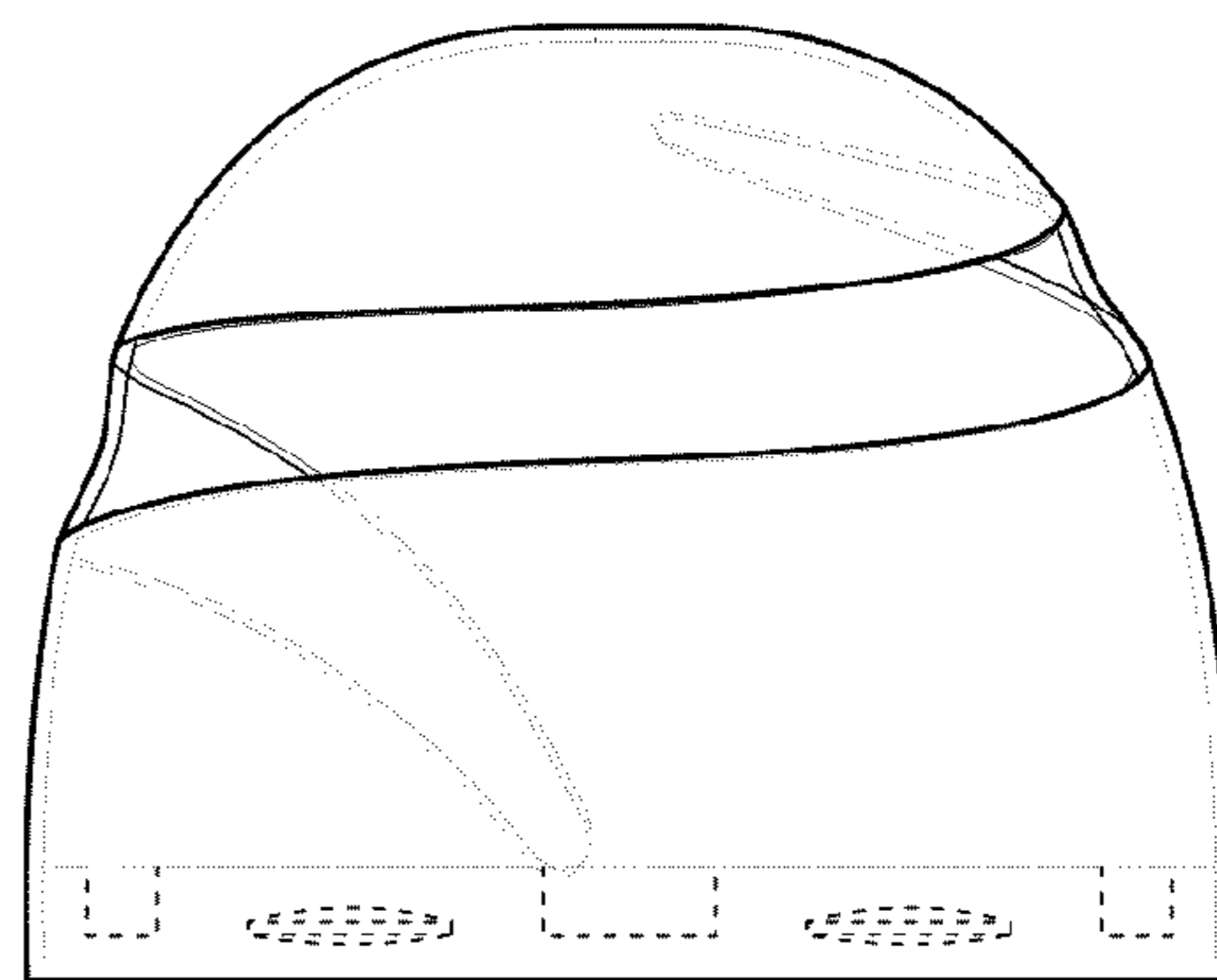

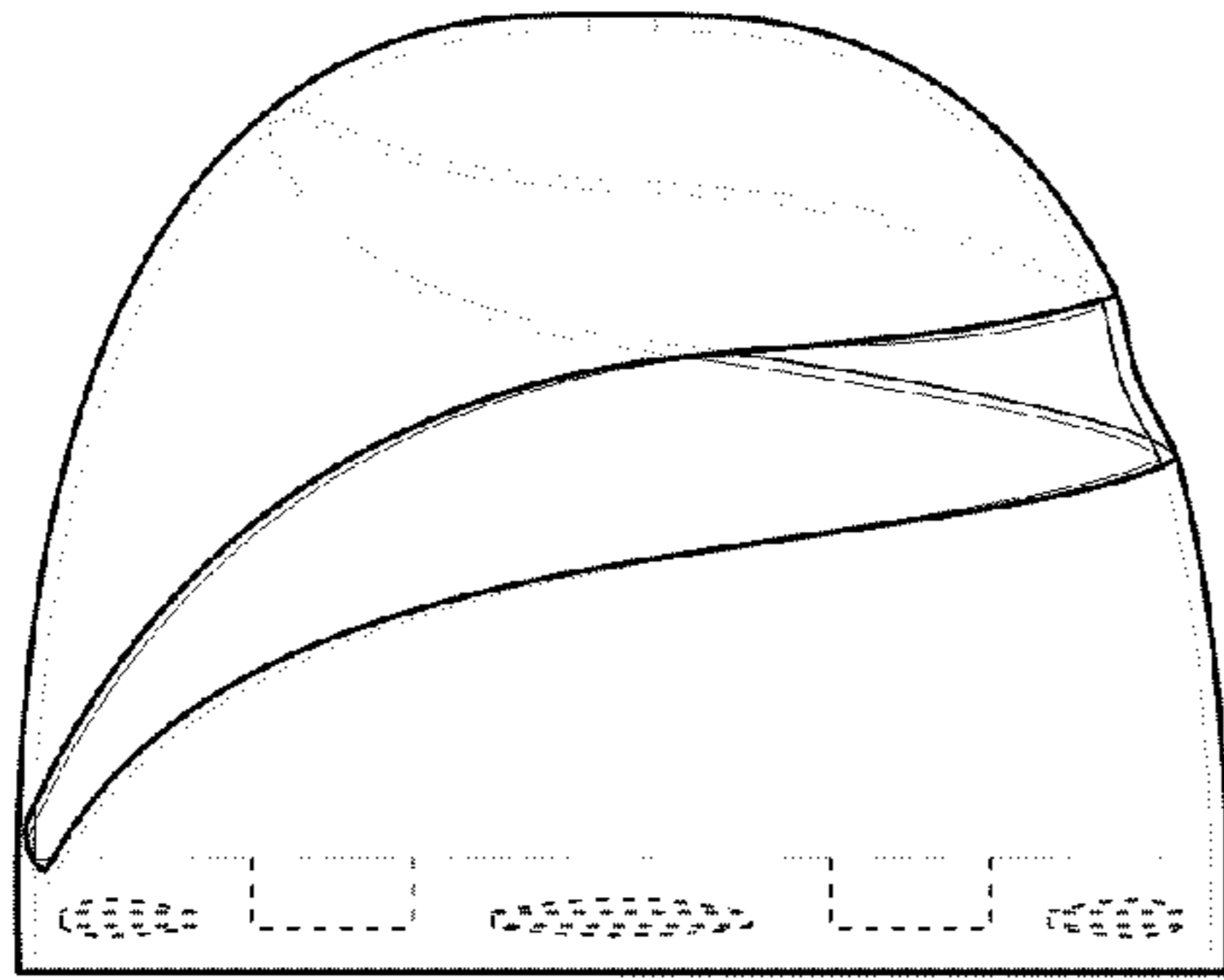

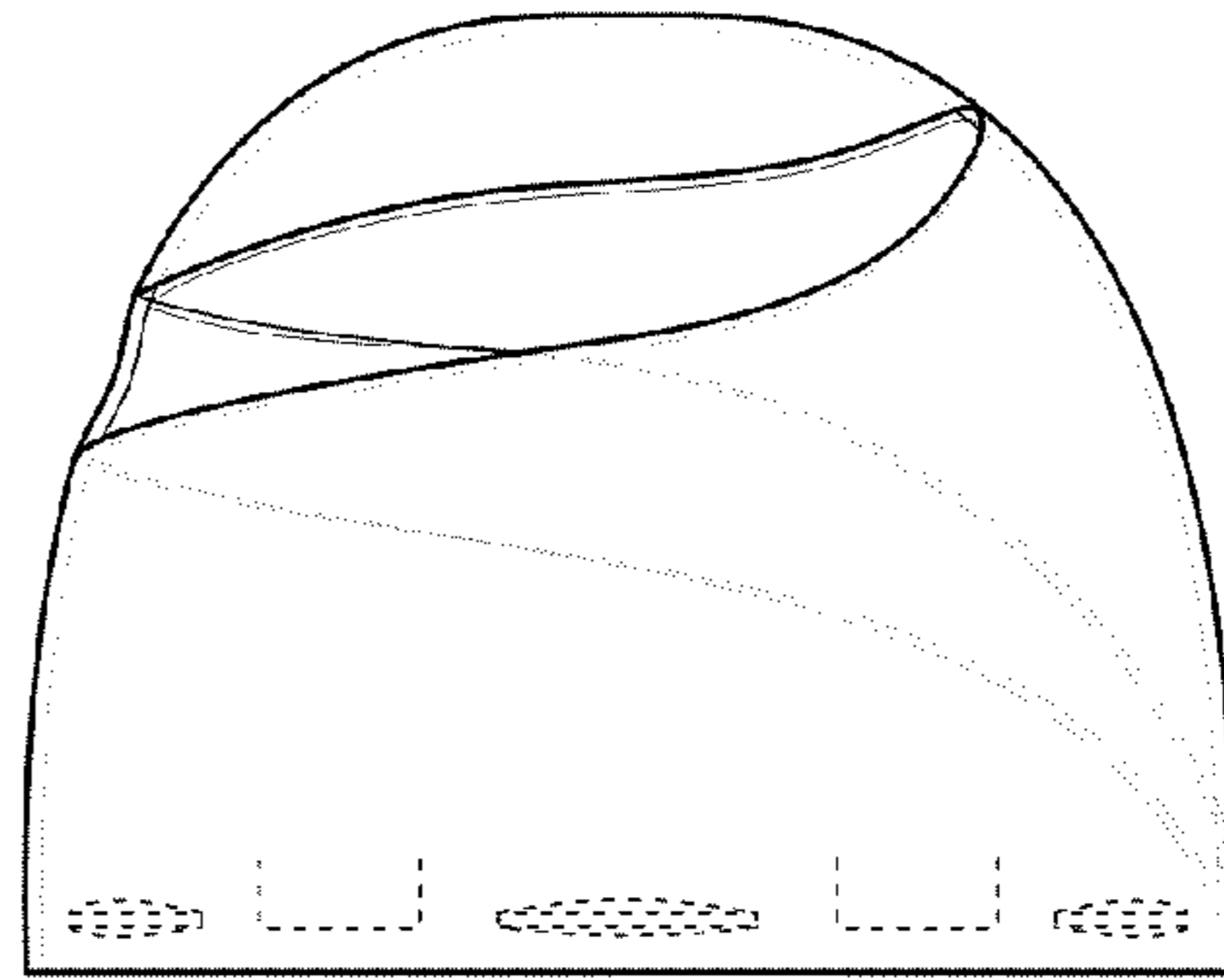

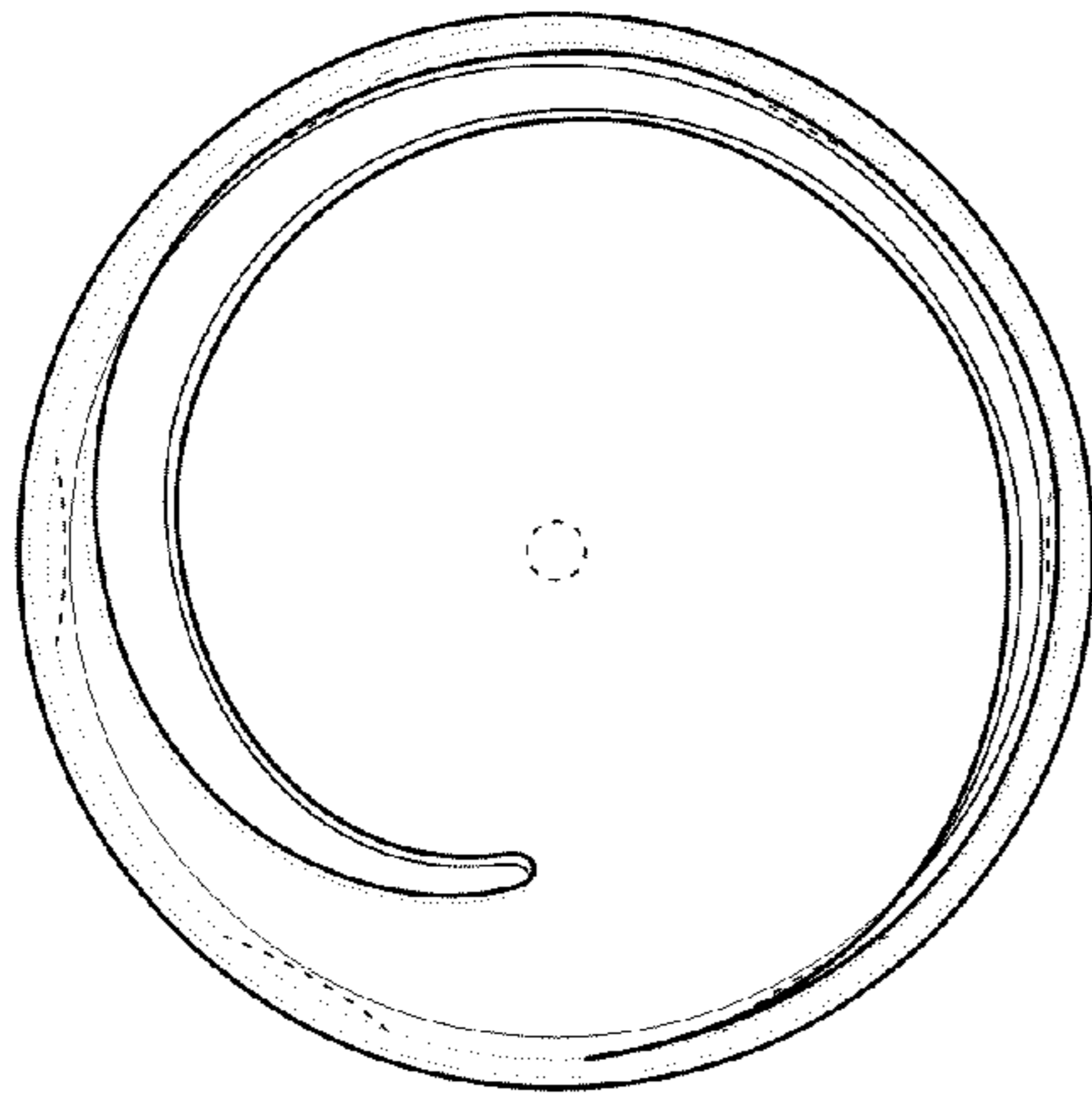

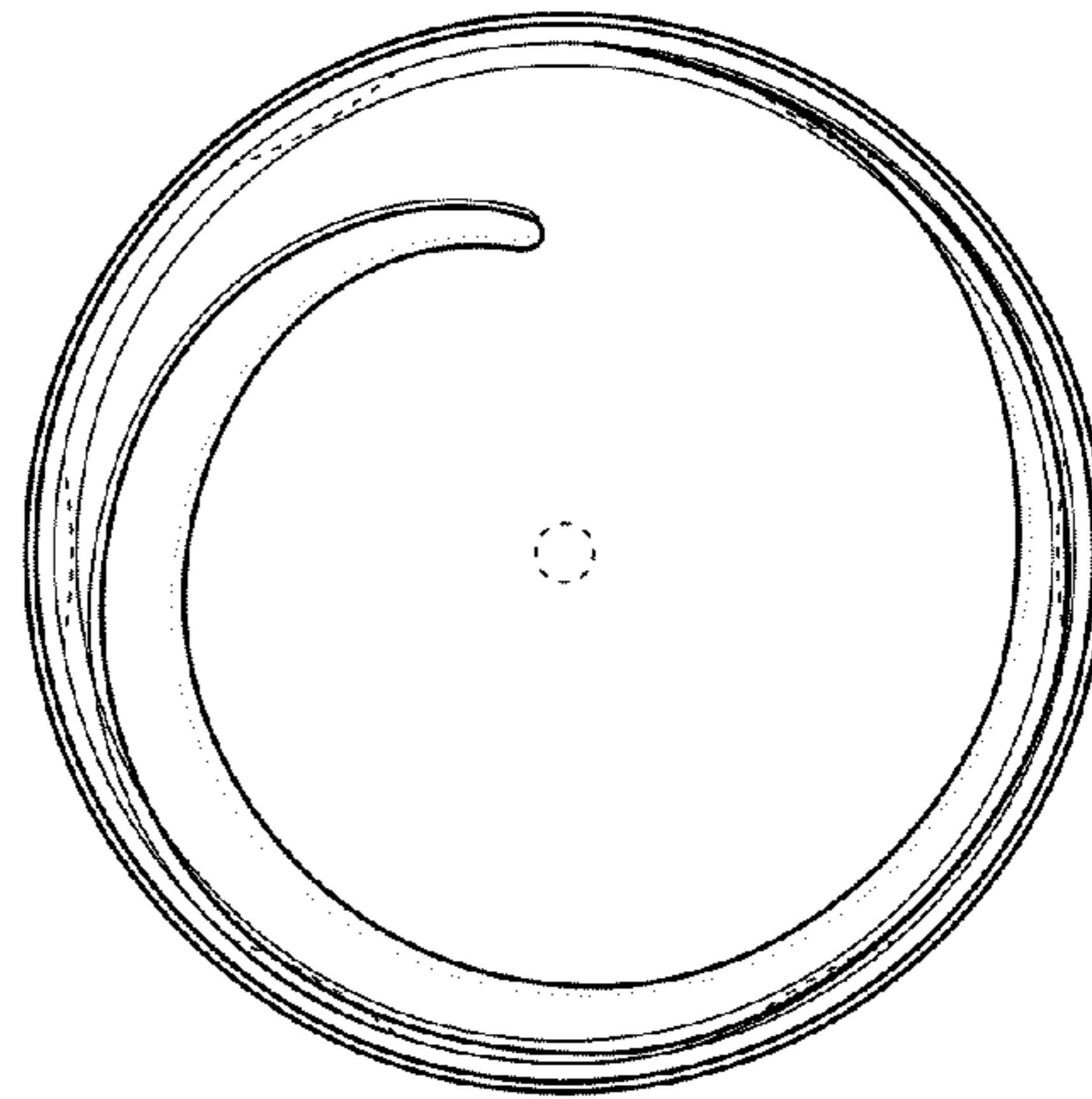

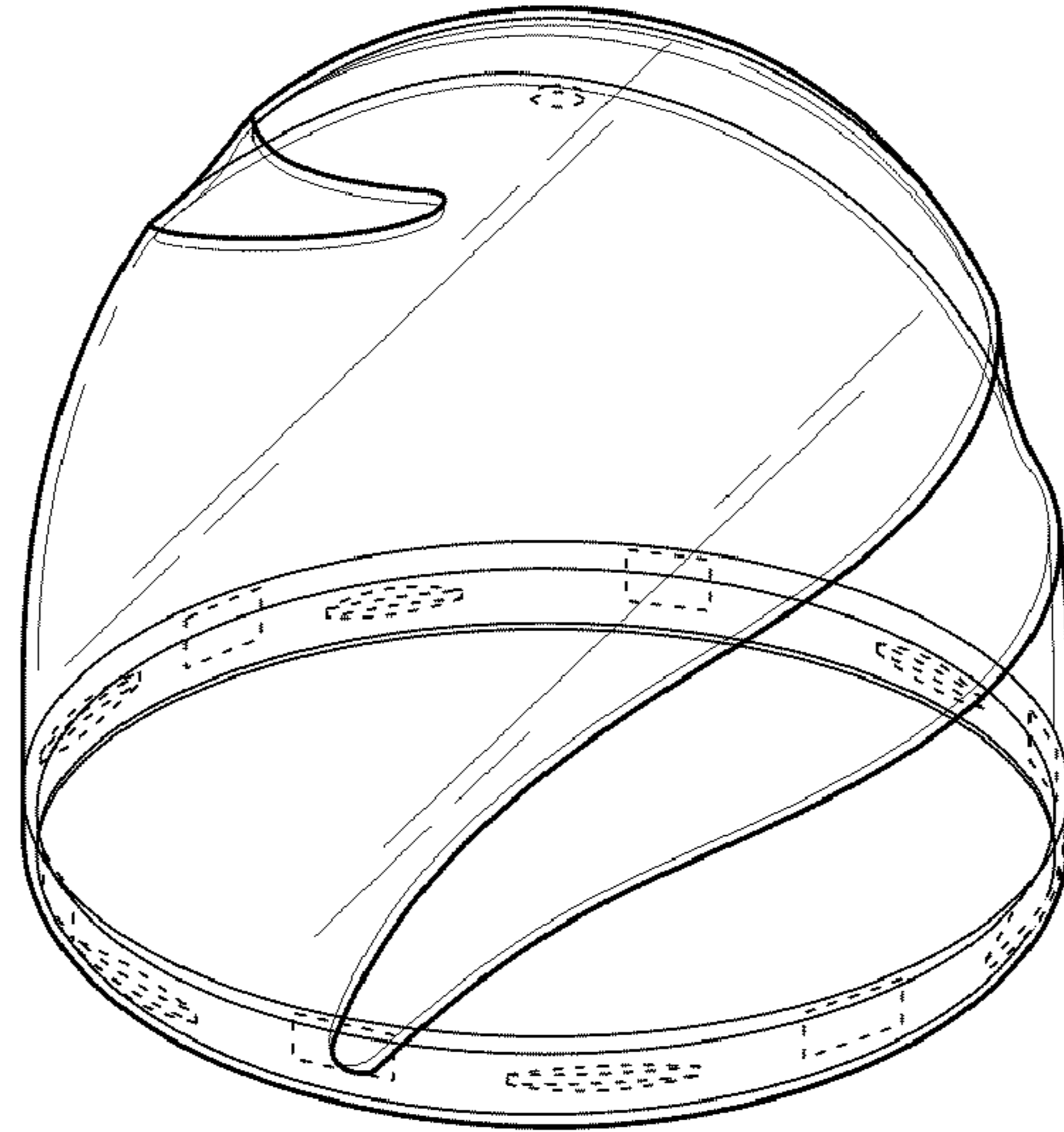

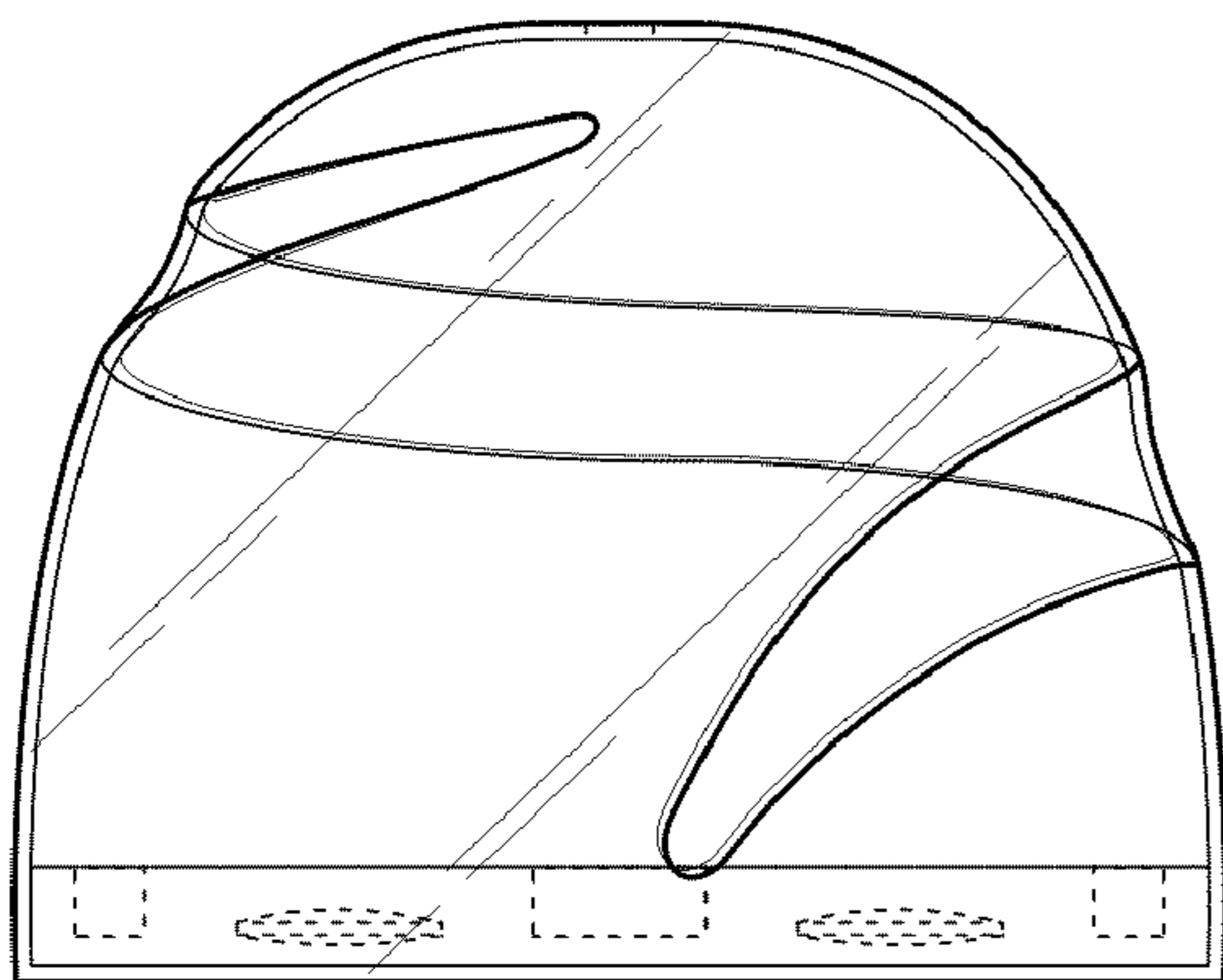

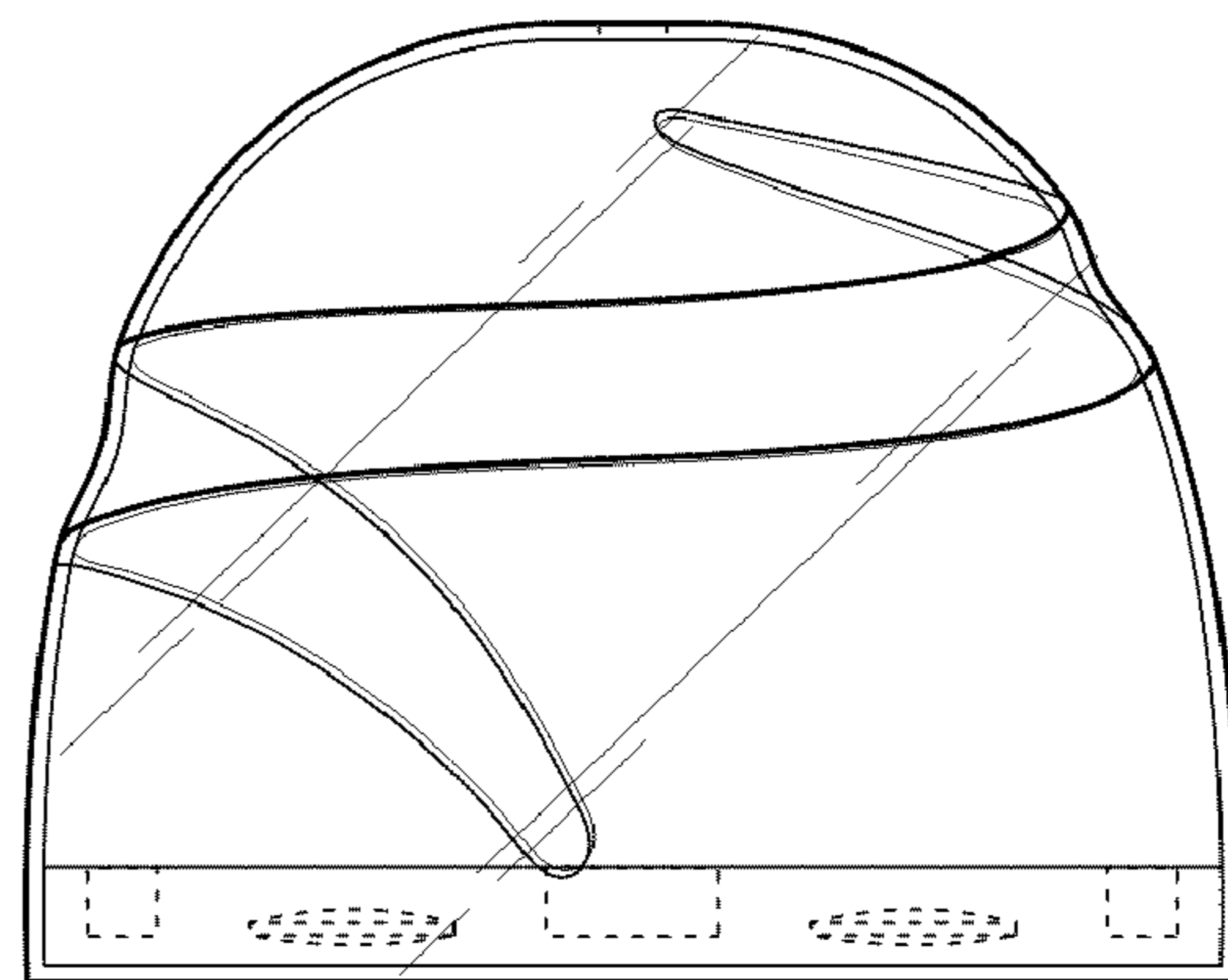

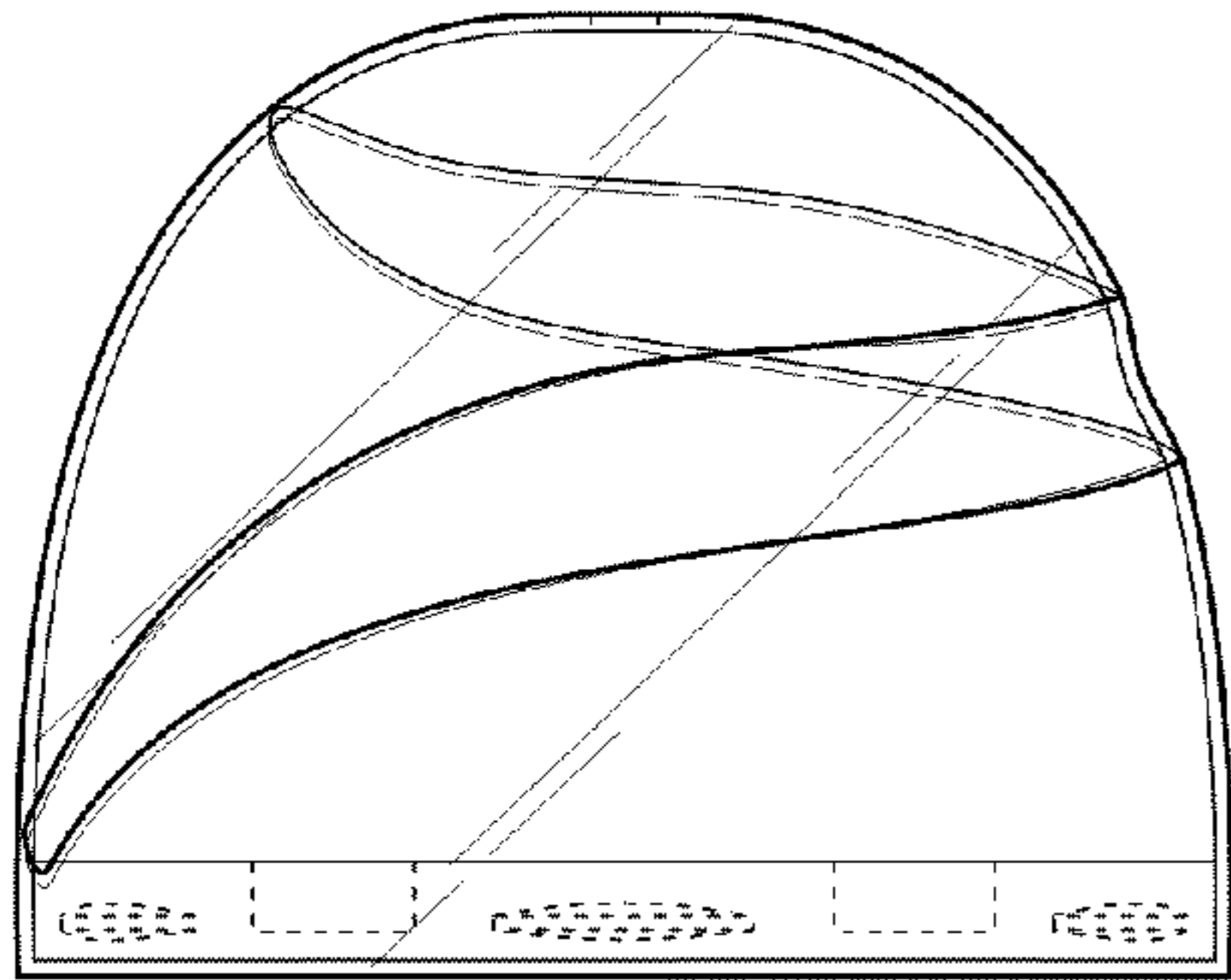

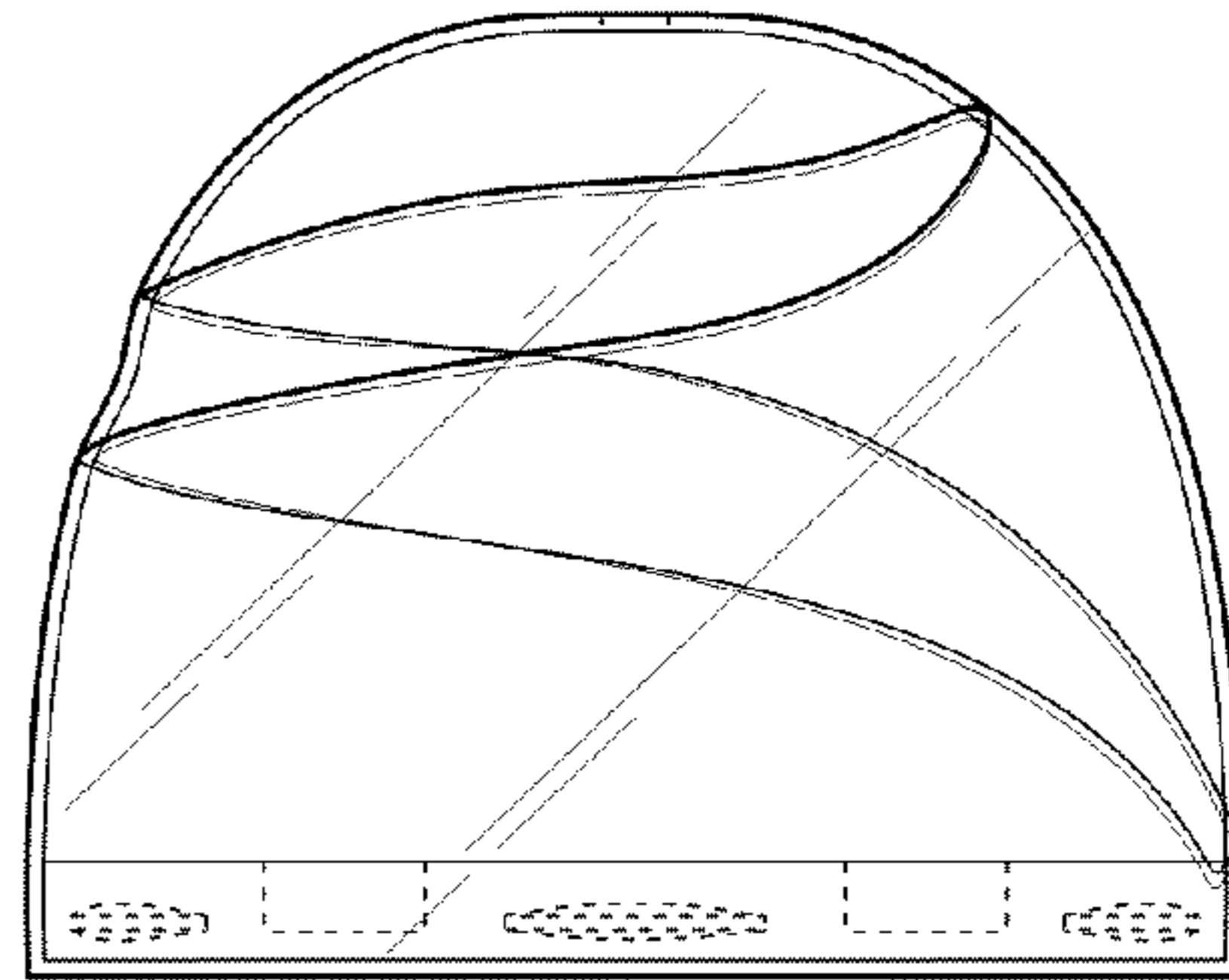

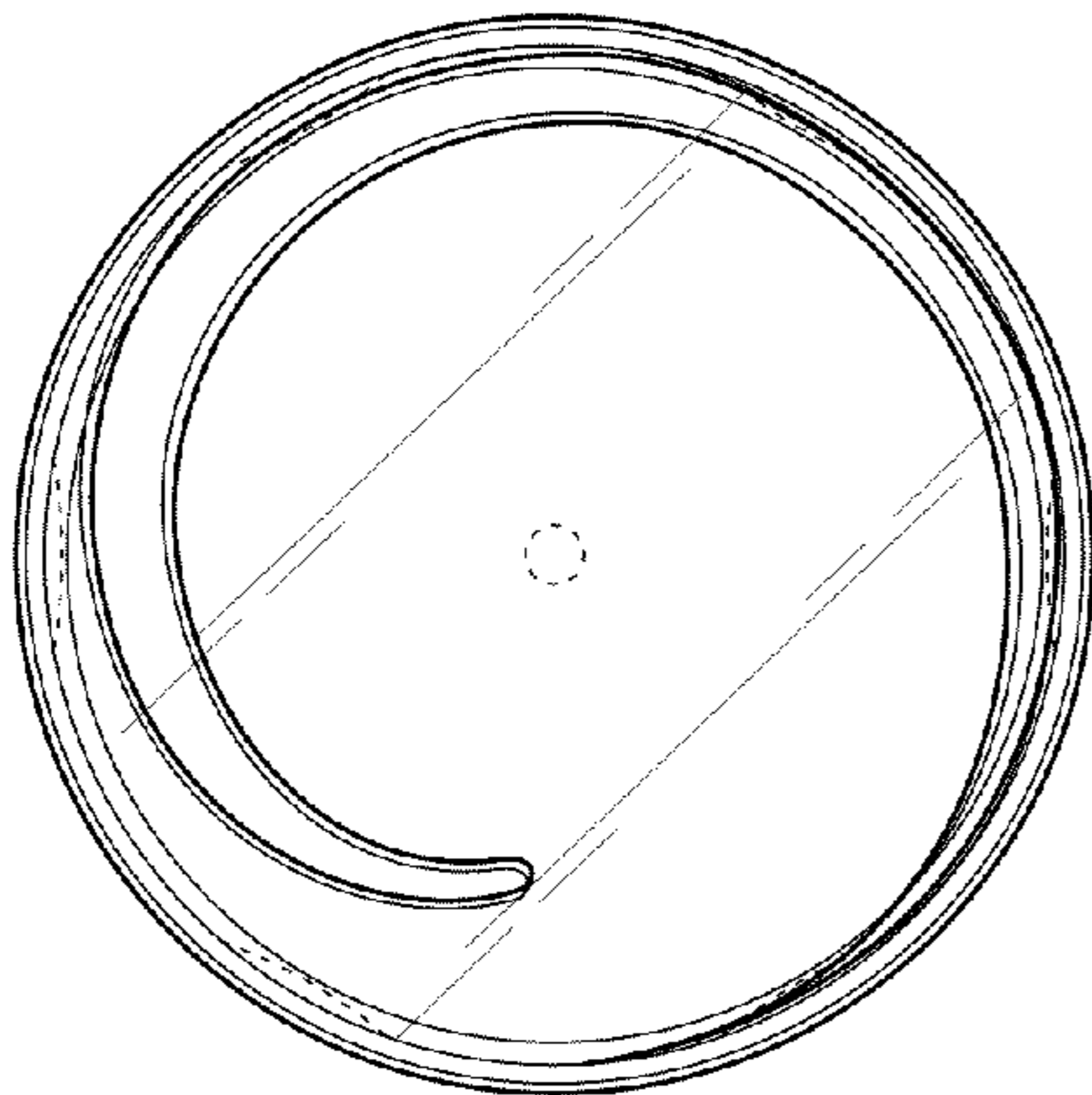

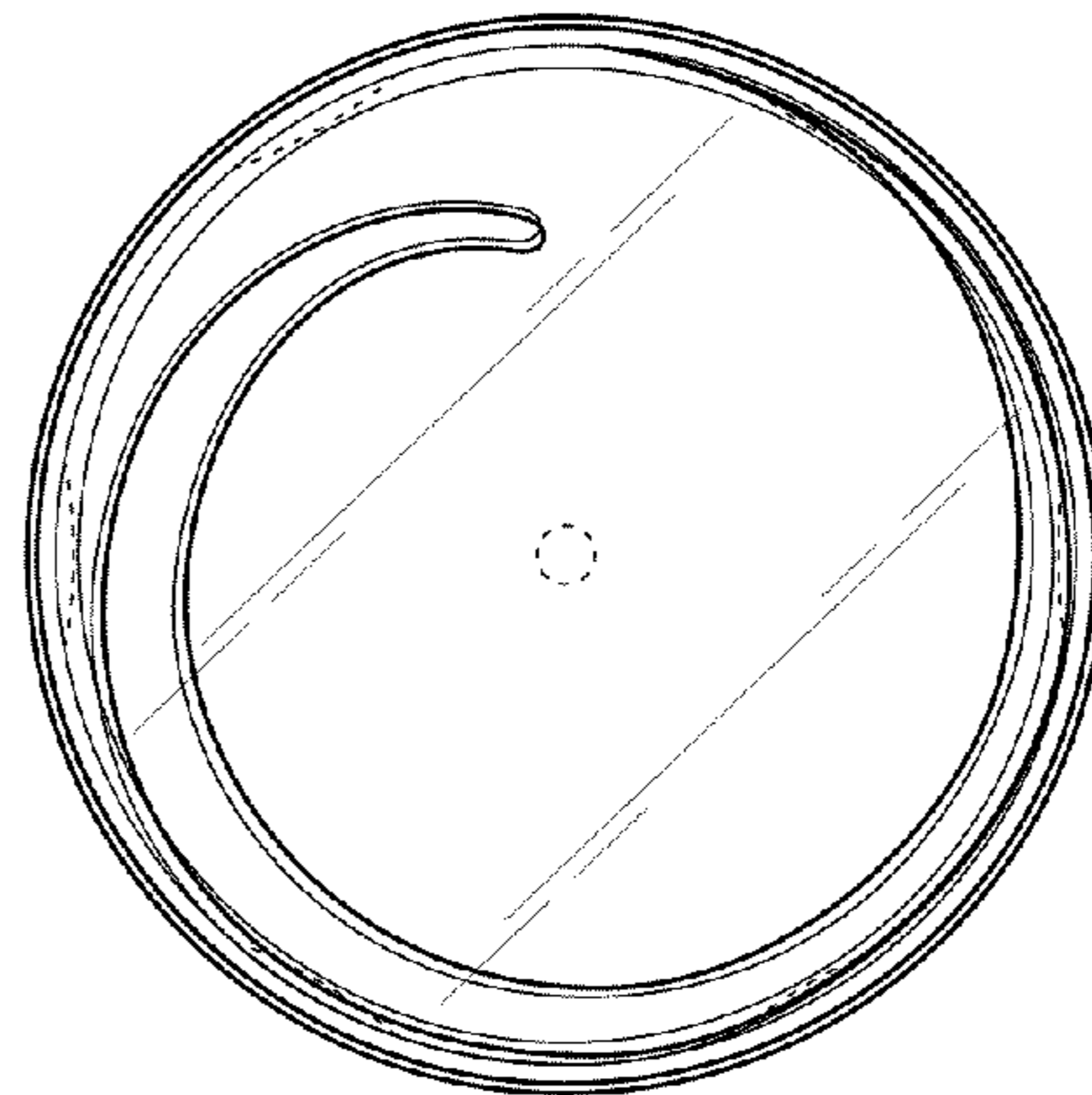

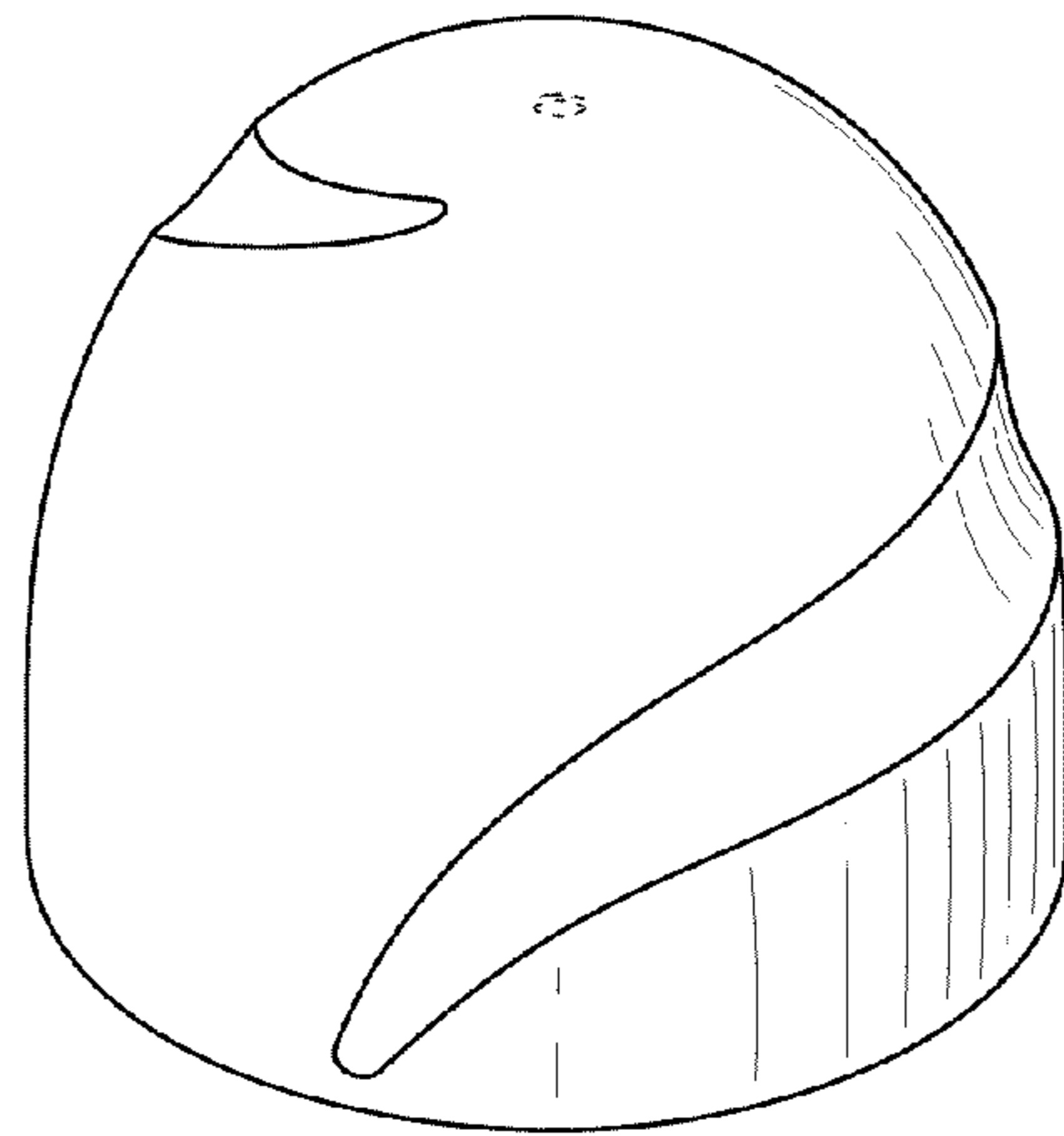

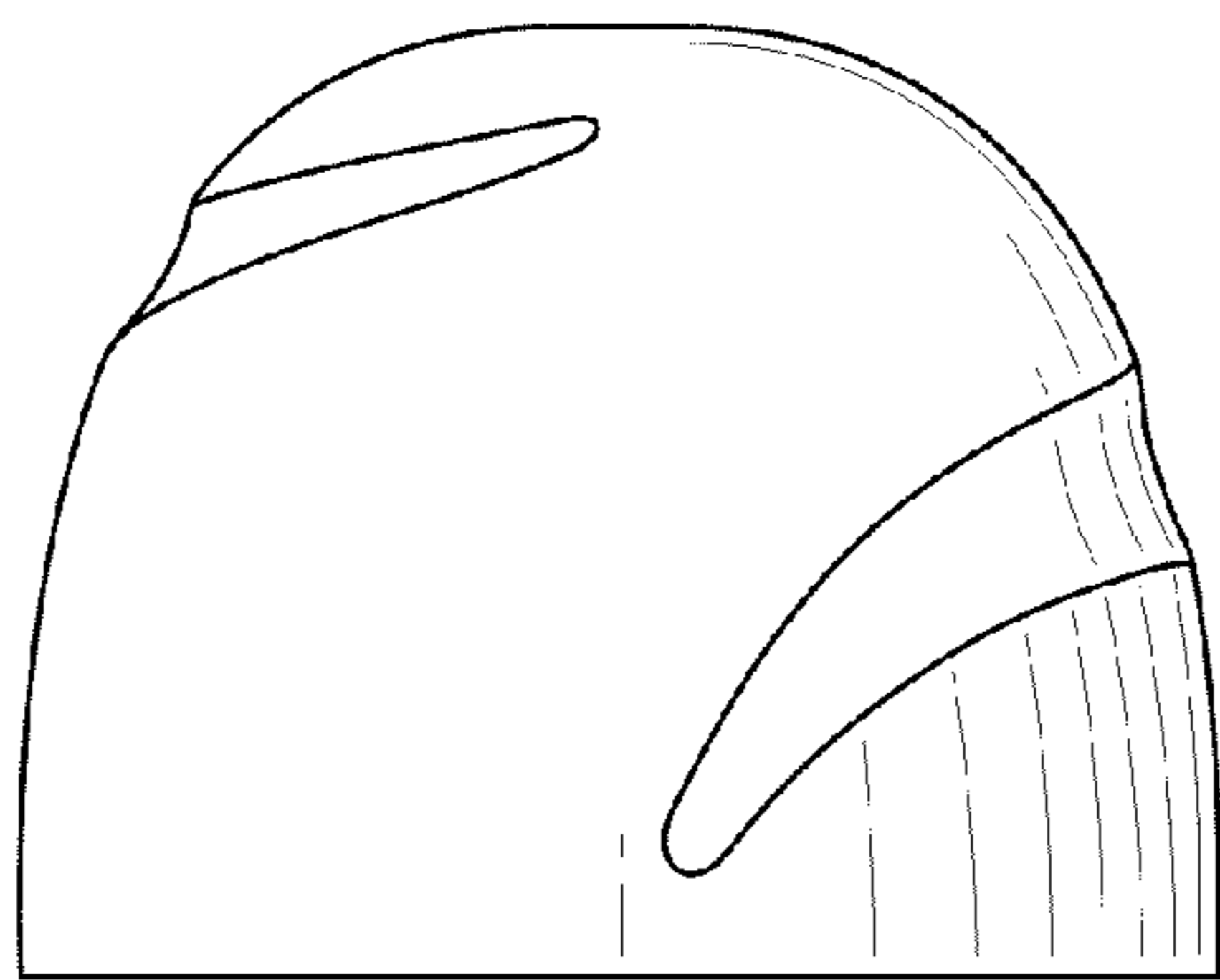

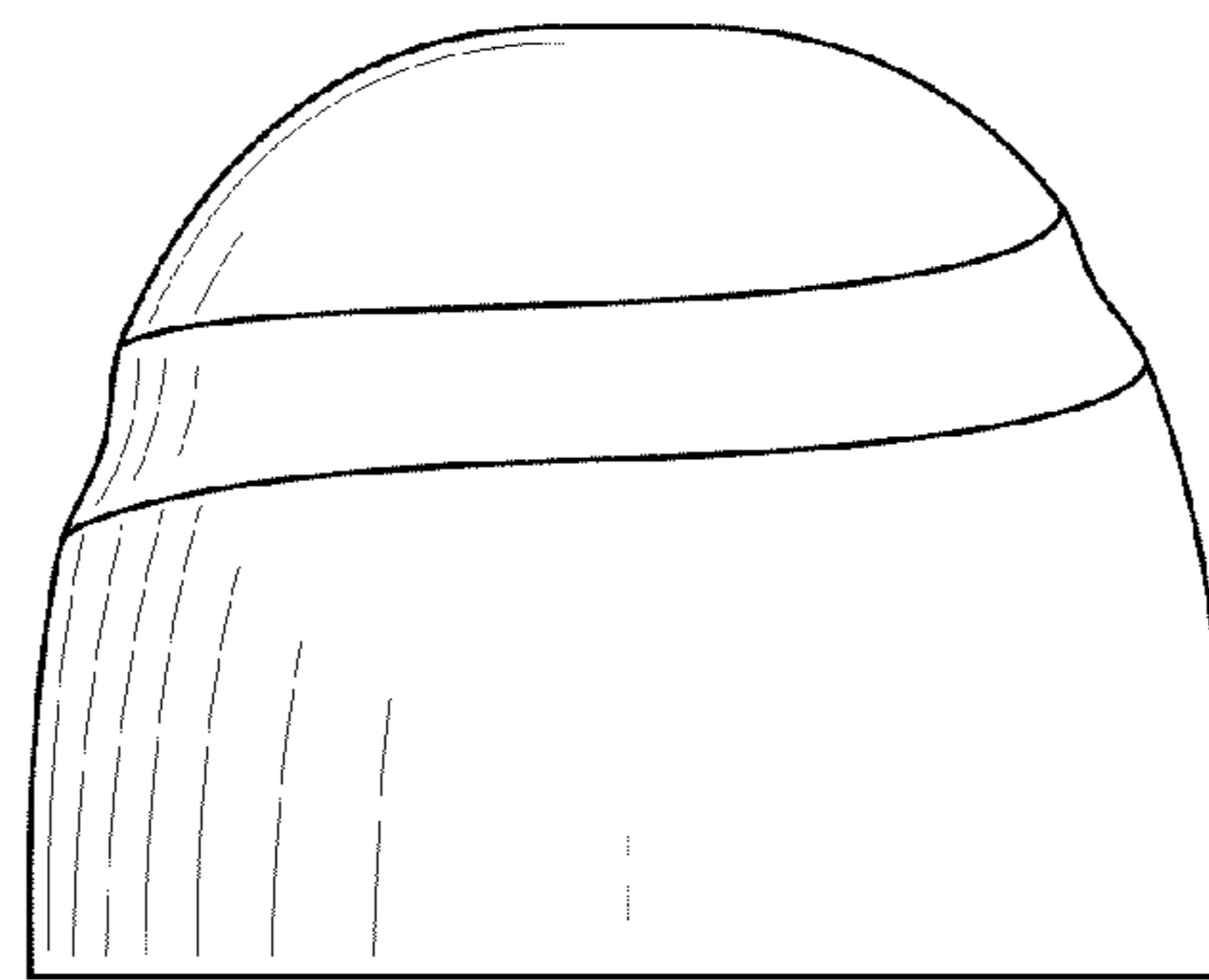

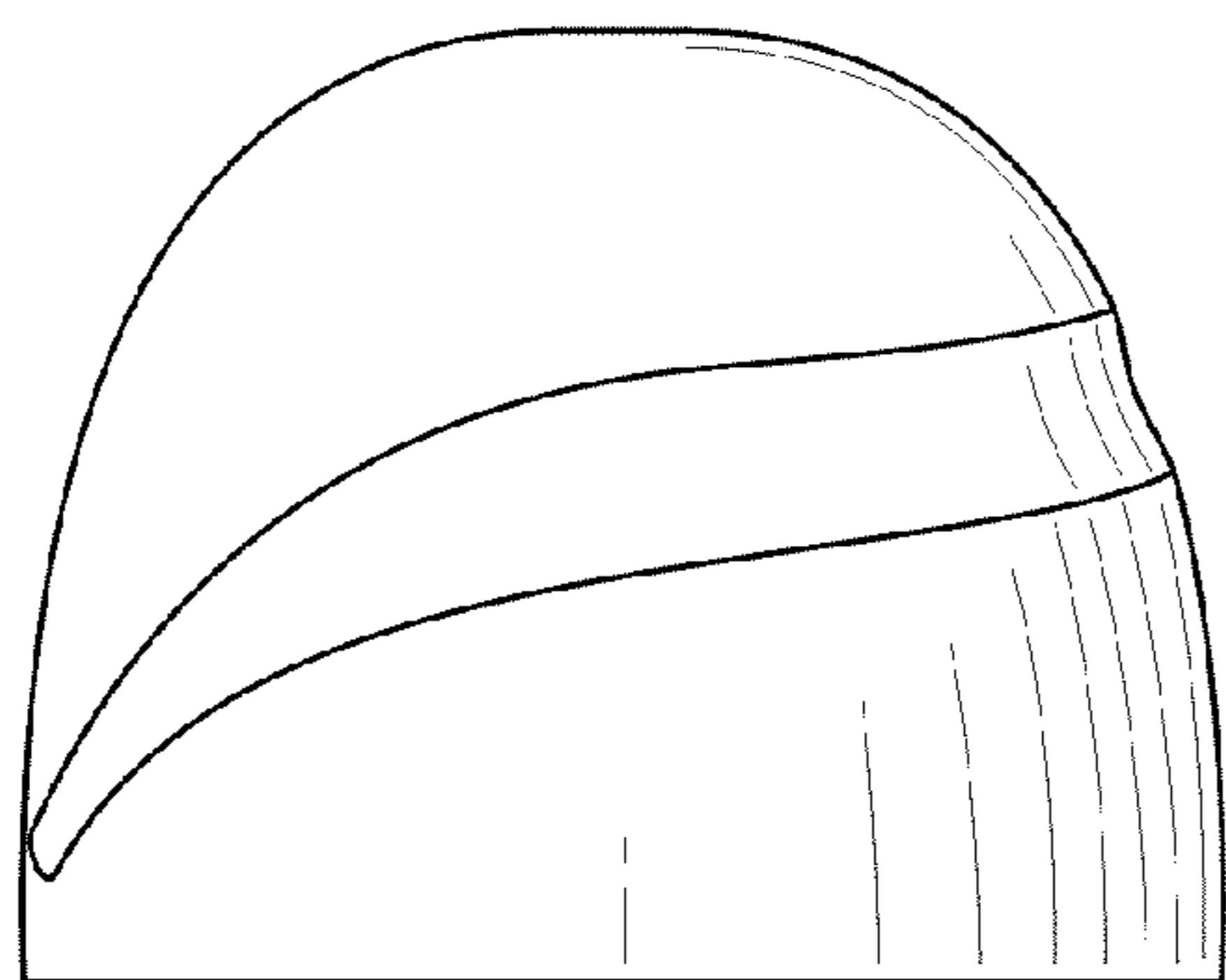

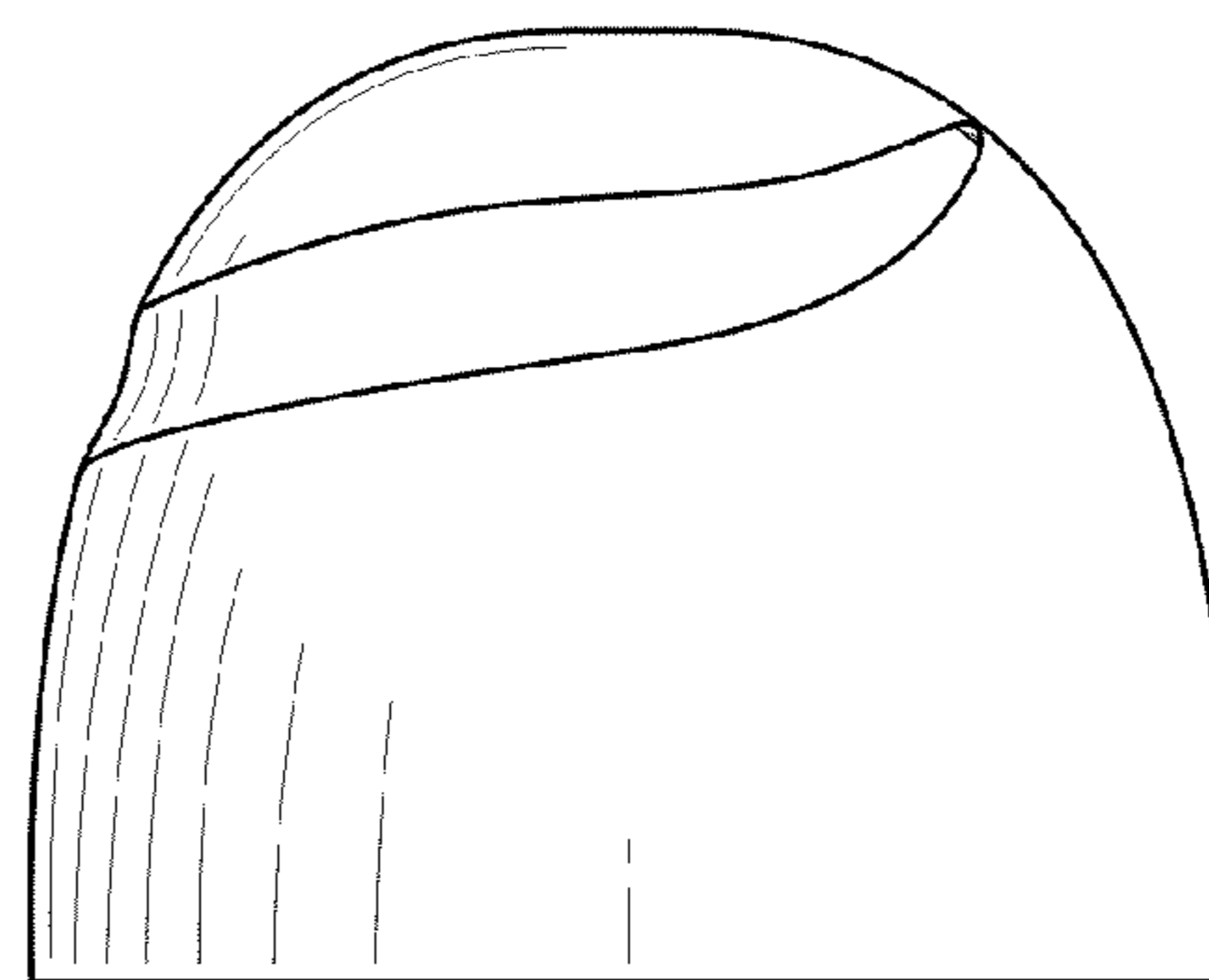

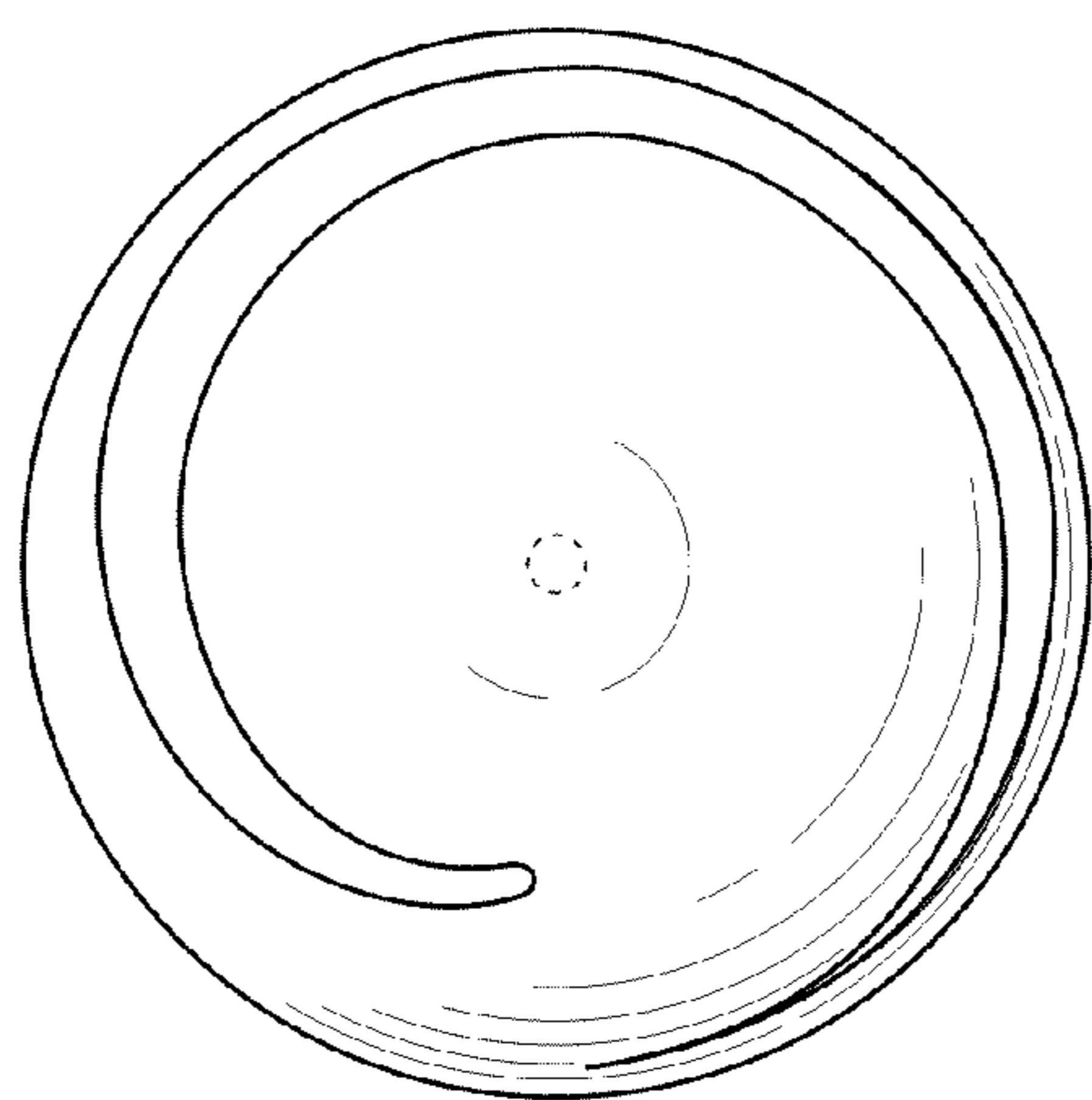

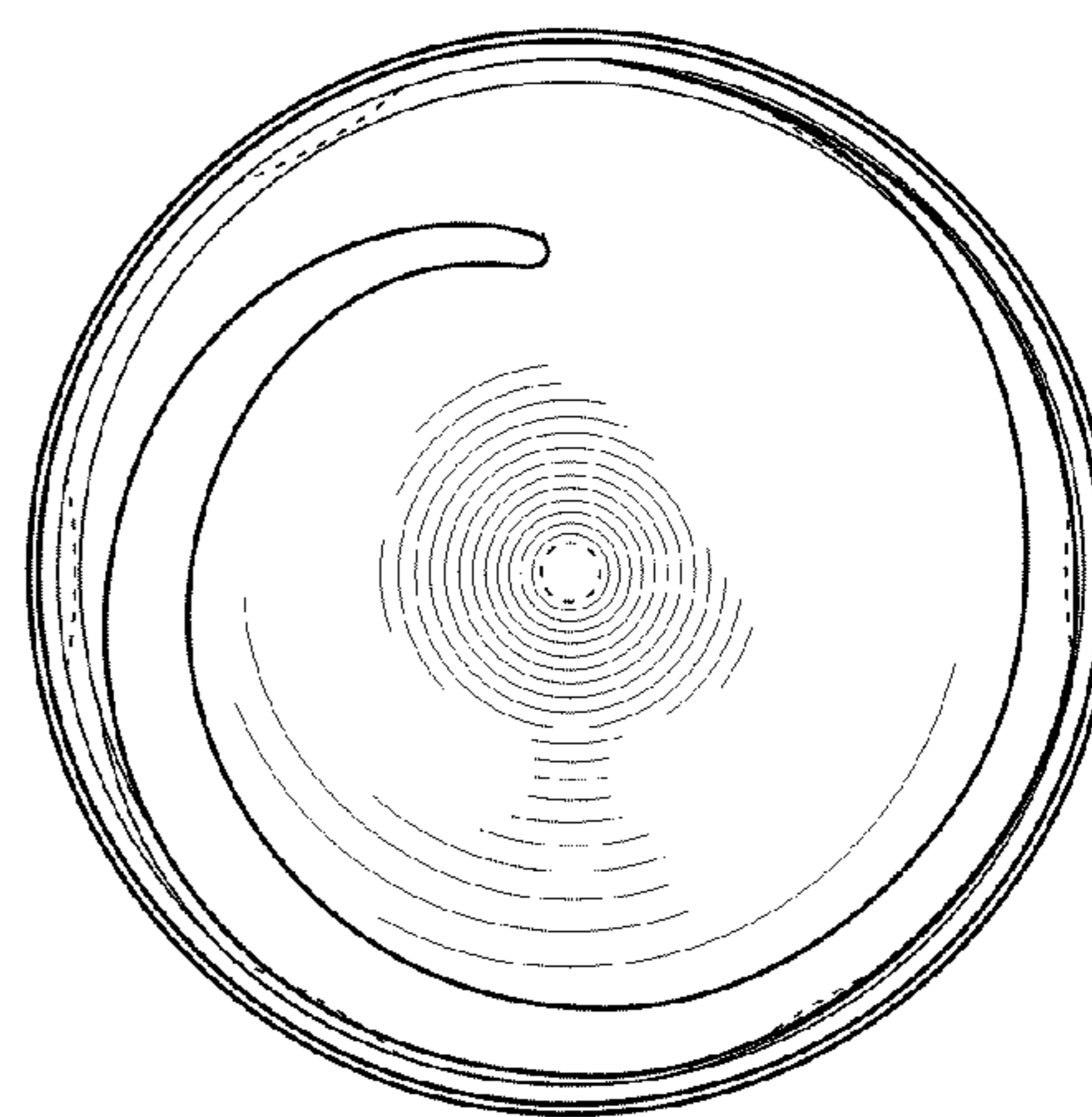

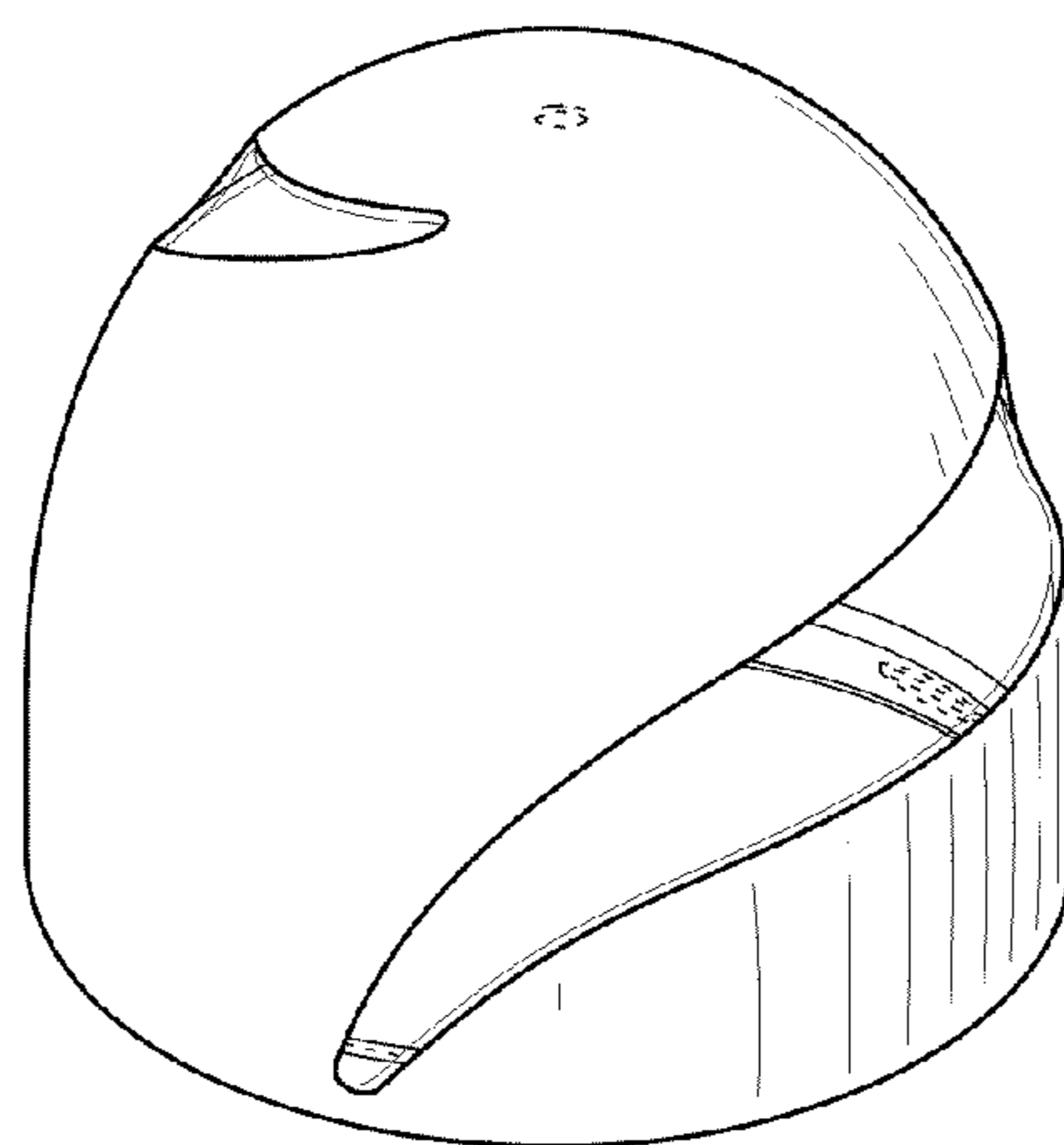

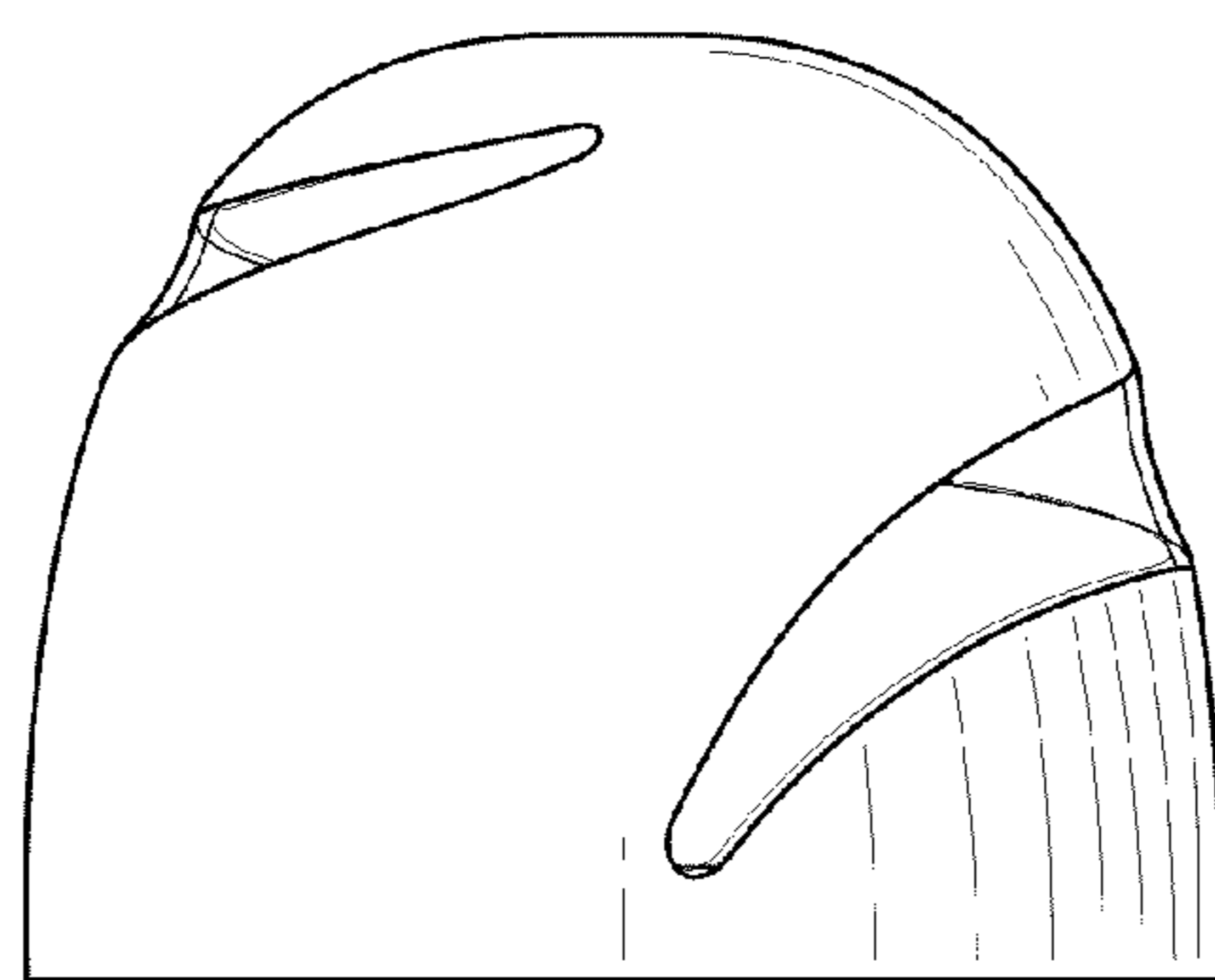

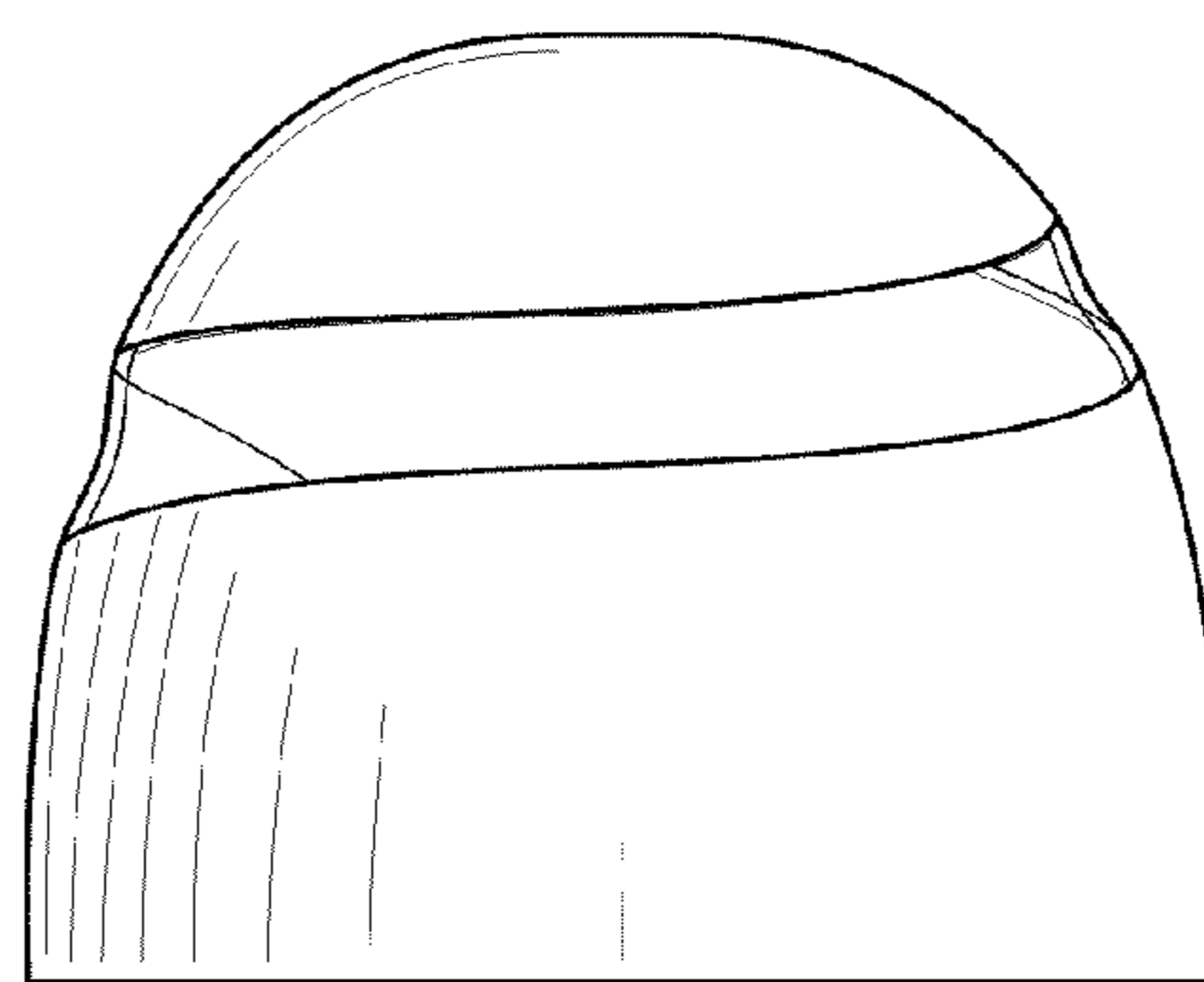

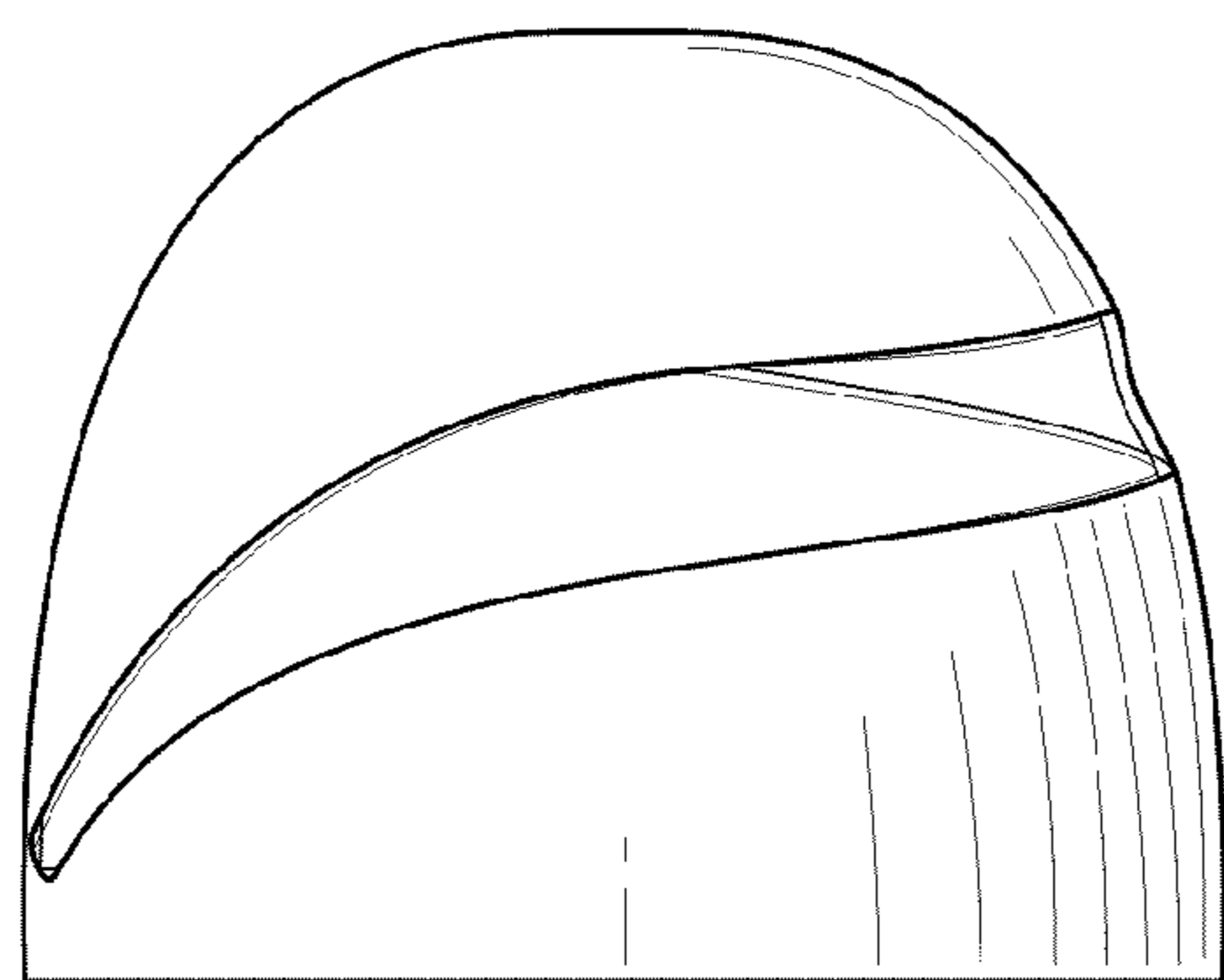

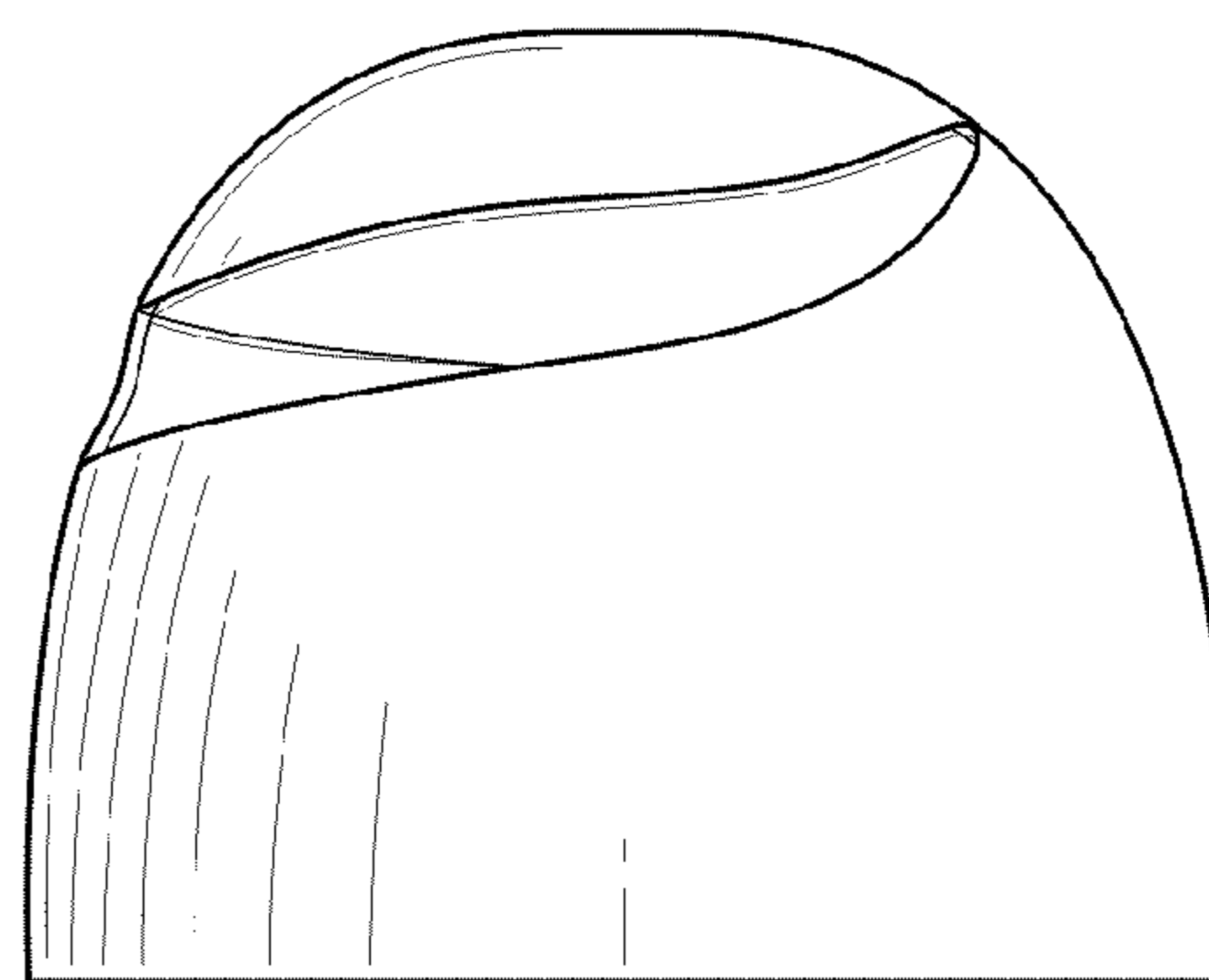

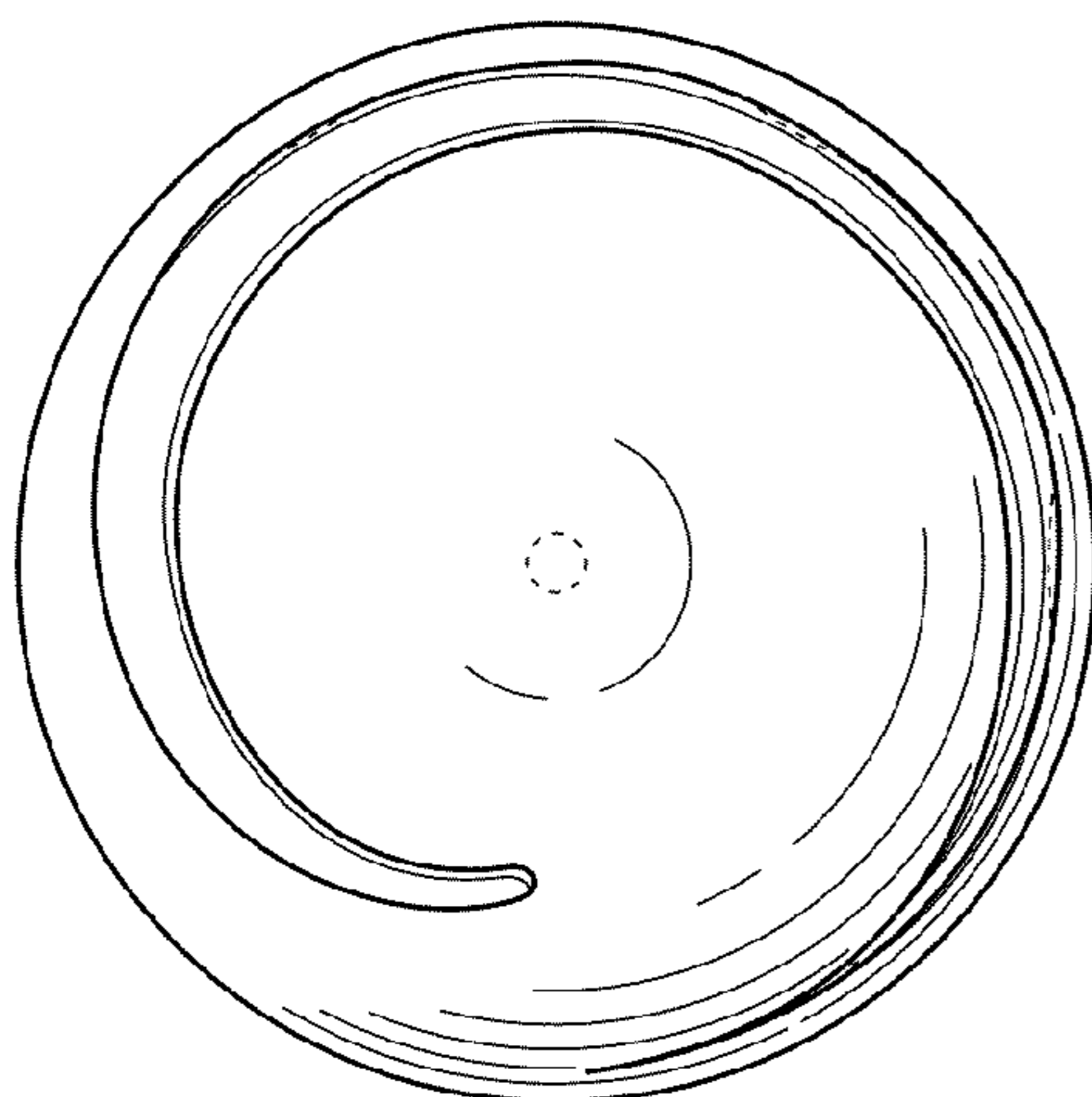

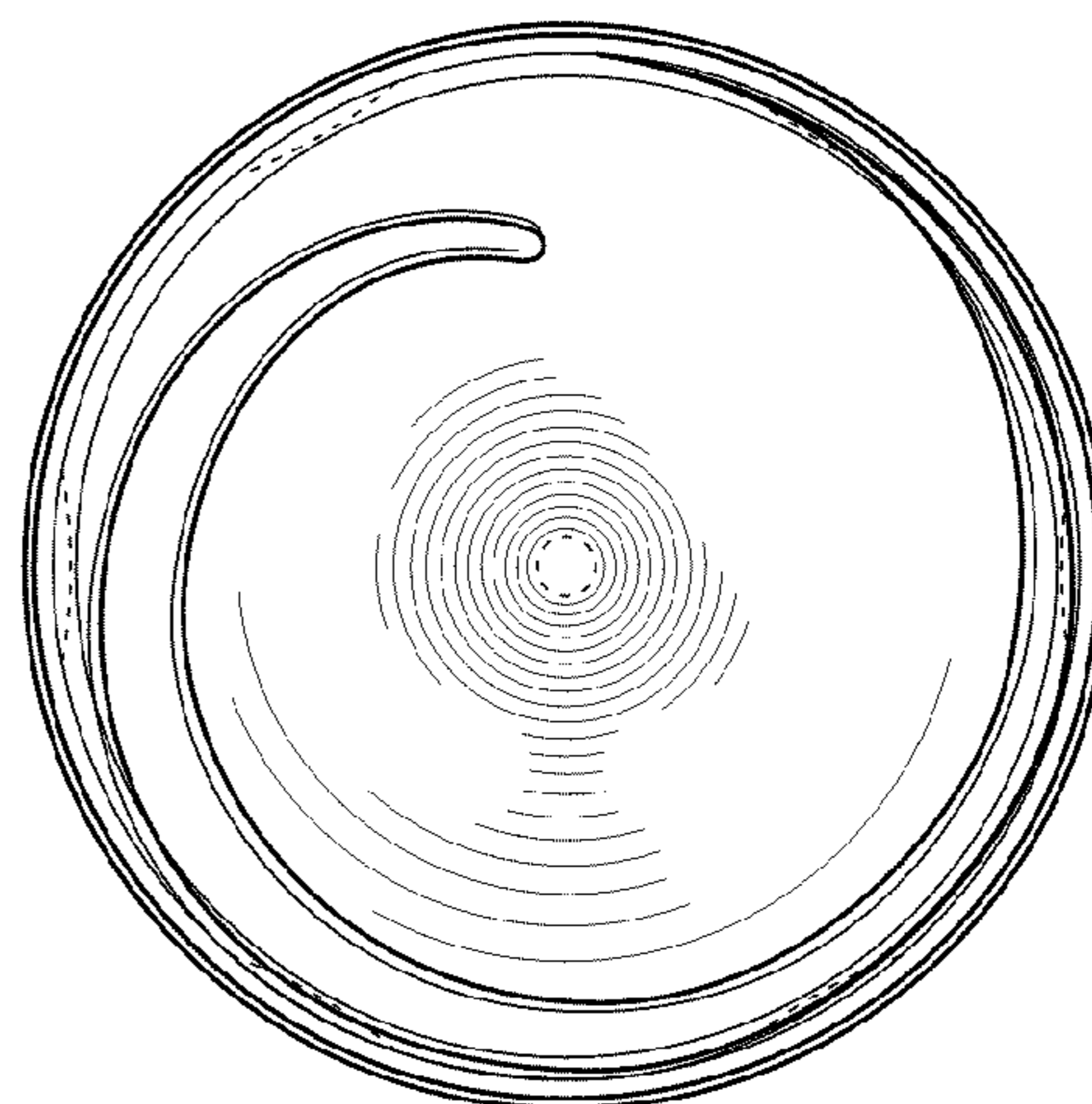
