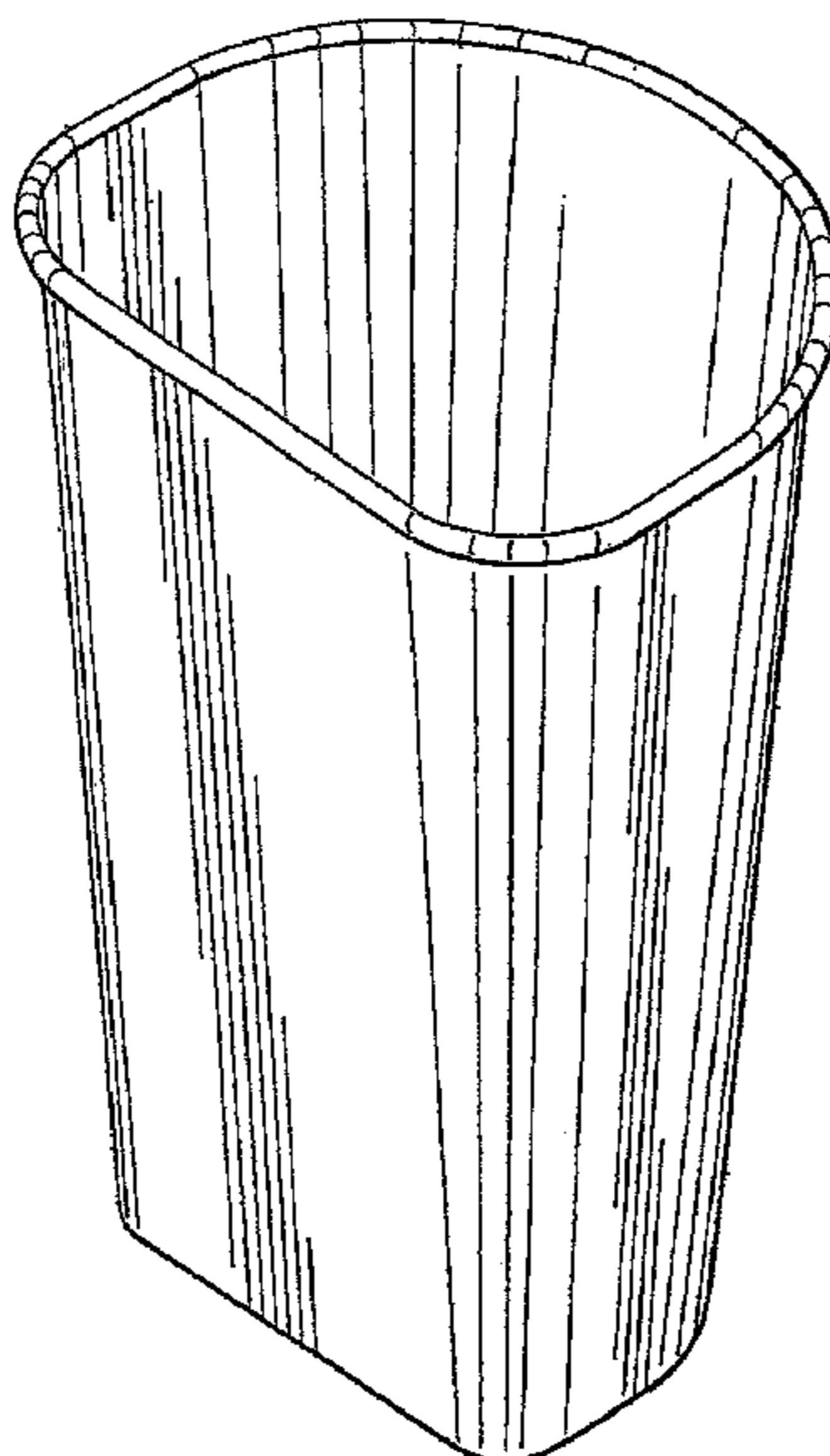
(57) **CLAIM**

The ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a beverage container showing my new design; FIG. 2 is a perspective view of the beverage container; FIG. 3 is another perspective view of the beverage container; FIG. 4 is a top plan view of the beverage container; and, FIG. 5 is a bottom plan view of the beverage container. The portions of the beverage container shown in broken lines form no part of the claimed design.

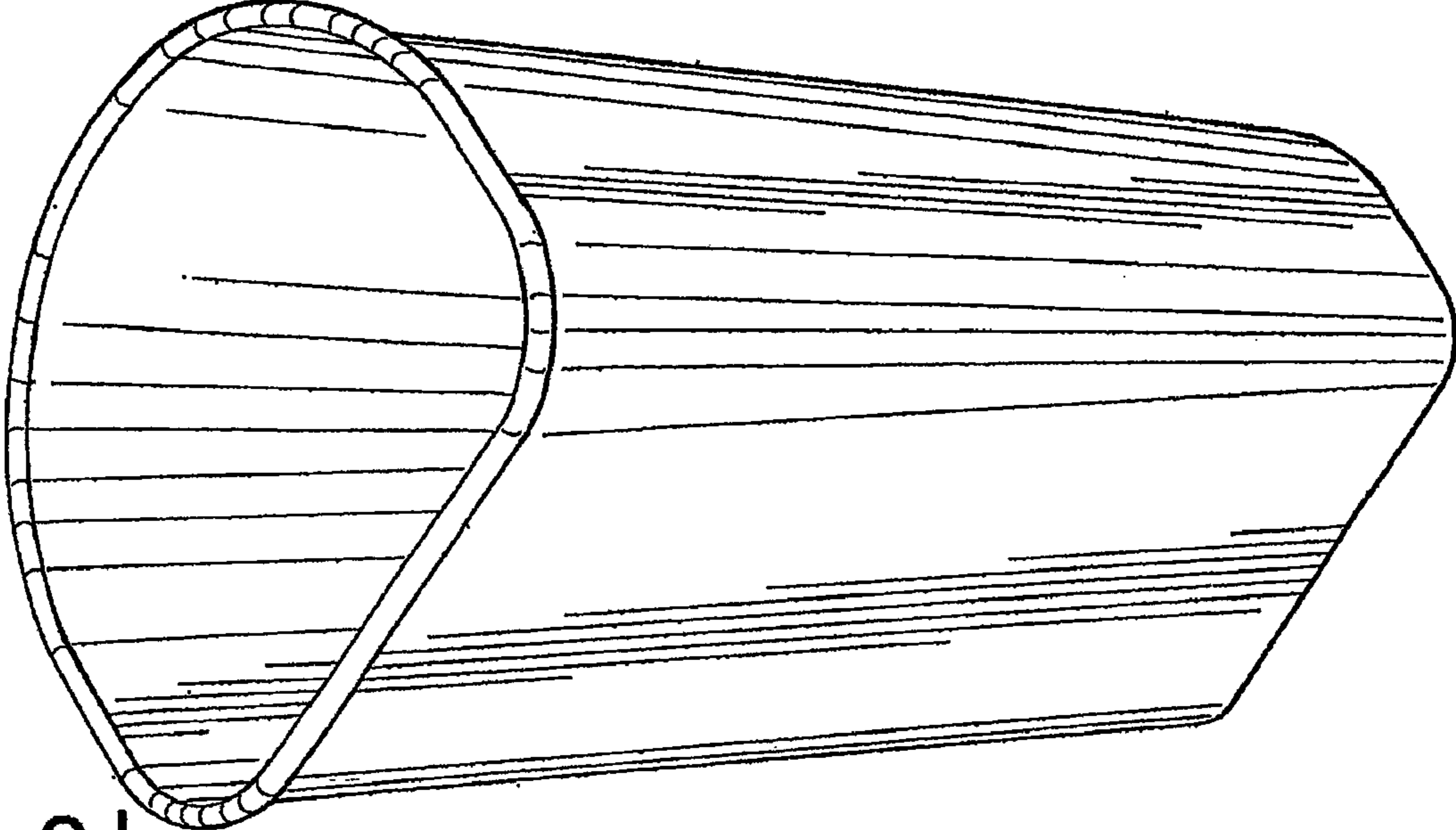

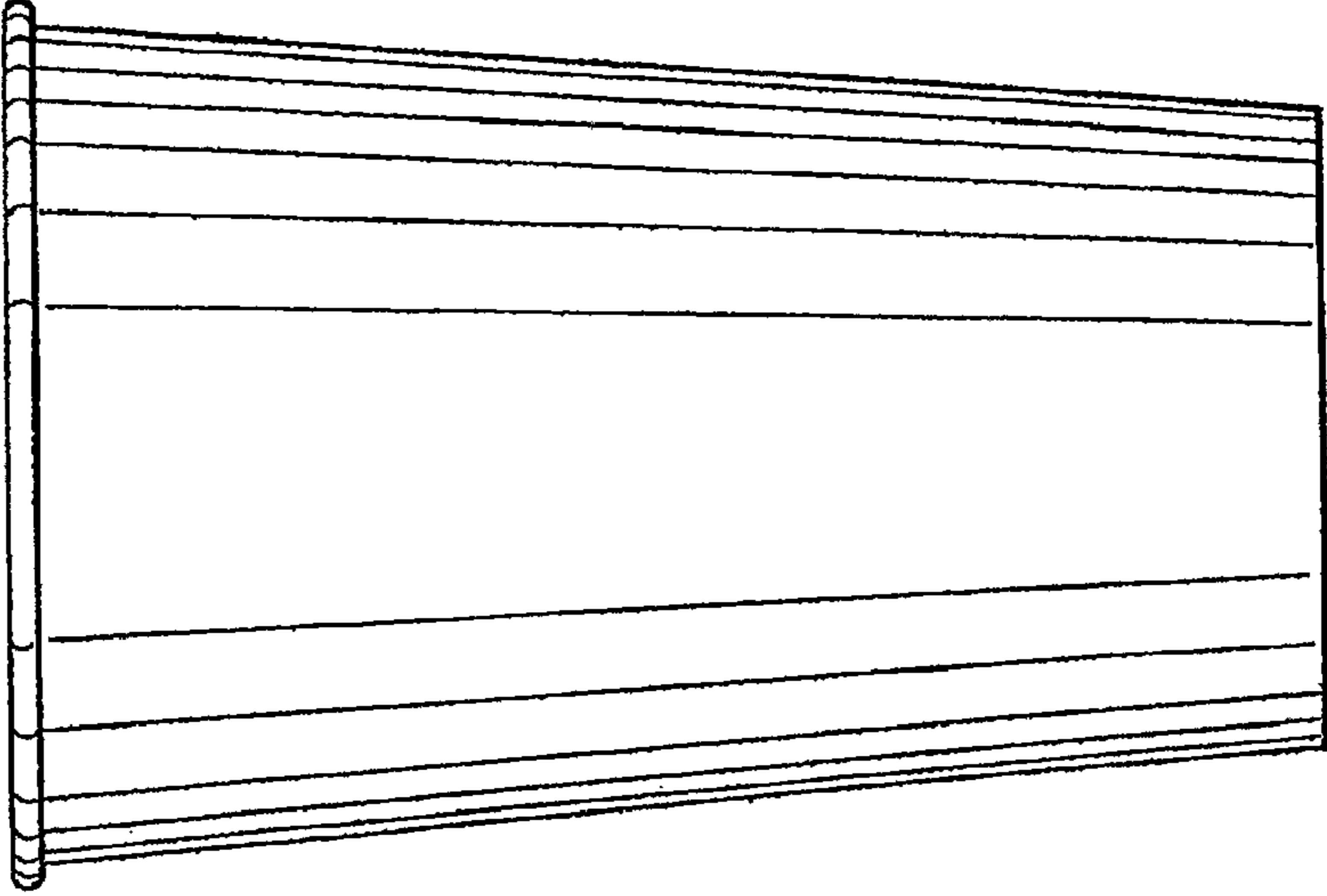

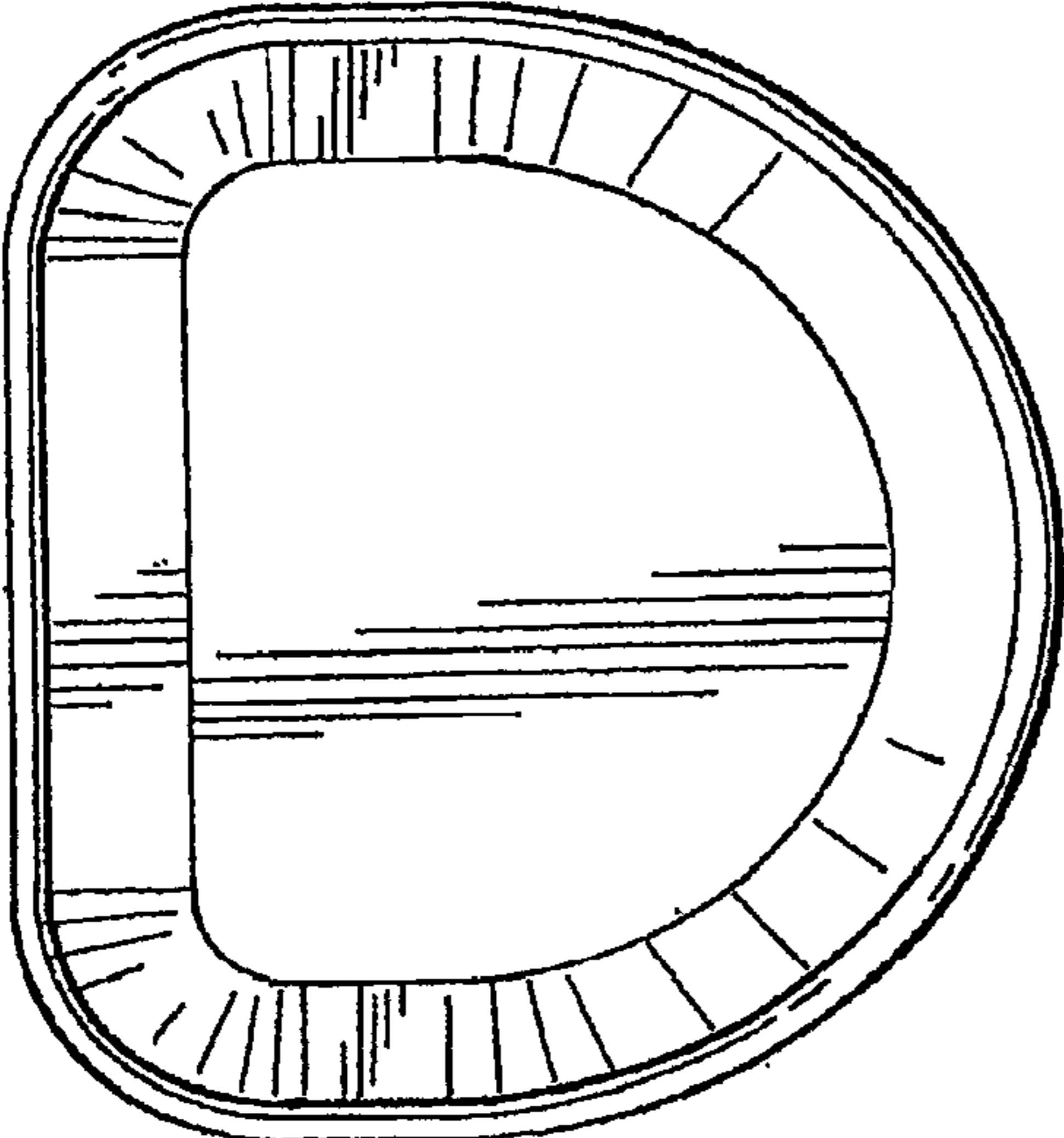

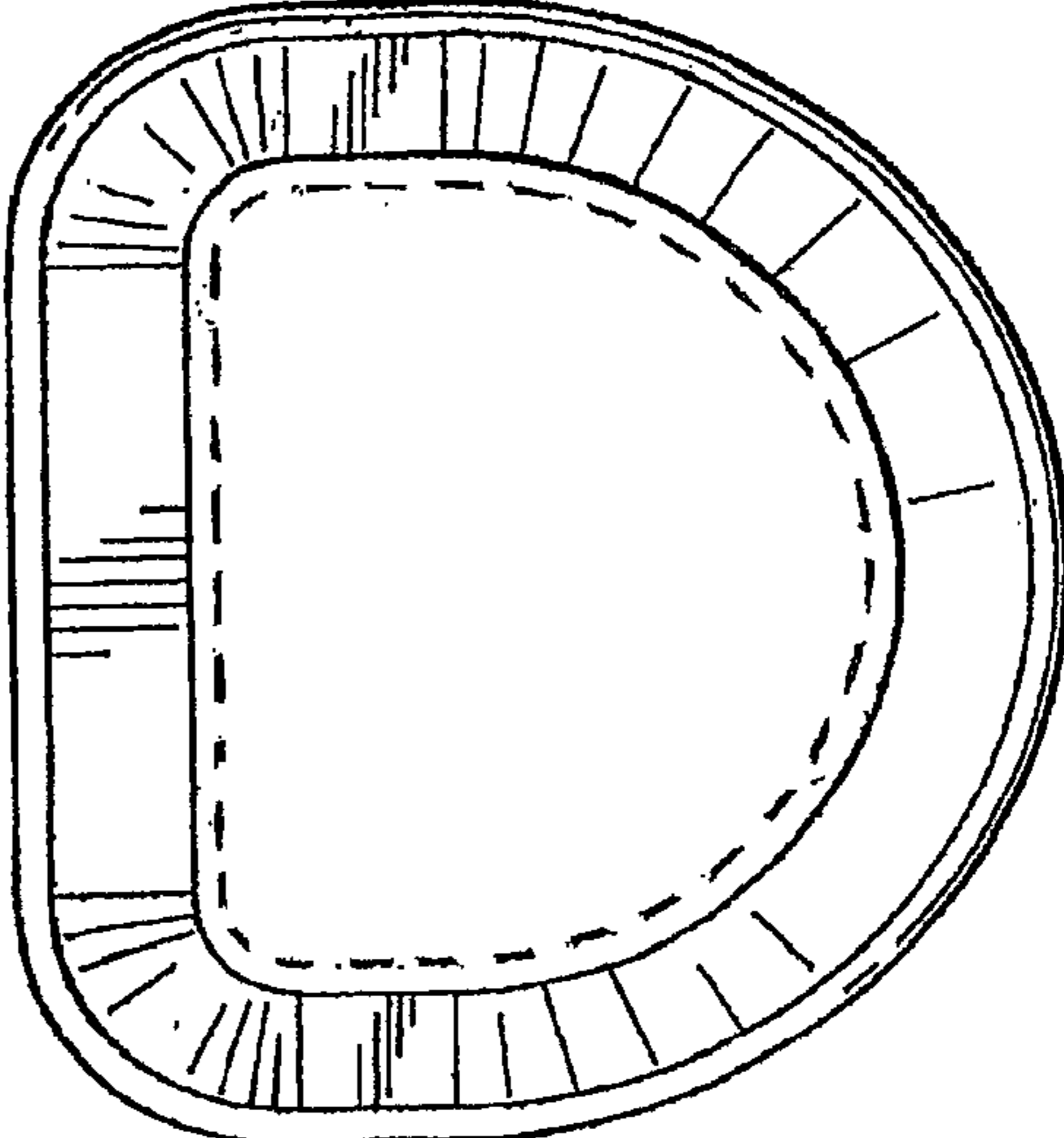

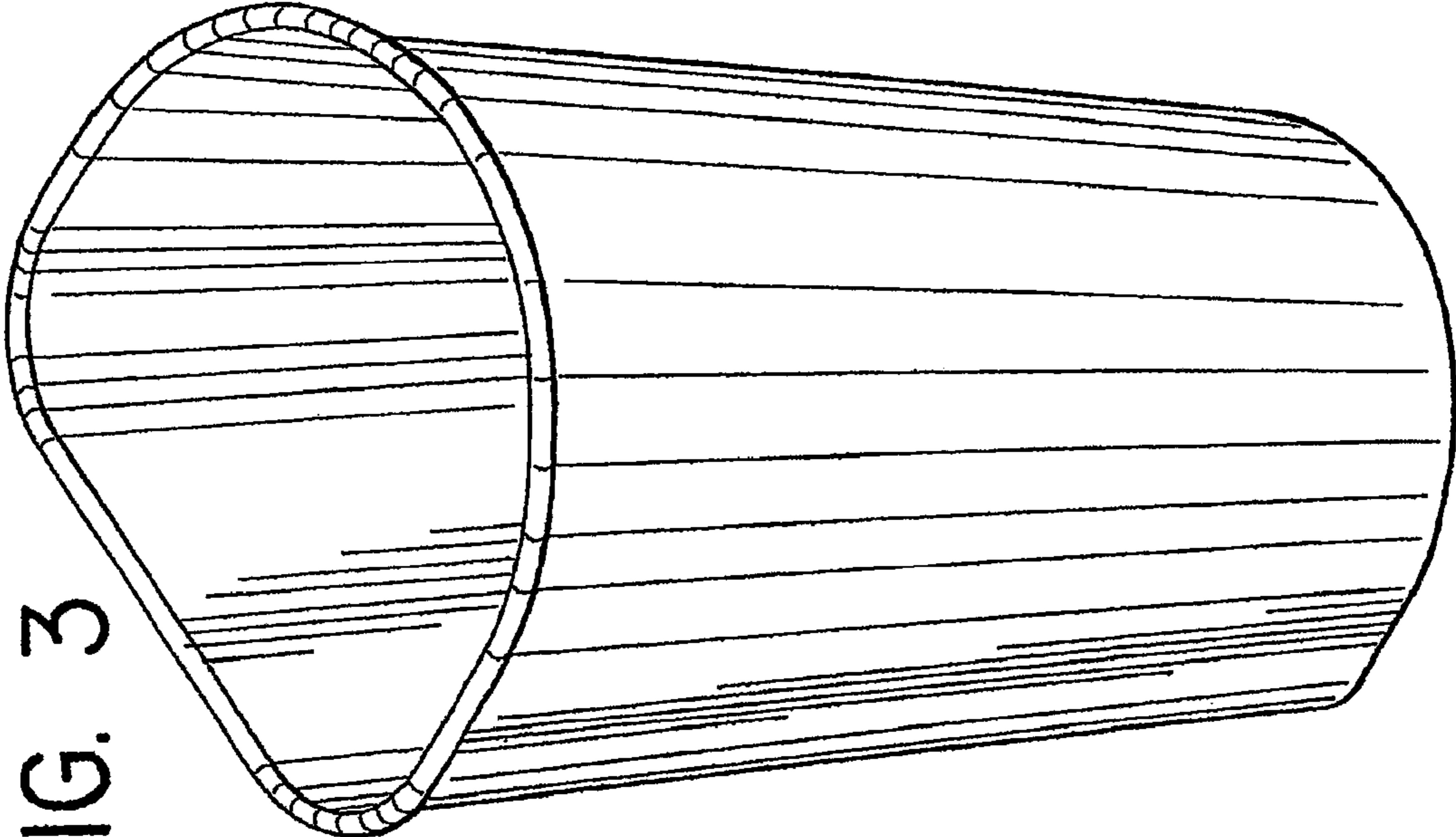
