DESCRIPTION

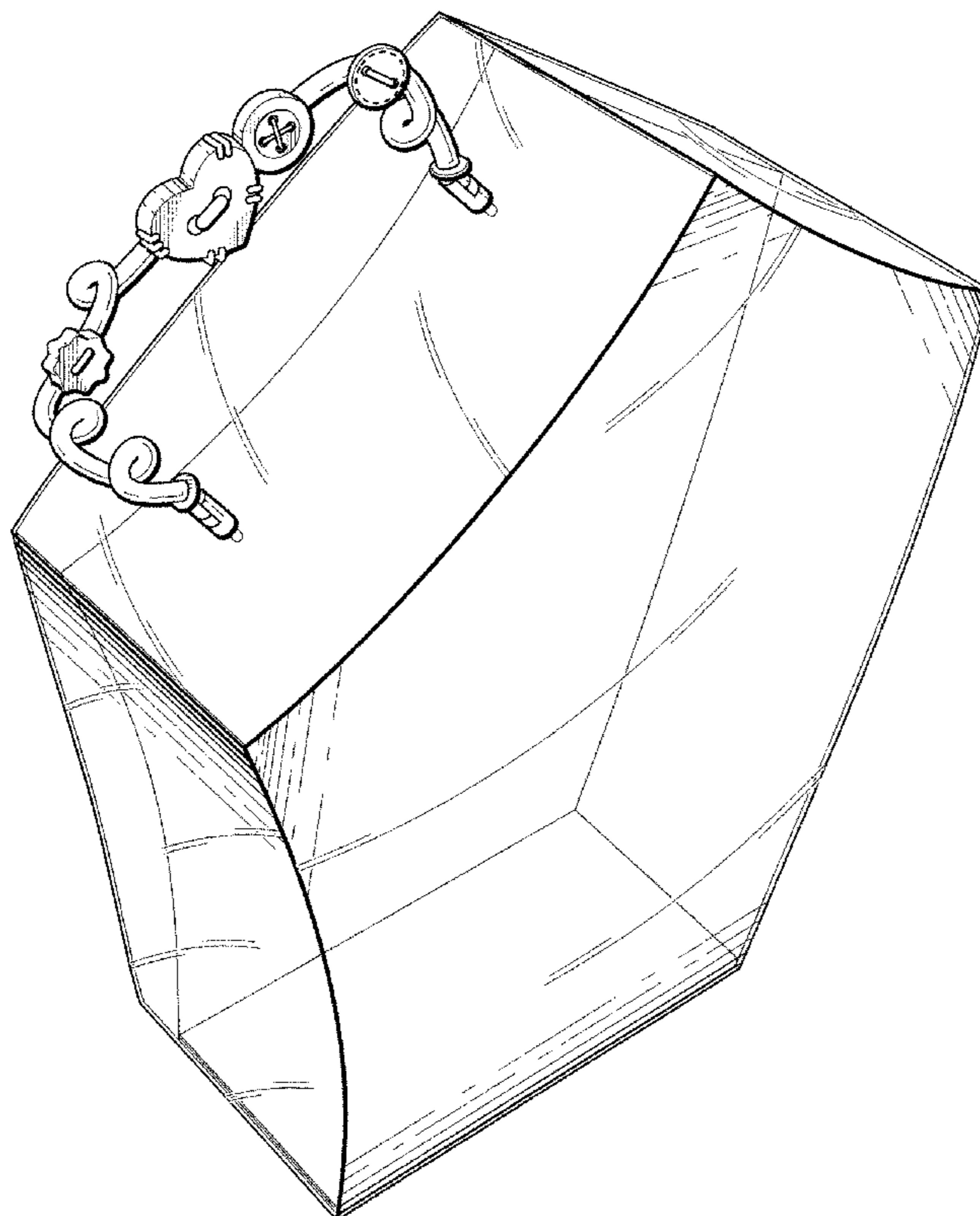
FIG. 1 is a perspective view of an embodiment of a product package showing our new design;

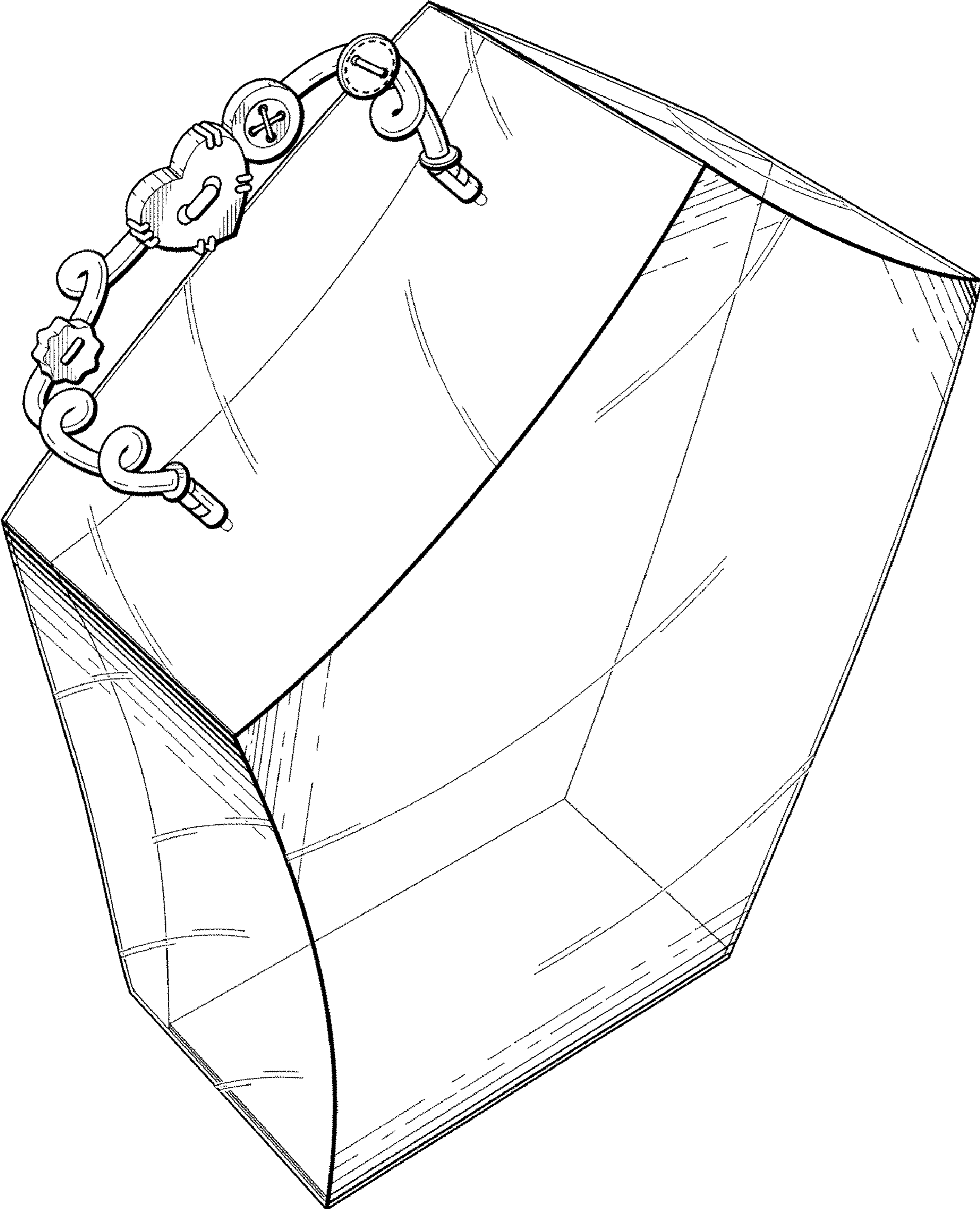

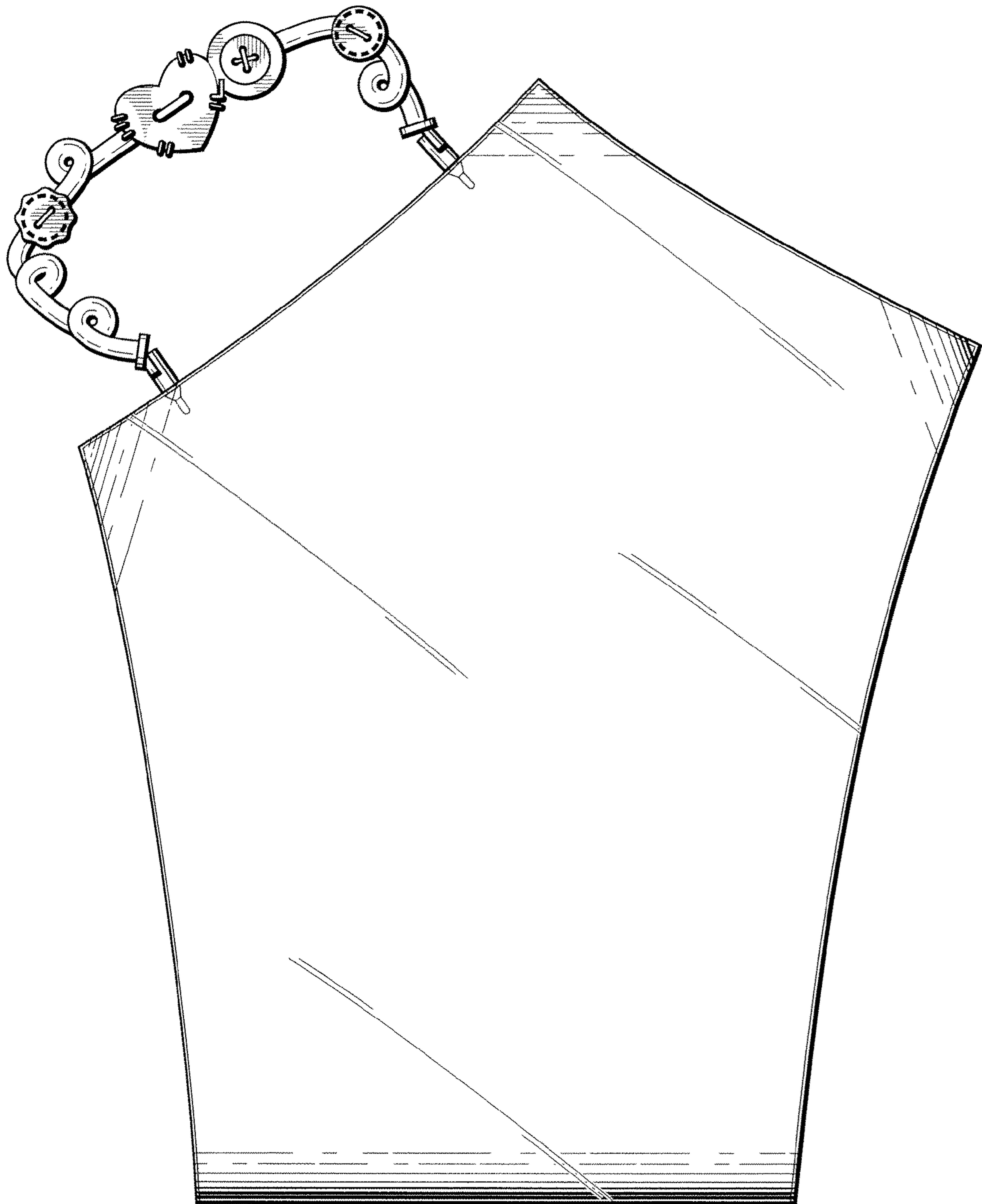
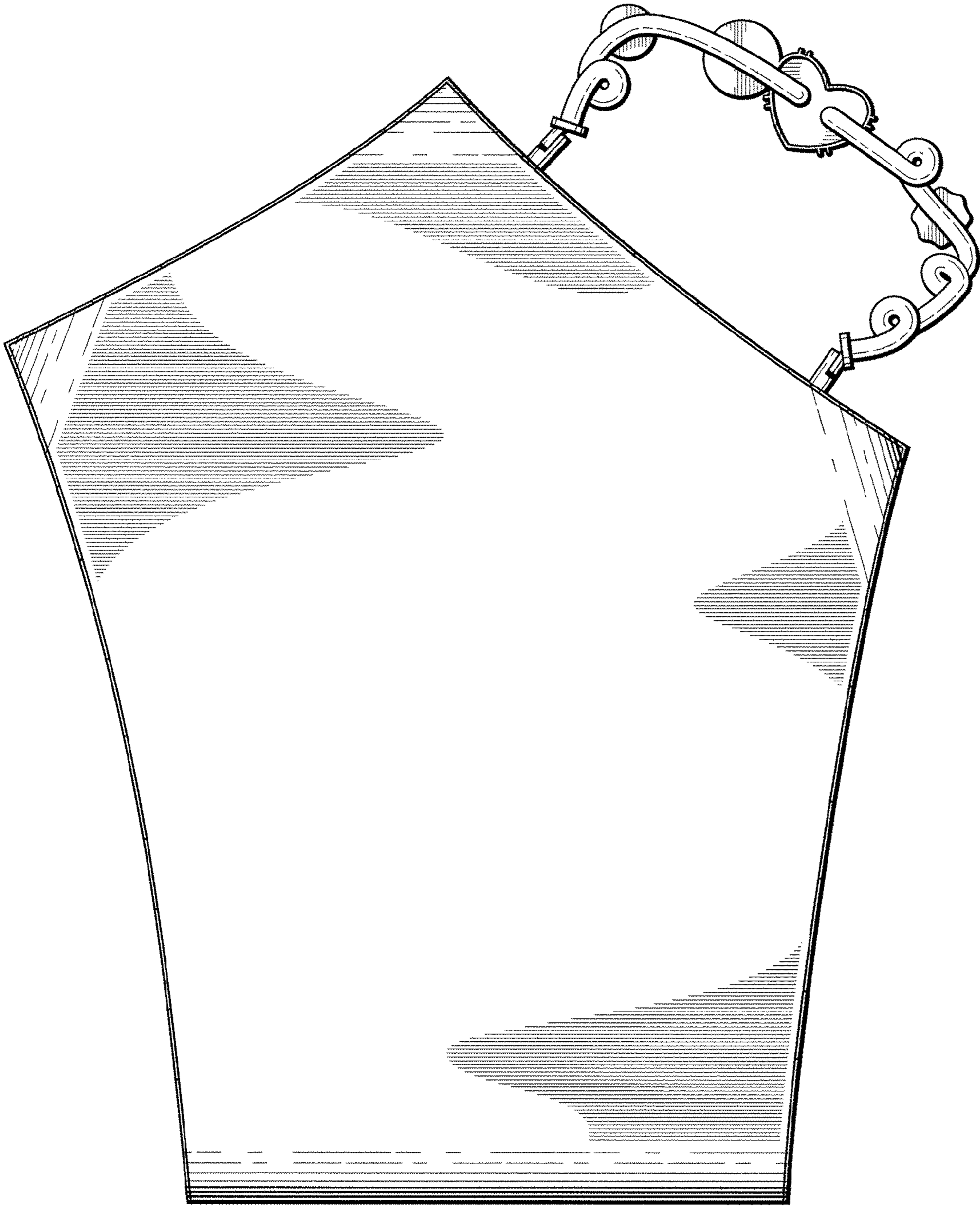

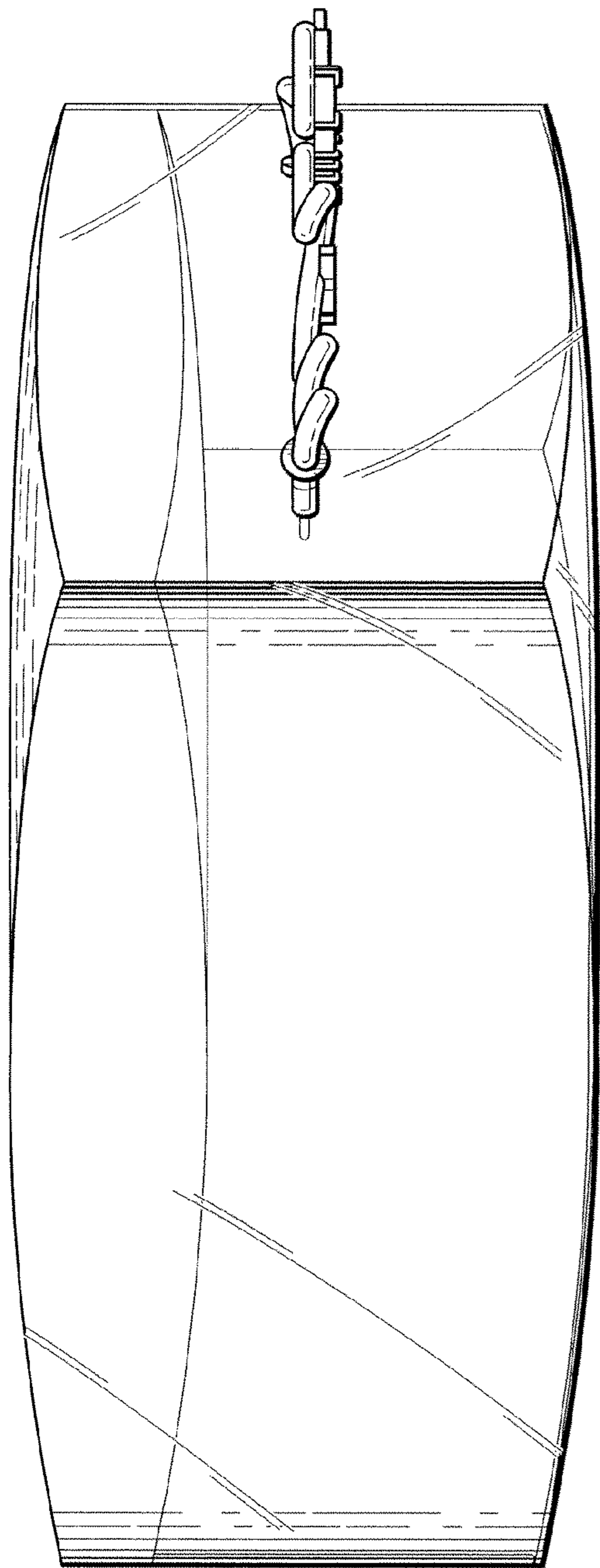

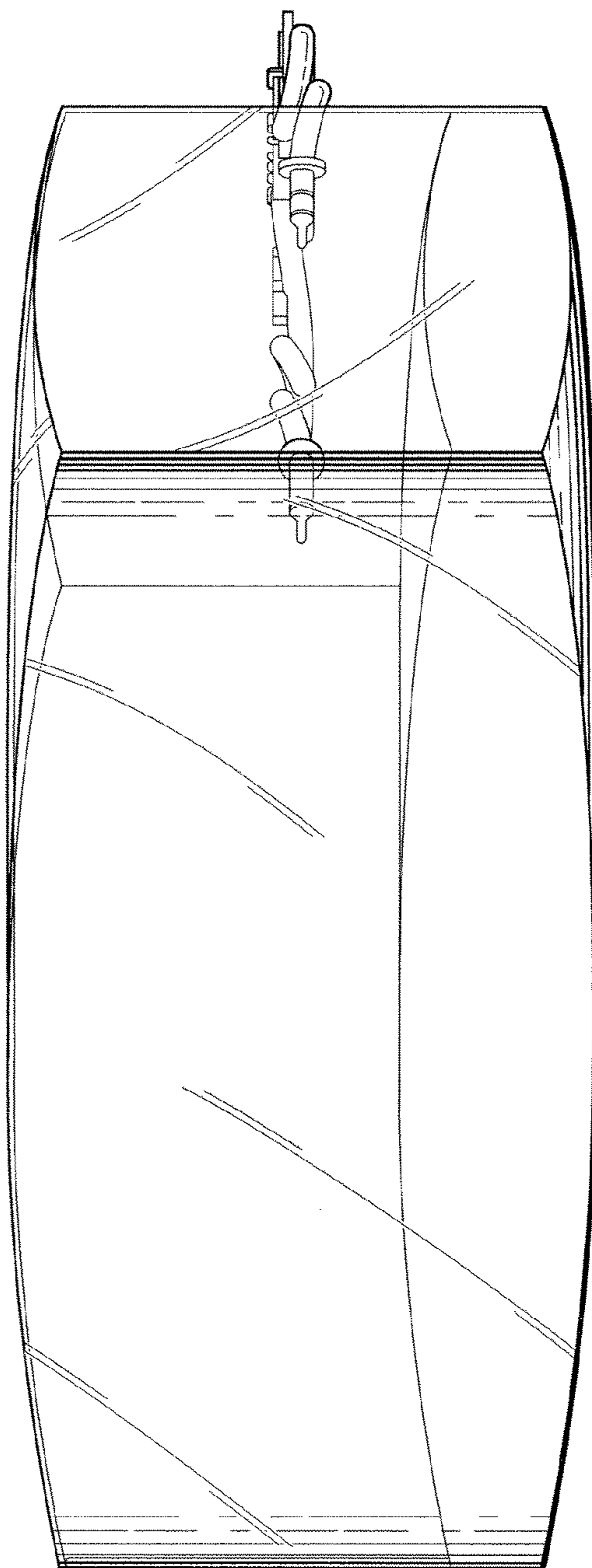

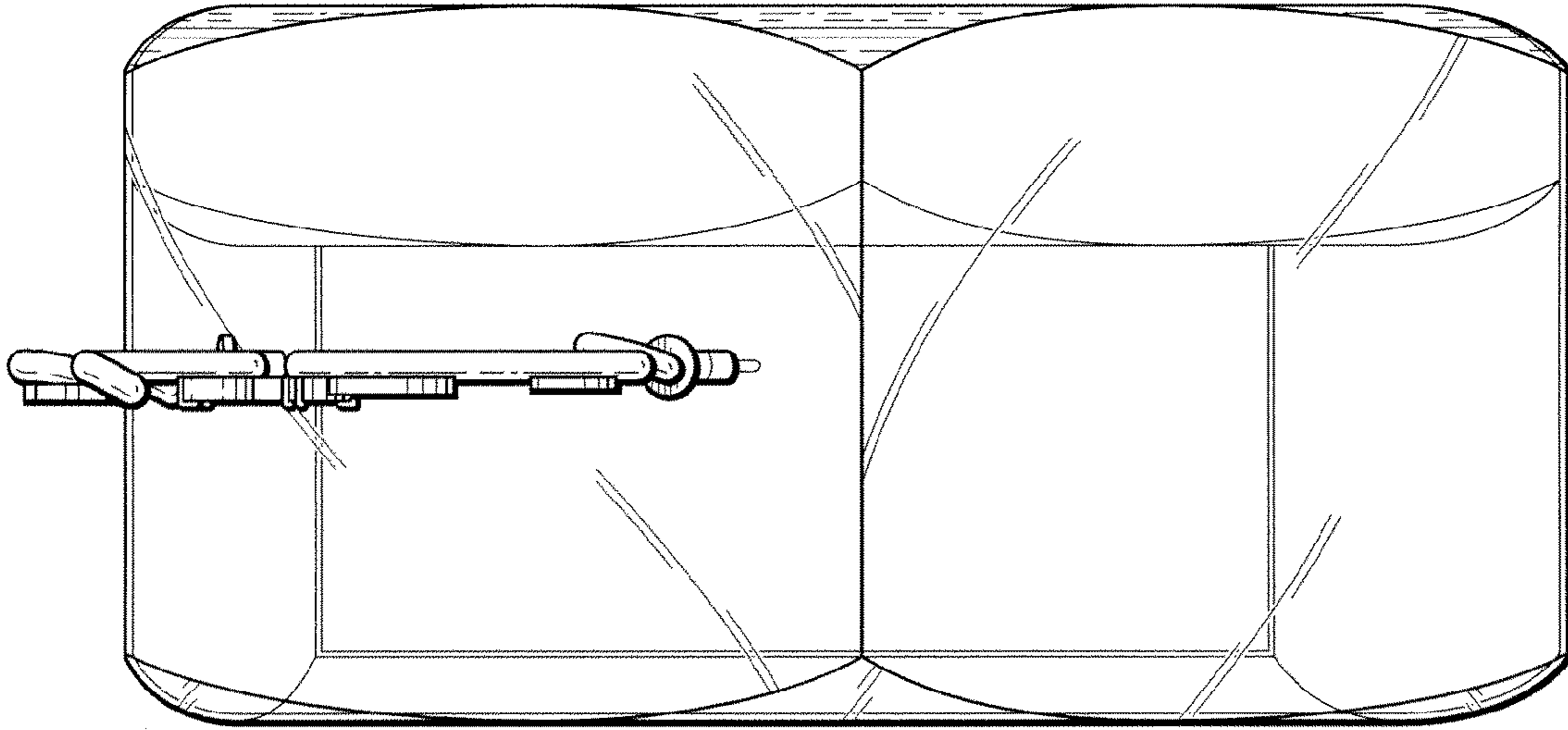
