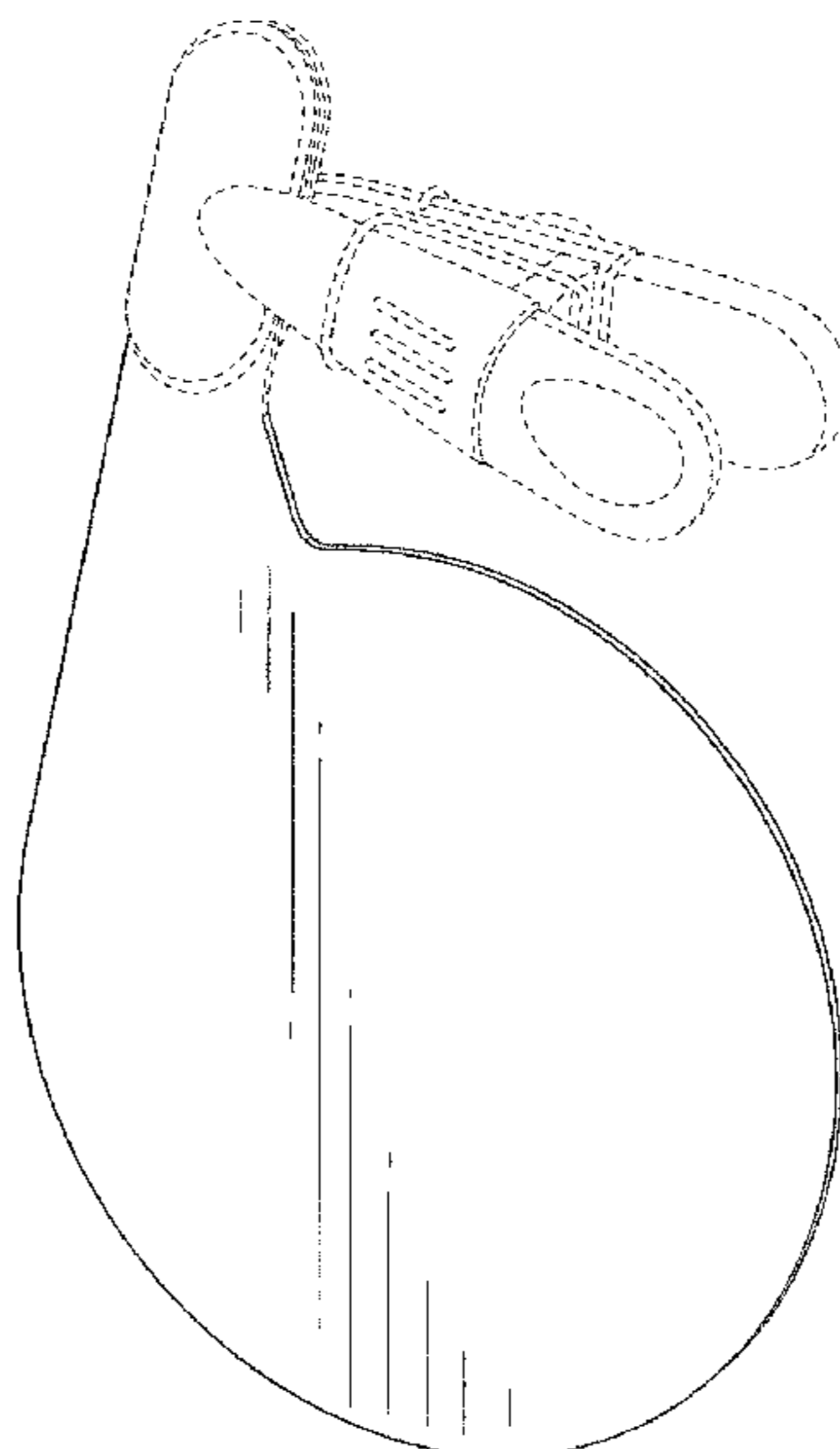
(57) **CLAIM**

I claim the ornamental design for a sun visor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sun visor.
 FIG. 2 is a front view of the sun visor of FIG. 1.

 FIG. 4 is a right-side view of the sun visor of FIG. 1.

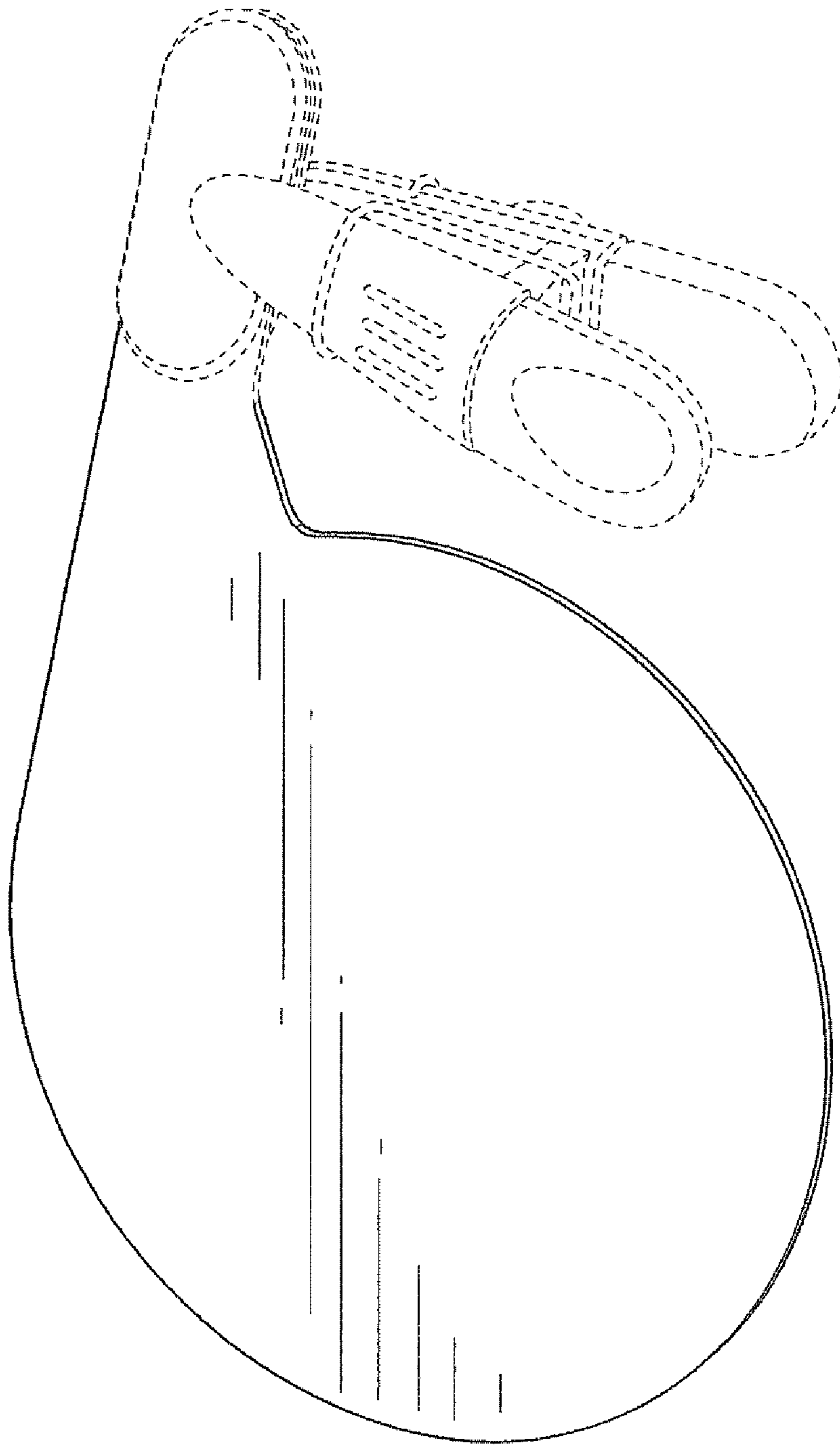

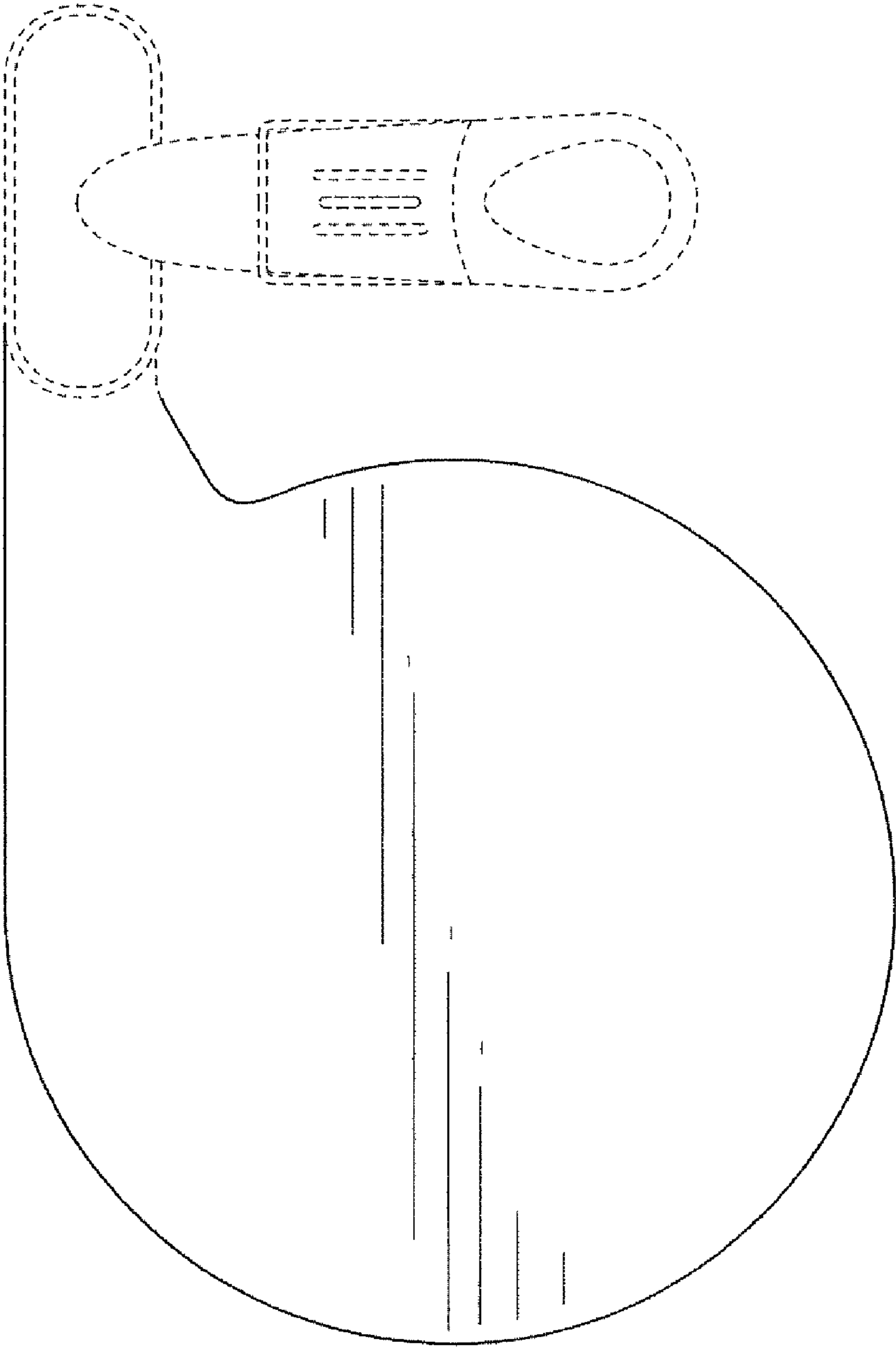

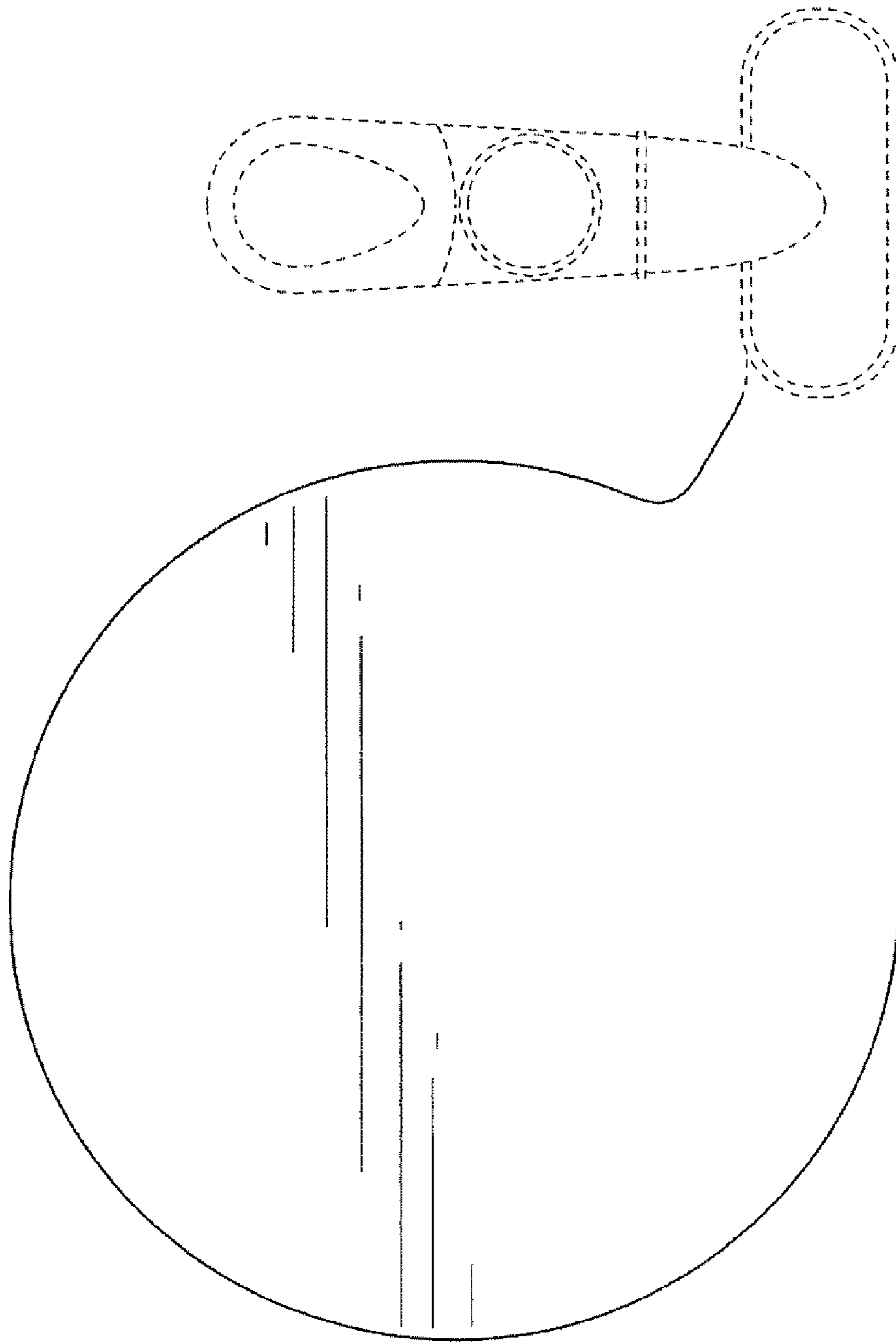

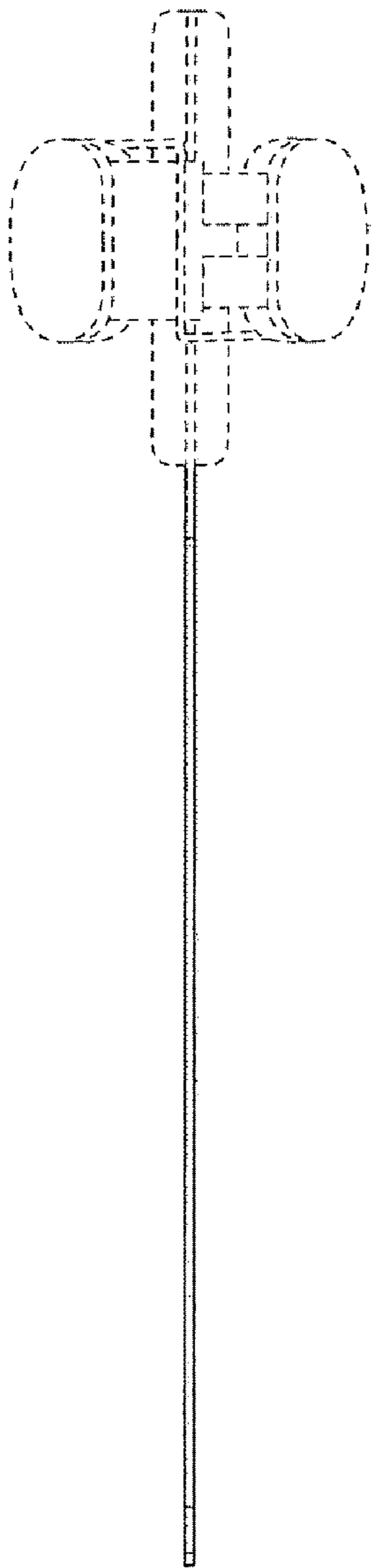

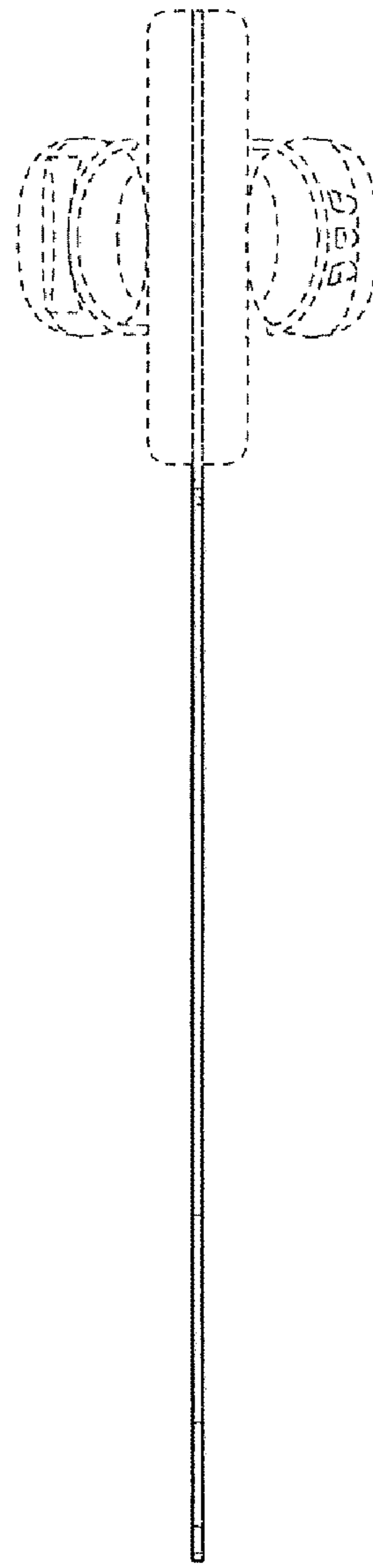

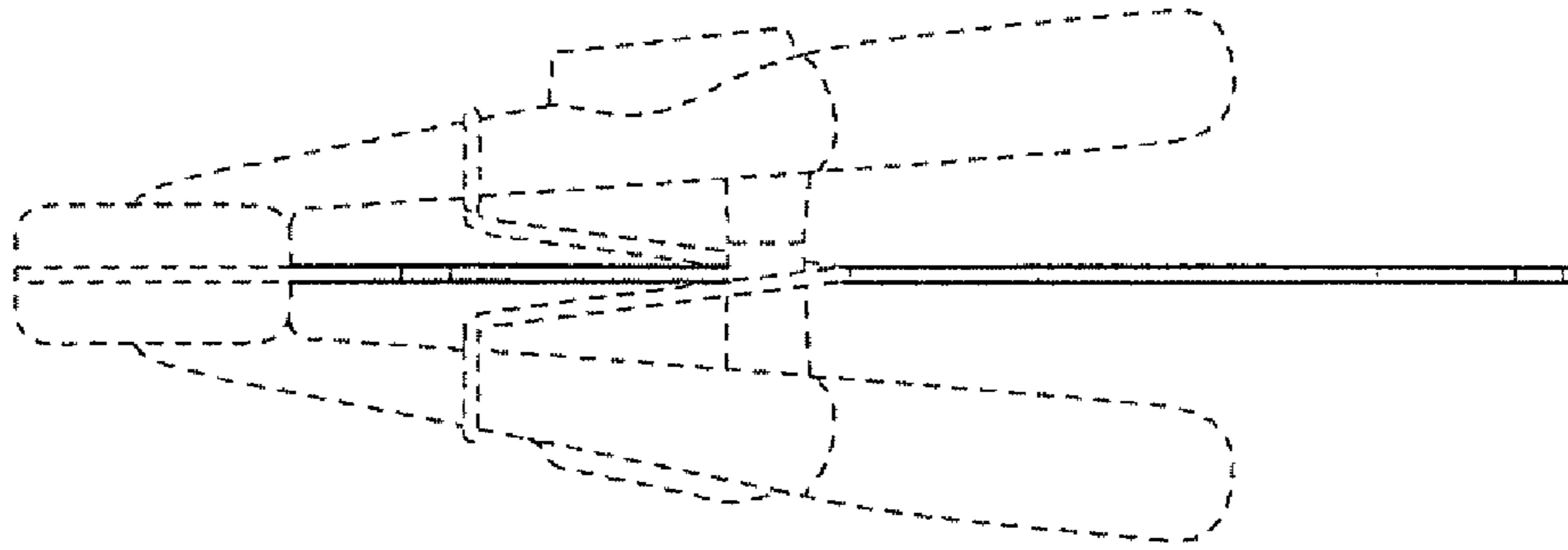

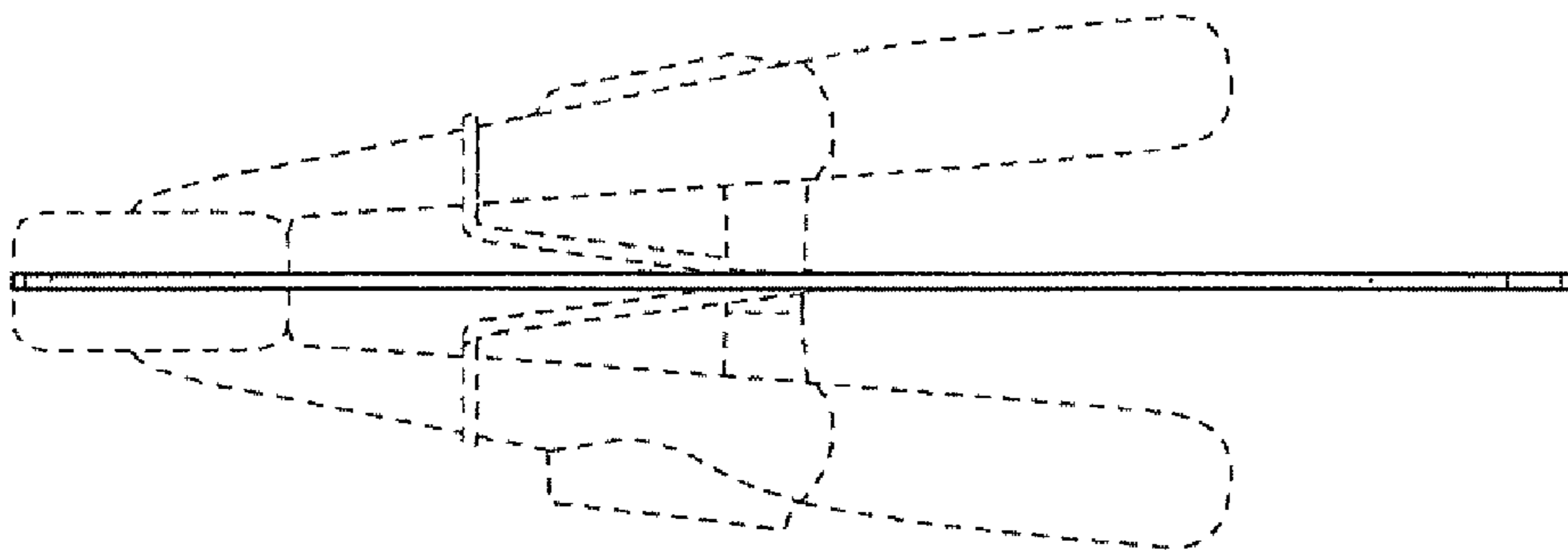
