(57) **CLAIM**

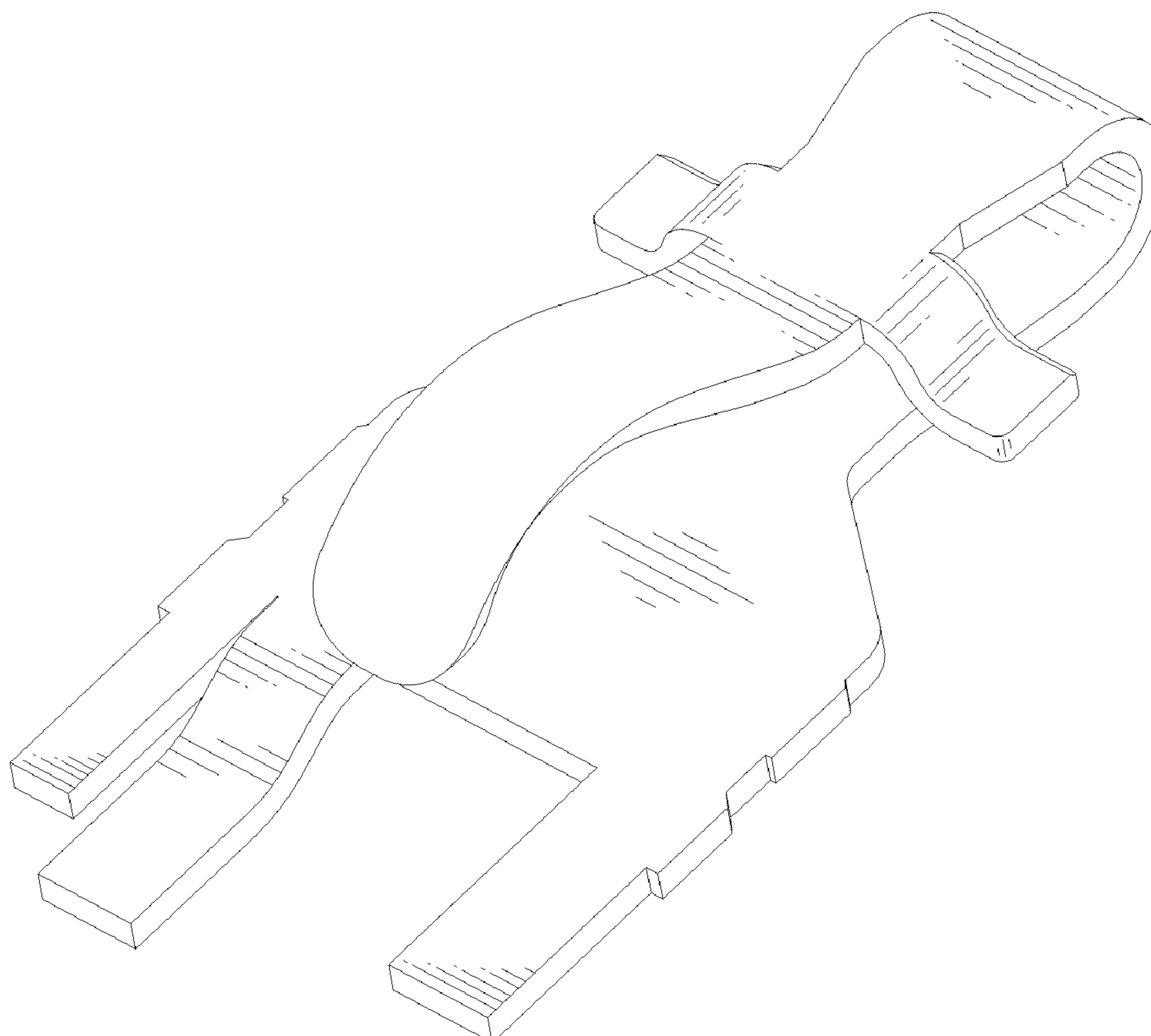
The ornamental design for a connector contact, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a connector contact showing our new design;

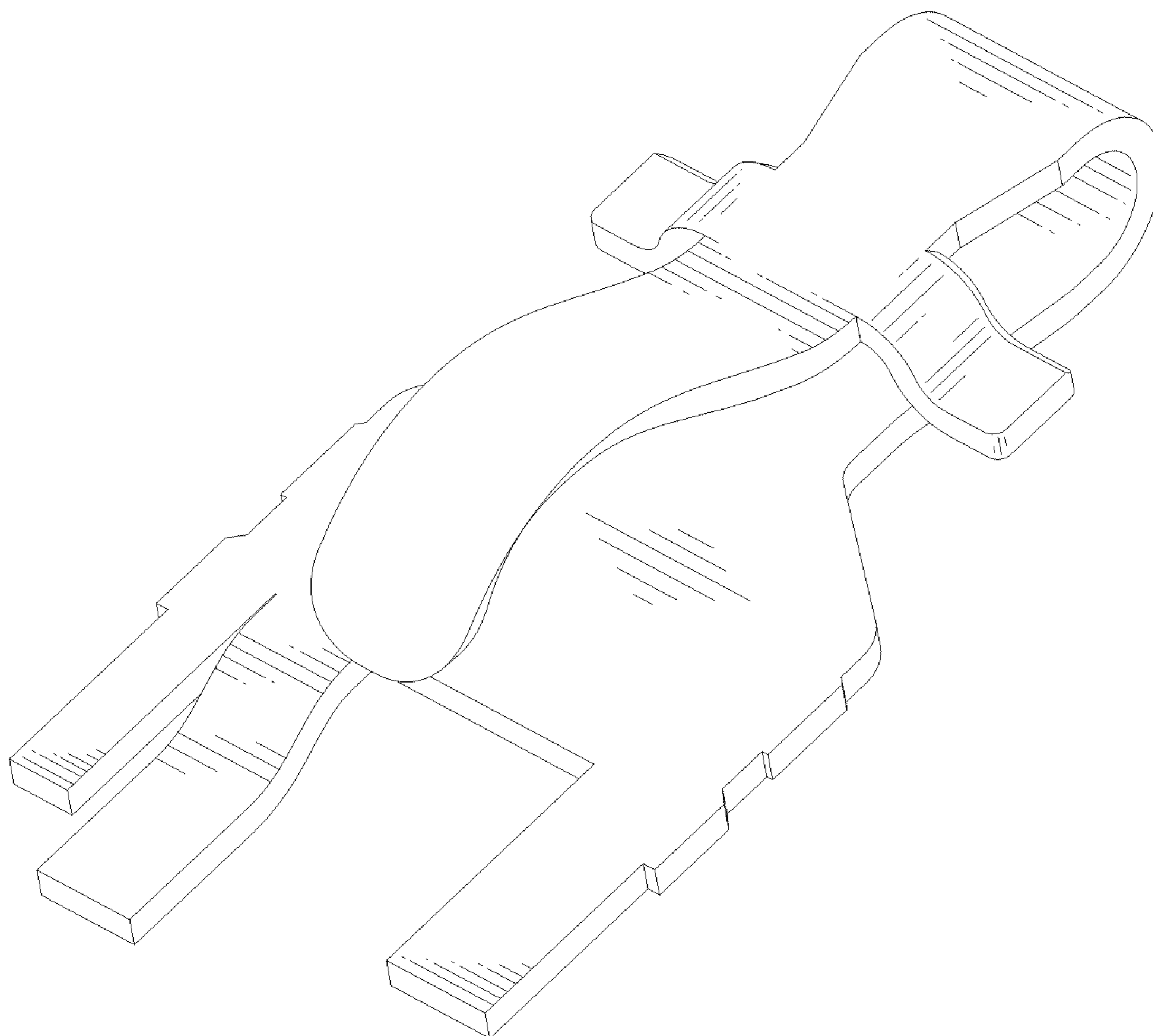

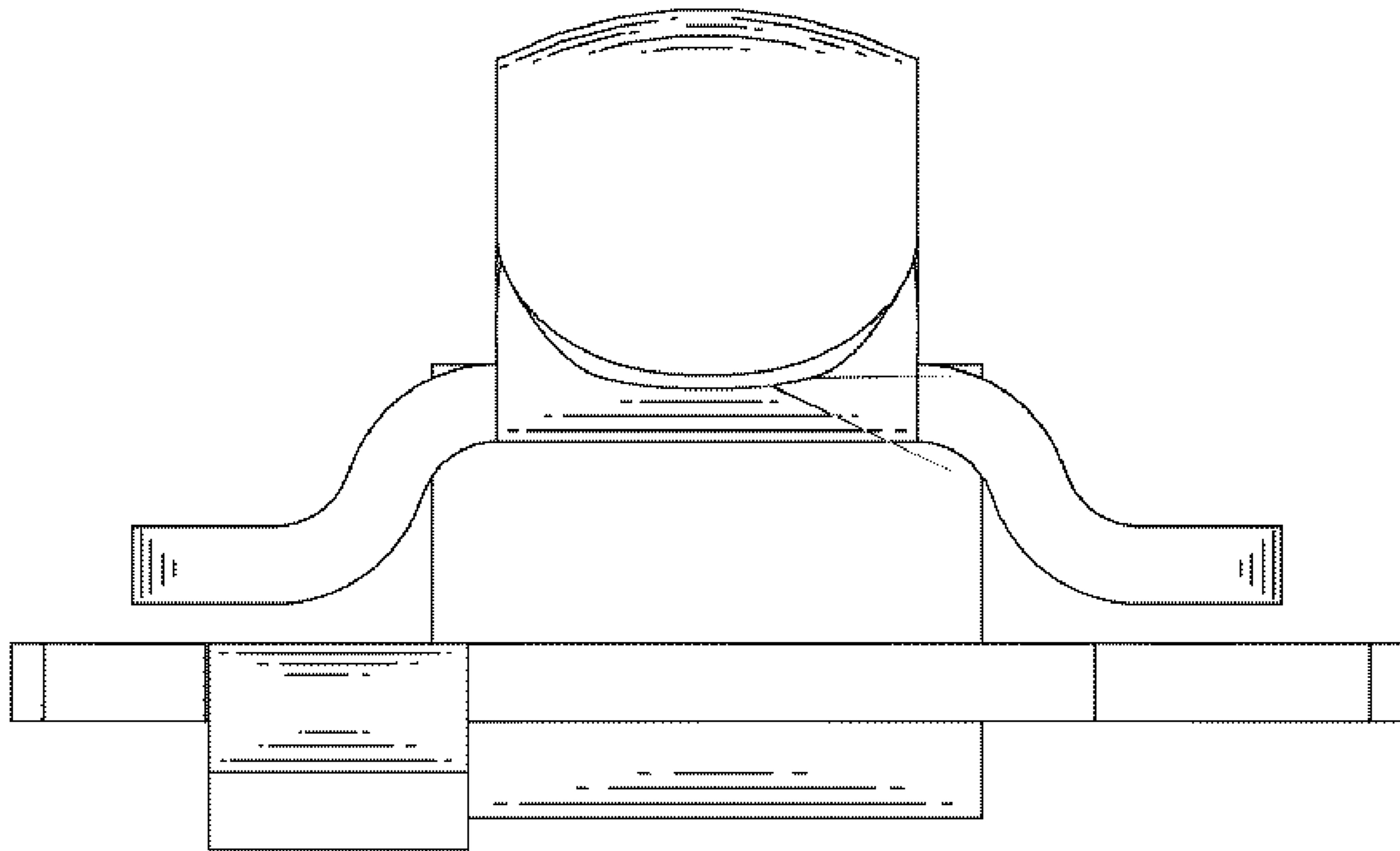

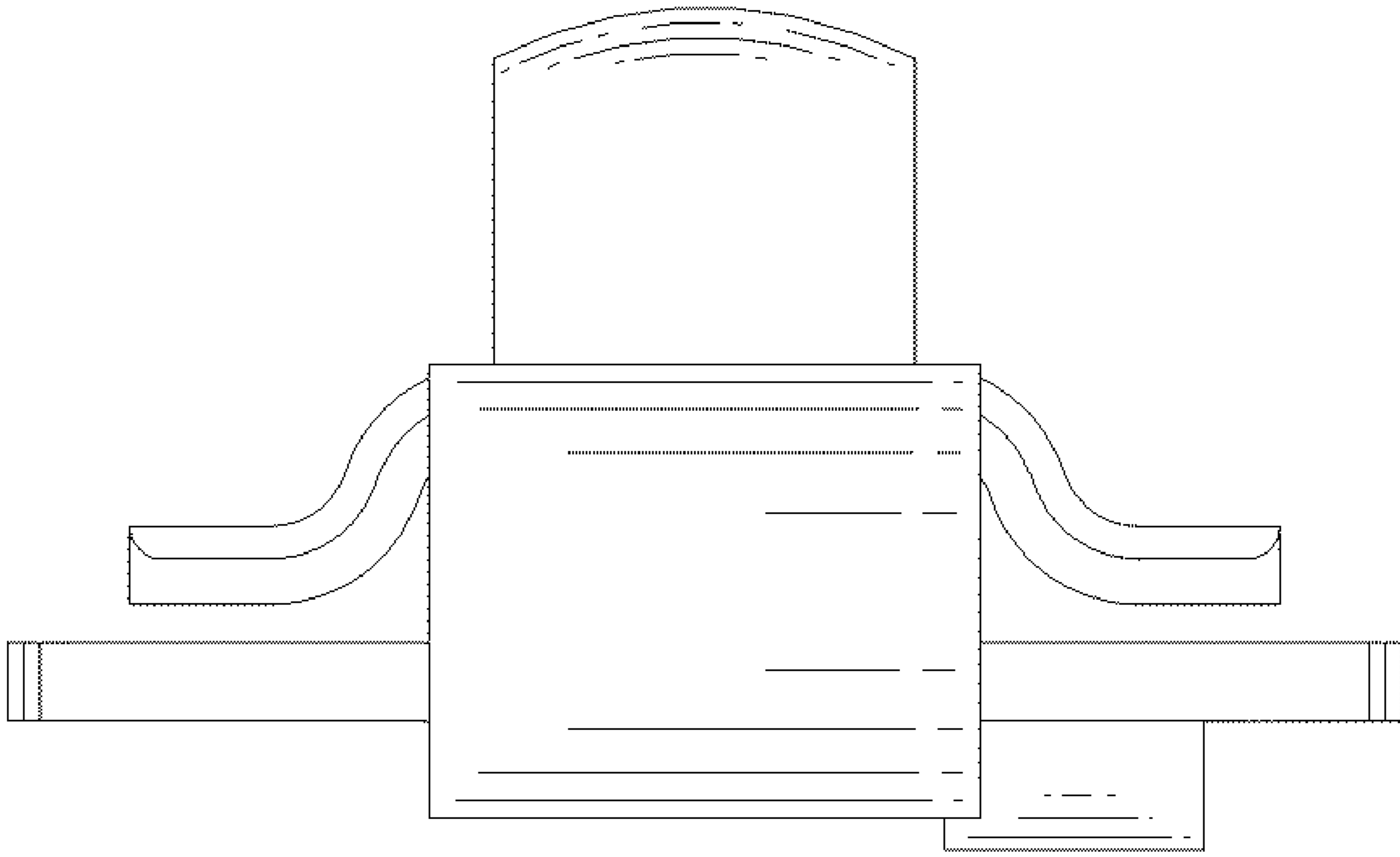

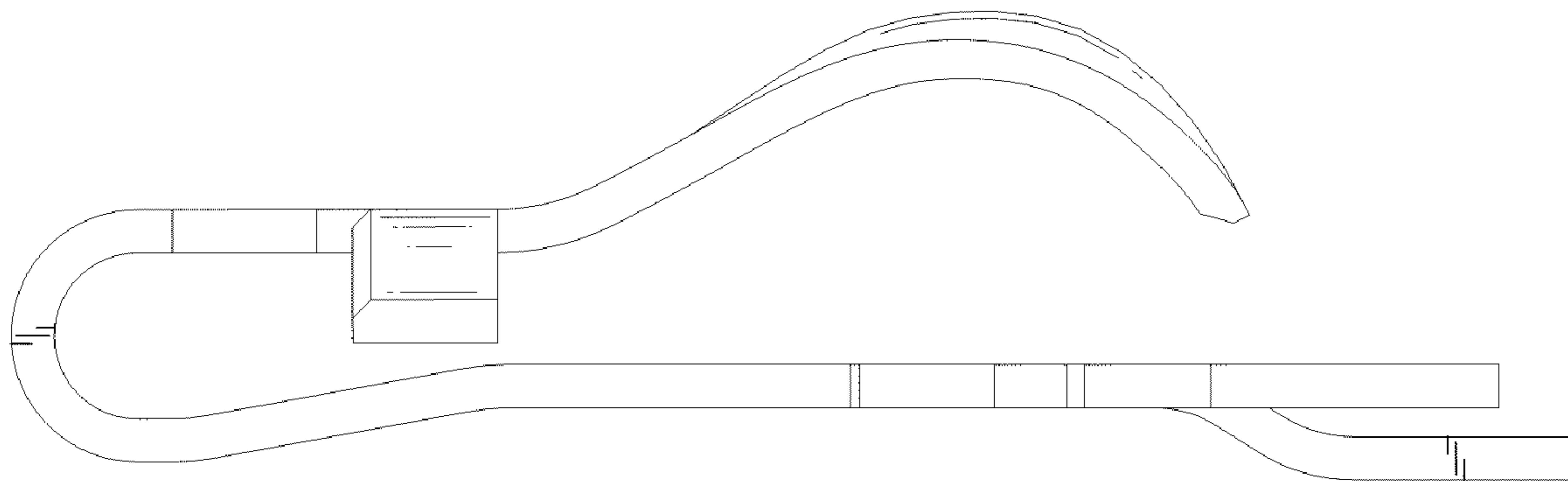

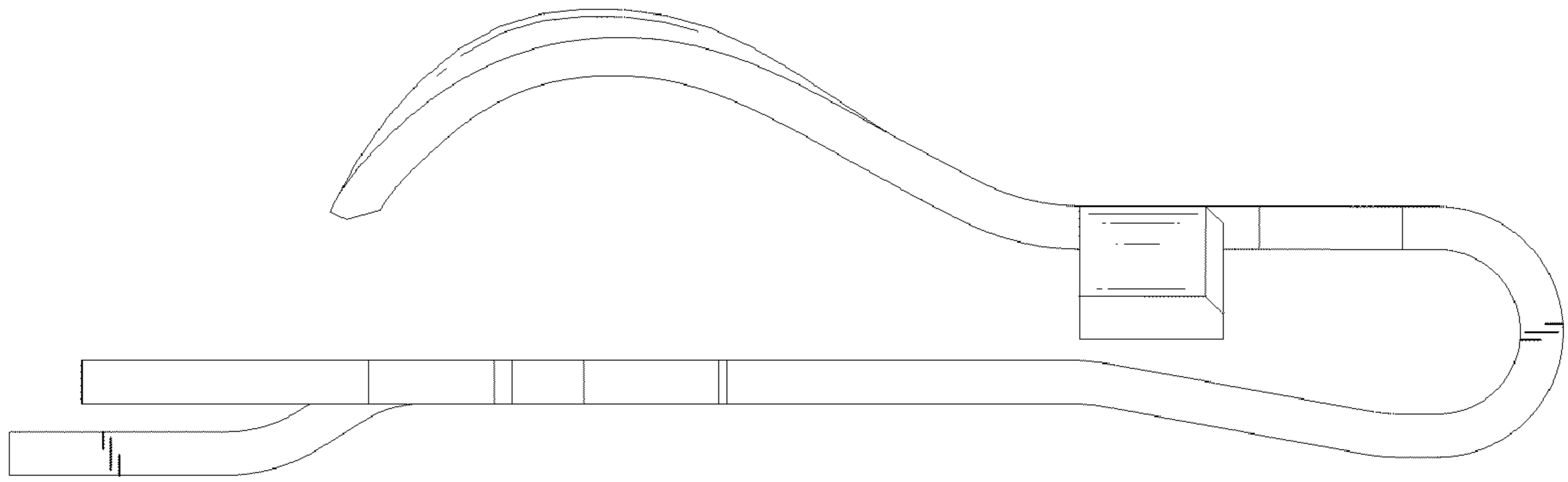

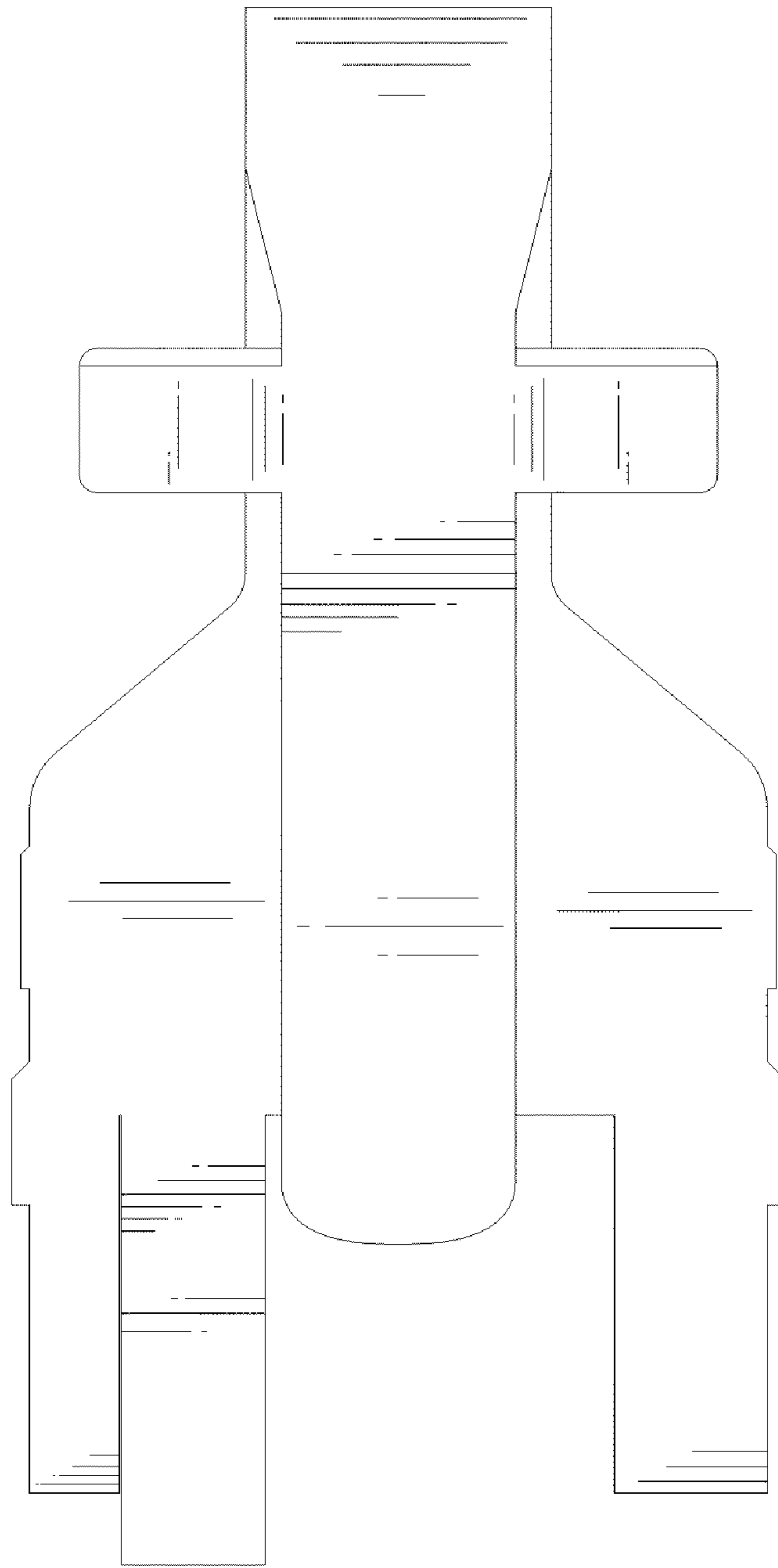

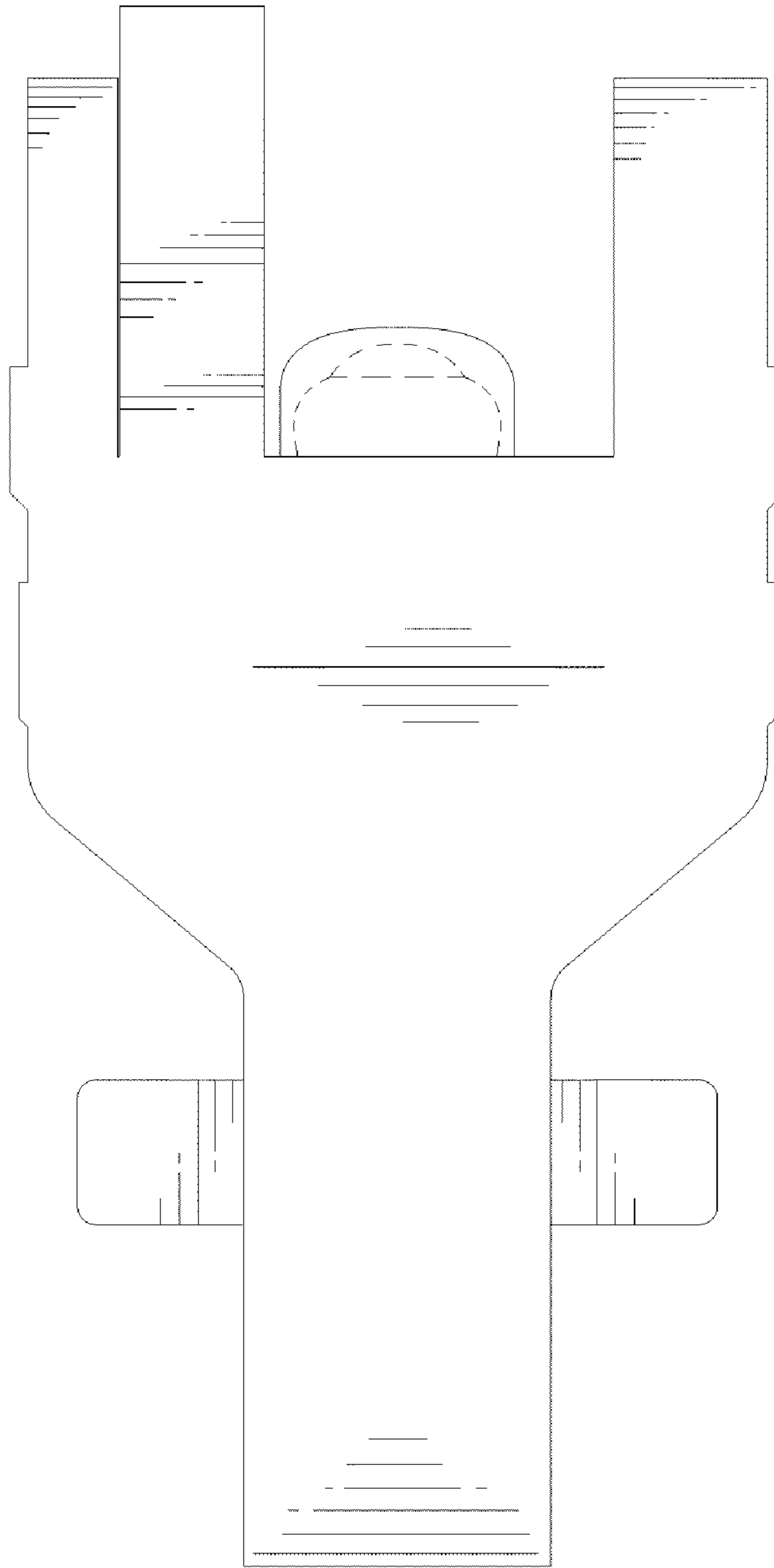
