(57) **CLAIM**

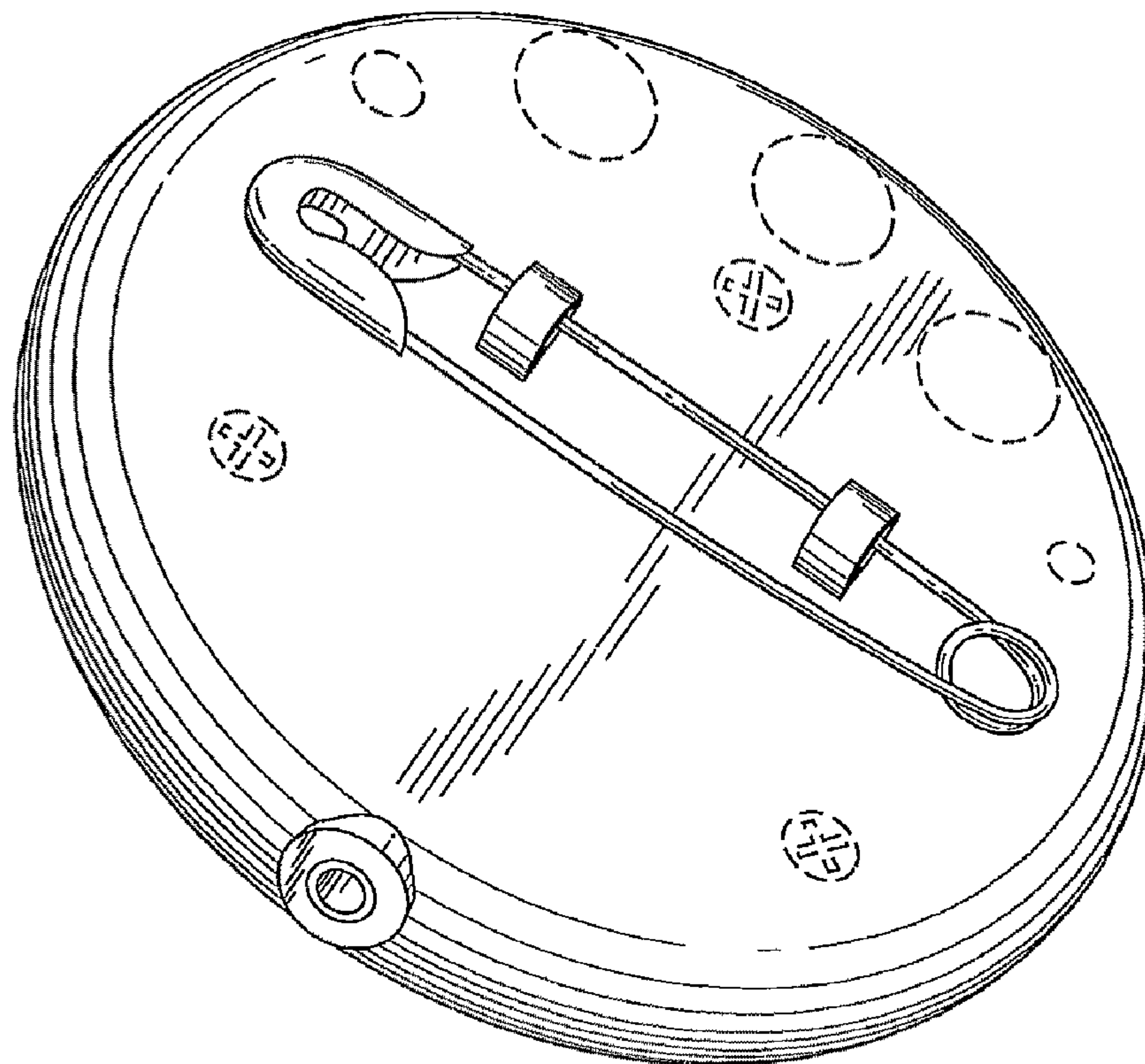
The ornamental design for a portable media player, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom rear perspective view of a portable media player showing my new design;  
FIG. 2 is a front elevation view thereof;

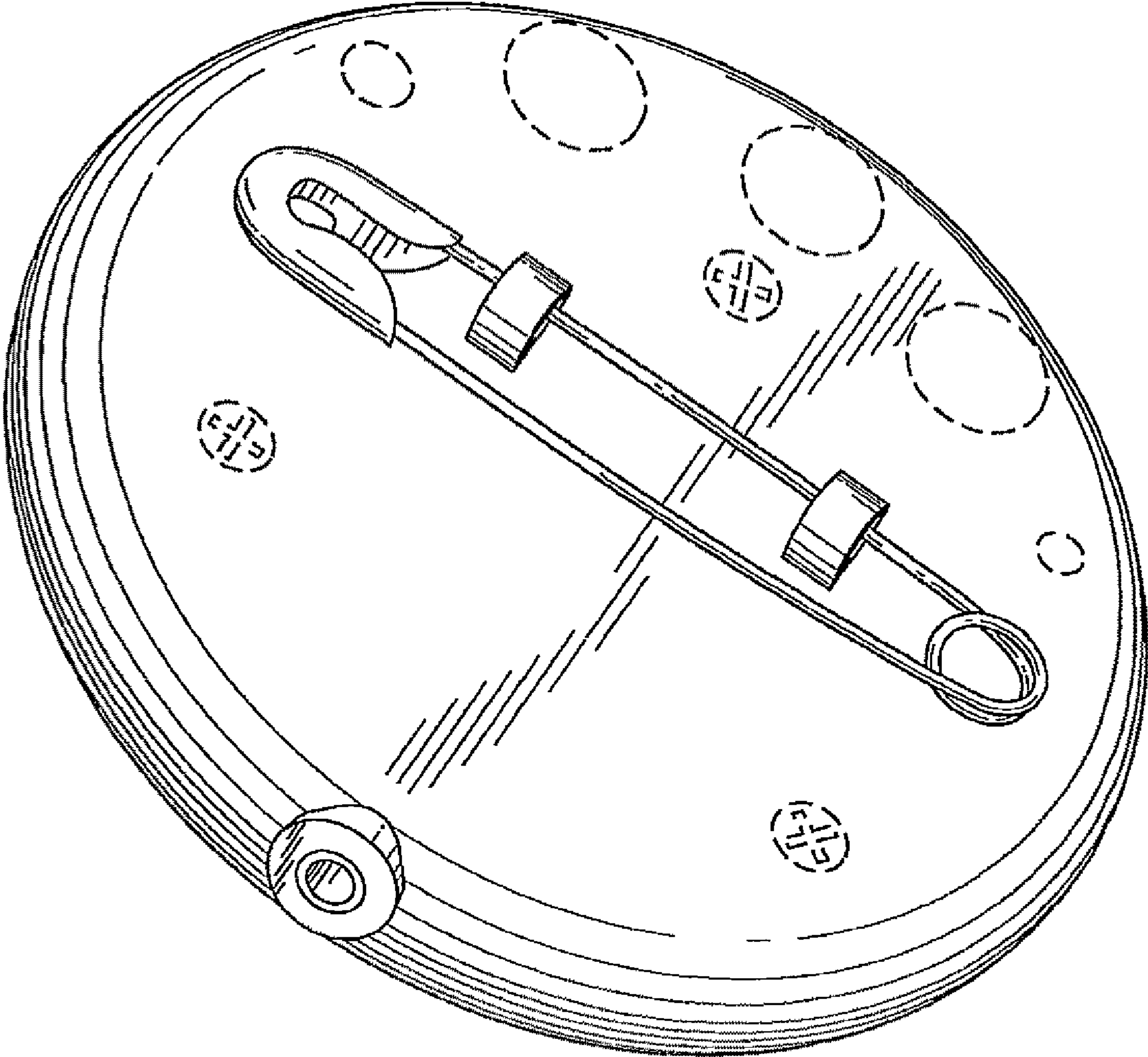

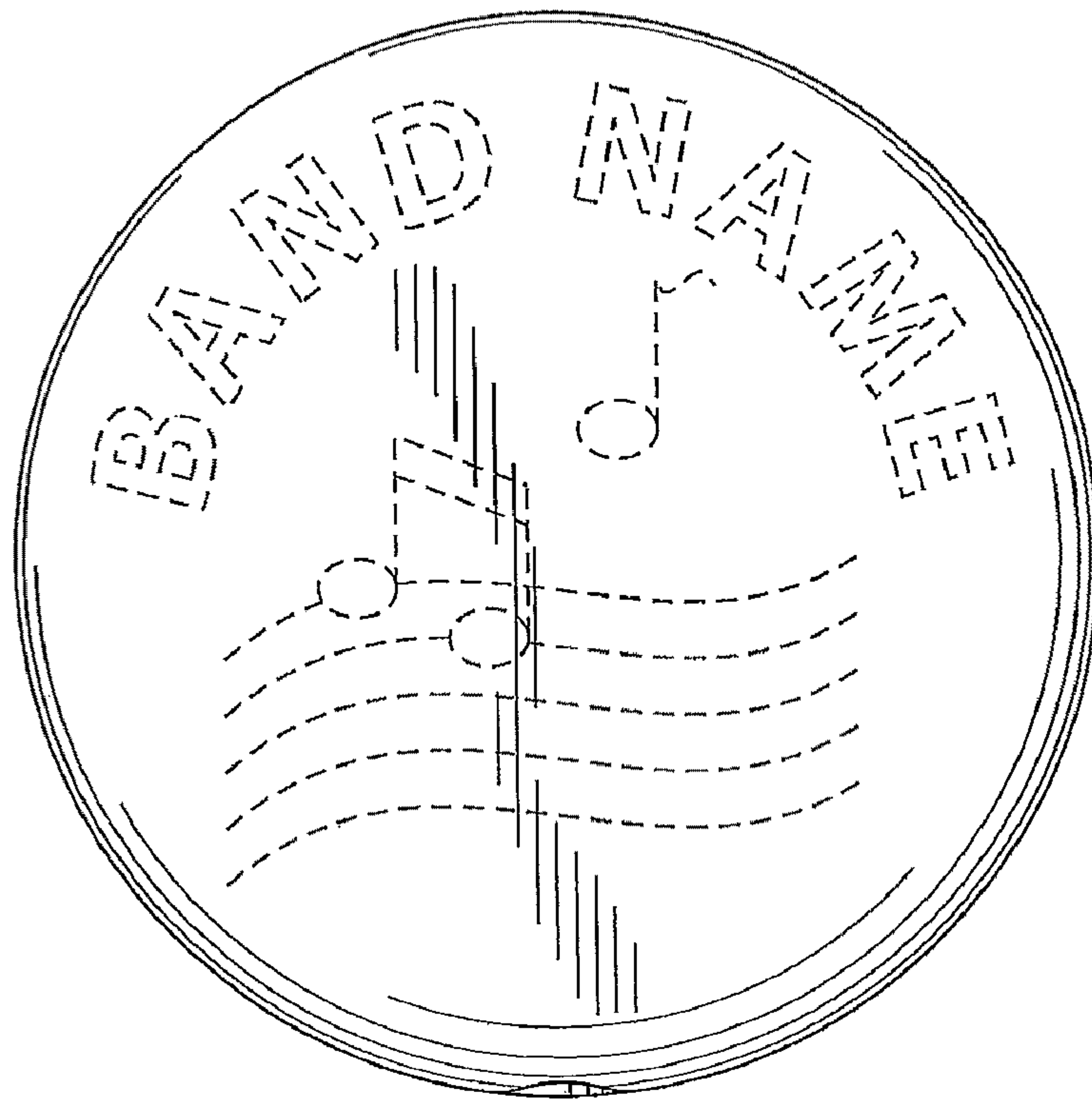

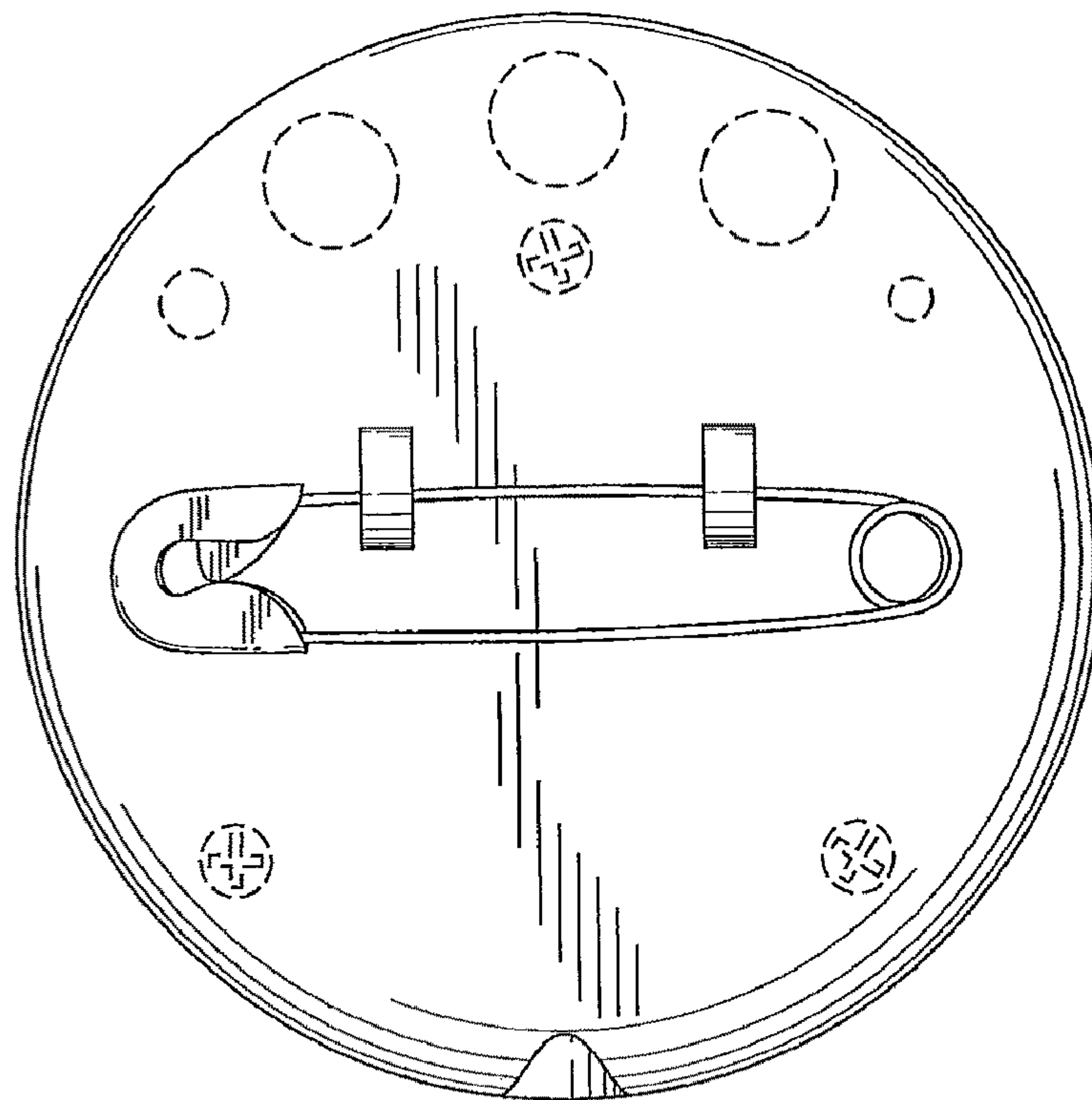

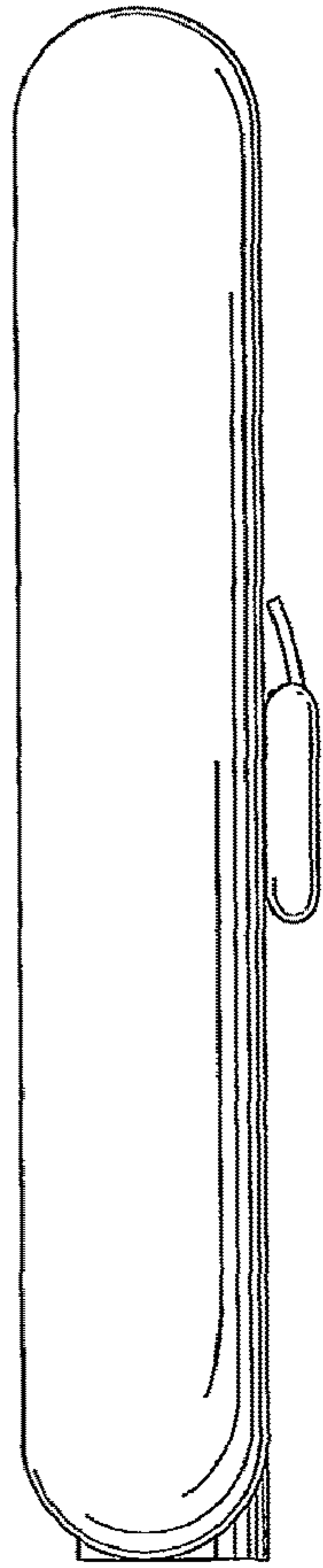

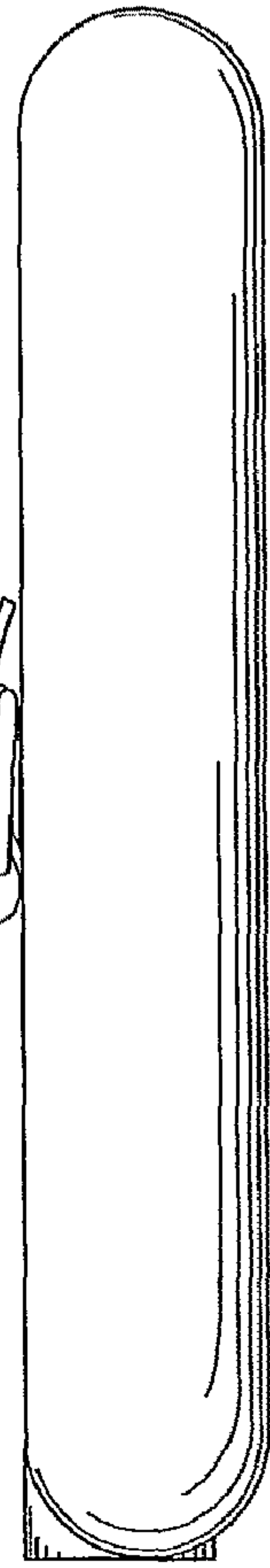

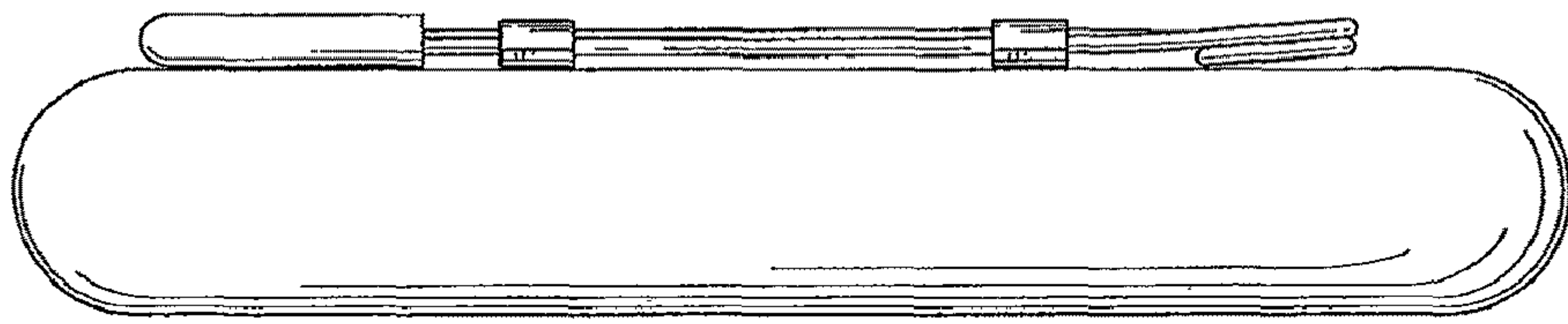

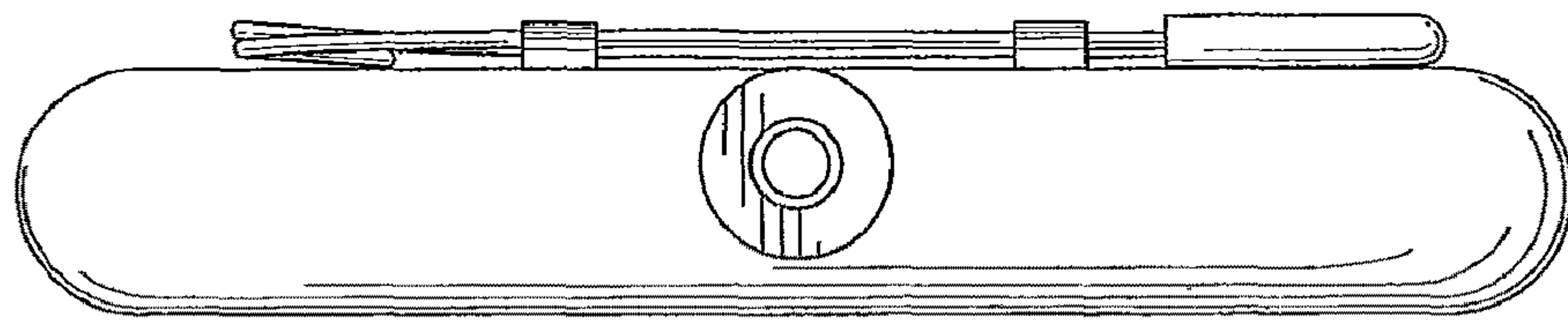
