What is claimed is the ornamental design for a ice dispenser paddle, as shown and described.

FIG. 4 is a top view of the ice dispenser paddle;

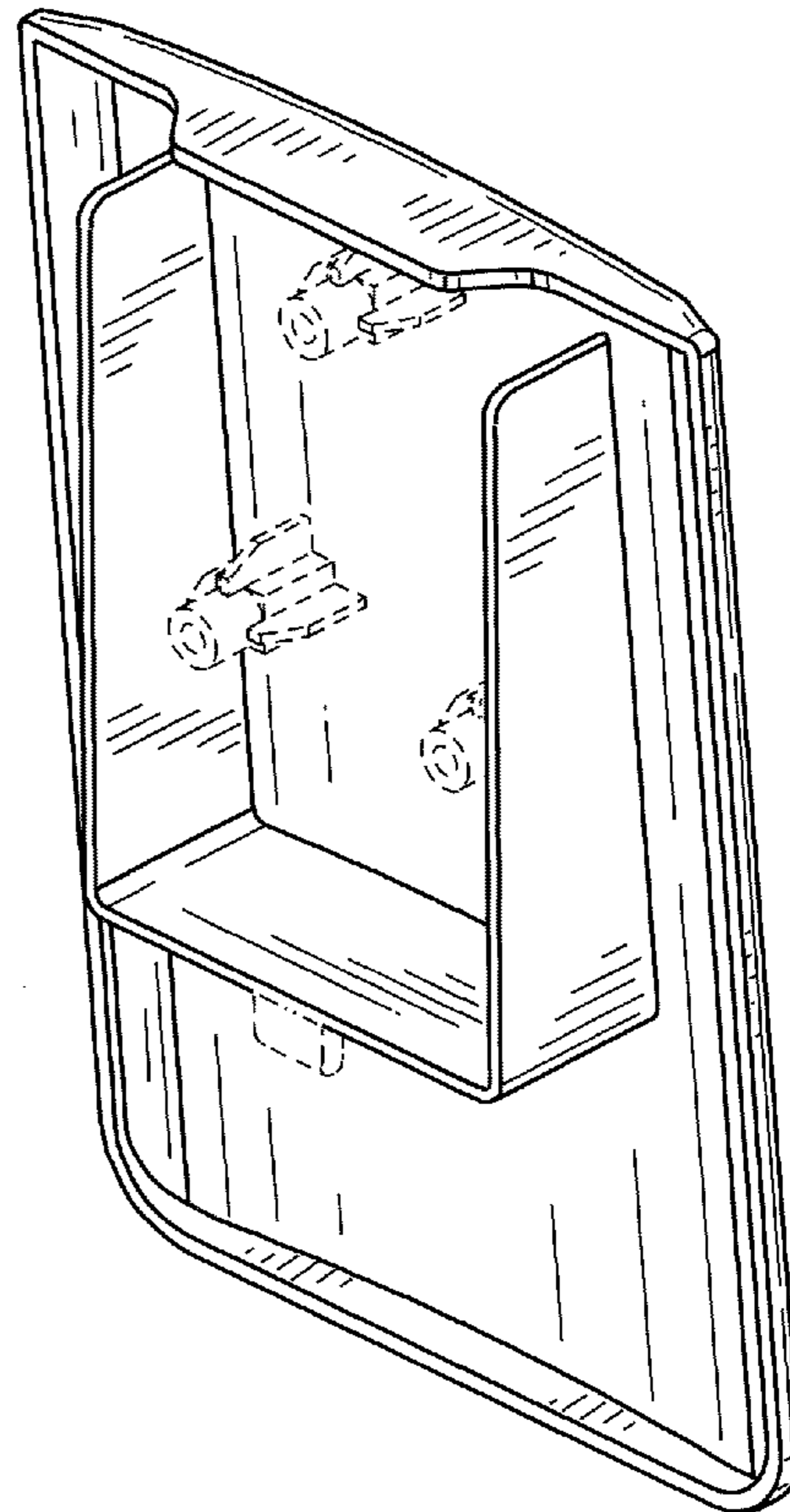
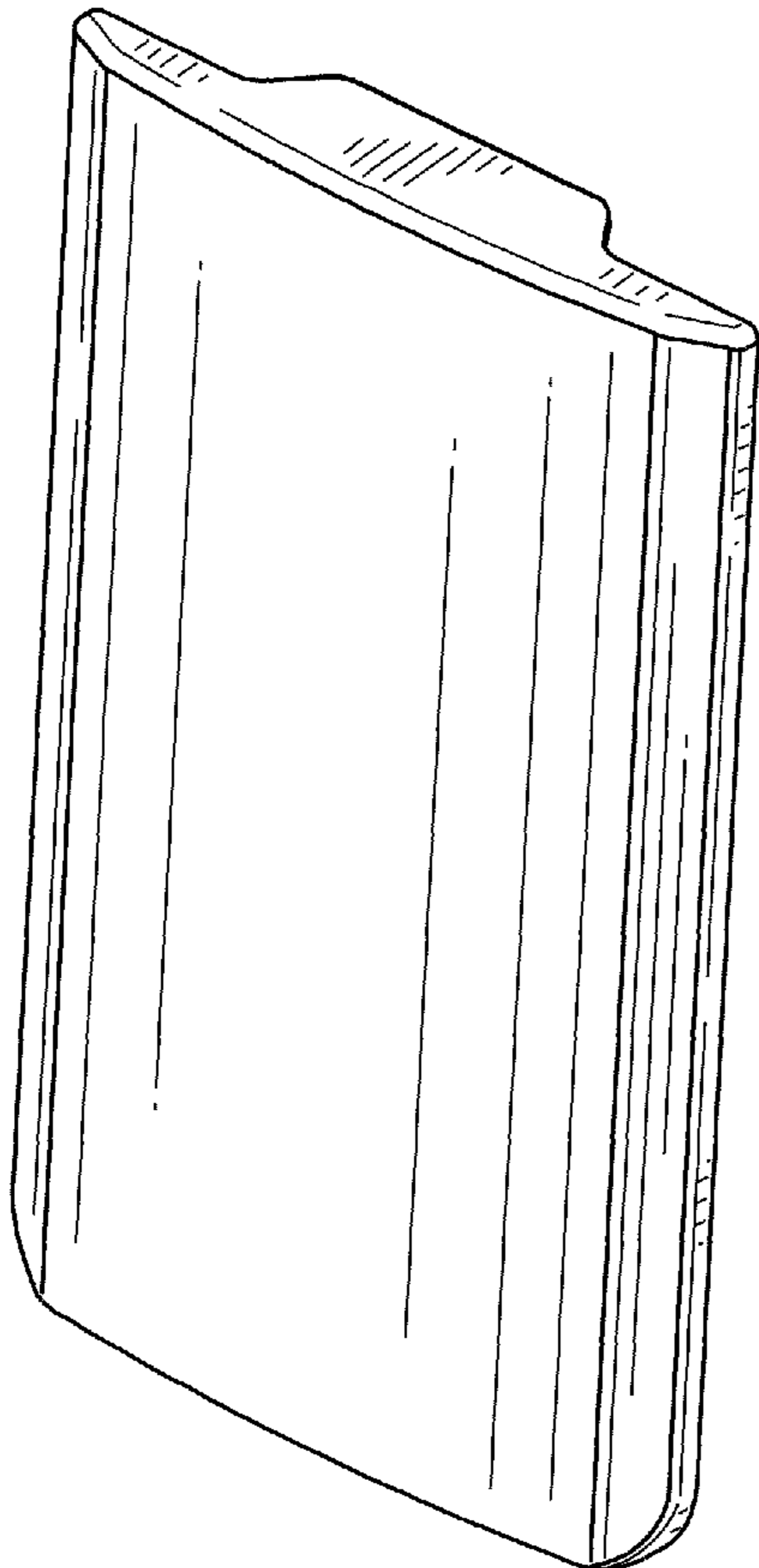
FIG. 5 is a bottom view of the ice dispenser paddle;

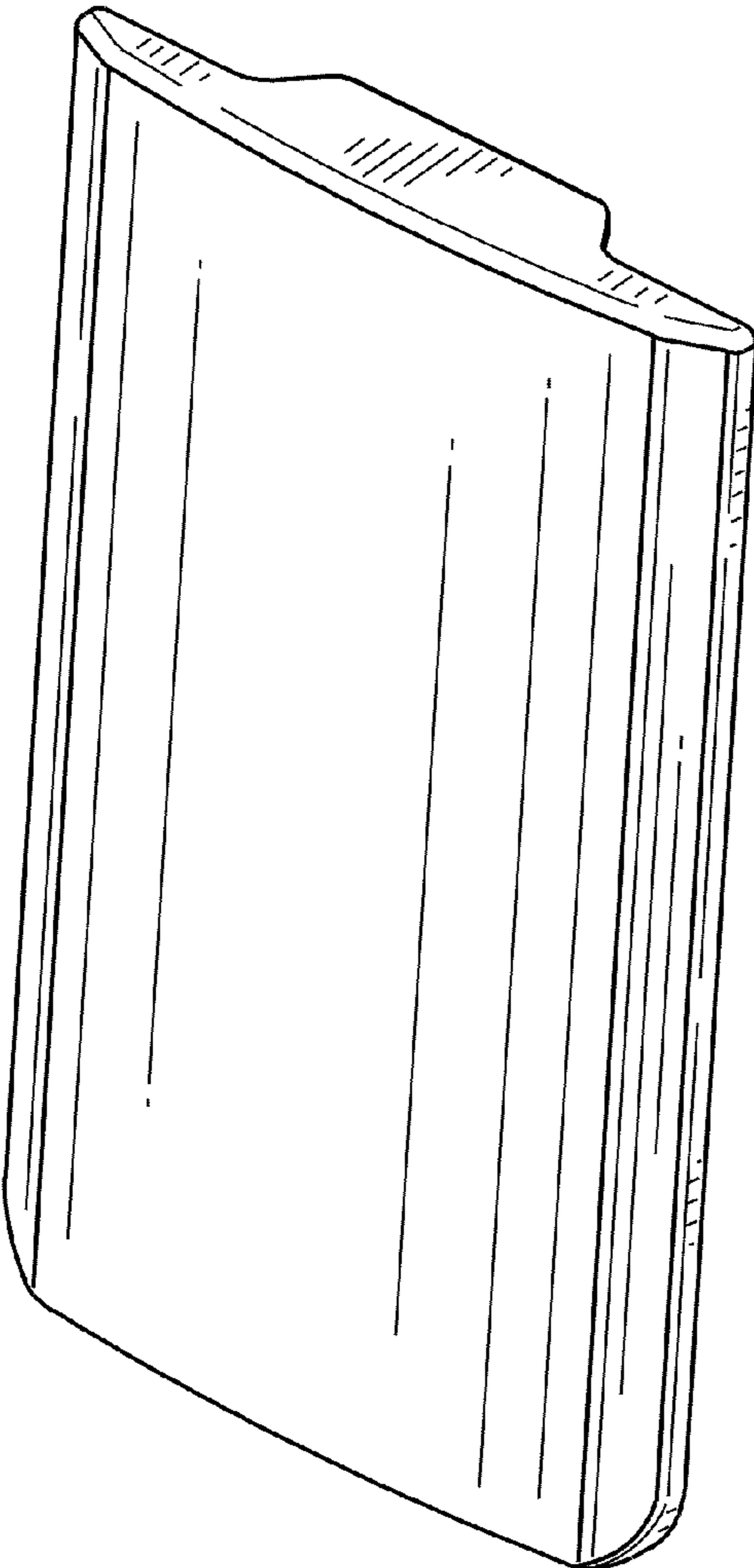

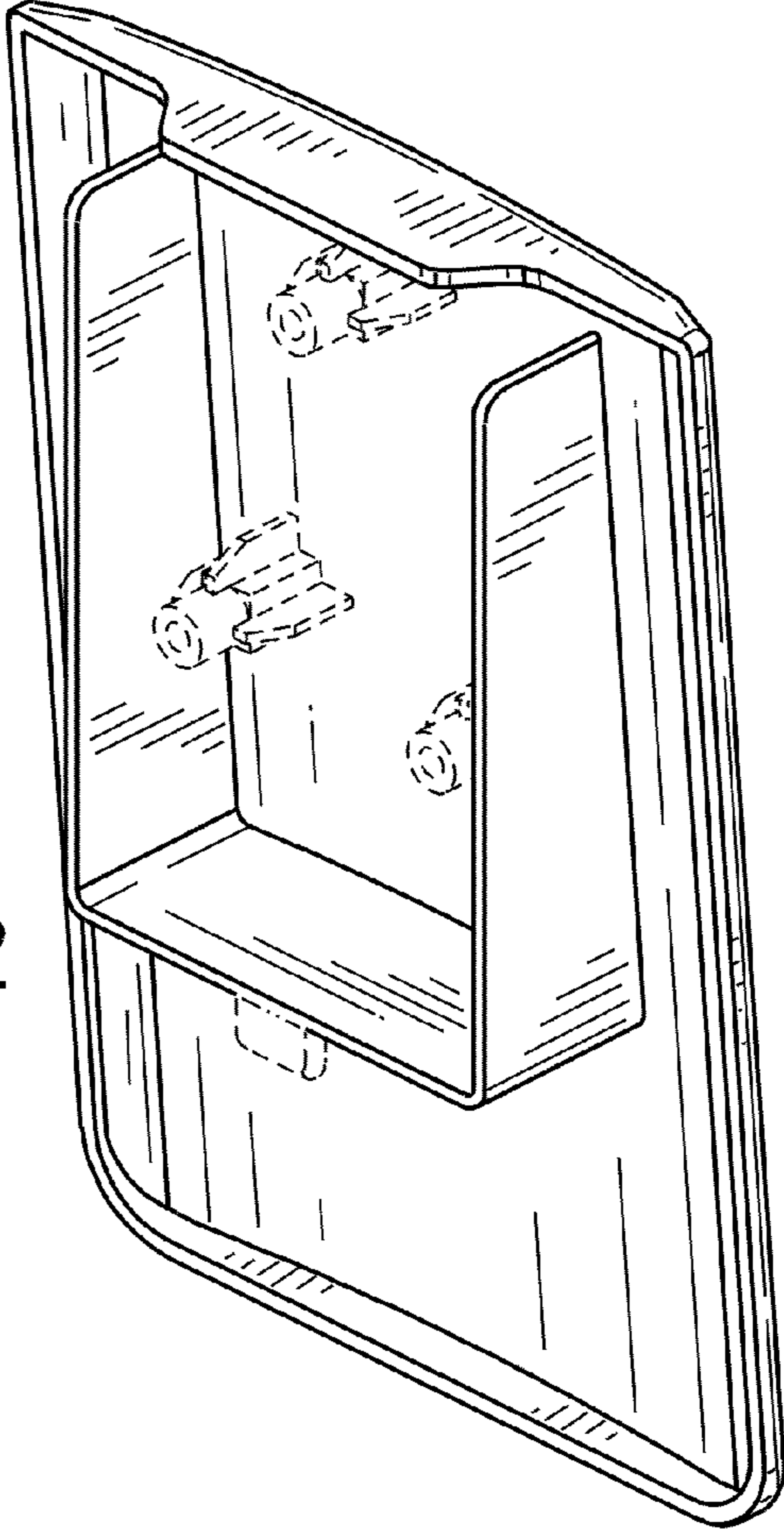

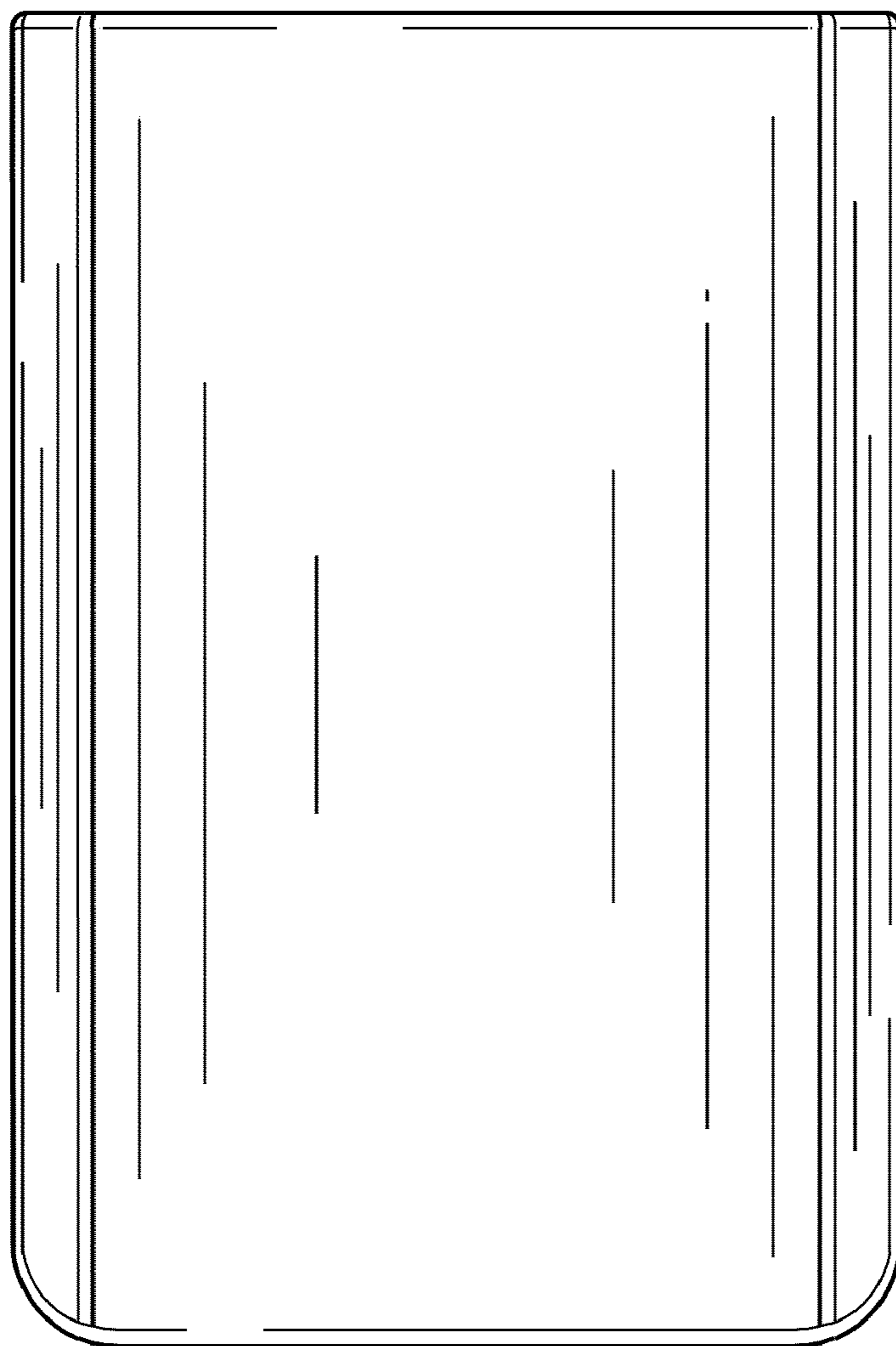

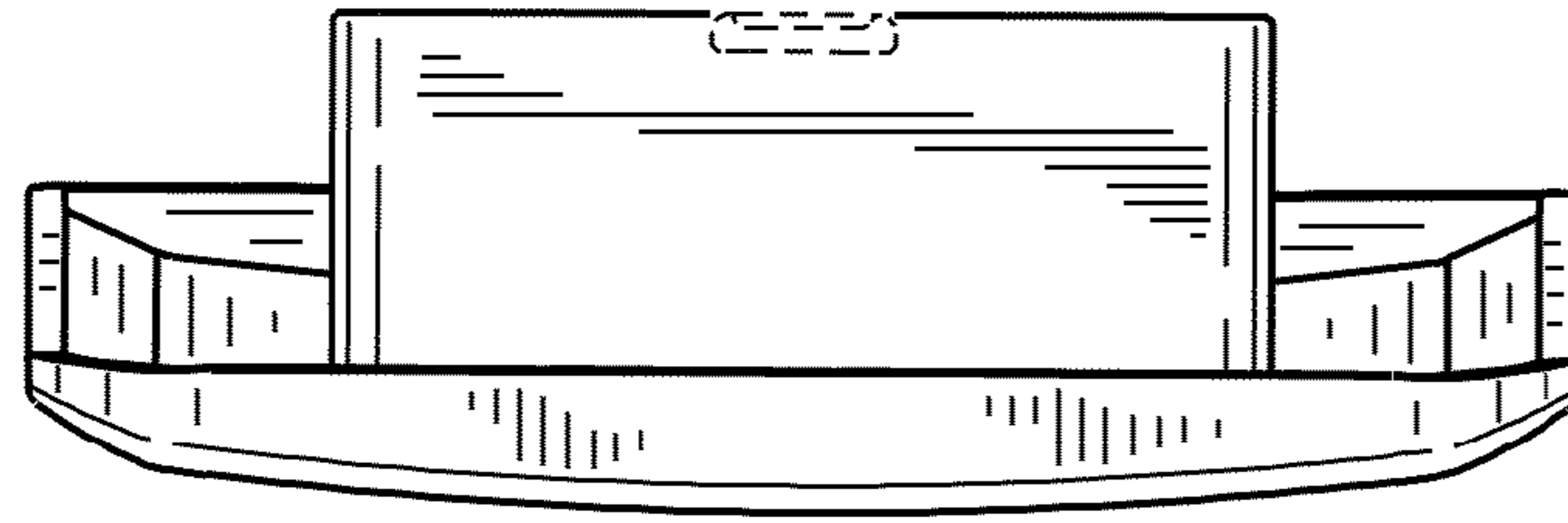

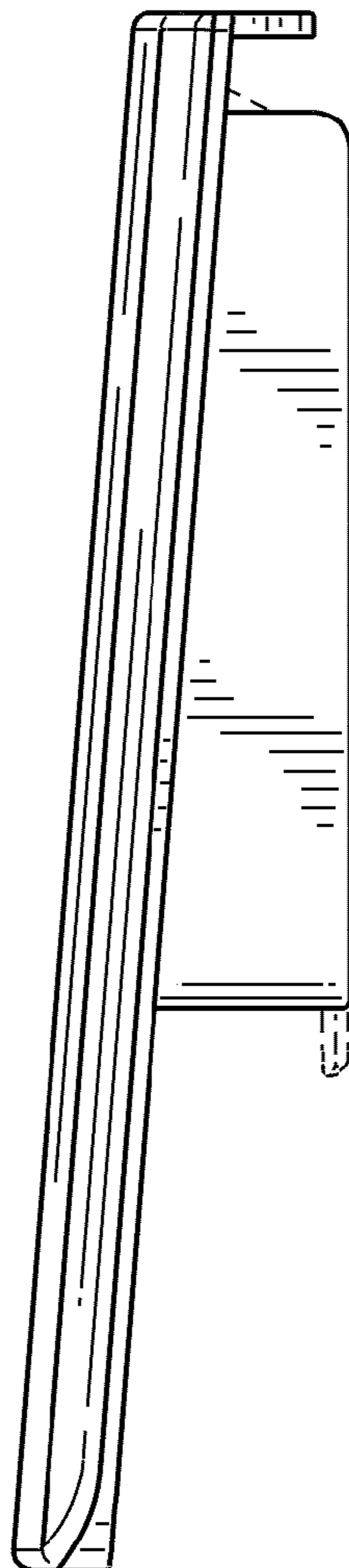

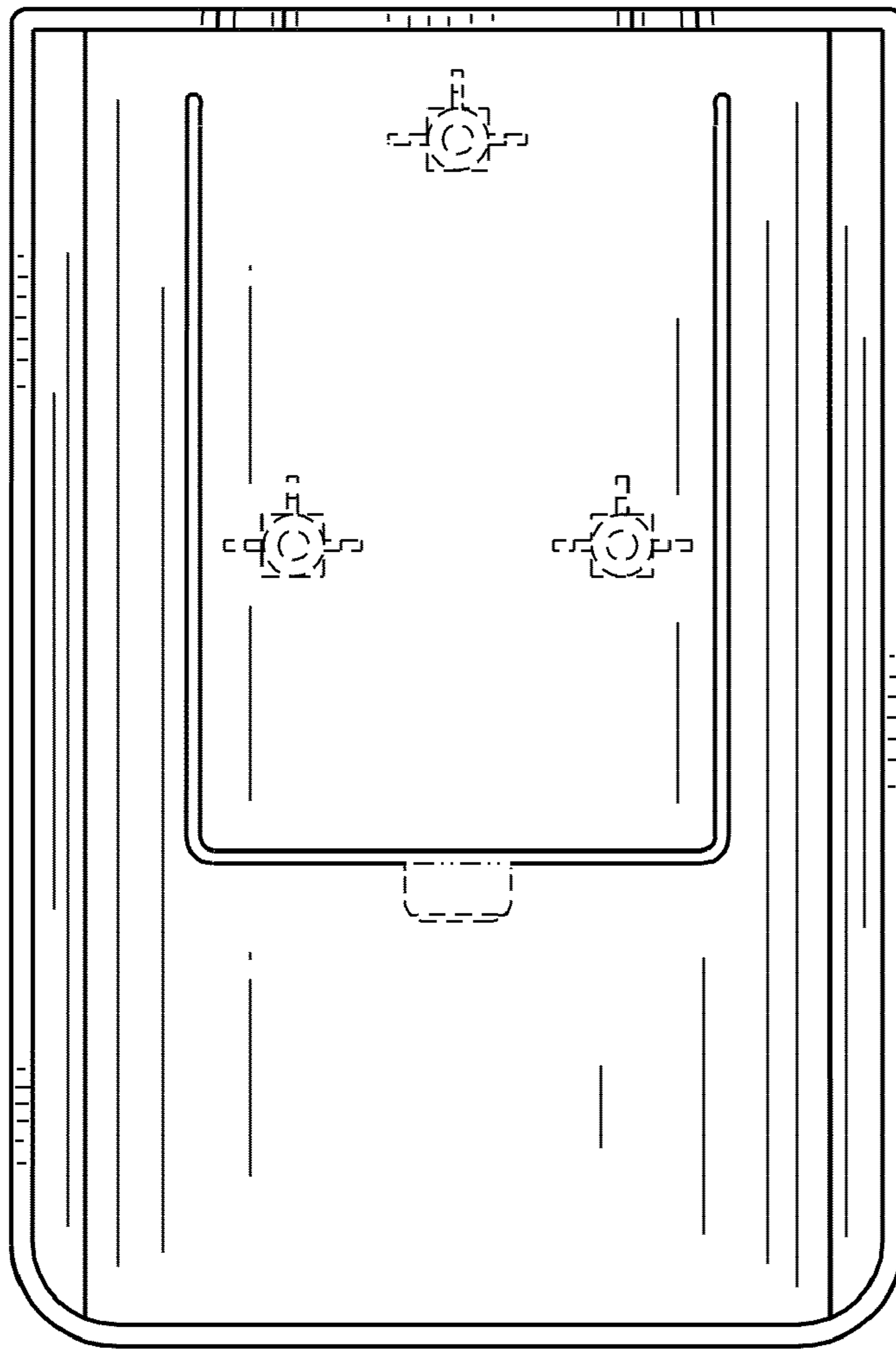
