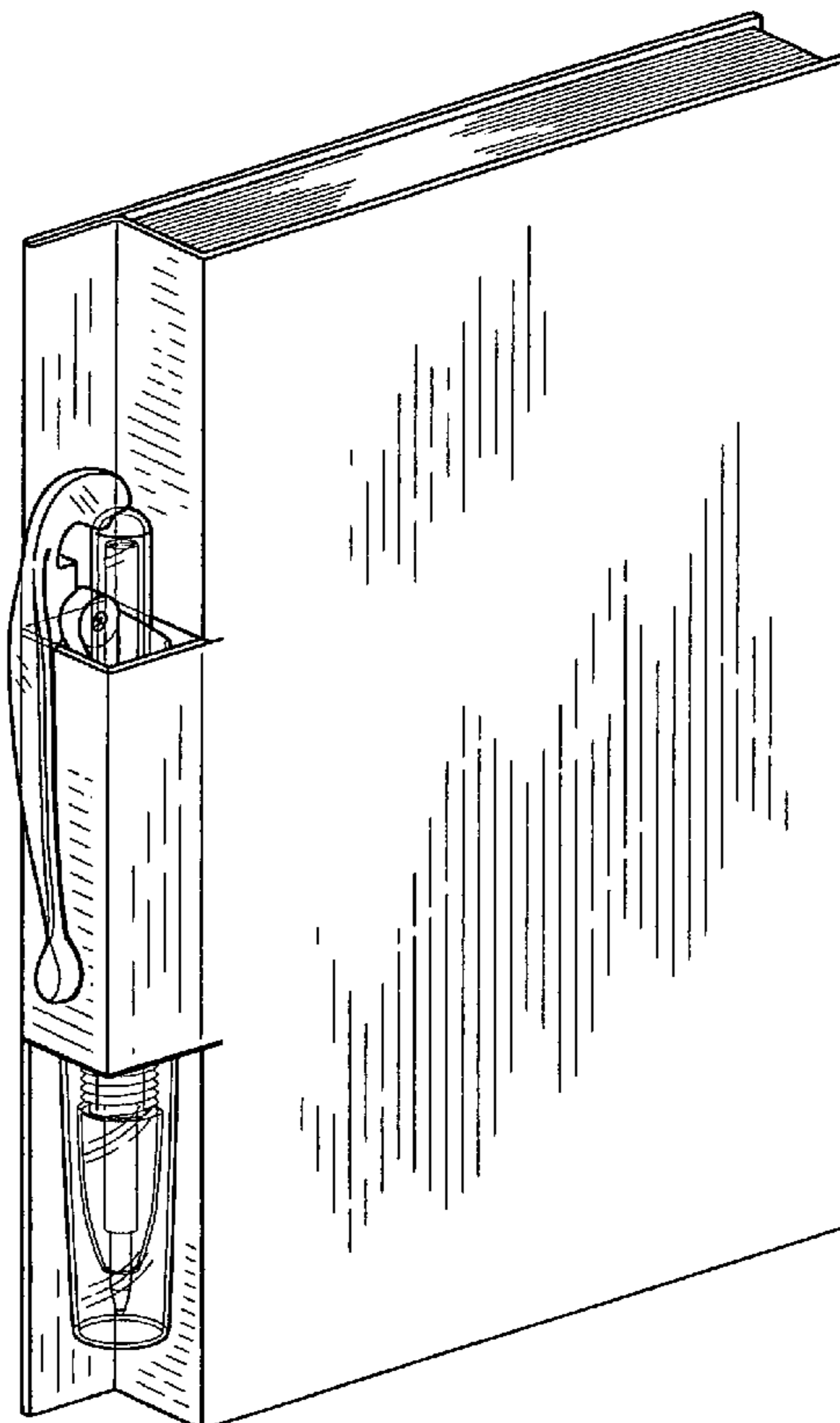
(57) **CLAIM**

The ornamental design for a notepad with integrally mounted writing instrument, as shown.

DESCRIPTION

FIG. 1 is a perspective view.
 FIG. 2 is a front plan view.
 FIG. 3 is a rear plan view;
 FIG. 4 is a side plan view taken from the left of FIG. 2;
 FIG. 5 is a side plan view taken from the right of FIG. 2;
 FIG. 6 is a top plan view;
 FIG. 7 is a bottom plan view;
 FIG. 8 is an exploded front perspective view showing the writing instrument removed for clarity;
 FIG. 9 is a front plan exploded view showing the pen removed for clarity with the pen shown in the deployed position; and,
 FIG. 10 is a side plan exploded view showing the pen removed from attachment to the notepad for clarity.

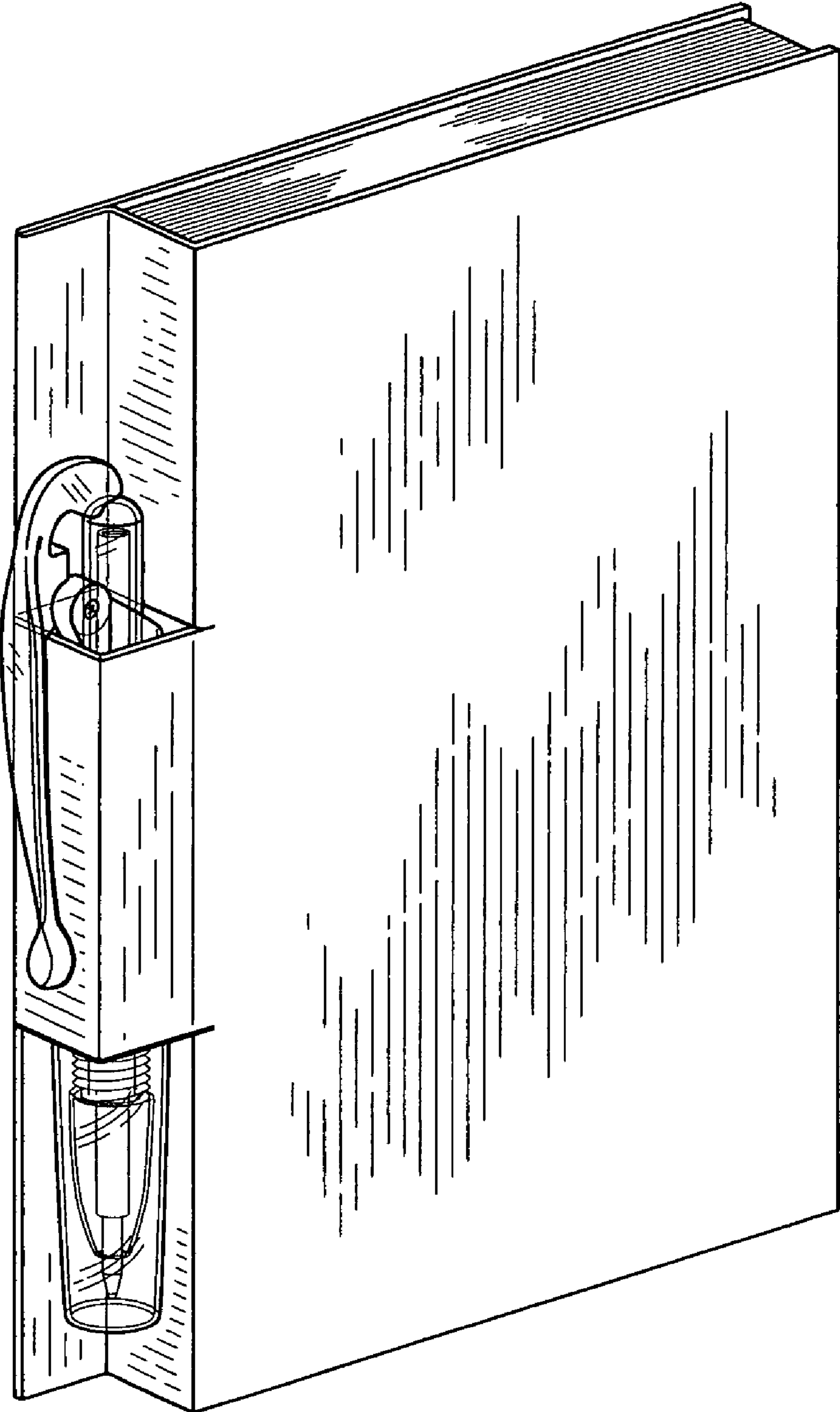

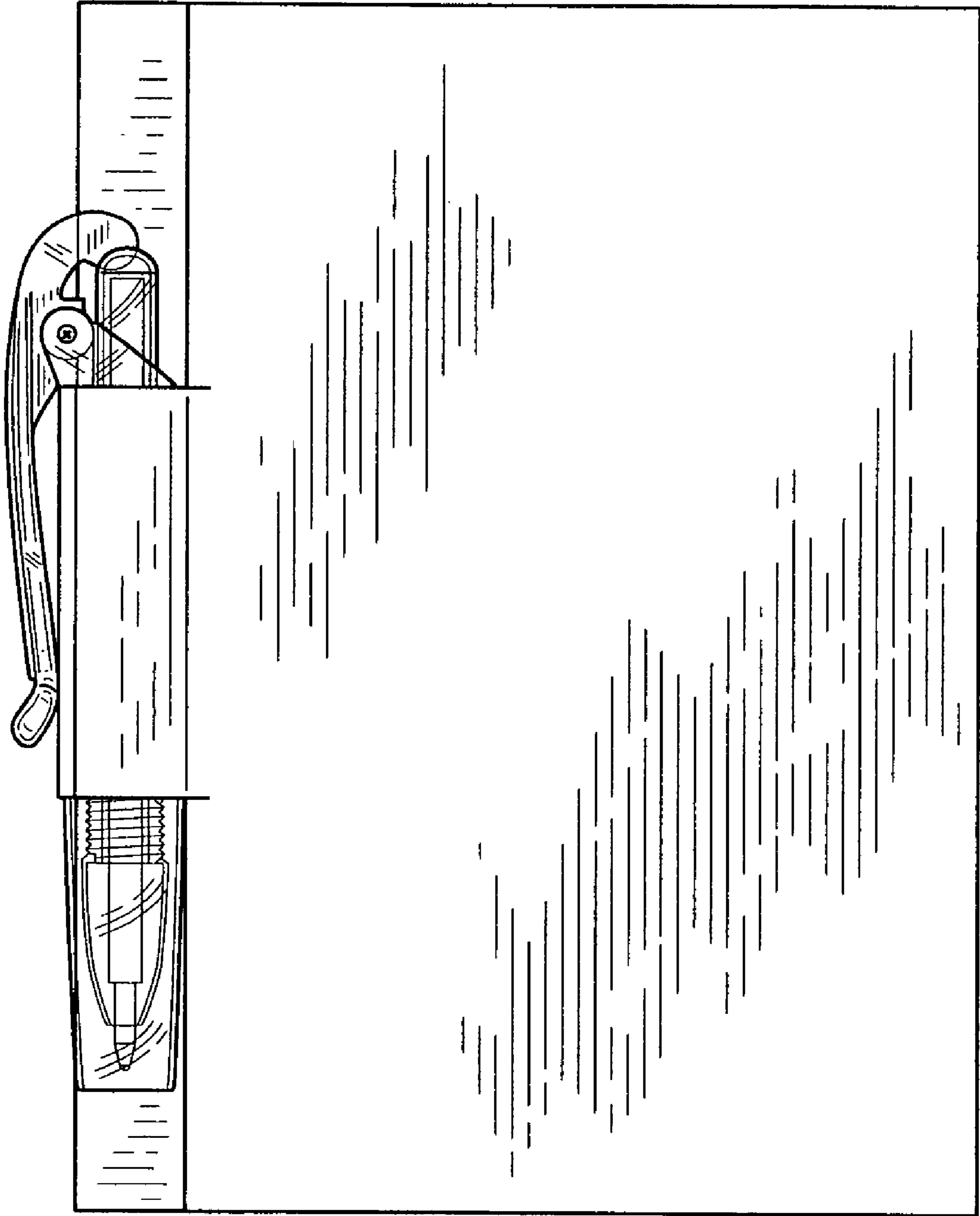

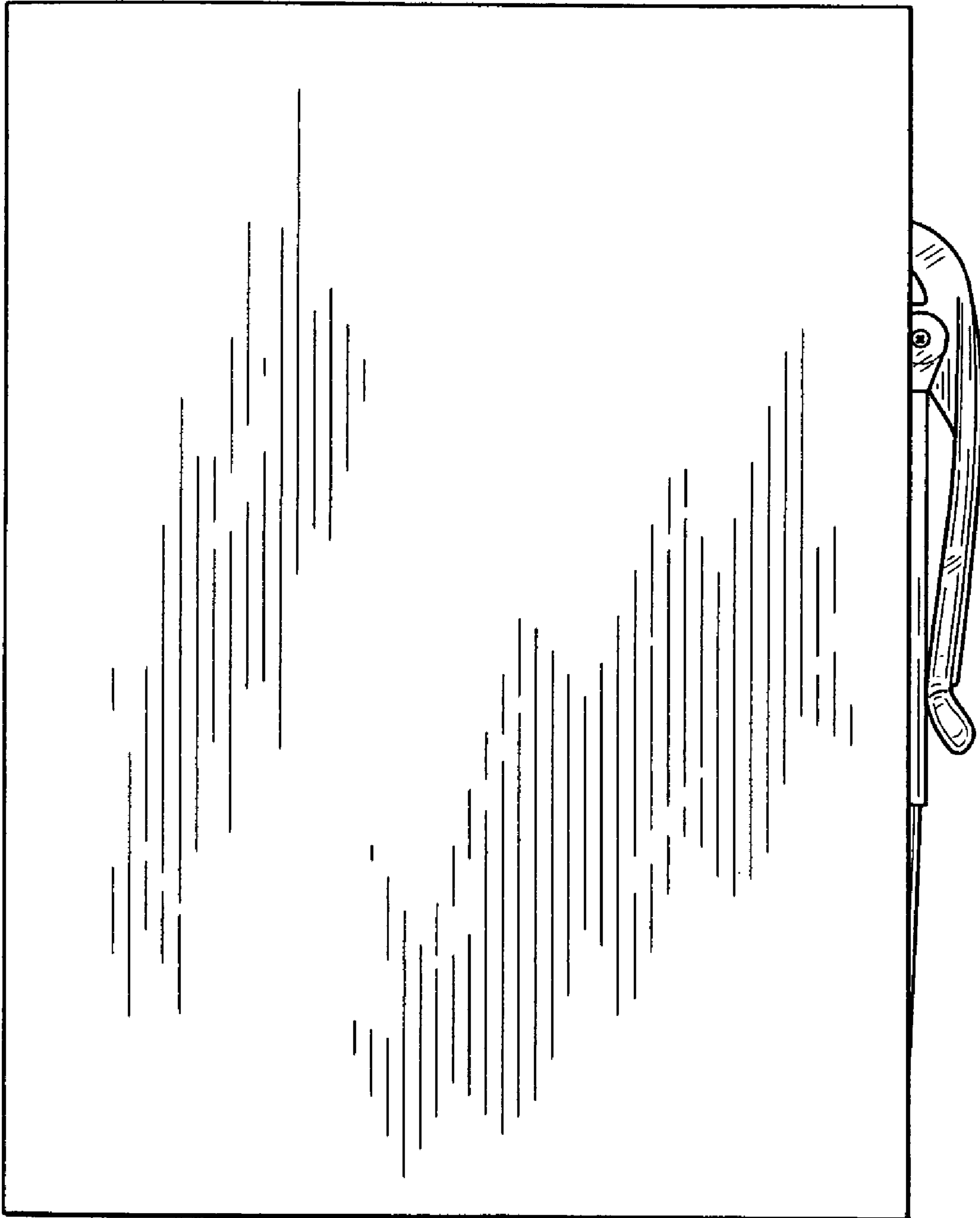

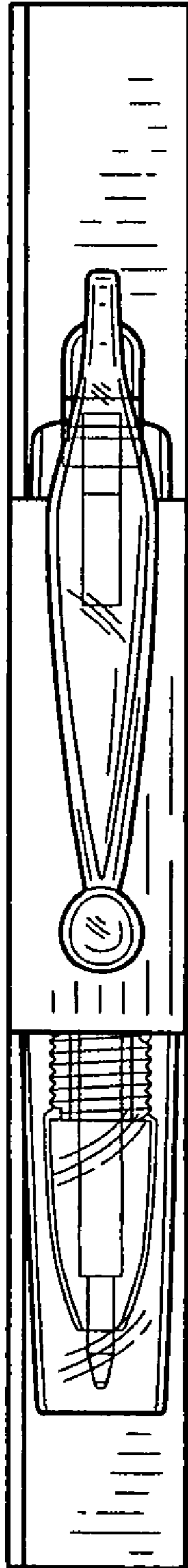

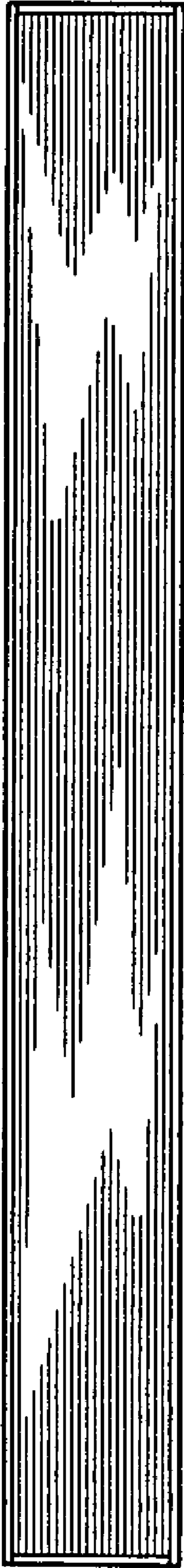

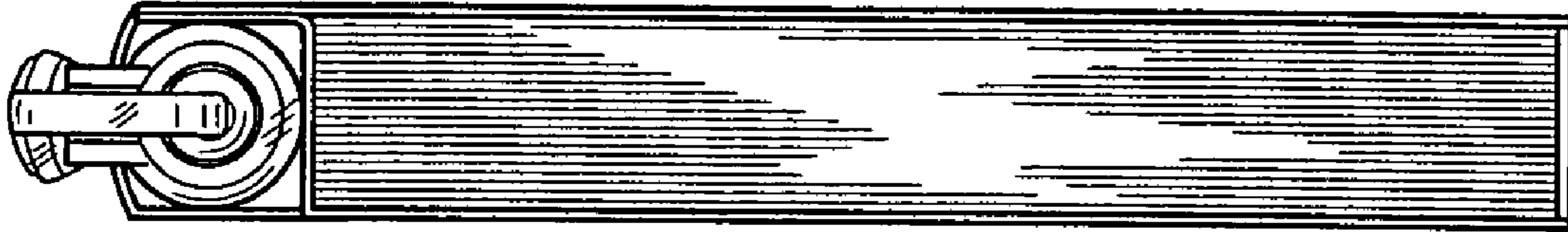

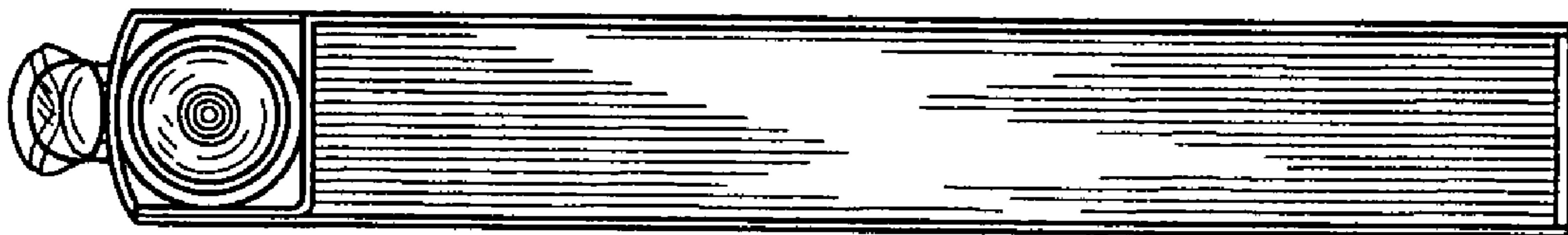

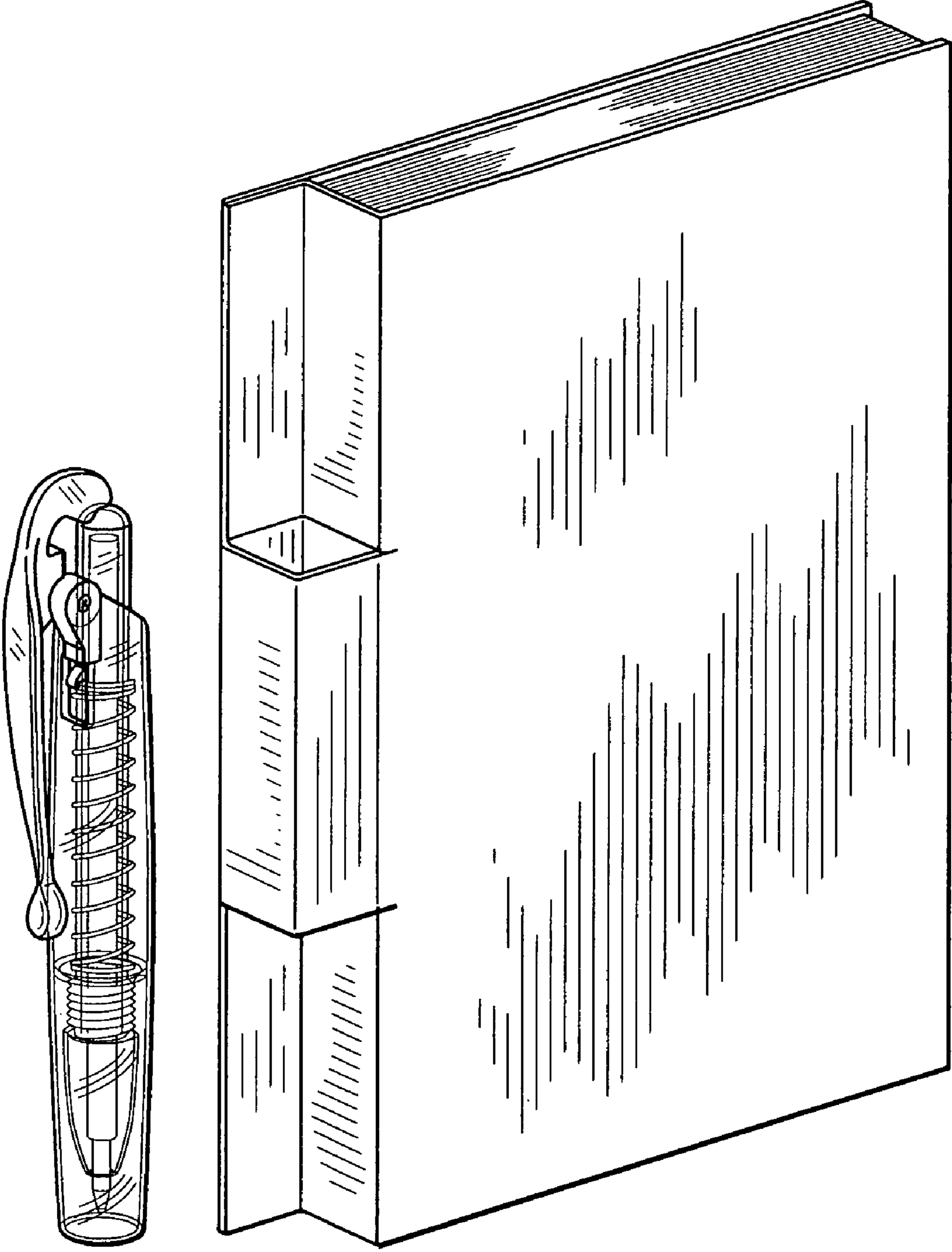

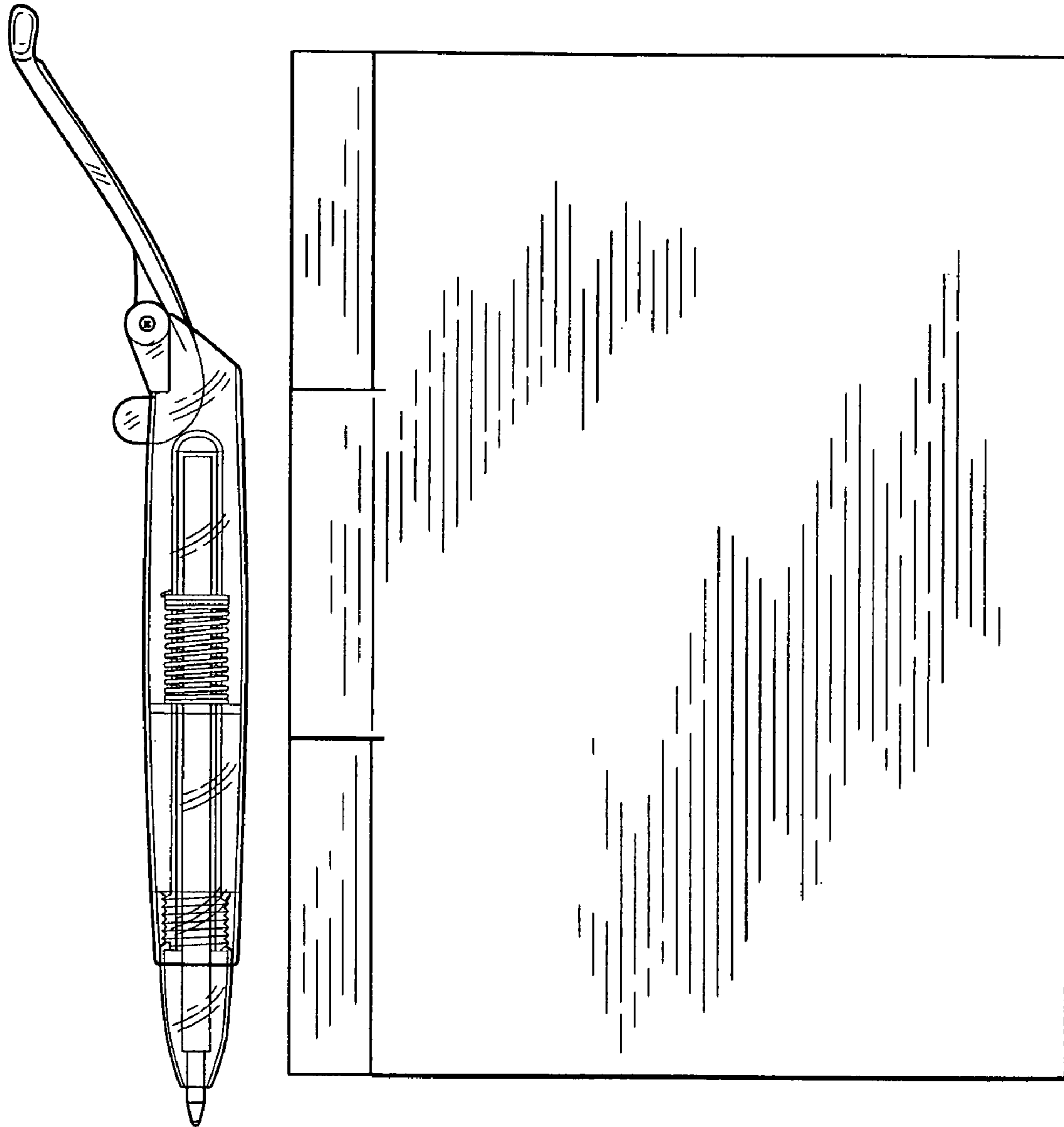

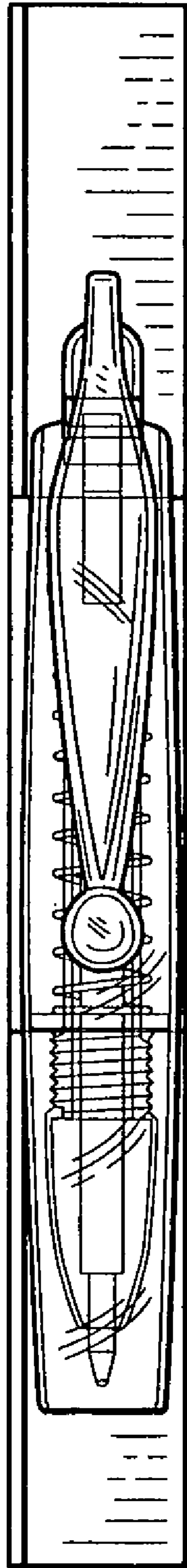
