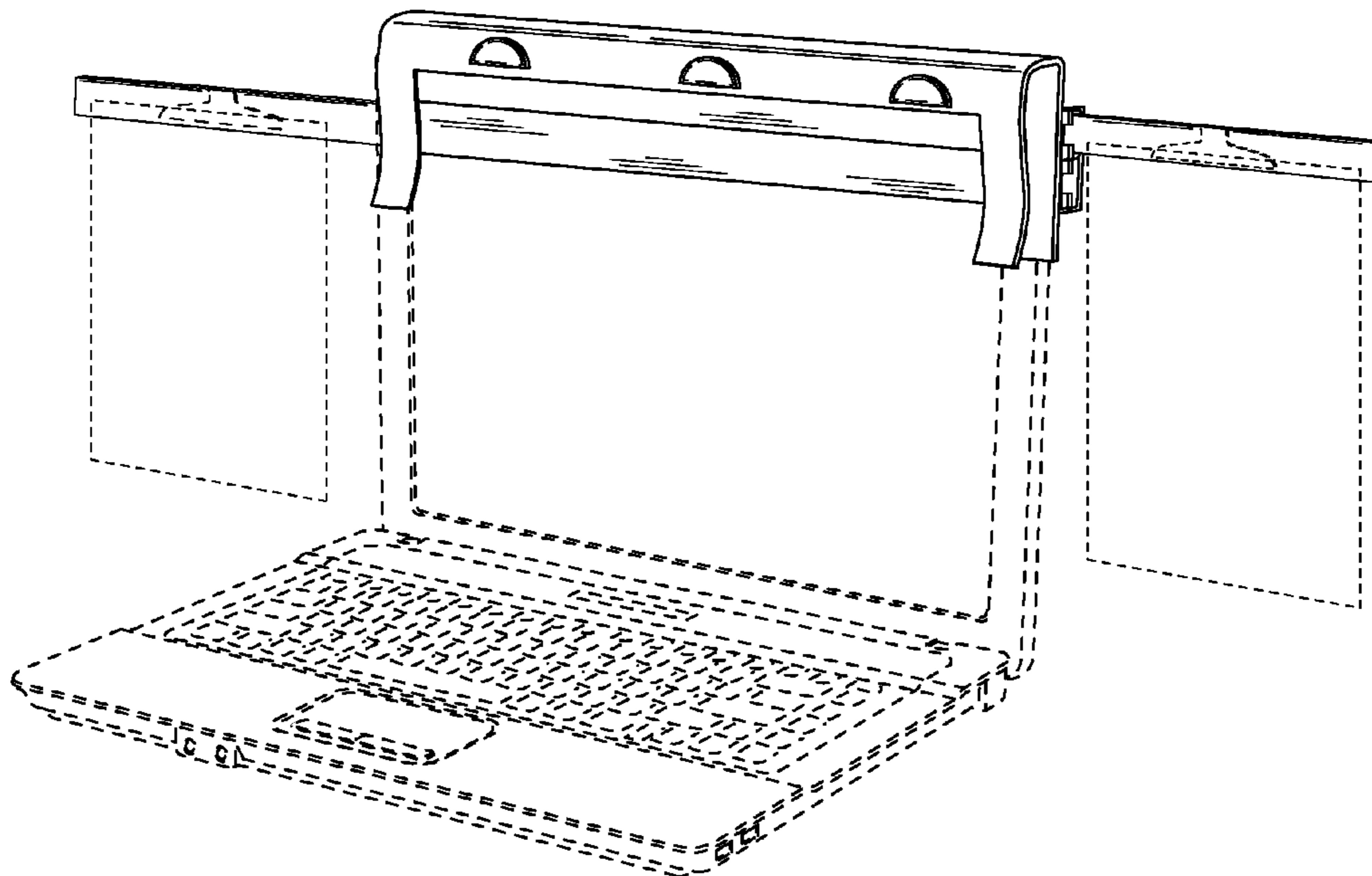
(57) **CLAIM**

What is claimed is the ornamental design for a document holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a document holder, showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is an enlarged left-side elevational view thereof;  
FIG. 5 is an enlarged right-side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines showing a laptop computer, clips and two documents in FIG. 1, clips in FIG. 2 and features in FIGS. 4 and 5 are included for the purpose of illustrating environmental features and portions of the invention that form no part of the claimed design.

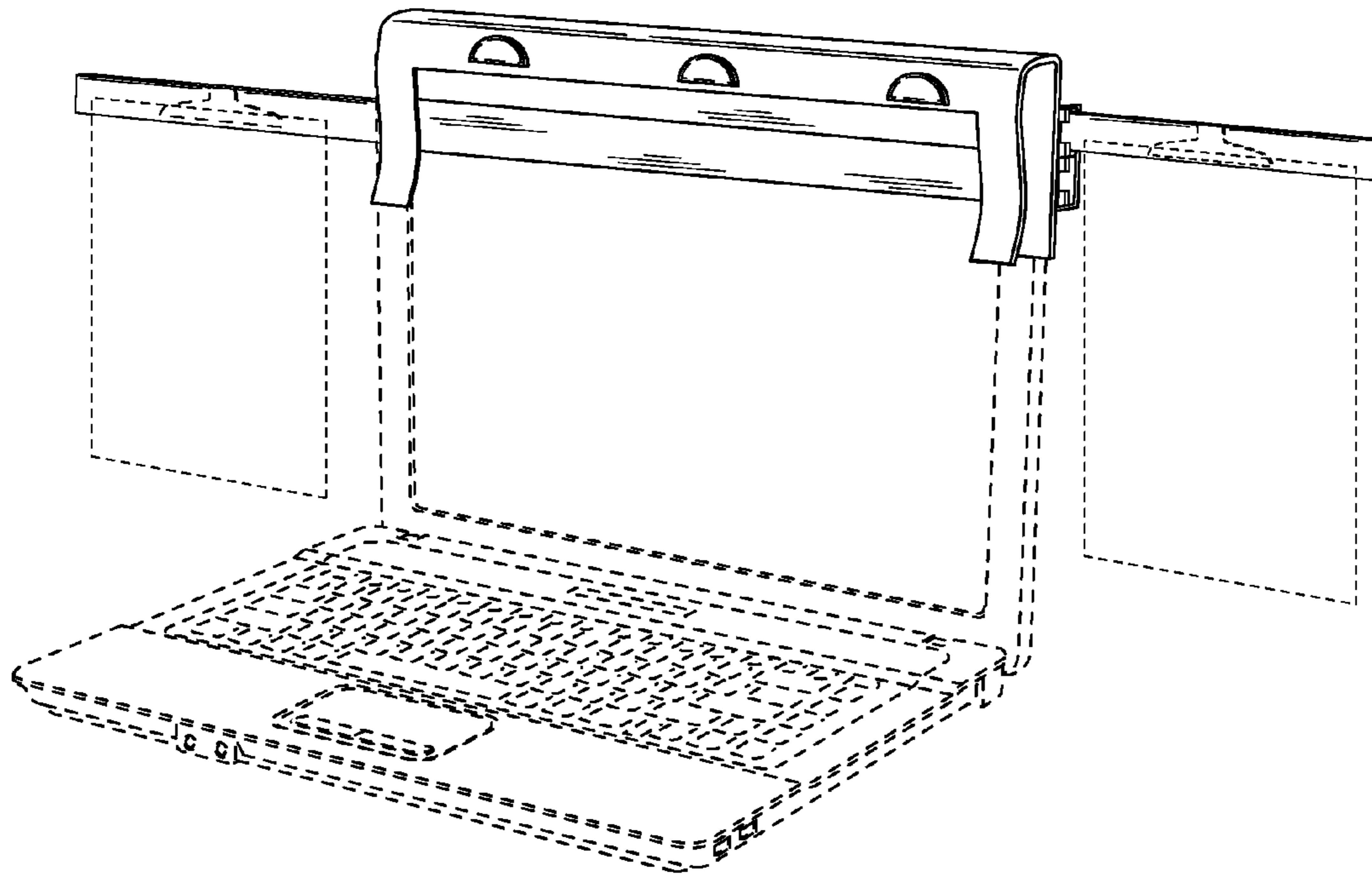

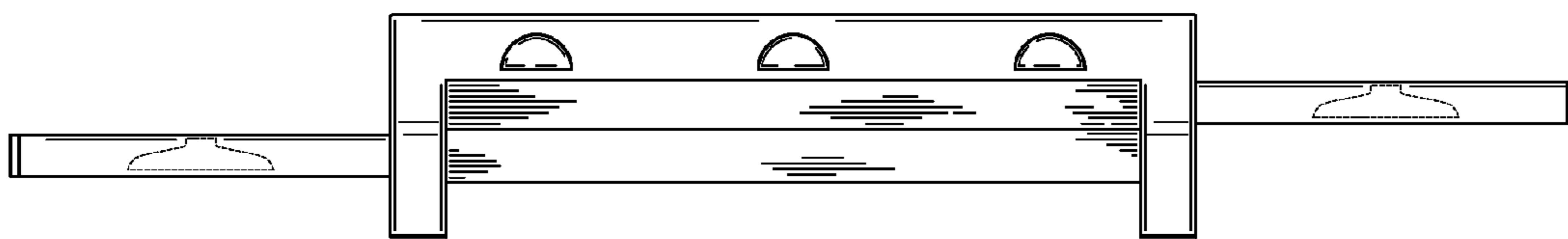

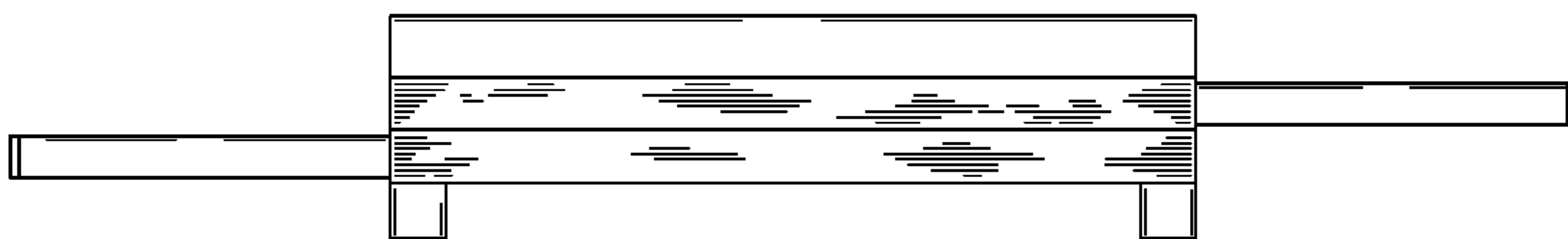

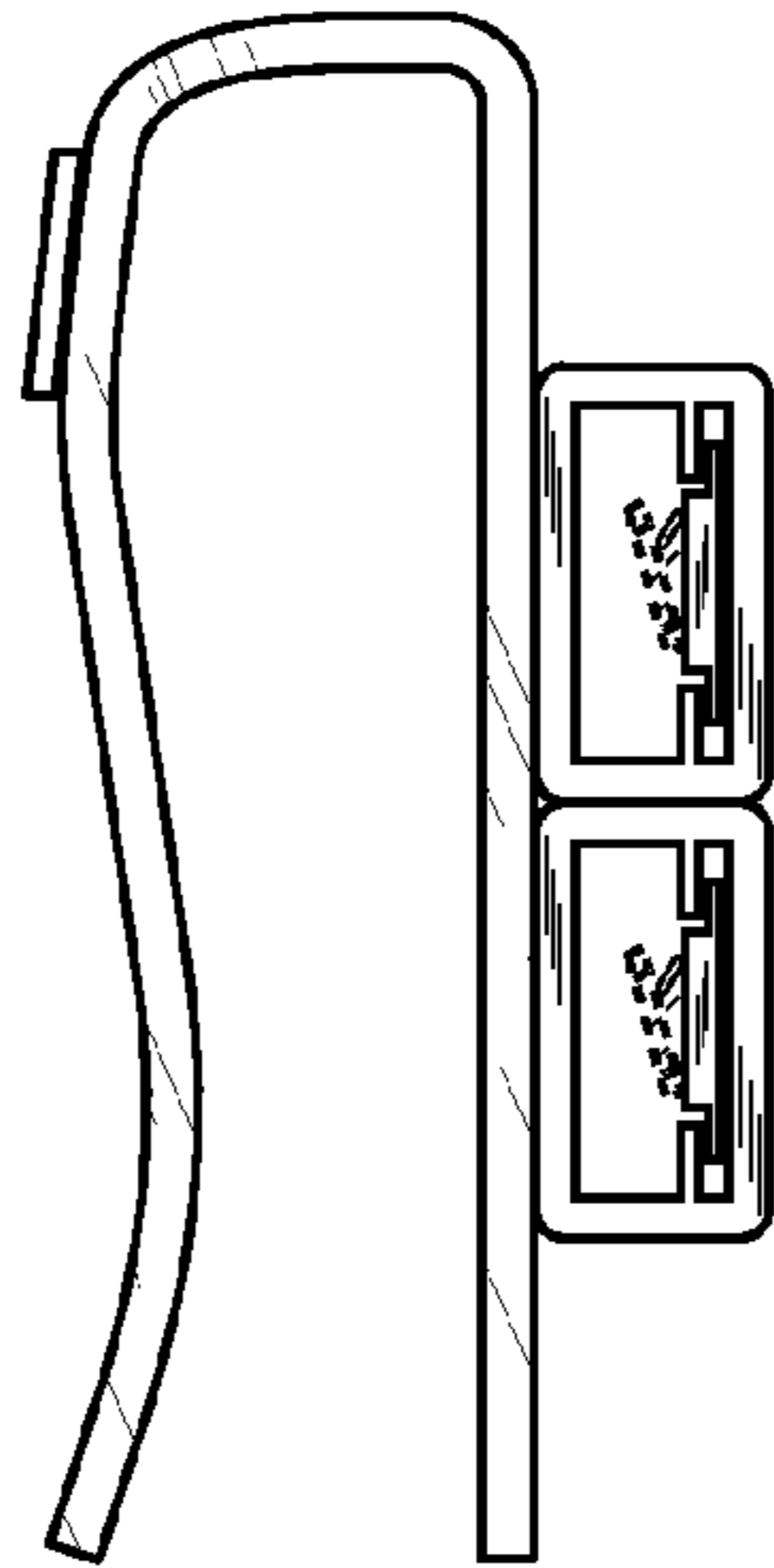

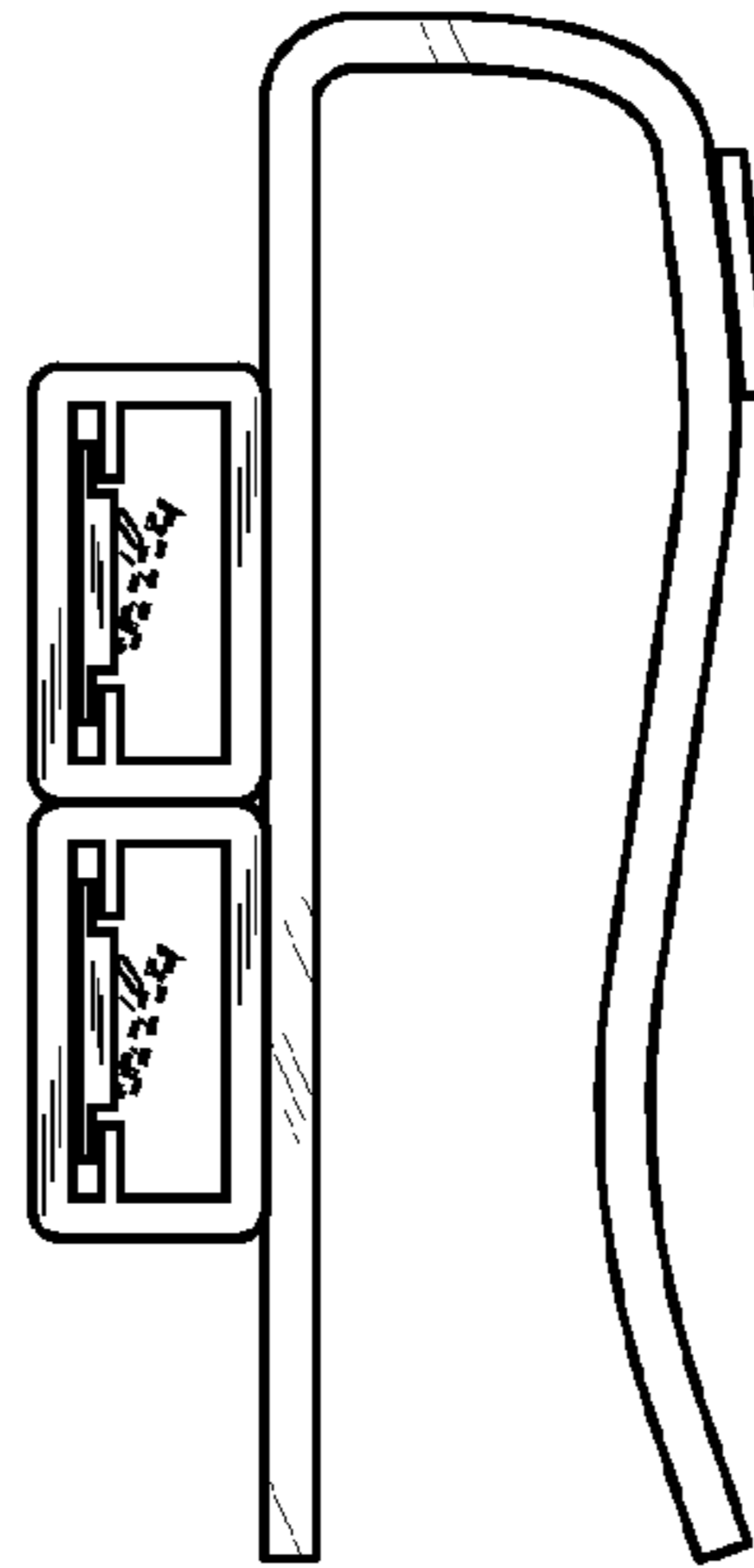

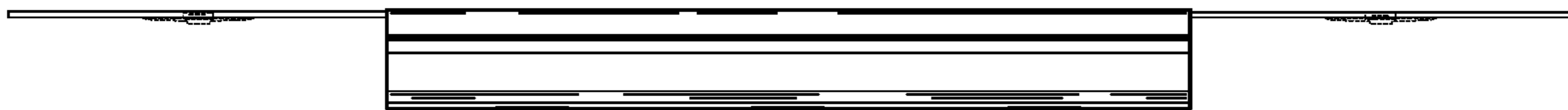
