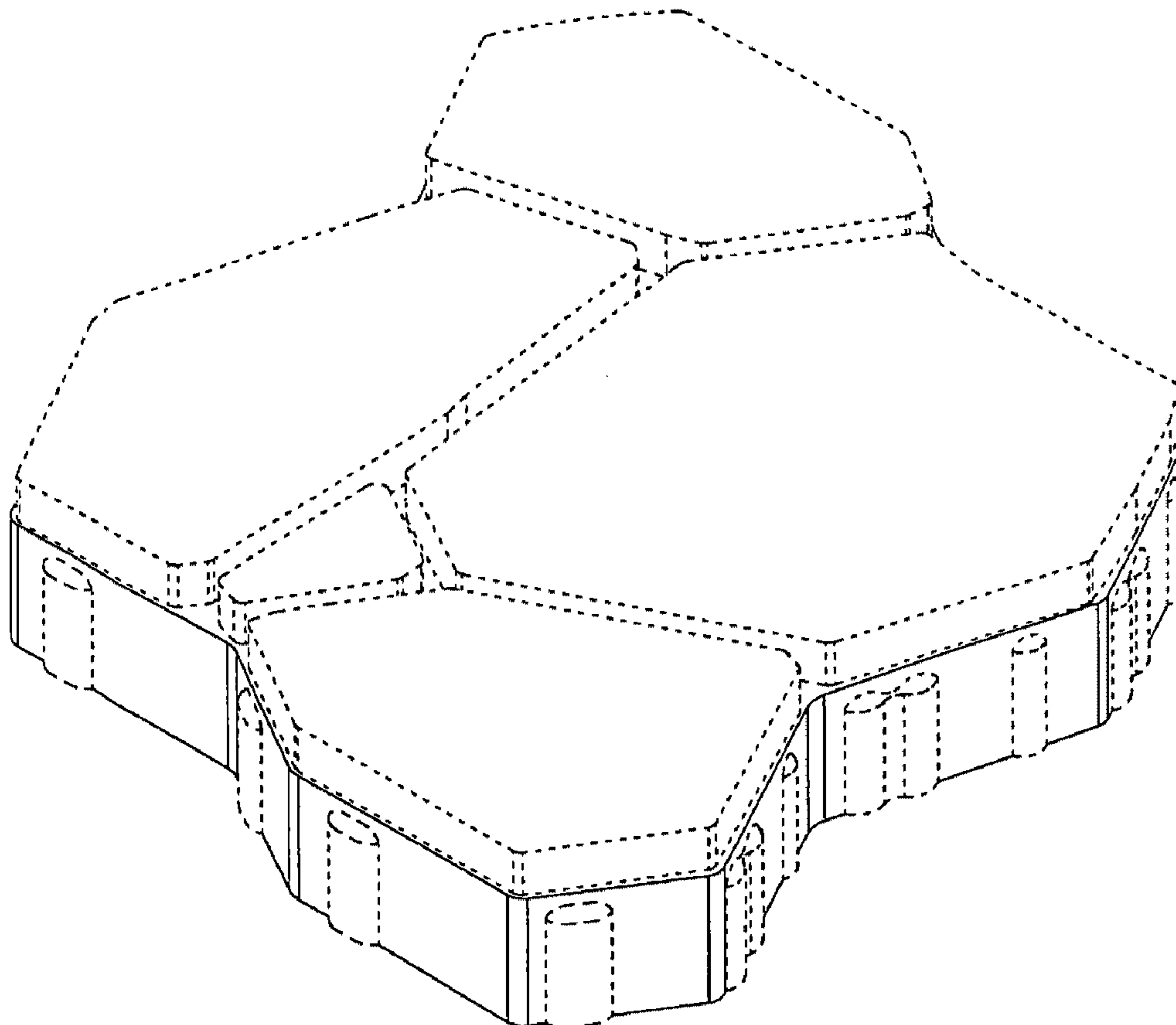
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the paver;
FIG. 2 is a left-hand view thereof;
FIG. 3 is a right-hand view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is an enlarged bottom view thereof; and,

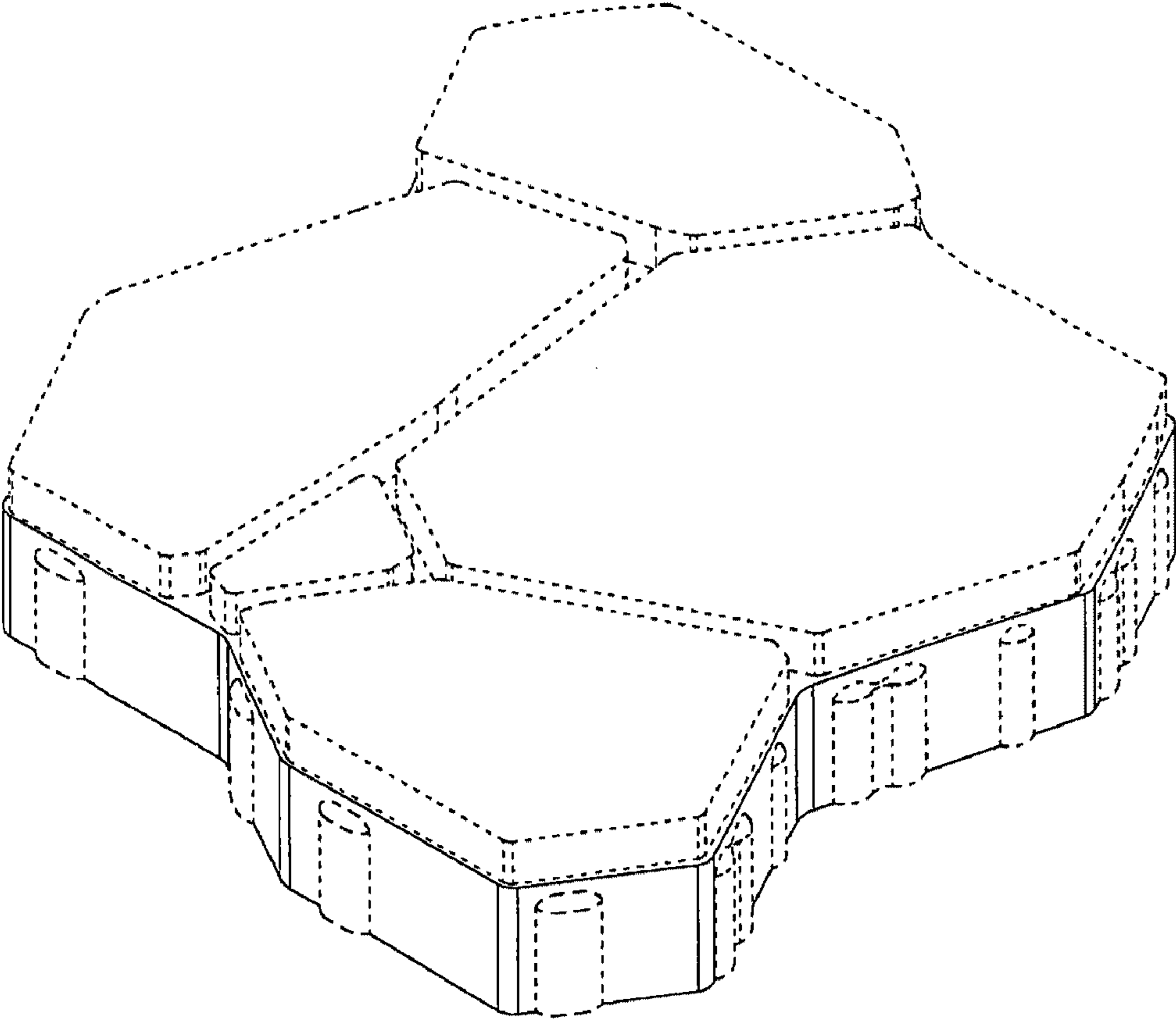

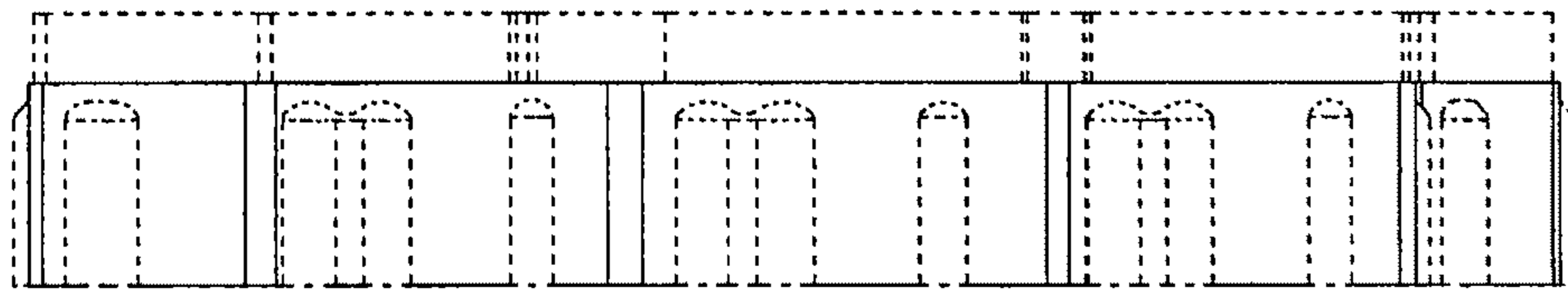

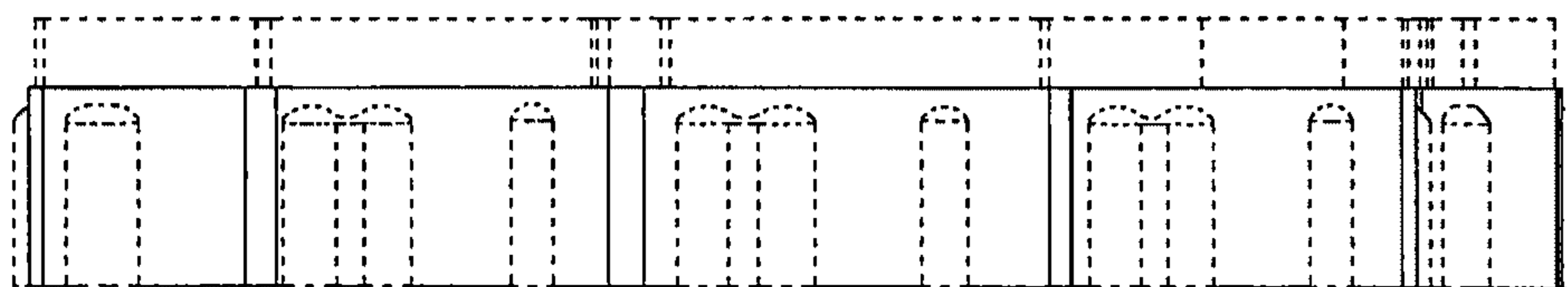

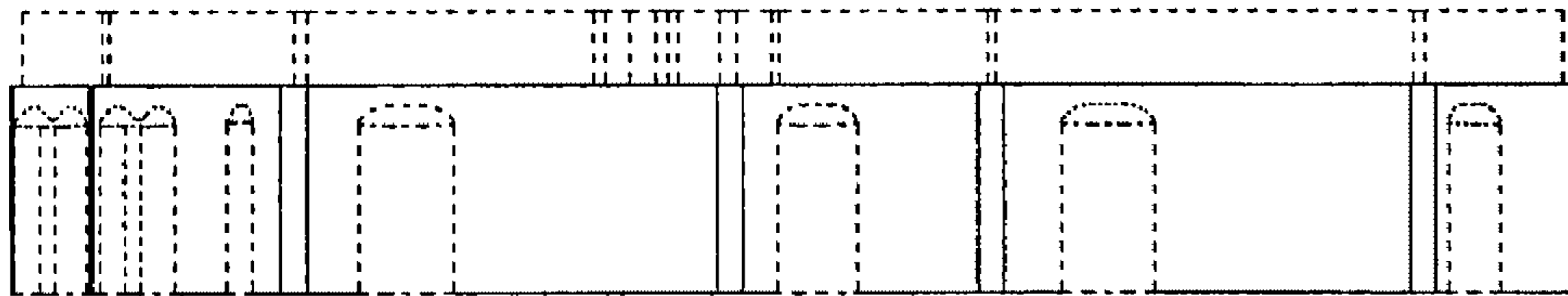

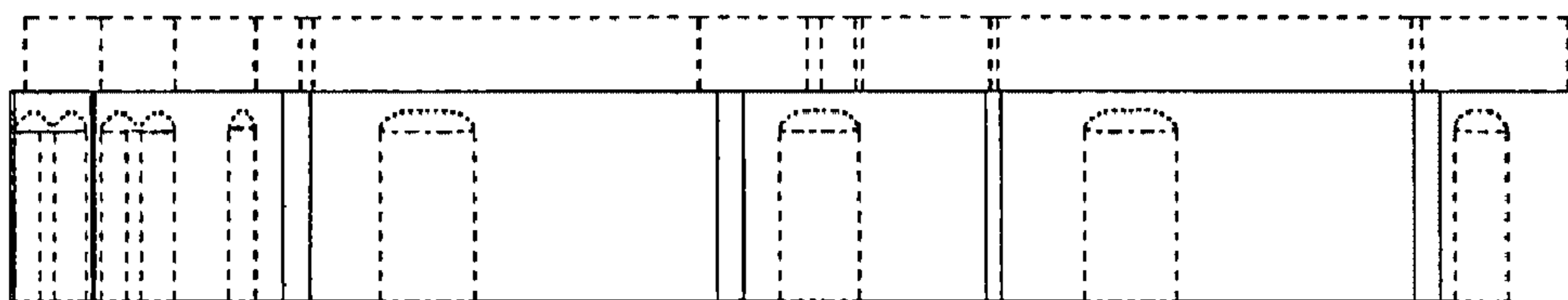

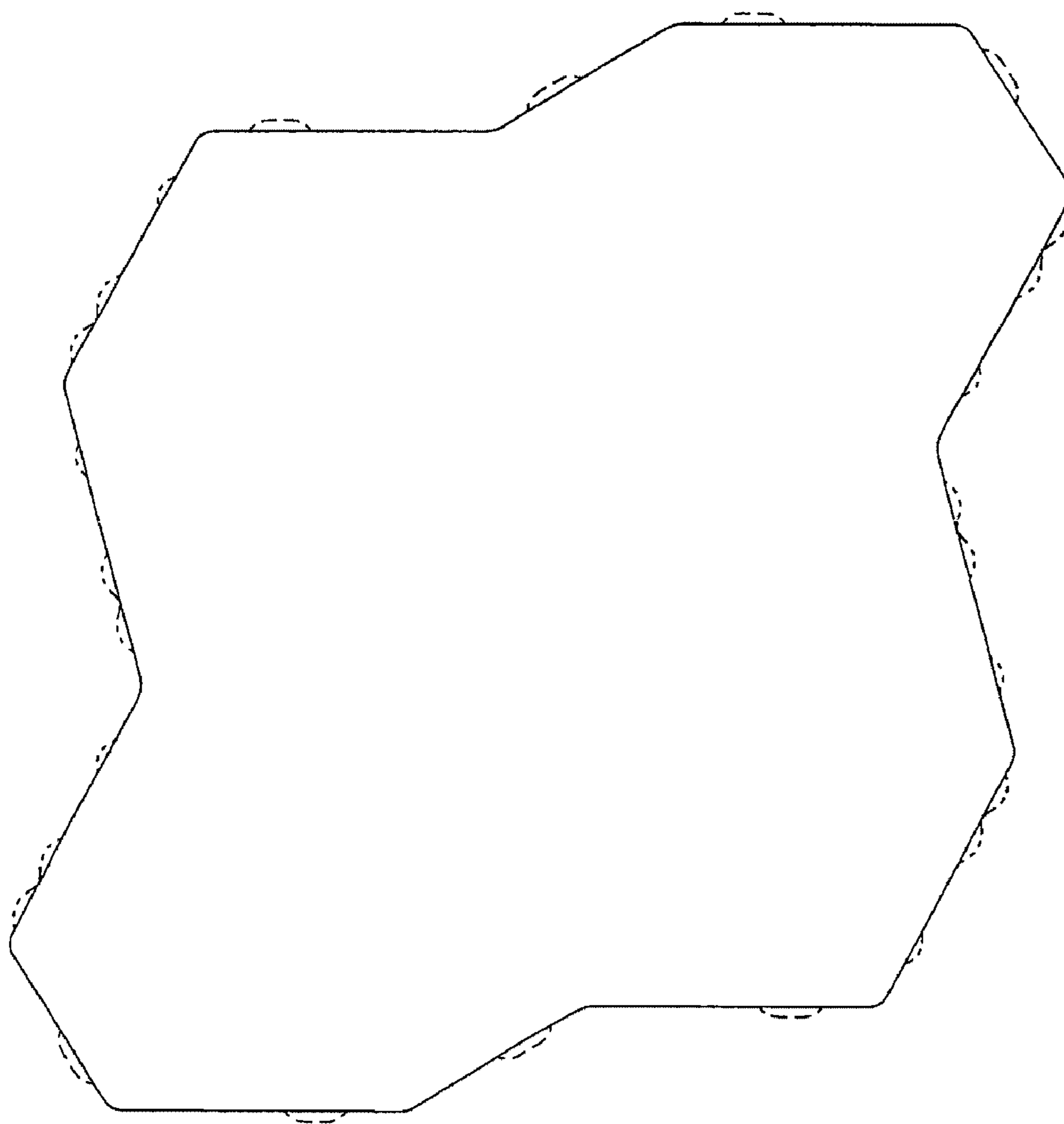

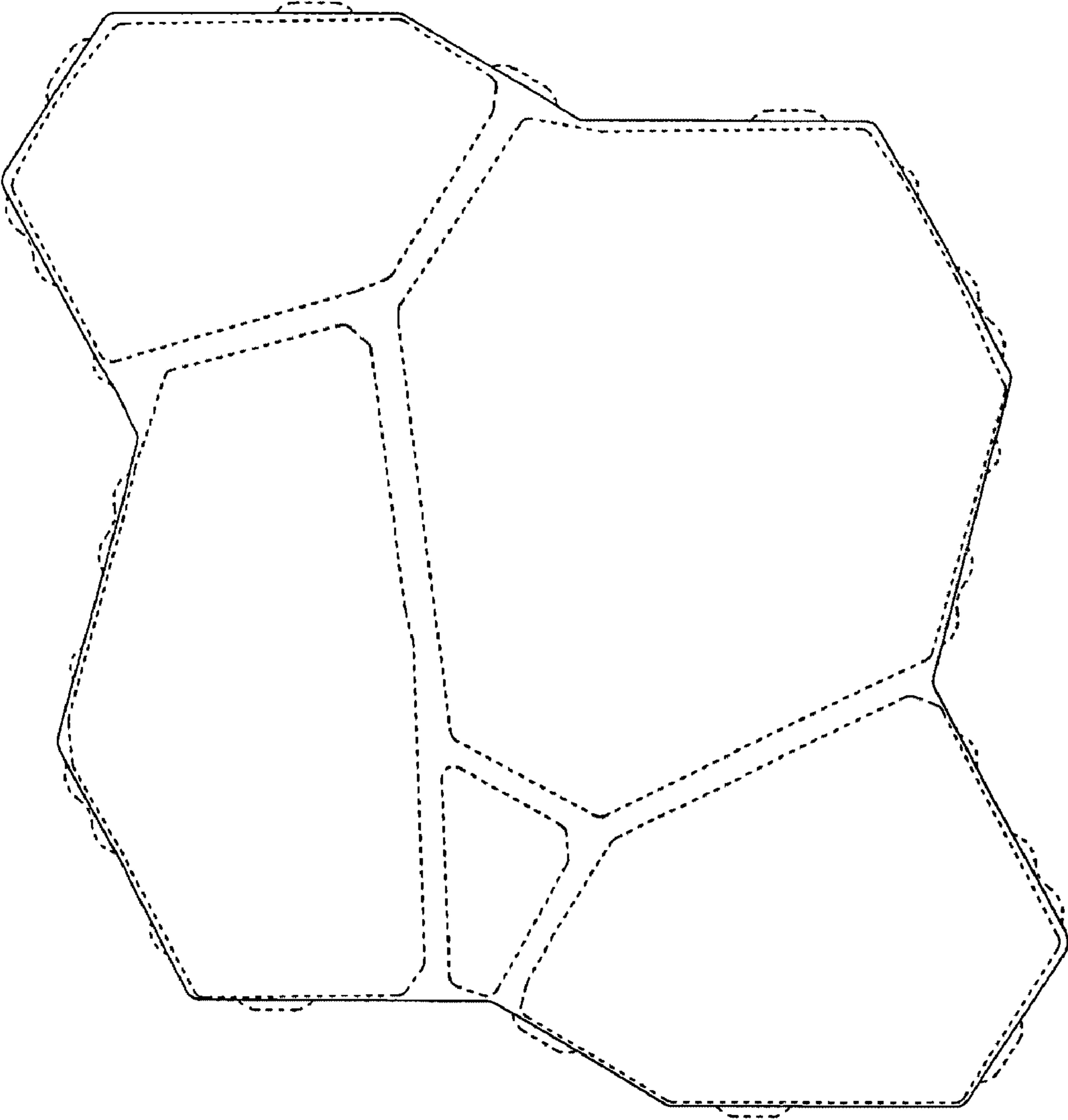
