(57) **CLAIM**

The ornamental design for a lottery number selector and ticket scratcher, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the new design showing the lottery number selector and ticket scratcher.

FIG. 2 is a front elevational view of the lottery number selector and ticket scratcher.

FIG. 3 is a back elevational view of the lottery number selector and ticket scratcher.

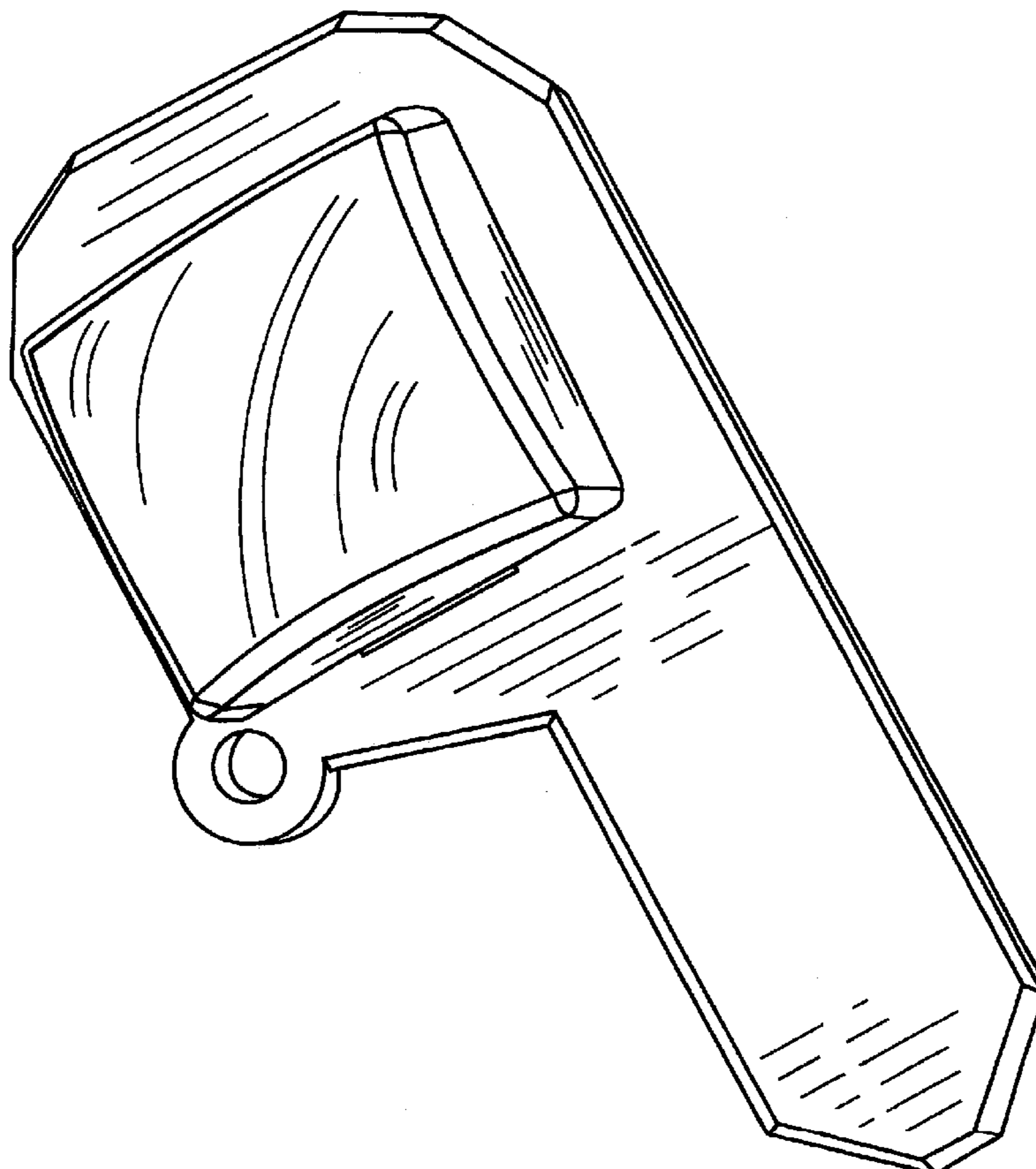
FIG. 4 is a right side elevational view of the lottery number selector and ticket scratcher.

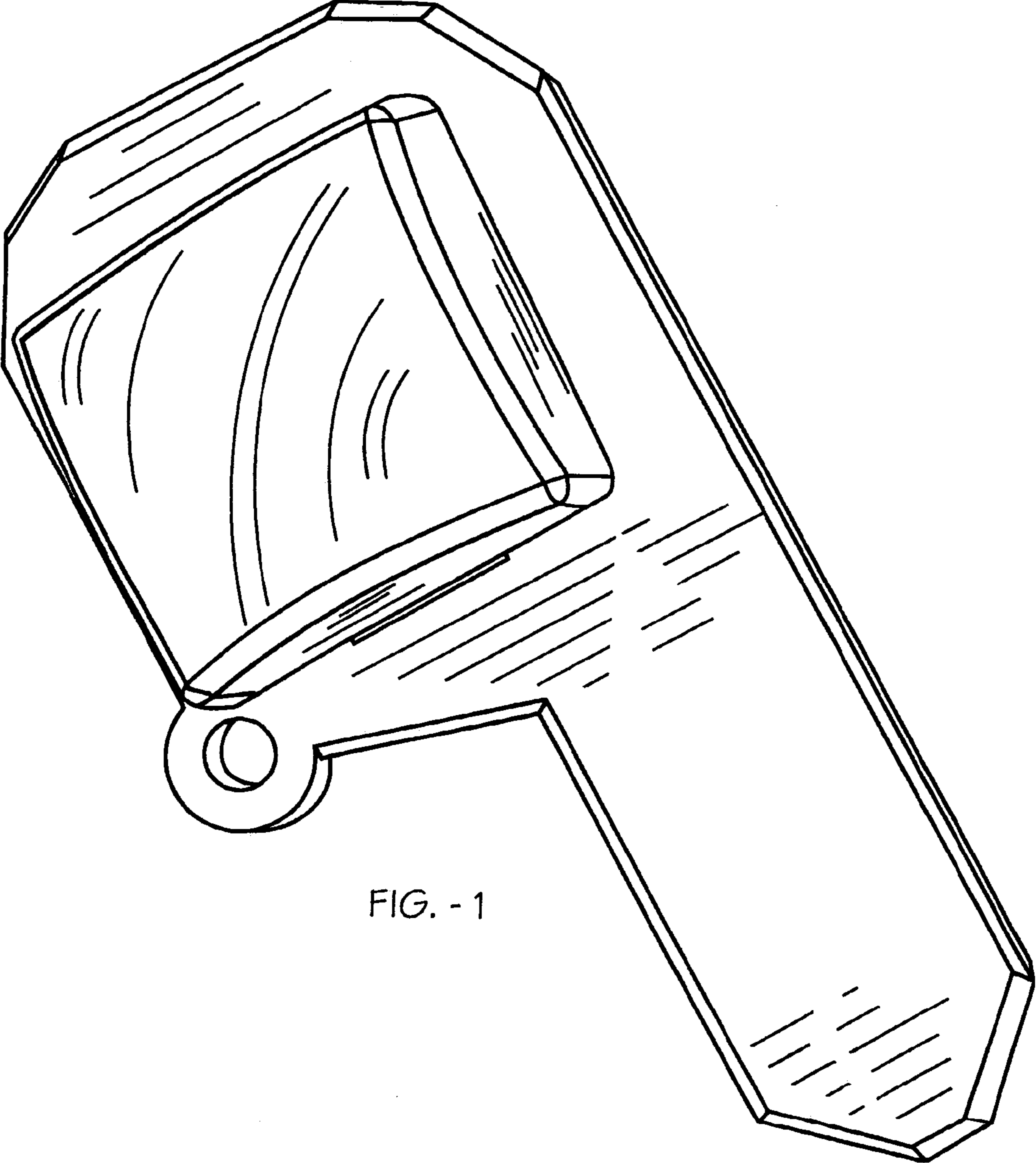

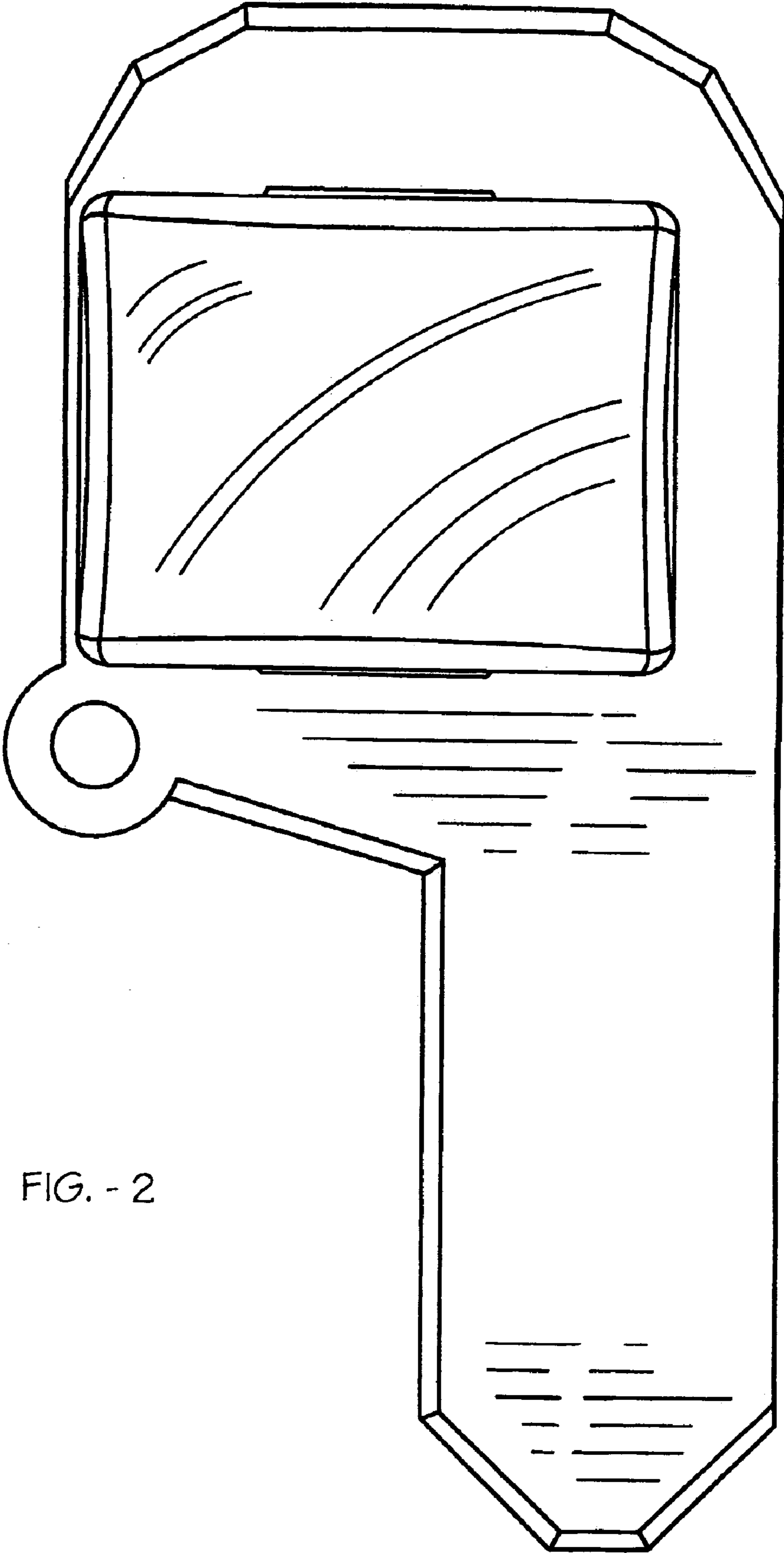

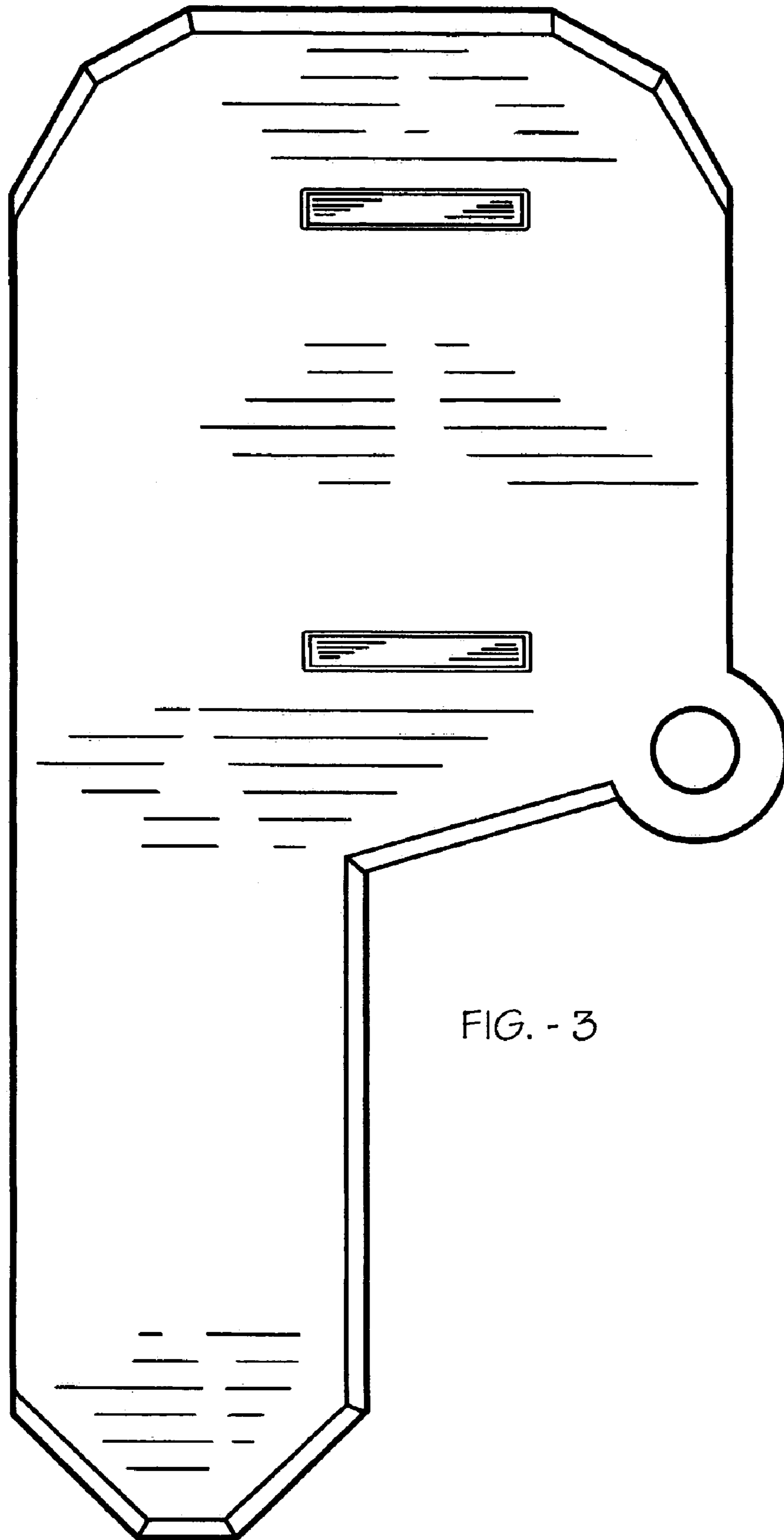

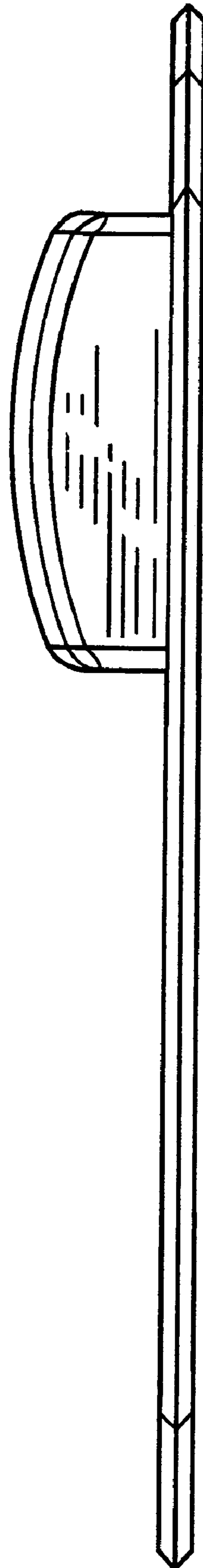

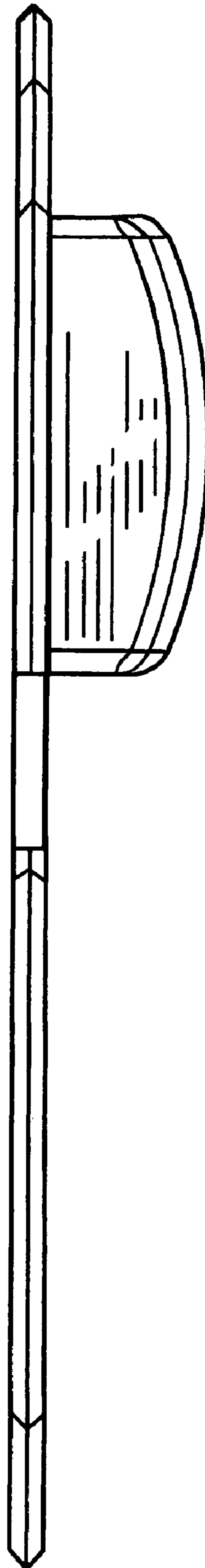

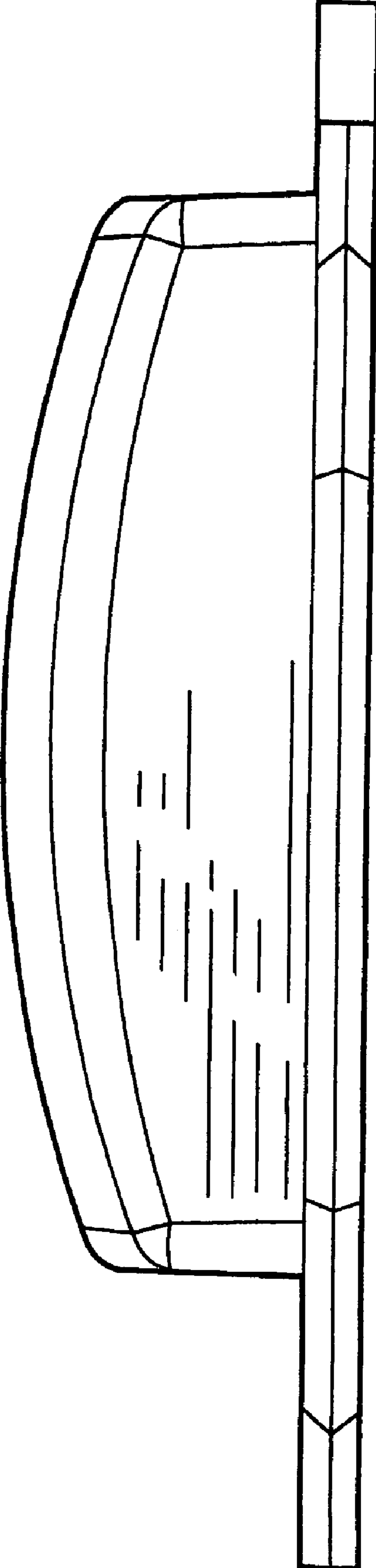
